MORE Power rates reduced

Groundbreaking of two big projects in Badiangan held

Western Visayas is projected to be the renewable energy capital of the country, according to the Department of Energy.

Energy Secretary Raphael Perpetuo M. Lotilla, who spoke during the 125th Independence Day celebration at Sta. Barbara town, emphasized the region's capacity on renewable energy supply.

According to him, Western Visayas has a hydropower potential of 930 MW, almost 500 MW for solar energy, and around 13,000 MW for wind energy.

Of this 13,000 MW wind energy potential, the 10,473 MW is going to be offshore and the major part of it is under Iloilo province and neighboring islands of Negros and Guimaras.

The biggest potential lies in a triangle between southern Mindoro, northern Antique, and northern Palawan.

Offshore wind power or offshore wind energy refers to the generation of electricity through wind produced from bodies of water, usually at sea.

"We hoped that with the total of 14,000 MW of potential renewable energy supply, we would have sufficient power to energize our development activities," Lotilla said.

With this also comes the establishment of the green and transmission system that matches the capacity of renewable energy projects which will be built from 2024 to 2040.

Moreover, the utilization of ports will support the offshore wind industry in the country.

The new rate stands at P12.2990 per kilowatt-hour (kWh), reflecting a noteworthy decrease of P0.9522 per kWh from the previous month's rate of P13.2511 per kWh. One of the primary factors contributing to this decrease is the lower generation cost.

For this month, the generation cost has decreased to P7.1182 per kWh, marking a reduction of P0.5362 per kWh. Several factors have contributed to this decline.

First and foremost, the addition of Energy Development Corp's geothermal power in the power supply mix has had a positive impact. Geothermal power, a renewable energy source, is known for its cost-effectiveness and environmental benefits.

Moreover, the lower exposure to high spot market prices in the Wholesale Electricity Spot Market has played a significant role in reducing generation costs.

Lastly, a decrease in coal prices has also contributed to this decline. Furthermore, the entry of a renewable energy supplier into the supply mix has yielded an additional advantage by reducing the value-added tax (VAT) on generation.

As a result, there has been a reduction of P0.1613 per kWh in VAT charges. Notably, the transmission charge has also decreased, further benefiting consumers.

The charge has dropped by P0.1831 per kWh, from P0.9057 per kWh in the previous month to P0.7226 per kWh this month.

This decrease is primarily attributed to the lower ancillary service charge and increased kWh billing determinant. The peak demand for this period has been recorded at 127.24 MW.

The positive trend of decreasing charges extends to the system loss charge as well. The system loss for the previous month was 7.00%, while the 12-month average system loss stands at 6.49%.

This reduction in system loss aligns with the decrease in generation and transmission charges, offering additional relief to consumers.

383K learners in Western Visayas enlist for SY 2023-2024

ILOILO CITY – The Department of Education (DepEd) said 383,117 early registrants from Western Visayas have signified to enroll in public schools for the school year 2023-2024.

DepEd-6 information officer Hernani Escullar Jr. on Wednesday said 77,214 registered for Kindergarten; 105,873 for Grade 1; 97,770 for Grade 7; and 102,260 for Grade 11 after the early registration ended on June 9.

"We surpassed this school year's early registration of 360,571 learners by as much as 22,546 or an increase of around 6.25 percent," he said, adding that while the early registration is intended for public schools, private schools can also conduct a similar activity.

be built immediately, however, preparations must be done such as training engineers, skilled people, and those who are going to construct the offshore wind energy.

"By 2034, the Philippines is projected to join the ranks of \$300 trillion economies in Asia, and without power, we will not be able to do that," Lotilla shared.

DOE also noted that energy independence is one of the current thrusts of the government, and that the country aims to achieve 100% electrification of all barangays and sitios at the end of the administration of President Ferdinand Marcos, Jr. (*PIA-Iloilo*)

The main objective of the activity, he said is for the department to capture all intended incoming Kindergarten and Grades 1, 7 and 11 that will help the department in preparing for the next school year.

"This is to ensure that once they enter our public schools, we can provide adequate learning resources and

'Pasaway' passengers

After the COVID paranoia and fear of taking public transport, I have once again rediscovered the benefits of riding or taking Grab Car rides.

Considering the fact that the distances I travel are short, I don't have to pay a fortune for a worry-free commute. Driving your own car in the metro is no longer as convenient as it used to be. Traffic has greatly increased, resulting in greater stress to drivers. Paying a small fortune for fuel and excessive parking rates is a serious consideration and there is no guarantee that you can find parking all the time. In fact, I know people who check in advance how challenging parking is where they are headed.

Of course, there are times and places where getting a Grab car can be a challenge, so I simply try to work out my meetings and schedules outside of the rush hour and certain business districts. Aside from the convenience, conversations with Grab drivers can be very educational in terms of social and class dynamics between passenger and drivers.

Whenever I ride a Grab car, my first question is if the driver is just "driving the unit" or if the driver owns the unit. Many passengers mistakenly assume that the guy behind the wheel is "just a driver." More than half of the time, I discover that today's Grab drivers are actually unit owners who are paying off a car loan while earning a living as a Grab driver.

A number of them are highly educated, college graduates who simply wanted to be their own boss, others are older head of the family who has to bring a wife to work or a child to school. A few actually ended up deciding to get a car to drive their daughter to work and earn a living in between.

In the course of these chats or impromptu interviews, I learned that being a Grab driver is not always easy. On bad days, they could end up with the "pasaway pasahero" or the passenger from hell who makes a booking and then cancels the very minute the driver is at the pick-up point.

'Unfreedoms'

On our 125th Independence Day, job fairs were held across the country. Many were for local jobs. One, organized by the Department of Migrant Workers, was packed with applicants. It was meant to assist prospective overseas Filipino workers.

The OFW phenomenon is a stark manifestation of Filipinos' lack of opportunities in their own land. Truly, we give the world our best. What would the founders of our nation think of this?

Jose Rizal might have understood the need to breathe freer air outside one's own country. It's amazing, and a source of patriotic pride, to see the recognition accorded to Rizal by the European countries where he spent several years of his life. But Rizal eventually returned to his homeland, where he faced a Spanish firing squad.

Then there are the backseat drivers who rudely tell the driver how to drive, where to pass or how fast to drive, without considering the fact that outside of the vehicle there are also the traffic enforcer from hell looking for their next victim. One Grab driver shared how a passenger apparently left the house late and harassed and threatened the driver to "fly" or speed up because the passenger might not make it to the flight.

When I asked if he reported the passenger to Grab management, the driver said they were not allowed to complain about rude passengers or answer back. They were expected to suffer in silence. I have heard this several times from different Grab drivers and this is unacceptable. Sorry, Grab management, but you have a responsibility to protect your partners in the business from being mistreated or threatened by rude and uneducated passengers.

If there are so-called passenger rights for travelers and riders, there should also be Driver's Rights and protection. Pasaway passengers should be blacklisted by Grab after two or three complaints from drivers.

Back when I was in the resort development business, there would be the rare case of guests from hell who were under the impression that because they paid for their stay in a resort, they had the right to demand things and express their displeasure at the resort staff. Like flies on the back of a carabao, they thought they were big shots or acted like they owned the place.

When I got a chance to compare notes with other resort operators, I learned how resort GMs would sit down the offensive guests, explain to them that the money they paid bought them the privilege to be treated as guests of the resort but not create a scene or harass the staff. If, however, they preferred to be elsewhere, a boat has been made ready to transfer them out of the resort within the hour. Believe it or not, those guests suddenly behaved and often turned out to be people who did not know how to turn off their "attack mode."

the US takes the same pragmatic approach, while protecting itself from foreign security threats amid its growing geopolitical rivalry with China.

Instead of commissioning surveys about the likely next president with the general elections still five years away (with the fees involved, pollsters I guess will only happily oblige), those who have money to throw away should consider commissioning studies on what national independence, patriotism and democracy mean to ordinary Filipinos, especially among Classes C to E, which constitute the largest voting segment of the population.

The significance of Independence Day in this country is lost to the majority of the citizenry, especially since there's also a segment that believes actual independence came only on July 4, 1946, when America handed over the reins of government to the Philippines. A smaller segment believes independence came with the shutdown of the US bases in the Philippines. An even smaller fringe – the one most vocal in opposing the expansion of the Enhanced Defense Cooperation Agreement and setting up of more EDCA sites – believes genuine independence will come only if the country scraps its Mutual Defense Treaty with the US.





I do hope that Grab management will introduce a reporting system, even a video recording system like that used by complaint or call centers that drivers of Grab can turn on when drivers are being verbally abused or threatened. From there, the customer can be advised about several reports filed by drivers or the pasaway passenger can simply be refused enrollment in the program. Just airing the side of drivers who, like many of us, are educated, self-employed and wellmannered persons and not nobodies!

One of the pronouncements made by President Bongbong Marcos after assuming office was that he would right-size the bureaucracy for purposes of streamlining and efficiency. If we can count on PBBM to keep his promise or pronouncement, may we suggest that the President assign some staff members to study the cloning or functions and powers in the national government.

Last week, our senior columnist Jarius Bondoc wrote about how a Dutch ship was ripped off with a half a million-peso bill for tugboat towing lasting 60 minutes total. Jarius pointed out that the bill, if levied by the Philippine Ports Authority, should have only been a few hundred dollars but because the Bases Conversion Development Authority gave the Poro Point Management Corp. the right to make up its own pricing structure, we now have a minor agency cloning the authority of the national agency.

At the MIAA, we have the Airport Police cloning the authority of the Philippine National Police, and let's not forget the conflict in issuing different visas under the PEZA – to the chagrin of the Bureau of Immigration. Nobody likes copy-cats!

Don Emilio Aguinaldo y Famy... under the protection of the Powerful and Humanitarian Nation, the United States of America."

No wonder Dictator Aguinaldo's independence aspiration ended up the way it did.

Aguinaldo is not exactly a revered figure in history, having ordered his rival for the revolutionary leadership, the upstart Tondo laborer Andres Bonifacio (plus brother Procopio) executed in the boondocks of Cavite. There's a Bonifacio Shrine at the site of his execution that requires some effort for tourists to reach. Before that, Aguinaldo's security forces also assassinated Gen. Antonio Luna in Nueva Ecija (Aguinaldo's descendants claim he did not order the hit).

The OFW phenomenon began during the regime of the elder Ferdinand Marcos, with the Middle East as the first destination. It should give you a hint of the economic situation during this "golden age" in Philippine history.

Ferdinand Junior at least seems aware of the serious problems faced by the nation, 125 years after the revolutionary government, riven by deadly power struggles, declared independence from Spain.

In a speech at the Independence Day rites, BBM lamented that national development is hindered by poverty, inadequate economic opportunities, inequality and disabling living conditions. You name it, we still got it, over a century after the revolution.

At least we're no longer under colonial rule. BBM also promised in his speech that the Philippines will never again be subservient to another country.

The statement was seen by some quarters as a reaction to criticism that his administration is turning the country into a vassal of Uncle Sam. But BBM is simply pursuing alliances that he deems to be in the best interest of a nation that has yet to develop credible self-defense capability, 125 years since declaring independence.

It doesn't mean turning his back on the world's second largest economy, China, with which many Filipinos (myself included) have ancestral ties. Even Millions of Filipinos can't care less if the country forges a security alliance with the US or China. For them, Independence Day is just another one of the long list of non-working holidays.

Rizal, who preferred autonomy to full independence, believing Filipinos were not yet ready at the time to fully cut ties with Spain, refused to endorse an armed revolution and instead espoused better education for his compatriots.

Over a century after his execution, Rizal would be dismayed to find out that 10-year-old Filipino students are faring badly in reading comprehension, and ranking low in mathematics and science.

The Philippine Declaration of Independence states that the decree was signed by "the Egregious Dictator

Scouts recruited from Macabebe in Pampanga later helped Americans capture president-turned-"rebel" fugitive Aguinaldo.

These aren't chapters in revolutionary history that would make Filipinos proud. The deadly infighting probably helped in making Filipinos welcome the new foreign occupation forces after the Spaniards sold the Philippines to the US for \$20 million.

Spanish colonial rule was replaced by what we like to describe as 50 years of Hollywood. (Today South Koreans rule the world; we're mesmerized by Hallyuwood).

Apart from independence from Spain, the revolution also sought to liberate Filipinos from poverty, injustice and poor education.

It says a lot about the state of the nation that 125 years since independence was declared, the President of the republic says he is striving to "remove the unfreedoms... to feed the hungry, free the bound, and banish poverty."

Defense capabilities



It was loud and clear.

We are referring to the statement by Secretary Gilberto Teodoro Jr. that the Department of National Defense remains committed to ensuring the Philippines remains safe, peaceful, united and progressive for Filipinos.

Coinciding with the celebration of the 125th Independence Day on Monday, the 58-year-old Teodoro, whose appointment by President Ferdinand Marcos Jr., enabled him to return to his old post, acknowledged challenges faced by the Philippines.

But he stressed: "Amid current and emerging challenges, we will continue to strive for the protection and betterment of our Motherland."

While he is not new to the DND portfolio – he was defense chief from August 2007 to November 2009 under then President Gloria Macapagal-Arroyo – Teodoro said manning the post is more challenging now as we are all living in a different world.

"It was not merely the relationship with China which was different then, during that time there was no Middle Eastern implosion yet, there was no Arab Spring, there was no tension between Russia and Ukraine and the relationship between China and the United States was different, even in the semiconductor and technology sector there was cooperation so now we live in a vastly different world," he added.

Teodoro said there is a lesson here: the need to build up the country's capabilities to make sure we are safe from any "world happening or event."

Many gave their hand when Teodoro said in a television interview the Philippines has the right to build up its credible deterrence without any question from other nations.

"The job of the Secretary of the National Defense is first and foremost building up our credible deterrence, and that will, and the way that we build up our credible deterrence is our business and nobody else's business and whether we partner with country X or Y in order to build up our own core strength is a question for the Philippines," he said.

We agree with him that other countries should not

question this right as the Philippines does not call out other nations engaged in the buildup of defensive and even offensive capabilities.

He was explicit, if distinct, when he said "Just like we do not question the buildup of not even defensive capabilities but offensive capabilities of other countries, they should not question ours and they should not tie up our buildup of our capabilities to any question of whether it's Taiwan or whatnot.

"The Philippines is for the Philippines and we leverage that and I think other countries want to help us because they view it as an integral (part of) standing strong with democratic values."

The DND chief was deafening when he said the Philippines is not a pawn of anyone in the ongoing 'geopolitical battle" in the region.

"And so the Philippines is a value (proposition) as we call it by its own self and not a pawn of anybody else in the geopolitical battle that's raging within our area now," he stressed.Right on. (manilastandard.net)

Most everyone knows what LEGO means. LEGO is a line of plastic construction toys which consists basically of variously colored interlocking plastic bricks that can be put together into almost anything you can imagine. Normally, Lego enthusiasts follow a printed instruction on how to put disparate Lego pieces together and build various kinds of buildings, vehicles, machines and background sets. Most enthusiasts start out as kids or teens. There are adults like me, however, who continue to build LEGO sets and are known as Adult Fans of Lego or AFOL.

Some LEGO builders take it a step further and engage in LEGO My Own Creation or MOC. In LEGO MOC, the builders make their own original creations out of basic LEGO bricks. Some of these LEGO original constructs are so massive and complicated that it takes months or years to build.

Most practitioners of LEGO MOC follow a similar process. We start by practicing on sets with specific instructions. We then learn certain techniques that can be used in various permutations. Thereafter, we imagine what we want to create and determine what parts we need for the creation. We picture the step by step process in our mind to build that Lego structure. With the end result firmly etched in our mind, we scour the community looking for these parts. Once the parts are in place, we then go about following the plan. Sometimes, we find glitches in the plan. We can't find a part or the part actually does not fit into the design. We, thus, adapt and change the parts or adjust the plan. Once the original creation is finished, we take a moment to enjoy it, then go on to the

Most builders who regularly engage in LEGO MOC, develop an adherence to certain tenets that are often applicable in other situations where one seeks to successfully achieve a goal. In two things where Filipinos are most passionate -- basketball and politics, we can note the presence of these tenets in successful runs in both fields and cite them as examples.

First, in most things, there are no shortcuts to successfully achieving an end goal.

LEGO MOC requires hundreds of hours of conceptualizing, picking the parts, and building the creation brick by brick. There is no other way to produce the LEGO MOC and as such, the LEGO MOC practitioner understands the importance of patience and the long burn.

Recently, the NBA crowned its new champion, the Denver Nuggets, whose road to success was a long and arduous process that took almost a decade to achieve. In basketball, putting together star players even for a short while is often a default mode of trying to win a championship. The Denver Nuggets took pains to methodically build their team and support structure from the ground up. They looked for players with potential and developed them. Their star player. Jokic. was drafted 41st overall. Once Jokic developed, they looked for the players that would complement him. It was a long and arduous process that required patience from the front office and the fans.

In politics, the successful candidates recently are the ones who start early building their brand and organization. In local elections, it takes at least 18 months to seed brand messages and train the campaign staff and workers to achieve political success.

Second, though we start from the basics, our creation or

end goal must be unique and original. In LEGO MOC, the basic build techniques are combined and tweaked to create a sum or whole greater than its parts.

The newly crowned NBA champions started with basics and developed their own unique twist to their players and tactics such as, the first point center who can bring the ball and pass it from the top of the key among other things. In politics, the candidates must always bring something unique to the table whether in their narrative or message.

Third, you need to find the right parts and be ready to change the parts or work around the challenges with the parts you have. The Denver Nuggets experimented with other players filling in the parts of their planned team before finding the core team for their run. When they found the core of Jokic, Murray, Porter and Gordon, injuries prevented them from plaving together for a long time but, they stuck with them and added more pieces. In politics, finding the right parts in the core message and finding the right members for the staff is a pivotal key to success.

In the end, it is evident that some of the games we play as kids or adults teach us more skills than we realize. As such, purposeful play must always be promoted as an additional means of learning about life skills.

This is my oblique observation.

PHA sets conference on Filipino people's struggles for nationhood

When the Philippine Historical Association (PHA) conducted its 2023 Annual Conference at the historic Metropolitan Theater in Manila on Aug. 31-Sept. 2, I have an ardent wish that the delegates will exert their best efforts to settle and put to rest the decades-old debates over certain aspects of the Filipinos' campaign for independence from Spanish occupation in the 1890s.

This early, I am certain that numerous books would be written later about the various topics and subjects that would be discussed thoroughly during the three-day conference. And hopefully, such books would put an end to the controversies over the 1896-1898 Revolution that "need to be restudied, to be reinterpreted, or even resolved."

According to its website, the PHA was founded on Sept. 18, 1955 by a group of prominent historians, among them, Teodoro Agoncillo, Encarnacion Alzona, Celedonio Ancheta, Gabriel Fabella, Esteban de Ocampo, Nicolas Zafra, and Gregorio Zaide. Their aim was to establish a scholarly association of historians devoted to the propagation of historical knowledge and studies, principally pertaining to the Philippines. Dr. Ma. Luisa T. Camagay, present PHA president, said the theme of the forthcoming conference is "SANGKAPILIPINUHAN: Retrospections on Independence and Nationhood." She added that this year's theme is in solidarity with the 125th anniversary of Philippine Independence and Nationhood on June 12.

Aug. 21-27, 1896. Among these places were Kangkong, Pasong Tamo, Pugad Lawin, Balara, Balintawak, Banlat, Bahay Toro and Caloocan.

The book author, Buehler, is a professional historian and granddaughter of Gen. Guillermo Masangkay, one of the closest comrades of Gat Andres Bonifacio in the Kataas-taasang, Kagalang-galang na Katipunan ng mga Anak ng Bayan (KKK). She had studied the so-called Masangkay papers thoroughly and became the basis of her book.

Incidentally, almost all of the places mentioned in her book as sites of the important meetings or early armed engagements of the Katipuneros were part of the former town of Novaliches. It must be pointed out that Quezon City was not yet in existence at that time, being founded only in October 1939 by then Philippine Commonwealth President Manuel L. Quezon.

In his book titled "Bones of Contention" published in 2014 by Anvil Publishing Inc., noted historian-professor and former National Historical Commission of the Philippines (NHCP) Chairman Ambeth R. Ocampo also cited some controversial episodes of the 1896

Meralco empowers LGUs in making communities more resilient

Mt. Mayon continues to exhibit signs of unrest several days after it spewed lava on the evening of June 8. This phenomenon serves as a reminder for everyone on the importance of having an emergency preparedness and disaster response plan on standby. This is especially crucial for countries like the Philippines, which are situated in the Pacific Ring of Fire. Simply put, due to our geographic location, we face an inherent risk of facing natural disasters like volcanic eruptions, earthquakes and typhoons, among others.

Recognizing the imminence and potential impact of these natural hazards, the government continues to work hand in hand with members of the private sector in strengthening the country's disaster response planning and preparedness. In fact, among its recent initiatives was the roll out of a web application aptly called "PlanSmart Ready to Rebuild".

This was launched by the National Disaster Risk Reduction and Management Council (NDRRMC), through the Department of Science and Technology (DOST), the Philippine Institute of Volcanology and Seismology (Phivolcs), and the Office of Civil Defense (OCD), and in partnership with the World Bank in September 2022.

PlanSmart was developed to overhaul and modernize the country's Disaster Risk Reduction and Management (DRRM) planning processes. Meant to be utilized by the country's different local government units (LGUs), this web application is expected to aid local government unit (LGU) officials in devising an efficient plan that will eventually pave the way for faster post-disaster rebuilding and recovery.

As the country's largest electric distribution utility, Meralco recognizes its important role in nationbuilding and economic development. The company has wholeheartedly backed the government in its endeavors and thrust, not just towards national growth and advancement, but also in disaster risk and response planning and preparedness. Hence, when the PlanSmart web application was rolled out, Meralco viewed it as another valuable opportunity to further support the government.

Since November of last year, through its social development arm, One Meralco Foundation (OMF), the company has been actively supporting various activities associated with PlanSmart including a series of regional training sessions that are aimed at strengthening the disaster response capabilities of LGUs. Over 180 participants from 52 LGUs in Metro Manila, Southern Tagalog region, and the Bangsamoro Autonomous Region in Muslim Mindanao who are all involved in their respective LGU's disaster rehabilitation and recovery programs have benefitted from these capacity-building activities.

"As the country commemorates its 125th anniversary of independence and nationhood, it is important to reflect on the historical and continuing struggles that have defined its journey towards self-determination and progress. This event also provides an opportunity for reflection on the country's past and present conditions," Camagay said.

The PHA itself, in its call for submission of discussion papers for the conference, said: "The Philippines, moving forward into the 21st century, continues to be plagued by unresolved controversies, contradictory directions, and contentious perspectives on Philippine nationhood."

There are indeed a number of controversial aspects in the Philippine history that need to be corrected or rectified. These include where and when the outbreak of the 1896 Revolution against Spain actually happened.

In the book "The Cry of Balintawak: A Contrived Controversy" written by Dr. Soledad Borromeo-Buehler and published by the Ateneo De Manila University Press in 1998, there were several places listed as the sites of Katipunnan meetings and armed engagements from Revolution involving Balintawak and Pugad Lawin, among several other places.

For one thing, Ocampo noted the conflicting dates and places where Bonifacio and the other Katipuneros tore their "cedula" or residence certificate.

"Officially, and since 1962, it has been celebrated on August 23, 1896 in Pugad Lawin. Traditionally, before 1962, it was commemorated on August 26, 1896 in Balintawak. On this matter, tradition dies hard," he said.

Meanwhile, as I was writing the concluding paragraphs of this column, I came across the latest column of veteran journalist Yen Makabenta under the title "Observer" and subtitled "It makes sense to revert the republic's name to Filipinas" (from the present Philippines) in the June 8, 2023 issue of the Manila Times.

Here's the first paragraph of Makabenta's column:

"Nobody screamed 'historical revisionism' back in the 1960s when President Diosdado Macapagal by proclamation on May 12, 1962, and the Congress by legislation on August 4, 1964, made the bold decision to move the annual commemoration of Philippine Independence Day from July 4 to June 12 in recognition of the transcendental importance of the establishment of the Philippine Republic by the revolutionary government under Gen. Emilio Aguinaldo in Kawit, Cavite on June 12, 1898." OMF president Jeffrey O. Tarayao said in an opening ceremony of a training session for the web application: "The PlanSmart Ready to Rebuild is an investment for the safety and survival of our people and the livelihoods and communities we have built. PlanSmart is a very important down payment. It is now our responsibility to pay for the balance by learning to utilize this for the good of the country and its future."

Apart from implementing emergency preparedness measures and disaster response operations, OMF has also been supporting underserved communities across the country through its electrification programs. Capitalizing on its robust grassroots partnerships, OMF delivers sustainable solutions that bring lasting impact within and beyond Meralco's franchise area.

Our country's post-disaster recovery is directly correlated to our level of preparedness against natural calamities. When faced with any form of natural disasters, our main objectives should be to minimize loss of lives and to mitigate the overall impact of these disasters on our infrastructure and economy. With this, strategic partnerships between the government and the private sector that are dedicated to this cause are crucial because effective preparedness requires collective effort to ensure that communities across the country are safer and more resilient.





DIRECTIONS:



'Birada' anti-drug drive nets over P8.7-M shabu in W. Visayas

ILOILO CITY – The monthly focused anti-drug operations launched by the Police Regional Office 6 (PRO-6) led to the confiscation of 1,281.83 grams of shabu valued at over PHP8.7 million and the arrest of 71 drug personalities in Western Visayas.

PRO-6 spokesperson Major Mary Grace Socorro Borio said their accomplishment was a result of 66 operations under their "Birada Semana" campaign conducted by various police units from June 5 to 11.

"Birada Semana is conducted once a month and is different from the regular operations that are conducted daily," she said in an interview on Wednesday.

The Iloilo Police Provincial Office (PPO), which came second to the Negros PPO in terms of number of operations at 11 and 27, respectively, netted the highest volume of drugs at 557.44 grams worth PHP3.79 million.

The Negros PPO confiscated 268.49 grams of shabu with a standard drug price of PHP1.82 million, the Iloilo City PO seized 259.8 grams worth PHP1.76 million, and the Bacolod City PO seized 159 grams valued at PHP1.08 million.

The Aklan PPO seized 0.30 grams of shabu worth PHP2,040, the Capiz PPO got 23.60 grams valued at PHP160,480, and the Guimaras PPO seized 13.20 grams worth PHP89,760. The Antique PPO had no confiscation.

The latest round of confiscation is higher compared to last month's Birada Semana, when 344.92 grams of shabu were confiscated with a standard drug price of PHP2.58 million.

"The community is now taking part in our fight against illegal drugs by giving information to our police operatives resulting in positive and high-impact accomplishments," she said.

Borio also attributed the accomplishment to their multisectoral campaign dubbed "Kasimbayanan -- Kawani (personnel), Simbahan (church), at Pamayanan (and community)."

"We now have linkages with other law enforcement agencies combined with positive information from the community resulting in bigger accomplishments," she said. (PNA)

Antique cops bring anti-drug campaigns to schools, communities

SAN JOSE DE BUENAVISTA, Antique – The San Jose de Buenavista Municipal Police Station in Antique will conduct frequent awareness campaigns in schools and communities on the ill effects of illegal drugs in support of the Buhay Ingatan, Droga'y Ayawan (BIDA) program.

BIDA, an intensified and holistic campaign against illegal drugs, was launched in Antique on Tuesday.

"We have several programs anchored on BIDA," said San Jose de Buenavista acting police chief Maj. Geremy Ian Magbanua in a press conference held at the San Jose de Buenavista Police Station on Wednesday.

Magbanua said that they will be holding lectures and symposia depending on the availability of schools.

The acting MPS chief convened on Wednesday various Barangay Anti-Drug Abuse Councils (BADACs) in the municipality as an initial step in reaching out to communities.

All 28 barangays of Antique's capital town have been declared free from illegal drugs under the Barangay Drug Clearing Program (BDCP).

"The BADAC will also be urged to focus also on those drug surrenderers or persons who used drugs (PWUDs) in their barangays for further interventions," Magbanua said.

Hopefully local government units could allocate funds for their Balay Silangan for the Community-Based Rehabilitation Program of the PWUDs this year, he added.

The municipality is currently utilizing the Regional Evacuation Center in Barangay San Pedro for the CBRP and rehabilitated 375 PWUDs from 2016 until 2020.

A surprise drug test was conducted among the PWUDs in February this year and all turned out negative for the illegal substance.

Magbanua also said that while they are intensifying the campaign, they are also ready

to use their "iron hand" on individuals who continue to engage in the illegal drug trade as part of their supply and demand reduction.

"We have a new personality arrested after a successful buy-bust operation yesterday, June 13," the chief of police said.

Police operatives seized from the suspect PHP7,000 worth of shabu and PHP1,000 marked money. (PNA)

The provincial government, through the Provincial Social Welfare and Development Office, also provided them with a sack of rice each along with canned goods and other grocery items.

Under the E-CLIP, former rebels or their qualified beneficiaries receive benefits, such as guaranteed safety and security, financial assistance, subsistence allowance, food expenses while in the custody of the receiving unit, travel and mobilization expenses, and corresponding compensation for surrendered firearms. Traders 'shortchange' hog raisers amid ASF threat in Antique

SAN JOSE DE BUENAVISTA, Antique - The Antique Provincial Veterinary (ProVet) has warned hog raisers against unscrupulous traders offering to buy their hogs at a lower price due to the suspected case of African swine fever (ASF) that was reported in the municipality of Hamtic.

ProVet Public Health Division chief Dr. Marco Rafael Ardamil said in an interview Wednesday that they received reports of traders or middlemen offering to buy live weight for only PHP70 per kilo or half the price of the PHP130-PHP140 current buying price.

"We received reports like in the town of Patnongon and other northern towns of the province that there are some people who are taking advantage and even threatening hog-raisers to already sell their live weight for as low as PHP70 per kilo," Ardamil said.

He added that they allegedly told hog raisers that they need to dispose of their hogs because soon the suspected cases in Hamtic will spread to their areas.

Ardamil, however, said that hog mortality is reported only in the town of Hamtic with 348 affected heads from 11 barangays.

"We still cannot confirm that the hog mortality is due


