Bacolod to break ground on more 4PH housing projects next month

BACOLOD CITY – The city government here is expected to break ground on additional condominiumtype housing projects under the Pambansang Pabahay sa Pilipino Housing Program (4PH) project in the middle of February.

Aside from the initial Yuhum Residences, which is underway in Barangay Vista Alegre, two other sites have been identified, including Barangay Banago and Estefania.

The Yuhum Residences-Banago, with an area of 3.5 hectares, is being proposed to have 3,627 units while in Yuhum Residences-Estefania, some 1,440 units

are expected to rise on a 2.4-hectare property.

The first 296 units of the Yuhum Residences-Vista Alegre in the initial four buildings are set for turnover on Feb. 14, along with the groundbreaking for the other projects.

Mayor Alfredo Abelardo Benitez said on Monday that the city government is fully supported by the national government in the implementation of the 4PH together with the Department of Human Settlements and Urban Development (DHSUD).

"We are the pioneers in this housing program. We are the first, we may be

involves the construction of 32.7-kilometer two seacrossing bridges including connecting roads and interchanges that will link Panay Island to Guimaras Island and Guimaras Island to Negros Island.

It will be funded by the Economic Development Cooperation Fund (EDCF) Loan Agreement No. PHL-23 with a total amount of PHP 3.180 billion.

First to be implemented is the Panay to Guimaras Section with a total length of 13 kilometers from the Municipality of Leganes, Iloilo to the Municipality of Buenavista, Guimaras.

Based on the proposed project timeline Section A will commence construction

in the third quarter of 2025 and is expected to be completed by the year

Meanwhile, Section B which is from the Municipality of San Lorenzo, Guimaras to Municipality of Pupulandan, Negros Occidental has a length of 19.47 kilometers.

The entire PGN Island Bridges Project is expected to be completed in the year 2032.

DPWH said the project is expected to reduce the travel time of commuters and motorists and transport of goods from Panay to Negros Island through ferries/RORO from 3-4 hours to just less than one

DA, SRA, stakeholders discuss plan to buy sugar from local farmers

BACOLOD CITY -The Department of Agriculture (DA) and Sugar Regulatory Administration (SRA) have convened sugar industry leaders to tackle government's plan to buy sugar directly from the farmers at a premium price amid the continuing low farmgate prices, usually between PHP2,400 and PHP2,500 per 50-kilo bag.

In a statement on Sunday, SRA Administrator meeting were leaders of Pablo Azcona said that he, Agriculture Secretary Francisco Tiu Laurel Jr. of Sugar Producers and Philippine International Trading Corp. president Federation of Sugarcane and chief executive officer Planters, Luzon Federation Undersecretary Emmie of Sugarcane Growers

millers, farmers and traders at the DA central office in Quezon City on Friday.

"(It was) a momentous event as the last time industry stakeholders sat down together was probably eight years ago. We hope this will be the beginning of a unified industry that openly communicates and supports each other," Azcona said.

Those who attended the the United Sugar Producers Federation, Confederation Association Inc., National Liza Perez-Chiong met with and Associations, Panay

sugar federation leaders, Federation of Sugarcane Farmers Inc., Philippine Sugar Millers Association, Philippine Association of Sugar Refiners, and groups of sugar farmers and traders.

> They helped in crafting the mechanics of the government participating in buying the sugar produce, the SRA chief said.

"We also discussed steps to be taken to further enhance productivity and profitability, ensure stability of sugar supply for consumers and industrial users, better retail prices and keeping in mind that the sugar farmer is also a retail consumer," he added.

Azcona did not provide details yet on the buying schedule and the purchase price.

He noted that "bringing all our sugar leaders to sit in one table and discuss together the state of the

Higher power rate awaits Iloilo City consumers

ILOILO CITY -Consumers of More Electric and Power Corporation (MORE POWER) will have a 10-centavo increase in their January billing cycle due to a hike in the transmission charge.

"This is solely due to the additional ancillary service charge by NGCP (National Grid Corporation of the Philippines) to maintain the reliability of their electricity grid and the balance in the system so they may recover in time of power system disturbance," MORE Power said in a statement on Monday.

The distribution utility will pass on 10 centavos per kilowatt-hour (kWh) to consumers following the 19 percent hike in the transmission charge.

With the increase, consumers will pay PHP10.321 per kWh for the Jan. billing from the PHP10.2259 kWh during the Dec. 2023 billing cycle.

Amid the hike in transmission charge, the generation charge decreased while the distribution system and metering rate remained the same.

In a press conference on Monday, Iloilo City Mayor Jerry Treñas said he was informed that NGCP implemented brownouts and blackouts earlier to prevent power interruption during the Dinagyang Festival.

"We'll take their word for that, otherwise we will be seeing them again," he said.

The weeklong events of the festival kicked off Monday, while the highlights are on Jan 27-28. (PNA)



industry has not happened in such a long time."

"This is a sign that the industry is united in finding a solution to improve the plight of the sugar farmer, who, in reality, is the most important link in the sugar supply chain. Without the farmer, the mills have nothing to grind, the traders have nothing to trade and the consumers and industries will have no sugar for their needs," the SRA chief said.

In a press briefing here last month, Azcona disclosed the government's plan to buy sugar directly from farmers to prop up farmgate prices and lower retail prices at the same time after the sugar producers' federations sought intervention from Laurel and President Ferdinand R. Marcos Jr. as the farmgate prices of sugar plummeted since the start of the milling season in September.

The price of PHP3,000 per 50-kilo bag is considered a fair market price, but farmgate prices are still only between PHP2,400 and PHP2,500, particularly in Negros, the country's sugar capital.

Azcona acknowledged the continued trust in and support of the President and the DA chief to the SRA, adding that he is optimistic that "the cooperation from all industry stakeholders will be the key towards a positive growth of the industry."

"I thank President Marcos and Secretary Laurel for keeping their commitment to help the industry, particularly the sugar farmers," he added. (PNA)

Negros Occidental power rates increase in January



BACOLOD CITY - Average residential power rates of all three distribution utilities in Negros Occidental increased in January, mainly due to higher generation and transmission charges.

The Northern Negros Electric Cooperative (Noneco), Central Negros Electric Cooperative (Ceneco) and Negros Occidental Electric Cooperative (Noceco) distribute electricity to the province through their respective franchise areas.

On Tuesday, Noneco said this month's rate increased by PHP0.487 per kilowatt hour (kWh) to PHP12.38 from last month's PHP11.89.

"The increase is attributed to the net increase of the electricity due to the market price of Wholesale Electricity Spot Market and increase in the fuel fee of Palm Concepcion Power Corp.," it said in a statement.

Ceneco, which serves the cities of Bacolod, Bago, Talisay and Silay, as well as the municipalities of Murcia and Don Salvador Benedicto, reported an average residential rate of PHP10.83/kWh for January, higher by PHP0.066 from the previous month's rate of PHP10.76.

In its advisory, the Ceneco management attributed the rate hike to the increase in average transmission charges by 10.35 percent due to the increase in the ancillary service charge.

"In monitoring the monthly electricity usage, consumers are advised to look at their kilowatt-hour consumption and not on the bill amount since it varies

depending on the passthrough charges," it added.

Noceco, whose area coverage includes the cities and municipalities in the southern part of Negros, has a residential rate of PHP12.24/kWh in January, with an increase of PHP0.42 from PHP11.82 in December.

The hike in total generation and transmission charges pushed for the higher rate, it said.

According to the Noceco management, higher electricity rates are expected in the coming months or during the hot season "when total demand is high because more expensive generation sources are added to meet the increased demand in electricity." (PNA)

Over 3.6K PUVs in Iloilo consolidate into cooperatives

ILOILO CITY – The majority of the public utility vehicles (PUVs) in Iloilo have been consolidated into various transport cooperatives, according to the Land Transportation recommendations to address livelihood projects for Franchising and Regulatory Board (LTFRB) on Friday.

In a press conference Friday, LTFRB spokesperson lawyer Salvador Altura said that based on its records as of end of 2023, about 75 percent or 1,692 of the 2,266 who have been consolidated into cooperatives are plying city routes while 97 percent or 1,911 out of the 1,978 are plying in the province.

Citing the latest board resolution and memorandum circular of the LTFRB, Altura said the franchise of all that failed to file their consolidation by Dec. 31, 2023 was already deemed revoked effective Jan. 1 this year.

However, all traditional units are allowed to ply routes until the end of this month in consideration of those areas where there was no consolidation.

"These are small and isolated routes where

only one or two units are plying. Suffice to say that areas where there is no consolidation have no urban areas," he said.

One of the possible the gap is to extend the route of those plying in the nearest areas, he added.

Meanwhile, the Department of Labor and Employment (DOLE) and the Technical Education and Skills Development Authority (TESDA) have already extended assistance to drivers and operators displaced by the implementation of the Public Utility Vehicle Modernization Program (PUVMP).

DOLE information officer John Mandario said that under the "entrepreneur" program, they have released over PHP10.44 million to 437 beneficiaries endorsed by the LTFRB and transport groups as of the end of December.

"We have granted 11 them," he said in the same press conference, adding that this year, they have another PHP10 million allocation targeting 335 beneficiaries.

TESDA supervising trade specialist Donnabelle Sollesta said they provided 900 scholarship grants to drivers and their beneficiaries who will graduate in January and February this year under the Tsuper Scholar Program.

Their assistance included free skills training and assessment with allowance and entrepreneurship training. (PNA)

Clean and green communities

How do you make our barangays – the country's basic political unit—self-reliant communities?

For the Department of Interior and Local Government that exercises supervision over barangay affairs throughout the country, it is by empowering them to be self-sufficient in food, stay healthy, heighten their environmental awareness, and keep their surroundings clean.

In fact, as reported by the DILG Barangay Affairs bureau in a recent media forum, there are now 25,000 barangays with flourishing community gardens. Last year, there were only eight such community gardens.

The dramatic increase in the number of community gardens is the offshoot of the "Kalinisan Day" initiative of the Marcos administration.

This program encourages barangays to put up their own community gardens, which will be planted with the 18 vegetables enumerated in the Tagalog song "Bahay Kubo." Planting such

crops is considered economical and promotes a healthier lifestyle.

The barangays have been directed to provide seedlings to their constituents. Funding for the project will come from the budgets of barangays rather than from the national government.

Urban farming of vegetables and fruits, the DILG said, will help address food security issues, such as hunger, and alleviate poverty as well.

By encouraging barangay folk to start by maintaining cleanliness in community, they can then turn their attention to food production and food security, take steps to main health and sanitation, and launch environmental protection and conservation efforts, among others.

The DILG wants to sustain the clean-up drive of the Marcos administration so that "Kalinisan Day" can bring about other changes that can strengthen community solidarity and empower them to take charge of their own future.

The national government has emphasized that community development encompasses not just cleanliness but also includes children's welfare, crime prevention, climate change adaptation, capacitating institutions to resolve local disputes, community health and nutrition, commerce and trade.

Given this, the DILG wants the clean-up program to lead to other positive outcomes. It has expanded the reach of the program to the 42,000 barangays, 1,700 cities and 82 provinces throughout the country.

In fact, the DILG has commended the local government of Quezon City for putting up 1,200 vegetable growing sites and for encouraging every community to undertake similar initiatives in other parts of the city.

We begin with a survey

"Survey and test a prospective action before undertaking it. Before you proceed, step back and look at the big picture, lest you act rashly on raw impulse." - Epicetus

Lately, I have had several meetings that follow a recurring pattern. The conversation almost always begins with the same statements. "Atty, I want to run in the next elections. I know I can win because the people I meet tell me I can win." I then ask them if they have commissioned a survey for this purpose. The response is almost always negative. It is either they do not believe or do not appreciate the relevance or importance of surveys as a starting point for any political decision.

Even at this day and age, there are many who do not understand or trust surveys. What is even more surprising is that there are some who do not even believe the surveys they commissioned themselves.

One of the common questions on the veracity of survey is the sample population size. How can a very small population size reflect the opinion of a larger population.

A veteran election expert who focuses on quantitative analysis once gave me the best explanation I have heard so far. When eating a cake, you do not need to eat a whole cake to know how it tastes. You just need

to slice a piece of it and then eat it. The trick is in the way you slice it. You need to get a complete cross section of the cake.

In the same manner, there is a science in determining the sample population that would accurately reflect the entire target population. At any rate whether you believe in surveys or not, I can give you a slew of evidence that can prove the high rate of success of some survey firms.

In any endeavor, a baseline survey of one kind or another is essential to understand the lay of the land. A baseline survey is a research tool that tells you what the relevant status quo is the state of other pertinent factors that could affect your project. For example, a project that seeks to decongest traffic needs to determine certain things like root causes of traffic, present road use, road network, geography and other relevant as a starting point for any such project. Without the baseline survey, it would be difficult to set a direction for any plan.

On the other hand, baseline political surveys are quantitative tools that focus on political opinions, attitudes and behaviors at a certain point in time. By understanding the target audience, political strategists can then map out their campaign strategy.

Surveys also give one an insight on possible opponents' strengths and weaknesses. Recently, some firms came out with survey results on senatorial preferences for the 2025 elections. Anyone interested in the next midterm elections can immediately get one significant observation. The next electoral process will again be dominated by sitting or former senators with awareness and preference ratings of above 90 percent and 20 percent, respectively. It is interesting to note though that some of the bets in the top 12 rankings are candidates who lost in previous elections and are now seemingly poised to enter the winning circle. The takeaway for rookie candidates is that it will be difficult to win but worth it to participate as preparation for future elections. Clearly there are many candidates who had to pay their dues in the form of losing previous electoral processes before gaining the prize.

For those thinking of participating in the next elections, before anything else, get a survey. This is my oblique observation.

Leave no one behind in Philippine education

The Commission on Higher Education (CHED) has informed state universities and colleges (SUCs) and local universities and colleges (LUCs) to stop accepting senior high school students starting the next academic year. The "next academic year" is 2024–2025.

What prompted CHED to issue such a directive? The CHED said SUCs and LUCs will no longer have any legal basis to ask for funding for their senior high school operations. The CHED asserts that the transition period in the implementation of K–12 is over; thus, there is no need for SUCs and LUCs to accommodate senior high school students.

I don't think this is about the question of funds intended for senior high school students. What must be paramount is providing various opportunities for our children and youth to access quality education, since this will shape them into responsible citizens who may become our future leaders. If indeed the transition is over, the government should have an alternative or a new program to accommodate senior students who prefer SUCs and LUCs.

Based on data from the Department of Education (DepEd), there are 17,751 Grade 11 students and 2,030,451 Grade 12 students currently enrolled in SUCs and LUCs. We can safely assume that the same number of students will lose the opportunity to enroll in SUCs and LUCs. Granting that the same number of students will transfer to DepEd schools, I don't think they can be accommodated in these schools.

The net result is the massive displacement of students on a nationwide scale. I believe our government should not allow this to happen. In 2016, the implementation of the K-12 program introduced a new curriculum

that aimed to prepare technologically proficient youth for early employment by building an even stronger foundation on critical subjects and skills. However, there were a number of issues: an estimated 400,000 students failed to enroll; parents were not financially ready for the additional two years of education; and, moreover, DepEd did not have enough classrooms and teachers.

I cannot help but wonder about the fate of the 400,000 students initially displaced by the K–12 program. Of course, the succeeding years would result in the displacement of students who could not afford an additional two years of education. While the government implemented a voucher system for the tuition fees, this did not include other miscellaneous expenses such as uniforms, transportation, and the like, which became a burden to the parents.

Then came the Covid-19 pandemic. The Covid-19 pandemic completely affected an estimated 27 million students. The Commission on Human Rights of the Philippines (CHR) conducted a study revealing that within the first three months of the pandemic, the number of out-of-school youth (OSY) increased from 16.9 percent in January to 25.2 percent in April 2020. The study emphasized that the Philippines opened its schools last, with no formal classes of any type being held from March to October 2020. Face-to-face classes were only held in some selected areas starting in October 2022.

The online or distance classes posed a lot of problems for students and teachers. The quality of education suffered a lot from a lack of gadgets, a lack of or intermittent internet connection, the short attention span of students, and difficulty complying with projects and requirements.

FRESH VIEWPOINTS: A NEW PERSPECTIVE

Studies have shown that students are "learning less" with distance or online education. In fact, the World Bank reported that 9 in 10 Filipino students aged 10 struggle to read simple text.

I realize that it was only on Nov. 2, 2022, when the Philippines returned to full face-toface classes, or just 14 months ago. The order to transition to five-day in-person classes was given by Vice President Sara Duterte, who is also the DepEd secretary.

It is unfortunate that after the displacement of students under the K-12 program and the Covid-19 pandemic, senior high school students may yet again find themselves displaced under the plan to phase them out of SUCs and LUCs. I believe that SUCs and LUCs must continue to accept senior students, considering that DepEd does not have enough buildings and teachers to accommodate them in the first place. Furthermore, SUCs and LUCs anticipate the displacement of senior high school teachers and non teaching personnel. The loss of jobs will affect thousands of families.

All aspects of Philippine society are still recovering from the pandemic. Businesses, agriculture, people, and education are still recovering as the global economy opens. Our people, especially the marginalized, are still reeling from the effects of the pandemic due to the massive loss of jobs and livelihoods. Inflation is causing all prices of basic commodities to increase, including the cost of transportation, which is significantly impacting the economic well-being of people.



Stricter security plans, minus signal shutdown set at Dinagyang fest

ILOILO CITY – Iloilo City will implement stricter security measures during the highlights of the 2024 Dinagyang Festival on Jan. 27-28 without imposing signal shutdown as requested by the Philippine National Police (PNP).

"It will be very strict," Mayor Jerry P. Treñas said during a press conference on Monday.

He said he might issue an executive order that prohibits the use of backpacks during the events should the Iloilo City Police Office request it.

He would also instruct the City Engineer's Office to install floodlights in areas where there is no lighting. When needed, he would also request augmentation from the Philippine Army.

He added three mobile jails of the Bureau of Jail Management and Penology will be on standby for unruly revelers and will be brought to the Iloilo City Action and Response (ICARE) center in Sooc, Arevalo, and Calumpang, Molo.

Treñas will meet with members of the Sangguniang Panlungsod on Tuesday and expects a briefing on the result of their committee hearing on the appeal of Brig. Gen. Sidney Villaflor for the local government to reconsider the earlier decision of the council on

signal shutdown.

"It's final, and while there is another letter of appeal that was sent to the city council, the city council will have to go over that. We want to give the letter of Gen. Villaflor as much as possible the seriousness it deserves so it has to go through due process," he said.

Treñas reiterated its opposition to imposing signal shutdown citing last year's experience when the shutdown affected telecommunication signals up to the Iloilo airport in Cabatuan town and other adjacent municipalities.

"Our police would be

extra vigilant because we expect more visitors. More visitors because the country has opened, more visitors because of revenge travel," he said.

Meantime, Tourism Regional Director for Western Visayas Crisanta Marlene P. Rodriguez said festivals, in general, played a huge role in the promotion of the tourism of a locality.

"We are expecting that the highlights of Dinagyang would increase tourist arrivals," she said in a separate interview.

She added they requested influencers from their central office to help promote the festival. (PNA)


