EVERYTHING is all set for the 2024 Iloilo Dinagyang Festival highlights this coming January 27 and 28, 2024.

Metro Pacific Iloilo Water uses new Technology to repair leak

WITH Metro Pacific Iloilo Water's aggressive campaign to bring down its water losses, the water utility has started using the TyfoFibrwrap Pipe (TFP) Rehabilitation System for its pipe repair operations in Carpenters Bridge.

MPIW is the first water utility company in Western Visayas to use this technology which allows the repair of a primary pipeline without interrupting the water supply service during its leak repair operations.

Given that the pipe is a critical asset to meet the water demand of 4,700 customers in Molo, Arevalo, and City Proper, it is not practical to implement the conventional approach of replacing every pipe segment. Instead, MPIW implemented an innovative trenchless technology using a carbon fiber-reinforced polymer strengthening material to externally repair the pipe and structurally rehabilitate the



Antique bamboo crafters seek P2.5-M aid for weaving center

BUENAVISTA, Antique – An association of bamboo crafters in Antique sought the support of the provincial board here to secure PHP2.5 million assistance from the office of Governor Rhodora Cadiao to build a weaving center.

On Monday, Board Member Karmila Dimamay sponsored a resolution approved by the provincial board for assistance from the Office of Governor Rhodora Cadiao upon the request of the Ramon Magsaysay Bamboo Crafters Association from Brgy. Ramon Magsaysay in San Remigio town.

The association

> "The Ramon Magsaysay Bamboo Crafters Association needs a weaving center that would house their equipment and where they could display their products," Dimamay

> Dimamay hoped Governor Cadiao would prioritize the request for the center to rise within this year or in 2025.

Association president Irele Mahimpit said they hope to build the center at the 1,000-square meter donated for them in their barangay.

"I am optimistic that with the center, we would produces baskets, trays, be able to produce more

The association completed the training on engineered bamboo at the University of Antique (UA) Main Campus in Sibalom last year.

They already have equipment like the pole cutter machine provided by the school.

"There are 33 members of our association who are earning a living through making bamboo products," she said.

another exciting event is the Ilomination Street Dance Competition and Floats Parade of Lights to be held on January 26 starting 6:00 p.m. from Atria Park District to SM City Iloilo to Iloilo Business Park (Megaworld).

Various commercial establishments and malls will also stage their respective events such as food festivals, concerts, and fireworks display which will surely attract thousands of people.

The Iloilo City Police Office (ICPO) together with the Iloilo Festivals Foundation Inc. (IFFI) and the Iloilo City Government had already laid down the security plan for the festival's final week.

Philippine National Police (PNP) Chief, Gen. Benjamin C. Acorda Jr. has ordered the suspension of permit to transport and carry firearms outside residence (PTCFOR) for 10 days in Iloilo City in a bid to boost the security measures for the 2024 Dinagyang Festival.

The suspension takes effect 12:01 a.m. of Jan. 19 until 12:01 a.m. on Jan. 29.

"The gun ban will be strictly enforced across all festival venues, procession routes, and related events. ICPO personnel will conduct thorough security checks to ensure compliance with this directive," the ICPO said in a statement.

ICPO chief PCol. JoerestyCoronica said only members of the PNP, Armed Forces of the Philippines (AFP), and other Law Enforcement Agencies (LEAs) performing official duties and in agencyprescribed uniforms are allowed to carry firearms.

With the gun ban in effect, carrying sharp objects, deadly weapons, and other contraband is also prohibited.

"We are ensuring a firearm-free Dinagyang Festival. Let's celebrate together in harmony, respecting the safety measures for a secure and enjoyable time while we devote Señor Santo Niño," he added.

Meanwhile, the Sangguniang Panlungsod committee on police matters has yet to conduct a public hearing on the request of the Police Regional Office 6 (PRO6) for a signal shutdown during the highlights of the festival.

lawyer Sedfrey Cabaluna, advanced state of distress in an interview, said the PNP requiring immediate has to present a compelling reason to convince the council, otherwise, they remain firm on their previous position not to support the signal shutdown.

"We want to listen to the regional office why they are pushing for this despite the earlier pronouncement of the city," he said.

Cabaluna said he hoped to have the matter tackled in their regular session on Jan. 24.

He said personally, he is not in favor of the shutdown given the experience last year when even neighboring municipalities and parts of Guimaras complained of no signal.

"I understand when we say shutdown, the whole jurisdiction of the city and the neighboring towns (is affected). It has an effect on our tourism, on our economy," he said. (with report from PNA)

Implementation of search warrant leads to arrest for firearms violation in Antique

IN a decisive operation against criminality, Tobias Fornier Municipal Police Station executed Search Warrant Nr 04-2024-EJ at Sitio Katsila, BrgyIgbalogo, Tobias Fornier, Antique. This operation resulted in the apprehension of Alias "Leonardo," a 45-year-old married farmer and resident of Brgy. Igbalogo.

The Search Warrant, issued by Hon. Ernesto L Abijay Jr, Presiding Judge, RTC Branch 10, San Jose, Antique, on January 16, 2024, was executed in strict adherence to Republic Act 10591. From Alias "Leonardo's" possession and control, the police confiscated one (1) unit of a .22 caliber revolver, devoid of ammunition.

The arrested individual is currently in the custody of Tobias Fornier MPS as legal proceedings unfold for proper disposition.

Cebu Pacific Debuts First Flight Under **Bulgaria Air Damp Lease**

CEBU Pacific (PSE: CEB), the Philippines' leading carrier, started operating on January 14 the A320ceo aircraft it acquired under its damp lease agreement with Bulgaria Air, further boosting the airline's capacity to meet the increasing demand for air travel.

million 2-storey-8 classroom of Fort San Pedro National High School; and P4.9 million repair of classrooms of S. Abeto Elem School in Arevalo.

Aside from school buildings and facilities, last year's accomplishment of the city government included the completion of 2-storey building with complete basic facilities in Barangay Dungon A, Jaro amounting to almost P5 million. This was sourced from the Local Government Support Fund – Support to the Barangay Development Program (LGSF-SBDP).

"We have also rehabilitated our public plazas and open spaces. We are also improving our public markets. Army's 3ID renews commitment to make Negros Island insurgency-free

Iloilo City Mayor Jerry Treñas, in a separate press conference, said he would talk to Villaflor about the



Top 3 and Top 4 Most Wanted Person of Malay Aklan **Apprehended for Murder**

The Malay Municipal Police Station (MPS) achieved remarkable success with the apprehension of two (2) individuals listed in the Most Wanted Persons (MWPs) at the Municipal Level for the crime of MURDER.

Border checkpoints in Antique curb spread of ASF

SAN JOSE DE BUENAVISTA, Antique - Border checkpoints in Antique effectively curbed the further spread of African swine fever (ASF) in the province.

Antique does not have a record of the animal disease spreading to adjacent towns of Hamtic, San Jose de Buenavista, Sibalom, and Belison, all in the southern

part of the province.

The last confirmed case in Antique was in Belison in November last year.

Dr. Marco Rafael Ardamil, chief of the Antique Provincial Veterinarian Office (PVO) Public Health Division, said Tuesday their checkpoints in Hamtic and Anini-y in the south and Pandan and Libertad in the north side continue.

ASF-free municipalities also established intertown checkpoints.

Antique Provincial Veterinary Office (PVO) Extension and Regulatory Division Chief Luela Furio said in an interview Tuesday that their checkpoints confiscated about PHP350,000 worth of pork and pork by-products transported to Antique from

ICPO Enforces 10-Day Gun Ban for Dinagyang Festival 2024

ILOILO CITY- In a bid to safeguard the well-being of all participants, the Iloilo City Police Office (ICPO) will implement a 10-day gun ban during the Dinagyang Festival.

Starting from 12:01 AM on January 19, 2024 until 12:01AM on January 29, 2024, the Gun Ban, mandated by the Chief PNP, Police General Benjamin C Acorda Jr, suspends the Permit to Transport and Carry Firearms Outside Residence (PTCFOR) throughout Iloilo City.

During this period, only authorized personnel from PNP, AFP, and other Law Enforcement Agencies (LEAs), engaged in official duties and attired in agency-prescribed uniforms, are permitted to carry firearms. Moreover, the

of the shutdown last year when there was no signal even in neighboring municipalities.

"I think Iloilo has been safe. Among the cities in the Philippines and the cities and LGUs in Western Visayas, I think Iloilo was the only one declared insurgency-free by both the police and the Army," Treñas said.

In the meantime, Villaflor turned over 2,417 reflectorized raincoats and 2,000 whistles worth PHP2.64 million to various police stations in the region following Monday's flag-raising ceremony at the PRO-6 headquarters here.

Each police station received 18 general purpose raincoats, except for the Malay Municipal Police Station which got 40 and the Regional Mobile Force Battalion headquarters and its line companies with 10 each. (PNA)

El Niño challenge

The El Niño phenomenon, the climate pattern that refers to the unusual warming of surface waters in the eastern equatorial Pacific Ocean, is in effect in the Philippines.

Geophysical, and Astronomical Services Administration, which provides weather forecasts and tropical cyclone warnings, flood bulletins and advisories, hydrological, and climatological farm forecasts, has said El Niño may take place until May and transition to El Niño Southern Oscillation-neutral until June.

North of Manila, the public has been advised to conserve water since the dry spell already affecting several provinces of the Cordillera Administrative Region is expected to last until April.

The region's El Niño Task Force said Abra, Ifugao, and Mountain Province are already in a dry spell while Benguet, Kalinga and Apayao are expected to experience drought later this month.

A dry spell means below-normal rainfall conditions for three consecutive months while drought is characterized by a rainfall condition below normal for five consecutive months or the reduction in the rainfall is about 41 to 80 percent compared to the normal rainfall data of a particular month.

Weather authorities noted while parts of the region PAGASA, or the Philippine Atmospheric, are in a drought condition, the high elevation of the region adds to the effects of the northeast monsoon, which gives a colder temperature in several towns and provinces.

> Baguio City recorded the lowest temperature of 14.6 degrees Celsius around 5 a.m. on Jan. 11.

> Because of the dry spell, the El Niño Task Force has advised the public as well as the farmers to conserve and reuse water.

> The task force also suggested several measures to address the situation and these include the installation of rainwater harvester.

> The WMO's new secretary-general Celeste Saulo warned El Nino, which emerged mid-2023, is likely to turn up the heat even further in 2024.

> The naturally-occurring climate pattern, typically associated with increased heat worldwide, usually increases global temperatures in the year after it develops.

The 2015 Paris climate accords aimed to limit global warming to well below two degrees Celsius above pre-industrial levels — and 1.5C if possible.

The Geneva-based World meteorological Organization said the 2023 annual average global temperature was 1.45 degrees Celsius above preindustrial levels (1850-1900) — though one of the six datasets it relies on, the non-profit research organization Berkeley Earth, placed the figure as high as 1.54C.

The WMO's new secretary-general Celeste Saulo warned that El Nino, which emerged mid-2023, is likely to turn up the heat even further in 2024.

The Washington, DC-based National Oceanic and Atmospheric Administration said the 2023 global surface temperature was 1.18C above the 20th-century average, and was hotter than the next warmest year, 2016, by a record-setting margin of 0.15C.

In the Philippines, you know that the long Christmas season has begun when you hear and see the signs of the said season. Christmas carols, bells, Christmas trees and other decorations begin to assault your senses when September comes. In this country, there is another season which is even longer than Christmas.

This month, we have already seen several 2025 midterm election senatorial preference survey results circulating in our news feeds. Each survey has different results and analysis which is now being actively discussed by thousands of netizens. In opinion columns and shows, political commentaries have now increased. Subtle public relation pieces for or against potential candidates such as stories and features are now popping up everywhere. There are also a growing number of posters being put up with greetings for every occasion or event imaginable by everyone thinking of running in the elections. All of these things clearly show that election season has already begun.

In keeping with the season, the government institution charged with holding elections has also been hard at work preparing for the said event. Despite initial hiccups, the Commission on Elections (Comelec) is now in the process of choosing, through public bidding, the new automated elections system that will be used in the coming 2025 elections.

All the players and stakeholders in the midterm elections are now beginning to make their initial moves. With barely sixteen months left before the May 2025 midterm elections, anyone planning to participate in the said elections need to begin preparations as early as possible. You need to finalize your plans, make your message, hire your political strategist and begin your journey today. The starting point for any electoral plans is always the election baseline survey.

A baseline survey, in general, is a research or study conducted to assess the situation prior to or at the start of a project. A baseline survey for election purposes measures several important factors needed in preparing for a campaign.

First, an election baseline survey can measure a potential candidate's awareness level in the voting

population. Do people even know the potential candidate exists? Does his/her name even ring a bell? Second, an election baseline survey can measure the potential candidate's acceptability as a candidate and corollary to that it can also measure preference levels. This is the crucial first step in any campaign. If you are a potential candidate, commission a survey NOW.

Sixteen months may seem like a long time but it is not. There is a Japanese concept known as Mottainai. Literally, it means "what a waste". Today, the said concept is also understood to mean "we should not waste time! "Time is the one political resource that cannot be added to any campaign". You can add more manpower, funding, logistics, and exposure but your campaign time is limited.

In any endeavors or undertaking you want to do, you really need to start today.

This is my oblique observation.

Government assistance to middle-income families

The news caught my attention at the start of the new year. This is the continuation of DSWD's Assistance to Individuals in Crisis Situations (AICS). The DSWD has halted the issuance of guarantee letters (GLs) under the AICS program since Dec. 7 last year. It resumed issuing GLs at the onset of January. GLs are issued to a person in crisis to guarantee the services of a service provider, such as a hospital. The DSWD will reimburse the service provider for the services rendered to the person issued with a GL. The AICS is considering the needs of poor Filipinos during emergencies, such as death and health, among others.

What is striking about the news, however, is that the AICS now includes middle-income earners. To avail of government assistance from DSWD or from local government units, one must present a certificate of indigency from the barangay. With the inclusion of middle-income earners in the DSWD assistance program, I guess there is no need for the certificate.

What is the reason for the inclusion of middleincome earners? According to DSWD Assistant Secretary Irene Dumlao, even if a family has resources, they can still experience crises.

Middle-income and middle-class families are classified according to income. According to the Philippine Institute for Development Studies (PIDS), a lower middle class has a monthly income between PHP21,194 and PHP43,828, a middle class between PHP43,828 and PHP76,669, an upper middle income between PHP76,669 and PHP131,484, and a highincome (but not rich) class between PHP131,484 and PHP219,140. You are considered rich if your monthly income is at least PHP219,140 and up.

I have been contemplating even before that it is unfair for middle-income families not to be included in government financial assistance considering that they regularly pay their taxes, especially the employees, who are automatically deducted from their income taxes. By prioritizing indigents, middle-income employees are marginalized from government services.

All levels of the middle class are affected by crises, though at different levels. The most vulnerable are the lower middle class since their resources are enough for their daily needs. An emergency sickness of a family member can pull their resources together to respond to such a crisis, leaving them in debt.

The inclusion of middle-income earners in AICS is a recognition of their vulnerability and a call for the government to address their welfare. AICS assistance includes medical, funeral, educational, transportation, food, and even cash. Beneficiaries can access medical and funeral assistance from various government institutions, including local government units (LGUs). Medical bills pile up if a loved one is committed to a hospital. While DSWD can issue GLs, the family is left to spend on medicines, which are exorbitant, especially for fatal diseases, such as cancer and kidney problems, among others.

The middle class was also affected by the pandemic. Companies depleted their meager savings immediately by closing their operations due to the lockdowns. I remember when only the poor were given "ayuda" by local and national governments. However, the middle class was later included as the lockdowns dragged on for several months, then years. Cash assistance was also provided to employees through the Social Security System (SSS). The Social Security System (SSS) also provided cash assistance of PHP10,000 each to returning overseas Filipino workers (OFWs).

According to the Philippine Statistics Authority (PSA), three out of 20 households belong to the middle-class population, and two-thirds reside in urban areas. When you reside in urban areas, the standard of living is quite high compared to those living in rural

In November last year, a World Bank official said that the Philippines is projected to become an uppermiddle-income economy by 2025 or 2026. Since 1987, the country has been classified as a lower middle-

income country with a gross national income (GNI) per capita of USD3,950.

The forecast of the World Bank is in line with the PBBM administration's target for the Philippines to reach upper middle-income status by 2025. If the government achieves that target, that means a GNI per capita income of USD4,466 to USD13,845 for the country. Achieving this target may be ambitious for the administration, but it is necessary to ensure the development of the country. According to the World Bank, development is not just about the income of a country's citizens. It also includes improving access to clean water and sanitation, lowering the stunting rate, and reducing poverty.

I think what is primary here is the provision of employment for Filipinos and the increase in wages and benefits. Definitely, the minimum wage of PHP610 in Metro Manila is not enough for a family of five. Increases in the prices of prime commodities have further weakened the buying power of the peso. We are not discounting, however, the desire of many Filipinos to work abroad, where salaries are much better. After the pandemic, there is again an increase in OFW deployment as economies have opened. This is side by side with the efforts of the Department of Migrant Workers (DMW) to simplify the processing of papers that cause bottlenecks in OFW deployment.

It is interesting to note from the study conducted by PIDS that OFWs predominantly belong to the middleincome category. There are also those that belong to upper-middle-income households. These may be professionals, such as engineers, architects, doctors, ship captains, and managers who sought greener pastures abroad. The desire to survive the family and provide a bright future for the children remains the driving force behind why Filipinos work abroad.

With an estimated 96.4 percent or around 50 million Filipinos employed as of November, the country's employment rate is also at its highest since 2005, according to the PSA.



Ex-rebels, farmers in Negros learn to make crafts for livelihood

Former New People's Army rebels and farmers in the remote village of Isabela, Negros Occidental are making craft products for livelihood through training facilitated by the Association of Negros Producers (ANP), the organizer of the renowned Negros Trade Fair.

Since last month, about 100 of them, all from Barangay Riverside, have attended the product development and basic marketing workshop hosted by the Philippine Army's 62nd Infantry Battalion at its headquarters in Barangay Libas.

"The aim is to equip them with skills to create marketable products and participate in prestigious industry showcases," Sybel Nobleza, ANP external affairs manager, said in a statement on Tuesday.

The participants learned about crafting products from locally abundant raw materials such as pandan, start-up capital, consistent (PNA)

BACOLOD CITY nito, bamboo and used straws.

> Pandan weavers have to present prototypes of their designs of eco-pandan bags for target customers such as wine producers, millennials and eco-friendly stores by the second week of January.

They learned to produce prototypes after they were introduced to product development and branding by Christina Marie Gaston, an international designer and chairwoman of ANP, who shared the journey of her brand, the Hacienda Crafts Company.

Nobleza, who discussed product screening and basic marketing, guided the participants on aligning products with customer needs and ensuring a compelling narrative behind each creation.

Acknowledging the challenges, she emphasized solutions such as securing

market access, and protecting identities for former rebelsturned-entrepreneurs.

Nobleza said they plan to introduce the product prototypes to the Pilak Awards Competition in preparation for the 38th Negros Trade Fair later this year.

In a statement, one of the participants, Nanay Adelfa, a 78-year-old weaver, said she is thankful for the opportunity to become an entrepreneur through the training workshops conducted by the ANP in partnership with the Negros Occidental provincial government and the Isabela municipal government.

"The ANP commits to closely monitor the product prototyping and organize further workshops," Nobleza

Hoilo City Hall goes green, adopts solar power

ILOILO CITY - The city government has tapped solar power to supply at least one-third of its around 200 kilowatts daily demand.

Iloilo City Mayor Jerry Treñas on Monday said the use of solar power could help lessen the city government's expenses on electricity.

The local government also intends to apply for the net metering program with the More Electric and Power Corporation (MORE Power) for the excess supply, especially Sundays.

The installation of the 134 solar panels was completed over the weekend and will already start operations within the week.

"This will be a big help in terms of consumption and at the same time, we will be doing green projects in the city," said engineer James Macairang of the City Engineer's Office during a site tour of the project on Monday.

The city government stands to save around

on Saturdays and PHP96,000 every month, not to mention the result of the net metering.

> Treñas said solar power will be also installed at the legislative building upon completion of the project.

The city government's two dialysis centers and the Esplanade currently are utilizing solar energy.

He said more public schools in the city will be adopting the use of solar power. The city's biggest national high school is already using solar. (PNA)
