Ordinance to protect cultural properties in Antique

BUENAVISTA, Antique – A proposed ordinance aimed to protect and conserve cultural properties, historical landmarks, monuments and shrines in Antique passed the scrutiny of the provincial board on Monday.

"The Province of Antique, known for its rich cultural and historical heritage and having been blessed with the number of cultural, religious, and tourist sites, wanted to ensure their protection and conservation," said board member Egidio Elio, Calixto Zaldivar.

> Elio said six structures in the province bear the historical marking of the National Historical Commission of the Philippines (NHCP), including the Leandro Fullon Shrine, Evelio B. Javier Monument, Balay na Bato, Old church and convent in Patnongon, Hantique Igcabuhi, and the bust of former Chief Justice

the provincial board also declared other structures 50 years old and above as cultural properties.

Any proposed construction, renovation retrofitting, or demolition activities that may affect the integrity of historical and cultural sites or any adjoining historical or cultural sites need consultation with the NHCP as provided for in Department of Public Works and Highways (DPWH) Order 12, series of 2019.

Through an ordinance, order, the provincial board, through the ordinance, prohibits demolition or damage of any local cultural properties, any awkward or disrespectful gestures, modifications and alteration of NHCP-marked historical edifices without permission by the national commission.

Any demolition or acts for other cultural properties without the NHCP should seek permission from the Antique Provincial Council on History and Cultural Heritage. (PNA)

ILONGGOS, VISITORS ENJOY REDEVELOPED PLAZAS

The Iloilo City Government has successfully restored the once-deteriorating district plazas, where people are now enjoying the open spaces as they relax, bond, and hold get-together activities.

Tourists love it, too, as must-try Ilonggo foods such as La Paz Batchoy and Pancit Molo and native coffee are just around the corner, waiting to be a gastronomic treat.

The plazas are now attracting crowds, particularly from late afternoon to late evening, as they have become a favorite hangout place for both locals and visitors alike.

Statues of Ilonggo heroes and history icons were also installed to instill a sense of pride and for the young generation to know the city's rich heritage.

Landscaping and lighting, as well as speakers and a fountain, were set up to create a laidback yet modern

International lifestyle designer PJ Arañador, in his Facebook post, said the plaza restoration project was a result of taxes well spent.

"I don't mind paying taxes to a city, like Iloilo, that uses our money properly and innovatively, not only on social and environmental considerations but also in wellness and well-being," Arañador stated.

"Health to citizens in Iloilo means... benches to read a book, trees to take refuge underneath, and plazas to walk on or dance the day. I walk at Jaro Plaza at least three to four times a day. It means a slimmer tummy and a longer life for me and the rest of the residents. Most of all, share happiness with all Ilonggos," he added.

Jaro Plaza is well-designed with great flat pavements, ample seats, classical pipe in music, giant tree canopies, picturesque and informative, clean and green, Arañador said, adding, "I only wish it would have a people's amphitheater, too."

He suggested that developments should consider becoming "people-centered" amid a busy life.

"Jaro Plaza allows me to walk and get my morning sun at least three times a week. Urban planning is not at all about skyscrapers or roads. It must include amenities that sustain



ILOILO CITY - Senior citizens were among the first in line here as voters' registration for next year's midterm elections started on Monday.

In an interview on Tuesday, Comelec-Iloilo City Assistant Officer II Jonathan Sayno said they catered to 236 applicants during the first day, 47 of whom were elderly.

"Mostly are senior citizens who are 90 or 80 years old. Their intention is not really to cast votes but to avail of benefits from the city government provided under the Ilonggo Centenarian Ordinance," he said.

Under the ordinance, senior citizens are eligible to receive PHP10,000 and PHP20,000 once they reach the age of 80 years and 90 years old, respectively.

One of the requirements to avail of the incentive is for them to be a registered voter of Iloilo City.

Meanwhile, Sayno said the Register Anywhere Program (RAP) is already available at their office on the second floor of the Angeles Arcade in De Leon-Mabini Streets in the city

"It goes together with our regular registration. In the meantime, we accept registrants here at our Comelec office while we are waiting for the final schedule of our satellite registration targeting big universities, malls, and barangays," he said.

Seven of those who registered on Monday availed of the RAP.

Sayno emphasized that the registration until Sept. 30 this year is only for regular voters.

Sangguniang Kabataan voters are not included because it will not be an SK election.

Those who cast votes in the October 2023 SK elections and would turn 18 on or before the May 12, 2025 midterm polls need not register because Comelec will automatically migrate their records to the database of regular voters.

Sayno said they target to register between 8,000 and 12,000 individuals.

Among the expected registrants are those who failed to register during the previous village election and transferees.

Iloilo City has 330,470 qualified voters as of the 2022 regular elections.

Iloilo City doubles garbage fee rate

ILOILO CITY-Garbage fees in this city have increased by 100 percent to cover the expenditures of the local government, which has been subsidizing over 80 percent of solid waste management expenses.

Engineer Neil Ravena, head of the General Services Office (GSO), said that with the adjusted rate effective January, the city government will not bear the burden of paying for the salary of street sweepers, payment for garbage collection and

United States Agency for **International Development** (USAID) on the cost-ofservice analysis (COSA) showed that in 2022, the city government collected PHP55.92 million but spent over PHP365.65 million on solid waste management, showing that 84 percent of the cost was subsidized.



Bacolod City logs over 1-K new business permit applications

BACOLOD CITY-This city government received business permit applications from around 1,100 new business establishments at the beginning of 2024.

Data as of Tuesday showed that the number is part of the 18,839 business permit applications received in January alone by the Business Permits and Licensing Office through the Business-One-Stop-Shop at the Ayala Mallss Capitol Central.

Mayor Alfredo Benitez said in an interview that last month's total was 11 percent higher than the 16,994 applications recorded in January 2023.

"As you can see, there is an influx of business establishments coming into the city. I hope that is because of the confidence in our business environment," he added.

In January this year, the city government collected PHP467.201 million in business taxes, higher by 18.4 percent compared to the PHP394.627 million generated in January 2023.

"January 2023 was already a record month. It was beyond the 2019 prepandemic level. We are way ahead," Benitez said.

The mayor reiterated the city government's campaign to ensure that all business establishments comply with the required permit after the City Legal Office (CLO) discovered during a recent mapping operation in the downtown area that only 10 of the 67 businesses in three buildings have permits to operate.

Last week, the CLO also apprehended a person who produces fake business permits.

In an earlier executive order, Benitez reconstituted the joint inspection team to conduct a "comprehensive mapping of all businesses in the city and document all the procedures for effective data banking.'

The order also directed the joint inspection team to "monitor and implement adherence of businesses to regulatory requirements set by the city on business operations."(PNA)

Bacolod City hikes wage of job order workers

BACOLOD CITY -More than 3,800 job order (JO) workers of this city government started receiving higher wages in January this year.

The current rate is PHP480 daily or PHP10,560 for 22 days per month, from the previous PHP450 per day or PHP9,900 monthly.

In a press conference

on Monday, Mayor Alfredo Abelardo Benitez said the upward adjustment conforms to the daily minimum wage rate in Western Visayas (Region 6).

"We adhered to the wage order. All JO workers are now receiving PHP480 per day. I checked the payment of wages in the first week of February; 70 to 80 percent have already been paid for January. The remaining workers should be fully paid by today or tomorrow," he said.

In October last year, the Regional Tripartite Wages and Productivity Board-6 granted a PHP30 daily minimum wage increase across all sectors.

The daily pay is PHP480 for non-agriculture establishments with more than 10 workers, PHP450 for non-agriculture establishments with 10 workers or less, and PHP440 for workers in agriculture.

To amp up EV training, TESDA gains insights from Malaysian auto giant

Top officials of the Technical Education and Skills Development Authority (TESDA) visited the facilities of a Malaysian automotive giant as part of their benchmarking activities in a bid to support the current administration's direction of improving the electric vehicle (EV) industry in the Philippines.

On the company's invitation, Secretary Suharto T. Mangudadatu and other TESDA executives toured the Bermaz Auto Berhad Head Office in Selangor, Malaysia, and received insights into the skills training best practices employed by Malaysia's prominent electric vehicle player.

During the visit last February 5, Bermaz showed the agency's top officials their production and training facilities, and shared their experiences in identifying the market, supply and demand as well as their contributions to the creation of an EV roadmap in Malaysia.

The TESDA Chief expressed interest in learning about the latest developments in the EV industry, specifically in setting up training facilities for the production and servicing of electric vehicles, including its operational protocols and equipment requirements.

"By benchmarking our training programs and curricula against international standards, we can ensure that our workforce meets the demands of the rapidly evolving electric mobility sector in the Philippines," the TESDA Chief said.

"This activity will also enable us to make necessary adjustments and tailor our training programs to the specific needs of the EV industry, ensuring that our graduates possess the skills required to succeed in this field," he added.

With a keen focus on advancing the skills of the local workforce, TESDA also sought knowledge exchange on the development of necessary skills policies that can contribute to ensuring workforce readiness and global competitiveness in the face of the Fourth Industrial Revolution (4IR).

Secretary Mangudadatu personally thanked Bermaz Auto Berhad for generously sharing their knowledge and expertise in the EV industry to the agency.

"We thank Bermaz for their kind support to TESDA as we embark on bolstering the growing EV sector in the Philippines. This is definitely beneficial in ensuring that our training programs are not only current, but also in line with emerging technologies and trends," the TESDA Chief

Secretary Mangudadatu also noted that e-vehicles offer cleaner and more efficient alternatives to traditional internal combustion engine vehicles, reducing harmful emissions and dependence on finite fossil fuels.

"Over the years, we have relied mainly on fossil fuels for our transportation. This does not only contribute to environmental degradation but also poses health risks to our citizens due to air pollution. However, amidst these challenges lies an

As per record, since coordination with the City August 2019 to December Agriculturist's Office. 2023, through the city's Program, around 30,776 trees mostly native species have already been planted all over the city with seedlings provided by the Caingin Tree Nursery.

Dayrit noted the figure does not include those tree seedlings distributed to groups, individuals, offices, and schools for their respective tree planting activities.

So far, some of the city areas planted with trees and being maintained are the esplanades; circumferential and coastal roads; General Luna to MH Del Pilar; Fort San Pedro: Calle Real (plant boxes); Hinactacan in La Paz; and other open spaces.

The city also maintains eight pocket forests along the city's flood ways.

According to Dayrit, they also target to distribute fruit-bearing trees to 40 city barangays, in

Getting to Know CRVS

The month of February has been designated as the Civil Registration Month pursuant to Presidential Proclamation No. 682 during the time of President Corazon Aquino. The celebration reminds every Filipino to have vital events in their lives to be registered in their respective civil registry offices as mandated under our civil registration law.

At the outset, it is imperative to refresh our minds with some of the basic precepts of civil registration and vital statistics or CRVS.

Civil registration is the recording in the appropriate civil registry office, vital acts and events that affect the civil status of individuals. Vital acts and events are the births, deaths, fetal deaths, marriages, and all such events that have something to do with an individual's entrance and departure from life together with the changes in civil status that may happen to a person during

his lifetime. Changes out, enforce and administer her certificate of live birth, need of a judicial order. In in the civil status of a person may be brought by marriage or its dissolution, legitimation, adoption, etc. Vital statistics are the statistics gathered relating to these vital acts and

Our civil registration system was established in 1930 by virtue of Act No. 3753 or the Civil Registration Law. Republic Act No. 7160 or the Local Government Code of 1991 formally established the City and Municipal Civil Registrars to directly carry the function of civil registration in their respective locality. Republic Act 10625 otherwise known as the Philippine Statistical Act of 2013 introduced the reorganization of our statistical system and merged the major statistical agencies including the National Statistics Office (NSO) into the present Philippine Statistics Authority (PSA). The PSA now serves as the central statistical authority of the government and one of its functions is to carry

civil registration in the country as provided for in Act 3753. The National Statistician is the head of the agency and at the same time act as the Civil Registrar General whose office oversee the implementation of civil registry laws and exercise technical supervision over all local civil registrars.

Civil registration is fundamental in the life of every citizen as it brings back multiple benefits. Civil registry documents such as birth, marriage and death certificates are the most reliable sources in establishing one's identity, civil status and family relations, not to mention the right of the child to be registered after birth and to have a name and nationality as contained in the UN Convention on the Rights of the Child. They are necessary in the availment of health, education and other public services. A certificate of live birth, for instance, is a mandatory requirement in school enrollment and in getting a learner's reference number. One needs to submit his or Death certificate is a prerequisite in processing a deceased person's insurance claim. Nearly all kinds of employment require the presentation of these civil registry documents.

On the other hand, the statistics derived from civil registry records provide our government an important demographic information that is essential in planning and policy-making. It equally aids the department monitor and ensure that development programs are truly responding to the social, economic, health and educational needs of the people they particularly serve.

Improvement of civil registration services in the country has gotten underway. The passage of Republic Act No. 9048 has given the city/municipal civil registrar or the consul general authority to correct a clerical error or typographical error in an entry and/or change the first name or nickname in the civil register without

marriage certificate or both, addition, Republic Act No. in order to get a passport. 10172 authorized the city or municipal registrar or the consul general to correct clerical or typographical errors in the day and month in the date of birth or sex of a person appearing in the civil register without undergoing judicial process. The use of surname of the father by an illegitimate child under RA 9255 can now be processed in the local civil registry office along with legitimation by subsequent marriage.

The local civil registry offices have long been embarking on various programs such as mobile registration in remote areas, mass weddings and other civil registration activities. The Barangay Civil Registration System (BCRS) is now in place in some LGUs.

Being the agency mandated by law to keep and preserve the birth, marriage and death records of every citizen, the PSA offers a variety of services through its regional and provincial offices. Its computerization project or the CRS-IT established

various Serbilis outlets nationwide to conveniently serve the requesting public. The Batch Request System (BREQS) which authorizes a partner to receive request for certificates from the public has effectively eased the long lines in physical outlets. Anyone can now request for his or her birth certificate in the local civil registry office where he or she resides as LGUs were already BREQS users. Through its Serbilis and Helpline services, requests for copies of civil registry certificates are likewise available online with door-to-door delivery service.

This year, we are celebrating the 34th Civil Registration Month with the theme, "CRVS: The Future of Seamless Services". The importance of civil registration cannot be overemphasized. Achievement of the essential goals of our social and economic development are heavily dependent on our civil registration system. A strong and efficient CRVS would lead us forward.

SAN JOSE DE BUENAVISTA, Antique -The provincial engineer of Antique is urging the National Historical Commission of the Philippines (NHCP) to lift the cease and desist order (CDO) issued on the rehabilitation of the President Diosdado Macapagal District Hospital in Tobias Fornier town for the project to proceed.

Engr. Inocencio Dajao Jr. said, with the assistance of the provincial legal office, they sent the proposed development plan of the hospital to the NHCP on Dec. 10066, as amended by RA 5, 2023, but they have not received a response.

The PHP15 million project seeks to upgrade the hospital to a 25-bed capacity from its existing 15-bed capacity.

"I am just hoping that how quickly we had responded to the NHCP letter, that would also be how fast they would respond to us," Dajao said in an interview on Tuesday.

Dajao said they immediately halted repair work that was about 60 percent to 80 percent completed following the issuance of the CDO signed by NHCP chairman Dr. Emmanuel Franco Calairo on Sept. 6, 2023.

The CDO cited that the 56-year-old hospital, an important cultural property, is protected from any modification or renovation based on Republic Act (RA) 11961 or the National Cultural Heritage Act of 2009; hence, the project needs clearance from the commission.

"Before the CDO was issued, we had already started construction of the sewage treatment plant, firewall, and repair of the wards as well as the existing hospital building," Dajao said.

Impact of dry spell in Antique won't affect food sufficiency

SAN JOSE DE BUENAVISTA, Antique The effect of the El Niño phenomenon on rice and corn crops in Antique will not affect the food sufficiency of the province since it is mild and negligible, according to the Office of the Provincial Agriculture (OPA).

OPA chief Nicolasito Calawag said eight municipalities, the majority in the southern part of Antique, initially reported damage in rice crops covering 1,762.57 hectares with losses estimated at PHP92.9 million as of Feb. 8, 2024.

damages could not affect food sufficiency since the area planted with standing

rice crops reached 3,249.3 hectares.

"There is still intermittent rain in the northern towns of Antique where we could have harvest rice and corn," he said.

"Farmers in municipalities where there's still water are also using quick turnaround rice varieties, so rice is harvested in a shorter time," Calawag said.

Those reported damage included Hamtic, Anini-y, Tobias Fornier, San Jose de Buenavista, Sibalom, San Remigio, Patnongon, and Valderrama.

For corn, the municipalities Calawag said the of Barbaza, Hamtic, Patnongon, Valderrama, San Jose de Buenavista, Sibalom, and San Remigio reported

that 327.855 of the total 403.8 hectares of standing crops are affected, with losses estimated at PHP15.7 million.

Calawag said farmers who could not plant rice due to the lack of water resorted to planting vegetables and other drought-resilient crops that could caution against the impact of El Niño.

"Some farmers have also opted to rest their farmlands by not planting any crop during the El Niño," he said.

He said that DA is also providing farmers with seeds for replanting.

Meanwhile, Calawag said they already contained rice black bug (RBB) infestation in Patnongon and Valderrama.

"The infestation covered

only around two hectares of the rice land in Patnongon and Valderrama," he said.

He said the immediate application of biocontrol agents following the fast detection by the Barangay Peste Brigade of the two municipalities in coordination with agricultural technicians from the Regional Field Office 6 (Western Visayas) of the Department of Agriculture helped curb the spread.

Calawag also urged other farmers to immediately coordinate with their respective Barangay Peste Brigade and Municipal Agriculture Officers if they are suspicious of infestation for immediate application of control measures. (PNA)

The Department of Foreign Affairs has resorted to an ingenious way to catch those suspected of having fraudulently acquired Philippine passports by presenting genuine birth certificates from the Philippine Statistics Authority and government- with law enforcement agencies, such as the issued identification cards.

How? By asking them trivia questions from local show business.

The DFA Office of Consular Affairs says since some of the suspected impostors can speak Filipino, their front-liners have devised their own methods to find out whether applicants are really Filipino as their documents claim.

They ask those foreigners applying for new passports or renewing expired ones such questions as "Who is the Superstar's love team partner?" "Name one of the Megastar's songs." "Who is the Star for All Seasons?"

These questions, the DFA said, are not likely to

How do you detect foreign nationals, said to be be answered at all by those suspected of having obtained fraudulent documents.

> Foreign nationals posing as Filipinos manage to get genuine PSA birth certificates because they can file for late registration of birth at the local civil registrar's office.

> The DFA has therefore begun to actively engage Bureau of Immigration and the National Bureau of Investigation, to file criminal charges against the foreigners.

> The DFA is on the right track in plugging the cracks in the system so that they can keep the situation from going from bad to worse.

> The DFA believes, for instance, that it must be very expensive for foreigners to acquire genuine documents from PSA. Something fishy is going on in that agency that needs decisive action from the proper authorities.

> At the main DFA consular office in Parañaque City, reports said, at least 58 Chinese nationals have been prevented from acquiring Philippine passports.

Several other consular offices around the country have reported similar attempts.

The recently convened Inter-Agency Committee on Passport Irregularities is investigating around 12 Philippine passport holders who are obviously foreigners.

Foreign nationals caught applying for Philippine passports have been blacklisted in the DFA database through their biometric information and can no longer apply in any consular office.

This is a correct response to what's obviously an underhanded attempt to go around the rules.

Under Republic Act 8239, or the Philippine Passport Act of 1996, the penalty for making false statements in the passport application is imprisonment of between three years and 10 years, and a fine of between P15,000 and P60,000.

This law should be implemented to the letter. (manilastandard)

The Traffic Czar: One office to rule them all

"Try to think of new ways to solve old problems." – Steve Wozniak

There is a renewed call by a business group for the creation of an office or position of a traffic czar. One office that will exist solely to study and know the problems causing traffic. One office that will bring all related agencies together and in shared knowledge and direction bind them. One office to rule them all.

A few days ago, the Management Association of the Philippines, led by its president Rene Almendras, created a stir when it declared that a traffic crisis exists in metro Manila and that a traffic czar is needed to implement a holistic plan to solve the said crisis. This was immediately countered by an official of the Metropolitan Manila Development Authority (MMDA) who stated that there is no need for a traffic czar.

The concept of appointing a single man to solve a community's problem is not an easy thing to sell. People and Filipinos, in general, seem to have an inherent aversion to mandated centralized control in anything. There seems to be a gut instinct common to many to resist giving a single office or person the needed power and authority to run roughshod over all traffic obstacles.

At present, our government has already tried coordinating agencies with different mandates through the Inter-Agency Council for Traffic (I-ACT), which uses cooperation as its key tool in finding and solving traffic problems. Is it time to truly try centralized traffic control under a very high-ranking official who would have the power and authority to compel various agencies to implement traffic measures? What kind of individual would even qualify to hold such a difficult post?

In the United States, there was a famous traffic engineer and commissioner named Henry A. Barnes who served in several cities including Baltimore, Denver, and New York. Given vast powers and authority, he was able to implement many innovations in traffic engineering, which are now commonplace, such as synchronized traffic signals, dedicated bus lanes, well-planned street expansions, and the famous Barnes dance, which is the precursor of the Shibuya Scramble in Tokyo. Barnes was known as a tough no-nonsense official who often had to push through various roadblocks to his innovations. He was not loved by everyone but in general, he got the job done.

Former Transportation undersecretary and MMDA chairman and traffic expert Thomas Orbos stated

in his opinion column that a traffic czar needs to be appointed by President Ferdinand R. Marcos Jr. himself to give him the gravitas to loop in all the related agencies and the Philippine National Police into a single program. Other than having the needed authority, Orbos insists that the traffic czar must have a specific skill set that includes having the abilities and qualities of a manager, coordinator, enforcer, communicator, politician, and innovator with at least a basic working knowledge of traffic engineering, urban planning, and logistics.

Former vice president Noli de Castro, in his show, had a simpler criterion. The traffic czar, he said, should not be a lawyer.

Clearly, the idea of appointing a traffic czar is both controversial and difficult to implement. Unfortunately, we seem to have tried many solutions to solve our perennial traffic problem. Perhaps, it is time to be creative and try something new.

This is my oblique observation.

the health of its residents," he said.

A well-traveled person, Arañador likened to "foreign feels" the new ambiance offered by the park that has been transformed into a feast for senses.

"In Scandinavian and Nordic countries, they embrace a culture called 'hygge' that includes walking every day to go to markets and groceries, etc. It makes them live happier, healthier, and longer. Their cities, like Iloilo City, are walkable. Paz Plaza with P75 million; It makes their residents Arevalo Plaza with P46 calm and well-balanced," Arañador said.

"Jaro Plaza is perhaps on par with Central Park in New York City, where I experienced walking with its ample sun benches, including my favorite Vivaldi's and Tchaikovsky's playing in the background. I walk to Jaro Plaza, which is a stone's throw from

where I live. I think, sleep, eat, and work better with people because I walk. Thanks, Iloilo City. You are adorable," he added.

Mayor Jerry P. Treñas stressed, "We want to make public spaces available to our constituents; they are very important as they give people a place to rethink and recharge."

City Hall has initially funded P257 million for the major makeover of Jaro Plaza with P90 million; La million; Plaza Libertad in City Proper with P30 million; and Mandurriao with P10 million.

Plaza Libertad also got P19 million, and Mandurriao Plaza got P17 million, or a total of P36 million, from the Green, Green, Green Program of the Department of Budget and Management and the

Department of the Interior and Local Government.

Jaro Plaza Bandstand, Belfry, and Lopez Jaena Shrine, as well as Molo Plaza, were funded by the National Historical Commission of the Philippines.

Plaza Libertad has paved the way for an assembly area now being used for Monday's flagraising ceremony and other programs organized by offices.

The plazas' perimeters have been opened for easy access, except for La Paz, which will be installed with a grilled fence to secure the facilities inside.

A retention pond and improved drainage system have made the area floodfree by catching rainwater, which can be utilized for watering plants.

The development of La Paz Plaza has been added, with features including a Koi Lagoon and Butterfly Garden, in partnership with the private sector.

The Liga ng mga Barangay office will be replaced by a community center with a library in front of La Paz Church.

Meanwhile, the gymnasium in Jaro Plaza will be relocated to Alta Tierra Subdivision.

ILOILO CITY – The on Monday. Department of Environment and Natural Resources (DENR) has warned the public against poaching the threatened agarwood tree, commonly known as Lapnisan, considered the highest-valued forest product in the world because of its distinctive fragrance.

"We, at the DENR, environment and balancing our ecosystem will always be our priority. We are here to protect and conserve our flora and fauna, but how can we achieve those if there are individuals patronizing illegal activities," DENR Western Visayas Regional Executive Director Livino Duran said

In a statement, the DENR said the resinous wood is used as incense for medicinal purposes.

Because of its distinctive fragrance, the pure resin in distilled form is used as an essential oil and perfume component.

It said that while propagation is allowed, the collection of seeds directly from the wild is prohibited.

"Secure all necessary permits with any activities concerning our flora and fauna, and seek clarification regarding environmentalrelated endeavors of other concerned stakeholders from the DENR," Duran said.

The DENR, through the Provincial Environment and Natural Resources Office (PENRO) Aklan, apprehended 10 persons in possession of 1.35 kilograms of agarwood with an estimated market value of PHP216,000 in Brgy. Kinalangay Viejo, Malinao, Aklan on Dec. 29 last year.

The Northwest Panay Peninsula Natural Park (NPPNP) rangers also arrested one poacher in possession of 2.630 kilograms of agarwood with an estimated value of PHP1.97 million while they were on overnight foot patrol and wildlife monitoring in the municipality of Nabas also in Aklan on Jan. 17 this year.

Considered as "Wood of the Gods", its Aquilaria malaccensis species is listed as endangered under the National List of Threatened Flora of the DENR-Biodiversity

Management Bureau.

Seven other species are listed as vulnerable based on **DENR** Administrative Order No. 2017-11 or the Updated National List of Threatened Philippine Plants and their Categories.

Generally, agarwood is a threatened plant species in the country and it is mandatory to identify the species to determine the fines and penalties associated with

the violation committed, the DENR said.

The arrested poachers are facing cases for violation of Presidential Decree (PD) 705 or Revised Forestry Code of the Philippines as amended, Republic Act 9147 or Wildlife Resources Conservation and Protection Act, and RA 11038 or the Expanded National Integrated Protected Area Systems (eNIPAS) Act. Victorias City expands initiatives to fight child malnutrition

BACOLOD CITY - organization. The City of Victorias in Negros Occidental is expanding efforts to address malnutrition among children in 15 of the city's 26 barangays through a sustained partnership with the Negrense Volunteers for Change (NVC) Foundation, a Bacolod-based non-profit

Mayor Javier Miguel Benitez and NVC chief executive officer and president Milagros Kilayko signed a memorandum of agreement in a ceremony held at the Victorias City Hall on Monday to seal the new partnership.

Some 61 stunted

children identified during the assembly of the Mingo Nutrition Program last month are the beneficiaries of the NVC's Mingo MingGROW Protocol, a 12-month complementary nutrition program for stunted children ages 6 to 36 months old.

"Through the partnership,

we aim to achieve zero stunted and severely stunted children in Victorias City," Benitez said in a statement on Tuesday.

The World Health Organization defines stunting, which is considered undernutrition, as low height-for-age.

Stunted children have

impaired growth and development due to poor nutrition, repeated infection, and deficient psychosocial stimulation.

The foundation will ensure the daily provision of 16 to 24 ounces of fresh milk per child, prescribe vitamins and minerals during the first month, facilitate home and group visits, and assist in creating family and community gardens for a sustainable food supply.

It will also tap barangay nutrition scholars to lead the peer groups, consisting of the mothers of beneficiaries, who will monitor and record the developments of identified children.

They also signed a memorandum of understanding for planning and the development of the city's nutrition master plan, with Victorias serving as one of the laboratories of NVC to implement the newly designed and tested protocols to eradicate malnutrition.

The Mingo MingGROW Protocol program is the second collaboration between the city government and the NVC, following the supplementary feeding program for 307 undernourished children last year. (PNA)

VENDORS TRAINING, LIVELIHOOD IN PREP FOR MODERN MARKETS

Iloilo City vendors are undergoing trainings related to business operations and market management through the City Government's flagship program Uswag Negosyo Academy (UNA).

Launched last year in partnership with BDO Foundation, UNA has already trained and empowered 130 vendors

This is in preparation for the opening of modern markets which are now undergoing construction works.

Mayor Jerry P. Treñas emphasized that this initiative is a big help to market vendors.

"We want a holistic approach in the redevelopment of our public markets. Part of this is the empowerment of our market vendors so they may also improve their business and income," he said.

The City Government is from various public hopeful to have the 3,000 vendors all trained.

They are from Iloilo Terminal Market, Central Market, Jaro Big Public Market, Jaro Small Public Market, La Paz Public Market, Mandurriao Public Market, and Arevalo Public Market.

Endorsed by the Local Economic Enterprise Office (LEEO), the market vendor must be a bonafide member with registered business, diligently paying his or her dues and committed to finish the training.

Local Economic Development and Investment Promotion (LEDIP) Office head Velma Jane Lao said the vendors are trained by batch and have to complete six sessions of trainings in order to avail of the livelihood

assistance worth P5,000.

Last year, six batches of vendors have graduated from the training. The first two batches were given livelihood assistance by the City Social Welfare and Development Office (CSWDO). The third to sixth batches were subsidized by BDO Foundation.

"We want our vendors to keep up with the redevelopment of public markets. We want to capacitate and empower them especially that we are now in the age of digitalization," said Lao.

They are trained on Work Ethics, Service Quality, Business Registration, Digitalization, Food Safety and Handling, Customer Service, Financial Literacy, Fair Trade laws, Consumer Rights and Responsibilities, Business Continuity Planning (BCP), and Financial Education (Fish N' Learn).

City Hall also partnered with government agencies like Bureau of Fisheries and Aquatic Resources (BFAR), Regional Tripartite Wages and Productivity Board of the Department of Labor and Employment, Department of Trade and Industry, and Iloilo City Community College for the program implementation. (Iloilo City PIO)

MORE EXCHANGES, **COOPERATIONS BETWEEN ILOILO** CITY, CHINA SISTER CITIES URGED

With everything coming back to normal after the pandemic, Consul General of China in Cebu Zhang Zhen has recommended for Iloilo City and its sister cities in China to have more people exchanges and cooperations.

"We all know that during the pandemic years the exchange remains at a very low level. But now after pandemic, everything came back to normal, so I will suggest that both sides make good use of the Sister City relationship and to explore more opportunities and possibilities to have tangible win-win cooperation which can bring more benefits to both sides," said

The Chinese official, who visited the city in line with the Chinese New Year celebration, said Iloilo's sister cities are very strong and famous in China and have their own features and strengths.

These are Qingdao wherein Iloilo has established sister city ties in 2000; Guangzhou City in Fujian province in 2020; and Wuhan in Hubei province in

"These big cities have vigorous potentials, and they have many, many strong sectors. So, I think the potential for the bilateral cooperation for Iloilo city and these cities are huge and great," she added.

She further cited, for instance, that "Wuhan is a very big city in the middle of China just like Iloilo, in the middle of the Philippines, the heart of the Philippines. Wuhan is also heart of China."

Meanwhile, with Iloilo City as a center of education, Zhang recommended more exchanges and cooperation in education.

"In China, there are a lot of good colleges and universities, including higher education; also the vocational education is very strong. Educational institutions can establish a kind of partnership, they can exchange students and teachers even ,have more common projects so both sides can benefit," she said.

Other potential areas for partnership, she noted, are agriculture, green energy, sustainable development, urbanization, and tourism.

"If the visa policy to China can ease, then I'm sure the two sides, the tourism bureaus and travel agencies can have better cooperation," she said. (Iloilo City PIO)
