recommend to the Iloilo City Council to declare a state of calamity in the metropolis due to pertussis.

Treñas said the declaration is needed in order to use the calamity fund of P16 million which will be allocated for medicines and vaccines.

"We need to access funds coming from the calamity funds. We cannot access funds from the calamity funds unless there is a declaration of state of calamity. It is the city council that declares state of calamity, and the CDRRMC recommends to the city council the declaration of state of calamity," Treñas said. The city mayor also cited that health personnel undergo training such as going around the barangays for vaccine distribution, while only children are allowed to wear face masks due to the vulnerability of their immune systems, while only the identified cases in a community will be isolated and not the whole barangay itself. On the other hand, Treñas said that children from Iloilo province will also be catered for vaccine immunization as long as there will be enough supplies, stressing that there will be no discrimination. Meanwhile, Dr. Roland Jay Fortuna, Assistant Department Head of CHO said that there is a rough estimate of 26,000 children aging from zero to 59 months old from the said three districts which will be prioritized with vaccine against pertussis. The said data was a projected number coming from the Field Health Services Information System (FHSIS).

# Pertussis cases in **Iloilo City reached to 15**

Pertussis cases in Iloilo City rose to 15 as of March 23 wherein seven are confirmed in the districts of Molo, Jaro, and Arevalo while eight are suspected cases according to the City Health Office (CHO).

According to Department of Health (DOH), the pertussis, also known as "whooping cough" is a highly contagious bacterial disease which is highly contagious in the early catarrhal stage, before paroxysmal cough wherein incubation period takes 7 days but it ranges from 5 to 15 days and is mainly caused by Bordetella pertussis bacteria.

CHO Assistant Department Head Dr. Raymond Jay Fortuna said, there are available vaccines for children in the surge of the said outbreak.

"So declaration sang outbreak, pahanumdom lang sa tanan nga pumuluyo, ang bakuna may ara kita para sa aton mga kabataan. Ang routine immunization sang city sige gyapon sa City Health Office, may available pa man kita nga mga bakuna para sa ila so for those nga kulang pa ang immunization, naka miss sang immunization nila magkadto lang sa mga health centers naton kay available ang mga bakuna," Fortuna said.

Fortuna added that there will be a need of additional vaccine as the projected number from Field Health Services Information System (FHSIS) in which 26,000 children aging zero to 59 months old from the said three districts were the first to be tallied for the vaccines.

He also added that they will request to provide additional

#### vaccines once needed.

"Subong kung may outbreak kita, may ginatawag kita nga outbreak response immunization so that's why we need additional vaccine," Fortuna added.


Fortuna also emphasized that pregnant women in their third trimester shall be also immunized to prevent their children in becoming carriers of pertussis.

"Sa mga adults naton, like ang pinaka high risk, or sa third trimester sang pregnancy nga makahatag kita sa ila kay kung magbata siya kag basi carrier ang bata niya nga waay pa nabakuna, dako gid ang tsansa nga basi magka pertussis man," Fortuna said.

On the other hand, there are available 525 multidose vials of vaccines at district health centers in which each vial contains 10 doses of vaccine, while there will also be routine immunization.

For children of six to 12 months, they should have completed three doses or primary series of vaccines while for 12-24 months with incomplete vaccines should be also complete so they will be given one dose of for booster, and children of 24 months and above will be given at least one dose of vaccine regardless of their vaccine status as per Fortuna.

In addition, Fortuna also cited that children who lose their vaccination card will be considered unvaccinated and may be given with one dose of vaccine while the City Epidemiology Surveillance Unit (CESU) is also active in searching children who missed the immunization or unimmunized.



The target population to be immunized will be 95% of the said number.

"So far sa latest nga data from DOH, Iloilo City is number one sa vaccination coverage, kita ang pinakataas at 77% compared sa Western Visayas so sige sige ang aton nga information campaign with regards sa vaccination, sa routine immunization sang mga kabataan naton," said Fortuna.

series of 2022, with the agenda of socialized and localized housing program worth P30 million has benefited 30 farmer beneficiaries from the Puroks 1-3 of the said barangay in which the houses will feature living spaces such as bedroom, bathroom, kitchen, and living room.





## Spotlighting Filipino legislators since the First PH Republic in 1898

Most of the younger generations of the Filipino representatives, including 35 elected by town chiefs population of over 114 million at present may be of different provinces, convened at the Barasoain interested to know that the First Philippine Republic Church in Malolos, Bulacan on Sept. 15, 1898 "to

under President Emilio F. Aguinaldo had a national budget of just PHP6,324,392 in 1899.

Certainly, many observers would comment that such an amount was just a drop in the bucket compared with today's national government budget of over PPP5.76 trillion.

What was more interesting was that the Filipino legislators at that time had a salary of only PHP6,000 per annum, or PHP500 monthly.

These data and other related information can be gleaned from the book "Foundations of Freedom: A History of Philippine Congresses" written by veteran author and editor Jose P. Abletez and published by the Merriam and Webster Bookstore Inc. in 1989.

The book contained a chronology and complete directory of legislators from the unicameral Malolos Assembly of Representatives (1898-1899) to the bicameral Congress restored under the Philippine Constitution of Feb. 2, 1987. It also showed the structure, membership, term of office and salary of members.

Abletez wrote that President Aguinaldo issued on June 18, 1898 a decree providing for the election of representatives to a "republican assembly" to constitute the national lawmaking body to be known later as the Malolos Congress.

The Revolutionary Congress, with 92 official

perfect the organization of the Filipino government."

The following day, the Malolos Congress elected Pedro A. Paterno as president of the assembly; Benito Legarda Sr., vice president; and Gregorio Araneta and Pablo Ocampo, secretaries.

These officials approved the 1899 annual budget of PHP6,324,792 for the Republic and authorized the issuance of paper money in small denominations amounting to PHP3,000,000 redeemable in three years.

According to Abletez, the Malolos Congress was replaced by the unicameral Philippine Commission composed of nine appointive members from 1901 to 1907.

From 1907 to 1916, a bicameral Philippine Assembly existed together with the Philippine Commission. It was composed of 80 elective members with a salary of PHP6,000 each per annum.

On Aug. 19, 1916, the United States Congress enacted the Jones Law calling for, among other provisions, a bicameral Philippine Legislature composed of a 24-member Senate (22 elective, two appointive) and 98-member House of Representatives (89 elective and nine appointive). They had the same remuneration of PHP6,000 annually until 1935.

The unicameral Commonwealth Congress existed from 1935 to 1941, when it was disrupted by the

A wartime National Assembly was organized on Sept. 20, 1943, composed of 108 members, including 46 provincial governors and eight city mayors appointed as ex-officio members.

With the end of the Japanese occupation of the Philippines in 1945 and the grant of Philippine Independence by the United States on July 4, 1946, the bicameral Congress was restored. It was composed of 24 senators with a term of six years and 120 congressmen with a four-year term and salary of PHP10,000 per annum.

The bicameral Congress was deemed phased out with the ratification by the barangay assemblies of the 1973 Constitution on Jan. 18, 1973. Then President Ferdinand E. Marcos Sr. issued Presidential Decree No. 955 creating the Batasang Bayan or Legislative Advisory Body composed of 130 members to help the Chief Executive in making laws for the nation.

During the martial law years, the unicameral Batasang Bayan existed from 1976 to 1978. Its members had no permanent remuneration and received per diems only when performing their legislative functions.

From 1978 to 1984, the Batasang Bayan was replaced by the Interim Batasang Pambansa (IBP) composed of 158 elective members, 14 sectoral

## **IS CONSULTATION - THE MEDIUM?** (Part V)

In Ecclesiastes 4:9-12, it was stated that:

'Two heads are better than one."

"Two heads are better than one, not because either is infallible, but because they are unlikely to go wrong in the same direction."

The proverb reflects the intuition that people working together in groups, communicating freely and sharing their confidence and judgements are more likely to come to a correct decision than they would if working alone. It is illustrates that sourcing ideas from each other spawns a better chance of coming up with a better strategy to overcome obstacles and achieve common goals.

A compendious review of constitutional references reveal that a Constitution is the foundation that supports everything that creates a government with enough power to act on a national level, but without so much power that would put fundamental rights at risk. Constitution-making is different from ordinary law-making as it deals with more fundamental questions than most forms of law such as statutory law, common law, treaties, or administrative regulations, which are made to conform with the constitution and in pursuance thereof.

As the nation's supreme law, the Constitution is the parent law. It codifies the core values and goals of the people to establish justice, insure domestic peace and tranquility, provide for common defense and security, promote the common welfare, and secure the blessings of democracy and liberty to ourselves and our posterity.

A constitution defines the branches of government and separates the powers into the legislative branch which makes the law; the executive branch which executes the laws; and the judicial branch which interpret the laws in order to make it difficult for one person, party, or group to get control of the government. Otherwise, as James Madison warned in Federalist #47:

"The accumulation of all powers, legislative, executive, and the judicial in the same hands, whether hereditary, selfappointed, or elective, may justly be pronounced the very definition of tyranny."

Accordingly, enacting or amending a constitution is a central political activity in contemporary times. It is an essential ingredient in the foundation of republics or countries in which opposing forces or influences are balanced during and after a political crisis.

The process of amending or revision of the constitution has been deliberately designed to be difficult to protect the constitution and the principles of the system of government set out by the framers. To prevent arbitrary changes of the constitution, an amendment may be proposed by threefourths of Congress members from each legislative chamber; or a constitutional convention which can be called by twothirds of Congress to propose amendment or revision; and a people's initiative can be put on the ballot for a referendum

or actual vote.

Historically, almost every attempt at amending the 1987 Philippine Constitution encountered skepticism because of the impression that they were either a cunning plan or action designed to secure the politicians positions, or a ploy to consolidate their powers and advantages to either prolong their stay in office or extend their term of office.

This probably explain why, according to the Pulse Asia survey on March 2023, forty-five percent 45% of Filipinos were against amending the 1987 Constitution. Of the 45 percent, 31 percent do not see the need for charter change now or at any other time in the future, while 14 percent are open to it someday.

As reported, 47% have prior awareness of proposals to change the Constitution, while around 53% have not heard, read, or watched any charter change motions before they were surveyed.

On the proposed amendments, 53 percent of the 1,200 respondents are against then proposal to lift the prohibition on foreign ownership of communications companies, 55 percent do not want to lift the prohibition on foreign ownership of utilities like electricity, 57 percent are not in favor of allowing foreign individuals and companies equal ownership in mass media and advertising.

Moreover, 67 percent are against removing limits on shares of stocks in Philippine corporations that may be owned by foreign individuals and companies; 72 percent are against allowing foreign individuals and companies to own residential and industrial lands; and 76 percent are against allowing foreign individuals and companies to utilize Philippine national resources.

Furthermore, 56 percent of respondents are against politically-related proposals to extend the terms of office of national and local elective officials.

As for the mode of amending the Constitution, only 34 percent of the respondents agree with the creation of a constitutional convention.

Adding to the people's skepticism could be that, as it appears, the Congress resolution RBH6 calling for constitutional convention have not provided ground rules. According to Congressman Rufus Rodriguez, Chairman of the House Committee on Constitutional Amendments Congressman Rufus Rodriguez, "It not true that only economic provisions would be tackled with the Resolution of both Houses No.6.".. "when there's a constitutional convention, they will have the constituent power to also be able to discuss not only our economic provisions", "but also political amendments..." Castro in a separate statement... " in short, it will also be empowered to entertain political amendments...according to the Deputy Minority Leader, France Castro"

The ambigous definition of the mete and bounds to circumscribe the convention spectrum, coupled with the lack of ground rules governing deliberations, leaves the Convention open wide to political considerations and pressures. There is no guarantee that the Convention could be limited to a given set of issues.



Without constitutional guidance the Convention could write its own agenda, and possibly influenced by powerful vested interest groups hence, it could go beyond its mandate.

Moreover, no other body including the courts has clear authority over the Convention. The Constitution provided for no authority above the constitutional convention, so it is not clear that the courts, congress, or the president could intervene if the convention went beyond the language of Congress resolution establishing it.

Thus, the people have become ambivalent, if not losing trust and confidence on government. Generally, the public have likewise become skeptical toward the political leaders who are perceived to protect and perpetuate their parochial, oligarchic and dynastic interests.

In the light of all the foregoing premises, if the nation's legislators and decision-makers are really determined to pursue constitutional change or reform a government that has been tainted by allegations of corruptions, and upgrade a governance whose reputation have been besmirched by incompetencies and inefficiencies, would it not be timely for the administrators of nation's affairs to shift to a new paradigm by engaging the citizens in a new reform process?

Government is a social institution composed of extraordinary collection of human persons thinking and interacting for the purpose of meeting their individual objectives and organizational

goals. According to the Civil Service Commission, as of June 30, 2022, there are 1,654,575 career civil servants, 195,882 non-career employees, and 642,077 job order/ contract staff, or a total of 2,492,734 civil servants working with government.

In addition, there are 316 congressmen, 24 senators, 82 provincial governors, 82 provincial vice-governors, and 820 members of the provincial boards. Moreover, there are 1,489 municipal vice-mayors, 1,489 municipal vice-mayors, and 11,916 municipal councilors; 149 city mayors, 149 city vice-mayors, and 1,270 city councilors. Furthermore, there are 42,929 barangay captains, 336,232 barangay councilors, and 294,007 sangguniang kabataan members, or a total of 394,845 elective officials.

If data are accurate and numbers won't like, altogether, there are

2,887,579 million government functionaries. This vast reservoir of human resources are endowed individually, jointly or severally with enriched experiences and stock knowledge. They are virtually living libraries from which the advocates of IS CONSULTATION / page 15

It must be emphasized that this humane treatment of animals should not be limited to house pets alone such as dogs and cats but should encompass all forms of animal treatment–protection of endangered species, wildlife conservation, and ethical treatment of livestock among others.

Recent reports that Killua tested positive for rabies also highlight the need for responsible pet ownership.

The senseless killing of Killua has opened discussions to revisit and amend the country's Animal Welfare Act to further promote the humane and dignified treatment of animals and ensure that stronger safeguards are in place to penalize abusers.

Killua's story is only one of several cases of animal cruelty in the country that sadly reflects the kind of progress we have. These past few days, several stories of animal abuse have made headlines to the disappointment of many.

Just before the killing of Killua, the stabbing of an aspin (short for asong Pinoy or local breed) Erika by a South Korean national also made headlines.

In a country where the majority of households or 64 percent are pet owners, animal welfare is a serious national issue that requires grave attention from policymakers, law enforcers, and advocacy groups.

While some would argue that there are more important issues to address than animal welfare, I

In light of the killing of the pet dog Killua, it is timely for our lawmakers to reopen discussions on amending the Animal Welfare Act of 1998 to ensure that the law is attuned to the current conditions of our society.

It is up to our lawmakers to give the law more muscle by increasing fines and penalties for violators to help deter future offenses and in effect, raise better awareness of animal welfare. This way, abuses, neglect, and abandonment of animals can be met with stricter punishments instead of just a slap on the wrist.

As Senator Grace Poe, who is among those seeking the amendment of the law said: "If we are to create a kinder society where animals and humans can co-exist in harmony, we must raise awareness on the proper, responsible, and humane manner of treating animals."

While significant progress has been made in promoting and protecting animal welfare, much remains to be done.

Amending the law on animal welfare is one matter, enforcing it is another.

The problem with animal cruelty should be addressed at the grassroots level and requires a multi-sectoral approach to raise awareness of animal rights and promote proper and humane treatment of animals. To drive widespread prevention of animal abuse, active collaboration is needed between policymakers, law enforcers, and the private sector, particularly advocacy groups.

For example, our barangay officials can partner with cause-oriented advocacy groups for information campaigns on animal welfare. The private sector on the other hand can fund programs that are geared toward raising greater awareness of animal rights.

Information is power when it comes to any social issue.

It is in this light that I also support the proposal to include animal welfare in the basic education curriculum so that Filipinos at a young age can learn how to treat animals properly as well as how to be responsible pet owners.

As we advocate for greater awareness on this issue, let us be reminded that our treatment of animals reflects our humanity.

> 3. Under Section 4 of the same law, NGCP was granted the power of eminent domain, subject to the requirements of the Constitution and existing laws.

> 4. Plaintiff is engaged in the business of transmitting electric power from the generating plants of power producers to distributors. As such, plaintiff's business is imbued with public interest.

> 5. Due to increasing demand for electricity, there is a need to construct a transmission system that will provide a reliable, secured and efficient power delivery system in the municipalities, cities and provinces in the Island of Panay, as well as in the other islands of Visayas. Owing to this necessity, plaintiff must immediately construct the transmission and interconnection lines that will significantly enhance the transmission of power to the distributors of electricity in the aforesaid areas. These undertakings are for the use and benefit of the public and one of which is known as the Barotac Viejo - Natividad 69kV Transmission Line Project.

> 6. Defendantsknown heirs of Spouses Pablo Macadag-um and Erlinda Tangu-an, who could be located, namely: Vivie T. Macadag-um, Spouses Robert T. Macadag-um and Mara M. Macadag-um, Renan T. 10.To enable plaintiff to construct and maintain the Barotac Viejo - Natividad 69kV Transmission Line Project, it is both necessary and urgent to acquire the above-described portion of Lot No.1372-A (7790), upon payment of just compensation, to ensure stability and reliability of power supply in the Island of Panay and other Islands of Visayas.

11. Plaintiff's personnel negotiated with the knowndefendants who could be located for the acquisition of the above-described portion of Lot No. 1372-A (7790) for the implementation of the project. However, no settlement was reached between the parties. Considering the urgency involved in the construction of the project, plaintiff has no other recourse but to file the instant Complaint.

12. Plaintiff is willing and able to pay the just compensation for he above-described portion of Lot No. 1372-A (7790)sought to be expropriated, subject to deductions for capital gains and documentary stamp taxes for the transfer of the property in the name of plaintiff, applicable estate taxes, and all other outstanding taxes under the National Internal Revenue Code (NIRC), and other outstanding realty taxes and dues under the Local Government Code, which plaintiff shall directly pay to the Government.

Section 13, R.A. 11361 provides that "Subject to the limitations and procedures prescribed by the law, the power to exercise the right of eminent domain granted to any person with a franchise to operate, manage, or maintain the electric power linesshall be governed by the pertinent provisions of the Rules of Court."

13. Section 13 of R.A. 11361<sup>6</sup> provides that Rule 67 of the Rules of Court governs plaintiff's expropriation cases.Under Section 2 of Rule 67 of the said Rules, plaintiff may already enter and possess the affected portion of the subject propertyduring the pendency of the expropriation case,<sup>7</sup> thus:

"SEC. 2. Entry of plaintiff upon depositing value with authorized government depositary. — Upon the filing of the complaint or at any time thereafter and after due notice to the defendant, the plaintiff shall have the right to take or enter upon the possession of the real property involved if he deposits with the authorized government depositary an amount equivalent to the assessed value of the property for purposes of taxation to be held by such bank subject to the orders of the court. Such deposit shall be in money, unless in lieu thereof the court authorizes the deposit of a certificate of deposit of a government bank of the Republic of the Philippines payable on demand to the authorized government depositary."

14. Pursuant to the above Rule, plaintiff shall cause to be served, among other means, together with the summons and the instant Complaint, a Notice to Take Possession<sup>8</sup> upon the defendants.

15. Notwithstanding that R.A. No. 10752 does not specifically apply to the plaintiff, but considering that it will be for the benefit of the defendants and in the interest of immediate project implementation within established timelines, plaintiffshall deposit with the Honorable Court, in favor of the defendants, 100% of the BIR zonal value of the portion of the subject property sought to be expropriated, including the cost of the affected improvements standing therein in the total amount of Thirty-Nine Thousand Seven Hundred One and 40/100 Pesos (Php39,701.40), thereby placing it in custodia legis, pursuant to OCA Circular No. 113-2019.

16. Upon deposit of the provisional amount, which is higher than the assessed value of the affected portion of the property, plaintiff would have fully complied with the requirements for the issuance of a writ of possession as mandated by law.

17. In a long line of cases<sup>9</sup> and in accordance with OCA Circular No. 113-2019, once the above requirements are complied with, it becomes the ministerial duty of the trial court to issue the writ of possession in favor of the plaintiff, without need of any further hearing. Therefore, this Honorable Court can already immediately issue to the plaintiff an order to take possession of the subject property and start the implementation of the project.

18. In the case of *Municipality of Cordova v. Pathfinder Development Corporation*, <sup>10</sup> the Supreme court emphasizes the mandatory issuance of the writ of possession upon the receipt of the required deposit. "No hearing is actually required for the issuance of a writ of possession, which demands only two (2) requirements: (a) the sufficiency in form and substance of the complaint; and, (b) the required provisional deposit x xxx. Upon compliance with these requirements, the petitioner in an expropriation case is entitled to a writ of possession as a matter of right and the issuance of the writ becomes ministerial."

19. Recognizing further the urgency of the resolution of expropriation cases involving transmission lines, in OCA Circular No. 127-2021 dated 13 October 2021, the Chief Justice of the Supreme Court enjoined judges to give primacy to cases that involve, among others, government expropriation, and infrastructure projects (including energy transmission projects), commercial- and economic-impact cases.

20. Moreover, it must be emphasized that an expropriation proceeding is an action quasiin rem.<sup>11</sup> Thus, jurisdiction over the defendants is not required. The important matter is that there is jurisdiction over the res. Concomitantly, prior service of summons upon the defendants is not required for the issuance of the Writ of Possession.

21. In NM Rothschild & Sons (Australia) Ltd. vs. Lepanto Consolidated Mining Company,<sup>12</sup>the Supreme Court held that:

#### PRAYER

WHEREFORE, premises considered, plaintiff most respectfully prays of this Honorable Court to:

1. ISSUE a Writ of Possession in plaintiff's favor authorizing it to enter and take possession of the portion of Lot No. 1372-A (7790)subject of this Complaint, that will be affected by the construction and implementation of the BarotacViejo - Natividad 69kV Transmission Line Project, as described in paragraph 9 hereof; order the demolition of the affected houses/structures standing thereon, if any; order all defendants to vacate the same; direct the Philippine National Police (PNP) to assist the plaintiff in the implementation of the said writ of possession so that project construction can immediately commence even during the pendency of the case; and if necessary, allow plaintiff to have temporary access in going to the area subject of the complaint while the construction of the project is on-going;

2. ISSUE an Order of Expropriation declaring that plaintiff has a lawful right to take and condemn to public use the portion of Lot No. 1372-A (7790), sought to be expropriated, consisting of a total area of 692 square meters, more or less, specified in paragraph 9 hereof;

3. After the determination of just compensation, ISSUE a Judgment:

22. Again, in Macasaet vs. Co, Jr., 13 the Supreme Court held:

"Jurisdiction over the person, or jurisdiction in personam-the power of the court to render a personal judgment or to subject the parties in a particular action to the judgment and other rulings rendered in the action-is an element of due process that is essential in all actions, civil as well as criminal, except in actions in rem or quasi in rem. Jurisdiction over the defendant in an action in rem or quasi in rem is not required, and the court acquires jurisdiction over an action as long as it acquires jurisdiction over the res that is the subject matter of the action. The purpose of summons in such action is not the acquisition of jurisdiction over the defendant but mainly to satisfy the constitutional requirement of due process."

23. Corollary to the successful and complete implementation of the Writ of Possession and for the orderly and peaceful entry of the plaintiff into the subject property for project implementation, the assistance of the Philippine National Police (PNP) and temporary access through the subject property to the area being expropriated is prayed for. In view of the requirement under Section 28.2, Rule 28<sup>14</sup> of the Revised PNP Operational Procedures, it is likewise earnestly prayed that the Order for issuance of a writ of possession specifically directs the PNP to render assistance because the PNP shall not act unless the same is specified by the Court.

24. While the instant special civil action is governed by Rule 67 of the Rules of Court which is not affected by the new amendments provided in A.M. No. 19-10-20, plaintiff nonetheless intends to present at least three (3) witnesses for the smooth flow of the case as in ordinary civil cases, namely: a) Jesse L. Asuga, to establish the propriety of expropriation for plaintiff's project, the necessity and public use for which the instant expropriation case is instituted, and other facts of the case, b) Asterio B. Tubera, to establish the areas and sites necessary for the construction of plaintiff's project pertinent to the subject property, the consequent necessity





GORGIO COFREROS GALARAGA'S) date of birth: December 26, 1987. As alleged by Petitioners, their aunt's age if so, based on respondent's date of birth, was impossible to bear a child at age Forty Eight (48) years old during that time. Thusly, the said mentioned certificate of live birth of respondent, according to petitioners impairs their legal rights, considering that the same implies that he (respondent J. GORGIO COFREROS GALARAGA) is the legal compulsory heir of deceased JOSEFINA COFREROS GALARAGA, when in truth and in fact the said registration was clearly simulated, as he is not the heir of the latter. ## DHSUD, NHA to aid calamity-hit families in Iloilo City

ILOILO CITY – The Department of Human Settlements and Urban Development (DHSUD) has ordered its regional office in Western Visayas to validate the number of families affected by fire incidents for the provision of financial assistance under the Integrated Disaster Shelter Assistance Program (IDSAP).

DHSUD Secretary Jose Rizalino Acuzar, in a letter dated March 21 to Iloilo City Rep. Julienne Baronda, said the regional office is confirming the total number of affected families.

"Upon receiving the funding requirement from our regional office, the central office shall undertake careful assessment and validation. Thereafter, our shelter response team shall distribute the financial assistance amounting to PHP15,000 per beneficiary family," he said in the letter obtained by the Philippine News Agency on Monday.

Acuzar said the aid constitutes the first phase of the IDSAP.

He also tasked the National Housing Authority (NHA) to identify and implement "appropriate housing program" to address the shelter needs of those displaced due to the rehabilitation of rivers and creeks in the city.

Last week, Baronda met with the officials of DHSUD and NHA in Manila to tackle any assistance to families affected by calamities and government rehabilitation projects.

She particularly sought assistance for fire victims in Barangays Airport in Mandurriao, Yulo Drive, and Sto. Niño in Arevalo, South Fundidor and Salvacion Habog-Habog in Molo, Sambag and Our Lady of Lourdes in Jaro, and Mabini in Lapaz.

Baronda also brought to their attention the families from Barangays Dungon-B who were victims of a typhoon and from Barangays Desamparados and Quezon affected by government projects. (PNA)

# TESDA, slow food educators to preserve Antique's culinary heritage

SAN JOSE DE BUENAVISTA, Antique – The Technical Education and Skills Development Authority (TESDA) has tied up with the Slow Food Educators of Panay (SFED) to preserve and promote the slow food or culinary heritage in Antique province.

TESDA acting Provincial Director Agnes Dimzon said Friday they are developing competency standards with the SFED to preserve and promote the culinary heritage in the province, initially with the "pinindang," a fried dried anchovy fish.

"Only a few of the younger generations know how to make pinindang and other culinary heritage, that is why TESDA has signed a memorandum of agreement (MOA) with the Slow Food Educators of Panay for the development of the competency standards or curriculum," she said in an interview.

Dimzon said TESDA Regional Director Florencio Sunico Jr. signed the MOA with SFED on March 16, 2024 at the Advance Central College in San Jose de Buenavista, where they will also hold slow food training and education for TESDA stakeholders.

She said they hope to finish the competency standard

SAN JOSE DE BUENAVISTA, Antique – The by next month and submit it to the TESDA industry board chnical Education and Skills Development Authority for approval and implementation.

SFED spokesperson Dr. Mary Rose Gemma Rodriguez, in an interview, said pinindang is the only culinary food included in the living catalog, Ark of Taste.

"Pinindang has already gained international exposure, for it is the first culinary heritage from Antique that had been included in the Ark of Taste, a collection of food products that are already in danger of disappearing," she said.

Rodriguez nominated Pinindang to the Ark of Taste last year. Currently, producers, mostly wives of fishermen from the towns of Culasi, Tibiao, and Laua-an, are reaping economic benefits compared to when it was only a traditional food served in the homes of Antiqueños.

The food product is now sold between PHP100 to PHP120 for a pack of 10.

Rodriguez further said they look forward to TESDAtrained food makers coming up with a uniform taste, diameter, and quality of the pinindang to be served in the restaurants as a distinct food from Antique when the competency standards are approved. (PNA)

financial obligations.

He also championed the expanded Centenarian law (Republic Act 11982) wherein senior citizens aged 80, 85, 90, and 95 are entitled to a cash gift of P10,000, and P100,000 for those reaching the age of 100.

which I do not approve at present, but I am not sure I shall never approve them. Having lived long to the autumn of life, I have experienced many instances of being obliged by insuperable information or overriding considerations, to change opinions even on crucial subjects, I once thought to be right, but found later to be otherwise.

Notwithstanding these sentiments, I agree to maintain the 1987 Constitution in spite of all its defects, thinking that knowing it will enable us to find practical ways and means of correcting and neutralizing its adverse effects. Besides, I am not certain whether the Constitutional Convention will enable us to obtain or make a better Constitution. Nonetheless, I know that although a constitution is framed to endure, it must go along with the development and progress of the human mind as it becomes more enlightened, as new discoveries social norms and opinions changes with the mores of circumstances, confounded in chaos. From the context of all the foregoing premises, the only way the proponents of constitutional change can ensure a wellinformed decision to amend the 1987 Philippine Constitution is to undertake an all-encompassing consultation. Consultation with stakeholders serves as fundamental mechanism for gathering information, perspectives, expertise and reactions from individuals involved in administering government affairs. It is crucial in ensuring alignment of a plan with the expectations and concerns of the constituencies.

with just one idea per civil servant, there are 14,437,895 million ideas available for exploration by the proponents of constitutional reform to source information to make a well-formed decision.

Viewed from the context of the foregoing perspective, would it be possible for the prime movers of constitutional reform to mobi- lize the Civil Service Commission to lead an expansive, in-depth and exhaustive consultation with the entire bureaucracy beginning with the top hierarchy of government from the 33 cabinet secretaries, the 37 heads of agencies, authorities and 219 GOCCs under the Office of the President, down across departments and other branches of governments to survey their views and opinions regarding constitutional change and government reform?

Will it be possible for the advocates of constitution change and government reform to enlist the Department of Local Government to lead a bottoms-up consultation process with the local government units starting at the barangay assemblies to enable the people to openly and freely discuss constitutional questions and issues about the 1987 Constitution and its infirmities to determine if there is an overriding public interest in order to evolve wider agreement on the amendments or revision?

Will it devalue the solons and administrators of the nation's affairs, to consult other jurisdictions, institutions and entities like heads of business and industry, trade associations, civic and religious leaders, and non-government organizations including the association of generals of the armed forces as "amicus curiae" in an inclusive, participatory and transformational process to engender a consensus around a constitutional framework that is agreeable to all?

If the proponents of constitutional change would really want

and help the citizens understand why we do what we do?

Lest I be misunderstood, I am profounding the foregoing questions sans malice. I am not claiming that the propositions aforecited are ex cathedra infallible. Neither I am intending to lecture and much less teach those mandated with the task of changing the constitution, and reforming government, or upgrading governance.

Suffice to say I subscribe to the view that a question is the beginning of education and that curiosity is the start of knowledge. In my inchoate opinion, questions and commentaries help make sure that the government is getting it right and alert it when it is not. Questions help solve problems by providing information that challenges the government assumptions when they are inaccurate, and to help government create a framework for understanding and discovery to resolve conflicts and disagreements.

As we have been taught in law school, democracy is a shared responsibility of the government and the citizens. Questions promotes power-sharing, and help preserve decision-making process and checks and balances.

I confess, there are certain parts of the 1987 Constitution

A comprehensive consultation with constituencies generates unique knowledge, insights and expertise which enriches decision-making process. It helps identify emerging issues and challenges which can impact now or in the future on constitutional reform. It helps create a more balanced strategic plan that reflects the collective intelligence of the organization.
