

Iloilo City accelerates towards a modernized and sustainable transport future

ILOILO CITY is undergoing a significant transformation in its public transportation network with a focus on modernization and sustainability.

The city is implementing the Local Public Transport Route Plan (LPTRP), launched in June 2022, to improve public transport services.

Under the LPTRP, Iloilo City is introducing 1,782 modernized jeepneys to 500 units already operating within the city limits.

These modernized vehicles are set to follow 17 existing routes, 7 new routes, and 1 enhanced new/developmental route. Restrictions have been placed on traditional jeepneys, limiting their operation to designated terminals in the city to streamline traffic and reduce congestion.

the Western Visayas replace older models, with Transportation Cooperative

deployed 95 new modern jeepneys across 13 routes in Iloilo City.

These jeepneys offer a host of amenities including air-conditioning, CCTV systems, Wi-Fi, GPS, and a cashless payment system, all while adhering to European emission standards for reduced environmental impact.

Capitol partners with PCIC to aid farmers affected by El Niño

THE Iloilo provincial government has partnered with the Philippine Crops Insurance Corporation (PCIC) to help farmers and fisherfolks affected by the El Niño phenomenon.

Last March 6, 2024, Governor Arthur Defensor, Jr. with Provincial Agriculture Office head Dr. Ildefonso Toledo turned over a check worth PhP 15 million to PCIC, led by its president Atty. Jovy Bernabe, as initial funding for the project dubbed SIGURADO or Sustainable Insurance from the

Iloilo District Hospitals go renewable

AS part of its effort in mainstreaming the use of renewable energy in its facilities, the Iloilo provincial government has embarked on the installation of solar rooftop projects in district hospitals.

Gov. Arthur Defensor Jr. led the turnover of the 30-Kilowatt Solar Photovoltaic and Efficiency Project (Phase I) worth P3.5 million intended for the COVID Ward and Service Award of Aleosan District Hospital in the municipality of Alimodianon March 6, 2024.

The province also broke ground the construction of the Phase II which involves the installation of 30kilowatt rooftop solar PV and streetlights which cost P3.7 million.

Joining the governor during the event are Provincial Administrator Raul Banias, Hospital Management Office Chief Dr. Paz Calopiz, Aleosan District Hospital Chief Dr. CherubinEstrellanes, Mayor. 'We don't want war': Army calls on rebels to embrace peace

The commander of the 301st Infantry "Bayanihan" Brigade (IB) has renewed his call for the members of the New People's Army (NPA) to go back to the side of the government and reconsider the path of peace in dealing with all their causes.

Brigadier General Michael Samson made this statement in a media interview following the encounter between the rebels and the troops of the 61st Infantry Battalion on Feb. 28 in the hinterland village of San Joaquin, Iloilo province.

"Actually, angatonpanawagan, kung mag balik lang sila sa sabak sang gobyerno, walagid sang problema, we will welcome. Waay man namon na gina kalipay ang engkwentro kung sadiin may mapatyan either sides," Samson said.

(Actually, if they want to return to the government, there's no problem because we welcome them. We don't

even want that there are casualties on either sides because of the clash.)

Samson reiterated that the government would be helping those rebels who want to go back to the mainstream society through different programs, like the Enhanced Comprehensive Local Integration Program (E-CLIP).

Ang gusto gid ya namon para matapos, they just avail the program of the government, like E-CLIP. Timaayo man na para magsugodnasila to become better citizens with their families. We call on them, mag-isa na ta nga mauntat nani para ka create nakita sang peaceful, sustainable environment that is conducive for the development. We are the army, we are with the people," he elaborated.

in Iloilo. The city is in the process of reviewing a proposal for a Bus Rapid Transit (BRT) system, envisioned to significantly improve the efficiency of public transportation.

The BRT system aims to reduce traffic congestion and provide a fast, reliable, and eco-friendly mode of travel for residents. In an effort to further modernize the city's transport system, a mobile app-based bikesharing system is being explored.

This initiative will promote a healthy lifestyle and provide a sustainable alternative to motorized transport, potentially alleviating traffic congestion. The move towards electrification of public transport is gaining momentum with plans to introduce a fleet of electric buses.

These buses are expected to be integrated with the proposed BRT system, representing a leap forward in the city's commitment to sustainable and green transport solutions.

The ambitious PHP189 billion Panay-Guimaras-Negros Bridge project is set to significantly reduce travel times, cutting the current four-hour journey (via ferries/RORO) between Panay and Negros islands to approximately one hour by land.

This monumental infrastructure is anticipated to be a catalyst for economic growth and enhanced interisland connectivity.

A significant upgrade is also on the horizon for the Iloilo International Airport, with Transportation Secretary Jaime Bautista advocating for its privatization.

The goal is to expand the airport's capacity to handle 10 million passengers annually, thereby boosting tourism and spurring economic development in the region. However, these developments are not without their challenges. The phase-out of traditional jeepneys in favor of modernized alternatives has met with some resistance from drivers and operators.

The Department of Labor and Employment (DOLE)

and the Technical Education and Skills Development Authority (TESDA) are actively supporting displaced drivers through the Public Utility Vehicle Modernization Program (PUVMP).

TESDA Director General, Tonisito Umali, announced that 900 scholarship grants have been provided to aid drivers and their beneficiaries, aiming to ensure that the transition to modern vehicles is both fair and inclusive. Infrastructure limitations also pose a hurdle, with concerns that the current infrastructure may not adequately support a fully modernized system, particularly the proposed BRT.

Moreover, public awareness is a critical aspect of these changes. Ensuring that the public is well-informed about new routes and system upgrades is essential for a smooth transition.

The city is therefore investing in public information campaigns to facilitate understanding and cooperation from all stakeholders.

As Iloilo City navigates through these transformations, the collective efforts of government agencies, transport operators, and the public will be paramount in realizing a modern, efficient, and sustainable transportation network for the future.

Antique eyes P119.86M hike in annual income from amended revenue code

SAN JOSE DE BUENAVISTA, Antique -The Antique provincial government targets PHP119.86 million in additional income annually with the proposed amendment of its existing revenue code.

"We needed to revisit our revenue code for it still dates back 18 years ago," said board member Victor Condez, author of the proposed 2023 Revenue Code of the province of Antique, which already hurdled its second reading during the regular session on Monday.

The provincial board approved the proposed ordinance on its first reading in September 2023 and went through a series of public hearings and consultations.

Among the salient provisions of the proposed ordinance are the increase in fees on provincial government services and the use of equipment.

The fees are considered outdated because the prevailing code was approved in 2006.

Condez said the PHP119.86 million income will come from the proposed rental of the Binirayan Hostel of PHP855,200; heavy equipment and material testing amounting to PHP3.3 million; old capitol building function room, floating cottage and "Balay na Bato" for pictorial amounting to PHP530,400.

Other sources include the rental of the Sports

Development Complex, PHP2.27 million; environmental fee and other permit applications for quarry, PHP2.47 million; room, board, oxygen and other facilities at the Angel Salazar Memorial General Hospital, PHP107.89 million; sale of fruit tree and vegetable seedlings, PHP1.33 million; and veterinarian health certificate, vaccination, and livestock and poultry projects at PHP1.22 million.

Antique Provincial Planning and Development officer Bienvenido Nallos Jr., in a separate interview, said the additional income will go to the various programs, projects and activities of the province.

Hoilo City promotes Waste Diversion

has been engaging in waste diversion initiatives, turning plastics into fuels.

Philippines recognized the metro with a Certificate of Waste Diversion for its unwavering support of climate action.

Some 2,220 kilograms of segregated residual plastic waste collected from January to February 2024 have been successfully diverted through APO Cement Corporation's co-processing technology in compliance with Republic Act No. 9003 or the Ecological Solid Waste Management Act.

After their delivery of

Iloilo City government cement in the city weekly, they ship the segregated waste back to their plant.

"One of our programs Through this, CEMEX is geared towards waste diversion and how to maximize its strategies. We signed a Memorandum of Agreement (MOA) with APO Cement Company, and they will be the ones using the waste in what we call co-processing, which will be used in the production of cement called Refuse-Derived Fuels (RDFs)," General Services Office Head Engr. Neil Ravena said.

"We have a certificate from the company to ensure that we have documents to present to the Department of Environment and Natural Resources (DENR) and other national government agencies that could be submitted as plastic credits to international environmental agencies," he added.

This initiative is also in partnership with Clean Cities, Blue Ocean (CCBO), United States Agency for International Development (USAID), and Central Philippine University (CPU) to promote waste

diversion and prevent waste in bodies of water that will create marine litter and microplastics in the ocean.

The city is committed to strengthening multi-sectoral collaboration in order to build a better environment and address climate change.

CEMEX is a cement provider that aims to promote innovative and sustainable solid waste management solutions by engaging government partners, from national to municipal level, presenting innovative ideas through summit roadshows, and recognizing local government units for their contributions to proper waste management.

Co-processing is the method of using a cement kiln for a sustainable way of processing waste, particularly single-use plastics.

This helps in effectively reducing waste being dumped in landfills and bodies of water, which is transformed into an additional energy source during cement production. (Andrea Pearl B. Fernandez/ Iloilo City PIO)

He already ordered deployment of troops to nearby areas to assure the safety of the community, noting that the residents' accurate information on the presence of the NPA helped in the success of the operation.

Samson concluded that they already wanted to end the more than 50 years of communist insurgency in a peaceful way rather than resulting in encounters, just like what happened in San Joaquin, Iloilo province.

"How we wish that the insurgency problem will end already and will not result in encounters. But what happened yesterday is an example of when they insist on fighting against the government. We will not hesitate also to use force to pressure them to take the best alternative -- to go back to the government," the commander said. (PIA



Gov't Forces About to Achieve "Total Victory" Over CTG in Visayas; Facilitates Declaration of "SIPS" in Negros and Panay Islands

CAMP PERALTA. Jamindan, Capiz – The journey of government forces and the people of Western and Central Visavas towards achieving "Total Victory" against the Communist Terrorist Group (CTG) is imminent, as it gets clearer every day.

This collective triumph against the CTG in the Visayas Region is coming sooner than expected after the last remaining guerilla front in Negros was declared as dismantled. With this recent development, Negros Island is now being recommended and gearing up to be declared as "Stable Internal Peace and Security" or SIPS.

In fact, the Negros Occidental Joint Peace and Security Coordinating Committee (JPSCC), comprising the 302ND and 303RD Infantry Brigades, Negros Occidental PNP and the Philippine Coast Guard, had already approved and

BUENAVISTA, Antique -Antique has enough swine to meet the demand for pork in the province, according to the Antique Provincial Veterinary (ProVet) on Tuesday.

ProVet Senior Agriculturist Luela Furio said that the inventory during the last quarter of 2023 showed the swine population in Antique at 46,022 heads.

Traders shipped around 3,599 heads outside the province during the first two months of 2024. The 42,423 hogs left in Antique are enough to supply the local pork consumption.

"Our four border checkpoints in the municipalities of Hamtic and Anini-y in the south and Libertad and Pandan in the north of Antique are monitoring daily the hogs being shipped out of the province," Furio said in an interview.

SAN JOSE DE Municipality of Caluya is applying for Recognition on Active Surveillance (RAS) on African swine fever (ASF), a requirement to transport live weight outside of the municipality and augment the stocks at the province's capital town, where there is a shortage in supply.

The swine population in the island as of the last quarter of 2023 was at 3, 162 heads.

"The issuance of RAS is necessary to show that the live weight from Caluya is ASF-free," she said.

Meat vendors from the San Jose de Buenavista could hardly find live weight to be sold at the Dalipe Tradetown since traders have local scouts or errands in the barangays to look for available hogs.

It is about community development, using our cultural riches to stimulate local economies and enhance pride and cohesion.

NCCA Commissioner Arvin Manuel Villalon's words rang true during the fieldwork and workshop: "Our cultural heritage is key to understanding our identity and origins, crucial amidst globalization and rapid global changes." He reminds us of an African proverb, "When an old man dies, a library burns to the ground," highlighting the urgency of our mission. Getting inspiration from the commitment of Sen. Loren Legarda to this cultural endeavor, Commissioner Villalon stressed that cultural mapping is not just an academic exercise but a lifeline to the soul of our society, ensuring that the libraries within our elders and the landscapes that have cradled generations are preserved and cherished.

But cultural mapping is more than preservation. This is a launchpad for innovation and creativity. By identifying and fostering creative assets, we pave the way for new industries and opportunities, marrying the traditional with the new. And let us not forget the role of cultural mapping in environmental conservation, where the cultural significance of natural landscapes is recognized and safeguarded.

Bacolod City opens 4PH housing program for OFWs, home renters

BACOLOD CITY – The city government here is opening the Pambansang Pabahay Para sa Pilipino Housing (4PH) Program to overseas Filipino workers (OFWs) as well as to home renters, who are not registered residents but are working in the city.

Councilor Vladimir Gonzalez, chairman of the City Council's committee on urban poor, housing and resettlement, said on Monday that although the

priority beneficiaries are still Bacolodnons, residents of other local government units can also avail of the city government's shelter program in partnership with the Department of Human Settlements and Urban Development (DHSUD).

"Good news because this is a national housing program, not only residents of Bacolod can avail of this. Even those from other cities and municipalities who are renting places in Bacolod

since they work here, can also qualify," Gonzales said in an interview.

"We will still prioritize the people of Bacolod. Probably with 10 to 20 percent of the housing units, we can entertain them," he

Gonzales said OFWs can also avail of housing units under the 4PH Program.

"Yes, they can. The OFWs can apply. They can grant a special power of attorney to a family member to process

the papers," he said.

The city government is implementing the 4PH Program mainly for informal settler families through a memorandum of agreement with the DHSUD.

The development of the first project, the Yuhum Residences-Vista Alegre, including an initial four buildings with 296 condominium-type housing units, is ongoing.

The Yuhum Residences-Banago housing project, with a target of 3,627 housing units, will be implemented

Gonzalez said that since the implementation of the 4PH has a subsidy from the national government, homeowners will pay an interest of only 1 percent per annum instead of the regular 6.25 percent.

They will also pay lower monthly amortization of PHP2,300 to PHP2,800, or not more than PHP3,000, he said.

Applicants must be members of the Home Development Mutual Fund (HDMF), also known as the Pag-IBIG Fund, but those who are not will be assisted to become one to avail of the shelter program, he added. (PNA)

And if we do this right, regionwide, we hope that, with God's grace, it will eventually be the start of a cultural mapping revolution in the rest of the islands in the country.



military outpost at the tiny South China Sea feat

We have our hand for European Union ambassador Luc Veron who has expressed serious concern over China's latest menacing maneuvers against Philippine resupply vessels that resulted in a collision in the disputed West Philippine Sea.

At the same time, we applaud Speaker Martin Romualdez who reaffirmed the other day the full support of the House of Representatives for President Ferdinand Marcos Jr.'s initiative to continuously enhance the capabilities of the Philippine Coast Guard and modernize the Armed Forces of the Philippines amid rising tension in the WPS.

European Union's top diplomat Veron, in a statement on X, said, and we quote: "Troubled by today's pattern of dangerous maneuvers and blocking from Chinese Coast Guard vessels and Maritime Militia targeting Philippine vessels engaged in crucial resupply missions."

A Philippine Coast Guard vessel escorting the rotation and reprovisioning operation of the Armed Forces collided with a bigger Chinese Coast Guard

ship Tuesday morning – the first serious incident reported since diplomats from both sides held talks in Shanghai on Jan. 17 to deescalate tensions in the waters.

Philippine vessels were on their way to the grounded ship BRP Sierra Madre in Ayungin Shoal to deliver supplies to Navy personnel stationed in the area when the incident happened.

China was of course quick to defend its actions, saying Philippine vessels trespassed into Chinese territory, which is not legally correct since an arbitral ruling by the The Hague-based Permanent Court of Arbitration in 2016 ruled overwhelmingly in favor of the Philippines.

It determined that major elements of China's claim – including its nine-dash line, recent land reclamation activities, and other activities in Philippine waters – has no legal basis.

World War II-era vessel BRP Sierra Madre has been at the Scarborough shoal, very near Philippine shores, since 1999 and serves as a Philippine military outpost at the tiny South China Sea feature, also known by its international name, Second Thomas Shoal.

Also known as Ayungin shoal, it is 105.77 nautical miles from Palawan and constitutes part of the country's 200-nautical mile Exclusive Economic Zone and continental shelf as provided under a United Nations convention.

Manila decided in 1999 to deploy a permanent station on Ayungin Shoal in response to China's illegal occupation of Panganiban Reef, also known as Mischief Reef, a Philippine territory, in 1995.

We quote again the European Union diplomat Veron, who said: "The EU reiterates the call for all parties to abide by the legally binding 2016 Arbitration Award and international law to peacefully resolve disputes, guaranteeing safety in maritime waters."

We raise our hopes the level-headed policy makers will see the wisdom in peacefully resolving disputes instead of using bully tactics.(manilastandard)

The ubiquitous street vendors' role in economy, governance, politics

Lately, the sari-sari store has been gaining a lot of notice. A recent report by analytics startup Packworks revealed that sales of sari-sari stores in the country posted a total of about PHP8 billion in sales last year. This whopping increase of about 21 percent in sales has prompted several people to notice the importance of the said stores to our economy. For the past few years, government agencies and private organizations have started several initiatives involving the said sari-sari stores. There are several capital assistance and entrepreneurship capacity-building programs that have been organized for sari-sari stores. This surge of support for the neighborhood small stores is a welcome development as they play an important role in communities all across the country.

There is, however, one more informal economic sector of society that needs the same amount or even more attention – the street vendors. The ubiquitous Philippine street vendors come in all shapes and sizes. You can see these instant stores using small boxes, tables, rolling carts, modular wooden structures,

tents, and any other structure that is easy to build and dismantle. They are a staple in any urban area with a high degree of foot traffic. They are the primary source of income for many Filipinos without the skill, education, or resources to find alternative means of earning a living. Unfortunately, the business and regulatory environment covering street vendors in our communities is often harmful to the said street vendors.

In local government development plans, the needs of street vendors are disregarded or seen as a hindrance. When urban development hits areas where street vendors are located, they are often evicted with little or no social protection or alternatives. Admittedly, the unregulated proliferation of street vendors can have negative effects in terms of traffic, public order, and public health. These negative effects, however, can be mitigated or lessened with a concerted effort by both public and private organizations in properly organizing and monitoring these street vendors.

It must be emphasized that street vendors play an important role in the informal economic environment. Street vendors can create additional jobs not only for themselves but for porters, transport operators, storage providers, and other related services. The

government can also obtain income from licenses, permits, fees, and fines. Ideally, street vendors can also account for about 25 percent of the gross domestic product of our country. Like sari-sari stores, they can provide needed goods and services to those who must buy life's necessities in very small quantities at affordable prices.

An empowered and capacitated street vendor sector can contribute to governance by acting as listening posts and communication platforms for local governments and their projects. They can even be force multipliers for traffic enforcement and delivery of basic services. In politics, street vendors can serve as leaders and message delivery platforms for a candidate as they are able to develop networks in any community.

There is no question that street vendors can have a large contribution to many things in a community. As such, they, too, deserve much support from all sectors of society.

Background

The Theatre of War

As I write this, the world is submerged in the quagmire of volatility, uncertainty, complexity, and ambiguity as the consequence of the horrible Russian full-scale invasion of Ukraine and the infernal war between Israel and Hamas war in Gaza.

While the world nervously ponder the future of this intractable wars, Ukraine is in a surrealistic situation. Without support from NATO, with the European Union financial support blocked by Hungary, while the West seems stymied to extend assistance, and with American additional aid stalled in bipartisan political gridlock in the U.S. Congress, Ukraine is agonizing in perplexity how else to respond to the aggressive and continued Russia aggression.

Meanwhile, the brutal Israel-Hamas war is spreading across borders between Israel and Gaza, Jordan, Lebanon, Iraq, Syria and Yemen. This historic internecine war is intersecting now with other Middle East conflicts. With Iran purportedly supporting the militias, believing that it can protect the Palestinians against Israel, and with proteges, like the Houthis wrecking havoc on container ships transporting supplies of crude oil, gas, fertilizers, wheat and agricultural commodities, and obstructing freedom of International navigation across the Panama Canal, the Red Sea, and the Mediterranean Sea will be, inevitably, embroiled in this historic war.

Experts analysis show that, unless a mutually acceptable and satisfying path to peace can be agreed soonest, this violent conflict could engulf the Middle East region and, possibly, trigger a cataclysmic war that could become the next

armageddon.

However and whatever the future of this genocidal conflicts, it becomes a litmus test for democracy. This is also a crucible for America's leadership and credibility. The world is watching closely whether the United States can sustain its influence and continue providing protective shield or security umbrella to its friends and allies.


Complicating the fragile situation is the tense relations between the United States and Russia, and the accelerating deterioration of America and China relations. The latter insist adamantly that Taiwan is an inalienable part of China. While America underscores that it is not supporting the independence of Taiwan, it continues to supply weapons through commercial sales to Taiwan, to enhance its defense and security against possible attack by China.

Compounding the imploding situation is North Korea's provocative firing of its latest and biggest missiles amidst the increasing tension with South Korea and the United States. Accordingly, these new breed of missiles could hit targets as far as 9,000 miles away as Guam and the Okinawa Islands of Japan including the U.S. mainland.

This egotistical exhibition of hypersonic missiles by North Korea, may have been encouraged by its deepening alliance with Russia and its Mutual Aid and Cooperation Friendship Treaty with the People's Republic of China. This intimidating display of powerful weaponry by North Korea, thus triggered an eerie feeling that is now pervading the atmosphere worldwide.

The emissions from this internecine conflicts have inescapably impacted across the globe. Obviously, it has impeded and disrupted the

world supply chain and production timelines worldwide. The impact triggered increases of prices



of crude oil and vital commodities beyond affordable level, thus compromising food security for the whole world, especially for countries who cannot produce food for its constituencies. From the context of the world's interdependence and interconnectivity, no country including the Philippines can isolate and be immune from its collateral damages.

Located at the confluence of maritime International trade routes in Southeast Asia, the Philippines has become a prisoner of geography. Given its position in the West Philippine Sea, it has been canalized into a territorial trap or in a geographic straight jacket. As the crossroad of the strategic geographic, economic, political and security competition between America and China in the South East Asia and Indo-Pacific Region, the Philippines has become hostage of the deepening and tense enmity between America and China.

The confluence of instabilities and uncertainties now obtaining is pushing the world to the brink of destruction. Thus, in a speech during the recently concluded Munich Security Conference, the UN Secretary General was prompted to warn that "our world still face nuclear dangers and . . . we are also dealing with the existential challenges of climate crisis and the risks of of uncontrolled artificial intelligence". Safety, fair play in the motorcycle taxi industry

With many Filipinos required to report physically to work whether daily or a few days a week, many have become dependent on alternative modes of transportation including motorcycle taxis to beat traffic in Metro Manila.

Despite the safety concerns hounding motorcycle taxi operations, it has become apparent that more commuters are using transportation network vehicle services (TNVS) as their preferred mode of transport. After all, it cannot be denied that traveling via TNVS significantly cuts travel time compared to commuting via jeepneys, buses, and passenger vans, admittedly for a higher fare.

President Ferdinand R. Marcos Jr, in a recent Facebook post, expressed interest in relaxing the regulations on TNVS, saying "more transport options will benefit commuters, drivers, and MSMEs (micro, small and medium enterprises)."

While more transport options are a welcome development for commuters, there is a need to strengthen regulation of the TNVS sector in a bid to promote road safety, encourage market competition to prevent monopolies and ensure fair play for the benefit of drivers, passengers, companies and even the government.

This need stems from the fact that our Filipino commuters deserve safe, affordable, and comfortable transportation options. The Land Transportation Franchising and Regulatory Board's (LTFRB) motorcycle taxi pilot study is already a step in the right direction to ensure that public transport rules and

regulations do not only meet the needs of commuters but also uphold integrity and accountability.

The pilot study is a critical point in the regulation of motorcycle taxi operations as it serves as an opportunity to address various concerns about the sector—ranging from safety, and service quality, to market share. Playing favorites at this stage will do the industry no good since it will only negate the essence of the study.

It is in this light that we must have discussions involving commuters, riders, motorcycle taxi operators, the regulator, as well as policymakers to achieve a balanced and effective regulatory framework that meets the needs of all stakeholders.

With the rapid growth of this sector, a regulatory framework for motorcycle taxi operations has become not only a necessity but an imperative. By formalizing the rules and regulations governing the motorcycle taxi industry, accountability is established for all stakeholders—government, operators, and riders.

It must also be emphasized that the government bears the responsibility of ensuring that the regulatory framework for motorcycle taxi operations promotes fair play in the sense that all operators meet the same requirements and undergo similar and strict licensing procedures to prevent monopolies. Of course, it goes without saying that achieving this requires the cooperation of all stakeholders particularly those from the private sector.

BFP logs 88 fire incidents in Antique, urges public to be vigilant

BUENAVISTA, Antique -The Bureau of Fire Protection (BFP) called on the public to be vigilant as 88 fire incidents transpired in Antique during the first two months of 2024, with damage amounting to PHP46.78 million.

BFP-Antique Provincial Fire Safety Enforcement Section officer in charge, Senior Fire Officer 1 Jefferson Cordero, said in an interview on Tuesday that fire spreads faster because of the drought.

"We would like to

SAN JOSE DE remind the public to make sure that they don't just indiscriminately throw their cigarette butts and to make sure that they put out the open flame from rubbish fire," he said.

Of the 88 incidents, 17 were grass or forest fires, and the rest were industrial, residential, and other types

Last year, they only recorded 25 fire incidents over the same period.

The BFP has established the Community Fire Auxiliary Group (CFAG), especially in the remote barangays, serving as their first line of defense.

"The BFP-Antique had been conducting CFAG training participated (in) by barangay officials and other community folks on basic rope technique, bucket relay, and emergency services that they were able to assist us," he said.

He said the CFAG helped the BFP suppress the forest fire that damaged about 20 hectares of agricultural and protected areas in Anini-y town on Feb. 12-13.

Gov't troops heighten pursuit ops vs. fleeing rebels

Government troops have intensified their pursuit operations against rebels who fled in the hinterland parts of San Joaquin in Iloilo following the Feb. 28 encounter that left four members of the Southern Panay Front, Komiteng Rehiyon Panay (SPF-KR-Panay) of the New People's Army killed and the capture of another.

Brig. Gen. Michael Samson, commanding officer of the 301st Infantry Brigade of the 3rd Infantry Division, Philippine Army, said the continued focused military operation aims to prevent the remaining forces from conducting atrocities.

"This is a big operation because, for us, we were

ILOILO CITY - able to prevent a possible tactical offensive against our government forces or our communities as a whole," Samson said in a media interview on Monday at the Police Regional Office 6 (PRO6) headquarters here.

> PRO6 acting Regional Director Brig. Gen. Jack Wanky led the presentation of recoveries at the encounter site and processed by the Philippine National Police Scene of Crime Operation, consisting of four M16 rifles, one tactical rifle, four grenade launcher ammunitions, three bandoliers, 13 pieces empty magazines, 283 pieces of 5.56 mm cartridges, and 17 pieces of 7.62x39mm cartridges.

The four rebels killed in the encounter were identified as Rena Rhea Camariosa, second deputy secretary of SPF-KR Panay and resident of Barangay Manampunay, Leon; Jonathan Sasi Sanogal of Barangay Palaca, Miagao, all from Iloilo; and Patrick both from Barangay Alegre, Sebaste, Antique. (PNA)

"On our part, we want to replicate it on the north side. Everything starts at home; we'd like to hopefully succeed here also then we start going out and pushing it to other provinces," he added.

Administration (NIA) assured rice farmers served by the Bago River Irrigation System (BRIS) in Negros Occidental of maximum availability of water supply amid the drought due to El Niño experienced by the province.

Engr. Isaias Melendez, division manager of NIA-Negros Occidental Irrigation Management Office (NOIMO), said on Tuesday that they regularly monitor the water level in the Bago River Dam and in the main canals to determine how many hectares can be irrigated by the current level.

"The NIA, for the main conveyance structures, will see to it that maximized availability of water from the dam can be supplied and
