On the other hand, the city mayor mentioned that the supply of water was added with 10,000 mlg as the Metro Pacific Iloilo Water (MPIW) negotitated with Prime Water Infrastructure Inc. (PrimeWater) to use the latter's line as one of the water sources.

"May dugang kita nga 10,000 mlg because of the line nga iya sang Prime nga negotiate sang MetroPac nga bayran nila ang Prime para mausar ang ini nga linya," Treñas added.

Treñas cited that MPIW distributes water to limited percentage such as 27% out of the total city population since many people are still depending to get water on shallow wells.

Meanwhile, the city mayor also cited that the city government shall look upon solutions and will decide on what to do regarding water supply in the city.

"Ang ulihi ko na to nga instruction, tan-awon ang mga barangays with water tanks and i-check kung diin pa nga barangay ang gaandar ila water tanks kay te in case maka declare kita state of calamity due to water supply, then makabalo kita kung diin kita mapadul-ong sang tubig," said Treñas.

Additionally, MORE Power eligible customers are also informed and reminded through calls and text messages of their entitlement, should they have missed the initial communication.

"We are committed to ensuring that all eligible customers" are aware of their entitlement to a bill deposit refund. Our proactive outreach aims to streamline the process and maximize the benefits for our valued consumers." Ma. Cristina Cabalhin, VP for Customer Care, stated emphasizing the importance of these outreach efforts.

MORE Power reiterates that ineligible customers who have not met the criteria for refund eligibility can still receive their bill deposit upon termination of their electric service, with an annual interest rate.

# **NO LOCKDOWN, NO TRAVEL RESTRICTIONS IN ILOILO CITY DUE TO PERTUSSIS**

following the declaration of pertussis outbreak and placing the metro under the state of calamity.

Mayor Jerry P. Treñas said the city government through the City Health Office (CHO) under Dr. Annabelle Tang and concerned city hall departments have taken proactive measures to prevent the spread of the disease that mostly affects infants and young children.

"Placing the city under the state of calamity paved the way for us to strengthen our outbreak response. But I would like to reiterate that we don't impose lockdown," Treñas stressed.

The City Hall has been receiving information about an alleged lockdown in Iloilo City due to pertussis, causing worry and averting others from pursuing their visit to the city.

Based on CHO data, confirmed cases of pertussis remained at nine.

In an advisory issued by CHO, it emphasized that the in-place proactive measures have established a protective barrier within the community, eliminating the need for travel restrictions to and from the City of Iloilo, and negating the necessity to cancel mass gatherings such as conventions, concerts, and similar events. It, however, strongly advised to strictly adhere to minimum public health standards.

"It is crucial to stay informed with accurate information about pertussis. Knowing the correct information will enable you to take proper preventive measures and avoid undue worries. Stay updated through official announcements from

The Iloilo City Government is on top of the situation the Iloilo City Health Office and trusted health authorities," the CHO advisory further read.

OUTBREAK RESPONSE

The following proactive measures are being implemented by the CHO against pertussis:

\*Community Awareness Activities: Public information campaigns have been launched to raise awareness about pertussis, its symptoms, and preventive measures.

\*Intensified Vaccination Campaign: An enhanced vaccination campaign against pertussis and other vaccinepreventable diseases is being conducted in various community settings.

\*Intensified Surveillance: Disease surveillance systems have been reinforced to swiftly identify, manage, and track the spread of pertussis within the community.

\*Active Collection of Samples: Samples are actively collected from probable cases and stored at the USWAG Molecular Laboratory for confirmatory tests at the Research Institute for Tropical Medicine (RITM) to accurately diagnose and manage pertussis cases.

\*Referral to Hospitals for Isolation, Detection and Treatment: In the event of a probable or confirmed pertussis case, referral to hospitals for appropriate medical treatment and isolation is implemented.

The Health Office has also recommended to the public to maintain hygiene practices.

The practice of good hand and respiratory hygiene include regular handwashing with soap and water, covering coughs and sneezes with a tissue or elbow, and maintaining distance from individuals who are ill. (Iloilo City PIO)

# Iloilo to disperse swine to help farmers cope with El Niño

ILOILO CITY – The provincial government has allocated PHP9 million for swine dispersal as a response to El Niño, initially targeting 15 municipalities situated in areas not affected by the African swine fever (ASF).

"We want to have a program that is El Niño-oriented. The assistance, instead of farm inputs, we will disperse animals that are not too dependent on the rain and the like," Iloilo Governor Arthur Defensor Jr. said in a press conference on Tuesday.

Defensor said it is another adjustment of the provincial government, aside from the existing program in agriculture.

"The swine approach is an adjustment. We turn to the animal industry," he added.

The scheme is also one way of helping the swine industry increase its inventory amid the ASF.


The PHP9-million budget covers the PHP6.93 million for the purchase of swine and PHP2.07 million for feeds.

Provincial Agriculture Office chief Dr. Ildefonso Toledo said the province will download the funds to municipalities that will identify recipients.

Each recipient is expected to get two piglets for fattening.

Losses due to drought per PAO-validated data reached PHP526.61 million, covering 9,528.18 hectares of high-value crops, rice, and corn and the fishery sector affecting 10, 292 farmers and fisherfolk from the 17 municipalities of the province.

Defensor said the cost of damage may increase as the El Niño progresses until May. "Our projection is until May. We will continue to implement our measures and extend as much as we can," he added. (PNA)





# 2 Antique towns badly hit by El Niño; Sibalom in state of calamity

SAN JOSE DE BUENAVISTA, Antique – The El Niño phenomenon has adversely affected two municipalities in the province of Antique.

Antique Provincial Disaster Risk Reduction and Management Officer (PDRRMO) Broderick Train on Tuesday said the municipality of Sibalom is already under a state of calamity, while the town of Anini-y gears to declare in the next few days.

"The local government unit of Anini-y informed the PDRRMO only yesterday that they are now preparing their damage report so they could also declare a state of calamity following Sibalom," Train said in an interview.

A report from the Sibalom municipal DRRM office,

covering 52 of the 76 villages, showed losses to rice crops already amounted to PHP42.5 million; corn, PHP407,790; and high-value crops at PHP31 million as of Jan. 30.

MDRRMO Joel Odango said that in addition to the damage to crops, eight villages are experiencing a shortage in potable water supply, namely Lacaron, Mojon, Igsuming, Maasin, Tula-tula, Igdalaquit, Calo-oy, and Salvacion.

"With the declaration of the state of calamity in Sibalom, the LGU (local government unit) has allocated PHP2 million for the procurement of water tanks for barangays suffering from water shortage," he said.

The Bureau of Fire Protection also conducts water rationing to requesting villages. (PNA)

# ILOILO CITY ELIGIBLE TO BE DECLARED ASF-FREE

Iloilo City is now eligible to be declared African Swine Fever (ASF)-free, based on the assessment made by the Department of Agriculture (DA) Western Visayas.

DA-6 regional executive director Dennis R. Arpia, in a letter to Mayor Jerry P. Treñas, informed the latter that the required documents submitted by the city government for the local declaration of "ASF-free" was found in compliance with Sections 4.1 to 4.2 of the DA Administrative Order No. 30 Series of 2021 "Guidelines for the Recovery and Declaration of Freedom from African Swine Fever (ASF) for Local Government Units (LGU).

"With this, may we recommend based on the guidelines stated in the related policies the City of Iloilo may now

pursue your 'Local Declaration for ASF Freedom', Arpia said as he further commended the efforts of the Iloilo City Task Force African Swine Fever (TF-ASF) against the hog disease.

Meanwhile, Treñas said the city has already opened its

borders to hogs and pork products from other areas.

The city mayor is hopeful that with the declaration, the city hog raisers will gradually start to repopulate, and the prices of pork will eventually go down.

# No whooping matter

Many people returning from their Holy Week break or first summer vacation are regretting their return to the work place. Some friends have shared that their office felt more like an "infirmary" or a clinic than an office, with a number of officemates showing up even when they were clearly sick or under the weather.

I don't know if it's a defensive mechanism or an act of denial, but folks immediately say they just have a cough and a slight fever or at the most they have the flu. I noticed that the other "C" word, meaning COVID, is frowned upon as well as any suggestion to get tested. Some people even view the wearing of a face mask as a sign of illness and not as a health and safety precaution as well as being considerate of others.

The good news is that the vaccination programs against COVID has stopped the outbreak of COVID or minimized its effects so much that it can now be managed at home with the typical fluids and bed rest routine. The bad news is that after COVID or the flu, we now have another disease that has been declared as a health concern.

I refer to the "whooping cough" which many people ignorantly treat as a minor ailment that affects children. This very cavalier attitude towards such a serious disease or infection is the result of our overall attitude that a cough is nothing serious.

I suppose that mindset is what develops when "cough" syrup is pushed, promoted or advertised more than anything we really need in the kitchen. There was a time when cooking oil and others got a lot of air time on radio and TV, but nowadays, the competition and advertising for cough syrups and remedies is so strong some brands even put down generics or herbal based cough syrup.

As a result, Filipinos now assume any cough is just a cough. They could have TB but it's just a cough until a fever sets in or blood spots show up. It's just a cough until blood tests indicate something strange and further tests indicate leukemia. It's just a cough until you can barely breathe and then die from asthma complications. Maybe it's time for legislators and health officials to rethink prescriptions for cough medicines.

Whooping cough is not "just a cough." Please read the health advisory from the Philippine College of Physicians that Dr. Rontgene Solante shared with me this Easter Sunday. This is a shortened version:

Philippine College of Physicians Position Statement on the Current Pertussis Outbreak in the Philippines

The Philippine College of Physicians (PCP) is deeply concerned with the recent increase in pertussis cases, commonly known as whooping cough, in the Philippines. In the first 10 weeks of this year, the Department of Health (DOH) has reported over 500 cases with 40 fatalities, and the declaration of outbreaks in Quezon City, Pasig City, Iloilo City and Cavite.

1. Pertussis is an acute respiratory infection caused by the bacteria Bordetella pertussis. The infection poses a significant threat particularly among infants and young children who are at risk of severe symptoms and life-threatening complications and outcome. While teens and adults may experience milder symptoms, there is a risk of severe illness, especially for those with pre-existing health conditions and the unvaccinated elderly population.

2. The PCP fully supports the DOH's call in promoting enhanced vaccination campaigns nationwide to increase vaccination coverage and protection of all infants and children to vaccine preventable diseases. We urge all stakeholders, health care providers, local government units, and community leaders to collaborate in preventing the spread of pertussis and other vaccine preventable infections including measles, diphtheria, influenza and pneumonia.

3. The PCP emphasizes the critical role of vaccination as the most effective method for preventing outbreak. PCP highly recommends getting a single Tdap vaccine for:

3.1 Infants and children

Three-dose primary immunization series with DTaP

# Death knell

Members of the House of Representatives were hoping for a dialogue with senators on Charter change while Congress is not in session, during the long break starting before Palm Sunday.

Alas, it was not to be. Senate President Migz Zubiri took off for Switzerland for the annual assembly of the Inter-Parliamentary Union in Geneva, during which he called for a "pause" to war – not the one raging between the two chambers of the Philippine Congress over Chacha, but global wars.

Other senators must have left the country as well to get away from the scorching heat not just from El Niño, but also from the House nagging to get to work on Cha-cha ASAP because time is running out. On what? The Marcos administration has four more years to go. stressed that PI is merely suspended.

But if PI is revived, will President Marcos – a believer in reliable surveys as far as we can tell – go along with it, considering that overwhelming 88 percent opposition to Charter change? That number is about as high as the consistent results of polling on Filipino sentiments against China on West Philippine Sea issues.

BBM had previously said (at least according to Senator Migz) that he wanted the Senate to take the lead on Cha-cha. But it looks like senators are enervated by the scorching Philippine summer, like those poor public school students and teachers, and would rather wait for the cooler months to get down to the complicated task of amending the Constitution.

Alongside the survey on Cha-cha is a commissioned one, conducted by Pulse Asia, which must also be bad news for the House and its leadership: Sen. Raffy Tulfo and Vice President Sara Duterte are statistically tied (with a difference of one percent) for the 2028 presidential race. In the commissioned survey on 2028 "presidentiables" taken in April last year by the other reputable pollster, Social Weather Stations, VP Sara topped the list at 28 percent – a wide margin from Tulfo's 11 percent. The margin could be wider if the three percent of the VP's father former president Rodrigo Duterte (at fourth place) would be added to her rating.

Studies have consistently shown that pertussis vaccine (Tdap) significantly decreases the incidence of pertussis by over 92 percent and 97 percent in reducing mortality rates. In fully vaccinated individuals the symptoms tend to be less severe, with a reduced likelihood of experiencing prolonged coughing spells, apnea and cyanosis. Extensive safety evaluations have confirmed that Tdap vaccines are safe for use in children and adults, pregnant women and seniors over the age of 65, with no unexpected safety concerns reported.

4. The PCP urges parents and caregivers to be vigilant for symptoms of pertussis – cough, colds, fever – and to seek prompt medical attention.

Early diagnosis and treatment are key to improving patient outcomes and reducing transmission.

#### And who would lose?

The same survey frontrunners, who could suffer the fate of former vice president Jejomar Binay and former

But the 19th Congress is counting down to the end of its three years in 2025.

The senators will likely prolong their vacation. Spring, with its pleasantly cool temperatures, has started in the Northern Hemisphere. And then there's that survey conducted from March 6 to 10 by Pulse Asia, showing a hefty 88 percent of Filipinos opposing Charter change. So there's no reason for the senators to cut short their vacation and rush back home to discuss Cha-cha with House members.

Because of the reputation of Pulse Asia, this survey could be the death knell for the latest push for Cha-cha as envisioned by the House.

Unfortunately for the folks lambasting the Chacha survey, Pulse Asia is not one of those fly-bynight pollsters that provide the results sought by the commissioning client. Polling costs millions and such clients should find either a credible pollster, or better uses for their money. While Pulse Asia also conducts commissioned surveys, the one on Cha-cha is noncommissioned.

\* \* \*

The comments from several key House members on the Pulse Asia survey indicate a chamber in panic mode. Will they shift to Plan B (or is it Plan A, the original?) and proceed with the people's initiative to rewrite the Constitution? Several House members have Former VP Leni Robredo came in third at six percent. She also placed third in Pulse Asia's poll taken last month. This latest survey was conducted amid what VP Sara described as an organized smear campaign against her.

Also noteworthy is that in both surveys, VP Sara's ally Sen. Imee Marcos was among the respondents' picks – fourth in Pulse Asia and seventh in SWS. Meanwhile, the VP's nemesis, Speaker Martin Romualdez, was not among the choices in SWS. In Pulse Asia, he merited mention, but with a preference rating of less than one percent.

\* \* \*

Since the poll last month was commissioned, Pulse Asia can't be criticized for conducting a survey House speaker Manny Villar. "Presidentiables" who peak early also draw enemies early along with special operations to bring them down.

VP Sara is seeing this now; Raffy Tulfo could soon see the same.

Yesterday, Pulse Asia released the results of its performance survey on the top four officials of the land, taken on March 24 this year and compared to the ratings on Dec. 23, 2023. This survey showed the VP's performance rating down by seven points, from 74 percent in December to 67 percent last month.

BBM suffered the worst drop among the four top officials: 13 percent, from 68 to 55 percent. He should wonder if his favorite cousin is dragging him down. Speaker Romualdez saw his rating fall by eight percent in the same survey, from 39 percent in December to 31 percent.

The main controversy last month was not rice or inflation, but Cha-cha. Surely BBM sees the significance of Migz Zubiri, beset by coup rumors amid his reluctance to dance the Cha-cha, being the only top official who registered an improvement in his performance rating, from 49 percent in December to 52 last month.

How might pro-Cha-cha congressmen react?

Why, they might go to the Supreme Court, to stop those pesky surveys.

# City gov't to provide pregnant mothers with vaccines vs. pertussis

As the children are more vulnerable to pertussis or whooping cough outbreak, pregnant mothers are highly encouraged to participate in vaccination for the welfare of their babies.

Iloilo City Mayor Jerry Treñas has reminded them to also get vaccinated for the prevention of the said respiratory illness, stating that there are vaccines provided for them in health centers.

"Sa indi kasarang magkadto sa aton health centers, sa mga nanay nga nagabusong, gakadto sa mga sentro, may mga bakuna kita nga gina procure," Treñas said.

The cases of the said respiratory illness have already reached to 22 with nine confirmed cases as of April 2, 2024 based on the report of Iloilo City Epidemiology and Surveillance Unit (ICESU).

The city mayor cited the significance of vaccination for pregnant mothers which is to prevent their babies from becoming carriers of pertussis or whooping cough.

"Importante nga ang mga nanay antis sila magbata kinanglan mahatagan na sila bakuna. We will procure vaccines so that we can even immunize the mothers who are pregnant," Treñas added.

Treñas also encouraged those who could afford private doctors or pediatricians to have their children vaccinated for pertussis.

"Sa aton ya mga ginikanan, sa makasarang nga madala nila ang ila kabataan sa ila pediatrician, ipa injectionan na nila," Trenas stated.

In addition, Treñas also mentioned that the city government shall also provide for additional vaccines once needed as the city also grapples along with other local government units (LGUs) in procuring vaccine supplies.

"Kita ta ang data sang Iloilo City, but kung tan-awon ta may ato na to sa QC, may ara sa Cavite, may ara sa iban nga lugar, I think pertussis is all over the place because of the lack of vaccines," Treñas emphasized.

Meanwhile, Iloilo City has been declared under state of calamity last March 26 by the Sangguniang Panlungsod (SP) due to pertussis wherein a quick response fund (QRF) amounting to P16 million out of the city's calamity fund will be used to procure supplies of vaccine for children in order to prevent the said respiratory illness.

# LGUs urged to support gov't flagship housing project

ILOILO CITY – Iloilo City Mayor Jerry Treñas urged other local government units (LGUs) in the country to support the Pambansang Pabahay para sa Pilipino Program (4PH), the flagship housing project of the Marcos administration that provides opportunities

With no other source of income, she opened a sarisari store business using the money she had saved from her previous job. She also did not consider looking for another employment as she was pregnant with her firstborn that time.

Initially, her store did not do well due to the small number of people in the neighborhood. However, as more family resided in the area, her business progressively improved; from an initial capital of PHP 2,000.00, she now has a capital of about PHP 200,000.00.

According to her, she would not be able to afford to expand her store without the assistance of CARD SME Bank, a thrift bank that offers business loans to micro,

small, and medium entrepreneurs.

At first she was skeptical to join, but after gaining positive feedback from the neighbors she decided to become a client of the bank in 2013. She used her initial loan of PHP 5,000.00 as an additional capital for her sari-sari store business. Currently, they own two tricycles, which they purchased with the money earned from their store.

Being a good payer that she is, she now has increased her loan into PHP 150,000.00. When she's in need of capital, CARD SME Bank is always there to support her and provide the needed capital to operate her business. Roland Samuel Young and



# **Challenging cascade**

These, amid what authorities call the peak impact of the El Niño phenomenon which typically leads to reduced rainfall in Southeast Asia where the Philippines is.

From droughts and water scarcity to crop failures, forest fires, and economic disruptions, its impact is felt across many sectors of society.

This phenomenon disrupts the monsoon patterns, causes prolonged droughts and water scarcity in many parts of the region, with rivers and reservoirs drying up, making it difficult for communities to access clean water for drinking and agriculture.

**Presidential Communications Office Assistant** Secretary and Task Force El Niño spokesperson Joey Villarama told a Bagong Pilipinas Ngayon briefing on Monday "What we are asking is to avoid careless, limitless use of electricity and water resources."

We are aware and are delighted the government is closely monitoring the effects of El Niño, considering the increasing water demand, but Villarama assured the public that contingency measures are in place.

There is also the possibility of weaker water pressure or water supply shortage is still there, because the water level of dam, particularly the Angat dam is declining.

To date, 80 of 82 provinces are already affected by the El Niño, with 16 under a state of calamity.

It is gratifying the National Water Resources Board has released advisories for water conservation to public pools in subdivisions, condominiums, and other household settings.

The El Niño Task Force has been instructed by President Marcos to secure a comprehensive disaster preparedness and rehabilitation plan and ensure "systematic, holistic, and results-driven interventions" to aid the Filipinos and alleviate the devastating effects of disasters.

El Niño's typical impact on Southeast Asia is drier-than-average rainfall conditions, including for much of the Maritime Continent during December to February and warmer temperature conditions typically follow drier periods.

El Niño's impacts on infectious disease spread, malnutrition, and respiratory and mental health varies across different regions.

The most affected areas include: Latin America, and the three members of the Association of Southeast Asian Nations: the Philippines, Indonesia and Malaysia.

El Niño has also historically impacted livelihood and health by causing extreme droughts and severe flooding in many countries.

In an agricultural country like the Philippines, where dry spells and droughts are expected, this could mean crop failures affecting food production.

The majority of global climate models suggest that El Niño will likely persist until the March-April-May 2024 season, with a transition to ENSOneutral conditions expected in the April-May-June 2024 season – referring to the El Niño-Southern Oscillation, a recurring climate pattern involving changes in the temperature of waters in the central and eastern tropical Pacific Ocean. (manilastandard.net)

At the peak of the Holy Week exodus, the Ninoy Aquino International Airport (NAIA) once again made headlines for the wrong reasons.

Travelers—many of whom are rushing for a reprieve from the hectic city life, or to be with their families for the break-had to endure the sweltering heat at the NAIA Terminal 2 on Holy Wednesday due to power fluctuations.

According to the Manila International Airport Authority (MIAA), the problem was due to a high power load triggered by the high heat index outside of the terminal. Meralco clarified that there was no problem in terms of power supply which was confirmed by MIAA as well.

While operations in check-in counters, baggage handling systems, and security remained functional thanks to generators, it was not enough to power the air conditioners, thus the discomfort to travelers rushing on the eve of the Easter Triduum. The MIAA brought in industrial fans to ease travelers' discomfort.

What makes the situation more disappointing is that the MIAA had repeatedly assured the public of the airport's readiness for the expected influx of travelers for the Holy Week break. Over a million passengers were recorded by MIAA from Palm Sunday to Easter Sunday.

This is not the first time that the country's main gateway was beset with problems during a crucial travel period. NAIA made international headlines on New Year's Day 2023 after technical issues forced a shutdown of the Philippine airspace.

News reports in the days leading to the Holy Week break also highlighted new and old problems in NAIA. From bed bugs to rats at airport terminals, issues hounding the gateway highlight the fact that NAIA badly needs private sector intervention.

I share the view that public-private partnerships (PPPs) offer an effective way forward to addressing situations that require urgent attention and action for the collective benefit of the public. This is why the looming entry of a private consortium to manage and upgrade NAIA is a welcome development.

If any, the Holy Wednesday incident serves as a major challenge to the consortium led by San Miguel Corp. (SMC) to drastically improve the situation at the airport to deliver a well-deserved pleasant experience to our travelers. Hopes are high that NAIA will soon be at par with South Korea's Incheon airport given that the latter's operator is part of the consortium.

We Filipinos deserve better. Our visitors deserve better.

While we have yet to see how the SMC-led consortium will rise to the challenge, I am optimistic given the group's commitment to invest over PHP122 billion for the NAIA modernization program within a period of 25 years.

In the case of NAIA, the private consortium is expected to bring the much-needed upgrades to airport services not only for the well-deserved convenience of our travelers but also to drive economic growth and improve the Philippines'

image and reputation to the international community.

By taking over the maintenance and management of the airport, the private sector effectively shares its wealth of resources, expertise, and experience to deliver quality essential services and projects to the public in the most effective and efficient way possible.

It must be noted that with PPPs, private sector investment is maximized for the collective benefit of the public. By relieving the government of airport maintenance and management costs, public funds can be allocated for other social services or projects that require additional financial support.

# The tattoo prank: Online responsibilities and liabilities

"It is not only for what we do that we are held the issue. Given the circumstances, would the food responsible, but also for what we do not do." -Moliere

For the past few days, several netizens have been mesmerized by the story of a food store owner who came out with a rather unique challenge.

In an online post, the food store owner issued a challenge wherein the same would pay PHP100,000 to anyone who would tattoo the store's logo on his/ her forehead. The post came out on April Fool's Day and it was apparently a prank, according to the online creator/food store owner who also pointed out that once anyone clicks the photo for instructions, then the phrase April Fool's would be clearly seen emblazoned at the bottom of the post.

Unfortunately for the said food store owner, someone actually allegedly took the challenge and had himself tattooed and wanted to claim the prize. The tattooed person, allegedly, badly needed the money and did not notice the phrase April Fool's.

Initially, the food store owner denied that he had any liability and argued that the post was clearly an April Fool's Day prank. He then blamed the tattooed person for having a low reading comprehension. A veritable online storm ensued. Thousands of netizens bashed the food store owner as being insensitive. At the end of the day, it was the food store owner who settled the matter when he eventually gave the prize money to the tattooed person.

Despite the settlement, numerous debates on online responsibility and even liability still surround store owner be held liable if the tattooed person had rejected the offer and sued him? This would have been an interesting case.

Some opined that the food store owner cannot be held liable as there was no obligation created on the part of the said food store owner. They say that the tattooed person was negligent and did not exercise the appropriate diligence when he read the post. On the other side of the fence, some say there was a contract created when the food store owner posted that challenge, and someone accepted. There are even some people who suspect that the entire incident was just a scripted incident to get folks riled up and garner views and comments.

Obligations are created by contract or law. One of the requisites of contracts is consent. Consent is created when there is an offer and acceptance. It can be argued that there was no valid offer by the food store owner. Under the law, however, when someone causes damage to another due to negligence, then, policing the posts made in their spaces, all sectors that person should compensate the other. It is dangerous to assume that everybody can understand the nuances of an online post, especially a prank.

It is also inherently wrong to pin responsibility on the victims of online pranks and irresponsible posts. Even if there was a degree of negligence by the reader of the online prank or post, the said reader did not initiate the incident. When someone posts a prank, that person cannot then shift the obligation to be diligent on the reader. It is also not the fault

of the reader if he/she has a low level of reading comprehension.

Whether this entire matter is scripted or not, this incident should open the legal discussion on liabilities and responsibilities for online pranks and posts, in general. There is a growing number of incidents where online pranks go awry. There must be clearer legislation or rules on online pranks that cause damage to people.

Worse than online pranks, is the growing proliferation of fake online news or so-called product endorsements of products with dubious qualities. The internet is now filled with so-called fake celebrity endorsements of health food, treatments, and even beauty products. These products mostly have no Food and Drugs Administration (FDA) approvals. Not only is there negligence involved but also a probable degree of malice.

With some social media platforms easing up on of society must be active in preventing the ill effects of these social media maladies. Do we need a fatal incident arising from an online post before collective action is taken?

This is my oblique observation.

# How older Novaliches residents shed off unsavory alias names

I was born eight decades ago in a sleepy barrio of the former agricultural town of Novaliches, shared since 1948 by Quezon City and Caloocan City, two of the largest and most progressive cities in Metropolitan Manila at present.

My growing-up years coincided with the time when many of the inhabitants of my erstwhile town comprised farming families owning several carabaos and cows as they were then tilling more than 10,000 hectares of rice fields.

Some families also owned horses and raised goats, pigs, ducks and chickens for their milk, meat and egg needs.

While I was in the elementary and high school, I began noticing that many of the family heads in our man he was looking for.

One thing surprising about these unsavory assumed names was that many of those who were addressed as such seemed to have appreciated them rather than feeling insulted or being despised.

Some of those who used to have such unpleasant assumed names were uncles or relatives of this writer. They included "Tanasyons Ubag" (a kind of edible root crop), "Andoy Balunbalonan" (an inner part of a chicken), or "Selong Karayom" (a needle).

As the population of Novaliches began to increase rapidly since the 1960s, the use of such alias or "aka" names began to be discarded by former farm families. When the family heads died, the assumed names also began to fade away and the community soon forgot about them. The development of rice fields in Novaliches into subdivisions, factory sites and other housing projects and shopping malls also caused the gradual disappearance of farmers and carabaos from the area and were subsequently replaced by numerous motor vehicles of various types and sizes.

Nagkaisang Nayon, Capri, Novaliches Proper, San Agustin, San Bartolome, Kaligayahan, Santa Monica, Pasong Putik, Santa Lucia, Gulod, Bagbag, Talipapa, Sauyo, Pasong Tamo, Tandang Sora, Culiat, Sangandaan, Baesa, Balong Bato, Kangkong, and Unang Sigaw.

On the other hand, the Novaliches side that belonged to Caloocan included barangays Bagbaguin, Caybiga, Llano, Deparo, Bagumbong, Camarin, Bagong Silang, Tala, Malaria, Pangarap, Makatipo, Amparo, half of Baesa, Sta. Quiteria, and Talipapa.

These barangays also used to be called the "Sabah" of Caloocan for being detached from mainland Caloocan and cannot be reached by city officials without passing through portions of the adjoining cities of Malabon, Valenzuela, and Quezon from the Bonifacio monument in Grace Park and Balintawak. Also at that time, both sides of the narrow Quirino Highway from Balintawak, Quezon City to San Jose del Monte (now a city of Bulacan province) and Tandang Sora Avenue from Balara, Diliman, to Quirino Highway in Barangay Sangandaan and Sta. Quiteria were still dotted with rice fields and forests.

place, in addition to their traditional first and family names, often had "assumed or alias or also known as (aka)" names, oftentimes not nice to hear.

By using such "aka" or assumed names, they were easily identified in the place by strangers looking for them.

Such unpleasant aliases included common Tagalog words such as "kabayo" (horse), "gata" (coconut milk), "palayok" (pot), "kambing" (goat), "baboy" (pig), "asuwang" (vampire) "pato" (duck), "bagyo" (typhoon), "pulgas" (louse), "galapong" (powdered wet rice), "kalakian" (male carabao), "bayawak (lizard), "sapatos" (shoes), "patis"(brine), pugo (quail), "bangus" (milkfish), "pagong" (turtle), "bulig" (a small mudfish), and "balangkas" (house or building plan).

These words were normally attached or added as an adjective to the first names of male persons in the locality to make their identification easier.

For example, when a carabao of a farmer got astray and was found in a neighboring barrio, such work animal was usually identified as owned by someone more known as "Tonyong Kambing" in the locality.

Whenever someone came around asking for a resident of a certain place, the stranger was usually asked in turn about the alias name of the

These are now causing monstrous traffic problems in the former Novaliches town which many local residents consider as the traffic capital of Metro Manila.

Incidentally, there was also a time when Novaliches served as the "egg, meat, fruit, and vegetable basket" or the source of these farm products for residents of both QC and Caloocan City. That was until the early 1970s when Novaliches was still considered the "bukid" or farm area of its two mother cities.

The southern parts of both Quezon City and Caloocan at the time were already commercially developed and no longer fit for growing or raising farm products.

The then sparsely-populated barangays of Novaliches belonging to Quezon City were

The same was true with General Luis Street from Malinta, Valenzuela City; Susano Road from Novaliches-Bayan, and Zabarte Road to Camarin, North Caloocan.

The two sides of the northern half of the present Commonwealth Avenue were then victual wilderness serving as pasture land of rich families and politicians owning cattle and carabaos for milk and meat purposes, and even horses for racing.

At present, almost all rice fields and forests in Novaliches have been converted into sites for subdivisions, factories, shopping malls, and other commercial uses.

Even the former Girl Scouts of the Philippines (GSP) national camp along Quirino Highway in Barangay San Bartolome is now SM City Novaliches Mall.

#### **REGULATION ORDINANCE NO. 2024-024**

#### AN ORDINANCE INSTITUTIONALIZING THE LOCAL ECONOMIC DEVELOPMENT AND INVESTMENT PROMOTION (LEDIP) OFFICE, ENUMERATING ITS POWERS AND FUNCTIONS, AND THE TRANSFER OF SEVERAL PLANTILLA POSITIONS FROM THE CITY MAYORS OFFICE TO THE LEDIP OFFICE

Sponsored by Hon. Rex Marcus B. Sarabia, seconded by Hon. Ely A. Estante, Jr., Hon. Candice Magdalane A. Tupas and Hon. Johnny Y. Young;

WHEREAS, under DILG Circular No. 2010-113, the National Government directed the local government units to designate a Local Economic and Investment Promotion Officer (LEIPO) as an economic partner in attracting more investments to enhance local economic activities;

WHEREAS, further under DILG Circular No. 2020-167, the National Government has further enjoined all local government units to expand the designation of the Local Economic and Investment Promotion Officer (LEIPO) and to establish its corresponding unit or office to facilitate and coordinate local economic development and investment advocacies of the LGU and mobilize a capacitated structure to organize all programs and projects;

WHEREAS, the creation for such new office is allowed under Section 76 of Republic Act 7160 or the Local Government Code of 1991 states that: "Every LGU shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.";

WHEREAS, from the authorities, cited, the Local Government of Iloilo City through the Sangguniang Panlungsod is empowered by the law to create offices and positions as the need arises;

NOW, THEREFORE, be it ordained by the Sangguniang Panlungsod of the City of Iloilo, in session duly assembled, to enact the following ordinance

SECTION 1. DECLARATION OF POLICIES. The Iloilo City Government recognizes the importance of local industries and enterprises as essential partners in nation building; hence, it is of paramount public interest that the policy making processes of the City Government should incorporate the best interests of the former. Therefore, it is the declared policy of the City Government to facilitate the development and expansion of the local industries and enterprises and to stimulate economic activity and growth by inviting and encouraging investments, most especially in targeted industries wherein the City of Iloilo intends to competitively distinguish itself in the national and world economy.

The Iloilo City Government as well recognizes the power of education and the rapid exchange of technology to enrich local human resources to drive the progress of local industries. Therefore, it is the declared policy of the City Government to involve itself in the direction of the education and technology sectors in order to ensure the alignment of the skills, knowledge, and expertise of the workforce with industry standards as well as to address the present and future needs of the local, national, and international industries

SECTION 2. CREATION OF THE NEW DEPARTMENT. A new department under the lloilo City Government is hereby created to be known as the "LOCAL ECONOMIC DEVELOPMENT AND INVESTMENT PROMOTION (LEDIP) OFFICE".

SECTION 3. MANDATE. The Local Economic Development and Investment Promotion Office shall be the primary agency of the Iloilo City Government in handling all activities related to local economic development in Iloilo City which includes but are not limited to: investment promotion, establishment of support mechanisms for the growth of Micro, Small, and Medium Enterprises (MSMEs), prescribe speedy processes for the issuance of business permits and licenses. provide mechanisms to business retention and expansion and other business and economic activities to attract investments, generate employment, and promote industry innovations

The LEDIP Office shall also be responsible for the development and implementation of policies, programs, and activities for the alignment of the local education system with counterpart industries with regards to their needs and standards to ensure the competency and quality of the llonggo workforce and to alleviate the problems arising from job mismatch and undereducation, as well as to stimulate interest and investment from targeted industries. The LEDIP Office shall also be responsible for the imposition of commercial best practices and industry standards for targeted industries as identified by the City Mayor and/or as prescribed by law, and to facilitate the rapid technology exchanges and advancements therein.

SECTION 4. POWERS AND FUNCTIONS. The Local Economic Development and Investment Promotion Office shall have the following powers and functions:

# New Antique-Iloilo road to boost tourism industry

SAN JOSE DE BUENAVISTA, Antique – Opening a new road connecting Antique and Iloilo provinces will boost the tourism industry, especially in Barangay Aningalan in San Remigio.

The new road connects from Iloilo City, passing through municipalities of Oton, Tigbauan, Guimbal, and Tubungan in Iloilo to Aningalan.

"Iloilo City is only about one and a half hours now from Aningalan, San Remigio because of the road opening," said Mayor Margarito Mission, Jr., in an interview on Monday.

the extreme heat because of its cooler environment. While he has no exact number of tourists who visited Aningalan last week, he said it could be a record high.

"The road will also be an alternative to the Hamtic, Antique to San Joaquin (route) that frequently experiences landslides," he said.

# W. Visayas public schools suspend F2F classes due to extreme heat

"Most of these were

based on the announcement of local chief executives, except for Guimaras where it was the school heads who declared. For those declared by the local government unit, we will wait for when they will lift their order," he said in an interview.

# Iloilo keeps Lent traditions alive from praying for rain to healing

ILOILO CITY - Close to 100 "babaylans" or shamans from Iloilo and other parts of Western Visayas will gather in Barangay Batga in the town of Tubungan, Iloilo, on Good Friday to perform a "Pana-et", an age-old ritual of lamentations, peace offering, and thanksgiving.

The ritual involves preparations and revely, sacrificing animals and offering them to appease the spirits, seek approval, or give thanks or appreciation, said Gilbert Marin, Iloilo Provincial Culture, Arts, History and Tourism Office (PCAHTO) head, in an interview.

"Maybe because of the current situation of the environment, they will be asking for rain," he said on Thursday.

It is also an opportunity to energize their power and skills to perform healing and it is held every seven years on Good Friday but they also gather annually when requested.

The tourism officer said the Pana-et is just one of the many Lenten practices observed in Iloilo

While open to the public, there are only designated areas where they can watch; the rest of the place is sacred for the "babaylans" to perform the ritual.

In Isabela, the Glory Hill in Barangay Mansablay features a 45-foot steel cross at the hilltop while in the adjacent La Castellana, a 40-foot Holy Cross, can be visited at the Mandayao Panorama View Park in Barangay Mansalanao.

Capt. Arjay Dangarang, officer-in-charge of Isabela Municipal Police Station, said in an interview they are coordinating with the Philippine National Police Special Action Force and the Philippine Army to ensure the safety and security of trekkers.

"We have 24-hour security in the area," he said.

Personnel of the Municipal Disaster Risk Reduction and Management Office, Municipal Health Office and Bureau of Fire Protection man the first aid and emergency response station.

The Glory Hill cross can be reached after about a two-hour climb, and during the trek, pilgrims pass by the 14 Stations of the Cross along cemented stairways and steep pathways.

There are also visitors who opt to stay the night in camp sites near the giant cross.

From the newly-constructed viewing deck, visitors can watch the sunrise and the sunset.

Based on the guidelines set by the municipal government, all visitors must log in at the entrance and are advised to follow the designated dress code.

They must also dispose of garbage in designated ing loud noise.

Weapons, gambling paraphernalia and alcoholic beverages are strictly prohibited and bonfires are not permitted on the premises.

In La Castellana, the pedestal of the gigantic Holy Cross, standing on a hilly field in Barangay Mansalanao, can be reached after an 83-step climb.

Alongside the religious structure is the Virgin Mary and Jesus Christ Shrine, which are the centerpiece of the Century Leaf Garden, a jump-off point
