News Express Iloilo City to activate add'I police stations July 2

Iloilo City will have four additional police stations that will be officially activated on July 2.

These are strategically located in Barangay Tanza Esperanza in City Proper district (Police Station 7), Barangay Bo. Obrero in Lapuz district (Police Station 8), Barangay M.H. Del Pilar in Jaro district (Police Station 9), and Gaisano Iloilo City Center in Barangay San Rafael, Mandurriao (Police Station 10).

For Mayor Jerry P. Treñas, this is a very welcome development for Iloilo City as this means a more orderly and peaceful Ilonggo community.

This, he added, is the result of the shared commitment of the Iloilo City Government and the Iloilo City Police Office (ICPO) in making Iloilo a safer and more livable place for everyone.

"With the rapid growth of our population and our economy, we should also take cognizance of the increased demands on public services, including law enforcement and emergency response, that's why we have established ICARE Centers and additional police stations," said Treñas.

ICARE stands for Iloilo City Action and Response Centers. Its frontline offices including the police caters to a certain area of responsibility and brings emergency response and

Education in the Philippines

Education provides changes that could affect a person's future. It is the process of teaching knowledge and receiving knowledge. Receiving knowledge could be a bit complicated. It actually depends on how knowledge is received. Is it actively received or passively received? If knowledge is actively received, learning takes place and the learning could pave a way to a bright future.

Looking into the educational situation in the Philippines, I could say that the quality of teaching is questionable. It is a common knowledge teaching and learning can be achieved in the educational learning institution. In short, it can be found in schools.

Why do I say that guality teaching is guestionable? In order to have the best from the learners, there should be quality in the resources that the learning institutions should possess.

In the Philippines, resources in private schools are excellent. Teachers are highly qualified, numerous classrooms are provided with good ventilation, learning materials are abundant. Whereas there are 20 to 30 learners in the private school classrooms, there are 50-60 learners in the public school classrooms. Aside from this, teachers in the public schools are dumped with tasks and responsibilities that are not given to private school teachers. The public school teachers I am talking about here, are those public school teachers teaching in the cities and towns.

The scenario, however, in the public schools found in far flung barangays situated several kilometers away from the towns is quiet pathetic. Here, the teachers sometimes take a long walk, cross many bridges, brooks, and rivers and walk in the rain before they reach their classrooms. When typhoon comes, classes are suspended in the areas. How can there be a quality education here?

I have clearly presented the difference and the quality of education in both the private and public schools. What I did is to give answer to the question: "is the quality of teaching in the Philippines

As of June 18, the City Social Welfare and Development Office (CSWDO) has recorded a total of 88 affected families. To break down, there are 34 totally damaged houses; 16 partially damaged; 33 sharers; and five boarders. The victims were temporarily evacuated at Rizal Elementary School.

The financial distribution was initiated to help the victims in fixing their homes or to buy their necessities. An amount of P10,000 each family were given to totally damaged; P5,000 for partially damaged; and P2,500 for sharers.

Cong. Baronda stated that the fire victims with sarisari stores shall be listed under DSWD's Sustainable Livelihood Program (SLP) to help them start anew with their livelihood worth PHP 15,000 each.

"Yari kita diri to give them hope, hatagan sila pag-asa, that's why ginpamangkot ta kon sin-o may tindahan para isulod ta sila sa Sustainable Livelihood Program, kay may ara pa man ta available nga pundo dira. Baronda stressed that they have been implementing the immediate response in times of disasters since 2019 in coordination with the DSWD-6.

Ask, seek, knock or try

Back when my daughter Hannah was in Junior High, she and some friends wanted so much to color or highlight their hair. Unfortunately, the school policy was against colored or hair highlights. Hannah eventually brought the issue home and expressed her views over dinner.

After sharing how, in my high school days, we held a one-day violent protest after our school banned "bell bottom" jeans, I encouraged my daughter to do the research regarding the rule and discuss it with their principal. After that, she went on to research if the DepEd actually had a firm rule on hair color or highlights.

After a few weeks, Hannah came home all excited to tell us that there was no rule on hair color or highlights and that her school had given the green light to students, provided their parents approved of it. Hannah put in the work, the time and stuck with the belief that "it can happen" – but little did I know that Hannah would go for "The Color Purple!"

I remembered this chapter in our life after a provincial mayor complained how the progress and development of his city was being held back by an insidious practice of companies and corporations in paying their income tax. For the last 30 years, I have known of this practice which has been to the disadvantage of provincial local government units.

What happens is that major corporations, hotels, resorts, malls, property developers, all pay sales tax or VAT locally but when it comes to paying their income taxes, they pay these in the city or municipality where their corporation is registered. Back in the 80's, it was simply a matter of convenience and security for companies to pay where the head office was and where their preferred banks were as well.

But more recently, I was told by another angry mayor that some companies are not simply security conscious or lazy, they actually have a sweet deal going on with certain Metro Manila-based LGUs. Apparently one or two major cities in Metro Manila are favorite business

addresses because they give some form of discount, tax incentive or payment scheme.

When a number of mayors tried to convince known corporations to pay income taxes for their businesses located outside Metro Manila, the standard question was: what's in it for us? Are you willing to give us a tax incentive? It seems that many corporations even think that the LGU should be grateful to them for setting up shops and businesses in their province or localities.

They conveniently forget that their businesses compete directly with the community in terms of resources such as water, electricity, transport, even manpower, while also causing traffic and pollution as well as killing mom and pop outlets or sari-sari stores.

I know that one or two members of past Congresses have attempted to pass a bill that would require corporations to pay income taxes where they make the money and not where their business is registered. Unfortunately, that bill has not been heard from since.

Given that Senate President Chiz Escudero and Speaker Martin Romualdez both have "provincial roots," I humbly suggest that they both include such a bill in their joint legislative agenda. Governors, mayors, even barangay captains have all been singing "My Fair Share" (Seals & Crofts) but corporations and certain Metro Manila cities are not playing fair.

Ironically, the incentive giving, sweet dealing LGUs make more money than they can ever use and will be getting even more after the Supreme Court agreed with Governor Mandanas of Batangas that LGUs should have increased share of Internal Revenue Allotments.

Aside from giving provincial LGUs their fair share from corporate income tax revenues, those funds will certainly ensure the continuing development of provincial LGUs where those corporations are already taking in profits. It's like reinvesting in your business, your market and your community.

townships, new growth areas that President Bongbong Marcos has been talking about, as well as contribute to the decongestion of Metro Manila. As companies like San Miguel Corporation and Metro Pacific invest in infrastructure and connectivity nationwide, local government units must have added funds to prepare the ground or create business environments for growth

and investments. I have always been a staunch believer in M7.7 or Matthew 7:7 where Jesus Christ teaches us such a powerful method of believing, manifesting or what kids refer to as one law of attraction: "Ask and it will be given to you; seek and you will find; knock and the door will be opened to you."

Aside from M7.7, I also practice the discipline of KULIT or nagging persistence, the power of prayer and forming alliances either for effective influence or force multipliers to create public opinion or substantiate a need or acquire an asset.

Based on these and many successful undertakings, I encourage my friends in the LGUs to believe in their claim, back it up with research as well as previous proposals and bills submitted in Congress, gather the different LGU organizations of governors, mayors, barangay captains as well as sympathetic corporations, the academe and your friends in local or national media.

If all this fails to change the rules or mindset, then take the matter to court! It would surely be interesting to see what happens when corporate practice ends up in the path of a train called the Local Government Code, which is a law of the land.

That is what Governor Mandanas of Batangas did and he won for every local government unit in the land. Just do it and believe!

Asymmetric self-defense

TAIPEI – Last Monday evening, the lines waiting to go up to Taiwan's iconic Taipei 101 were long as usual.

And at nearby Din Tai Fung restaurant, renowned for its delectable xiao long bao, the waiting time for dine-in with no reservation was an hour, with even the function rooms for big groups fully booked.

The adjoining food court was packed with people as usual, many of them foreigners.

Taiwan received 6.5 million foreign visitors last year (the Philippines received 5.45 million), and is aiming for 10 million for 2024. This is down from the original 12 million, adjusted after China discouraged its citizens from traveling to Taiwan.

Despite intensifying Chinese military intimidation activities around Taiwan, which Beijing considers a renegade province, I haven't noticed any heightened concern among residents here in comparison with my

stance. While the Taiwanese go on with business as usual, they are fortifying their defenses.

Last Sunday at the centennial rites of the Republic of China Military Academy (also called Whampoa) in Kaohsiung, new Taiwan President William Lai urged the students and alumni to resist defeatism, to unite and be prepared to make sacrifices to defend national sovereignty.

This defeatism springs from a warning, believed fomented by pro-China elements, that Beijing's strategy would be to mount such a rapid, massive invasion that the US would have no time to come to the rescue of Taiwan that the first battle would be the last.

The Philippines has similar elements warning that the country cannot survive an attack by the Chinese, so why not just kowtow to Beijing and give them all the territory they want?

not only psychologically but also militarily and in other ways to defend themselves as China engages

in hybrid warfare and employs gray zone tactics to advance its strategic interests.

Although constantly preparing for the worst, and despite China's saber-rattling following the election of a president that Beijing considers to be pro-Taiwan independence, Hsu downplays the threat of armed conflict.

"We don't think war is inevitable. We don't think war is unavoidable," she told us. "We just want to prevent the worst from happening."

"Everything's just the same in Taiwan," Shih-yin Huang of the Tourism Administration's International Affairs Division told foreign journalists here last Monday when asked if China's saber-rattling was altering Taipei's tourism projections.

The COVID pandemic, Huang told us, had greater negative impact on Taiwan's tourism than China's belligerent acts.

* *

This doesn't mean, of course, that Taiwan is taking the Chinese threat for granted. Beijing has openly warned that it intends to reunite with Taiwan, and retake the self-ruled island by force if necessary.

Senior US military officials believe China could invade Taiwan as early as 2027. Last April, the former commander of the US Indo-Pacific Command, Adm. John Aquilino, echoed this assessment, saying China would have this capability by 2027. Whether Beijing would have the interest to do so remains to be seen.

Catherine Hsu, director general of the Department of International Information Services at the Ministry of Foreign Affairs, narrated this story to illustrate the attitude of the typical Taiwanese for the past seven decades: a woman doing her morning exercises was asked to comment on the possibility of a Chinese invasion. The woman's reply, according to Hsu: "If the day comes, it comes."

For Taipei, it's not a completely "what, me worry?"

Beyond urging his compatriots not to give in to a defeatist narrative propagated by China, Lai is leading Taiwan in bolstering self-defense capability and preparing for asymmetric warfare against a superior force.

For example, Taiwan has included drone development in its military buildup program. The island, whose economy has thrived on high-tech innovation, is not scared of embracing technology, including artificial intelligence.

Al is spooking even the global tech leaders, but not Taiwan's Ministry of National Defense. It intends to obtain this year 968 medium and large-sized military and attack drones equipped with AI and machine learning capability, to boost sea and air combat power. The MND already has over 2,000 military drones.

Taiwan wants to be "an Al island," Hsu told us.

The drones will be developed by the MND's Armaments Bureau through its Chungshan Institute of Science and Technology. Commercial drones for use by Taiwan's military will also be produced by private contractors.

Hsu stressed that help from its allies led by the US is always welcome. "We think the US is a very, very close partner," she said, "(but) first we want to encourage our people to show determination to defend ourselves."

"We can't expect foreign aid before we show our determination," she said, adding that the Taiwanese should learn lessons from Russia's invasion of Ukraine.

Taiwanese people, Hsu said, have prepared themselves

Even a Chinese blockade would be risky for Beijing, Hsu pointed out, as it would disrupt not only the Taiwanese economy but also the global supply chain. Taiwan is a top producer of high-tech electronic components and similar items needed by major companies such as Apple.

Hsu said there is no reason for Beijing to believe President Lai will be ramping up moves to declare Taiwan independence.

"Taiwan is already an independent country as far as we are concerned," Hsu said. "There is no need for Taiwan to re-declare independence."

She noted that Beijing might be referring to Lai's remarks from many years ago, when he advocated for "pragmatic Taiwan independence."

"Pragmatic means that he won't provoke," Hsu explained to us. "So, no, the new government is not more pro-independence.'

The Chinese, she said, "have to accept the reality that the Republic of China already exists."

If the Taiwanese spent time worrying about a Chinese invasion, Hsu said, Taiwan would not have become the world's 20th largest economy, with its people living in a free society.

This attitude was evident last Monday at the heart of Taipei, where I joined the crowds in stuffing my face with xiao long bao, from the signature version to the desserts with taro and chocolate filling plus the salted egg custard bun.

"Education is the overall development of a student" (Thomson, Joel). Here, the emphasis is on the overall development, not on a partial development of a person. However, in this aspect, one can see that there are flaws in our educational system.

Let us consider the "form" versus "substance" in our system. What are the "forms" that are obvious in our system? The rules found in our learning institutions are part of the "forms." We have the rules on wearing of uniforms, conforming to dress codes, following how long or short the hair should be, how long or short the dress for women should be and many others. These have nothing to do with the learning and nothing to do with the total or overall development of a person.

Other "forms" provide stress and failure to students. For instance, at the end of the academic year, learners receive ribbons, certificates, medals plaque of appreciation to the learners who the teachers "believe" deserve these awards. The teachers have become the judge, and the grades are the basis for these awards. These awards make our students "grades" conscious. Because of the grades, the learners no longer focus on learning, rather they memorize without understanding.

Our children should be trained to be more curious about things around them. Their curiosity is stifled because they memorize things they don't understand since they want to receive medals at the end of the school year.

Many of them did not develop their creative skills because they are grades-oriented and focus on their academics. Yes, we have good athletes and sportsmen but many of them did not continue because many of them were conscious that awards in academics are far more important than awards in cultural and sports.

Mr. Thomson stressed these questions: "are medals required in job application?", can they be used in the real world?"

There are many flaws in our educational system. We tend to focus more on rules, grades and awards. We forget that every child is unique. We forget that children have different skills and they have different ambitions. We often forget that each child could have a different journey. Going to school should not be a difficult activity in these journey.

Going to school should be fun. It should be an investment. Going to school is a good period to answer the questions that baffle them. The school is not a place for a child to be judged.

Let me cite a commendable fact about the educational system in Japan which contributes to the overall development of the learners. It has the most holistic approach to teaching. The students

Several senators recently expressed disappointment over the failure of the Anti-Money Laundering Council (AMLC) to do its work in connection with the now-viral POGO hub in Bamban, Tarlac.

During the Senate investigation it was revealed the contractor that built the infamous POGO hub could not be found, there also being no trace of the P6.1 billion used to construct it.

For Senator Sherwin Gatchalian, the AMLC "totally failed to perform their mandate," saying the POGO hub was being used for large-scale money laundering by a syndicate.

The senator said the AMLC's monitoring was "very weak," this despite several government measures aimed at removing the Philippines from the Financial Action Task Force (FATF) Grey List, a roster of countries recognized for their weak anti-money laundering measures.

Weak monitoring is only a symptom of a much bigger disease— weak institutions. Weak monitoring begets even weaker enforcement.

Our regulatory authorities seem weak compared to large multinational companies holding dominant market positions with the power to ignore government actions.

Take Google and Apple for example.

These two tech platforms continue to defy calls

to block unregulated players from their mobile app stores.

Several months ago, both the Securities and Exchange Commission and National Telecommunications Commission banned certain investment platforms for being unregistered in the country, aimed at protecting Filipino investors.

Both regulators issued warnings against popular platforms like Etoro, XM, and Gemini, with others being totally banned like OctaFX, MiTrade, and Binance.

The biggest is Binance—a widely used cryptocurrency exchange in the country—which has pleaded guilty to anti-money laundering infractions in the US and its founder to serve jail time for this and other offenses.

Both the NTC and SEC have requested a ban on these apps.

Months later, they remain available to Filipinos.

None of these apps are registered with SEC, much less AMLC, hence the ban.

If the AMLC cannot even monitor locally registered companies, what more unregistered foreign companies?

look like chump change compared to the billions of dollars that continue to be laundered through these unregulated platforms.

Apple and Google are manifestly indifferent to the national interest of the Philippines, where they enjoy a huge following.

How can these companies hold so much power that they can choose to ignore the government?

Maybe it's about time for our legislators to review whether the Philippine Competition Commission is carrying out its mandate.

We should look into Google and Apple's anticompetitive practices, since this is the only logical explanation for them to act with such impunity and ignore our regulators because of their dominant market position.

South Korea has even gone as far as passing an Anti-Google law addressing this.

What is clearly needed to overcome this challenge is a whole-of-nation approach to solve our shady global reputation for being a money laundering hub.

Whether our legislators and regulators will take any action remains to be seen. (manilastandard.net)

Closing the loop

Around a month ago, President Ferdinand R. Marcos Jr. said the government is hard at work to improve and upgrade the country's transportation system, even committing to make the Philippines a "leader in smart and sustainable transportation."

While the Philippines still has a long way to go in terms of matching the likes of Singapore, Japan, South Korea, and Hong Kong in mass transport, President Marcos' words offer hope to commuters and motorists who are long tired of long lines in bus and train stations, and the hours lost to traffic jams on a daily basis.

I have said before that when it comes to mass transport, rail transit offers the most effective and viable solution. Aside from efficiently moving people from one point to another, it also significantly helps lessen congestion on roads thereby, addressing traffic.

Sadly, the Philippines has yet to provide commuters with an efficient mass rail transit that will allow for seamless line transfers to get to one point from another without the need to shift to another mode of transportation, such as buses or taxi cabs.

The good news is all this could improve if the proposal submitted by the consortium of Metro Pacific Investments Corp. (MPIC) and Japan's Sumitomo Corp. is approved and put into action.

The consortium has proposed to rehabilitate, operate, and maintain the Metro Rail Transit 3 (MRT-3), as well as carry out the necessary operations to allow through-train-operations

to connect the MRT-3 with the Light Rail Transit 1 (LRT-1) – finally closing the loop and creating a loop similar to other countries.

Under the proposal, rehabilitation works will be integrated with the construction of the South Interconnection Facility, which would allow for seamless transfers between the MRT-3 and LRT-1 and vice versa. The proposal was recently endorsed by the Public-Private Partnership Center.

If implemented, this is guaranteed to be of great convenience not just to thousands of commuters but to motorists as well.

Interoperability between the MRT-3 and LRT-1 will help reduce travel time and lower transportation costs for commuters on top of the added convenience and effectively help decongest EDSA as well.

The consortium estimates a 24 percent reduction in EDSA traffic volume if the MRT-3 and LRT-1 are integrated and if riding capacity is immediately increased.

The responsibility of operating and maintaining the train lines will also be assumed by the consortium, establishing accountability.

On the part of the government, turning over the maintenance and operations of the MRT-3 to the consortium will immediately eliminate PHP1.3 billion in subsidies allocated for the train line. These subsidies can be realigned. This can be reallocated to boost funding for infrastructure projects or social services.

Moreover, the government will immediately receive concession payments from the consortium should the proposal be approved.

Both MPIC and Sumitomo have demonstrated rail expertise, which makes their consortium the most qualified choice to take over operations of the MRT-3.

Through the Metro Pacific Light Rail Corp., MPIC has investments in the LRT-1 while Sumitomo has been credited for drastically improving the reliability of the MRT-3 as its maintenance provider. Sumitomo has also shown rail expertise in Japan – known for having one of the most efficient rail systems.

With the Philippines working to become an uppermiddle-income country in the coming years, the need for a more efficient and reliable mass transport system is further highlighted to match and support the country's economic growth trajectory.

Our commuters deserve better. Accepting and implementing the proposal of MPIC and Sumitomo is a step in the right direction towards providing Filipino commuters with better transportation, reducing traffic, and supporting economic development.

Stop violence against children

Violence against children remains a critical issue globally, with the Philippines being no exception. The United Nations International Children's Emergency Fund (UNICEF) estimates that three out of five Filipino children experience violent discipline. On a larger scale, of the 33.4 million children aged 1 to 14, approximately 20 million (59 percent) have experienced violent discipline in the past month. Despite various efforts to curb this menace, the prevalence of physical, emotional, and sexual violence against children in the Philippines continues to alarm child rights advocates and policymakers.

In this age and time, with the government's ceaseless campaign to nurture children without violence, it is troubling to know that discipline using violence is still pervasive. In a civilized society, violence as a form of punishment for children is unacceptable.

In the Philippines, there are already laws that outlaw violence against children. These laws, enacted several years ago, continue to be relevant for the protection of children. Perhaps one of the best laws, though often misconstrued, is Republic Act 7610, or the Special Protection of Children Against Abuse, Exploitation, and Discrimination Act. According to UNICEF reports, 32 years after the enactment of this law in 1992, 59 percent of Filipino children continue to face abuse. This raises questions about the effectiveness of government information dissemination regarding children's rights.

Child abuse is not only a phenomenon in the Philippines. It is a worldwide issue, with UNICEF reporting that 400 million children under the age of five experience violent discipline methods that affect them physically and psychologically. This violence often occurs in their homes and excludes other abuses perpetrated by parents, siblings, and relatives, most heinously sexual abuse.

According to UNICEF, parents and other adult family members in many countries worldwide subject more than two in three children to violent discipline through physical punishment or psychological aggression. Given the current level of technology, there should be measures to reach out to parents to raise their awareness about the proper methods of disciplining their children.

Physical violence against children in the Philippines includes corporal punishment at home and in schools, physical abuse by family members, and violence in the community. Schools, intended as safe havens, often become environments where children face physical punishment from educators. Everyone should understand that several laws, including the Juvenile Justice and Welfare Act of 2006, enunciate that corporal punishment is unlawful.

Unfortunately, many people still accept corporal punishment as a form of discipline. Civil society organizations have been pushing for a law that prohibits corporal punishment and instead promotes positive discipline as an alternative.

Sexual violence is one of the most heinous forms of abuse that children in the Philippines face. This includes incest, sexual exploitation, and online sexual abuse. The proliferation of the internet has exacerbated the problem, with the Philippines becoming a global hotspot for the live-streaming of child sexual abuse. Economic hardship drives some families to exploit their children sexually for monetary gain, leading to lifelong psychological and physical trauma for the victims.

Bullying, both in schools and online, is a significant issue affecting Filipino children. Peer violence can range from verbal taunts to physical assaults and cyberbullying. The rise of social media platforms has provided a new avenue for bullies to target victims anonymously, leading to severe consequences, including suicides. There have been several cases in the Philippines that have resulted in the deaths of teenagers, highlighting the severe impact of bullying on Filipino children.

There is a significant lack of awareness regarding children's rights and the impact of violence on their development. Many parents and guardians are unaware of alternative, non-violent forms of discipline and conflict resolution.

Our government has enacted several laws aimed at protecting children from violence. These include the Special Protection of Children Against Abuse, Exploitation, and Discrimination Act and the Anti-Bullying Act. Recent efforts focus on strengthening these laws and ensuring stricter penalties for offenders.

FRESH VIEWPOINTS: A NEW PERSPECTIVE

Non-government organizations and international organizations, including UNICEF and Save the Children, have been actively involved in raising awareness about child rights and the impact of violence. Campaigns like "SaferKidsPH" aim to educate both children and adults about the dangers of online sexual exploitation and how to prevent it.

Community-based programs are essential in addressing violence against children. These programs should involve local leaders, parents, and children in creating a safer environment. We conduct training sessions on positive parenting and child protection to empower communities to safeguard their children.

In line with the efforts of local government units to curb violence against children, I commend Quezon City Mayor Joy Belmonte for her leadership in combating child labor and other forms of violence among minors in her city. Mayor Belmonte highlights that Quezon City has implemented various programs, such as the Zero Child Labor Action Plan, strengthened the Barangay Council for the Protection of Children (BCPC), established Task Force Sampaguita and Magdalena, and created a Child Labor Prevention and Elimination Program section within the Public Employment Service Office (PESO).

The Quezon City government has also partnered with various nongovernmental organizations to address the alarming increase in online sexual abuse and exploitation cases in the Philippines. These NGOs include Mission Alliance Philippines, the Center for the Prevention and Treatment of Child Sexual Abuse, Plan International, and the Royal Norwegian Embassy in Manila.

Let's face it, child abuse in various forms continues to be pervasive. Initiatives at the local level can significantly help curb violence against children.

Linus security blanket and the West PH Sea

In the widely popular Peanuts comic strips written and drawn by Charles Schulz which featured Snoopy and Charlie Brown, there is a popular side character known as Linus Van Pelt. Linus is known for his intelligent quotes and astute observations. He is, however, more popularly known for his ever-present blue security blanket which was first introduced in June 1954. That iconic security blanket is celebrating its 70th anniversary. The term security blanket had been in existence before the popular comic strip came into existence. During World War 2, the term security blanket was primarily used to refer to measures taken for security purposes. In time, the two concepts merged, and security blankets became something children needed as protection and as a means of confronting stress. Eventually, it became a term used to describe an object or concept used for the said purposes. In recent times, it is now also used to refer to anything that provides a feeling of safety and comfort.

For a time, many parents and even psychologists feared that security blankets, in any form, inhibited children's growth and independence. There are also the negative consequences that occur when the

Recently, the Philippine government was criticized for seeking closer military alliances with the US and its allies to help establish our defensive measures in the West Philippine Sea. Many analysts likened our growing dependence on these allies to having a security blanket with all its negative connotations and consequences. Many of the critics point out that having a defense security blanket might hinder the growth of our own defensive capabilities and expose us to negative consequences if the said security blanket is withdrawn.

Having a security blanket, however, is not necessarily a bad thing. There are experts who also state that security blankets can be good tools to help the emotional transition from dependence to independence. Transitional objects are not a sign of weakness or insecurity. Security blankets can be used to help children transition to adulthood more smoothly.

In terms of our country's issues in the West Philippine Sea, having the alliances as our security blanket can give us the time and means to modernize and strengthen our own defensive capabilities. The Enhanced Defense Cooperation Agreement (EDCA) will allow our country access to more modern tools and facilities.

The EDCA, unlike the previous US bases agreement,

is part of what is now termed the policy of "flexible enmeshment". The agreement will allow the Philippines to wind down the enmeshment when national interests dictate the same. In terms of sudden withdrawal of support, the present strategic enmeshment and strategic importance of the EDCA sites will make sudden withdrawal highly improbable.

While maintaining the said enmeshment and the security blanket, all sectors must now contribute to the government's military modernization. Though we may not be able to achieve a fully independent capability to defend ourselves alone, a continuous effort to improve our capability in a synergized manner with our allies can give us a measure of legroom in our foreign relations objectives. Eventually, if we are given enough time and support, we may be able let go and chart our own path without fear.

This is my oblique observation.

Fire displaces 82 families in two lloilo City barangays

A fire broke out around 2:15 AM on June 17 at a residential area in Rizal Estanzuela and Tanza Bonifacio in Iloilo City.

Cong. Baronda also requested Department of Social Welfare and Development (DSWD)-6 Regional Director Carmelo Nochete for additional relief packs and other assistance for the survivors of the fire incident.

Bago City starts trashto-cash program to reduce plastic waste

BACOLOD CITY – The City of Bago in Negros Occidental launched a community-based waste-to-cash program to reduce plastic waste as part of its activities for the observance of Environment Month this June.

Vice Mayor Ramon Torres said Wednesday that the launch of the "Aling Tindera Plastic Waste to Cash" in Barangays Ma-ao and Poblacion, in partnership with Friends of Hope Inc. and Germany-based development agency Deutsche Gesellschaft für Internationale Zusammenarbeit, on Tuesday would help address plastic pollution.

"It is important to work hand-in-hand in the protection and conservation of the environment through a program such as this," Torres said in a statement.

The two "Aling Tindera" waste collection stations are near the expanded sanitary landfill site in Sitio Pandan in Barangay Ma-ao and beside the fish port at the Bantayan Park in Barangay Poblacion.

City Environment Management Office head Vicente Mesias said the four-hectare expansion area could still accommodate more waste generated in the city.

However, through the program, they are looking at reducing waste generation and the volume of garbage disposal at the sanitary landfill.

"We are eyeing to open more 'Aling Tindera' stations. The project will surely have positive social and environmental impacts on the community," he added.
