To recall, on May 9, 2024 Governor Rhodora Cadiao submitted to the SP her request for Supplemental Budget No. 1 with an amount of Php 1,075,610,772.00.

The Ombudsman noted that the respondent SP members "deliberately delayed action thereon by interposing all kinds of objection on the wisdom of the said Supplemental Budget during the regular sessions on May 20, 2024 and May 27, 2024".

Further, the SP members allegedly boycotted the regular session on June 3, 2024 despite due notices thus resulting in adjournment for lack of quorum.

It can be noted that SB No. 1 included three items which were the subject of strong objections from the respondent SP members. These items are: 1) Installation of Solar Photovoltaic System in eight hospitals for Php 190 million, 2) Purchase of Home Solar System for Php 375 million, and 3) Installation of Solar-powered Streetlights for Php 200 million for a total of Php 765 million.

The source of fund for the said three items is the 80% of the Province of Antique's share from the proceeds derived from the development and utilization of hydrothermal, geothermal and other sources of energy required under Sec. 294 of the Local Government Code of 1991.

On June 10, 2024, the SP finally had a quorum, thus the regular session was successfully conducted.

However, the respondent SP members, constituting the majority, deleted the budgetary allocations of the said three items thereby reducing the province's share from the proceeds derived from the development and utilization of hydrothermal, geothermal and other sources of energy to less than 80% to lower the cost of electricity.

In effect, the Ombudsman said, it deprived the 200 barangays and about 15,000 households of the home solar system.

The Ombudsman found sufficient grounds to preventively suspend the eight SP members considering that there is strong evidence showing their guilt.

Vice Governor Edgar Denosta, in an interview with local media, lamented the Ombudsman decision, but he assured that the SP will continue to perform its duties to the people of the Province of Antique.

Denosta said they will consult with the Department of Interior and Local Government (DILG) as to what will happen as there are only five SP members left which could not constitute a quorum.

He expressed hopes that the suspended ex-officio members from Sangguniang Kabataan Provincial Federation, Philippine Councilor's League, and Liga ng mga Barangay will be replaced as soon as possible so that the SP of Antique could again perform its functions.

Meanwhile, Board Member Molina said while their group respects the decision of the Ombudsman they are surprised by the fast resolution of the complaint against them without getting their side.

He said they will file a motion for reconsideration to the Office of the Ombudsman.

MPIW's broader efforts to address water supply

PRO-6 keeps law enforcement momentum in Western Visayas

The Police Regional Office (PRO)-6 headed by its Regional Director, Police Brigadier General Jack Wanky has kept its momentum in law enforcement and anti-criminality campaigns in Western Visayas, leading to a decrease of crime incidents.

This achievement was presented during the "Kapihan sa Bagong Pilipinas" held at the Department of Public Works and Highways (DPWH)-6 Operations Center in Fort San Pedro, Iloilo City on August 6.

The peace and order within the region is considered to be generally peaceful as there were no presence or record of major crime incidents and high profile cases especially during festivals such as Ati-atihan in Aklan, Dinagyang in Iloilo City, and Masskara in Bacolod.

During the first half of 2024, the crimes under peace and order index within the region was in a downward trend with a decrease of 11.68 percent. This year's record has 5,529 incidents with a decrease of 731 compared to the same period of 2023 with 6,260.

The index crimes in Western Visayas has a decrease of 339 incidents or 23.64% while the non-index crimes decreased to 4,434 compared to the same period last year with 4,826.

The crimes within the region such as murder, homicide, physical injury, rape, robbery, theft, and carnapping have also decreased wherein the first six months of 2024 has a record of 1,089 incidents which is lower by 339 incidents compared to the same period last year.

In addition, the Regional Anti-Cybercrime Unit (RACU)-6 has recorded 218 incidents which is lower by 80 incidents compared to last year with 298.

Moreover, the PRO-6 has continued its operations and accomplishments against all forms of illegal activities from January to June 2024.

PRO-6 has arrested 1,600 individuals and seized about 34,297 grams of shabu worth Php233 million and 20,200 grams of marijuana worth Php2.4 million while 2,368





individuals were arrested and confiscated with a total bet money of Php979,000.

Under law enforcement operations, about 358 individuals with loose firearms were arrested while 414 assorted firearms and 100 explosives were confiscated. About 1,698 assorted firearms and 216 explosives which are un-renewed and unregistered were also confiscated.

In prevention of illegal logging activities, 104 individuals were apprehended while Php1.6 million worth of lumber and charcoal were confiscated.

Meanwhile, the PRO-6 assures the public in keeping the peace and order within the region by enhancing or improving the skills of its personnel to give quality service to people in the community; monitor illegal activities such as drugs; monitor cybercrime which involves foreign nationals; implementing police visibility and patrolling; and coordinate with local government units (LGUs) in monitoring crimeprone areas.

NPA member killed, high powered firearm seized in Iloilo

ILOILO CITY – Another member of the New People's Army (NPA) was killed during an encounter in remote Barangay Cabatangan in Labunao town, Iloilo province on Wednesday.

Killed was Jose Jerry Tacaisan, alias Miller//Bronze, 54, and a resident of Sitio Tabionan, Barangay Bucari, Leon town. The incident also resulted in the recovery of a high-powered firearm.

Tacaisan was a member of the Regional Headquarters (RHQ) and a former squad leader of the dismantled Southern Panay Front

During the last two weeks, President Bongbong Marcos has been seen a lot during inaugurations, ribbon cuttings and project launches hosted by private business. Among the big-ticket events that PBBM went to were the project launch of San Miguel Corporation for the TPLEX extension from Rosario to San Juan, La Union.

While the TPLEX-ex project is classified as an "extension," I would dare say that it is the major component of the TPLEX that will boost tourism and development in the province of La Union by cutting the travel time drastically. Many local tourists and developers have expressed appreciation for and interest in the area but have had second thoughts due to the time it currently takes to get there.

After the TPLEX-ex launch, the President was guest of honor at the inauguration and energization of the National Grid Corp. of the Philippines' 500kilovolt transmission line capable of delivering 8,000 megawatts of electricity. In a country where many provinces lack dependable and affordable electricity, major transmission lines are what we need to raise our economic status.

Last Sunday, I received a video message from Benjamin Yao, head of STEELASIA, including the speech delivered by President Bongbong Marcos during the inauguration of the STEELASIA plant in Compostela, Cebu. Arranging the visit and participation of the President was no simple task that had been in the plans for many months.

I have written about STEELASIA before and the fact that there is a serious need for the government to recognize the efforts to establish steel plants in the country and to produce steel products instead of importing practically everything beginning with staples, steel beams and even roofing materials.

PBBM being at the inauguration and other such events shows that the President is pro local business and not just pro-travel for foreign investments. These businesses, investors and industries are already on of value or go around with a begging bowl to friends,

the ground and actively contributing to infrastructure development and economic activity.

President Marcos Jr. and his staff should arrange more of these appearances and events because it also brings attention to the developments and investments happening all over the country during his term. In terms of image building, these make a positive difference for the President.

At this stage, PBBM could make a serious difference by consulting local business groups what immediate actions, assistance or engagement would motivate companies to do more. About a month ago, the proposed bill creating the "Bulacan EcoZone" lapsed into law and supporters and people of Bulacan province sighed with relief that PBBM did not veto it like he did the first version.

So yes, President Bongbong Marcos should focus on spending more time and energy highlighting actual business developments because it is proof of investors' confidence in the country.

politicians and government agencies or a congressman and a senator to get a referral and subsidy.

Pass-through fees

On Sept. 25 last year, President Marcos ordered a stop to the collection of various forms of fees from delivery vehicles for simply passing through any road that was not built by local governments.

Either BBM's Executive Order No. 41 was not cascaded down to the local government units, which collect the fees, or else the national government gets little respect from the independent LGU republics.

With Marcos' third State of the Nation Address just around the corner, I asked a prominent businessman for his SONA priority wish list. He mentioned three, one of which is for a genuine end to the so-called pass-through fees, which he says continue to be collected.

Apart from city and municipal governments, the fees are collected by barangays and in some areas by the police. Seeing the inability of the national government to enforce its own order, and to avoid the hassle, delivery

With Marcos 2.0 consistently getting the lowest survey ratings in taming inflation, and food inflation driving the high inflation rate, EO 41 was issued to stop the collection of the pass-through fees.

The EO cites a provision in Republic Act 7160, the Local Government Code, that expressly prohibits such fees: Section 133(e) of RA 7160, which states that "the taxing powers of local governments shall not extend to the levy of taxes, fees, and charges and other impositions upon goods carried into or out of, or passing through, the territorial jurisdictions of LGUs in the guise of charges for wharfage, tolls for bridges or otherwise, or other taxes, fees, or charges in any form whatsoever upon such goods or merchandise."

According to Malacañang, these include fees for vehicle stickers, discharging, delivery, market and entry permits.

businessman is hoping for a cargo railway system - now in the works, but still several years away from coming onstream.

A problem with possible short-term solutions is steep domestic cargo shipping cost, which the businessman said is among the highest in Asia and should be regulated.

Another problem is the horrid traffic in Metro Manila, which is costing billions in lost productivity. The businessman noted one aspect that has not been highlighted - that Metro Manila must be the only megacity in the world without a numbered bus system, which allows the dispersal of waiting areas along specific routes and

drivers simply pay up.

EO No. 41 took into account the complaints of businessmen, that the pass-through fees contribute to logistics costs, which are already too high compared to those in several neighboring countries.

As in most fees collected by the government from the private sector, the pass-through fees are in turn passed on by traders to consumers.

The fees are among the reasons for high food inflation, particularly in Metro Manila and other urban centers that source most of their food supply from distant farming areas.

Metro Manila gets most of its rice from Central Luzon, vegetables and fruits from La Trinidad in Benguet as well as Laguna and Cavite, chicken and pork from Rizal and beef from Batangas. Think of how many places the delivery trucks must pass through and pay such fees before the commodities reach the markets of Metro Manila.

Even when farm gate prices of tomatoes plunged so low some farmers simply dumped their crops, tomato retail prices in Metro Manila did not fall significantly.

Bringing down prices of agricultural commodities was another item on the SONA priority wish list of the businessman. These commodities are raw materials not only for the major food processors but also for micro and small enterprises that account for the majority of businesses in this country.

RA7160 imposes penalties for violations. Despite this, EO 41 is proving ineffectual. The national government may have to begin imposing sanctions on LGUs that defy the order.

LGUs are also providing the biggest roadblocks to a third item on the businessman's priority list: ease of doing business.

Local and foreign business groups alike continue to complain about the difficulty of opening, operating and even closing a business in the Philippines compared with neighboring countries.

Not surprisingly, these countries are drawing far higher levels of foreign direct investment. With many businesses decamping from China, Vietnam is reportedly getting so much FDI these days it is starting to experience inadequacies in providing requirements such as electricity.

Businessmen in the Philippines acknowledge the efforts of the Anti-Red Tape Authority in improving ease of doing business. ARTA, however, is up against a local government leviathan where systems are designed so that personnel from the barangay up can collect grease money before anything gets done.

The businessman said LGUs should develop a mindset similar to the mission of the Philippine Economic Zone Authority: to attract as much investments as possible that can create meaningful employment. If people have decent jobs or livelihoods due to economic activities that can be attributed to good governance, wouldn't this be

reduces traffic buildup at bus stops.

The foreign chambers, for their part, have come up with a list of 21 pieces of legislation that they hope will get priority at the SONA.

No. 1 on the list is the lifting of foreign ownership restrictions, which will require Charter change. As of last weekend, however, the reliable word from the Senate is that Cha-cha is dead in this Congress. Lawmakers can instead work around the constitutional prohibitions to further ease the restrictions – something they have already done in other recently enacted laws.

Some of the other items on the list should also prove unappealing if the Marcos administration is serious in its rightsizing objective: the creation of more executive departments and offices.

When the government needs to create jobs, it creates new agencies, new provinces and cities, and now new barangays, which are quickly packed with beneficiaries of political patronage or members of political dynasties.

Since merit is rarely considered in patronage-driven job generation, government efficiency has not improved commensurately with the bureaucratic bloat.

For every problem, a new department. Do all those extraneous fees go to fattening the bureaucracy?

BBM said eliminating pass-through fees would improve ease of doing business and cut transport and logistics costs - one of the eight pillars in his socioeconomic agenda. Surely this should prove more doable than his aspiration for rice at P20 a kilo.



SIM cards have been used by criminals in various online scams in the Philippines.

These include phishing, automated teller machine skimming, identity theft, online shopping scams, lottery scams, crowdfunding scams, love or romance scams, advance fee fraud, fake websites, SIM swap scams, SMS phishing, blackmail, credit card scams, impersonation scams, online banking scams, catfishing, charity scams, computer hacking, investment scams, and grandparent scams, among others.

Barbers, chairman of the House committee on dangerous drugs, noted some narcotics peddlers use postpaid SIM cards to hide their real identities and avoid detection so they could post and sell their "coded" illegal wares on various social media platforms such as Facebook and Instagram, X (formerly Twitter), TikTok and YouTube.

make the unwary and the unsuspecting part with their hard-earned money, it seems, and authorities are having a hard time running after the cybercriminals and putting them in the only place where they belong: in jail.

While we welcome the development of new technology and digital media to make communication easier and allow us to expand the limits of the possible in various areas of endeavor, whether in the economic, social and political spheres, we must be constantly on guard against the use of information and communication technology and digital media for committing crimes.

The proposed amendment of the SIM **Registration Act is a step in the right direction** as it would correct the loopholes allowing the unscrupulous and the criminal-minded to commit various types of offenses punishable under our statutes. (manilastandard.net)

Good intentions, as we know by now, do not always translate to good laws.

The good intention behind Republic Act 11934, or the Subscriber Identity Module Registration Act, enacted in Oct. 2022-to prevent cybercrimes—appears to be a colossal failure.

That's the rationale behind the proposal of Surigao del Norte Rep. Robert Ace Barbers to amend RA 11934, which mandates the registration of both post and prepaid SIM cards.

The lawmaker believes local and foreign criminals have managed to skirt the law and continue scamming operations.

"The law was intended to curb cybercriminal activities, to address issues related to trolling, hate speech and online disinformation. But what we are seeing and witnessing today is that online scamming activities remain unabated," Barbers pointed out.

He cited the recent raids by the Presidential Anti-Organized Crime Commission on POGO (Philippine offshore gaming operators) facilities in Bamban, Tarlac, and Porac, Pampanga, that

1,000 MW of needed power supply of distribution utility Meralco—a move that will ultimately result in a negative domino impact on the delivery of electricity service to millions of consumers.

The issue stems from the complaint of the consortium operating the Malampava Gas Field, which argued that the terms of the biddings violated existing laws that give preference to indigenous natural gas in awarding power supply contracts—allegations that Meralco debunked.

In its recent statement, Meralco clarified that, in fact, power plants using Malampaya gas have expressed interest to participate in the bidding.

But because of the TRO, the bidding for the two power supply contracts-600 MW and 400 MW-will be delayed for 20 days to the detriment not just of ordinary consumers, but also industries that require stable, continuous, and reliable electricity service. Finally, this also poses as a roadblock to the government's push for energy security.

What many don't realize is that delays in these biddings ultimately have a consequential impact on the pockets of ordinary consumers.

When the implementation of power supply agreements is delayed, energy security is threatened. In essence, delays in the awarding of these contracts will compel Meralco to source the much-needed supply from the spot market, exposing consumers to highly volatile prices. In

supply that could have been made available to them in a cost-efficient manner if only the biddings for the supply contracts were implemented as scheduled.

Such a scenario defeats the very purpose of the CSP wherein the winning bidder is chosen based on price offer. It contradicts the mandate of distribution utilities like Meralco to supply sufficient, continuous, and reliable electricity in the least cost manner to consumers.

Moreover, it goes against the government's goal of achieving energy security since it puts in peril the power supply situation.

Clearly, it is the consumer who will suffer in the end. Questioning the rules of these biddings proves to be a futile exercise given that these proceedings are conducted in a highly transparent manner.

These biddings observe strict processes and adhere to stringent rules set by the Department of Energy (DOE) and Energy Regulatory Commission (ERC)—which are tasked to ensure the transparency and integrity of these biddings.

According to Meralco, the DOE in fact issued a Certificate of Conformity to proceed with the CSPs-proof that the terms of the biddings comply with applicable government rules and regulations.

Neither the DOE nor the ERC has flagged any irregularity in relation to the biddings as well.

Questioning the integrity of these biddings is extremely

insulting on the part of the government-particularly the DOE and ERC given that extensive research and hours have been devoted to craft the strict rules governing the CSPs.

It must be noted that after a winning bid has been declared, the ERC still has to conduct a stringent assessment to ensure that these contracts adhere to the strictest standards and rules set by the government.

At this point, it is best to rethink whether a halt in the implementation of the bidding is really in the best interest of the government and the consumer or if this is being clouded by business interests.

Let us not be distracted by technicalities and unnecessary obstructions from the goal of providing Filipino consumers with the cheapest possible power supply that will not only support communities but enable economic growth as well.

This for sure is in the best interest of the consumer and the country.

The need to prepare for La Niña

When Typhoon Carina inundated Metro Manila flooded streets. and nearby provinces with floods, President Ferdinand R. Marcos Jr. was utterly dismayed. Social media was abuzz with memes suggesting that nature was fact-checking the President after he stated during his State of the Nation Address (SONA) that over 5,000 flood control projects were currently under construction across the country.

The President's dismay is understandable, as a Senate committee hearing on the Department of Public Works and Highways (DPWH) budget for fiscal year 2024 revealed that the agency's budget to address flooding would amount to at least P1 billion per day. Senator Joel Villanueva revealed that the country spent PHP1.079 billion daily on flood control projects in 2023. This year, the government's flood control funding is now at PHP1.35 billion per day.

Given the enormous budget, there seems to be no reason for Metro Manila and nearby provinces to experience such severe flooding as seen with Typhoon Carina. Many Filipinos were surprised by the amount spent on flood control projects, and now that this information is public, there are heightened expectations for significant improvements, especially in flood-prone areas.

Typhoon Carina has caused massive destruction. According to the National Disaster **Risk Reduction and Management Council** (NDRRMC), the number of people affected has reached 4.8 million, with 48 deaths. This makes Typhoon Carina the strongest typhoon to hit the Philippines in recent years, surpassing Typhoon Karding in 2022, which affected 1.4 million people.

Typhoon Carina also brought more rainfall compared to Ondoy. PAGASA reported that the typhoon-enhanced southwest monsoon (habagat) dumped 471 millimeters of rainfall, compared to 455 millimeters during Ondoy. This resulted in the submersion of many parts of Metro Manila, the stranding of people, and the flotation of cars on

The failure to prepare for the rainy season was a significant factor. Typhoons would intensify the "habagat", according to our weather bureau's forecast. Last June, a barge damaged the floodgate in Navotas, a flood-prone area, aggravating the situation. The floodgate is crucial as it prevents seawater from entering communities during high tide. Typhoon Carina severely flooded Navotas and its neighboring cities.

Given the expectation that more typhoons will enter the country's area of responsibility, immediate repair of the damaged floodgate is essential to prevent future flooding.

The flooding in Metro Manila and nearby provinces is also attributed to reclamation projects in Manila Bay, according to authorities. Typhoon Carina's flooding prompted a Senate hearing. The Secretary of the Department of Environment and Natural Resources (DENR) stated that "reclamation projects will slow down the flow of water and change the circulation and retention of pollutants and organic materials in the bay."

People have long claimed that reclamation projects in the Manila Bay area cause flooding. The National Capital Region alone has reclaimed a total of 2,576 hectares of Manila Bay's coast. President Bongbong Marcos suspended 22 reclamation projects in Manila Bay in 2023. If these projects continue, we can expect more flooding in our communities.

Senator Cynthia Villar has opposed reclamation activities in Manila Bay, particularly those affecting Las Piñas City. She wants these activities stopped because they prevent rivers from flowing to the sea.

PAGASA has issued a La Niña Alert, stating a 70 percent chance of La Niña occurring from August to October and persisting until the first quarter of 2025. Typhoon Carina may be the beginning of this phenomenon, with stronger typhoons expected in the coming months.

Awareness, especially among the younger generation, will prepare them to mitigate the impact of climate change.



from 8.73 percent for stunting.

However, there remain 3,841 underweight children, 1,366 wasted, and 6,559 stunted.

"That is why we continue to advocate to reduce cases and achieve zero hunger so there will be no children and households that will go hungry," Marcelo said in an interview.

The provincial government has already implemented initiatives to include Project Nutrivac: Nutrition and Vaccination Towards a New Normal, benefitting an initial of 50,000 in the first month of its implementation in 2022.

Under the project, individuals who availed of the vaccination were also provided NutriVac packs from July to August 2022.

Further, 3,375 malnourished children received nutribuns, and 735 availed the meal supplementation.

It also collaborated with the Philippine Multi-sectoral Nutrition Project for towns of Badiangan, Carles, and Dueñas; the National Nutrition Council for the Tutok Kainan Dietary Supplementation Program; and the Core Philippines for the Breaking Barriers in the First 1000 Days (BBF1KD) in Barangays Bolo and Abay in Maasin town. will be monitored are those three to 18 years old," she said.

Oblima said these children are supposed to have 85 percent school attendance monthly or a maximum of four absences in a month.

Children who comply with the condition will receive PHP300 per month if they are in daycare to elementary, PHP500 per month for junior high school, and PHP700 per month for senior high school.

"The cash grant is released every two months so the children will have some amount to buy their school supplies and other needs," she said.

Oblima said parents should encourage their children to be in school so they can comply with the requirements.

Tuesday.

He added they could assume there were illegal activities involving foreigners since there were two instances recorded here --the arrest of 17 Chinese nationals engaged in cybercrime in 2023, and the arrest of a Chinese national selling fake cigarettes.

Cabaluna said he wants to know the developments of the two cases and to look into whether there is a bigger issue or a wider network.

Margie Mijares, whose children are in Grades 10 and 11, said the cash grant ensured their children can continue with their schooling. Both children received cash grants since their elementary grades.

"My children were able to continue their schooling because of the 4Ps cash grant," she said.

Mijares said she works as a house helper while her husband is a tricycle driver, so they could not afford to send their children to school.

His son Melvert was grateful for being a beneficiary of the 4Ps.

"Every time I would need some school supplies or other needs, I have money to pay for because of the cash grant," he said.

He hoped to someday reach his dreams in life. (PNA)

"We wanted to know directly from the investigating agency if there's reason really to move towards more stringent measures against foreign nationals that are operating here, especially those illegal businesses," he added.



'Transport break' slightly affects commuters in **Iloilo City**

ILOILO CITY - The two-hour "transport break" joined by over 400 modernized buses in Iloilo City slightly impacted this city while over 1,000 consolidated traditional jeepneys continued to ply their routes on Monday.

PRO-6 Regional Director Brig. Gen. Jack Wanky, during the Kapihan sa Bagong Pilipinas, said installing CCTVs in strategic areas of the community is a big deterrence to crime.

"We have to compete with criminals who are also advanced in perpetrating crimes. We have to compete with them in terms of technology. That's why one of our focus is the installation of CCTVs cameras," Wanky said, citing modernization efforts of the Philippine National Police (PNP) in response to the Bagong Pilipinas program of the Marcos administration.

"Through our experience, there is also a big chance we can solve the problem when street crimes are captured on CCTVs," he said.

It is for this reason, he said, that he always emphasized during

region is generally peaceful due to the absence of major crime incidents."

"No incidence of bank robbery, kidnapping, hijacking, and other high-profile cases were recorded," he said.

The crime rate in the region under the peace and order index during the first half of the year was in a downward trend, having an 11.68-percent decrease.

"This year, it logged 5,529 incidents, lower by 731 compared to the same period last year, with 6,260. On index crimes, it posted a decrease of 339 incidents or 23.64 percent. The non-index crimes went down to 4,434 compared to 4,826 in the same period last year," he said. (PNA)



Traffic Management Unit head Uldarico Garbanzos said there was coordination about the nationwide unity caravan amid the resolution suspending the implementation of the Public Transport Modernization Program (PTMP).

"We prepared for it," Garbanzos said.

Raymundo Parcon, president of the Western Visayas Transport Cooperative, said the break was done during two "dead hours" and they resumed afterwards.

"We would like to manifest to our national group. We would like to present to the government to give leeway to legal cooperatives because we are the ones supporting the program of the government," he said in a separate interview.

Instead of suspending the PTMP, he said the government should instead address the issues involved.

The Western Visayas Alliance of Transport Cooperatives and Corporations, Inc., in a resolution passed last week, called for a "fair and just treatment" of the situation and for the city's Local Public Transport Route Plan (LPTRP) to be exempted from suspension.

Iloilo City is the first highly urbanized city in the Philippines to implement an enhanced LPTRP, covering 25 routes composed of 17 rationalized and eight developmental routes.

The coops said they directly invested over PHP1.7 billion for the modern jeepneys, employing 3,405 workers.

TB cases in Antique alarm town mayor

SAN JOSE DE the disease through droplets, Jinalinan. BUENAVISTA, Antique -The mayor of Laua-an has expressed alarm over high cases of highly contagious tuberculosis (TB) infections in their municipality.

Joenes Jereza, Nurse II and Health Promotion Designate of the Integrated Provincial Health Office (IPHO), said they diagnosed 224 cases from Laua-an town and provided treatment to 175 patients in 2023.

They diagnosed 46 cases in the first quarter of this year, a bit lower than the 50 cases in the same period last year.

Jereza said these recorded cases might have close contact with TB patients, and could have acquired

causing an increase in the cases.

The health officer attributed the high detection rate to the active case finding with the help of the Department of Health, the Global Fund and free mobile X-rays.

MayorAserBaladjay said in an interview Wednesday that he issued a directive for all front-liners, particularly barangay health workers (BHWs), to use facemasks to prevent the further spread of the disease.

"There are two barangays in our municipality where TB cases have been confirmed," he said, adding that most of the cases came from Barangays Jaguiquican and

Meanwhile, the province of Antique, as of the first quarter of 2024, has 759 reported TB cases, with a 19 percent treatment coverage rate. For the same period last year, the province recorded 728 cases.

The total cases for 2023 were 3,180, with a 79 percent treatment coverage rate.

"Patients are urged to go to their RHUs once they have the warning signs of TB such as fever, cough, and weight loss," he said.

He said the treatment for the first two months is very crucial to prevent transmission to close contacts and other vulnerable groups. (PNA)

DTI grants Iloilo weavers additional facilities, equipment

ILOILO CITY – An association of handloom weavers in Iloilo will receive additional shared service facilities (SSF) project from the Department of Trade and Industry (DTI).

The DTI on Monday said that in addition to the anticipated completion of their two-story production and showroom, the Baraclayan Weavers Association (BWA) in the municipality of Miagao will receive this year PHP372,520 worth of SSF project.

"BWA will receive its third SSF project, composed of industrial sewing machines, an embroidery machine, and additional handlooms," it said in a statement.

The weavers received their first set of the SSF project in 2018, with six units of handlooms and accessories and additional seven steel handlooms, wrapping frame, spooling wheel and manual sewing machine in 2020.

In 2023, the association acquired seven wooden looms with accessories and edging embroidery machines.

SSF is the flagship project of the DTI aimed at improving the productivity and efficiency of micro, small and medium enterprises (MSMEs) through access to technology.

"SSF Project is meant to improve MSME competitiveness by providing machinery, equipment, tools, systems, accessories, and other auxiliary items, skills, and knowledge under a shared system between private and public partnership," the DTI added.

Currently, the association with 32 weavers has been producing various products, including hablon cloth made of cotton, polycotton, polyabaca, polypiña, table linens, and tote bags.

The association's loomweaving center was a contender for the DTI Best Shared Service Facility Project in Western Visayas for 2024. (PNA)



DepEd Antique needs P2.5-B to meet classroom shortage

SAN JOSE DE BUENAVISTA, Antique – The Department of Education (DepEd) Schools Division of Antique needs around PHP2.5 billion to address its shortage of 986 classrooms.

DepEd engineer Rex Galero said in an interview Tuesday they are urging local and national governments to help as they still have a big classroom shortage even if there is an ongoing construction of 12 classrooms funded under the 2023 budget, and 28 classrooms this year.

"The classroom shortage is due to the establishment of the integrated high schools, reconstruction of new classrooms to replace the old ones, and some that had been damaged by typhoon Odette," he said.

Galero said some newly established integrated high schools hold classes in makeshift classrooms provided by local government units.

In San Remigio alone, six integrated high schools, especially in remote barangays, were established in the last five years to provide access to elementary learners who would like to proceed to the secondary level.

Hundreds of members of the FCTC gathered at the Fuente Osmeña Rotunda and marched toward the regional office of LTFRB, demanding the national government not to suspend the implementation of the PTMP. "We are here to voice out our opposition to the Senate resolution suspending the public transport modernization program," FCTC chair Ellen Maghanoy said. Bacolod City to form task force to mitigate fire incidents

BACOLOD CITY - Mayor Alfredo Abelardo Benitez said on Monday that he will form a task force to monitor and develop plans to mitigate fire incidents after two instances here last week razed 96 houses and caused the death of purok (sub-village) official.

"We met with our fire marshal (Supt. Jenny Mae Masip) this morning. We had a meeting, together with the concerned departments, on what happened. There were two fire incidents --in Barangay 2 and Barangay 16," he said.

Benitez said these locations are among those considered fire-prone areas or red zones that are hard to reach with no regulations for fire safety.

"In both cases, we found deficiencies during the response. We are planning to rectify those. Part of our strategy to prevent fires is to identify what we call red zones," he added.

In red zones, mainly occupied by informal settlers, houses are made of light materials and stand very near each other.

As of Aug. 4, the Bureau of Fire Protection (BFP)-Bacolod has identified 195 fire-prone areas or red zones in most of the 61 barangays in the city.

In these areas, 57,798 families, comprising 170,143 individuals, occupied 48,467 houses.

BFP-Bacolod data from January to July this year showed that of the 192 fire incidents in red zones, 77 or 40.10 percent are residential fires, whose top three causes include electrical ignition, unattended cooking, and overheated home appliances.


Benitez said the city will provide 10 units of mobile phones to the Bacolod City Fire Station to improve the response time.

"Those calling for response will no longer have to call through landline," he said.

The mayor said there should be alarm and communication systems in place in each purok for more efficient coordination with fire responders and a standard operating procedure (SOP) for crowd control.

'The fatality in Barangay 16 went back to his house. It was too late when he went out; he was trapped. The SOP should be when there is fire, no one should be allowed to go back to his or her house," he added. (PNA)

"Of the newly opened integrated high schools in San Remigio, there is now an ongoing construction of four classrooms at the Aningalan Farm School," Galero said.

The other integrated high schools in San Remigio are still holding classes in makeshift classrooms.

"There are also the 1970s Marcos pre-fab(ricated) and Bagong Lipunan classrooms (buildings) that already need to be replaced for the safety of the learners," he said.

Further, 281 classrooms have to be repaired while 32 are for replacement after they were damaged by Typhoon Odette on Dec.16, 2021.

Galero added Senator Loren Legarda, who hails from Antique, already requested the number of classroom shortage so she could help look for funding.

Antique has 136,691 learners enrolled in public schools as of Tuesday. (PNA)
