

MPIW inaugurates water pipeline project in Jaro district

Metro Pacific Iloilo Water (MPIW) has inaugurated the water pipeline project in Barangay Tabuc Suba Covered Gym on Thursday, September 12.

Amounting to Php7 million, the project aims to supply potable water to nearly 1,500 households in Jaro district such as in SitioIlaya, Barangay Tabuc Suba, and Barangay San Isidro.

This 925-linear-meter pipeline, with 150 mm diameter pipes, marks a significant upgrade to the water infrastructure in Jaro District which will benefit its residents.

MPIW Chief Operating Officer Mr. Angelo David Berba emphasized the project's importance for long-term service reliability and acknowledged the cooperation from the Iloilo City government and its community.

"The Sitio Ilaya Expansion Project is part of Metro Pacific Iloilo Water's investment to achieve longterm service reliability for our customers. We deeply MPIW / page 2

The event kicked off with a motor show at the Provincial Capitol Grounds in San Miguel, Jordan, Guimaras followed by the unity ride going to the Municipality of Buenavista.

The event is one avenue to promote the province as a premier destination for sports and other tourism activities according to Executive Assistant III Gerardo Gaitan who represented Governor JC Rahman A. Nava, MD.

3ID highlights 'peace packages' for former rebels

THE 3rd Infantry Division of the Philippine Army has emphasized the availability of various government assistance programs for members of the Communist Terrorist Group and other extremist groups, encouraging them to consider a peaceful and productive life within the

These include the Enhanced Comprehensive Local Integration Program (E-CLIP), Aid to Individuals in Crisis Situations (AICS), TulongPanghanapbuhaysaAting Disadvantage/Displaced Workers (TUPAD), and the Payapa at Masaganang Pamayanan (PAMANA).

The government extends amnesty and transformation programs to individuals affiliated with the CTG, Moro National Liberation Front (MNLF), Moro Islamic Liberation Front (MILF), and the Revolutionary Proletarian Army – Alex Boncayao Brigade (RPA-ABB).

"As of now we have more than P90 million dedicated solely for the rehabilitation and reintegration of our former rebels," said 3ID spokesperson Lt. Col. J-Jay Javines during a recent press conference organized by the Provincial Task Force to End Local Communist Armed Conflict in Roxas City.

He added that about 1,000 former rebels have already availed of the E-CLIP.

"Pag meron tayong problema sa mga FRs pina pasok natin dyan kahit papano mabigyan sila ng tulong," noted Javines, referring to the AICS program.

(When we have problems with the FRs (former rebels), we make sure to provide them with assistance through the AICS."

The 3ID official also acknowledged other programs of the national government and local government units that have contributed a lot to ending the insurgency problem.

"Insurgency is not purely a military problem. 90 percent of it is a socio-economic-political problem that requires the contribution of everyone," he stressed, noting also the role and contribution of the local media in advocating for peace during the media interaction. (PIA)

achievements in nutrition, noting that only one-eight of 36,000 preschool children are malnourished.

Health projects like the two Uswag Dialysis Centers and the ongoing construction of the P1.2 billion Iloilo City Hospital were also highlighted.

Treñas took pride in the recognitions Iloilo City has received, including awards for its health professionals and institutions.

More healthcare projects are underway, such as a Stroke Rehab Center and Mega Health Center.

He also highlighted financial assistance provided to over 15,000 beneficiaries through the Assistance to Individuals in Crisis Situation (AICS) by the Department of Social

Welfare and Development (DSWD).

The city's educational initiatives were acknowledged, with the Iloilo City Community College (ICCC) and Technical Institute of Iloilo City (TIIC) producing globally competitive graduates, and the Uswag Scholarship serving 2,000 scholars.

Housing programs benefited 8,579 families, with 42 relocation sites and condominium projects, and restoration of public spaces was also noted.

The city government's response to the El Niño crisis through water delivery was mentioned, along with the city's status as the eighth safest in Asia.

Iloilo City's security and anti-drug efforts were

highlighted, including the capture of 877 drug suspects and the seizure of P132 million worth of shabu.

The city has aligned with President Marcos Jr.'s stance against POGOs and continues to support law enforcement with resources.

Environmental initiatives, such as tree planting and a solid waste management facility, were stressed, along with the modernization of public transport, including ecofriendly jeepneys and future plans for a Bus Rapid Transit system.

The city's numerous awards, including the GalingPook and UNESCO Creative City of Gastronomy, underscore its accomplishments.

Treñas concluded by expressing gratitude to various groups and stakeholders for their contributions to Iloilo City's success.

"Together, we build a city that is just not content with its present state but is constantly striving for moremore opportunities. more growth, and more prosperity for all. My beloved Ilonggos, I am forever grateful for the privilege you have given and will continue to give me, to serve you both now and, in the days to come," said Treñas.

Meanwhile, Iloilo City will be hosting the 44th CityNet Executive Committee meeting on November 18-20, 2024.

initiatives include the launch of enhanced Z benefits, which cover cancers such as colon and rectal, and the outpatient benefit package for mental health services, introduced in October 2023.

In the outpatient setting, the Konsulta Package has seen expansions, including the Guaranteed Accessible Medications for Outpatient Treatment (GAMOT) program, which added 32 essential drugs to its list, supporting patients with chronic conditions

like diabetes, asthma, and hypertension.

To further improve healthcare access, the budget per patient under the Konsulta Package increased from Php500 to Php1,700, incorporating screening services like mammograms and ultrasounds to aid in the early detection of breast cancer.

In terms of special benefits, the Z Benefit Package for breast cancer saw a substantial increase by 1,300%, reaching Php1.4

million per patient.

Other notable enhancements include increased coverage for neonatal sepsis and bronchial asthma, and the introduction of outpatient therapeutic fare benefits for children suffering from severe acute malnutrition.

PhilHealth's efforts to enhance benefit packages will continue, with future plans to cover more services such as physical and medical rehabilitation, chemotherapy, emergency care, cataract extraction, and specific Z benefit packages for severe health

conditions. On the financial side, PhilHealth has made strides in improving claims payment, with an average processing time reduced to 19 days—well ahead of the 60-day legal requirement.

For the first half of 2024, PhilHealth has already disbursed Php74.95 billion in claims nationwide, marking a 16% increase compared to the same period last year.

PhilHealth is also advancing its digital services by integrating its system with the eGovPH Super App, launched by the Department of Information and Communications Technology (DICT), allowing members to access their profiles, contributions, and availment histories more easily.

Through the app, members can also register for the Konsulta Package, simplifying access to essential healthcare services.

NTF-ELCAC adopts paradigm shift in peacebuilding efforts

The National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) is adopting a "positive peace" framework, signifying a paradigm shift in its peacebuilding efforts amid the declining threat of communist insurgency.

NTF-ELCAC executive director Undersecretary Ernesto Torres Jr. said there is a need to acquire "new lenses" in the pursuit of peace, noting that it should not be seen as merely the absence of conflict or violence.

"Peace encompasses the integrity of the social, political, and cultural superstructure; and the economic base of a society," he said in a news release Wednesday.

Torres, who spoke before participants during the "Positive Peace" training at the Sheraton Hotel Manila on Tuesday, said such perspective signifies a paradigm shift in the NTF-ELCAC's approach to peacebuilding.

He cited the need to move beyond traditional security measures and adopt a more holistic approach that considers the social, political, cultural and economic factors contributing to a peaceful and prosperous society.

"As peacebuilders, we need to acquire new lenses in our collective effort to attain a just and lasting peace, and inclusive development for a united people," Torres said.

The one-day training, hosted by the non-profit think tank Institute for Economics & Peace in collaboration with the NTF-ELCAC, equipped participants with tools and strategies to integrate "positive peace" principles into its cluster action plan.

Lawmakers' support hailed

The anti-insurgency body also welcomed House Speaker Ferdinand Martin Romualdez's commitment to deliver vital funding and infrastructure to communities freed from communist insurgency.

Torres, in a separate statement, said Romualdez's pledge will significantly advance the government's mission of ensuring sustainable peace and development in these conflict-affected areas.

"This is a crucial step in our shared goal of building a lasting peace. Speaker Romualdez's commitment to NTF-ELCAC / page 4

Around 1.5K Iloilo City residents get access to potable water

ILOILO CITY - Around 1,500 residents here gained access to potable water supply with the inauguration of the 925 linear meters pipe-laying project of the Metro Pacific Iloilo Water (MPIW) in Jaro district on Thursday.

The PHP7 million project will serve residents in Sitio Ilaya, Barangay Tabuc Suba, and Barangay San Isidro, including the Uswag condominium.

"This is just one of the projects that we rolled out. We still have ongoing projects in Barangay Lanit and four more in City Proper. Our target is to expand the water availability and service coverage here in Iloilo City," MPIW chief operating officer Angelo David Berba said in an interview.

He said the project will be formally launched next week.

Before the project, most of the residents in the area



funding and implementing critical barangay development projects are key to transforming these former insurgent strongholds into vibrant, thriving communities," he added.

Romualdez earlier reaffirmed the House's support for the Barangay Development Program (BDP), which has been instrumental in fostering inclusive growth in insurgency-free areas.

"We in the House of Representatives are fully committed to supporting the peace-building efforts in recently cleared areas. To consolidate these gains, I will advocate for more infrastructure and barangay development

projects, which are crucial for long-term stability," Romualdez declared.

"Rest assured, I will explore legislative measures to support this objective and exert efforts to convince our local executives in joining us for a whole-of-government approach in securing peace for our homeland," the House Speaker added.

93% of barangays in Western Visayas drug-cleared

total of 93.21 percent of the 4,051 barangays in Western Visayas are considered drugcleared as of Aug. 31 this year, data from the Philippine Drug Enforcement Agency (PDEA) showed.

"The illegal drug problem in Western Visayas is generally manageable," as stated in the executive summary of the presentation of Intelligence Agent III Ruben Pilar Jr. during the Regional Peace and Order Council third quarter meeting presided by its chairperson, Negros Occidental Governor Eugenio Jose Lacson, at the Negros Residences here on Wednesday.

Of the 4,051 total barangays, the 93.21 percent

> Only 275 barangays, or 6.79 percent, remain to be cleared.

A drug-cleared barangay refers to a village previously classified as drug-affected and underwent the Barangay Drug Clearing Program and declared as drugcleared by the Regional Oversight Committee on Barangay Drug Clearing (ROCBDC).

A drug-free barangay is a barangay unaffected by illegal drugs that has been vetted and confirmed by the ROCBDC.

Based on the data of

the provinces of Aklan, Antique, and Guimaras are 100-percent cleared.

Of the 327 barangays in Aklan, 220 are drugcleared while 107 are drugfree; Antique, with 590 barangays consisting of 288 drug-cleared and 302 drugfree; and Guimaras, with 98 barangays composed of 82 drug-cleared and 16 drug-free.

Drug-cleared data of other provinces, including Capiz, 93.45 percent; Iloilo province, 99.59 percent; and Negros Occidental, 81.36 percent, while for highly-urbanized cities, Iloilo City has 52.78 percent and Bacolod City, 34.43 percent. (PNA)

ILOILO CITY - The Department of Trade and Industry on Wednesday urged Iloilo farmers to embark on bamboo growing given the increasing demand.

Engr. Jonathan Tejida, the supervising trade industry development specialist of DTI, said the demand for bamboo is for construction purposes, especially with the sprouting of micro, small and medium enterprises producing "bahay kubo."

"Technically, the industry is progressive. We cannot think of it as a dying industry; we are progressing because of the support of the government and the community," he said in a media conference.

Citing the recent data from the Municipality of Maasin, Teiida said there are around 3,900 hectares of bamboo plantations within and outside the local government.

During the first half of the year, some 19,000 bamboo poles were sourced from the municipality.

Tejida said they will conduct an inventory to capture the picture of the industry in Iloilo.

Meanwhile, the agency will hold a tree planting activity on Sept. 18 in Alimodian, to celebrate Bamboo Month this September.

Various bamboo products will also be showcased during the second day of the Artesanias de Iloilo on Sept. 24.

There will be food tasting of food products out of bamboo shoots, a bamboo-weaving craft demonstration. and a bamboo product competition in partnership with the Iloilo Bamboo Industry Development Council.

"The product competition seeks to inculcate among producers that they need to introduce new products every vear. We have continuous assistance with the help of the Iloilo Bamboo Industry Development Council," Tejida added.

He said that last month, the Local Economic Development and Investment Promotion (LEDIP) Center of Iloilo province conducted a three-day Bamboo Craft **Enhancement Training for** the members of the Maasin Bamboo Association in Barangay Tubang, Maasin, Iloilo.

DTI also approved two shared service facilities for the bamboo industry in Maasin to improve their bamboo handicrafts.

No. 1 in local revenue growth in PH provinces

Negros Occidental ranks

BACOLOD CITY - Negros Occidental topped the ranking in terms of growth in local source revenues among all the provinces in the country in 2023, based on the list released by the Department of Finance-Bureau of Local Government Finance

"We have been recognized. It's even more a challenge for us to be able to continuously increase our local source of funds," Governor Eugenio Jose Lacson said in an interview on Wednesday.

Based on the year-on-year growth in local source revenues, Negros Occidental recorded the highest ratio of 163.66 percent for fiscal year 2023.

The recognition of nationally ranked top-performing local government units in strengthening local government finance for fiscal years 2022 and 2023 was in BLGF Memorandum Circular 017-202, dated Aug. 19.

Trailing behind Negros Occidental are Camarines Sur, North Cotabato, Nueva Viscaya, Misamis Occidental, Zambales, Palawan, Nueva Ecija, Sorsogon, and Davao Oriental.

Lacson mentioned in his State of the Province Address last month that the Provincial Treasurer's Office "exceeded expectations in revenue generation for both calendar year 2023 and the first semester of 2024."

Data showed that local revenue generation in the previous year "soared to a staggering 198 percent of our target, amounting to PHP1.2 billion compared to the previous period (2022) with an estimated target collection amounting to PHP635.9 million."

"This remarkable achievement demonstrates our team's successful efforts in revenue generation and its significant contribution to local finances," the governor said. In the first half of 2024, the province's collection efficiency

of local sources stands at 103 percent, with an actual collection of PHP713.3 million, from last year's PHP694 million. "It proves that the revised revenue measures have been effective,

efficient, equitable, and sustainable," Lacson said. (PNA)



Hours after Kingdom of Jesus Christ founder Pastor Apollo Quiboloy was taken into custody early Sunday evening, there was confusion on whether he was arrested as a culmination to a 16-day standoff that pitted the Philippine National Police with the members of the KOJC.

Government officials initially said the pastor had been arrested. It made sense.

After all, they had been pursuing Quiboloy for a long time. There was a warrant of arrest which the PNP had been trying to serve on Quiboloy's person outside the KOJC compound.

But lawyer Israelito Torreon said no; Quiboloy made "the ultimate sacrifice."

"He could not bear to witness a second longer the sufferings that his flock was experiencing for many days," Torreon said of the pastor accused of sexual abuse and qualified trafficking, among others, both in the Philippines and in the United States.

out of his own volition, gave up his person to the authorities. It conveys a willful submission to the law which one supposedly respects.

An "arrest" sounds otherwise, pointing to a resistance or refusal to be taken. Unfortunately for the person being arrested, he was overpowered. Defeated. Humiliated.

A surrendering pastor making the ultimate sacrifice on behalf of the people who follow him and regard him as some divine entity is more palatable to his supporters. What a poignant narrative that can be shoved down the throats of those with the misfortune of not knowing how to verify their leaders' claim.

But he "surrendered" because he was told he must do so, or face other consequences. In any case, with the objective of the word play being obvious to all, does the difference even matter?

Beyond the word-twisting and face-saving "Surrender," of course, means that the pastor, attempts, what we should be looking at now is the

People must see through how the rich and mighty employ all means available, even their facility with words, to sway public opinion.

But they cannot get away with so many things and not be caught – or, prevailed upon to surrender.

We are fortunate in Quezon City to have legitimate CSOs organized under a people's council, which has institutionalized their participation in local governance. Sectoral CSOs with specific advocacy skills participate in the deliberation, conceptualization, and evaluation of city projects. Their involvement in local governance allows them to monitor budget expenditures and track project completion.

However, structural changes are the only way to achieve CSO participation in local governance. In Quezon City, it was the determination of both the CSOs and the local executive that enabled this participation. A shift in the cultural disposition of the people also played a crucial role, allowing them to assert their role as active participants in local governance. People's participation ensures the sustainability of government programs and aligns them with the needs of the constituents.

The Department of the Interior and Local Government (DILG) has mandated the creation of people's councils across local government units (LGUs). However, compliance with this directive has been disappointingly low. According to a 2022 DILG report, only two out of 82 provinces have established a people's council. Similarly, just 13 out of 149 cities and 104 out of 1,489 municipalities have followed

Local and national governments should encourage people's participation. The Philippines has a rich tradition of vibrant CSO engagement across all sectors, including business, farmers, workers, and the urban poor, among others. The understanding of community and national issues I've encountered from all sectors has always impressed me. I firmly believe that nation-building and national development should not be the sole responsibility of the government, but rather the active participation of the people.

Transformational leadership is an approach in which a leader inspires and motivates team members to create positive changes within an organization. It is a dynamic and powerful leadership style that can lead to rapid innovation, improved conflict resolution, increased group morale, decreased turnover, and a sense of ownership among team members (Bass, B.M., 1985).

Transformational leadership must focus on four elements, namely: as a role model, as a motivator, as an innovator, and as a collaborator. These are my contextualized basic elements for a transformational leader to improve school performance and culture a system of excellence towards the realization of DepEd vision and mission.

Proper leadership to implement this change requires the ability to influence the thoughts and actions of other people (Taleghani, Salmani, &Taatian, 2011). These alternative models of teaching and learning offer the possibility for educators to reinvent the teaching and learning process (Gonzales & Vodicka, 2012). Because many students are now bombarded by technology at every turn, educational classrooms may benefit from implementing technology tools that could potentially heighten student interest and provide a more personalized learning experience (Gonzales & Vodicka, 2012). Kotter (2012) stated, "Change leadership is much more associated with putting an engine on the whole change process, and making it go faster, smarter, more efficiently. Transformational Leaders themselves, constantly learn, and transform their perspectives.

As proposed by Kouzes and Posner (2017) transformational leadership is grounded in the concepts of inspiring and motivating people toward a shared vision to achieve goals at a higher standard. Hooper and Bernhard (2016) characterized transformational leadership as a model for the school stakeholders to work together for the same common goal. A transformational leader intentionally designs structures for collaboration within a school to be culturally responsive and inclusive of all students to support teaching and learning (Hooper & Bernhard, 2016).

As school leader designated to take care a school which is located in a challenging situation, I reflectively embraced the opportunities given to me by DepEd and LGU. To some this maybe sort of challenging detours, yet to me it's a blessing. A blessing to be part of the less privilege and bring some source of inspiration to some that would help the smile and hope to recover amid their unfamiliar circumstances.

As a collaborator, the leader'sdecision must come from a variety of sources, established open communication both in the internal and external community, and it should be data driven. The leader facilitates rather than directs all actions. Information is shared, decisions are made by the group and solutions are arrived at after considering input from the entire team. It is a shared responsibility to all the members to work hand in hand in the quest for excellence.

Ramsey (2009) states that when school leaders communicate effectively, students learn, parents and community members understand and support what the school is doing, and the process of teaching and learning moves forward. However, as school leaders begin to consider implementing the tools needed for personalized learning, they are quickly confronted with the challenges of locating content; finding, hirring, and managing teachers; organizing systems to support students; and selecting and managing technology (Watson &Gemin, 2009). Leading a school as an instructional leader in a time of crisis is stressful especially in times of change. Instructional leaders must work to promote positive relationships with the teachers in the building as relationships and bonds between teachers and principals are vital to the success of collaboration efforts (Malloy &Leithwood, 2017).

Transformative leadership is obviously aspirational; it is a particular orienting view of the current condition and the human potential. As such, no one individual or group can necessarily claim to be the shining example of transformative leadership. To the extent that it is aspirational, transformative leadership is also an invitation to participate in a collective journey into the future, a journey of creative inquiry, creating ourselves, our relationships, and our communities.

The basic premise of Transformative Leadership is that everyone can lead, and that particularly in this transformative moment, everybody contributes to, and in fact co-creates, the world we live in, whether conscious of their agency or not. Every choice, every action, every discussion, every interaction is a reflection of how we are leading our own lives. Transformative Leadership invites everybody to ask what kind of a world they are creating through their thoughts, beliefs, actions and interactions. Transformative leadership is, at its heart, a participatory process of creative collaboration and transformation for mutual benefit. At the core of Transformative Leadership are 4 orienting concepts, Being, Relating, Knowing, and Doing that assist in the framing and development of our understanding of the world, and our own approach to living and leading.

Encourage collaboration and partnership and quest for excellence for the betterment of the school and local community. Constantly communicate with stakeholders for feedback for the continuous improvement of the school system.

One year from now, all I learned on this subject Philosophy and Practice of Transformational Leadership, I expect to see multiple transformation to my leadership career and the organization I lead.

In conclusion, as a scholar of the PNU, I would embrace change for the better, reflectively, and critically adopt the result of transformation as a school leader. Thus, change is inevitable but development with sustainability to improve our lives as an institution and as part of the national government agency is a must. Seeing myself one year from now, as a leader and an agent of change, I will be a contributory factor for sustainable development aligned to the DepEd's vision, mission, and core values and to the MATATAG agenda of our DepEd secretary. The learnings I valued from here will be transformed into a quality practice that would emulate my colleagues, community stakeholders and all that I work with to be inspired to do and practice excellence to achieved our desired goals towards ourselves, society and God.

that we have on the substations, on the lines, on the vegetation, on the causes and everything, we were able to craft our fiveyear development plan," Castro said.

Negros Power, the joint venture partner of Central Negros Electric Cooperative (Ceneco), obtained a franchise to manage and operate the electricity distribution system in the cities of Bacolod, Bago, Talisay, and Silay, as well as the municipalities of Murcia and Don Salvador Benedicto in July this year.

In his presentation, Castro said the first three years will be the rehabilitation and standardization phase, including meter replacement and installation of elevated metering centers, rehabilitation of major substations, and improvement of infrastructure such as pole replacement, intermediate installation, and line rehabilitation.

"Right now, we've seen about 50,000 electric meters that have to be replaced. Immediate is about 30,000. We will also do the elevated metering centers because that will actually reduce the systems loss. We have to do major rehabilitation in three years for nine or eight substations," he added.

Also included in the first three years is the implementation of distribution utility best practices such as the 69 kilovolt (kV) transmission looping, in/out configuration at 69kV line for N-1 reliability and line protection, load break switches and auto circuit enclosers installation for feeder tie-ups and faster fault isolation, and replacement of old pin insulators.

The fourth and fifth years will be the modernization and expansion phase, which will involve the use of a supervisory control and data acquisition (SCADA) system, the establishment of the Capitol Substation, expansion of lines and increased capacity, and continuous improvement of system reliability and capacity.

It will also include deploying innovative solutions, such as increasing response teams and deploying quick response teams in motorbikes for efficient troubleshooting in challenging locations.

Castro said they would also acquire a 30/37.5 megavolt amperes (MVA)/69/13.2kV mobile substation worth PHP103 million to temporarily serve customers while a particular permanent substation undergoes maintenance.

Bacolod City Mayor Alfredo Abelardo Benitez, who was among the officials who attended the Negros Power presentation, welcomed the five-year development plan but said the consumers should watch out for its implementation.

"It's better that they presented it to the stakeholders. We heard it, and we will hold them to their word of executing the plans that they have presented," he added. (PNA)

AN ORDINANCE CREATING ONE (1) POSITION NAMELY THE CITY GOVERNMENT ASSISTANT DEPARTMENT HEAD II – SALARY GRADE (SG) 24 UNDER THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) OF THE OFFICE OF THE CITY MAYOR, ENUMERATING ITS FUNCTIONS AND APPROPRIATING **FUNDS THEREOF**

Sponsored by Hon. Rex Marcus B. Sarabia, seconded by Hon. Jose Maria Miguel S. Treñas and Hon. Johnny Y. Young;

WHEREAS, Section 76 of the Republic Act 7610 or the Local Government Code of 1991 states that: "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, the Local Government of Iloilo City through the Sangguniang Panlungsod is empowered by the law to create offices and positions as the need arises;

WHEREAS, the Public Employment Service Office (PESO) of the Iloilo City Government was established in compliance with R.A. 8759, otherwise known as the PESO Act of 1999. The PESO was institutionalized through Sangguniang Panlungsod Regulation Ordinance (SP-RO) No. 2019-507 and further amended by SP-RO No.

WHEREAS, the PESO is responsible for facilitating employment, providing labor market information, and supporting job seekers and employers through various programs, services, and partnerships, thereby enhancing local employment opportunities and economic development;

WHEREAS, the extensive responsibilities and associated workload of the PESO necessitate the appointment of an additional supervising officer to improve task delegation, ease the workload, and strengthen the management of funding to enhance the support they provide to our llonggo Jobseekers and Migrant Workers;

WHEREAS, as stipulated in the Social Protection and Sensitivity category under CY 2024 and 2025, Section 3.16 of DILG's Memorandum Circular 2024-064, pertaining to the 2024 Seal of Good Local Governance, the permanent PESO Manager for a highly urbanized city such as Iloilo City must hold a minimum Salary Grade of 24. Consequently, there is a need to create an additional position with the said Salary Grade to comply with this

- Shall facilitate the safe return of OFWs who are in distress or have encountered emergencies, such as natural disasters, conflicts, or abuse;
- Shall provide emergency financial assistance to OFWs and their families in critical situations:
- Shall conduct financial literacy programs to help OFWs and their families manage their earnings effectively;
- Shall implement a more structured approach to monitoring the well-being of OFWs, which will involve regular check-ins and data collection through Barangay Employment Service Officers (BESO). This data will be used to inform our advocacy efforts and to ensure that our services continue to meet the evolving needs of our community;
- Shall perform other duties that may be assigned by the head of office from time to time.

AN ORDINANCE CREATING THREE (3) POSITIONS, ONE (1) ADMINISTRATIVE OFFICER V - SG 18 AND TWO (2) ADMINISTRATIVE ASSISTANT IV - SG 10 UNDER THE OFFICE OF THE SECRETARY TO THE MAYOR - OFFICE OF THE CITY MAYOR, ENUMERATING THEIR FUNCTIONS AND APPROPRIATING **FUNDS THEREOF**

Sponsored by Hon. Rex Marcus B. Sarabia, seconded by Hon. Jose Maria Miguel S. Treñas and Hon. Alan A. Zaldivar;

WHEREAS, Section 76 of the Republic Act 7610 or the Local Government Code of 1991 states that: "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";

WHEREAS, the Local Government of Iloilo City through the SangguniangPanlungsod is empowered by the law to create offices and positions as the need arises;

WHEREAS, lloilo City is one of the highly urbanized cities in the Philippines. As the Chief Executive, the City Mayor's Office exercises general supervision and control over all programs, projects, services, and activities of the LGU. This includes ensuring compliance with laws and ordinances, maximizing resource generation, and delivering basic services and facilities. Furthermore, the Office also manages vital responsibilities in city administration and development;

WHEREAS, the Office of the Secretary to the Mayor is integral in implementing policies, plans, programs, and projects, as well as in the delivery of the functions, and in the execution of the City Mayor's functions and responsibilities:

WHEREAS, the Office of the Secretary to the Mayor entails substantial volume of workload with duties and responsibilities of the personnel being receiving, filing, organizing, drafting, and endorsing documents to the Chief Executive of Iloilo City, as well as executing all directives from the same;

WHEREAS, the current structure of plantilla positions in the Office of the Secretary to the Mayor lacks midlevel roles, with a significant gap between supervisory positions and lower-level roles at Salary Grades 6 and 2. This gap limits the scope of duties and responsibilities within the Office. Creating an Administrative Office V (SG 18) will provide necessary supervision, while additional Administrative Assistant IV (SG 10) positions will support clerical tasks and enhance operational efficiency;

WHEREAS, the addition of these new positions under the Office of the Secretary to the Mayor is essential for enhancing the operational efficiency and effectiveness of the Office. These new roles with address critical gaps in the current staffing structure, facilitate the effective management of substantial workload and ensure the smooth

DA Chief eyes expanded **ASF gov't-controlled** vaccination by October

Agriculture Secretary Francisco Tiu Laurel Jr. on Wednesday expressed plans to expand the governmentcontrolled vaccination against African swine fever (ASF) in Visayas and Mindanao in October.

"Iyong (The) procurement process for the 150,000 (doses), it should be awarded in, by, estimated timeline by October 10. So, October 10 ang target date na ma-award iyongkontratasa (to award the contract to the) supplier and then they will deliver the same day," he said.

Initial target areas for

the government-controlled ASF vaccination expansion include red zones or areas with active ASF cases in La Union, Quezon, Mindoro, Cebu, North Cotabato, and Sultan Kudarat.

As of Sept. 6, the BAI said 472 barangays in 109 municipalities and 31 provinces were still classified as red zones.

The agrichief, meanwhile, agreed with Senator Cynthia Villar following the Senate committee hearing on ASF, citing the need for more vaccine suppliers in the country.

To date, the DA is using AVAC live vaccines from a supplier in Vietnam for its government-controlled vaccination in Batangas.

In a statement Tuesday, APECO said its President and Chief Executive Officer Gil Taway IV has submitted a formal position paper to the National Commission on Indigenous People (NCIP) reflecting the investment promotion agency's support for the application for a Certificate of Ancestral Domain Title (CADT) of the IPs.

APECO said it will assist in the technical and legal aspects of the application and coordinating closely with the NCIP for the IPs to acquire their CADT.

"The Agtas of DiCaDi have, for generations, served as rightful custodians of their ancestral territory. Their

PhilHealth urges more Ilonggos to avail of Konsulta package

Ilonggos are encouraged to avail of the KonsultasyongSulit at Tama (Konsulta) Package, a primary benefit provided by the Philippine Health Insurance Corporation (PhilHealth) through 172 accredited providers in Western Visayas.

During the KapihansaBagongPilipinas forum here on Tuesday, PhilHealth Region VI Field Operations Division officer-incharge Bien Paul Obordo said 126 of their providers are local government unit (LGU)-based, 41 are hospital-based, and five are private clinics.

The program has benefitted 189,150 members so far as of July, representing an accomplishment rate of 118 percent against their target of 160,306 for the period.

"Based on our data, PhilHealth has already paid around PHP72 million to our Konsulta providers in Region 6. Our target is 100 percent for all LGUs and cities. Eleven LGUs have not applied for accreditation," he said.

said, adding that the current number of providers is not enough to cater to the more or less 8.2 million population of Western Visayas.

The Department of Health and local government units are requested to provide additional doctors to help in the implementation.

Part of the Konsulta Package is the PhilHealth Guaranteed Accessible Medications for Outpatient Treatment, where 32 more essential drugs and medicines have been added to the 21 existing available medicines.

"There are free maintenance medicines for patients with asthma, diabetes, and hypertension, among others, and laboratories as will be recommended by your provider," the PhilHealth said.

Under the KonSulta program, members will be given access to free medical consultations, free health risk screening and assessment, free selected laboratory and diagnostic testing, and free He said availing the services is faster selected drugs and medicines in line with

Society, said the two-foot and eight-inch bell with a lower diameter of 32 inches was cast in 1794, one year after the first known stone church in the municipality was constructed.

"The bell is very special and rare, believed even to be the oldest in Panay and Negros islands," he said.

He said that the Augustinian priest Fr. Jose Abollo, assigned in Sibalom from 1791 to 1806, was responsible for the building of the first stone church and the casting

"The magnificent bell is also a symbol of how Sibalom was a progressive town since then," De Gracia said.

Casting a bell entails melting sacks of coins, which depicted how progressive Sibalom, considered one of the richest municipalities in Panay island and the rice granary of Antique province, even during that time, he said.

Parish Priest Jose Tubianosa recalled the bell was part of the lives of the people of Sibalom.

"I could recall that every six o'clock in the afternoon when the bell rings, people really stopped to pray whether they are walking along the streets or playing basketball in the plaza," he said.

The bell also rings whenever a church member dies or to inform the public to prepare for typhoons.

He also said that with the 230th anniversary of the bell, the parish welcomes pilgrims, tourists, and students who would like to visit and see the bell.

On the other hand, the over 200-year-old Talisay tree just across the Sta. Rita de Cascia Parish Church was marked a natural landmark, simultaneous with the commemoration activity.

"The town's interactions with Spanish colonial authorities and its evolving social and cultural practices extended around the tree, embedding it in the early colonial of the town's history," said Edbert Jay Cabrillos, a professor at the University of Antique and the program convener.

He said that the tree was a witness to the brutal conflict during the Philippines' struggle for independence from Spanish colonial rule and during World War II when the Japanese forces took control of Sibalom.

"The Talisay tree became infamous for the hangings that occurred there with the Japanese using the public space to instill fear and maintain control of the population," Cabrillos said.

Hopefully, the National Commission on Culture and the Arts (NCCA) will recognize the bell and the Talisay tree as important cultural and historical property so it is protected and preserved, he said. (PNA)

Renewed trust in due process sways Mabilog to return to PH

ILOILO CITY – Former Iloilo City Mayor Jed Patrick Mabilog returned to the Philippines with a renewed trust in the government's commitment to uphold due process and fairness, his legal counsel, Jeric Jucaban said Wednesday.

consideration and "respect for the law and

assessment of the current judicial system, Mayor Mabilog has decided to come back, trusting in the current administration's commitment to due process and fairness," Jucaban said in a statement.

He added that as a "After careful manifestation of Mabilog's his readiness to address the matters that have been pending against him," he submitted to the legal process and the custody of the National Bureau of Investigation.

The former mayor posted bail for the graft charges filed against him at the Sandiganbayan.

"At this time, Mayor Mabilog will refrain from making any public statements, as he is currently evaluating his legal remedies concerning the cases filed against him during his time abroad. He seeks to navigate these challenges with the utmost care and consideration," Jucaban said.

Mabilog sought asylum in the United States for fear of his life after he was tagged by former President Rodrigo Duterte as a narco-politician.

He arrived at the Ninoy Aquino International Airport Terminal 3 on Tuesday, where he was met by Iloilo City Lone district Rep. Julienne Baronda and his close friends.

Baronda, in a statement, said Ilonggos welcomed Mabilog's "courageous and selfless decision to return home and seek justice for his sullen reputation and the tarnished image of Iloilo City."

"We all know he was never a drug protector. We are all witnesses, our beloved Iloilo City was never the most 'shabulized'," she said.

Political comeback?

Meanwhile, Justice Secretary Jesus Crispin Remulla said it is still too early to tell what the return of Mabilog will bring about, but said that the latter's decision may be related to political plans for next year.

"He may have some fears for his life and we are willing to grant protection of sorts unless of course he can be given witness protection later on if there are cases he wishes to bring forward. But as it is right now, he's one person who just returned at the political landscape," Remulla said in a press briefing at the Department of Justice in Manila when sought for comment.

"Elections are coming in. Filing of COCs (certificates of candidacy) is next month. It's very timely for him to come back

and relaunch his political career. Practically, that's how I look at it. And of course, lumamig na siguro ang hangin sa paligid niya, kaya kung titingnan natin (the atmosphere around him has somewhat relaxed, and if we look at it) it's his decision to make and he went home to, I think, rejoin the political landscape," he

The DOJ chief, however, said Mabilog must squarely face the charges against him.

"He will have to clear himself from the charges brought up against him at the Sandiganbayan. He posted bail, I was told vesterday. The NBI was there to make sure that he didn't come home blind and just ride a car and drive off to the sunset. Pero nung sinamahan siya na mag-post ng bail (But when was accompanied to post bail), and we know that he was going to follow the law. Tingnan natin (Let's see)," Remulla said. (PNA)

PhilHealth pays close to P4B in claims in W. Visayas

ILOILO CITY – The Philippine Health Insurance Corporation (PhilHealth) has paid over PHP3.995 billion in claims in Western Visayas from January to June 30 this year.

Lifestyle diseases like hypertension ranks second in terms of claims at PHP67.989 million, PhilHealth VI public affairs unit head Janimhe Jalbuna said in an interview on Wednesday.

The highest was moderate-risk pneumonia with PHP314.8 million.

Meanwhile, the hemodialysis procedure, which got the highest claim for medical procedures at PHP593.68 million, has risk factors such as diabetes and hypertension.

"Some of these conditions can be addressed by our Konsulta benefit package. Hopefully, they will be able to maximize the Konsulta benefits to at least prevent the medical condition, if they have, from worsening and getting confined," Jalbuna said.

Other top claims for medical cases included hypertensive emergency urgency at PHP67.99 million; acute gastroenteritis, PHP39.86 million; urinary tract infection, PHP40.72 million; peptic ulcer disease without hemorrhage, PHP24.24 million; dengue fever, PHP33.06 million; anemia, PHP34.68 million; chronic kidney disease with PHP47.38 million; fluid and electrolyte disturbances, PHP24.65 million; newborn sepsis, PHP39.48 million; and asthma in acute exacerbation with PHP20.26 million.

For medical procedures, included in the top 10 claims were the expanded newborn package with PHP76.34 million; routine obstetric care including antepartum care, PHP101.6 million; chemotherapy administration, PHP93.28 million; animal bite, PHP34.2 million; intensity modulated treatment delivery, PHP55.94 million; routine obstetric care including prenatal, PHP63.47 million; outpatient with human immunodeficiency virus – acquired immunodeficiency syndrome (HIV-AIDS), PHP61.2 million; caesarean section primary, PHP115.19 million; radiation treatment delivery, PHP10.59 million; and caesarean delivery, with PHP65.22 million.

Jalbuna said through the Konsulta package, they are looking at reducing in-patient care, especially for common medical conditions.
