ILOILO Governor Arthur "Toto" Defensor Jr. is sure to finish his third and final term as he does not have a strong opponent in next year's election.

The vice governorship, however, will be a tough contest as there are two Defensor's runningmate Anilao Mayor Nathalie Ann Debuque and Fifth District Congressman Raul "Boboy" Tupas.

Defensor vouched for Debuque's qualifications

to become the next vice governor. She is "intelligent, competitive, and dynamic," he said, adding "you should know her for I am sure you will also like her."

Baronda, Treñas-Chu sure winners, VM

Ganzon faces strong opponent

BOTH candidates for representative and mayor of Iloilo City re-electionist Julienne "Jam-jam" Baronda and Mayor Jerry Treñas' daughter RaisaTreñas-Chu, respectively, are apparently sure winners in next year's election.

This, as the camps of Baronda and Treñas reached a so-called "unity agreement for peace".

Treñas, who is supposed to run for his third and final term, deferred his re-election bid to give way to his daughter RaisaTreñas-Chu.

The vice mayoralty post, however, is not without a contest as the Baronda camp fielded former Councilor Julie Grace "Love-love" Baronda as its candidate for vice mayor against incumbent Jeffrey Ganzon.

certificates of candidacy (COCs) in the afternoon of October 8, which is the last day of filing.

Prior to that, there were rumors that former Mayor Jed Patrick Mabilog would

run for mayor under the Baronda camp.

Joining the Team Gugma's proclamation rally at the University of San Agustin, Mabilog declared that he has sacrificed by not running for mayor so that there will be (political) peace in the city and in deference to Congresswoman Baronda.

He later apologized to all his supporters who expected that he would file his candidacy. "I prayed, I prayed hard... there's not just enough time. We will gather our forces and fight Both camps filed their another day!" he said in a Facebook post.

#### 7,000 beneficiaries get at **DOLE-TUPAD** assistance

The Department of Labor and Employment (DOLE)-6 held its "Tulong Pang hanap buhay sa Ating Disadvantaged / Displaced Workers" (TUPAD) Program at Iloilo Sports Complex in La Paz, Iloilo City on October 4.

The said payout consisted of 7,000 beneficiaries coming from different barangays and districts in the city of Iloilo.

The beneficiaries have received Php 4,800 each after their ten days of work such as cleaning within their respective communities.

The event was spearheaded by Uswag

Ilonggo Partylist Representative Cong. James "Jojo" Ang Jr. along with Iloilo Governor Arthur "Toto" Defensor Jr. who is also the regional chairperson of the said partylist.

It was also attended by local officials from the city government such as Vice Mayor Jeffrey Ganzon, Executive Assistant Raisa Treñas-Chu, and the members of the Sangguniang Panlungsod (SP).

The DOLE-TUPAD Program is an initiative by the government which aims to give assistance and support to underemployed, self-employed, and displaced marginalized workers.

## W. Visayas begins ASF recovery program

Western Visayas is now on the road to recovery from the impact of the African swine fever (ASF), with the Department of Agriculture kicking off its sentinelling program in the region.

Iloilo Provincial Veterinarian IV Wendy Degillo said Tuesday that the swine dispersal started in five barangays in the municipality of Oton on Oct. 4.

"Actually, in the whole Western Visayas, Oton is the first. They have 225 farmer-beneficiaries, but the delivery of piglets is by batch. Last Friday, they distributed 73 piglets for five barangays," she said in an interview.

The recipients came from Barangays Mambog, Bita Sur, Bita Norte, Caboloan Norte, and Caboloan Sur.

Each farmer is entitled to three piglets, but only one was released on Friday.

The initial piglets will be tested and if found negative, that is the only time that the recipients could get their additional two piglets.

Before the dispersal, there was a thorough disinfection of their pigpens, and an environmental swabbing was conducted to ensure the place was free from the virus.

Degillo said the piglets were also tested to ensure they were negative for the virus.

"All recipients are practicing biosecurity level 1. They have been oriented about it; it's now up to them how they put it into practice," she said.

Degillo said a weekly monitoring will be conducted by the barangay officials and trained barangay biosecurity officers.

At present, 17 of the 28 local government units affected by ASF in Iloilo have progressed from red (infected zone) to pink or buffer zone.

These are Oton, San Miguel, Santa Barbara,

New Lucena, Leganes, Dumangas, Ajuy, Batad, Concepcion, Barotac Viejo, Mina, Banate, Lambunao, Dingle, Janiuay, San Enrique, and Zarraga.

They also encouraged the 11 others to comply with documents to progress to the pink zone.

In the meantime, data from the National ASF Prevention and Control Program showed that 44 of the 76 LGUs hit by ASF have progressed to pink from red.

Further, two LGUs from the region upgraded from pink to yellow.

Those in the pink zone can already start the sentinelling. (PNA)

## BIR-Iloilo nears P18.516-B collection target for 2024

Bureau of Internal Revenue Region 11 (Iloilo) has already collected PHP13.33 billion as of September, out of the over PHP18.516 billion collection goal for

During the Kapihan sa Bagong Pilipinas on Wednesday, BIR 11 reported that the collection from January to September this year is higher by PHP1.49 billion compared with the same period in 2023.

BIR Revenue II consisted of revenue district office (RDO) 71 based in Aklan,

ILOILO CITY – The RDO 72 in Roxas City, RDO 75 in Zarraga in Iloilo, RDO 73 covering Antique, and RDO 74 in Iloilo City.

> "With these RDOs, we were able to deliver the very much-needed collection for Revenue Region 11-Iloilo. You are a witness to these various developments and the improvement that made Iloilo become another BGC (Bonifacio Global City) of the Visayas. It's another investment capital, I believe, because we are collecting this PHP18 billion taxes wherein the internal revenue allotment goes back to

different local government units that we have," BIR 11 officer in charge Regional Director Emilia Combes.

Combes said the collections were through voluntary compliance and enforcement activities they have initiated.

Collection Division chief Lea Lebrilla, meanwhile, said they constantly monitor their top withholding agents, run against tax evaders, and enforce the Oplan Kandado to ensure they achieve the target collection.

"For Region 11, speaking of delinquent accounts, we have collected a total of PHP17.7 million as of September 2024, and that includes different settlement modes. Last year, we collected PHP10.3 million, so we have an increase of PHP7.3 million or 17.46 percent," she said.

District offices also continue to monitor their top taxpayers, she added.

Last year, BIR 11 collected PHP15.979 billion, an increase of PHP1.22 billion compared with the PHP14.75 collection in 2022. (PNA)

## School-based immunization targets 27K learners in Antique

BUENAVISTA, Antique-The school-based immunization (SBI) for Tetanus Diptheria (Td), and Human Papillomavirus (HPV) targets 27,281 learners in Antique.

"The school-based immunization resumed after the pandemic to provide the learners with protection from measles, pertussis, and other diseases," said Department of Health (DOH) Antique provincial head Dr. Rommel Garganera during a press conference on Wednesday.

Antique Provincial Health Office National Immunization Program Coordinator Tesie Mae Bañes said the 27,281

SAN JOSE DE learners are composed of 9,966 learners in Grade 1 and 11,358 learners in Grade 7 targeted for MR the Measles-Rubella (MR), and TD, and 5,957 female learners in Grade 4 for the HPV.

> "We were not able to have school-based immunization since 2019 because the learners did not have face-to-face classes," she said.

> She added they will have another month-long backup or immunization in November to reach out to those who were not vaccinated in schools.

> Teams from Rural Health Units will reach out to the learners in schools in geographically isolated and disadvantaged areas (GIDAs).

## **VCT** boosts Iloilo port terminal services with new mobile harbor cranes

ILOILO CITY - The Visayas Container Terminal (VCT), the business unit of the International Container Terminal Services, Inc. (ICTSI) in Iloilo, on Wednesday put into operation its two new mobile harbor cranes (MHS), boosting this city as a competitive and efficient trade gateway for Western Visayas.

"These new cranes, the largest and most modern in Panay Island, represent our commitment to pursue a culture of efficiency and advancement. The flexibility offered by these MHCs will allow us to deliver an immense improvement in service to our clients," ICTSI executive vice president Christian Gonzales said in his speech during the inaugural operation of the MHCs at the Iloilo Commercial Port Complex here on Wednesday.

Each MHC has a reach of 46 meters with a lifting capacity of 100 tons, boosting the ability of the VCT to handle the increasing volume of containerized, bulk, general, and cargo projects in the region, according to the VCT statement.

"The new technology is expected to streamline operations, leading to faster turnaround times for vessels and trucks, improved safety, and greater port efficiency," it added.

In an interview, outgoing VCT executive director Timothee Jeannin said they have made significant improvements in the terminal facilities and strategic civil works since the firm started operating in April this year.

The VCT has acquired new reach stackers, prime movers and empty container handlers, and expanded its bulk operations with additional bagging machines, clamshells and mobile equipment.

"We also secured the necessary mobile equipment to improve our operational capacities. It is one phase of VCT, which is already achieved and secured. We

already secured some specific clients," Jeannin

To accommodate all vessels coming, Jeannin said, they decided to dredge berths 2, 3, and 4, which were not in their original

A new international trade service from Vietnam to Iloilo will have its first call this late October.

Its current international services are from Tianjin, Yantai, Qingdao, Shanghai, Wenzhou, and Xiamen to Iloilo; and Singapore to Iloilo, connecting cargoes from the United States, European Union, and other global ports.

Acting Iloilo City Mayor

Jeffrey Ganzon, in his message, said the arrival of the MHCs is more than just an addition to the port facilities, but also represents the future of the city's economy.

"This port modernization that we are currently witnessing will create more investment opportunities across the region. With VCT's increased operational efficiency, greater cargo handling capacity, and enhanced connectivity, this will allow our businesses to meet the rising demand of our thriving local economy and bolster our competitiveness in national and international trade," he said. 

## Military modernization

How serious is the Philippine government in in the vital sealane. modernizing its military?

Very much so, it would appear, amid rising tension between the Philippines and China in the West Philippine Sea.

As a matter of fact, the government recently organized an exhibition where global defense contractors—a total of 291 firms—put their advanced military technology and weapons systems on display. This is part of the Philippine effort to proceed with a multi-billion-dollar program to modernize our military.

That the Philippines is an emerging market for the defense industry is clear. The International Development and Security Cooperation think-tank believes so: "Our strategic issues with China have caught the attention of defense firms, and the exhibit demonstrates support from like-minded nations, many of whom are our partners and allies."

The government has allocated \$35 billion, spread over the next decade, as it faces increased aggressive actions by Beijing on sea and air over contested areas

Buying advanced military hardware and technology will complement the Marcos administration's steppedup security partnerships with other friendly countries, such as Japan and Australia, to boost the country's capability to defend its territorial and maritime claims in the South China Sea.

We have the 1951 Mutual Defense Treaty with the United States where we vowed to come to each other's defense in case of an armed attack by a third country. While the US government has time and again said that its commitment to help defend the Philippines is "ironclad," we must also build up a credible deterrence posture on our own.

The goal of military modernization is to develop a credible defense posture at this time. We need to acquire advanced assets such as fighter jets, submarines and missile systems to protect our territorial integrity.

While long-standing military ties ensure the United States is a key supplier, the Philippines has broadened defense procurement to nations such as India, Israel, Poland, South Korea, and Turkey. The

recent exhibition featured new companies, with other participating nations, including Britain, France and

A significant development along this line is that in 2022, the Philippines purchased a \$375-million BrahMos anti-ship missile system, and the firm is now offering a ship-mounted version.

State-run Israel Aerospace Industries (IAI), which had earlier supplied advanced surveillance capabilities, including electro-optic systems, is also ready to provide reconnaissance aircraft and coastal radar equipment.

The Philippines is also evaluating offers for 40 multirole fighter aircraft. Sweden's Saab, which builds Gripen jets, is widely considered a contender. The company has vowed to deliver effective and costefficient air power to the Philippines.

Modernizing our forces will take time due to the resources needed. But we must explore all possibilities and engage with reliable defense enterprises and select the best systems for our specific needs. (manilastandard.net)

## Honoring the legacy of Filipino seniors

The Philippines welcomed October with the the establishment of the National Commission of celebration of the Elderly Filipino Week with the theme "Senior Citizens- Building the Nation, Inspiring Generations".

The weeklong tribute to senior citizens from Oct. 1 to 7, saw various promos and gimmicks for the Filipino elderly including free medical services and discounts from different stores. While all of these are much welcome benefits, I cannot help but think of the need to improve the social services and programs for senior citizens.

Thankfully, elderly Filipinos have a strong advocate for their cause in government through Senior Citizen Party-list Rep. Rodolfo "Ompong" Ordanes.

In a recent statement to mark Elderly Filipino Week, Ordanes said: "It is only fitting that we recognize, celebrate, and honor every senior citizen for being the pillars of our communities and society."

Ordanes, 71, stands out among the many lawmakers in our country as a committed advocate for the improved welfare of the Filipino elderly. As a senior citizen myself, I highly appreciate his legislative efforts to improve the array of benefits and services available to the elderly in the Philippines, especially for the indigent.

A longtime fighter for the welfare of senior

Senior Citizens —which provided the elderly with a formal platform dedicated to addressing their unique needs, concerns, and challenges. The body also helps ensure that the voices of senior citizens are heard in national discussions on various social

Ordanes also led the push for the increase in the monthly pension of poor senior citizens. From the PHP500 monthly stipend, Ordanes strongly advocated to double the amount to PHP1,000 per month. This benefits over 4 million senior citizens who are ineligible to receive stipends from either the Government Service Insurance System or the Social Security System.

More than the amount, the increase represents Ordanes' recognition of the economic plight of many indigent senior citizens —a sizable portion of our population who I believe can continue to contribute to national development and social progress if properly supported.

Pushing his advocacy further, Ordanes lobbied to expand the coverage of the pension to all Filipinos aged 60 and up. The measure has gained the approval of the House of Representatives and once implemented, is estimated to benefit over 10 million Filipino senior citizens.

The move is a testament to his belief in equal citizens, Ordanes is the one we should thank for support for all senior citizens, regardless of their

economic background.

More recently, Ordanes was instrumental in the passage of Republic Act No. 11982, which provides monetary incentives to octogenarians and nonagenarians and not just to senior citizens who reach the age of 100. Under this law, senior citizens are entitled to a PHP10,000 cash incentive upon reaching the ages of 80, 85, 90, and 95.

To further protect the Filipino elderly, Ordanes is pushing for the passage of the Senior Citizens Protection Against Fraud Act to address the growing concern on financial scams and exploitation that often target older Filipinos. The veteran legislator is also advocating to expand and increase the discounts provided to senior citizens and persons with disabilities for basic goods and services.

All these measures are worth lauding as these set the benchmark for legislative work that is focused on enhancing the lives of Filipino senior citizens.

What many don't realize is that the improvements that Ordanes advocates do not only benefit the current crop of senior citizens. Rather, these lay the foundation for better social programs and services for the Filipino elderly in the years to come.

### World Teachers' Day: Honoring the pillars of education

## The political plan

"Before beginning, plan carefully." - Cicero

So, you have finally made up your mind and filed your certificate of candidacy. What's next? If you're a political aspirant and asking this question, then you have a problem. At this point in your political adventure, you should already have a political campaign plan.

This week, I had the opportunity to assist many aspirants file their certificates of candidacies in various Commission on Elections (Comelec) offices. While waiting in line, I got the chance to talk to many of the political aspirants and I was surprised that many of the aspirants I spoke to had only vague ideas of what their next steps would be in the coming months.

In any endeavor, a detailed plan is essential. Benjamin Franklin once said that "by failing to prepare you are preparing to fail".

What's in a political campaign plan? First, you need a detailed political landscape analysis. Voter demographics and concerns, topography, voting history, opponent analysis and a baseline survey are key pieces of information needed to properly start your

plan. More often than not, aspirants rely on "feelings" and top of mind analysis and ignore data.

Second, you need your field plan to guide your political operations group on the ground. A field guide contains the target number of command votes which your operations group will aspire to organize and indoctrinate. The field guide will also contain your target voters or the voters you wish to engage. It could be based on location or sector depending on which your survey analysis would indicate as your weak point. Lastly, your field guide must contain the manner in which you will engage the said voters. Voters can be engaged in many ways such as through curated small, medium or large meetings with specific goals.

Third, you need your communication plan. Your communication plan includes the basic marketing tools needed to reach your market voters. This would include you branding, message and narratives. Your communication plan must also include the media platforms which you will need to utilize to convey your messages such as tv, print or social media.

#### **ORDINANCE NO. 2024-455-A**

## AN ORDINANCE ON SOURCE WATER PROTECTION OF THE MUNICIPALITY OF MINA

BE IT ORDAINED by the Sangguniang Bayan of Mina, Province of Iloilo, in session assembled that:

Section 1. Short Title. This Ordinance shall be known as the "Source Water Protection Ordinance of the Municipality of Mina".

**Section 2.** *Purpose.* This Ordinance identifies and establishes the source water of Mina Potable Water System. It set regulations to ensure the sustainability of adequate quality and quantity of drinking water supply for the municipal potable water system.

Section 3. *Identification of Drinking Water Source Protection Area (DWSPA)*. - The portion of the Suague River from the intake pipe of municipal water treatment plant in Brgy. Mina East, extending 500 meters upstream, 100 meters downstream, and 30 meters landward from the edge of the riverbed, including all tributaries within that distance is hereby identified and delineated as the source water protection area of Mina Potable Water System.

Section 4. Establishment of Intake Protection Zones. (IPZ) - The following protection zones are hereby established within the water source protection area:

- 4.1. **Intake Protection Zone 1 (IPZ-1)** is the area closest to the intake pipe which extends 200 meters upstream, 100 meters downstream, and 30 meters into land from the edge of the river;
- 4.2. Intake Protection Zone 2 (IPZ-2) is the remaining area within the DWSPA;

Section 5. *Illegal Discharge of Waste and Pollutant*. Within the established DWSPA, no person shall discharge any domestic sewage, industrial waste, or pollutant not meeting the effluent standards set by the Department of Environmental and Natural Resources (DENR).

Section 6. Prohibited Use and Activities. The following activities and uses are prohibited:

- 6.1. Intake Protection Zone 1
  - i. Unless pertains to operational activity of the water system or otherwise permitted, authorized, or in cases of emergencies, no person is allowed within the area;
- 6.2. Intake Protection Zone 1 & 2
  - i. Littering, throwing, dumping of any waste matters, or causing or permitting the same;
  - ii. Dumping of animal carcass/es;
  - iii. Washing, cleaning, or any related activity that will cause or discharge harmful chemicals from cleaning agents. This includes agricultural, petroleum, fertilizer, and other similar products or chemicals that will contaminate and pollute the source of drinking water,
  - iv. Construction or operation of landfills or any waste disposal facility;
  - v. Underground storage tanks or containers for bulk petroleum or chemicals;

**Section 7.** *Penal Clause.* Any person who violates the provision of this Ordinance shall be punished with a fine of not less than Three Hundred Pesos (P300.00) but not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not less than one (1) day to not more than Fifteen (15) days, upon the discretion of the Court.

**Section 8.** Compromise Agreement. Upon approval by the Office of the Mayor, a compromise agreement may be allowed by payment of a fine to the Municipal Treasurer's Office or render community service to the municipality for not less than one (1) day to not more than fifteen (15) days.

**Section 9.** Separability Clause. - If for reason or reasons, the provision or provisions of this Ordinance shall be held invalid or unconstitutional, other parts thereof which are not affected shall continue to be in full force and effect.

Section 10. Effectivity. - This Ordinance shall take effect upon approval and publication required by law.



## Transport coop launches China-made e-jeeps in Bacolod City



BACOLOD CITY -The Cebu People's Multi-Purpose Cooperative (CPMPC), owner-operator of the modernized People's Jeep, launched the initial five units of China-made electric (e)-jeeps that will operate in this city as part of the implementation of the Public Transport Modernization Program.

The e-jeepneys, which will ply the Fortune Towne-Central Market loop, are supplied by Chinese-Korean electric vehicle company e-Future Motors Philippines (PH).

Robert Cerrada, chief operating officer of e-Future Motors PH, said Wednesday that the delivery of the e-jeeps is the result of the memorandum of agreement

signed by the company with the CPMPC last year.

"This is the first in Bacolod, the culmination of our almost a year of planning and coordination with the local government unit. Our operators can really save on cost by using e-jeep. At the same time, it is environment-friendly," Cerrada told the Philippine News Agency.

Bacolod-based e-Future Motors PH is a subsidiary of Jiangsu Fengchuen New Energy Power Technology Co. Ltd. Fengchuen, with its head office in Wuxi, Jiangsu province, and a factory in Jiangyin City, China.

Each unit, which costs about PHP2.4 million, is being supplied to the

CPMPC on a rent-toown arrangement directly financed by e-Future Motors

"For now, we provided them with slow chargers. Charging stations are also available at the Bacolod City Government Center and Ayala Malls Capitol Central," Cerrada said.

In a video message after the launch on Tuesday, Renalin Martem, managing partner of CPMPC Bacolod Satellite Office, said they have signed up for 10 units, and the remaining five are still coming from China.

"After this, it will take one to two weeks before the units can start operation since we still have to process the documents and permits with the Land Transportation Franchising and Regulatory Board (LTFRB)," she said.

Martem said that aside from being environmentfriendly, e-jeeps also require lower operating costs.

"Based on our experiment, we can have big savings on fuel for operations. It's really lower. We can save as much as 54 percent compared to using (diesel). This is the first in Bacolod and also in Negros Occidental," she added.

Macario Quevedo, CPMPC director for transport operation, said the 10 units are part of the 60 franchises awarded to them by the LTFRB to operate modern jeeps in Bacolod. (PNA)

The petition alleges that: the <u>respondent</u>, <u>Philippine Statistics</u> <u>Authority is a government office und in its official capacity with postal address at PSA Complex East Avenue</u>, <u>Diliman</u>, <u>Quezon</u> City, 1101; respondent, Local Civil Registrar of Carles, Iloilo is a government office sued in its official capacity with postal address at the Municipal Building, Barangay Poblacion, Carles, Iloilo; the fact of birth of the petitioner was first recorded with the Local Civil Registry of Carles, Iloilo under Registry No. 50 (a-77); under Registry No.50 (a-77) her first name was erroneously indicated as "Lala" and her year of birth was "1976"; in the year 1989 when petitioner graduated from elementary, her fact of birth was belatedly registered by her mother Nida G. Bagoy with the Local Civil Registrar of Carles, Iloilo under Registry No. 89-48, thinking that her daughter's birth was not yet registered; in the year 2023, when petitioner requested a copy of her Certificate of Live Birth with Registry No. 89-48 with the Philippine Statistics Authority, she could no longer get a copy of the same, instead she was issued a Certificate of Live Birth with Registry no. 50 (a-77): it appearing that a prior registration of the fact of birth of petitioner was made in the year 1977, however petitioner's mother could not recall having caused the registration of the same, and considering further that an incorrect date of birth and first name was also indicated in that first registration; petitioner's true and correct name is Yala Gregorio Bagoy and the correct year of birth is 1975 as reflected in her PSA Certificate of Live Birth under Registry No. 89-48 as well as in her other competent evidence of identity as follows, A PSA copy of Petitioner's Marriage Contract, petitioner's Certificate of Baptism issued by Sta. Teresa de Avila Parish, Carles, Iloilo, Certificate issued by Carles Central School that petitioner's records were destroyed by typhoon Yolanda, Secondary Student's Permanent Record of Yala G. Bagoy issued by Don Casimero Andrada National High School, Voter's Certification of Yala Bagoy Marcelino issued by COMELEC, Barangay I.D. of Yala Bagoy Marcelino, Certificate of Indigency issued by the Punong Barangay of Barangay Guinticgan, Carles Iloilo, Barangay Clearance issued by the Punong Barangay of Barangay Guinticgan, Carles Iloilo, National Police Clearance; there is therefore a need to rectify the Certificate of Live Birth of Lala Gregorio Bagov under Registry No. 50 (a-77) to reflect her correct year of birth as 1975, and her correct first name as YALA, in order to avoid confusion as to her identity and consequently, it will conform and reflect the true and correct entry in her public records considering petitioner has been consistently using the name Yala Gregorio Bagoy since childhood and 1975 as her year of birth; no third person will be prejudiced by the correction of the Certificate of Live Birth subject of this case, and this petition is not intended to conceal a crime or any wrong-doing; petitioner is an indigent and would like to avail of the benefits provided under Republic Act No. 9406, and petitioner likewise requests to be exempted from payment of filing fee; petitioner and her witnesses shall testify and their testimonies are supported by several documentary evidence as follows, PSA copy of Petitioner's Certificate of Live Birth with Registry No. 50 (a-77), petitioner's Certificate of Live Birth with Registry No. 89-48 issued by the Local Civil Registrar of Carles, Iloilo, PSA copy of Petitioner's Certificate of Live Birth with Registry No. 50 (a-77), PSA copy of petitioner's marriage contract, Petitioner's Certificate of Baptism issued by Sta. Teresa de Avila Parish, Carles, Iloilo, Certificate issued by Carles Central School that petitioner's records were destroyed by typhoon Yolanda, Secondary Student's Permanent Record of Yala G. The Clerk of Court is directed to furnish copies of this Order to the Philippine Statistics Authority, Office of the Solicitor General, Civil Registrar General, Local Civil Registrar of Carles, Iloilo, the petitioner, private respondents, and counsel/s.

Petitioner is ordered to furnish copies of the petition to the Philippine Statistics Authority, Office of the Solicitor General, Civil Registrar General, Local Civil Registrar of Carles, Iloilo, private respondents, and to submit compliance thereto within ten (10) days from receipt of this Order.

## **BIR-7** boasts revenue collection windfall in 2023

CEBUCITY-The Bureau of Internal Revenue in Central Visayas (BIR-7) recorded a 10.21 percent increase in revenue collections in 2023.

At the Bagong Pilipinas forum on Tuesday, BIR-7 Director Douglas Rufino said the bureau recorded a PHP3.9-billion jump in last year's collection compared to 2022.

Year-on-year, the tax agency's regional office collected PHP42.5 billion in revenues last year against PHP38.6 billion in 2022.

Last year's collection was also 1.47 percent higher than the PHP41.9 billion targeted collection.

"With this, our region was recognized as the Top 2 region all over the country in achieving the highest excess collection over the goal," Rufino said.

He attributed the windfall to the continuous effort in

conducting multiple tax operations and constant communication with taxpayers.

Among the big operations of the BIR-7 was the issuance of a mission order against cigarette packing machines, raw materials and finished products declared as illicit

"This came from an intelligence report from the police community that there is such an ongoing manufacturing of illicit cigarettes in Daanbantayan (in Cebu)," Rufino said.

When the tax agents implemented the mission order, the packing machines and the raw materials were gone but they received information these were moved somewhere to Mandaue City.

The BIR-7 seized the cigarette-packing machines and raw materials.

## PH pharma players urged to shift to 2D barcodes to combat fake meds

MANILA - Local pharmaceutical industry players were urged to adopt 2D barcodes, which include Quick Response (QR) codes, as a measure to fight the spread of counterfeit medicines and medical supplies in the domestic market.

This measure is important as the country remains on the radar of the United States Trade Representative (USTR) for fraudulent medical products, said GS1 Philippines, the leading organization for implementing local barcode standards.

In a statement Wednesday, GS1 Philippines said it is implementing the Global Trade Item Numbers (GTINs) in the country which can capture crucial data, such as the date of manufacture, expiration date, and the manufacturer's

name that enhances product identification and verification.

These complex data can be stored by utilizing 2D barcodes, which use verical and horizontal patterns like QRs.

The current 1D barcode technology can only identify product codes.

Consumers can access data and verify the product by scanning the QR code, which cannot be done on 1D barcodes.

"The threat of counterfeit medicines compromises both consumer safety and trust in healthcare providers. By leveraging barcode technology, we can establish a cohesive integration of global standards that prioritizes patient safety, particularly in regions facing serious challenges with counterfeit products," GS1 Philippines president

Roberto Claudio said.

Pharmaceutical and Healthcare Association of the Philippines (PHAP) and GS1 Philippines officer and trustee Teodoro Padilla has affirmed the local pharmaceutical industry's support in adopting 2D barcode technology among domestic players.

"PHAP supports this innovation, acknowledging its potential to verify products and prevent

counterfeit medicines from reaching patients. To further strengthen our fight against fake drugs, PHAP urges collaboration among pharmaceutical companies, regulatory bodies, healthcare providers, and the general public to expedite the adoption of this technology, strictly enforce regulations, and increase awareness to ensure the safety and wellbeing of Filipino patients," Padilla said.

"When there is something that comes to my attention, it could be anything. It's an interaction between my internal world and the external world. It is not a particular nor is it a particular mental state. It is always a combination of stimulus and response. It has

His practical advice to aspiring young musicians: "If you have the luxury of working with a good teacher, I advise getting a good one."
