

Php1.1 Million worth of counterfeit cigarettes seized

BOXES of counterfeit cigarettes were confiscated during the operation conducted by Criminal Investigation Unit (CIU) of the Iloilo City Police Office (ICPO) at Sitio Kawayanan, Brgy. Tabuc Suba, La Paz, Iloilo City on October 12.

The operating unit has arrested Rogelio Gumaro Boniba, 57, and a resident of the said barangay, due to violation of the Section 170 of Republic Act No. 8293 or the Intellectual Property Code of the Philippines.

DepEd-6 supports 7k students through farm schools

THE Department of Education (DepEd) in Western Visayas, under the leadership of Regional Director Ramir Uytico, has made significant strides in supporting students through the establishment of farm schools in the region.

These schools were initiated under Republic Act 10618, which mandates the creation of at least one farm school in every town across the country.

As of 2024, DepEd-6 oversees 31 farm schools, catering to a total of 7,869 learners, with a budget allocation of 106 million

This initiative aims to offer secondary students alternative career options, particularly in agriculture

and aligns with the K-12 basic education curriculum in both public and private

The program focuses on equipping students with knowledge about food production and instilling the value of agricultural education, which can be

applied in home or urban gardening.

Additionally, DepEd-6 plans to provide students with the necessary materials and technical skill certificates to help them become productive leaders and capable individuals in the agricultural sector.

Bacolod City Mayor Albee Benitez recently took his Tesla Model X for a spin around the city, as a GrabCar driver-partner, surprising unsuspecting passengers with a unique ride-hailing experience.

In a vlog posted on his official Facebook page, Mayor Benitez personally chauffeured three passengers, engaging them in conversations about their daily commute and the growing adoption of digital ride-hailing services in the city.

Mayor Albee Benitez shares, "As a public servant, I wanted to personally experience how ride-hailing drivers serve the riding public through digital platforms. > As a frequent Grab passenger, Joy told the mayor that aside from the convenience of hailing a ride from a mobile phone, she particularly likes the transparency around the fare as it is shown and calculated upfront upon ride booking.

> The second booking was a two-stop ride for two passengers who both worked for a call center on Burgos Avenue. Like Joy's, the look on their faces as the Mayor flung open the Tesla's door upwards, was of a complete surprise. "Servoso? Si Mayor? Kala ko talaga prank. Pero ang Grab, di naman siguro maglahuglahug," passengers Theresse and Barbara recalled.

Also frequent Grab passengers, the women said they feel safer taking Grab than other modes of transportation. Safety is a high priority, especially for women who work at night in call centers.

The conversation inside the vehicle as Mayor Albee was driving them to their destinations also gave the mayor a peek into the Business Process Outsourcing (BPO) industry from the perspective of Bacolod City residents who work in outsourcing.

A Salute for Digital Ride-**Hailing Drivers**

Going online as a GrabCar driver-partner during a rainy Monday evening at the onset of Typhoon Gener, Mayor Albee lauded driverpartners for their dedication

and commitment to their profession. The mayor noted how their service makes everyday commutes for his citizens safer and more convenient, especially during inclement weather. "Ganito pala feeling maging Grab driver," the mayor said in his vlog, calling the experience "fulfilling but also not easy...especially during bad weather."

After spending an hourand-a-half in the driver's seat, the mayor made approximately 300 pesos for the two bookings. "Not bad for a short amount of time," he said, noting that being a ride-hailing driver is a viable livelihood opportunity for Bacolodnons.

Bacolod City was the first city outside of Metro Manila to welcome GrabCar. From only 44 drivers when GrabCar first arrived in February 2016, there are now more than 500 active driver-partners plying the roads of the city. GrabCar now offers services beyond Bacolod City, extending from Manapla to Bago, with plans to further expand to Escalante in the north and Kabankalan in the south. ###

movement of goods and services in Western Visayas slowed down to 3.4 percent in September from 4.9 percent in August, the Philippine Statistics Authority (PSA) reported on Wednesday.

The headline inflation, year-on-year, was also lower at 6.6 percent.

At a press conference, PSA VI chief statistical specialist Marlene Alviar said the main sources of the deceleration are the slower growth in the food and non-alcoholic beverages commodity group with an inflation rate of 3.3 percent from the previous 6.2 percent in August, and transport, which slowed down to -2.1 percent from 0.7 percent.

Food and non-alcoholic beverages contributed a 79.4 percent share to the downtrend inflation, while transportation had a 15.7 percent share.

"Of the 13 major commodity groups, seven have recorded lower inflation rate in September," budget their money wisely, she said.

These included food and non-alcoholic beverages at 3.3 percent from 6.2 percent; alcoholic beverages and tobacco, 3.3 percent from 3.7 percent; transport, -2.1 percent from 0.7 percent; recreation, sport and culture, 3.8 percent from 4.2 percent; education services, 8.1 percent from 10.3 percent; restaurants and

ILOILO CITY - The accommodation services, 6.1 percent from 6.2 percent; and personal care, and miscellaneous good and services with 2.8 percent from 3.2 percent.

Meanwhile, higher inflation was noted in clothing and footwear at 3.8 percent from 3.6 percent; furnishing, household equipment, and routine household maintenance at 2.5 percent from 2.4 percent; and health at 3.1 percent from 3 percent.

Three other commodity groups recorded constant inflation, including housing, water, electricity, and other fuels; information and communication; and financial services at 5.6 percent, 0.9 percent; and -1.0 percent, respectively.

In the same briefing, PSA VI officer in charge Regional Director Nelida Amolar said that while the inflation rate has slowed down, Western Visayas is still the highest in the country, although by a smaller percentage.

She urged consumers to prioritize what they need most, and avoid unhealthy food, especially since their report showed a big percentage of expenses are on food.

The PSA report also showed that among the provinces and highly urbanized cities in the region, Aklan recorded the lowest inflation at 2.3 percent. (PNA)

W. Visayas farm schools develop new breed of farmers

years after the Department of Education (DepEd) put up farm schools in Western Visayas, almost 8,000 junior high schools have already developed an interest in farming.

This new breed of farmers is now enrolled in 31 farm schools in various school divisions in the region, DepEd Western Visayas regional director Ramir Uytico said on Wednesday.

These farm schools would help the region sustain food sufficiency in the long run.

"If we want to arrest, if we want to eradicate poverty and hunger, then support our farm schools," Uytico said in an interview.

Dr. Elena Gonzaga, DepEd chief of the curriculum and learning management division, said they contextualized the subjects, focusing on fishery, agriculture, and entrepreneurship.

Other regions have visited Western Visayas for learning and benchmarking activities.

The establishment of farm schools received over PHP106 million in support funds during its infancy.

This year, Uytico will try lobbying again, confident of support from their central office because of the noble purpose of the program.

He added they are also looking at establishing a community talipapa so the learners can sell their produce.

"We are planning to establish a Jayobo Farm School community talipapa where the produce will be sold and income will be used for the operation, and part will also go to learners as their gain," he said.

Uytico also encouraged hotels and restaurants to buy their materials from farm schools.

He said the farm schools will grow, and the people of Western Visayas can benefit from the program. (PNA)



One hundred forty-three Filipinos convicted of various crimes in the United Arab Emirates were pardoned by United Arab Emirates President Sheikh Mohamed bin Zayed. President Ferdinand Marcos Jr., through a phone call, thanked his counterpart for the gesture, saying that the act was generous and that it brought relief to many families.

Some 13.6 percent of the 2.16 million overseas Filipino workers listed in 2023 worked in the UAE, according to the Philippine Statistics Authority. Meanwhile, 4.2 percent of the \$21.5 billion in OFW remittances registered in the first seven months of 2024 came from workers in the UAE, according to the Bangko Sentral.

The pardons come on the heels of the October 5 execution of a Filipino in the Kingdom of Saudi Arabia. No other details were provided on the execution except that the case arose from a financial dispute in 2022. The Filipino was supposedly involved in some business ventures in the KSA. The Philippine government exerted earnest efforts to save the life of the OFW, even offering compensation, but the execution proceeded, nonetheless.

We are also seeing the ongoing repatriation for workers caught in the ongoing conflict in the Middle East.

For decades now, OFWs have made up a significant portion of the population, with the resources they send serving as drivers of consumption and economic activity. For decades, too, the sacrifices that they make in leaving behind their loved ones and the familiarity of home have been extolled. Unfortunately, migrant workers have been painted as either victims of crimes in their places of destination – that is, if they themselves are not the perpetrators of these crimes, driven by a confluence of factors.

Worse, some of them are falsely accused

of crimes, in which case they become victims all over again, of justice systems that provide greater voice to others than to some, and which sometimes assigns rights depending on gender, or economic class.

The tragedy of overseas workers finding a life abroad that is so far from what they had envisioned is a frequent story, and each retelling does not diminish how compelling each situation is. That we have established a separate government agency for migrant workers is a testament to the reality of the need to go abroad to earn a living.

There has also been great effort to arm departing workers with information regarding their own rights and the culture of the country in which they will work. Still, let us not lose sight of the ideal that leaving the Philippines to work elsewhere should be a deliberate choice, and no Filipino should feel compelled to take the risks at all costs. Reprieve for senior citizens

have been put in place to improve state support for the Filipino elderly. While huge strides have been made, the fact remains that much more citizens.

According to the National Commission of Senior Citizens, the Filipino elderly are estimated to comprise about 8.5 percent of the country's household population by the year 2030 -- a sizable portion that, if properly supported, can continue to contribute to nation-building.

While retirement in the Philippines is commonly set at 60, many Filipinos continue to work even as senior citizens. I, for one, remain an active member of the workforce even after I turned 60 at the start of the year.

Across different sectors and industries, the elderly often fill up senior management and leadership positions —a testament to their wisdom in the workplace. Sadly, despite the decades of industry contributions of senior citizens, they end up disadvantaged when it comes to government support at a time when they need it the most.

Indigent elderly Filipinos for example are only entitled to a PHP1,000 monthly pension on top of discounts mandated by law for their purchase of basic goods and services.

It is the collective responsibility of all Filipinos to ensure that our elderly —who toiled for decades to build our nation— are well-supported in their twilight years.

As our country works towards continuously improving the quality of life of Filipinos, let us ensure that the welfare of senior citizens is considered. They have laid the foundations of today's economic gains; now, it is time and only proper to give back.

In my next column, I will discuss how crucial healthcare support is for seniors which unfortunately is much wanted to this day.

Strengthening trade, diplomacy, people-to-people ties

Nanning, the capital of the Guangxi Zhuang Autonomous Region in southern China, is known as the "Green City" for its lush tropical greenery. It serves as a vital cultural, transportation, and economic hub and is a gateway for trade with Southeast Asia due to its proximity to Vietnam.

In this context, the 21st China-ASEAN Expo (CAEXPO) took place in Nanning from Sept. 24 to 28, 2024, emphasizing the strengthening of economic and cultural connections between China and ASEAN (Association of Southeast Asian Nations). Given its status as the world's second-largest GDP (gross domestic product) economy and the largest in purchasing power parity (PPP), China's growing influence in Southeast Asia is undeniable.

The theme of the CAEXPO 2024 was "Upholding Amity, Sincerity, Mutual Benefit, and Inclusiveness for Common Development— Creating a Diamond Crown New Future: Promoting Development of a China-ASEAN Free Trade Area 3.0 and High-Quality Growth of This Region." The theme reflects a focus on strengthening strategic partnerships between China and ASEAN, aiming to foster economic growth and deeper regional cooperation through mutual respect and inclusivity.

CAEXPO 2024 showcased key areas of cooperation, investment, and development, which will shape future relations in the region. The expo provided a significant opportunity for the Philippines to strengthen bilateral ties, secure trade agreements, and contribute to regional peacebuilding efforts.

The Philippines played an active role at CAEXPO 2024, with a large delegation comprising government officials, business leaders, and entrepreneurs. The Philippine delegation includes 15 exhibitors specializing in the areas of food and beverage, lifestyle, and services.

I had the honor of representing the Association for Philippine China Understanding, Inc. (APCU) in the delegation. The venue, the Nanning

International Convention and Exhibition Center, was an architectural marvel. The exhibition area alone covers 90,000 square meters and hosted 3,300 exhibitors, including 2,004 in the main exhibition area.

The Philippine pavilion prominently featured products and services from sectors like agriculture, processed foods, textiles, and ecotourism. Among the most notable developments were several investment agreements and memorandums of understanding (MOUs) with Chinese firms, covering infrastructure, renewable energy, manufacturing, and agribusiness.

A standout agreement was a USD300 million commitment from a leading Chinese infrastructure company to invest in the Philippine transportation network, including port expansions and rail projects. We expect this investment to enhance connectivity, boost trade, and expand tourism opportunities. Additionally, a USD50 million deal for the export of mangoes and bananas to China was signed, benefiting local farmers and supporting economic growth in rural areas.

One of the key highlights of CAEXPO 2024 was the China-ASEAN People-to-People Exchange Pavilion, designed to foster cultural and educational exchanges between China and ASEAN countries. This pavilion showcased the rich diversity of ASEAN cultures, traditions, and values while promoting cross-cultural understanding.

For the Philippines, it was a chance to present its vibrant cultural heritage through traditional performances such as the 'Tinikling' and Kalinga dances. Philippine universities also participated in the exchange program, promoting partnerships with Chinese educational institutions. These exchanges not only celebrate cultural diversity but also enhance soft diplomacy by facilitating interactions among students, artists, and professionals from both regions.

In addition to cultural showcases, the pavilion

hosted workshops and forums that focused on strengthening cooperation in education, tourism, and media. Such discussions play a crucial role in fostering people-to-people ties, which are essential for long-term regional stability.

Beyond economic benefits, CAEXPO 2024 emphasized its role in maintaining peace and stability in the region. With ongoing tensions over territorial disputes in the West Philippine Sea (WPS), the expo provided an important platform for dialogue and diplomacy. By promoting economic interdependence and people-to-people connectivity, CAEXPO fosters an environment where disputes can be resolved through negotiation rather than conflict.

I have long advocated for people-to-people dialogue as a means of addressing WPSrelated issues. Civil society, including business organizations, plays a key role in fostering solutions and helping de-escalate tensions. Platforms like CAEXPO highlight that peaceful cooperation can lead to shared prosperity. The economic partnerships secured during the expo are critical in defusing tensions, as countries with intertwined economies are more inclined to seek peaceful resolutions.

The establishment of the China-ASEAN Peopleto-People Exchange Pavilion complements these peacebuilding efforts by promoting mutual understanding and trust. Cultural and educational exchanges build bridges of friendship, which can act as buffers against geopolitical friction. The People-to-People Exchange Pavilion enhances soft diplomacy, fostering mutual understanding and supporting peace and stability through deepened economic cooperation. I hope CAEXPO will continue to institutionalize these exchanges to provide a lasting venue for dialogue and understanding, leading to peaceful solutions for regional challenges.

Political disinformation in local politics

As the political season heats up, especially in local contests, the proliferation of online disinformation campaigns seems to be increasing at an alarming level again. Political disinformation is false information deliberately spread to deceive people and harm opposing candidates.

It is unfortunate that today's technology has allowed disinformation to spread rapidly. Also, a new breed of political disinformation consultants (PDCS) has emerged and become much-coveted members of local candidates' campaign teams. These PDCS are different from the normal social media consultants who focus on open online campaigns. These PDCS concentrate on utilizing information tools to conduct what is called "black hat" operations where they focus on besmirching the reputation of opposing candidates.

political disinformation methods. For example, if a candidate has been accused in court or a legislative hearing of a particular crime, PDCS would create a false news item, which would state that the said candidate has already been convicted.

Photo and video manipulation are common tools for these "black hat" operations. They can get a photo of a convicted person in an orange jail uniform and swap the face with the target candidate's face. In the United States, they had a faked video of a presidential candidate allegedly in handcuffs. Some image manipulations are done so expertly that it is hard to tell that they are fake.

Local PDCS operators also use local trolls to flood comment sections with baseless accusations and share fake links. There are even groups today that allegedly offer Exaggeration is one of the more common systems that could allow one person to

create a multitude of undetectable fake avatars that could be used to create false accounts. These fake accounts, managed by a few individuals, can take on a multitude of trolls in a more efficient manner.

Standard disinformation countermeasures like reporting and factcheckers are fast becoming obsolete as the onslaught of new technology and cunning PDCS flood the market. Political strategists and campaign managers cannot hope to keep up with this troubling trend without the help of experts on countermeasures. As we have been saying lately, amateurs can no longer hope to survive in today's local political battlegrounds.

This is my oblique observation.

ORDINANCE NO. 2024-455-A

AN ORDINANCE ON SOURCE WATER PROTECTION OF THE MUNICIPALITY OF MINA

BE IT ORDAINED by the Sangguniang Bayan of Mina, Province of Iloilo, in session assembled that:

Section 1. Short Title. This Ordinance shall be known as the "Source Water Protection Ordinance of the Municipality of Mina".

Section 2. *Purpose*. This Ordinance identifies and establishes the source water of Mina Potable Water System. It set regulations to ensure the sustainability of adequate quality and quantity of drinking water supply for the municipal potable water system.

Section 3. *Identification of Drinking Water Source Protection Area (DWSPA)*. - The portion of the Suague River from the intake pipe of municipal water treatment plant in Brgy. Mina East, extending 500 meters upstream, 100 meters downstream, and 30 meters landward from the edge of the riverbed, including all tributaries within that distance is hereby identified and delineated as the source water protection area of Mina Potable Water System.

Section 4. Establishment of Intake Protection Zones. (IPZ) - The following protection zones are hereby established within the water source protection area:

- 4.1. **Intake Protection Zone 1 (IPZ-1)** is the area closest to the intake pipe which extends 200 meters upstream, 100 meters downstream, and 30 meters into land from the edge of the river;
- 4.2. Intake Protection Zone 2 (IPZ-2) is the remaining area within the DWSPA;

Section 5. *Illegal Discharge of Waste and Pollutant*. Within the established DWSPA, no person shall discharge any domestic sewage, industrial waste, or pollutant not meeting the effluent standards set by the Department of Environmental and Natural Resources (DENR).

Section 6. Prohibited Use and Activities. The following activities and uses are prohibited:

- 6.1. Intake Protection Zone 1
 - i. Unless pertains to operational activity of the water system or otherwise permitted, authorized, or in cases of emergencies, no person is allowed within the area;
- 6.2. Intake Protection Zone 1 & 2
 - i. Littering, throwing, dumping of any waste matters, or causing or permitting the same;
 - ii. Dumping of animal carcass/es;
 - iii. Washing, cleaning, or any related activity that will cause or discharge harmful chemicals from cleaning agents. This includes agricultural, petroleum, fertilizer, and other similar products or chemicals that will contaminate and pollute the source of drinking water,
 - iv. Construction or operation of landfills or any waste disposal facility;
 - v. Underground storage tanks or containers for bulk petroleum or chemicals;

Section 7. *Penal Clause.* Any person who violates the provision of this Ordinance shall be punished with a fine of not less than Three Hundred Pesos (P300.00) but not more than Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not less than one (1) day to not more than Fifteen (15) days, upon the discretion of the Court.

Section 8. Compromise Agreement. Upon approval by the Office of the Mayor, a compromise agreement may be allowed by payment of a fine to the Municipal Treasurer's Office or render community service to the municipality for not less than one (1) day to not more than fifteen (15) days.

Section 9. Separability Clause. - If for reason or reasons, the provision or provisions of this Ordinance shall be held invalid or unconstitutional, other parts thereof which are not affected shall continue to be in full force and effect.

Section 10. Effectivity. - This Ordinance shall take effect upon approval and publication required by law.

AN ORDINANCE IMPOSING BUILDING PERMIT EXEMPTION FEE – P100.00 AND OCCUPANCY PERMIT EXEMPTION FEE – P100.00 FOR THE STRUCTURES MADE OF TRADITIONAL INDIGENOUS MATERIALS AS AMONG THE REQUIREMENTS IN THE ISSUANCE OF BUSINESS PERMIT

NOW, THEREFORE:

BE IT ORDAINED by the Sangguniang Bayan of Mina, Iloilo in session assembled that:

Section 1. Title. This Ordinance shall be called,"An Ordinance Imposing Building Permit Exemption Fee – P100.00 and Occupancy Permit Exemption Fee – P100.00 for the Structures made of Traditional Indigenous Materials as among the requirements in the issuance of business permit".

Section 2. Imposition of Fees. The following fees shall be collected from the applicants securing business permits:

- 1. Certificate of Building Permit Exemption Fee -P100.00
 - a) Traditional indigenous structures with material cost of not more than P15,000.00.
 - b) Other structures with an area of not more than 10sq. m. and/or material cost of not more than P50,000.00.
- 2. Certificate of Occupancy Permit Exemption Fee P100.00

Section 4. Repealing Clause. In the event that a part of this Ordinance is inconsistent with the previous related Ordinance, the remaining parts not affected shall remain in full force and effect.

Section VII- SEPARABILITY CLAUSE – If for any reason, any part, section or provision of this Ordinance shall be held invalid or unconstitutional, other provisions or parts thereof not affected thereby shall remain in full force and effect;

Section IX – REPEALING CLAUSE – All other ordinances, rules or parts thereof which are Inconsistent with these ordinance are hereby repealed or modified accordingly;

P92-M road projects to improve access, boost tourism in Iloilo

ILOILO CITY – Three road projects implemented by the Department of Public Works and Highways (DPWH) are eyed to improve access in remote areas and enhance connectivity to key tourism areas in Iloilo.

The first two projects are implemented by the Iloilo 1st District Engineering Office from Barangay Potrido to Barangay Alimodias in the town of Miagao, according to the DPWH on Wednesday.

The first project, worth PHP14.7 million, covers the construction of the 280meter concrete Malagyan-Tigmalapad Road, leading to Sinuhotan Cave and Tinagong Dagat Lake.

Another is the PHP71.6 million access road that will provide access to Bugsukan and Banogon Falls and the 500-hectare rice terraces. It has two sections, including 840 lineal meters for section 1 and 1,445 lineal meters for section 2.

"The construction of these access roads is crucial for promoting sustainable tourism in Miag-ao. By

AMENDED ORDER

A verified petition was filed by the petitioner through her counsel, praying that after due notice, publication and hearing, an order be issued ordering the correction of the Certificate of Live Birth of Yala Gregorio Bagoy under Registry No. 50 (a-77) in order for the petitioner to use her true and correct name Yala Gregorio Bagoy and correct the year of birth of 1975.

The petition alleges that: the <u>respondent, Philippine Statistics</u>
<u>Authority is a government office sued in its official capacity with</u> postal address at PSA Complex East Avenue, Diliman, Quezon City, 1101: respondent, Local Civil Registrar of Carles, Iloilo is a government office sued in its official capacity with postal address at the Municipal Building, Barangay Poblacion, Carles, Iloilo: the fact of birth of the petitioner was first recorded with the Local Civil Registry of Carles, Iloilo under Registry No. 50 (a-77); under Registry No.50 (a-77) her first name was erroneously indicated as "Lala" and her year of birth was "1976"; in the year 1989 when petitioner graduated from elementary, her fact of birth was belatedly registered by her mother Nida G. Bagoy with the Local Civil Registrar of Carles, Iloilo under Registry No. 89-48, thinking that her daughter's birth was not yet registered; in the year 2023, when petitioner requested a copy of her Certificate of Live Birth with Registry No. 89-48 with the Philippine Statistics Authority, she could no longer get a copy of the same, instead she was issued a Certificate of Live Birth with Registry no. 50 (a-77); it appearing that a prior registration of the fact of birth of petitioner was made in the year 1977, however petitioner's mother could not recall having caused the registration of the same, and considering further that an incorrect date of birth and first name was also indicated in that first registration; petitioner's true and correct name is Yala Gregorio Bagoy and the correct year of birth is 1975 as reflected in her PSA Certificate of Live Birth under Registry No. 89-48 as well as in her other competent evidence of identity as follows, A PSA copy of Petitioner's Marriage Contract, petitioner's Certificate of Baptism issued by Sta. Teresa de Avila Parish, Carles, Iloilo, Certificate issued by Carles Central School that petitioner's records were destroyed by typhoon Yolanda, Secondary Student's Permanent Record of Yala G. Bagoy issued by Don Casimero Andrada National High School, Voter's Certification of Yala Bagoy Marcelino issued by COMELEC, Barangay I.D. of Yala Bagoy Marcelino, Certificate of Indigency issued by the Punong Barangay of Barangay Guinticgan, Carles Iloilo, Barangay Clearance issued by the Punong Barangay of Barangay Guinticgan, Carles Iloilo, National Police Clearance: there is therefore a need to rectify the Certificate of Live Birth of Lala Gregorio Bagov under Registry No. 50 (a-77) to reflect her correct year of birth as 1975, and her correct first name as YALA, in order to avoid confusion as to her identity and consequently, it will conform and reflect the true and correct entry in her public records considering petitioner has been consistently using the name Yala Gregorio Bagoy since childhood and 1975 as her year of birth; no third person will be prejudiced by the correction of the Certificate of Live Birth subject of this case, and this petition is not intended to conceal a crime or any wrong-doing; petitioner is an indigent and would like to avail of the benefits provided under Republic Act No. 9406, and petitioner likewise requests to be exempted from payment of filing fee: petitioner and her witnesses shall testify and their testimonies are supported by several documentary evidence as follows, PSA copy of Petitioner's Certificate of Live Birth with Registry No. 50 (a-77), petitioner's Certificate of Live Birth with Registry No. 89-48 issued by the Local Civil Registrar of Carles, Iloilo, PSA copy of Petitioner's Certificate of Live Birth with Registry No. 50 (a-77), PSA copy of petitioner's marriage contract, Petitioner's Certificate of Baptism issued by Sta. Teresa de Avila Parish. Carles, Iloilo, Certificate issued by Carles Central School that petitioner's records were destroyed by typhoon Yolanda, Secondary Student's Permanent Record of Yala G. Bagoy issued by Don Casimero Andrada National High School, Voter's Certification of Yala Bagoy Marcelino issued by COMELEC, Barangay I.D. of Yala Bagoy Marcelino, Certificate of Indigency issued by the Punong Barangav of Barangay Guinticgan, Carles, Iloilo, Barangay Clearance issued by the Punong Barangay of Barangay Guinticgan, Carles, Iloilo, and National Police Clearance.

Pursuant to the provisions of Rule 108 of the Rules of Court, this petition is hereby set for hearing on <u>5 November 2024</u> at <u>8:30 o'clock in the morning</u> before the Regional Trial Court, Branch 70, Barotac Viejo, Iloilo, at which time, date and place, the respondents, or any person who may have interest in entries sought to be corrected may, before the date set for hearing, file their opposition thereto.

This Order shall be published once a week for three (3) consecutive weeks in **News Express**, a newspaper of general circulation in the province of lloilo accredited by this Court at the expense of the petitioner.

The Clerk of Court is directed to furnish copies of this Order to the Philippine Statistics Authority, Office of the Solicitor General, Civil Registrar General, Local Civil Registrar of Carles, Iloilo, the petitioner, private respondents, and counsel/s.

Petitioner is ordered to furnish copies of the petition to the Philippine Statistics Authority, Office of the Solicitor General, Civil Registrar General, Local Civil Registrar of Carles, Iloilo, private respondents, and to submit compliance thereto within ten (10) days from receipt of this Order.

MUNICIPAL ORDINANCE NO. 2024-18

AN ORDINANCE MANDATING ALL BUSINESS OPERATING WITHIN THE MUNICIPALITY ENGAGED IN THE MANUFACTURING, SELLING OR DISTRIBUTING PHILIPPINE NATIONAL POLICE (PNP) UNIFORMS, INSIGNIAS AND OTHER ACCOUTREMENTS TO SECURE PHILIPPINE NATIONAL POLICE (PNP) CERTIFICATE OF CONFORMITY (COC) AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF.

WHEREAS, Section 16 of the Local Government Code or Republic Act
7160, otherwise known as the General Welfare Clause provides, in part,
that every local government unit shall ensure and support the maintenance
of peace and order within their respective territorial jurisdiction;

WHEREAS, on 03 September 2020, the Philippine National Police
Directorate for Research and Development (PNP-DRD) has issued
DRD Standard Operating Procedure No. 2020-001 prescribing the

WHEREAS, Executive Order No. 297 entitled Regulating the Manufacture, Sale, Distribution and Use of Philippine National Police (PNP) Uniforms, Insignias, and Other Accourrements was signed on October 4, 2000 to control and manage the unauthorized manufacture, sale and distribution of Philippine National Police (PNP) uniforms, insignias and other accourrements;

WHEREAS, the unauthorized manufacture, sale, use and distribution of Philippine national Police (PNP) uniforms, insignias and other accoutrements impose serious concerns since such symbolic Philippine National Police (PNP) identifiers, instead of providing a comforting sense of security, could be used by lawless elements in the commission of crime within the municipality;

WHEREAS, LOI 2005 "TAMANG BIHIS" prescribes the guidelines to be observed by all PNP personnel of all units/offices in the implementation of the rules and enforcement of the laws against the illegal Manufacture,

Distribution, Sale and Use of PNP Uniforms, Insignias and Other Accoutrements, including the Materials for their Production;

WHEREAS, Executive Order No. 297 imposes as penalties the immediate closure of establishment, cancellation of business license or permit, condemnation, seizure and forfeiture of unauthorized items; and imposition of reasonable fines for violators of the said order, all of which could be undertaken by the local government units concerned;

WHEREAS, on 03 September 2020, the Philippine National Police Directorate for Research and Development (PNP-DRD) has issued DRD Standard Operating Procedure No. 2020-001 prescribing the procedures and guidelines in handling of samples of Philippine National Police (PNP) uniforms and accourrements to ensure the integrity of the submitted samples as basis for issuance of Certificate of Conformity (COC);

WHEREAS, to ensure that Philippine National Police (PNP) uniforms, insignias and accourtements are manufactured, sold, distributed or supplied only by authorized manufacturer, distributor, supplier and/or seller and used exclusively by uniformed personnel of the Philippine National Police (PNP) and to mitigate or even eradicate the proliferation of the unauthorized Philippine national Police (PNP) uniforms and commission of other illegal activities, there is a need to enact a corresponding Municipal Ordinance;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN DIONISIO, ILOILO IN SESSION ASSEMBLED THAT:

SECTION 1. TITLE – This ordinance shall be known as "An Ordinance Mandating All Business Operating within the Municipality Engaged in the Manufacturing, Selling or Distributing Philippine National Police (PNP)Uniforms, Insignias and Other Accourtements to Secure Philippine National Police (PNP) Certificate of Conformity (COC) and Prescribing Penalties for Violations Thereof."

SECTION 2. SCOPE AND APPLICATION – All businesses operating within the territorial jurisdiction of the Municipality of San Dionisio, whether in physical, online or in digital platforms, engaged in the manufacture, sale and distribution of Philippine National Police (PNP) uniforms, insignias and other accoutrements. It includes enterprises dealing with new materials for the production of aforementioned items.

SECTION 3. DEFINITION OF TERMS – For purposes of implementation of this Ordinance, the following determinations shall be binding and controlling:

- a) Philippine National Police (PNP) uniforms, insignias and accoutrements — these are authorized clothing, garments, distinguishing mark, emblem, merchandise, or decorations worn by bona fide members and officially acknowledge by the Philippine National Police.
- b) Certificate of Conformity (COC) a certificate issued by the Philippine National Police (PNP) through the Directorate for Research and Development (DRD) which signifies authority to manufacture, sell, or distribute Philippine National Police (PNP) uniforms, insignias and other accoutrements.
- c) Distributor an authorized agent of a supplier or manufacturer to supply or deliver Philippine National Police (PNP) uniforms, insignias and accoutrements wherein the letter has a valid PNP Certificate of Conformity (COC).
- d) Manufacturer act of producing or trading of fit-to-use, ready-to-wear, or ready-to-use PNP uniforms, insignias and other accoutrements.

SECTION 4. REQUIREMENT FOR PNP CERTIFICATE OF CONFORMITY – All businesses engaged and dealing with Philippine National Police (PNP) uniforms, insignias and accoutrements must present to the Philippine National Police (PNP) his/her valid business permit in order to secure a PNP Certificate of Conformity (COC).

SECTION 5. COORDINATION WITH THE PNP – For effective implementation of this Ordinance, the Philippine National Police (PNP) shall coordinate with the Business Permit and Licensing Office (BPLO) of the Local Government Unit of San Dionisio, Iloilo to ensure that all covered establishments engaged in the manufacturing, selling, or distribution of Philippine National Police (PNP) uniforms, insignias and other accoutrements that are applying for a business permit shall be evaluated by a dedicated Philippine National Police (PNP) personnel.

The Philippine National Police (PNP) shall also submit to the Business Permit and Licensing Office (BPLO) a List of registered covered establishments who failed to secure the Philippine National Police (PNP) Certificate of Conformity (COC).

SECTION 6. AUTHORITY TO INSPECT ESTABLISHMENTS – The Business Permit and Licensing Office (BPLO), the Philippine National Police (PNP), the barangay officials, particularly, the Barangay Kagawad on Peace and Order Committee assisted by Task Force "BANTAY BIHIS" shall periodically conduct joint inspection of covered business establishments requiring the presentation of its respective Philippine National Police (PNP) Certificates of Conformity (COC).

SECTION 7. IMPLEMENTING OFFICES – The Business Permit and Licensing Office (BPLO) in coordination with San Dionisio Philippine National Police (PNP) Station is the primary office mandated to execute the provisions of this Ordinance.

SECTION 8. PENALTIES – Failure to secure a Philippine National Police (PNP) Certificate of Conformity (COC) or present the same during the inspection, the following penalty applies:

1st **Offense** – Issuance of Demand Letter to be issued by the Business Permit and Licensing Office (BPLO)

2nd **Offense** – Fine of One Thousand Pesos (P1,000.00) and the items found therein shall be seized or confiscated subject to proper disposal, without prejudice to the revocation of business permit and the filing of appropriate administrative, civil or criminal case.

3rd **Offense** – Fine of One Thousand Five Hundred Pesos (P1,500.00) and the items found therein shall be seized or confiscated subject to proper disposal, without prejudice to the revocation of business permit and the filing of appropriate administrative, civil or criminal case. Likewise, the Business Permit and Licensing Office (BPLO) and the Philippine National Police (PNP) may recommend the suspension of the business operation, revocation of the business permit, or closure of the business establishments, depending on the nature of the violation committed.

SECTION 9. SEPARABILITY CLAUSE – Iffor any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

SECTION 10. REPEALING CALUSE – All ordinances, rules and regulations or parts thereof in conflict with this Ordinance are hereby repealed, provided that the rights that are vested upon the effectivity of this Ordinance shall not be impaired.

SECTION 11. EFFECTIVITY CLAUSE – This ordinance shall take effect fifteen (15) days after its approval, posting in conspicuous places and publication in local newspaper of general circulation.
