City gov't distributes reading workbooks to **Grade 3 learners**

The Iloilo City Government, in collaboration with Synergeia and EDCOM, turned over 6,828 reading workbooks for Grade 3 learners on October 22 as a part of a Proof of Concept (POC) project aimed at improving reading literacy of students and the teaching strategies of teachers for reading.

During the turnover ceremony, some of the student recipients came from Iloilo Central Elementary School (ICES) and Jaro I Elementary School.

The city government allocated Php874,000 for the printing of 7,600 workbooks and an additional

Php400,000 for a ten-day training program for 150 Grade 3 teachers.

Acting City Mayor Jeffrey Ganzon emphasized the importance of these workbooks in fostering a love for reading, while Special Assistant to the City Mayor Ms. Maria MathildeTreñas underscored how this initiative shall strengthen and improve the region's educational framework.

Plans for future Learning Action Cell (LAC) sessions, coaching, and mentoring were also highlighted.

The initiative was supported by Schools Division Superintendent Ms. Ma. Luz M. De Los Reyes and Synergeia Focal Person Mr. Edwin Nacionales.

WV 2023 poverty incidence drops to 9.8%

The poverty incidence in Western Visayas dropped to 9.8% in 2023, down from 12.1% in 2021, based on data from the Philippine Statistics Authority (PSA)-6.

This represents around 119,000 families with incomes below the poverty threshold, compared to 140,000 families in 2021.

Mt. Kanlaon strict protection zone pushed



Western Visayas' Regional Disaster Risk Reduction and Management Council (RDRRMC) approved Resolution 7, recommending the declaration of a 4-km. permanent danger zone (PDZ) set by the Philippine Institute of Volcanology and Seismology (PHIVOLCS) in Mt. Kanlaon as a strict protection zone (SPZ).

"Under the law, when this particular area will be categorized as a strict protection zone, meaning to say there will be no human activity except for research and Indigenous People cultural practices," Melissa Banias, chief of the operations section of the Office of Civil Defense, said during the RDRRMC full council special meeting in Iloilo City on Tuesday where they unanimously approved the resolution.

The resolution, addressed agricultural development. to the Protected Area Management Board of the Mt. Kanlaon Natural Park (PAMB/MKNP), said that the PHIVOLCS Kanlaon Volcano Alerts Scheme states that even in normal conditions, perennial hazards may occur suddenly and without warning within the radius of the 4-km.

The area is currently in the marine protection zone of the MKNP.

In an interview on Wednesday, RDRRMC chairperson Raul Fernandez said the PAMB has been waiting for the resolution to declare the SPZ.

With the approval of the resolution, Fernandez said, they are now discussing strategies that would involve the relocation of families

living within the PDZ.

Data from the MKNP PAMB showed that more or less 60 households are within the PDZ, based on the PAMB map, although the local government unit of La Castellana accounted for 15 families - 10 in Barangay Masulog and five in Barangay Biak na Bato.

Ten families, or 34 individuals, from La Castellana town are taking temporary shelter in two evacuation centers.

He said they could not just relocate them until a permanent relocation site is identified.

"What we will do is we will help La Castellana to temporarily house the affected families until such

time that we put in place the relocation area," Fernandez said.

During the meeting, Banias reported that the first demarcation flag indicating the 4-km. PDZ was installed in Barangay Biak naBato in La Castellana, Negros Occidental on Oct. 8.

The eruption of Mt. Kanlaon volcano on June 3 caused PHP245.74 million in damage and losses as of Oct. 1, based on data from the Department of Agriculture.

The assistance provided by various government agencies, nongovernment organizations, and local government units reached PHP44.67 million. (PNA)

City gov't turns over socialized housing units for low-salaried employees

The Iloilo City Government in partnership with SM Development Corporation (SMDC), CFC ANCOP, and the Department of Human Settlements and Urban Development (DHSUD) turned over the KaUSWAGAN Residences —the first vertical socialized housing units at Barangay San Isidro, Jaro Iloilo City on October 24.

The two four-storey buildings, worth Php248 million, provide 120 housing units to low salary grade City Hall employees (Salary Grade 8 and below) with a minimum of five years of service by December 31, 2021 wherein they don't have property or houses in Iloilo City.

Additionally, the said initiative serves as an accessible and affordable housing for Iloilo City Government employees, with the aim to reduce the 6.5 million housing backlog in the metropolis.

Through collaborative efforts, SMDC also reaffirms its commitment in providing socialized housing and

building a nation of homeowners in the city.

On the other hand, the Iloilo City Local Housing Office (ICHLO) is in-charge of facilitating the application process of qualified beneficiaries as defined by the Iloilo City Local Housing Board (ICLHB).

This initiative aims to address the housing shortage in Iloilo, offering affordable homeownership through partnerships with PAGIBIG.

Through the collaborative efforts, SMDC also reaffirms its commitment in providing socialized housing and building a nation of homeowners in the city.

Meanwhile, SMDC is the residential arm of SM Prime Holdings Inc. (SMPHI) which is one of Southeast Asia's largest integrated property developers.

The said event was spearheaded by SMDC key officials, Iloilo City Government officials headed by Acting Mayor Jeffrey Ganzon, and department heads.

SSS intensifies campaign vs. delinquent employers in Iloilo

ILOILO CITY – The Social Security System (SSS) served notices to seven establishments in Iloilo to comply with the contributions of their employees as part of the Run After Contribution Evaders (RACE) activity on Tuesday.

In an interview on Wednesday, Amiel Genova, senior communications analyst at SSS Visayas West 2 Division, said the pre-selected establishments were reminded of their obligation under the Social Security Act of 2018, where employers should be compliant in paying the contribution of their workers.

The total delinquency of the establishments engaged in spa, food, laundry, and clinic businesses totaled over PHP489.6 million.

"We gave them notice to coordinate with our office within 15 days to possibly rectify their records," he said.

He added SSS offers an installment program where employers can pay on a staggered basis or avail of the condonation program, where penalties are waived if establishments are qualified.

"This is one of the last resorts before the filing of cases," he said.

The region's poverty incidence among families was also lower than the national average of 10.9 percent.

Several provinces experienced a significant decrease in poverty incidence, including Aklan (3.1%), Antique (13.8%), and Guimaras (3.8%). Iloilo City's rate dropped to 2.3%, while Iloilo Province's fell to 12./ percent.

However, some areas like Capiz (9.8%), Negros

Occidental (25.7%), and Bacolod City (6.2%) saw increases in poverty incidence.

In addition, the PSA-6 also reported that the region's poverty incidence among the population was 13.7%, equivalent to 664,000 individuals and lower from 820,000 in 2021.

OIC Regional Director Ms. P13,710; Capiz at P13,850; PHP2.34 million. NelidaAmolar stated that the poverty threshold or the minimum income needed

to meet basic food and non-food needs, was set at an average of P13,801 per month for a family of five.

Aklan had the lowest poverty threshold at P12,558, while Negros Occidental had the highest at P14,892. Some provinces such as Antique has poverty On the other hand, PSA-6 threshold reached at Guimaras at P12,853, and Iloilo at P13,933.

Meanwhile, National Economic and Development Authority (NEDA)-6 Regional Director Arecio Casing, Jr. credited the boost in Aklan's tourism, particularly in Boracay, for contributing to the reduction and other provinces were also encouraged to explore similar economic opportunities.

P2.34-M aid released to 'Kristine'affected families in W. Visayas

ILOILO CITY - The Department of Social Welfare and Development (DSWD) reported on Thursday that relief goods provided to families affected by Severe Tropical Storm Kristine (international name: Trami) in Western Visayas reached

The assistance consisted of PHP1.16 million worth of goods from the DSWD and the rest came from local government units as of noon today, mostly in family food packs, and the majority were for Iloilo, Capiz, and Negros Occidental provinces.

"We recognize the fast in poverty in the province action of our staff, as well as those from the LGUs. We see the prepositioning of food packs to be very helpful because it makes

the withdrawal of goods faster and easier. Goods are strategically located already in different sites in the region," officer-in-charge Regional Director Arwin Razo said in a statement.

The office still has PHP147.2 million worth of standby funds and stockpiles to respond to the situation.

Meanwhile, the Regional Disaster Risk Reduction and Management Council situation report released at 12:01 a.m. Thursday showed that the weather disturbance has affected 4,602 families or 20,403 individuals from 83 barangays in Western Visayas.

Of the affected families, 283 are being sheltered in 25 evacuation centers, while 137 others are outside evacuation centers.

The report also said 45 houses were damaged, six were destroyed, and 39 were partially damaged.

Further, 371 passengers are stranded in various ports in the region, together with 221 rolling cargoes, 11





'Kristine' strong winds evacuation of 244 families in Antique

BUENAVISTA, Antique -A total of 244 families or 759 individuals in Antique evacuated to safer places due to strong winds brought by Severe Tropical Storm Kristine (international name: Trami), the Provincial Disaster Risk Reduction and Management Office (PDRRMO) reported.

The families are from the towns of Anini-v, Tibiao, Libertad, San Jose de Buenavista, Tobias Fornier, Barbaza, San Remigio, and Bugasong, said Local Disaster Risk Reduction and Management Officer III Michael Tolentino in an interview on Thursday.

"Of the 244 families evacuated in the eight towns of the province, Anini-y for their safety. 193 families are inside the evacuation centers being taken care of by their respective local government units," Tolentino said.

The 51 other families opted to stay with their relatives until the weather improved.

He added that fishing and passenger vessels are also advised not to venture out to the sea due

Slow food education center eyed in Bacolod City

'Kristine' affects 469 families in Cordillera

BAGUIO CITY - The Department of Social Welfare and Development (DSWD) - Cordillera said about 469 families, or 1,568 individuals, in the region have been affected by Severe Tropical Storm Kristine (international name: Trami).

In its situational update No. 4 issued at 6 a.m. Thursday and submitted to the Cordillera Disaster Risk Reduction and Management Council (CDRRMC), the DSWD said of the total, 352 families have evacuated, with 225 families taking temporary shelter in 21 evacuation centers across the region, and 127 families opting to shelter with friends and relatives.

It also reported damage to 31 houses.

"DSWD is augmenting the resources of the local government units to ensure that there will be no scarcity of food and other necessities of families, especially those in evacuation centers," DSWD-Cordillera Director Maria Aplaten Catbagan said in an interview Thursday.

She said a total of PHP26.7 million worth of humanitarian assistance has been provided.

Catbagan assured the public that the regional DSWD office has available 67,008 family food packs and 25,361 non-food items, as well as PHP2.9 million in standby fund.

"We have an ongoing validation of the reported displaced persons and validation of the reported forced evacuation in Mountain Province," she said.

She said DSWD is providing augmentation to local government units, citing that "we practice communitydriven response."

Meanwhile, Benguet Governor Melchor Diclas, in a post on his official social media page, said Sitio Camp 2 in Barangay Twin Peaks, Tuba is closed to all types of vehicles due to a road slip.

"All other national roads and bridges within Benguet First District Engineering Office's area are passable to traffic," the post added.

Diclas also said light rain showers are being experienced in Benguet. (PNA)



Better healthcare for elderly Filipinos

A few weeks ago, I read on the news that state health insurer PhilHealth was studying the viability of covering assistive devices such as wheelchairs, canes, crutches, and walkers by next year -- a benefits package that if implemented, would help many Filipinos, including a great number of senior citizens.

After all, estimates of the National Commission of Senior Citizens show that the Philippines will have a "significant aging population" by 2030 with the Filipino elderly expected to comprise about 8.5 percent of the household population. As of 2020, senior citizens numbered over 9 million.

These numbers only highlight the need for the government to expand and improve public health programs and support for the elderly, given the expected jump in their numbers over the next half a decade and the fact that many Filipinos aged 60 and above are already retired and dependent on their pension payouts.

While the current array of healthcare benefits for senior citizens is a welcome development, such as the 20 percent discount on health services and the exemption of several medicines from value-added tax (VAT), the reality is these are not enough to support the advanced medical needs of the elderly, many of whom require regular medical attention in their golden

Current financial support programs such as social security benefits and the pension for indigent senior citizens are greatly insufficient to cover the healthcare services needed by the elderly.

And with rising medical costs, it's a sad reality that many Filipino families are just one hospital bill away from poverty.

Responding to the healthcare needs of elderly Filipinos require a multifaceted approach that fills in gaps in the public health system and infrastructure, as well as financial support.

Primarily, the government must allocate sufficient funds to improve the facilities and services in public hospitals since these are the most accessible ones, especially to indigent Filipinos. Doing so would improve the quality of medical care provided not only to senior citizens but to the entire community as well.

In the context of rising medical costs, senior citizens should be provided with more comprehensive medical benefits. Top of mind is expanding the tax exemption on medicine purchases of senior citizens to cover the various medical conditions faced by the elderly.

Currently, only select medicines are covered by the VAT exemption, such as those for high cholesterol, diabetes, cancer and hypertension.

Moreover, it would also be ideal for the government to mandate all hospitals to have a dedicated unit for attending to inquiries, billing, payment processing, and other administrative concerns of senior citizens.

This would ensure that their concerns are properly addressed without disrupting normal hospital

operations.

Beyond expanding the healthcare benefits of senior citizens, the government must also address accessibility barriers confronted by many elderly Filipinos, particularly those living in rural and remote areas.

Often, limited health services and lack of awareness among the elderly are prevalent in rural areas, gaps that highlight the need for a more robust system to respond to this demographic's needs.

Local government units (LGUs) should take the lead on this through an aggressive and widespread information campaign on the available programs and benefits for elderly Filipinos to ensure that senior citizens have access to their much-deserved health benefits.

Across the country, LGUs should also invest in programs that promote healthy aging among Filipinos. These include exercise programs to encourage an active lifestyle, which can help reduce the risks of chronic diseases.

By expanding and improving health benefits for senior citizens, our country not only honors their contributions to society but also strengthens our public health infrastructure for the benefit of future generations of Filipinos who will be senior citizens as well.

Honoring IPs and their aspirations for self-determination

Every October, the Philippines celebrates Indigenous Peoples Month to honor the unique cultures, wisdom, and contributions of the country's Indigenous Peoples (IPs). The theme for this year's celebration, "Valuing, Nurturing, and Honoring Indigenous Peoples and Indigenous Knowledge," highlights the need to recognize, care for, and respect indigenous communities and their age-old wisdom. This knowledge, rooted in sustainable living and harmony with nature, is especially relevant today as the world faces environmental challenges such as climate change.

NCIP chairperson Jennifer Pia-Sibug-Las highlighted that this year's celebration offers a chance for the entire country to come together to honor the cultures, knowledge, and rights of IPs. The celebration aims to increase awareness. foster appreciation, and foster solidarity with IP communities, making their voices heard and their contributions acknowledged both locally and nationally.

The celebration not only honors the indigenous peoples' cultural heritage but also marks a major legal achievement—the passage of the Indigenous Peoples Rights Act (IPRA) on Oct. 29, 1997. This law was a major step forward in protecting the rights and lands of indigenous peoples in the Philippines.

The IPRA is a crucial law that recognizes the rights of indigenous peoples to self-determination, cultural integrity, and ownership of their ancestral lands. A key part of this is the issuance of Certificates of Ancestral Domain Title (CADT) or Certificates of Ancestral Land Title (CALT). These titles officially recognize indigenous peoples rights to their ancestral lands, allowing them to control and manage these areas.

However, obtaining these titles is often a difficult process, with indigenous communities facing many obstacles, such as lengthy documentation and resistance from groups with vested interests in their lands. Civil society organizations have played an important role in helping indigenous peoples navigate these challenges and claim their rightful ownership.

Another key provision of IPRA is the Indigenous Peoples Mandatory Representation (IPMR) in local legislative councils. This ensures that indigenous peoples have a voice in local government, where they can advocate for their rights and interests. IPs themselves select their representatives, who serve as champions for their communities, helping address their needs and concerns at both local and national levels.

According to the United Nations Development Programme (UNDP), IPs in the Philippines make up an estimated 14 to 17 million of the population, representing 110 ethnolinguistic groups. The Cordilleras in Northern Luzon, the Aetas in Central Luzon, and the Lumads in Mindanao are the primary locations for them. Discussions about national development often exclude indigenous peoples, despite their rich cultural diversity.

IPs Month seeks to raise awareness about their contributions and struggles while fostering solidarity with their communities. The celebration highlights their vital role as stewards of the land. For centuries, indigenous peoples have lived in harmony with nature, using sustainable farming, forestry, and water management practices. Their deep understanding of the environment has preserved biodiversity and protected ecosystems in their ancestral domains. This knowledge is especially valuable in addressing today's environmental crises, offering solutions rooted in sustainable living.

IPRA also created the National Commission on Indigenous Peoples (NCIP), a government agency responsible for ensuring the protection of indigenous peoples' rights. The NCIP plays a critical role in processing ancestral land claims, providing legal and technical support to indigenous communities, and resolving disputes related to land ownership. Additionally, the NCIP

advocates for policies that address the unique challenges faced by indigenous peoples, such as access to education, healthcare, and economic opportunities.

However, the NCIP has faced challenges in fully implementing its mandate, making Indigenous Peoples Month an important time to evaluate its work and push for reforms that strengthen the protection of indigenous peoples' rights.

Despite legal protections, many indigenous communities continue to face challenges, particularly when it comes to defending their land from encroachment by large-scale industries such as mining and logging. These operations often violate indigenous peoples' rights by failing to obtain their Free, Prior, and Informed Consent (FPIC) as required by law.

Indigenous communities are also fighting for greater autonomy, seeking to preserve their cultural practices and self-governance systems. Their struggle is not just about land but also about maintaining their way of life and ensuring that they can decide their future. MUNICIPAL ORDINANCE NO. 179 SERIES OF 2020

AN ORDINANCE REQUIRING ALL BUSINESS AND COMMERCIAL COMPLEXES AND ESTABLISHMENT AND OTHER PLACES AND SPACES CONSIDERED AS HIGH RISK TO INSTALL CLOSE CIRCUIT TELEVISION (CCTV) CAMERA AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, Sec. 16 of the Local Government Code of 1991 (R.A. 7160) provides that the local government units shall exercise its powers expressly granted, and those that are necessarily implied therefrom, which are necessary and essential to the promotion of the general welfare of its inhabitants;

WHEREAS, Sec. 447 of the same code provides that Local Government Units may "maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot violence, rebellion or sedition and impose penalties for violations thereof".

WHEREAS, the use of CCTV Cameras has been proven to be an incredibly useful tool in aiding the Police in investigations, preventing thefts and other crimes, protecting the company and employees against physical or verbal attacks from the general public, settling of disputes and keeping of records;

WHEREAS, the Municipality of Caluya, is in active pursuit of programs and measures that endeavor to create an environment conducive to the advancement of local trade and commerce and considers business its indispensable partner in the promotion of progress and development.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan in Session assembled, that:

SECTION 1. TITLE. This ordinance shall be known as the "CCTV CAMERA Ordinance of the Municipality of Caluya.'

SECTION 2. DECLARATION OF POLICY. It is hereby declared the policy of the Municipal Government of Caluya to protect the security and well- being of its constituents from criminality and lawlessness by enacting sound measures for the maintenance of peace and order within its jurisdiction.

It is also the policy of the Municipal Government of Caluya to ensure that the fundamental rights of an individual to privacy is not and will not be unreasonably hampered nor curtailed other that what is necessary for the protection of the welfare of the public in general.

Thus, in the enactment and implementation of this ordinance, the Municipal Government of Caluya reiterates and affirms its adherence and full respect for every individual's fundamental right to privacy by regulating the installation and use of video surveillance camera or CCTV, ensuring that Feed Locations are limited to public spaces only and by the provision of proper safeguards against unauthorized viewing and/ or disclosure of video recording made in accordance therewith.

SECTION 3. DEFINITION OF TERMS. For the purposes of this Ordinance, shall following terms shall mean:

BUSINESS ESTABLISHMENTS - refers to banks and their satellite offices, branches and Automated Teller Machines (ATMs), money changers, pawnshop, credit facilities and other similar lending and financial institutions, as well as other high-risk commercial complexes or establishments as may be identified by the CCTV Camera Council.

CLOSED-CIRCUIT TELEVISION OR CCTV - refers to video surveillance camera used to transmit visual information to a monitor or a number of monitors.

COMMECIAL COMPLEX AND ESTABLISHMENT - refers to a building or structure or a set of buildings or structures usually owned by a single owner, company or corporation housing under its roof several business entities of varied natures by various owners.

CRITICAL ASSETS - persons, properties of resources of the Municipality that may be in need of protection or recovery, or is in danger of destruction.

CULLING - the process by which records of feeds are picked out or selected to be discarded or destroyed.

DESIGNATED SECURITY PERSONNEL - police or civilian personnel authorized to operate or use particularly CCTV Camera or cameras.

FEEDS - are visual information or images transmitted by video surveillance cameras to the monitors.

FEED LOCATIONS – areas that are covered or viewed by video surveillance camera.

HIGH RISK AREAS - refers to commercial complexes and establishments or other places and spaces with common business areas where there is a greater degree of susceptibility to occurrence of accidents or criminalities because of the numerous financial, social or business of the Municipality are situated.

MONITORS - the screens or other devices on which feeds are viewed.

NEW BUSINESS ESTABLISHMENTS - refers to newly created trading or commercial concerns undergoing application for business permit or the license to operate prior to the effectively of this ordinance.

OLD BUSINESS ESTABLISHMENTS – refers to existing business establishments that have duly secured current business permit of the license to operate and are already operating at the time of the effectivity of this ordinance.

RECYCLING - refers to a process by which records or tapes of feeds or visual information may be erased through overrun by another or new visual information.

SATELLITES BRANCHES/OFFICES - refers to small extension offices of business concerns such that of banks, airline companies and the like.

SECTION 4. SCOPE OF APPLICATION AND INSTALLATION OF VIDEO SURVEILLANCE CAMERAS. All business establishments and other commercial complexes and establishments and places and spaces considered as high-risk areas as defined herein are hereby mandated to install video surveillance cameras and monitors in the premises of their establishments subject to limitations prescribed herein and by the CCTV Camera Council created for the purpose.

CCTV Surveillance cameras are also hereby required of the Municipal Government to be installed in identified high risk areas and public spaces or places of the Municipality for protection, traffic monitoring and crime prevention and detection, its treasury, storage facilities, and other critical assets for protection and preservation.

The provision of the preceding paragraph likewise applies to all commercial establishments and financial institutions and government or non-governmental offices which may not be considered as high risk but have installed or affixed CCTV in their place of work or commerce prior or subsequent to the enactment of this ordinance.

A written notice declaring the presence of a CCTV Camera or cameras in any business or commercial establishment/s so covered by this Ordinance must be posted by the owner/s in conspicuous place or places with the vicinity of the establishment.

SECTION 5. REQUIREMENT FOR BUSINESS REGISTRATION. A Certificate of Compliance (COC) must be secured by new business establishments specified in Section 4., paragraphs 1 and 2 from the CCTV Camera Council as a requirement by the Municipal Government for the approval of their business permit applications. Likewise, same COC shall be required of old business establishments, those in paragraph 3 of the same section included, as a requisite upon every renewal of their business permits.

SECTION 6. CREATION AND COMPOSITION OF CCTV CAMERA COUNCIL. A CCTV Camera Council shall be created as an oversight body tasked with the approval, control and supervision of all CCTV Camera use and installation composed of the Municipal Mayor or his designated representative as chairman, the Caluya PNPas Vice-Chairman, the Municipal Engineer, Sangguniang Bayan Committee Chairman on Public Safety and two (2) members from the business sector within thirty (30) days after the approval of this ordinance.

SECTION 7. SPECIFIC POWERS OF THE CCTV CAMERA COUNCIL. The CCTV Camera Council shall have the following specific powers and functions:

- 1. Create and adopt Policies and Procedures Manual within sixty (60) days after its creation setting up the criteria and standards for CCTV cameras and monitors;
- Maintain a log of all CCTV Cameras and their corresponding feed locations, the dates of their approval, and the criteria used for their approval;
- Maintain a log of the name/s of designated person/s authorized to handle, operate, and preserve the records or tapes of CCTV cameras of each establishment;
- Create a Task Force that shall have visiting powers to inspect, evaluate and monitor establishments with CCTV cameras at any given time so as to determine compliance with the Ordinance:
- Monitor and inspect all preserved/stored feeds, the date and the records were taken, and determine when such records of feeds are due for recycling or culling;
- Receive and/or approve application for CCTV installation prerequisite to issuance of Certificate of Compliance;
- Recommend to the Municipal Mayor, the approval or renewal of business permits of establishments so affected by the ordinance as well as the suspension or revocation of
- Identify business, commercial complexes and establishments, or other places and spaces which may be considered as high risk as defined under the Ordinance; and
- Perform such other duties and functions as may be set forth in the Policies and Procedures Manual.

SECTION 8.LIMITATIONS ON USE. CCTV Cameras, and any and all feeds, maybe solely used in the specific instances set forth in this Ordinance, and use of CCTV Cameras by such persons other than the owners and designated security personnel authorized to operate the same in any manner or location, or for any other purpose, is expressly prohibited.

- LAW ENFORCEMENT AND CRIME PREVENTION. CCTV Cameras, and any all feeds, may be used for the purpose of providing surveillance in the service of law enforcement and crime prevention within the Municipality where there is documented criminal activity.
- 2. MAINLAND/ISLAND SECURITY. CCTV Cameras, and any and all feeds, may be used for the purpose of providing surveillance in the service of mainland/island security, law enforcement and crime prevention, and disaster preparedness and recovery in areas identified as critical assets of the Municipality as may be set forth by any competent authority.
- 3. TRAFFIC MONITORING. CCTV Cameras, and any and all feeds, may be used for the purpose of traffic monitoring but are not intended to include enforcement of traffic violations. Notwithstanding the foregoing, the Feeds from CCTV Cameras used for traffic monitoring may be used for lawful purpose in the event that such CCTV Cameras, while being used for their primary function, incidentally view behavior that has caused or is likely to cause danger to person or property.

SECTION 9. PROHIBITIONS. The feeds shall not be used for the following:

- 1. **BROADCASTING.** Broadcast by any of the authorized persons prescribed herein of any of the feeds or any of its parts or records on or through any medium other than the monitors;
- **2. VIEWING.** Feeds shall not be viewed by any person/s other than those expressly authorized herein to view the records of feeds.
- **3. TRANSFER.** Feeds shall not be transferred to any third party, whether for profit or not;
- **4. REPRODUCTION.** No person shall be allowed to copy any or all parts of any records of the feeds.

SECTION 10. PRESERVATION OF FEEDS. Feeds shall be recorder or otherwise stored by owner or owners of institutions or establishments for future use for a period of not less than three (3) months. Until the expiry of such time, the records or tapes of such feeds may be recycled or destroyed unless otherwise a proper request for a specific log of any given feed shall have been made to the contrary as provided for in the proceeding section in which case the properly requested specific record/s of feeds must be turned over, in its original and unadulterated form and substance, to the proper requesting authority.

SECTION 11. PROPER REQUEST FOR FEEDS. Stored or preserved Feeds may be used anytime to satisfy the following:

Any authorized subpoena or any written order of any court of competent jurisdiction;

- Any written request from the chief officer of the investigating body or authority ensuing the advent of a criminality for proper disposition of crime investigation and report; and
- 2. Any written request from the duly constituted legislative body or assembly for purposes in aid of legislation.

SECTION 12. PENALTIES. Failure to comply with any of the provisions of this Ordinance is punishable with the following:

ON SECTION 4:

- 1. **NEW BUSINESS ENTITIES** withholding of permit to operate.
- OLD BUSINESS ENTITIES suspension or revocation of business permit and Php 2,500.00 fine

ON SECTION 9 -11:

Violation of any of the provisions set forth in Sections 9 to 11 of this ordinance shall be punishable by Php 2,500.00 fine

SECTION 13. REPEALING CLAUSE. All ordinances and resolutions inconsistent herewith are hereby repealed or modified accordingly.

SECTION 14. SEPARABILITY CLAUSE. In the event that any of the provisions of this ordinance is declared illegal, the validity of the other provisions shall not be affected by such declaration.

SECTION 15.EFFECTIVITY. This ordinance shall take effect immediately upon compliance of posting and publication requirements. Provided, however, that the establishments herein covered are given until January of the year following the effectivity of this ordinance to fully comply with the provisions of Section 4. Provided, further, that the provisions of Section 5 for business applications and renewal are totally enforceable thereafter.

MUNICIPAL ORDINANCE NO. 245 SERIES OF 2023

AN ORDINANCE REGULATING THE OPERATION OF VIDEO-KARAOKE BARS, BEERHOUSES, EATERIES AND RESTAURANTS WITH KARAOKES AND VIDEOKES, OTHER SIMILAR NIGHTSPOT AND ESTABALISHMENTS IN THE MUNICIPALITY OF CALUYA, ANTIQUE AND PROVIDING PENALTIES FOR VIOLATION THEREOF

WHEREAS, the Local Government Code of 1991 mandates that the Sanggunian Bayan may, among others, regulate the establishment, operation and maintenance of entertainment, or amusement facilities, xxx and such other events or activities, for amusement or entertainment, particularly those who tend to disturb the community, or annoy the inhabitants, or require the suspension or suppression of the same, xxx;

WHEREAS, it is the duty of the Sangguniang Bayan to regulate certain activities in order to promote the general welfare of its constituents;

WHEREAS, in the furtherance of public safety, the present administration of this LGU has considered the enactment of a legislative measure that would ensure peaceful and orderly community in the Municipality of Caluya;

WHEREAS, series of public consultations and interviews with concerned residents, Barangay Official and other concerned sectors in the community had been conducted;

WHEREAS, it was learned that the influx of establishments offering various kinds of intoxicating substance and allowing the operation of video-karaoke machines, cause the residents to complain about the nuisance during nighttime;

WHEREAS, it was also reported that video-karaoke bars, beerhouses, eateries and restaurants with karaokes and videokes, similar night spots and establishments are allowing entertainers, guest relation workers to offer extra-services in exchange of financial consideration, thus, causing the deterioration of good moral values among customers;

WHEREAS, based on ocular inspection, video-karaoke machines and other similar equipment are being operated in full view of the public, with some obscene which are not suitable for minors.

NOW, THEREFORE, in view of the above premises, **BE IT ENACTED** by the Sangguniang Bayan of Caluya, Antique, in session duly assembled, that:

SECTION 1 – **TITLE**. This ordinance shall be known as "AN ORDINANCE REGULATING THE OPERATION OF VIDEO-KARAOKE BARS, BEERHOUSES, EATERIES AND RESTAURANTS WITH KARAOKES AND VIDEOKES, OTHER SIMILAR NIGHTSPOT AND ESTABALISHMENTS IN THE MUNICIPALITY OF CALUYA, ANTIQUE AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

SECTION 2 – SHORT TITLE. The short title of this ordinance shall be known as "THE VIDEO-KARAOKE BAR ORDINANCE OF 2023";

SECTION 3 – **SCOPE AND COVERAGE**. This ordinance shall cover all business establishments operating videoke and karaoke, videoke and karaoke bars, beerhouses, eateries and restaurants with videokes and karaokes and other similar establishments and night spots in the Municipality of Caluya, Antique.

- ➤ ESTABLISHMENTS a place of business with its possessions and staffs/personnel;
- > VIDEO AND KARAOKE BARS a place where the audio-visual systems are set for musical accompaniment to a song performed by following the words displayed in a video screen. It

(SGD.) RIGIL KENT G. LIM Municipal Mayor is also a place where foods, beverages and other intoxicating substances are being offered to customers:

- ➤ BEER HOUSES a place where beer is mainly served, although other forms of intoxicating substance, wine and liquor are also available for customers;
- NIGHT SPOTS those establishments that are open late at night and provide foods, drinks, entertainment and music for dancing;
- ➤ ENTERTAINERS include singers and guest relations officers (GRO) of videoke and karaoke bars, beerhouses, eateries and restaurants with videoke and karaoke bars, similar nightspots and establishments who entertain patrons or customers by sitting and conversing, dancing, singing, eating or drinking with them;
- EGRESS an arrangement of facilities to assure a safe means of exit from the establishment;
- MUNICIPAL MONITORING COMMITTEE. The Committee duly constituted to monitor the implementation of this Ordinance;

SECTION 5 - PROHIBITIONS.

- a. No person, natural or juridical, shall operate videoke and karaoke bars, beerhouses, eateries and restaurants with videokes and karaokes, similar night spots and establishments for commercial purposes without first securing a Sanitary Permit issued by the Municipal Health Officer, Mayor's Permit, Barangay Clearance and paying for other related corresponding fees provided for under Municipal Ordinance No. 163 otherwise known as the Municipal Revenue Code of Caluya, Antique, or any rules and laws that may hereinafter promulgated by the Sangguniang Bayan;
- b. For purposes of this Ordinance, no videoke and karaoke, videoke and karaoke bars, beer houses, eateries and restaurants with videoke and karaoke, similar night spots and establishments shall be established within one hundred (100) meters radius from any educational, religious or public institutions such as schools, colleges, universities, hospitals or clinics, churches or chapels;
- c. No videoke and karaoke, videoke and karaoke bars, beerhouses, eateries and restaurants with videoke and karaoke, similar night spots and establishments shall utilize gambling, prohibited under P.D. 519, such as "pinball machines" slot machines and other similar devices:
- d. The following requirement shall be strictly observed in the establishments:
 - Operating of karaoke and videoke music shall be allowed only form 7:00 AM to 10:00 PM ONLY, however, establishments with total enclosure of the premises to prevent the sound to escape may operate beyond 10:00 PM. The establishments shall provide and post in conspicuous places the opening and the closing time;
 - ii. Minors as customers or workers shall not be admitted. The operator/owner shall cause the posting of placards in conspicuous places indicating the words "MINORS BELOW 18 YEARS OLD ARE NOT ALLOWED."
 - iii. Customers are prohibited to carry firearms, licensed or unlicensed, deadly weapons and explosive except those authorized by law and in the performance of their official function. The posting of placards indicating "ALL FORMS OF DEADLY WEAPONS ARE NOT ALLOWED INSIDE" shall be strictly complied;
 - iv. Adequate spaces and lighting, proper ventilation shall be maintained under satisfactory sanitary conditions at all times;
 - v. Adequate parking spaces for vehicles, dressing rooms for ladies, clean kitchen, regularly sanitized and separate lavatories for male and female, emergency lights, medical kits and communication adequate sound proofing shall be provided the owner/operator;
 - vi. The establishment shall be properly enclosed or fenced, provided with a single ingress or egress and shall have no direct or indirect communications whatsoever with any dwelling place, house or building except the single ingress or egress;
 - vii. Banning of prostitution and showing of lewd shows; and
 - viii. Banning the use and selling of prohibited drugs.

SECTION 6 - ADMINISTRATIVE PROVISIONS. The following administrative provisions of this ordinance shall be observed for its effective implementation:

- a. Any person/s who are interested to establish business covered by this ordinance shall only be allowed after complying all requirements provide by Municipal Ordinance No. 163 also known as The Revenue Code of the Municipality of Caluya, Antique;
- b. The business as herein indicated shall be established only in an area/zone declared as commercial area, pursuant to the provisions of the Comprehensive Zoning Ordinance of the Municipality of Caluya, Antique;
- c. Personnel such as waitress/waiter, food handlers, servers, guest relation workers, etc. shall undergo monthly examinations. Medical certificates duly signed by the Municipal Health Officer (MHO) shall be issued to him/her. Payments of Medical Examination and Certificates shall be in accordance with the provisions provided in the Revenue Code of the Municipality of Caluya, Antique. Failure of the above-cited personnel to secure the said medical certificate shall not be allowed to work and the manager or operator/owners are liable to answer any penalties under this Ordinance. All personnel of such business are strictly required to secure their working permit, medical certificates and birth certificates. Minors found working in the establishments covered by this Ordinance shall be immediately referred to the MSWDO, for appropriate legal actions against the owner or operator;
- d. Structural design of the building must be enclosed, to prevent unnecessary noise/nuisance during night time. Other materials that can minimize noise/nuisance should be used. The operation of business shall be confined only inside the building. In case the owner/operator shall construct a building for business covered by this Ordinance, he/she shall first submit

to the Office of the Municipal Engineer a copy of architectural design or its blue print and shall secure building permit, electrical permit and zoning clearance;

- e. Operators/owners shall by all means cooperate in upholding peace and order and shall report to the Caluya Police Station or any of its COMPAC station whenever circumstances so warrant;
- f. All operators and owners are required to comply all rules and regulations under any existing national laws and or Municipal Ordinances or any Ordinances that are hereinafter be promulgated by the Sangguniang Bayan of Caluya, Antique;

For the purpose of this Ordinance, a Municipal Monitoring Committee is hereby constituted as follows;

Chief of Police ----- Chairman

MEMBERS:

Municipal Treasurer or his/her representatives
Municipal Engineer or his/her representatives
MSWDO or his/her representatives
MHO or the Sanitary Inspector
MPDO or his/her representative
Sangguniang Bayan Secretary
DILG Officer
Representative from NGO

The Municipal Monitoring Committee is hereby authorized to conduct inspection and investigation whenever there are complaints or petitions from concerned parties. It shall be the duty and functions of the committee to endorse results and recommendations to the Local Chief Executive, copy furnished the Sangguniang Bayan, for appropriate actions.

SECTION 7 - PENALTIES

Owners/operators, including personnel working of the business establishments found guilty
of violating any provisions of this Ordinance are subject to the following penalties;

1. **FIRST OFFENSE** – a fine of Php 1,000.00

2. **SECONDE OFFENSE** – a fine of Php 2,000.00

- THIRD OFFENSE a fine of Php 2,500.00 and revocation of their business permit or IMPRISONMENT of not more than ONE (1) month and totally banning their operation upon the discretion of the proper court.
- b. PUBLIC OFFICIALS tasked to implement and enforce this Ordinance and who failed or refused to implement or enforce this local ordinance shall be punished with a FINE of Php 2,000.00 and/or IMPRISONMENT OF NOT MORE THAN ONE (1) MONTH at the discretion of the proper court without prejudice to the filing of administrative cases in the proper government agency;

SECTION 8 - EXEMPTION. Operators of video-karaoke machines beyond 10:00 PM is hereby allowed one (1) week before and after any special holidays, to mention, Christmas, New Year and Town Fiesta. In case of special occasions, such as birthdays, wedding, baptismal and Barangay Fiesta, etc. and during funerals where the party opts to avail, the operation and use of video-karaoke machines may be allowed in any place within the territorial jurisdiction of the Municipality of Caluya, Antique.

SECTION 9 - SEPARABILITY CLAUSE. If for any reason or reasons, any part or provision of this Ordinance is declared invalid, null and void, the other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 10 - TRANSITORY PERIOD. All existing establishments prior to the enactment of this Ordinance not in accordance with Section 5(b) and Section 6(b) shall be given three (3) months to relocate their business.

SECTION 11 - REPEALING CLAUSE. All existing ordinance, rules and regulations or parts thereof in conflict with or inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 12 - EFFECTIVITY. This Ordinance shall take effect upon its approval and after due posting and publication as provided in the Local Government Code of 1991.

3 siblings yield P1.36-M shabu in Bacolod sting op

BACOLOD CITY - Police operatives arrested three siblings, who yielded PHP1.36 million in shabu, in a buy-bust at Purok Kabugwason, Barangay Mansilingan here Wednesday morning, a report from the Bacolod City Police Office (BCPO) showed.

"The BCPO remains committed to its intensified efforts in the campaign against illegal drugs and urges the public to continue supporting the authorities to address the problem," Col. Joeresty Coronica, police city director, said in a statement.

Police identified the suspects with their aliases as "Eron," 35; "Irene," 34; and "Ilyn," 26.

At past 3 a.m., an undercover policeman bought two sachets of shabu worth PHP20,000 from the suspects during the operation conducted by the joint team of the City Drug Enforcement Unit and the Bacolod City Maritime Police Station.

Operatives also seized from their possession four sachets of the same prohibited substance weighing 200 grams with a standard price of PHP6,800 per gram or a total of PHP1.36 million.

Charges for violation of Section 5 (sale of dangerous drugs) and Section 11 (possession of dangerous drugs) of Republic Act 9165 or the Comprehensive Dangerous Drugs Act of 2002 are being readied against the suspects.

The Wednesday morning haul is the latest among the series of major anti-drug operations conducted by the BCPO to prevent further proliferation of shabu in the ongoing 45th MassKara Festival.

On Oct. 17, CDEU operatives seized a kilogram of shabu worth PHP6.8 million from a lone suspect during a buy-bust in Purok Masinadyahon, Barangay 12.

TESDA, DMW forge partnership to boost **OFW** employment and livelihood

Reinforcing its programs and services for Overseas Filipino Workers (OFWs) and their families, the Technical Education and Skills Development Authority (TESDA) and the Department of Migrant Workers (DMW) formalized a partnership to enhance OFWs' and their dependents' skills and employability.

Last October 15, TESDA Director General, Secretary Jose Francisco "Kiko" B. Benitez, and DMW Secretary Hans Leo J. Cacdac signed a Memorandum of Agreement (MOA) during a ceremony held at the TESDA Women's Center in Taguig City.

"This is the contribution of TESDA to equip Filipinos with the necessary skills and knowledge while they are still in the country, when already in their host

country, and upon return to the Philippines," Secretary Benitez said in his speech.

Under the agreement, programs and services available for OFWs and their families; and, provide and certification to OFWs and their families endorsed by DMW based on the skills priorities.

TESDA shall also conduct language and culture training for the outbound OFWs; implement the Overseas Scholarship Program for OFWs while in their host country; conduct competency assessment for OFWs in the host country; and, conduct capabilitybuilding interventions for trainers and assessors endorsed by DMW.

For its part, the DMW shall advocate for training programs focused on

upskilling, re-skilling, and cross-skilling, including Competency Assessment and Certification; and, TESDA shall conduct identify, pre-evaluate, and orientations on TESDA recommend to TESDA eligible OFWs and their family members.

It shall also endorse to skills training, assessment, TESDA returning OFWs qualified to become trainers and/or assessors; identify, assess, and recommend technical vocational courses and training centers abroad that have the potential for conducting skills training programs; and, provide TESDA with labor market information.

"Let us continue working together to strengthen the competence of our OFWs, build a robust, agile, globally competitive, and world-ready, workforce, and improve the quality of life of the OFWs and their families," the TESDA chief said.

Meanwhile, for his part, Secretary Cacdac emphasized that the partnership will facilitate the delivery of skills and livelihood training to OFWs and their families as instructed by President Ferdinand "Bongbong" Marcos.

"Skills are the highest form of protection. The more skills equipped our workers are entering the host country, the better suited they are to integrate and protect themselves in the process," Secretary Cacdac said.

Also, in attendance during the signing ceremony were TESDA Deputy Directors General Rosanna Urdaneta, Vidal Villanueva III, Nelly Nita Dillera, and Felizardo Colambo, along with DMW Undersecretary Patricia Yvonne Caunan, Assistant Secretaries Francis Ron De Guzman and Venecio Legaspi.

Negros Occidental recovers control of official Facebook page

BACOLOD CITY -Negros Occidental's provincial government is strengthening the security protocol in its social media assets after recovering access to its official Facebook page on Wednesday, a day after it was hacked.

Charina Magallanes-Tan, head of the Public Information Office, said in an interview that losing access to the "Provincial Government of Negros Occidental" page was quite a scare and that she is glad they were able to regain control of it after sending a request to Meta, the owner and operator of Facebook.

"Meta responded to our request and restored access to the PIO. We will change the entire security protocol of the page. After this scare, it's just good, and we're fortunate that we got the page back," she added.

She said they have yet to know the identity of the hacker since another unit of Meta deals with the investigation.

Magallanes-Tan said they have also filed a complaint with the Department of Information and Communications Technology and the

Cybercrime Investigation and Coordinating Center to investigate the incident.

O n Tuesday morning, the "Provincial Government of Negros Occidental" Facebook page was compromised with unauthorized access and showed photos of half-naked women on its stories.

The page, which posts updates on the activities of Governor Eugenio Jose Lacson and the province, has 183,000 followers.

"Our Facebook page is

very important, especially now that there is a typhoon. We regularly post updates on it. The hacking really caused disruption in public service," Magallanes-Tan said.

A similar hacking incident was also experienced by the official Facebook page of former Negros Occidental 3rd District Rep. Jose Francisco Benitez last year, and the administrators were able to regain access to the page after two days.

ORDER

Petitioner, through counsel, filed a petition praying that after due notice and hearing, iudament by rendered ordering the defendants to deliver, produce and surrender the Owner's Duplicate Copy of Transfer Certificate of Title No.176,250, issued by the Register of Deeds of the Province of Iloilo and directing the entry of a new certificate or memorandum upon such surrender; and/or in case the defendants refuse to [do] so, the issuance of order to surrender the owner's duplicate copy, and, in the event that the respondents fail or refuse to surrender TCT No. T-176,250, declaring the Owner's Duplicate Copy of Transfer Certificate of Title No.176,250 issued by the Register of Deeds of the Province of Iloilo as null and void; and ordering the issuance of a new certificate of title in lieu thereof, should the defendants refuse to deliver the said title.

In the Order dated April 3, 2023 (Exhibit "B"), the Court set the petition for hearing on June 27, 2023 at 8:30 o'clock in the morning so that any person who may have an interest in the petition may appears and show adverse cause, if any, to the granting of the Petition. As directed, the Order was posted in three (3) conspicuous places as shown in the Certificate of Posting (Exh. "C") issued by the court sheriff. The order, together with a copy of the petition was furnished to the respondents- spouses and the Register of Deeds of the Province of Iloilo. However, copy of the petition and Order of the Honorable Court dated April 3, 2023 furnished to the private respondents through registered mail were unsuccessful, due to insufficient/ no-existing address.

The court subsequently issued a resolution on February 26, 2024 granting the Motion for Leave of Court to Serve Summons by Publication. An Amended Order for Publication was thereafter issued setting the initial hearing to June 13, 2024 at 8:30 o'clock in the morning.

During the initial hearing, no opposition on record, as well as, in court was interposed, despite the posting and notice to the Register of Deeds for the Province of Iloilo. Petitioner, having introduced evidence to prove jurisdictional facts, was allowed to present evidence to prove the merits of this petition before the Branch Clerk of Court.

Witness Trixie Ann M. Quiambao, 42 years old, married and a resident of Rizal Estanzuela St., Iloilo City and Liaison Officer, testified that: she is the authorized representative of the petitioners in this case as evidenced by a Special Power of Attorney executed by the petitioners in her favour; the spouses asked her to help them regarding their Barotac Viejo property, known as Lot No. 7021, Barotac Viejo cadastre, covered by Transfer Certificate of Title No. T-170,250 as they could not personally attend to it at the moment because they are currently based in the United States of America, working as nurses, and they wanted to have the said lot registered in their name; respondents-spouses Antonio Biona and Chelita Lou Biona bought the Lot No. 7021 from the Rural Bank of Pavia (Iloilo), Inc. by virtue of the Deed of Absolute Sale on June 23, 2003 and afterwards, the petitioners bought the said lot from the respondents under a pacto de retro sale on April 7, 2004; spouses Biona failed to repurchase the same from the spouses-petitioners; petitioners-spouses filed a Petition for consolidation of title on November 17, 2004 before the Regional Trial Court of lloilo Branch 31 which the court decided in their favor by directing the Register of Deeds to transfer the ownership of Lot No. 7021 in the name of spouses Cortez; the petitioners failed to transfer the registration of the property in their names because the respondents failed to surrender the original copy of the Owner's Duplicate Copy of the certificate of title to the petitioners; she tried to contact the respondents but was not able to reach them; and, petitioners are praying that the honourable court orders the respondents to deliver, produce and surrender the Owner's Duplicate Copy of Transfer Certificate of Title No. T-176,250 issued by the Register of Deeds of the Province of Iloilo and direct the entry of a new certificate or memorandum upon such surrender, and/or declare the Owner's Duplicate Copy of Transfer Certificate of Title T-176,250 issued by the Registry of Deeds of the Province of Iloilo as null and void, and direct the issuance of a new certificate of title should the respondents refuse to deliver the said title.

Second and final witness, Ma. Eden C. Callosa, of legal age, married, and a resident of Lopez Jaena St., Lapaz, Iloilo City testified that: she is the authorized representative of the petitioners in this case as evidenced by a Special Power of Attorney executed by the petitioners in her favour; she is the sister of co-petitioner Irwin Cortez and the sister-in-law of co- petitioners Sigrid Cortez; they both asked her for help regarding their Barotac Viejo property, known as Lot No. 7021, Barotac Viejo cadastre, covered by Transfer Certificate of Title No. T-170,250 as they could not personally attend to it at the moment because they are currently based in the United States of America, working as nurses, and they wanted to have the said lot registered in their name; respondents-spouses Antonio Biona and Chelita Lou Biona bought the Lot No. 7021 from the Rural Bank of Pavia (Iloilo), Inc. virtue of Deed of Absolute Sale on June 23, 2003 and afterwards, the petitioners bought the said lot from the

respondents under a pacto de retro sale on April 7, 2004; respondents-spouses Biona failed to repurchase the said lot from the spouses-petitioners; petitioners-spouses filed a Petition for consolidation of title on November 17, 2004 before the Regional Trial Court of Iloilo Branch 31 which the court decided in their favor by directing the Register of Deeds to transfer the ownership of Lot No. 7021 in the name of spouses Cortez; the petitioners failed to transfer the registration of the property in their names because the respondents failed to provide the petitioners the original copy of the Owner's Duplicate Copy of the certificate of title; her brother instructed her to try to get in touch with the respondents Biona but she was not able to reach them; and, the petitioners are praying that the honourable court orders the respondents to deliver, produce and surrender the Owner's Duplicate Copy of Transfer Certificate of Title No. T-176,250, issued by the Register of Deeds of the Province of Iloilo and direct the entry of a new certificate or memorandum upon such surrender, and/or declare the Owner's Duplicate Copy of Transfer Certificate of Title T-176,250 issued by the Registry of Deeds of the Province of Iloilo as null and void, and direct the issuance of a new certificate of title should the respondents refuse to deliver the said title.

The government prosecutor actively participated in the proceedings and the Register of Deeds of the Province of Iloilo, despite notice, did not interpose any objection. The respondents did not participate in the proceedings nor surrender the title in the course of the hearings.

Sec. 107 of P.D. No. 1529 provides the proper remedy when an owner's duplicate certificate of title is being withheld by another person, viz.:

Sec. 107. Surrender of withheld duplicate certificates. Where it is necessary to issue a new certificate of title pursuant to any involuntary instrument which divests the title of the registered owner against his consent or where a voluntary instrument cannot be registered by reason of the refusal or failure of the holder to surrender the owner's duplicate certificate of title, the party in interest may file a petition in court to compel surrender of the same to the Register of Deeds. The court, after hearing, may order the registered owner or any person withholding the duplicate certificate to surrender the same, and direct the entry of a new certificate or memorandum upon such surrender. If the person withholding the duplicate certificate is not amenable to the process of the court, or if for any reason the outstanding owner's duplicate certificate cannot be delivered, the court may order the annulment of the same as well as the issuance of a new certificate of title in lieu thereof. Such new certificate and all duplicates thereof shall contain a memorandum of the annulment of the outstanding duplicate. (emphasis supplied)

In a similar case where the holder of the title defied the directive of the lower court requiring her to surrender the owner's duplicate certificate of title, the Supreme Court held that the owner's duplicate certificate of title in her possession should have no force and effect. The court emphasized that the person ordered by the court to surrender possession of the owner's duplicate certificate of title "cannot simply disregard the directive without any consequences under Sec. 107 of P.D. No. 1529.

In this case, there was a previous petition for consolidation of ownership in pacto de retro, Special Civil Action No. 04-28365 filed before Regional Trial Court Branch 31 filed by the same petitioners, spouses Irwin Cortez and Sigrid Cortez. In the Decision dated June 24, 2005, penned by Hon. Rene S. Hortillo, the validity and due execution of the Deed of Absolute Sale in favor of the spouses-petitioners and directed the Register of Deeds, Province of Iloilo to Transfer Ownership of Lot No. 7021 in the name of the spouses-petitioners and to issue a new Certificate of Title in their names after payment of the required legal fees.

Considering that despite the decision of RTC Branch 31 that was issued almost twenty (20) years ago, the respondents still refused or have not yet surrendered the title to the petitioners, this court must apply the provision in Section 107 of PD 1529.

WHEREFORE, the petition is hereby **GRANTED**, The Court orders:

- 1. Respondents to produce, deliver and surrender the Owner's Duplicate Copy of Transfer Certificate of Title No. No. T-176,250 within thirty (30) days after the date of publication, and for the petitioner to publish this Order once in a newspaper of general circulation in the Province of Iloilo accredited by this court at their expense;
- 2. The Register of Deeds of the Province of Iloilo to make an entry of a new certificate or memorandum upon such surrender; and
- 3. In the event that the respondents fail or refuse to produce, deliver and surrender the said owner's certificate within the period of thirty (30) days, the said Owner's Duplicate Copy of Transfer Certificate of Title No. T-176,250 is declared NULL and VOID and the Register of Deeds of the Province of Iloilo is ordered to issue a NEW Certificate of Title in lieu thereof. Such new certificate of title shall contain a Memorandum of the annulment of the outstanding certificate.

Furnish copies of the Order to the petitioners and their counsel, respondents and the Registry of Deeds of the Province of Iloilo.

The Clerk of Court of the Office of the Clerk of Court (OCC) of Barotac Viejo, Iloilo is hereby ordered to release the unspent amount in the Sheriff's Trust Fund (STF) account, if any, in compliance with the OCA Circular No. 63A-2022

Electronics exports to rebound in 2025: SEIPI

MANILA – The export of electronic products is expected to rebound in 2025, the Semiconductor and Electronics Industries in the Philippines Foundation, Inc. (SEIPI) said on Thursday.

SEIPI President Dan Lachica told reporters at the sidelines of the 13th Arangkada Philippines Forum in Pasay that SEIPI is projecting a 5-percent growth in electronics exports next year.

This will be a turnaround from the projected 10-percent contraction in electronics exports this year.

Last year, exports of electronic products amounted to USD41.91 billion.

Lachica said inventory correction and new expansion will help boost exports growth next year.

"Well, like I said before, the inventory correction. we're working on that and hopefully again with the initiatives of the government to promote investments, we're looking for new products, new expansions for the coming year," he said.

Preliminary data from the Philippine Statistics Authority showed that exports of electronic products amounted to USD27.4 billion in January to August this year, up by 1 percent from the USD27.18 billion in the same period last year. (PNA)

Jan.-Sept. budget deficit narrows by 1.35%

MANILA – The national government's budget deficit narrowed from January to September this year, data from the Bureau of the Treasury (BTr) showed.

In its latest cash operations report released on Thursday, the BTr said the budget deficit during the period went down by 1.35 percent to PHP970.2 billion from the PHP983.5 billion logged in January to September last year.

The government incurs a budget deficit when spending exceeds its revenues.

"The total deficit for the first three quarters was 9.08 percent short of the PHP1.1 trillion program for the nine-month period and is at 65.36 percent of the PHP1.5 trillion revised full-year program," the BTr said.

Revenue collection went

up to PHP3.3 trillion, 16.04 percent higher than the PHP2.8 trillion collection in 2023.

The revenue collection during the period was also PHP142.8 billion ahead of the January to September program.

Of the total collection, taxes collected by the Bureau of Internal Revenue (BIR), Bureau of Customs (BOC), and other offices accounted for about 85.39 percent or PHP2.8 trillion, up by 10.62 percent year on year.

The remaining 14.61 percent or PHP481.1 billion, were non-tax revenues, which grew by 62.54

Spending, meanwhile, reached PHP4.3 trillion, higher by 11.56 percent, leading to a PHP46 billion overperformance compared

MANILA — Tojo Motors Corp., a local electric vehicle (EV) "fabricator", has received close to 1,000 orders of EV units for public utility vehicle (PUV) modernization.

On the sidelines of the 12th Philippine Electric Vehicle Summit (PEVS) in Pasay City on Thursday, Tojo Motors chief executive officer Ralph Legaspi said the company would need additional capital to boost its capacity to meet the growing demand driven by the government's PUV Modernization Program.

A Laguna-based EV fabricator, which designs, fabricates, manufactures, and assembles the EV unit, Tojo Motors is expected to deliver 576 units for the transport cooperative servicing Makati-Manila area, 150 units for Novaliches-Malinta route, 120 units for Blumentritt-Baclaran route, and 120 units in Calamba area.

Legaspi said these orders are Class 2 fourwheeler EVs.

Revenue collection for September climbed to PHP299.7 billion, outperforming the previous year's outturn by 17.32 percent.

BIR collections for September improved to PHP174.7 billion, 14.79 percent higher than last

"This is attributed to higher personal income tax (PIT), particularly on withholding on wages due to the release of salary differentials of civilian government personnel pursuant to Executive Order No. 64, series of 20242, which updated from the Salary Standardization Law (SSL) of 2019," the BTr said.

This is followed by higher collections from documentary stamp tax.

Collections by the BOC, however, slid by 3.31 percent to PHP76.3 billion in September due to doubledigit negative growth in import duties, partly due to tariff reduction of some commodities.

"Also, the decline is due to an alarming increase in smuggling activities within the year, as the current amount of the BOC's seized goods has already surpassed their total haul in 2023," the bureau said.

Total expenditures for September, on the other hand, grew by 13.15 percent to PHP572.9 billion from PHP506.3 billion a year

The BTr said the increase was due to non-interest expenses, particularly due to the implementation of capital outlay projects of the Department of Public Works and Highways, larger personnel services expenditures due to the implementation of the first tranche of salary adjustments of qualified civilian government employees, as well as the payments for health emergency allowance claims of health care workers.
