

## Iloilo-Antique road project aims to entice more tourists

SAN JOSE DE BUENAVISTA, Antique - The completion of the paving of a 1.3-kilometer road from Tubungan, Iloilo to San Remigio, Antique will entice more tourists to visit the so-called "Little Baguio" of the province.

San Remigio Mayor Margarito Mission Jr. said in an interview that the road will reduce by half the current three-hour travel to Aningalan from Iloilo City.

Aningalan, about six kilometers away from Tubungan, is one of the premier tourism destinations in Antique because of its cool climate and picturesque mountain sceneries.

"The 1.3 kilometers remaining unpaved road portion is on the side of Iloilo province, so it will be the Department of Public Works and Highways (DPWH) First District Engineering Office that will implement the road completion," Mission said.

He said Senator Loren by summertime when Legarda already sourced a PHP50 million budget for the engineering office to implement the project.

Meanwhile, Mission said that the DPWH Antique District Engineering Office is repairing the road depressions from the town proper of San Remigio to Barangay Aningalan with a budget of PHP109 million and an additional PHP28 million for the bridge construction.

"I hope that the road repair and bridge construction can already be finished

there would be an influx of tourists," Mission said.

He added that he requested an additional PHP60 million from Tourism Secretary Christina Garcia Frasco for the construction of an event place to host weddings and other important activities during the groundbreaking of the Tourists Rest Area (TRA) on Thursday.

"I requested the event place under Phase 2 of the TRA based on our tourism plan," Mission said.

# Guimaras' 2023 economic growth reach 7.9%

The economic growth in the province of Guimaras has reached 7.9 percent, equivalent to Php17.42 billion for 2023, with an increase of Php 1.28 billion from its 2022 GDP of Php16.14 billion.

This was presented during the 2023 Economic Performance in Province of Guimaras Forum spearheaded by Philippine Statistics Authority (PSA)-Guimaras last November 26 at District 21 Hotel in Mandurriao, Iloilo City.

Contributing to the said growth was Accommodation and Services which is one of the major industries with a 55.2 percent share to the total gross domestic product

(GDP) of the province while the two other industries that also contributed were Agriculture, Forestry, and Fishing with 29.0 percent; and Industry with 15.8 percent.

Guimaras Province also topped among the provinces and cities of Western Visayas in 2023 in terms of growth rate in performance of services with 12.4 percent.

On the other hand, the top three industries with the largest contribution to the GDP growth of Guimaras include:

\* Wholesale and retail trade; repair of motor vehicles and motorcycles - 2.2 %

\* Public administration and defense; compulsory social security - 1.1%

# **ERC Clears MORE Power's Enhanced Net Metering Initiatives**

towards promoting renewable energy in the Philippines, MORE Electric and Power Corporation (MORE Power) has taken proactive steps to enhance its Net-Metering and Distributed Energy Resources (DER) initiatives. On November 11, 2024, MORE Power submitted a letter to the Energy

IN a significant move Regulatory Commission in Iloilo City but also (ERC) requesting the consolidation of Net-Metering and DER Certificate of Compliance (COC) applications at its Customer Care Office in Iloilo City.

"This initiative aims to simplify the application process for consumers interested in renewable energy solutions, not only

extending to Central Negros and Tagbilaran City," said Roel Z. Castro, President and CEO of MORE Power.

The ERC has responded favorably, agreeing to consolidating applications at the Iloilo Office, where it will maintain a monthly schedule. This arrangement allows authorized ERC representatives to assess

applications on-site, expediting the issuance of Statements of Account for submissions from MORE Power, as well as from Negros Electric and Power Corporation (NEPC) and Bohol Light Company Inc. (BLCI). This "One-Stop-Shop" approach is designed to make the application process more accessible and efficient for consumers.

ERC Chairperson Monalisa Dimalanta commended MORE Power's proactive measures, stating, "The Commission appreciates MORE's initiative in further streamlining the processing of Net Metering and DER applications".

This collaboration underscores a shared commitment to enhancing renewable energy adoption in Iloilo City, positioning it as a model for other local government units (LGUs) nationwide."We look forward to more DUs supporting these prosumer programs towards the realization of energy democracy," Chairperson Dimalanta added.

The partnership between MORE Power and the ERC is not new; it builds on previous agreements aimed at promoting renewable energy technologies. In August 2023, MORE Power signed a tripartite agreement with the ERC and the Iloilo City government to establish a one-stop shop for renewable energy technologies. This agreement has already resulted in the issuance of Certificates of Compliance to 33 qualified net metering customers. The total installed capacity to date is 4,336 kW with a total of 172,997 kWh generated in October 2024.

Mayor Jerry Treñas of Iloilo City highlighted the broader implications of this partnership, stating that it aligns with national sustainability targets and encourages green practices among residents. The initiative not only promotes environmental sustainability but also aims to reduce electricity costs for households and small businesses.

Meanwhile, Bacolod City Mayor Albee Benitez expressed his support, highlighting, "I commend Roel Castro of MORE/ Negros Power for his initiative to streamline the application process for Net Metering and Distributed Energy Resources through the one-stop shop of Energy Regulatory Commission. This paves the way for greater accessibility to renewable energy solutions for our community".

As part of this collaboration, the ERC will provide technical and regulatory expertise to streamline documentary submissions, installation processes, payment procedures, and permitting associated with Net-Metering and DER. Additionally, the ERC in partnership with MORE Power, plans to conduct information drives to raise awareness about renewable energy benefits among electricity consumers in Iloilo, Central Negros and Tagbilaran City.

The partnership between MORE Power and the ERC is set to significantly enhance renewable energy adoption in the Visayas by streamlining access to Net-Metering and Distributed Energy Resources (DER). This initiative not only reflects MORE Power's commitment to sustainability but also serves as a model for other local government units to follow. By making renewable energy technologies more accessible, the collaboration aims to reduce greenhouse gas emissions and lower electricity costs for households and small businesses.

As this initiative unfolds, stakeholders are optimistic about its potential to foster a culture of sustainability in the Visayas. The combined efforts of MORE Power, the ERC, and the local government will provide practical solutions that empower residents to engage in energy conservation while supporting local economic growth through cleaner energy technologies.



# DOT chief Frasco breaks ground Antique TRA

Tourism (DOT) reinforced its commitment to sustainable tourism with the groundbreaking of the province's first Tourist Rest Area (TRA) on Thursday (Nov. 21) in Brgy. Aningalan, San Remigio, Antique.

The Tourism Infrastructure and Enterprise Authority (TIEZA) will oversee construction and funding, the local government unit (LGU) will manage and maintain the facility, and the DOT will monitor compliance with sustainability guidelines.

Secretary Frasco presented a scale model of the TRA to San Remigio Mayor Margarito Mission Jr. and Congressman Antonio AgapitoLegardaJr., symbolizing the collaborative effort to bring sustainable tourism infrastructure to Antique.

San Remigio Mayor Margarito Mission Jr. expressed his gratitude, calling the project a historic first for the municipality. "This is a historic moment for our town. For the first time in

169 years, we are honored by the visit of a Secretary—the alter ego of our President. Secretary, maraming, maramingsalamat," the mayor said. It has been 15 years since 58 individuals were slaughtered in what is now known as the Maguindanao Massacre in Ampatuan town in Maguindanao. The exact anniversary was last Saturday, November 23. On this day, a mix of family members, political

supporters, media workers and even bystanders were were killed for being part of a convoy for the filing of the certificate of candidacy by the then-incumbent local executive's political opponent.

There was nothing accidental in the grim turn of events. The manner in which the killings were conducted was unprecedented. Premeditation was established by the courts in a decision handed down in 2019, a full ten years after the tragedy.

Justice was neither swift nor perfect — it others, feeling like god, is a trait that remains rarely is. Some of the accused were never made to account for their participation. The patriarch of the Ampatuan clan died while the case was pending. There remains one casualty whom the court has refused to recognize just because his body has never been found.

The wrath of the reigning family at that time knew no bounds. They could not believe anybody would have the compunction to challenge them. Their rage moved them to do what was previously unthinkable even in a place where violence and clan rivalry were commonplace.

### A leap forward

### Towards a safe Philippines for children

"Each day of our lives, we make deposits in the memory banks of our children," wrote Charles R. Swindoll.

But how can we make meaningful deposits in these memory banks when violence against children remains alarmingly prevalent in the Philippines? According to the United Nations Children's Fund (UNICEF), nearly 8 in 10 Filipino children have experienced some form of violence —whether at home, in school, or within their communities. This grim reality persists despite the passage of numerous laws and the implementation of various programs aimed at safeguarding children's welfare.

This troubling fact calls for deep reflection as the Philippines celebrates National Children's Month (NCM) this November. The celebration commemorates the adoption of the Convention on the Rights of the Child (CRC) by the United Nations General Assembly in November 1989. The Philippines ratified the CRC in August 1990, just nine months after its adoption, affirming the country's commitment to recognizing and upholding the rights of individuals under the age of 18, as enshrined in the convention.

This year's NCM theme, "Break the Prevalence, End the Violence: Protecting Children, Creating a Safe Philippines," highlights the urgent need to address the pervasive violence that endangers Filipino children. It calls on all Filipinos to take collective action to dismantle the structures and conditions that perpetuate such abuse and neglect. The theme emphasizes both the urgency of the issue and the shared responsibility to protect children from harm.

Physical abuse, sexual exploitation, online sexual abuse, neglect, and bullying mar many Filipino children's daily lives. These experiences are more than individual tragedies; they reflect systemic failures to ensure children's safety and well-being. This year's theme clearly challenges us to build a society where children can grow and thrive fearlessly, surrounded by love, respect, and protection.

The impact of violence on children extends far beyond immediate physical harm, leaving emotional and psychological scars that can hinder their development and overall well-being. Victims are more likely to suffer from mental health issues such as depression, experience educational setbacks, and become vulnerable to further exploitation.

The rise of digital platforms has introduced alarming new risks. Online sexual exploitation of children (OSEC) has identified the Philippines as a global hotspot, with abuse broadcasting to victims as young as 2 years old. Poverty, inadequate parental supervision, and a growing global demand for exploitative materials fuel this disturbing trend.

UNICEF reported that online sexual abuse and exploitation of 2 million Filipino children occurred in 2021 alone. They groomed and coerced many of these children, often luring them with promises of gifts or money in exchange for performing sexual acts. They further threatened or blackmailed some of these children into compliance, trapping them in a cycle of abuse and fear.

Efforts to combat OSEC have led to numerous arrests in the Philippines and abroad. A particularly shocking case involved a graphic artist who had worked for Pixar and Disney, producers of computer-animated movies loved by children. In 2023, a French court sentenced him to 25 years in prison for ordering livestreamed sexual assaults on preteen girls in the Philippines. The court found him guilty of complicity in the rape of hundreds of girls, human trafficking, and accessing child pornography. Such cases highlight the horrific scale and complexity of crimes targeting Filipino children, leaving many to grapple with the sheer extent of this exploitation.

Financial desperation often leads families to rationalize or even participate in these exploitative acts, with OSEC being particularly pervasive. The high demand for exploitative materials and the lure of quick financial gain turn vulnerable children into commodities. This tragic cycle underscores how poverty not only strips families of financial stability but also erodes moral boundaries, leaving countless children at risk.

Addressing this crisis requires a multifaceted approach. Strict law enforcement is essential to dismantle trafficking networks and hold perpetrators accountable. At the same time, there must be meaningful efforts to alleviate poverty, empower families with sustainable livelihood programs, and educate communities about the profound and lifelong harm caused by such

exploitation. Only by addressing the root causes can the Philippines protect its children from falling victim to these horrific crimes.

Today, less people see reading books as a top choice for among leisure activities. As such, several academicians have suggested that it is time to promote programs that put fun back in reading. One such program is allowing comic books and other forms of fantasy literature to become staple reading materials in schools. Once sneered at by stiff leaders of academe as an improper form of

- 1. Plaintiff is a sovereign entity to whom all lands of the public domain belong represented by the Regional Director of Department of Environment and Natural Resources (DENR), JIM O. SAMPULNA, where it may be served with judicial processes through the Office of the Regional Director, Department of Environment and Natural Resources (DENR) Regional Office VI, Pepita Aquino Avenue, Port Area, Iloilo City, Philippines;
- 2. Defendant **NELCRIS TILLO** is of legal age, Filipino, single and a resident of Brgy. Alipata, Sicogon Island, Carles, Iloilo where he may be served with summons and other court processes;
- 3. Defendant Register of Deeds, Province of Iloilo holds office at the Office of the Registry of Deeds, Province of Iloilo, LRA Building, Iloilo City, where he/ she may be served with summons and other court processes. That, on the basis of the Free Patent Application of defendant Nelcris Tillo over a parcel of land surveyed as Lot No. 4752, Cad. 478-D, identical to Lot No. 6, GSS-06-000247 with an area of more or less 4.9630 hectares, situated in Barangay Alipata, Sicogon Island, Carles, Iloilo, and upon his representation that he is entitled to a free patent grant over the said lot, then Provincial Environment and Natural Resources Officer (PENRO) of Iloilo, Valentin P. Talabero, approved the said application and issued Free Patent No. 063014-10-18940 on December 29, 2010;
- 6. That the aforesaid patent was transmitted to the Register of Deeds of the Province of Iloilo for registration and issuance of certificate of title. Consequently, Original Cerificate of Title (OCT) No. 2011000167 was issued in favor of defendant Nelcris Tillo. Photocopy of OCT No. 2011000167 is hereto attached and marked as Annex "B" and made an integral part hereof;
- 7. That upon subsequent investigation and conduct of verification survey by the Department of Environment and Natural Resources (DENR), it was found out that the land covered by OCT No. 2011000296 overlapped with a titled parcel of land covered by Psu-5511 and was already issued a Decree No. 121734 on March 17, 1921 and pursuant thereto Original Certificate of

Title No. 21418 was issued which title was eventually transferred to Sicogon Development Corporation (SIDECO) under Transfer Certificate of Title No. T-80191, thus, the subject land is already considered as private property over which the DENR-CENRO Office-Sara no longer has jurisdiction to issue a free patent title. Copy of the Verification Survey dated June 18, 2014 and Transfer Certificate of Title No, T-80191 are hereto attached and marked as ANNEX "C" and "D" and made an integral part hereof;

8. That the decree of registration withdraws the land from the mass of public domain and making it a private property of the person or entity that first caused the registration.

Second paragraph of Section 31 of PD 1529 provides:

"The decree of registration shall bind the land and quite title thereto, subject only to such exceptions or liens as may be provided by law. It shall be conclusive upon and against all persons, including the National Government and all branches thereof, whether mentioned by name in the application or notice, the same being included in the general description "To all whom it may concern".

Likewise, jurisprudence dictates:

"Private ownership of land is not affected by issuance of the Free Patent over the same land because the Public Land Law applies only to lands of public domain. Only public land may be disposed by the Director. Since as early as 1920, the land in dispute was already under the private ownership of herein petitioner and no longer part of the lands of the public domain, the same could not have been the subject of the patent. The patentee and his successorsin-interest acquired no right to title the lands." Xxxx1

The Supreme Court further ruled:

- "The Director of Lands has no authority to grant free patent for land that has ceased to be a public land and has passed to private ownership and a title so issued is null and void"xxx2
- 9. That defendant did not have an absolute title to the property nor any imperfect or incomplete title which can be registered under Act 496 and C.A. 141, otherwise known as the Land Registration Act and the Public Land Act, respectively, in as much as the subject land has already been issued a title and the same has been a private property as early as 1921;
- 10. The foregoing findings show that OCT No. 2011000167 was erroneously issued in favour of defendant Nelcris Tillo as the land covered by his title can no longer be disposed of by Free Patent mode under the Public Land Act (CA 141);
- 11. All told, Free Patent No. 063014-10-18940 and OCT No. 2011000167 as well as any and all titles derived therefrom are, therefore, NULL AND VOID AB INITIO;

#### **PRAYER**

WHEREFORE, it is respectfully prayed that after trial, judgment be rendered by this Honourable Court in favour of herein plaintiff as follows:

- 1. Declare Free Patent No. 063014-10-18940 and OCT No. 2011000167 in the name of Nelcris Tillo and all subsequent certificates of title emanating therefrom, null and void ab initio:



"As of now, in our 42 municipalities and one component city composed of 1,721 barangays, we have already established 102 teen centers. In the 2.0 version, the building is a separate structure worth PHP3.5 million each," said PPO head lawyer Ruel Von Superio, in an interview on Wednesday.

The new version will have a lounge area, counseling room and activity area, Guidance Office and Teen Center Coordinator Office, a toilet, and a pantry.

The centers will house the Career Guidance and Counseling Program and the Voter's Education Program initiatives of Governor Arthur Defensor Jr. under his Bulig Eskwela sang Probinsya (Bes Probins) Program.

# **Educational heritage building in Iloilo restored**

ILOILO CITY – The fully restored Quezon Hall or Bulwagang Quezon of the West Visayas State University (WVSU) in Iloilo City's La Paz district was reopened Wednesday afternoon.

Restoration works included preserving original wooden moldings, repairing concrete and steel elements, restoring stairs, balusters, arcs, and columns, repainting architectural features and conducting roof restoration to maintain the hall's historical character while ensuring its functional integrity.

tegrity. WVSU President Dr. Joselito Villaruz said the Henry Sy Foundation and SM Foundation are ideal partners for the restoration project because of their targeted social investments in education and drive for preserving Filipino heritage, including architectural landmarks.

"Most important in the Quezon Hall project is the value of connecting healthy buildings and structures to an enhanced learning and working environment that goes a long way in making strides towards long-term educational investments," Villaruz said
