determined if they manifest fever; rashes on hands, feet, or other body parts; and mouth ulcers which could lead to loss of appetite.

Hortinela also cited that the transfer of HFMD can be through the secretions of nasal mucus, saliva. She added that the transmission can be first detected at the mouth but not necessarily as it may vary and either can be detected in other body parts such as the hands or feet.

In addition, City Health Officer Dr. Annabelle Tang urged that schools should also enforce proper hygiene such as regular handwashing and monitor students for HFMD symptoms to prevent the spread of the disease.

The CHO stressed the significance of consulting health centers and reporting suspected HFMD cases for proper monitoring, urging private medical professionals to report cases for a better tracking.

provisions on non-impairment of contracts, due process, and equal protection, as well as existing laws safeguarding their exclusive rights under the National Electrification Administration (NEA) Decree and the Electric Power Industry Reform Act of 2001 (EPIRA).

However, the Supreme Court, in a decision penned by Associate Justice Rodil Zalameda, ruled that exclusive franchises are not constitutionally protected. The Court emphasized that public utilities must serve the public interest, and competition could improve services and lower electricity rates.

The decision reaffirmed the government's authority to prioritize public welfare over contractual obligations, citing the principle of police power as superior to property rights. The Court referenced its ruling in Carlos Superdrug Corp. vs. Department of Social Welfare and Development, where it held that even constitutionally protected rights could be regulated in the interest of the common good.

The Court also denied the intervention of the Philippine Rural Electric Cooperatives Association (PHILRECA), which argued that the expansion undermined the exclusive rights of electric cooperatives. The Court found cater to the psychosocial needs and development of teenagers. (Capitol photo)

# 'Rocky Mountain' homes

Approximately 800 of the country's richest and most influential business owners are facing the possibility of finding their "home sweet home" in Camp John Hay turn into Rocky Mountain homes if they are forced to renegotiate the lease or cost of ownership of their luxury cottages.

The BCDA already announced last week that the Supreme Court has stood by its decision for the John Hay Development Corp. (DEVCO) to return the property to the BCDA and for the BCDA to return the money of JH-DEVCO because both parties were in violation of contract.

The problem is that the SC decision, which has not been readily available to the public, was allegedly not as detailed in terms of how things are supposed to be done.

For instance, DEVCO had sold about 800 luxury cottages when they started the project and the 800 owners who represent the top corporations, CEOsbosses and families were all buyers in good faith. JH-DEVCO was likewise a seller in good faith. So how do you tell the country's richest and powerful groups that they may be evicted or will now have to renegotiate with the BCDA?

Does the Supreme Court expect JH-DEVCO to return the investments of those homeowners, minus the years of use or ownership?

The BCDA has actually come out with newspaper ads advising the owners to contact the BCDA, obviously to be informed that there is now a new landlord and that the rent or lease or terms will have to change, and they better bring their fat check books or be ready to arrange bank transfers.

The second complication involves compensation for JH-DEVCO. Will the BCDA give back only the bid payment of JH-DEVCO or are they also bound by the SC decision to pay back all the expenses made by the corporation as they developed properties and hotels, etc? Will that include the refund to homeowners if JH-DEVCO has to return payment?

Third, where will BCDA get the money to give back JH-DEVCO, given that the BCDA is not exactly rolling in cash and receivables? Will the BCDA be required to make payment on the court's timetable or will it be a case of "pay when able?"

While all these headaches are swirling around, what the public has not heard are credible claims that certain people in government, particularly Malacañang, had a hand in the matter. Someone from Padre Faura confirmed what a friend from Baguio called as an unusual interest for the government to get back John Hay.

Exactly who in Malacañang has a special interest, and why, is now the subject of silent whispers. Is it simply a case of the government wanting to get a better deal or getting more? Will the renegotiation of 800 homes turn into a "networking opportunity" to win favor from the private sector? Or is there a group with a particular interest in the properties?

After the decision was handed down with finality, my sources claim that the BCDA was advised-instructed "by Malacañang" to issue eviction notices to the current owners of the luxury cottages. The idea, I presume, was to establish the government's claim as well as shake up the current owners to make them more amenable to the renegotiation.

Fortunately, the BCDA officials opted to follow proper protocol by issuing public notices before sending out eviction notices, which remains a touchy matter given the social status and legal standing of the 800 homeowners. The question now is, why was someone in Malacañang so hands on during the hearings at the Supreme Court and the post judgment actions of the BCDA?

Meanwhile, the decision of the Supreme Court and the can of worms the issue has opened leaves a serious tale of caution to would-be investors or buyers in government projects. In the Philippines, a simple change of government midway of your project can run you out of town or triple your cost or a 10-year court

battle to dislodge you.

You can be a seller or buyer in good faith but that is no legal guarantee of ownership. Contracts may stipulate the government's obligation, but all the delay and consequential cost of money or lost opportunities will force you to undertake the government's obligation. You could be well on your way when suddenly some mayor says stop because his campaign contributor asked him to realign a road, a highway or MRT nearer to his project.

Sadly, you cannot rely on the justice system either.

While studying the matter, I came to realize that unless you are the only game and player in town, working with government is as risky as playing in the casino or fighting in the cockpit.

While we all grew up believing that justice is done with eyes blindfolded, it is not necessarily inviolable for those in robes. They too are human, dependent or subject to a process designed by politicians and jurors and buttered by utang na loob or political pressure.

Starting from becoming a fiscal, an RTC judge, the Court of Appeals, a justice in the Supreme Court, all the way to Chief Justice, the procession to the halls and pillars require soliciting favor to get a seat, have a sala, endorsements, political backing, being part of a church, a cult or a fraternity to get the votes and ultimately the presidential signature.

Yes, they are men and women of merit, men and women of laws, but in the face of human reality, they too are subject to pressure. Their budgets are dependent on members of Congress, and in a nation fueled by "pakikisama," sometimes holding up the scales of justice becomes a burden and the balance tilts for those in power.

# Breakup year

The year 2024 will be remembered in our country Mindanao. for three things in politics in government. The first is the breakup of the UniTeam – unexpected only because it happened so soon.

The collapse of the 2022 winning coalition led to the second significant event - remarkable mainly because it would have been unthinkable in the previous administration: the Dutertes' loss of invincibility.

Scrutiny of fund utilization by the Dutertes led to the third noteworthy development of the year: heightened public awareness of the budgeting process and priorities of the Marcos administration and its allies.

BBM refused to return the budget bill to a reconvened bicameral conference, probably believing it would be an exercise in futility, with the "pork"-hungry epal lawmakers digging in their heels in an election year.

reputable pollster Social Weather Stations Inc. showed both President Marcos and Vice President Sara Duterte continuing to suffer declines in their trust ratings.

The question for the new year is what people are going to do about such developments.

As for the 2025 budget for pork and patronage (not progress), BBM made some token line item vetoes, but retained the funding priorities of his congressional allies. Meaning, lower appropriations for health, education, agriculture, social welfare, the conditional cash transfer and the Armed Forces modernization program, among others.

The P288.6 billion added by the bicam to the Department of Public Works and Highways' P825.11 billion budget in the National Expenditure Program (NEP) was slashed by BBM by a measly P26 billion - just enough to lower the total P1.1 trillion DPWH funding to a level slightly below the allocation for the entire education sector. This is the part that fulfills the Palace promise of making the 2025 compliant with the Constitution.

Administration officials had said Congress exercised its power of the purse, and BBM had limited power to moderate the congressional greed.

There is in fact something that the executive can do, to show who is the ultimate holder of the power of the purse: Malacañang can delay until after the elections the release of AKAP payouts, funding for unprogrammed pork appropriations and the DPWH projects that are not in the NEP submitted by the executive branch.

Gloria Macapagal Arroyo, during her presidency, wielded this executive power of the purse extensively, to bend Congress to her will.

If BBM allows the release ASAP of these questionable funds, in time for the election campaign, all the Palace sound and fury over the mangling of the 2025 national budget would signify nothing. BBM will just be another actor in the zarzuela of plunder that was foisted upon the Filipino people, complicit in the impounding of public funds for personal and partisan purposes.

On Rizal Day, BBM urged Filipinos to be catalysts for change. He should lead by example.

There are actions that can help correct the ills and make our country a better place. We can all play a role in this, building on the significant developments in the year just past.

May 2025 be a year of meaningful change for all!




Increased patrols and exercises have lately surged in the Palawan area, well within the country's 200mile exclusive economic zone.

Last weekend, the United States deployed a carrier strike group from the Indo-Pacific Command to the West Philippine Sea to conduct the first Maritime Cooperative Activity of 2025 with Filipino forces.

Officials said the activity on Jan. 17-18 included the guided missile frigate BRP Antonio Luna, the offshore patrol vessel BRP Andres Bonifacio, two FA50 fighter aircraft, and Philippine Air Force Search and Rescue assets.

Backing up the Filipino forces was a US aircraft carrier strike group centered around the USS Carl Vinson and its air group, escorted by the guided missile cruiser USS Princeton, destroyer USS Sterett, an MH-60 Seahawk helicopter, a V-22 Osprey helicopter, and two F/A-18 Super Hornet fighter bombers.

The two militaries conducted a Communications Check Exercise, Division Tactics/Officer of the Watch maneuver, a Photo Exercise, and Dissimilar Aircraft Combat Training, according to a news release from the Armed Forces of the Philippines.



# **Beyond the 2025 PH-US maritime activity**



The maritime cooperative activities demonstrate a "collective commitment to strengthening regional and international cooperation in support of a free and open Indo-Pacific," according to a news release by the US Navy.

China has responded to such activities between the two treaty allies in the South China Sea by increasing its patrols and exercises in the area, expressing the line the Philippines should adapt to this process.

Coincidentally, the first joint drills of 2025 took place only three days before Donald Trump, who has spoken little about the region as president-elect, returns to the White House which he occupied for four years from Jan. 2017.

The 78-year-old Trump has spoken to President Ferdinand Marcos Jr. via phone call and has met with the President's cousin, Philippine ambassador to the US Babes Romualdez, in person.

Certainly, there will be many phrasal verbs and

ripples from the increasing drills and exercises near the strategic international sea lane in the South China Sea.

What is concerning is the often intrusion of Chinese vessels, including Beijing's Coast Guard, in the West Philippine Sea, which clearly violates Philippines territory.

Washington has been on the right sail with its freedom of navigation operations in the South China Sea, while expressing support for an agreement on a binding code of conduct in the region, and expressing it will do what is necessary to assist the Philippines in the tension-filled South China Sea.

The activities in the West Philippine Sea are certain to have ripples as well in the Southeast Asian region, with the Philippines' co-member countries in the Association of Southeast Asian Nations keenly keeping their guard, and in East Asia, where China and the United States are astutely watching each other from the different wheelhouses of their ships.

As the Senate continues to deliberate on this matter, it is timely and crucial to highlight that passenger safety and the welfare of riders should be prioritized in regulatory discussions. Motorcycle taxis have rapidly increased on our public roads in recent years as an alternative solution to traffic woes and gaps in public transportation.

However, as with any quickly expanding industry, the growth of the MC taxi industry shows the heightened responsibility to ensure that safety standards are upheld and met for all stakeholders-passengers and riders alike.

For instance, during Senate deliberations on this matter, the issue of riders lacking the necessary professional licenses onboarded by a certain company was discussed-underscoring the need for stricter regulation and more rigorous screening. The Land Transportation Franchising and Regulatory Board (LTFRB) has since issued a warning to ride-hailing platform Angkas for allegedly onboarding some 100 riders lacking a professional driver's license.

A study by the International Transport Forum further highlighted the safety risks of motorcycle taxis, with

motorcycle riders.

Reports such as these only highlight the pressing need to regulate the MC taxi industry for the benefit of both passengers and riders alike. Our lawmakers and the LTFRB should immediately address gaps in the regulation of the MC industry to ensure that only qualified drivers are allowed to ferry passengers and that ride-hailing platforms are held responsible for upholding proper labor and safety standards.

It is incumbent upon all ride-hailing platformsincluding MC taxi companies—to check that their hired riders are equipped with proper professional licenses and provide appropriate safety training. Further, these companies should be strictly regulated to ensure adherence to labor standards so that riders are fairly treated and compensated.

Strict penalties should be implemented not only for riders with infractions but also for ride-hailing platforms that violate labor rules and allow unsafe practices.

The urgency of a regulatory framework for this cannot be overemphasized given the economic contributions of the transport network vehicle service (TNVS) sector-of which MC taxis form part. A 2023 study conducted by the Center for Research and Communication of the University of Asia & the Pacific showed that the TNVS and delivery sector contributed around PHP37 billion to PHP165.6 billion

to the country's gross domestic product (GDP) from 2019 to 2021.

To ensure that the MC taxi industry continues to contribute to our economy, our legislators and the LTFRB clearly need to work together to create a regulatory environment that empowers and ensures the welfare of all stakeholders-passengers, riders, and ride-hailing platforms. Such a regulatory framework should safeguard passenger safety, ensure the welfare of riders, and preserve the economic contributions of the MC taxi industry to our country's transportation sector.

Filipino commuters-the majority of whom are hardworking citizens-deserve nothing less than safe, affordable, and comfortable transportation options. Our government is responsible for providing an enabling environment for this.

And with more Filipinos using motorcycle taxis as an alternative transportation option, the government needs to ensure that this industry operates safely and responsibly. Only through strict enforcement of safety standards and labor rules can the MC taxi industry continue to become an active contributor to the economy in a way that serves the best interest of all stakeholders.

# Poverty, employment in PH – Unpacking the contradiction

In a nation boasting one of the lowest domestic helpers. unemployment rates in recent years, the rise of self-rated poverty to record-breaking levels presents a perplexing paradox. This is the reality the Philippines faces today. Recent data from two reputable sources-the Social Weather Stations (SWS) and the Philippine Statistics Authority (PSA)—underscore this striking contradiction, demanding closer examination and analysis.

Self-rated poverty, as reported by the SWS, surged to 63 percent in December 2024, marking the highest level since November 2003, which recorded 64 percent. For the entire year, the average self-rated poverty was 57 percent, a level not seen in over two decades. This data indicates that more than half of Filipino families perceive themselves as poor, raising alarms about the broader socioeconomic conditions in the country.

In contrast, the PSA reported a drop in the unemployment rate to 3.2 percent in November 2024, down from 3.9 percent in October. This translates to 1.66 million unemployed individuals, a significant decline from the previous month's 1.97 million. The numbers suggest a robust job market, theoretically providing stability and a pathway out of poverty for Filipino workers.

rated poverty and low unemployment highlights deeper systemic issues that employment statistics alone cannot capture.

The self-employed category includes individuals running small businesses such as sari-sari stores, balut and cigarette vendors, padyak drivers, ambulant vendors, and similar occupations. Familyoperated farms or businesses, like larger sari-sari store owners, often employ one or two underpaid workers.

Unpaid family workers refer to individuals, such as farmers and their family members, who assist on farms without receiving monetary compensation. This group also includes family members helping to manage sari-sari stores or small family businesses without remuneration for their labor.

It is important to note that these figures do not account for underemployment. As of September 2023, the underemployment rate-representing employed individuals seeking additional work or longer hours—rose to 11.9 percent from 10.7 percent, affecting approximately 5.94 million people.

The characteristic of Philippine employment is that while more Filipinos are technically employed, many are underemployed, working jobs that offer meager wages, lack security, or provide limited hours. The prevalence of informal sector work, However, the contradiction between high self- where benefits and fair compensation are often absent, exacerbates this issue. Thus, employment does not necessarily equate to financial stability or improved living conditions. The minimum wage in the Philippines is insufficient to meet the basic expenses of families. In the National Capital Region (NCR), the daily minimum wage is set at PHP645 for the non-agriculture sector and PHP608 for agriculture, service, or retail establishments with 15 or fewer employees, as well as manufacturing companies with fewer than 10 employees.

Even with employment, families struggle to meet their daily needs due to inflation, which erodes purchasing power. This disconnect between income and expenses fosters a perception of poverty despite job gains.

The country also unevenly distributes economic opportunities. Urban areas may enjoy better employment rates and higher wages, while rural communities often face limited job prospects and lower earnings. The national unemployment rate may mask these regional inequalities, leaving rural families more vulnerable to poverty.

Self-rated poverty may reflect subjective assessments of well-being, influenced by cultural expectations, aspirations, and relative comparisons. Even with employment, families may feel poor if they cannot afford what they perceive as basic necessities or if their living standards fall short of societal norms. Addressing this paradox requires a multifaceted approach. Beyond reducing unemployment, the government must focus on creating high-guality, wellpaying jobs, particularly in industries that can absorb a large labor force, such as manufacturing and agriculture. Expanding access to social safety nets, such as health insurance, education subsidies, and housing programs, can help bridge the gap between employment and financial security. Stabilizing prices through targeted interventions, such as subsidies for essential goods and services, can alleviate the financial burden on families. Investing in rural development, infrastructure, and local industries can mitigate regional disparities and promote a more equitable distribution of economic gains. The coexistence of low unemployment and high self-rated poverty in the Philippines underscores the complexity of economic well-being. Employment alone is not a panacea for poverty; the quality of jobs, the cost of living, and broader systemic issues play equally crucial roles. Policymakers must adopt a holistic approach to address these challenges and create a society where employment genuinely translates to prosperity for all Filipinos.

The government classifies employed individuals into four categories: wage and salary workers, selfemployed without any paid employees, employers in their own family-operated farms or businesses, and unpaid family workers.

Wage and salary workers are individuals employed in private households, private establishments, government agencies, or government-controlled corporations, or those earning a wage in their own family-operated farm or business. This category includes members of the Armed Forces of the Philippines (AFP), Philippine National Police (PNP), Bureau of Jail Management and Penology (BJMP), and Bureau of Fire Protection (BFP), making the government the largest employer in the country.

Workers in private households comprise maids/ domestic helpers, cooks, gardeners, drivers, and similar roles. For instance, domestic helpers are entitled to a minimum monthly salary of PHP6,000. On April 1, 2024, the Department of Labor and Employment (DOLE) raised the minimum wage for household workers in Central Luzon to PHP6,000, benefiting approximately 126,000 domestic workers, or kasambahay. A similar adjustment took effect in Eastern Visayas on Dec. 2, 2024, benefiting 57,080

Wages are significantly lower in other regions. For instance, the minimum daily wage in the Cordillera Administrative Region (CAR) is PHP470, while in Mimaropa, it ranges from PHP404 to PHP430.

The Ibon Foundation, an economic think tank, has advocated for a family living wage in the Philippines to address the economic needs of Filipino families. The family living wage refers to the income necessary to cover the cost of living, including all essential food and non-food expenses, with sufficient allowance for savings and investments to ensure social security.

As of December 2024, the Ibon Foundation reported that a family of five in the National Capital Region (NCR) requires a daily wage of PHP1,223 or PHP26,590 per month. The estimated daily living wage is slightly higher in other regions, at PHP1,227

Petitioner Jeff Anthony Geraldoy Larida is of legal age, Filipino, a resident of #56 Sta. Cruz, Arevalo, Iloilo City and married to the respondent. On the other hand, the respondent Maria Fatima Suero Fuentes is of legal age, married to the petitioner and is a resident of 17 Salazar Street, San Miguel, Iloilo.

The petitioner and the respondent knew each other sometime in 2016 through Facebook. The petitioner still communicated despite the strong personality of the respondent. Later when the petitioner asked her to be his girlfriend, the respondent agreed. The parties continued with their long-distance relationship. Early in their relationship, the couple always had quarrels. The petitioner is very sensitive and would often throw tantrums. On one hand, the petitioner is insensitive, unemphatic, and would often prioritize himself. Their frequent quarrel is primarily defined by their respective personalities and the respondent only thinks of herself the same is true with the petitioner.

period together which proved to be one of their most turbulent times and contributed to their eventual break-up. Even after resuming their separate work schedules and meeting annually in Iloilo, their attempts to rekindle their relationship during a 2022 vacation in Baguio City ended familiar arguments, reinforcing the unresolved issues between them. The parties' antipathy intensified as they struggled with their differences and family-related issues. The respondent felt overwhelmed by the challenges she faced with her relatives' health problems and found it frustrating that petitioner demanded her attention despite her own distress. She resented having to juggle her responsibilities, including managing calls from petitioner while dealing with family emergencies and financial stress. However, while on assignment, the petitioner experienced a lack of communication with the respondent due to poor internet connectivity. Upon receiving only one message from the respondent after a week, the petitioner felt deeply neglected and realized that his efforts in the relationship seemed unappreciated. This realization led him to cease communication with the respondent. After petitioner realized that he and the respondent have been living separate lives and after a thorough consideration of their marital status, he went to his lawyer, who then advised him to voluntarily submit himself first to a psychiatric clinical examination and evaluation.

Petitioner subsequently went to the clinic of Dr. Diosdado V. Amargo Jr. Upon careful evaluation of herein respondent. Dr. Amargo revealed the presence of Narcissistic Personality Disorder on the part of the respondent which is grave, severe, and incurable, as well as deeply ingrained in her personality structure that has rendered her as psychologically incapacitated to perform her marital duties and obligations. Dr. Amargo also found out that the petitioner himself also suffered from a psychological incapacity. The petitioner fulfilled the diagnosis of Narcissistic Personality Disorder. The psychological incapacities of both the petitioner and the respondent are grave and serious, which incapacitated them from carrying out the basic marital duties required in a marriage. The psychological incapacities of both the petitioner and respondent were also found to be permanent and incurable. Dr. Amargo's recommendation strengthens the case for nullifying the parties' marriage due to the respondent's Narcissistic Personality Disorder and also due to the petitioner's Narcissistic Personality Disorder.

WHEREFORE, premises considered, it is most respectfully prayed of the Honorable Court a) to declare the marriage between the petitioner Jeff Anthony G. "My wife and I could hardly afford to buy food to feed our children," he said.

He said he takes on carpentry and farm jobs to earn and bring home food.

The Walang Gutom 2027: Food provision through Strategic Transfer and Alternative Measures Program aims to decrease incidence of involuntary hunger experienced by low-income households and make them productive citizens of the country.

Through a whole-of-nation approach, the program provides monetary-based assistance in the form of an EBT card that will be loaded with food credits amounting to PHP3,000 to purchase a select list of food commodities from partner merchant stores. (PNA)
