and other incidents that ruined the environment and the experience for other visitors.

Through Executive Order 016 series of 2025 signed by Mayor Jerry Treñas, the Sunset Boulevard Task Force will be implementing their functions and duties.

The task force will be headed by Ret. Col. Uldarico Garbanzos, head of the Public Order and Safety Management Office-Traffic and Transportation Management Office (POSMO-TTMO).

These implementations include ensuring public order and safety; monitor and review traffic regulations; enforcement of traffic violations; traffic flow management; crisis management and emergency preparedness; and sustainable mobility promotion.

The implementation will also be done in collaborative efforts with other agencies including Iloilo City Police Office (ICPO), Land Transportation Office (LTO) Region 6, City Disaster Risk Reduction and Management Office (CDRRMO), among others. In the said E.O., drinking of alcoholic beverages within Sunset Boulevard from 11:00 PM to 4:00 AM is strictly prohibited. Minors are also prohibited to wander, saunter or loiter in the area from 11:00 PM to 4:00 AM while reserving portions of the said area to be used as parking spaces is also not allowed. In addition, the EO also ensures the cleanliness and beauty of the Sunset Boulevard through the City Environment and Natural Resources Office (CENRO) and General Services Office (GSO). The CENRO in partnership with other offices, will be taking charge of waste management, environmental conservation, and beautification of the said area.

Vital bridges improve rural connectivity in Iloilo Province

THE construction of two (2) vital bridges by the Department of Public Works and Highways (DPWH) now significantly improves safety and connectivity for far-flung communities in Maasin and Janiuay, Iloilo Province.

Completed in the municipality of Maasin is the Tubang Bridge project which involved the construction of a 60-lineal meter concrete bridge with sidewalks and slope protection, as well as the installation of metal guard rails and thermoplastic pavement markings as safety features.

In his report to DPWH Secretary Manuel M. Bonoan, DPWH Region 6 Director Sanny Boy Oropel said that the new Tubang Bridge replaced the existing spillway bridge which has been utilized as a vital transportation link between barangays that often faced mobility challenges during inclement weather.

Barangay Tubang and 11 other neighboring barangays are now better connected and have unhampered access to basic goods and services.

Meanwhile, the project in Barangay Quipot, municipality of Janiuay involved the construction of a 60-lineal meter long,

Locals are grateful for the bridge as they now have a sturdier structure to help them reach markets, schools, health centers, and government facilities.



Compulsory poll debates

THE Commission on Elections is on the right track in proposing compulsory debates for candidates, both for national and local positions.

This, we hope, will give the electorate the opportunity to closely examine the qualifications of candidates and what they propose to do once elected to public office.

The Constitution, after all, only lists down the most basic qualifications for all candidates: they should have reached a certain age, are Filipino citizens, able to read and write, registered voters, and residents of the **Philippines.**

Those are the basic requirements. But candidates should be able to explain to voters what they stand for, whether on national or local issues and concerns, and to offer a clear platform on what they intend to do after they have been sworn into public office.

The fundamental law also makes it very clear: "Public office is a public trust. Public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, integrity, loyalty and

efficiency, act with patriotism and justice, and lead modest lives."

Voters should be able to sift the chaff from the grain, so to speak, and not rely solely on the basis of name recall or popularity of candidates.

Should you vote for a candidate who declines to explain what he wants to do in public office and says that he would do so only when he has been declared among the winners? Of course not.

Voters should be able to distinguish between candidates who make false or empty promises and those who have the proven competence and expertise to make a difference in the lives of Filipinos.

And we need to remind the electorate that no less than the fundamental law frowns on political dynasties: "The State shall guarantee equal access to opportunities for public service, and prohibit political dynasties as may be defined by law."

The Comelec, as explained by Chairman George Garcia, has the power given to it by the Constitution to

issue rules and regulations pertaining to elections.

Hence, it can compel compulsory attendance by candidates in public debates, in the same way that it can regulate the size of campaign posters, or require the registration of social media accounts, violations of which can lead to a candidate's disqualification from the race.

What the Comelec wants is for public debates to be conducted by media would be "just and fair to everyone" and that all candidates will have equal opportunity whether they belong to any party or not, or whatever their beliefs are.

Candidates should comply with Comelec guidelines or else they will face the corresponding punishment if they fail to do so.

Debates are important as these allow voters to know the stand of candidates on key political, economic and social issues.

This is democracy at work and runs counter to votebuying, intimidation or coercion that undermines our goal of free and fair elections. (manilastandard.net)

across the world to look inward to strengthen local industries and foster resilience to mitigate the impact of trade tensions and global supply chain disruptions.

Here in the Philippines, a low-hanging fruit that has long been underutilized is the agriculture sector. Despite its huge upside potential, the agriculture sector's contribution to the Philippine economy has been shrinking with increasing reliance on imports.

The Philippine Statistics Authority (PSA) reported that in the last guarter of 2024 alone, agriculture and fisheries production decreased to around PHP484 billion from PHP494 billion in the same period of 2023. The decrease was the third straight quarter of contraction in 2024 and led to an overall decline of around 2 percent in the sector's output for the year. Agriculture, forestry, and fisheries contributed around 8 percent of the total Gross Domestic Product (GDP) in 2024—lower than the 8.6 percent share in 2023.

These figures, if any, highlight the need for better investment and policy support for the agriculture sector, not only to boost economic resilience but more importantly to drive growth. Urgent reforms and increased investment in agriculture are necessary to achieve long-term food security, address food inflation, and improve economic resilience.

Admittedly, accelerating the development of the agriculture sector is a tall order but not impossible-

technologies, the private sector can collaborate with the government to embrace modernization and address the problem of underinvestment—which has long been a problem stifling the growth of agriculture.

The recent growing interest in organic and local products provides a timely opportunity to revitalize agriculture to create a sustainable and resilient sector. reducing reliance on imports but also creating a more resilient supply chain.

Moreover, this expansion into milk products by Carmen's Best serves as a testament to the country's capability to produce world-class dairy-as long as the right support systems are in place.

Of course, this expansion would not have been possible without the necessary investments in modernized milking facilities, cold storage, and transportation to ensure high standards. The good news is with enabling policies and streamlined regulatory processes, expansions such as these can also be replicated in other agricultural products.

Developments such as these also serve as an invitation to other private companies to take a more active role in uplifting local agriculture. By prioritizing local produce, investing in research and development, and creating an enabling market and regulatory environment—the government can propel the agriculture sector to new heights for the benefit of the country.

It is high time for an agricultural renaissance. With the right investments and enabling policies, the country's farmers and agribusinesses can lead the way towards a more self-sufficient future.

Enhancing social security

Starting January 2025, the scheduled increase in Social Security System (SSS) contributions in the Philippines has taken effect, raising the total rate to 15 percent.

What is often overlooked in the discourse is that, under this new structure, employers will shoulder a 10 percent share, while employees contribute 5 percent. While media narratives frequently emphasize the burden on workers, it is important to recognize the significant share borne by employers, reflecting the government's commitment to shared responsibility in ensuring social protection for all.

For instance, an employee with a monthly salary credit of PHP15,500 will see their employer contribute PHP1,550 to the SSS, while the employee contributes PHP775. Additionally, the employer must pay another PHP30 to the Employees Compensation Program, bringing their total financial obligation to PHP1,580. This structure underscores the government's effort to distribute the financial responsibility equitably, with employers taking on a greater share to strengthen the social safety net. The increase in contributions aims to bolster the SSS fund's long-term sustainability, ensuring that it can provide meaningful benefits to both employees and retirees. It also reflects the government's proactive approach to addressing the challenges posed by an aging population and the need for a more robust social protection system. While it is true that businesses, particularly micro, small, and medium enterprises (MSMEs), face additional costs, the government recognizes their critical role in the economy. To this end, initiatives such as financial literacy programs, access to affordable credit, and government-backed support systems are in place to help MSMEs navigate these changes. Policymakers are also encouraged to explore further measures, such as staggered implementation schedules or targeted tax incentives, to ease the transition for smaller businesses.

REGULATION ORDINANCE NO. 2024-283

A COMPREHENSIVE SOLO PARENTS ORDINANCE OF ILOILO CITY, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES Sponsored by Hon. Frances Grace V. Parcon-Torres and unanimously Co-sponsored by all Members of the City Council;

WHEREAS, Article II, Section 9 states that the State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

WHEREAS, Article II, Sections 10 and 12 of the Philippines Constitution mandates the recognition of the sanctity of family life and shall protect and strengthen the family as a basic autonomous social institution, and that the state shall promote social justice in all phases of national development, respectively;

WHEREAS, as a response to the needs of the solo parents and in order to promote the policy of the State to promote the family as the foundation of the nation, strengthen its solidarity and ensure its total development, Congress enacted R.A. 8972 or Solo Parents Welfare Act of 2000;

WHEREAS, in compliance with the above mandate, the City Government of Iloilo enacted Regulation Ordinance No. 2019-289 or an Ordinance Institutionalizing the Program and Services to Solo/Single Parents and their children, providing funds therefore, and for other purposes or the Solo Parents' Ordinance of the City of Iloilo on May 31, 2019;

WHEREAS, On June 4, 2022 Former President Rodrigo Duterte signed into law Republic Act 11861 or the "Expanded Solo Parents Welfare Act" to reinforce the two decade-old Solo Parent's Welfare Act of 2000 by expanding its scope of applicability and increasing the benefits granted to solo parents and their families;

WHEREAS, on September 29, 2023, The Department of Interior and Local Government issued DILG Memorandum Circular No. 2023-140 or the Guidelines for Local Government Units Concerned on the Implementation of RA 11861 otherwise Known as the Expanded Solo Parents Welfare Act. No. 2023-140 and stated that the law mandates that the cash subsidy shall be allocated by the concerned city;

the spouse is detained or is serving sentence for a criminal conviction for at least three (3) months;

- 4. Parent left solo or alone with the responsibility of parenthood due to physical and/or mental incapacity of spouse as certified by a public or private medical practitioner;
- 5. Parent left solo or alone with the responsibility of parenthood due to legal separation or de facto separation from spouse for at least six (6) months: *Provided*, that he/she is entrusted with the custody of the children;
- 6. Parent left solo or alone with the responsibility of parenthood due to declaration of nullity or annulment of marriage as decreed by a court or by a church: *Provided*, that he/she is entrusted with the custody of the children;
- 7. Parent left solo or alone with the responsibility of parenthood due to abandonment of spouse for at least six (6) months;
- 8. Spouse or any family member of an Overseas Filipino Worker (OFW), or the guardian of the child or children of an OFW: *Provided*, That the said OFW belongs to the low/semi-skilled worker category, and is away from the Philippines for an uninterrupted period of twelve (12) months: Provided, further, that the OFW, his/her spouse, family member or guardian of the child, or children of an OFW, belongs to low or semi-skilled worker category, subject to the assessment of the duly appointed or designated social worker;
- 9. Unmarried mother/father who has preferred to keep and rear her/his child/children instead of having others care for them or give them up to a welfare institution;*Provided*, that the solo parent had the sole parental care and support of the child or children;
- 10. Any legal guardian, adoptive or foster parent who solely provides parental care and support to a child or children;
- 11. Any relative within the fourth (4th) civil degree of consanguinity or affinity of the parent or legal guardian whose death, or disappearance, absence or abandonment of the child or children, for at least six (6) months, led to the said relative assuming solo parental care and support of the child or children: Provided, That in case of solo grandparents who are senior citizens and who have the sole parental care and support over their grandchild or grandchildren who are unmarried, or unemployed, and twenty-two (22) years old or below, or those twenty-two (22) or over but who are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation or discrimination because of physical or mental disability or condition, Provided, further, That the child or children entitled to be supported beyond the age of majority shall be limited to those who are in school or in training for some profession, trade or vocation, consistent with and as provided in Article 194 of Executive Order No. 209 (E.O. No. 209), or The Family Code of the Philippines; The solo grandparents shall be entitled to the benefits of this Act in addition to the benefits granted to them by Republic Act No. 9994 (R.A. No. 9994) or the "Expanded Senior Citizens Act of 2003"; or;
- 12. A pregnant woman who provides sole parental care and support for her unborn child or children.
- b. Adolescent parents shall refer primarily to men and women who are nineteen (19) years of age and below, who have a child or children and opt to parent and raise the child or children on his/her own;
- **c.** Adoptive parent refers to a person who, through adoption, is considered the legitimate parent of a child over whom he/she has parental authority. In order for an individual to become an adoptive parent, he/she must complete all the legal requirements and must have been decreed as qualified to adopt a child by the court,

pursuant to Republic Act No. 8552 or the "Domestic Adoption Act of 1998", or by the National Authority for Child Care (NACC), pursuant to Republic Act No. 11642 or the "Domestic Administrative Adoption and Alternative Child Care Act."

d. Children or dependents – as defined under RA 11861 refer to those living with and dependent upon the solo parent for support who are unmarried,

WHEREAS, the passage of time necessitates the adoption of the added benefits and updated definition under the Expanded Solo Parents Welfare Act;

WHEREAS, there is a need to revisit Regulation Ordinance 2019-289 in order to strengthen the intent of the law by amending, striking out, or adding provisions for this purpose.

NOW THEREFORE, be it ORDAINED as it is hereby ORDAINED by the Sangguniang Panlungsod of Iloilo City in a session assembled that:

SECTION 1. TITLE

This Ordinance shall be known as the "Comprehensive Solo Parents Ordinance of Iloilo City."

SECTION 2. DEFINITION OF TERMS

a. Solo Parent

A solo parent refers to any individual who falls under any of the following categories:

- 1. A woman who gives birth as a result of rape and other crimes against chastity even without a final conviction of the offender: *Provided*, that the mother keeps and raises the child;
- Parent left solo or alone with the responsibility of parenthood due to death of spouse;
- 3. Parent left solo or alone with the responsibility of parenthood while

unemployed and twenty-two (22) years old or below, or those over twenty-two (22) years old but who are unable to fully take care or protect themselves from abuse, neglect, cruelty, exploitation, or discrimination because of a physical or mental disability or condition; *Provided*, that children or dependent/s entitled to be supported beyond the age of majority shall be limited to those who are in school or training for some profession; *Provided*, that this definition shall only apply for purposes of availing the benefits under this Ordinance;

- e. CSWDO refers to the City Social Welfare and Development Office;
- f. DILG refers to the Department of Interior and Local Government;
- g. DSWD refers to the Department of Interior and Local Government;
- h. Flexible work schedule a work arrangement granted to solo parent employee to vary the arrival and departure time in the workplace without affecting the core work hours as defined by the employer;
- i. Foster parent refers to a person who is duly licensed by the Department of Social Welfare and Development or the NACC to provide foster care to a child or children;
- **j.** Legal Guardian refers to a person granted legal guardianship over the person or property, or both, of a minor or an incompetent, by a court of proper jurisdiction;
- k. Means-tested refers to the determination whether a solo parent has no visible means of income, or his/her income is otherwise insufficient to enable the solo parent to provide sole parental care and support to a child, children,

or dependent/s owing to the demands for subsistence of his/her family and the conditions prevailing in the place of residence;

- Parental care and support acts of providing for the basic needs, health care, mental and physical safety, emotional support and formation of the personality of the child, children or dependent/s and do not depend solely on the support given by the person obligated to support;
- m. Parental leave leave benefits granted to a solo parent to enable the performance of parental duties and responsibilities where physical presence is required or beneficial to the child;
- n. Pension-tested refers to the determination whether a solo parent is not receiving any person, retirement benefits or payout, or his/her pension, retirement benefits or payout is otherwise insufficient to enable the solo parental care and support to a child, children, or dependent/s owing to the demands for subsistence of his/her family and the conditions prevailing in the place of residence;
- o. Relative within the fourth civil degree of consanguinity or affinity where "consanguinity" refers to relationship by blood, "affinity" refers to relationship by marriage; "relative within the fourth civil degree" includes one's spouse, parents, grandparents, great-grandparents, great-great grandparents, children, grandchildren,

great-grand-children, great-great grand children, uncles, aunts, great-uncles. great-aunts, first cousins by virtue of blood relationship or marriage;

- p. SPD Solo Parent Division
- q. SPIC Solo Parent Identification Card;
- **F.** Spouse refers to a husband or wife by virtue of a valid marriage or a partner in common-law relationship as defined in Article 147 of Executive Order No. 209, otherwise known as "The Family Code of the Philippines";
- s. Subsidy-tested refers to the determination whether a solo parent is not receiving any form of aid, support, grant, or appropriation, in cash or kind, from the government or a private entity, or his/her aid, support, grant, or appropriation, in cash or kind, from the government or a private entity is otherwise insufficient to enable the solo parent to provide sole parental care and support to a child, children or dependent/s owing to the demands for subsistence of his/her family and the conditions prevailing in the place of residence.

SECTION 3. APPLICATION

An individual is deemed a "solo parent" eligible to apply for a SPIC when he or she is in exclusive possession of parental authority, care and financial maintenance responsibilities for a child or children, or dependent/s. It is imperative that said individual does not engage in cohabitation and/or co-parenting arrangement with another person, unless their spouse is incapacitated either physically or mentally, rendering them unable to fulfil the responsibilities of child care and support.

SECTION 4. SOLO PARENT ID AND BOOKLET

The CSWDO shall cause the issuance of a Solo Parent Identification Card (SPIC) which shall be considered as competent evidence of identity and membership in the sector as well as entitlement under this ordinance. The CSWDO shall review and verify the documents submitted by the applicant and shall issue the Solo Parent Identification Card (SPIC) and booklet.

The SPIC and booklet shall be valid for one (1) year, subject to renewal conditioned upon the assessment and evaluation of the solo parent by the social worker.

The following are the requirements:

1. Barangay Certification to prove that the applicant is a resident of the

SECTION 7. SOLO PARENTS WEEK AND DAY

There shall be a Solo Parents Week and National Solo Parents Day every 3rd week and 3rd Saturday of April to highlight the role and significance of every solo parent in the Philippines.

SECTION 8. WORK DISCRIMINATION

No employer, whether public or private, shall discriminate against solo parent employee with respect to employment terms and conditions on account of his/her status.

SECTION 9. BENEFITS AND PRIVILEGES

- (a) Parental Leave. In addition to leave privileges under existing laws, a forfeitable and noncumulative parental leave of not more than seven (7) working days with pay every year shall be granted to any solo parent employee, regardless of employment status, who has rendered service of at least six (6) months: *Provided*, That the parental leave benefit may be availed of by the solo parent employees in the government and the private sector.
- (b) Maternity Leave. All covered female workers in government and the private sector, including those in the informal economy, regardless of civil status of the legitimacy of her child, shall be granted one hundred five (105) days maternity leave with full pay and an option to extend for an additional thirty (30) days without pay. *Provided*, that in case the employee qualifies as a solo parent under Republic Act No. 8972, or the "Solo Parents' Welfare Act", the employee shall be paid an additional maternity benefit of fifteen (15) days as provided for in Republic Act No. 11210 or the 105-Day Expanded Maternity Leave Law.
- (c) A ten percent (10%) discount and exemption from the value-added tax (VAT) on baby's milk, food and micronutrient supplements, and sanitary diapers purchased, duly prescribed medicines, vaccines, and other medical supplements purchased from the birth of the child or children until six (6) years of age of a solo parent who is earning less than Two hundred fifty thousand pesos (P250,000.00) annually, subject to adjustment in accordance with the provisions on the exempt taxable income under the National Internal Revenue Code (NIRC), as amended by Republic Act No. 10963, otherwise known as the "Tax Reform for Acceleration and Inclusion (TRAIN)': *Provided*, that nothing in this section shall violate the provisions of Republic Act No. 10028, otherwise known as the 'Expanded Breastfeeding Promotion Act of 2009'; *Provided*, that in cases where the solo parent or his/her child or dependent is also a holder of PWD and /or Senior Citizen ID he/she may only avail discount under one category;
- (d) Prioritization of solo parents. particularly solo mothers in re-entering the work force, and their children as applicable, in apprenticeships, scholarships, livelihood training, reintegration programs for OFWs, employment information and matching services, and other poverty alleviation programs of the City of Iloilo subject to the standard eligibility and qualifications;
- (e) Social Safety Assistance. During disasters, calamities pandemics, and other public health crises, the solo parents and their children are entitled to social safety assistance such as food, medicines, and financial aid for domicile repair in Iloilo City subject to the guidelines provided;
- (f) Livelihood Opportunities . The local government of lloilo City through the Public Employment Service Office shall, in coordination with other related government and non-government agencies, provide livelihood assistance and skills training under any of the city's applicable programs or projects, subject to the qualification requirements under existing ordinance, rule and regulation to solo parents;
- (g) Housing Services. Prioritization and allocation in housing projects with liberal terms of payment on government low-cost housing projects in accordance with housing law provisions prioritizing applicants below poverty line as declared by the Philippine Statistics Authority (PSA);
- barangay for at least one (1) year and that the child or children is/are under the parental care and support of the solo parent;
- 2. PSA Birth Certificate of the child or children;
- 3. Sworn affidavit of the solo parent declaring that the solo parent is not cohabiting with a partner or a co-parent, and has sole parental care and support of the child or children: *Provided*, that for purposes of issuance of subsequent SPIC and booklet, the requirement of sworn affidavit shall be submitted every year;
- 4. Supporting documents such as Declaration of Nullity of Marriage, Death Certificate of Spouse, Medical Certificate as proof of mental incapacity, if incapacitated, Certification from the Jail if the spouse is detained for at least one year;
- 5. Solo Parents Orientation Seminar Certificate of Attendance;
- 6. Social case study report.

SECTION 5. SOLO PARENT DATABASE

The City Social Welfare and Development Office shall undertake a city-wide registration of all solo parents and their children in the one hundred eighty barangays of Iloilo City. The CSWDO shall establish and maintain a centralized datebase of all solo parents who have been issued SPIC and booklets. Obtaining among others information on their names, ages, address, income, source of income, number of children per solo parent and their circumstances of being a solo parent.

SECTION 6. RIGHT TO ORGANIZE

All barangays in the City of Iloilo are hereby encouraged to organize their own Solo Parents Organization. The seven (7) districts in the City of Iloilo are also encouraged to organize their own Solo Parents Federated Organization.

- (h) Automatic coverage under the National Health Insurance Program (NHIP) administered by the PhilHealth with the solo parent's premium contributions to be paid by the National Government: *Provided*, that the solo parent's premium contribution in the formal economy shall be shared equally by the solo parent's employers and the National Government;
- (i) Special Lanes. Solo parents shall be included in the special lanes within the territorial jurisdiction of Iloilo City designated for Senior Citizens and PWD;
- (j) Designated Parking Spaces. Solo parents shall be included in the designated parking spaces within the territorial jurisdiction of Iloilo City designated for Senior Citizens and PWD;
- (k) Cash Subsidy. An additional One Thousand Pesos (P 1,000.00) per month allowance shall be allocated every solo parent who is earning a minimum wage and below in the City of Iloilo.

SECTION 10. CRITERIA FOR CASH SUBSIDY

A solo parent who is earning a minimum wage and below shall be entitled to Means-, pension-, and subsidy-tested monthly cash subsidy of One Thousand Pesos (P1,000.00) per month.

The basis whether the claiming solo parent is eligible to the means-tested, pension-tested, subsidy-tested monthly subsidy are the following:

- Voter's ID or Certification or any government issued ID that the applicant is a registered voter of Iloilo City;
- 2. Barangay Certification that applicant is a resident of the barangay for at least two (2) years and that the child or children is/are under the parental care and support of the solo parent. *Provided*, that if the solo parent is a transferee from another barangay, he /she shall secure a clearance from his/her previous barangay, indicating whether he/she availed of any benefits from solo parent, and the nature of such benefits; and
- 3. That the solo parent is in possession of a valid SPIC;
- 4. That the solo parent submits an accomplished claim form;
- 5. That the solo parent is earning a minimum wage or below tagged as "eligible" and not beneficiary of the Pantawid Pamilyang Pilipino Program or recipient of any other cash assistance or subsidy from any other government programs cash assistance. An eligible solo parent who is senior citizen or a person with disability may continue to receive senior citizen or person with disability benefits without forfeiting the benefits under Expanded Solo Parents Welfare Act and this ordinance.

SECTION 11. LIMITATION OF THE BENEFITS OF A SOLO PARENT

Only a solo parent exercising sole parental custody, care and support of child, children, or dependent/s is entitled to claim the benefits of a solo parent under this Ordinance: *Provided*, that a solo parent shall not lose his/her status as a solo parent if the other parent provides occasional assistance and/or seasonal gifts that do not meet the legal requirement of support under The Family Code of the Philippines: *Provided*, further, that the absence of a valid and legal marriage between the mother and the father of the child, children, or dependent/s does not automatically entitle either individual to the benefits under this Ordinance if the factual circumstances demonstrates that parental custody, care and support are shared by the mother and the father.

SECTION 12. TERMINATION OF THE BENEFITS OF THE SOLO PARENT

When a solo parent, as defined under this Ordinance ceases to be such by reason of a change of status and circumstances, the said solo parent shall be ineligible to avail of the benefits under this Ordinance.

SECTION 13. PROCEDURE FOR TERMINATION OF BENEFITS

In cases where a solo parent has a change of status or circumstances making him/ her ineligible to avail of the benefits this Ordinance, the procedure for termination of the benefits of such solo parent shall be as follows:

- A solo parent shall declare his/her intention to continue or terminate the provision of benefits and services before the lapse of one year from the issuance of the SPIC which he/she shall surrender to the said CSWDO;
- b) If the solo parent does not voluntarily declare his/her intention to continue or terminate the provision of benefits and services before the lapse of one year from the issuance of the SPIC, the Social Worker, based on a report by the employer or any interested person, shall conduct the necessary assessment/ evaluation to ascertain if grounds for termination and withdrawal of benefits exist;
- c) The solo parent shall be informed of the result of the assessment/evaluation conducted by the Social Worker, including the termination of the benefits or services, if warranted, through a written notice, with proof of receipt of the solo parent. The termination shall take effect immediately upon the receipt of the preceding section. The solo parent whose benefits have been terminated shall not use his/her SPIC after the receipt of the notice of termination;
- d) The Solo Parent's failure to renew his/her SPIC on or before the end of the year of its issuance shall result in the automatic expiration of the SPIC one

SECTION 16. SOLO PARENT'S HELP DESK

A solo parent's desk shall be established in the 180 barangays in Iloilo City under City Social Welfare and Development Office with the Barangay Committee Chairperson on Social Services as the Desk Officer.

SECTION 17. THE FUNCTIONS OF SOLO PARENTS BARANGAY HELP DESK

The following are the functions of the Barangay Solo Parents Desk Officer, as follows:

- a. Maintain and regularly update the list of Solo Parents in the barangay;
- b. Serve as general information and liaison center for solo parents;
- c. Monitor compliance with the provisions of the Ordinance, particularly the grant of privileges and additional benefits;
- d. Assist in the organizational structure of the solo parents' organization and federation; and
- e. Perform such other duties and functions necessary for the implementation of this Ordinance.

SECTION 18. ABUSED, ABANDONED, OR NEGLECTED SOLO PARENTS OR SOLO PARENTS WHO ARE VICTIMS OF DOMESTIC VIOLENCE

In cases where a solo parent has been abused, abandoned, or neglected by his or her co-parent, he or she may seek the help of the CSWDO, which, in turn, shall coordinate with the respective barangay officials and/or police officers assigned in the nearest Philippine National Police station where the abused, abandoned, or neglected parent resides, in order to provide immediate assistance. If the co-parent is gainfully employed, the abused, abandoned, or neglected parent shall have the right to retain a portion of the former's income, to be agreed upon by both parents or by a valid order issued by a court of competent jurisdiction, for the support of the child.

SECTION 19. SPECIAL PROTECTIONS FOR ADOLESCENT SOLO PARENTS

In addition to the provisions of this Ordinance, adolescent solo parents, including victims of child marriages, shall also be provided with assistance from the CSWDO and the City Health Office which may include counselling and psycho-social services.

SECTION 20. PENAL CLAUSE

(a) Any person who misrepresents status or falsifies any document to avail of the benefits, to cause another person to avail or be denied of the benefits provided under this Ordinance, or any person who abuses the privileges and benefits granted herein shall be punished with a fine of:

First Offense – P1,500.00 or community service; Second Offense – P2,500.00 or community service; Third Offense – P5, 000.00 or one (1) month imprisonment, or both, at the discretion of the Court.

If the violator is a corporation, organization or any similar entity, the officials thereof directly involved shall be liable therefore.

Upon filing of an appropriate complaint and after due notice and hearing, the proper authorities may also cause the cancellation or revocation of the business permit, permit to operate, franchise and other similar privileges granted to any business entity that fails to abide by the provisions of this Ordinance.

SECTION 21. APPROPRIATIONS

The amount necessary to carry out the provisions of this Ordinance shall be included in the budget of concerned agencies in the General Fund Budget of the year following the approval of this ordinance and every year thereafter.

SECTION 22. IMPLEMENTING RULES AND REGULATIONS

Within six (6) months from the effectivity of this Ordinance, the City Social Welfare and Development shall issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 14. REINSTATEMENT OF BENEFITS

The termination of said benefits shall be without prejudice to the reapplication of the solo parent and reinstatement of said benefits, should the circumstances so warrant.

SECTION 15. SOLO PARENT DIVISION

There shall be a Solo Parent Division under the CSWDO. The SPD shall establish linkages and work together with accredited civil society and nongovernmental organizations, political organizations and the barangays in Iloilo City. The SPD shall:

- (a) Plan, implement, and monitor yearly work programs in pursuance of the objectives of this Ordinance;
- (b) Draw up list of available and required services from the solo parents;
- (c) Maintain, audit and regularly update, on a quarterly basis, the list of solo parents, issued SPIC and booklets, and submit the same to DSWD;
- (d) Issue free booklets to solo parents;
- (e) Serve as a general information and liaison center for solo parents;
- (f) Monitor compliance with the provisions of this Ordinance, particularly the grant of privileges and additional benefits;
- (g) Report to the mayor or the CSWDO, any individual, establishment, business entity, institution or agency that violates any provision of this Ordinance;
- (h) Assist the solo parents in filing the complaints against any individual, establishment, business entity, institution or agency that refuses or fails to provide the privileges and additional benefits of solo parents granted under this Ordinance; and
- (i) Provide such other services as maybe required under this Ordinance.

SECTION 23. REPEALING CLAUSE

All ordinances, rules and regulations as part thereof, in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Provisions of Regulation Ordinance no. 2019-289 are hereby expressly repealed

SECTION 24. SEPARABILITY CLAUSE.

If any provision of this Ordinance is held invalid or unconstitutional, other provisions not affected thereby shall continue to be in full force and effect.

SECTION 25. EFFECTIVITY CLAUSE

This Ordinance shall take effect immediately upon its approval.

COMPLAINT

Plaintiff, National Grid Corporation of the Philippines (NGCP), by counsel, respectfully states:

1. NGCP is a private corporation created and existing under Philippine laws, with principal office address at NGCP Building, Quezon Avenue corner BIR Road, Diliman, Quezon City. It may be served with notices and other court processes through its Right-of-Way Department – Visayas Division, Banilad Power Complex, Nasipit, Talamban, Cebu City, and copy furnished the afore-mentioned principal office.

2. Pursuant to Republic Act (R.A.) No. 9511, NGCP was granted a franchise to operate, manage and maintain, and in connection therewith, to engage in the business of conveying or transmitting electricity through a high-voltage back-bone system of interconnected transmission lines, substations and related facilities, systems operations, and other activities that are necessary to support the safe and reliable operation of a transmission system and to construct, install, finance, manage, improve, expand, operate, maintain, rehabilitate, repair and refurbish the present nationwide transmission system of the Republic of the Philippines.

3. Under Section 4 of the same law, NGCP was granted the power of eminent domain, subject to the requirements of the Constitution and existing laws, *viz*:

"SEC. 4. Right of Eminent Domain. — Subject to the limitations and procedures prescribed by law, the Grantee is authorized to exercise the right of eminent domain insofar as it may be reasonably necessary for the construction, expansion, and efficient maintenance and operation of the transmission system and grid and the efficient operation and maintenance of the subtransmission systems which have not yet been disposed by TRANSCO. The Grantee may acquire such private property as is actually necessary for the realization of the purposes for which this franchise is granted: *Provided*, That the applicable law on eminent domain shall be observed, particularly, the prerequisites of taking of possession and the determination and payment of just compensation."

4. NGCP's basic critical mandate is to transmit high voltage electricity generated by the generating plants of power producers to the various distribution companies and electric cooperatives across the country. This crucial mandate plays a vital role in ensuring the steady and reliable delivery of electricity to the public. Given the indispensable nature of its operations, NGCP's mandate is imbued with public interest.

5. NGCP cannot ascertain the exact whereabouts of **Rosa J. Yenko**, **Rosemarie J. Yenko**, **Victorino Yenko**, **Jr.**, **Spouses Esther J. Yenko and Romulo Manlapig, and Delfin J. Yenko**, despite diligent and exhaustive efforts.

6. NGCP likewise cannot ascertain the existence, identities, and whereabouts of all other persons who may have any rightful claim or interest over the property subject of this Complaint, despite diligent and exhaustive efforts.

Notice of Resolution,⁴ promulgated on 6 February 2024, a pertinent portion of which provides:

"Notice is hereby given that the Commission, after due deliberation and evaluation, in a Regular Commission Meeting held on 17 April 2024, **RESOLVED** the following matters:

"1. NGCP's proposed Panay-Guimaras 138kV Interconnection Project in the instant *Application* amounting to Two Billion Three Hundred Twenty Million Six Hundred Forty-Five Thousand Seven Hundred Twenty-Five Pesos and Seventy-Six Centavos (Php2,320,645,725.76) is hereby APPROVED, subject to optimization based on its actual use and verified expenses incurred during the reset process for the subsequent regulatory period, following the procedures stated in the Rules in Setting the Transmission Wheeling Rates (RTWR), as amended, and other relevant issuances of the Commission. The project cost indicated herein is solely for the purpose of determining the permit fee;

² Section 14. Unknown identity or name of defendant. – Whenever the identity or name of a defendant is unknown, he may be sued as the unknown owner, heir, devisee, or by such other designation as the case may require; when his identity or true name is discovered, the pleading must be amended accordingly. 3 Section 16. Service upon defendant whose identity or whereabouts are unknown. — In any action where the defendant is designated as an unknown owner, or the like, or whenever his or her whereabouts are unknown and cannot be ascertained by diligent inquiry, within ninety (90) calendar days from the commencement of the action, service may, by leave of court, be effected upon him or her by publication in a newspaper of general circulation and in such places and for such time as the court may order.

"x x x"

11. Given the foregoing, there is genuine necessity and urgency to immediately construct and implement the Project which is intended to accommodate the entry of the 40 MW Sibunag Wind Power Plant which will result in increased power supply and transmission towards Panay and reliability and flexibility of the grid in the area. Hence, the immediate completion and energization of the said project are critically important.

12. The Project's route commences at NGCP's existing Iloilo Substation in Brgy. Ingore, La Paz, Iloilo City, and stretches via overhead transmission line towards the Ingore Cable Terminal Station in the same barangay. It then proceeds via submarine cables towards the Sawang Cable Terminal Station in Brgy. Sawang, Buenavista, Guimaras, and continues via overhead transmission line towards the projected Zaldivar Substation in Brgy. Zaldivar, Buenavista, Guimaras, where it terminates.

13. The determination of the areas to be affected by the construction of the Project, which includes the property subject of this Complaint, was the result of an in-depth study by the engineering group of the NGCP. It included the survey and re-survey of the areas to be affected and spot mapping thereof to determine the terrain, suitability of the soil, tower deflections, and other technical and social factors. The choice of the areas to be affected as well as of the path of the transmission lines is neither arbitrary nor whimsical. Varying factors are always considered, such as, but not limited to the integrity of the line and the grid, the cost, and the ease of maintenance of the transmission lines.

14. The route of the Project was established by NGCP in good faith, taking into account all the mentioned paramount technical considerations, to cause the least possible damage to the affected localities, avoiding as far as practicable urbanized, commercial and public areas, thereby making it the least burdensome to the general public and all the landowners in the area, taken as a whole. The selection of the route and the taking of the properties affected by it, including the property subject of this Complaint, are in accordance with the ruling of the Supreme Court in the case of **Sumulong vs. Guerrero, G.R. No. 48685, September 30, 1987**, wherein it was held:

"x x x Absent a clear showing of fraud, bad faith, or gross abuse of discretion, which petitioners herein failed to demonstrate, the Court will give due weight to and leave undisturbed the [expropriator]'s choice and the size of the site for the project. The property owner may not interpose objections merely because in their judgment some other property would have been more suitable, or just as suitable, for the purpose. The right to the use, enjoyment and disposal of private property is tempered by and has to yield to the demands of the common good. x x x." (Bracketing and replacement supplied.).

15. To fully implement and complete the project, NGCP needs to immediately take, by voluntary acquisition or expropriation, properties, or portions thereof, that are affected or traversed by the Project. It is genuinely necessary to take the properties traversed by the transmission line project because the transmission line would physically occupy the affected properties, through its construction and through its operation and maintenance after it is energized. The high voltage of electricity that would be transmitted by the transmission line requires that its transmission/power line corridor be cleared of occupants and of both natural and man-made obstacles for its proper operation and maintenance, and for the safety of people, properties and the transmission line itself. This public use of the affected properties necessitates their taking.

7. The above-mentioned unknown claimants and interest-holders are impleaded herein pursuant to Section 1,¹ Rule 67 of the Rules of Court and Section 14,² Rule 3 of the Revised Rules of Civil Procedure, because NGCP cannot determine with certainty the identities of all persons who have the exclusive ownership of the property herein sought to be expropriated, despite diligent and exhaustive efforts. NGCP undertakes to cause, by way of motion for leave of court, the service of summons to them, as well as to the named defendants above whose whereabouts are unknown, by publication pursuant to Section 16,³ Rule 14 of the Revised Rules of Civil Procedure.

¹ Section 1. 8. In order to meet the increasing demand for electricity in the cities, municipalities and provinces in the Islands of Panay and Guimaras and to support the continuing growth and development in the area, there is a need for NGCP to construct a new transmission system that will suit the present and future power requirements therein. Without this new transmission system, the power requirements in the aforementioned region will not be supplied, leading to power outages

9. Owing to this necessity, NGCP must immediately construct the transmission line, substations and other facilities that will transmit uninterrupted power to the distributors of electricity in the aforesaid area. This undertaking is for the use and benefit of the public and is known as the Panay-Guimaras 138kV Interconnection Project (the Project).

10. The Energy Regulatory Commission (ERC) approved the Application filed by NGCP for the approval of the Panay-Guimaras 138kV Interconnection Project, docketed as ERC Case No. 2017-110RC in a

16. The genuine necessity and public use for which the taking of properties for the transmission line project of NGCP are in accordance with the rulings of the Supreme Court, particularly in the cases of **The Manila Railroad Company vs. Mitchell, G.R. No. 19280, March 16, 1923 (En Banc)**,⁵ and **MORE Electric and Power Corporation vs. Panay Electric Company, Inc., G.R. No. 248061, September 15, 2020 (En Banc)**,⁶ and **National Power Corporation vs. Benjamin Ong Co, G.R. No. 166973, February 10, 2009**.⁷

17. In the exercise of its right of eminent domain, NGCP intends to expropriate a portion of a parcel of land denominated as **Lot No. 3799-B**, a private property located in Brgy. Ingore, La Paz, Iloilo City. As indicated in the pertinent portion of the Index Map,⁸ the said portion of Lot No. 3799-B is within the route and site of the project.

18. Lot No. 3799-B is registered under Transfer Certificate of Title (TCT) No. T-113385⁹ in the names of Rosa J. Yenko, Rosemarie J. Yenko, Victorino Yenko, Jr., Esther J. Yenko, married to Romulo Manlapig, and

The affected area sought to be expropriated consists of 1.953 square meters, more or less, as shown in the Sketch Plan¹¹ and Narrative Technical Description,¹² and is more particularly described below, to wit:

19. To enable NGCP to construct and maintain the Panay-Guimaras 138kV Interconnection Project, it is both genuinely necessary and urgent to acquire, upon payment of just compensation, the above-described portion of Lot No. 3799-B, to ensure stability and reliability of power supply in the cities, municipalities and provinces in the Islands of Panay and Guimaras, as well as other parts of the country.

20. NGCP's personnel endeavored to locate the defendants in order to negotiate with them for the acquisition of the above-described portion of Lot No. 3799-B for the implementation of the project. On October 13, 2021, NGCP's personnel went to the site of the affected area of the subject property and made inquiries with neighboring landowners and barangay officials regarding the identities of its owners. They further posted a tarpaulin on the site, stating NGCP's intent to take the affected portion of the property for its project and inviting any person with interest over the property to contact them. However, none of the defendants could be located despite diligent and exhaustive efforts. Hence, no negotiations could be conducted. Considering the urgency involved in the construction of the project, NGCP has no other recourse but to file the instant case.

21. NGCP is willing and able to pay the just compensation for the above-described portion of Lot No. 3799-B, subject to deductions for capital gains and documentary stamp taxes for the transfer of the property in the name of NGCP, any other applicable estate taxes, all other outstanding taxes under the National Internal Revenue Code (NIRC), and other outstanding realty taxes and dues under the Local Government Code, which NGCP shall directly pay to the Government.

22. Recognizing further the urgency of the resolution of expropriation cases involving transmission lines, in OCA Circular No. 127-2021 dated 13 October 2021, the Chief Justice of the Supreme Court enjoined judges to give primacy to cases that involve, among others, government expropriation, and infrastructure projects (including energy transmission projects), commercial - and economic-impact cases.

23. Moreover, an expropriation proceeding being an action quasi in rem,14 jurisdiction over the defendants is not required. It is only required that there is jurisdiction over the res. Concomitantly, prior service of summons upon the defendants is not required for the issuance of the Writ of Possession

time thereafter and after due notice to the defendant, the plaintiff shall have the right to take or enter upon the possession of the real property involved if he deposits with the authorized government depositary an amount equivalent to the assessed value of the property for purposes of taxation to be held by such bank subject to the orders of the court. Such deposit shall be in money, unless in lieu thereof the court authorizes the deposit of a certificate of deposit of a government bank of the Republic of the Philippines payable on demand to the authorized government depositary.

27. Pursuant to the above Rule, NGCP shall cause to be served, among other means, together with the summons and the instant Complaint, a Notice to Take Possession¹⁹ upon the defendants.

28. In the interest of immediate project implementation within established timelines, NGCP shall deposit with the Clerk of Court of this Honorable Court, in favor of the defendants, 100% of the BIR zonal value of the portion of the subject property sought to be expropriated, in the total amount of Nine Million Seven Hundred Sixty-Five Thousand Pesos (Php9,765,000.00), thereby placing it in custodia legis, pursuant to OCA Circular No. 113-2019.

29. Upon deposit of the provisional amount, which is higher than the assessed value of the affected portion of the subject property, NGCP will have fully complied with the requirements for the issuance of a writ of possession as mandated by law.

30. In a long line of cases²⁰ and in accordance with OCA Circular No. 113-2019, once the above requirements are complied with, it becomes the ministerial duty of the trial court to issue the writ of possession in favor of the NGCP, without need of any further hearing. Therefore, this Honorable Court can already immediately issue to the NGCP an order to take possession of the subject property and start the implementation of the Project.

31. In the case of Municipality of Cordova v. Pathfinder Development Corporation,21 the Supreme Court emphasizes the mandatory issuance of the writ of possession upon the receipt of the required deposit. "No hearing is actually required for the issuance of a writ of possession, which demands only two (2) requirements: (a) the sufficiency in form and substance of the complaint; and, (b) the required provisional deposit x x x x. Upon compliance with these requirements, the petitioner in an expropriation case is entitled to a writ of possession as a matter of right and the issuance of the writ becomes ministerial."

32. Corollary to the successful and complete implementation of the Writ of Possession, and for the orderly and peaceful entry of the NGCP into the subject property for project implementation, the assistance of the Philippine National Police (PNP) and temporary access through the subject property to the area being expropriated are necessary. In view of the requirement under Section 28.2, Rule 2822 of the Revised Philippine National Police Operational Procedures, the Order for issuance of a writ of possession needs to specifically direct the PNP to render assistance in order for the PNP to have basis to act. As such, NGCP prays that this Honorable Court also direct the PNP Officers to assist in the implementation of the Writ of Possession that will be issued.

Tubera, Regional Survey and Geotechnical Supervisor, whose testimony is being presented to establish the areas and transmission line route necessary for the construction of NGCP's project pertinent to the subject property, the consequent necessity of the taking of the subject property, and other facts of the case. A copy of his Judicial Affidavit is attached herein as Annex "J:" and

documentary as circumstances may require during trial.

PRAYER

WHEREFORE, premises considered, NGCP most respectfully prays for this Honorable Court to:

1. ISSUE a Writ of Possession in NGCP's favor:

- a) Authorizing it to enter and take possession of the portion of Lot No. 3799-B, subject of this Complaint, that will be affected by the construction and implementation of the Panay-Guimaras 138kV Interconnection Project, as described in paragraphs 17 and 18 hereof;
- b) Ordering the demolition of affected houses/structures standing thereon, if any;
- Ordering all defendants to vacate the same; c)
- Directing the PNP to assist the NGCP in the implementation d) of the said writ of possession so that project construction can immediately commence even during the pendency of the case: and
- If necessary, allowing NGCP to have temporary access e) in going to the area subject of the Complaint while the construction of the Project is on-going;

2. ISSUE an Order of Expropriation declaring that NGCP has a lawful right to take possession and condemn to public use the subject portion of Lot No. 3799-B sought to be expropriated, consisting of 1.953 square meters, more or less, as specified in paragraphs 17 and 18 of this Complaint;

3. After the determination of just compensation, ISSUE a Judgment:

a) Authorizing NGCP to pay to the defendants the amount of just compensation fixed after deducting the provisional deposit, capital gains and documentary stamp taxes for the transfer of the property in the name of NGCP, the applicable estate taxes, all other outstanding taxes under the National Internal Revenue Code, and all outstanding realty taxes and dues under the Local Government Code, which NGCP shall pay to the Government;

b) Declaring NGCP as the lawful owner of the portion of Lot No. 3799-B, sought to be expropriated, consisting of 1,953square meters, more or less, specified in paragraphs 17 and 18 hereof;

c) Directing the Registry of Deeds for City of Iloilo, to register and annotate the Writ of Possession, Order of Expropriation and Judgment on Transfer Certificate of Title No. T-113385, and, upon application by NGCP, to issue a new and separate certificate of title in the name of NGCP over the portion of Lot No. 3799-B, sought to be expropriated herein, free of all liens, encumbrances and other matters annotated on TCT No. T-113385, and without the need for the presentation of the owner's duplicate copy of the said certificate of title; and

d) Directing the City Assessor of Iloilo, to cancel Tax Declaration No. 15-04-011-00147, and to issue a new and separate tax declaration in the name of NGCP over the portion of Lot No. 3799-Bsought to be expropriated herein.

NGCP prays for other relief just and equitable under the premises.

24. In NM Rothschild & Sons (Australia) Ltd. vs. Lepanto Consolidated Mining Company,¹⁵ the Supreme Court held that:

"[W]hen the case instituted is an action in rem or quasi in rem, Philippine courts already have jurisdiction to hear and decide the case because, in actions in rem and quasi in rem, jurisdiction over the person of the defendant is not a prerequisite to confer jurisdiction on the court, provided that the court acquires jurisdiction over the res."

25. Again, in Macasaet vs. Co, Jr., 16 the Supreme Court held:

"Jurisdiction over the person, or jurisdiction in personam-the power of the court to render a personal judgment or to subject the parties in a particular action to the judgment and other rulings rendered in the action-is an element of due process that is essential in all actions, civil as well as criminal, except in actions in rem or quasi in rem. Jurisdiction over the defendant in an action in rem or quasi in rem is not required, and the court acquires jurisdiction over an action as long as it acquires jurisdiction over the res that is the subject matter of the action. The purpose of summons in such action is not the acquisition of jurisdiction over the defendant but mainly to satisfy the constitutional requirement of due process."

ALLEGATIONS IN SUPPORT OF THE **ISSUANCE OF A WRIT OF POSSESSION**

26. Section 13 of R.A. 1136117 provides that Rule 67 of the Rules of Court governs NGCP's expropriation cases. Under Section 2 of Rule 67 of the Rules of Court, NGCP may already enter and possess the subject property during the pendency of the expropriation case,¹⁸ thus:

ILOILO CITY – The local government has assured the public that strict measures are in place to prevent the proliferation of fake persons with disability (PWD) ID cards in the city.

Acknowledging the growing concerns about fraudulent PWD IDs and their impact on local businesses, Joy Fantilaga, spokesperson for Mayor Jerry Treñas, emphasized the need to develop proactive measures to address the issue.

"As early as last year, we implemented strict measures to protect businesses from abuse while ensuring that only legitimate PWDs receive the benefits intended for them," Fantilaga said.

In 2023, Treñas issued Executive Order 157, requiring all PWD ID cards issued by the city government to bear security labels.

Since March 2024, only PWD ID cards bearing the official security label/sticker have been honored in all establishments in the city.

"This is a reminder once again to all establishments to strictly honor only PWD cards with the security label or sticker. This directive ensures that discounts rightfully serve those who need them while protecting businesses from financial losses due to fraudulent claims," she added.
