vice president and her team, with whom he shared the same vision and passion for progress.

"I can still remember, during my first term as mayor, I also had a study tour in Naga City where I learned about their housing initiatives, their relocation sites, as well as the perimeter boundary ordinance for out-of-town jeeps and buses," Treñas shared.

His contemporaries at that time included the late Mayor Jesse Robredo, husband of Leni, and then Mayors Mary Jane C. Ortega and Marides Fernando of San Fernando City, La Union and Marikina City, respectively - all equally distinguished leaders.

Treñas noted that, alongside Mayor Jesse and Mayor Ortega, they served as speakers in international learning seminars for local government units (LGUs) and at the World Economic Forum in Johannesburg, South Africa and Vancouver, Canada.

Meanwhile, together with Mayor Fernando, they gave lectures to the first candidates for the initial LGU elections in Indonesia, funded by the World Bank.

"Being a city mayor, learning is never-ending. We always learn something new every day," the local chief executive expressed.

Treñas said just like other LGUs that visited the city to benchmark, Iloilo City is elated to also share its best practices and programs to Naga City.

He remarked that before, he went to several cities like Naga City to learn, and now everyone is going to Iloilo to learn from the city. "As leaders like Leni, we all strive for continued progress in our respective cities, and this can be replicated by other LGUs," Treñas said.

During the COVID-19 pandemic, he recalled the assistance of the former Vice President, who donated P7 million worth of COVID-19 test kits and an RT-PCR machine for the city and province of Iloilo.

Iloilo City continues to serve as a model for other LGUs due to its fast-growing economy and sustainable practices.

Under Mayor Treñas' current term, close to 50 LGUs have benchmarked in Iloilo City. Among them are the LGUs of Masbate, Albay, Koronadal City, Pampanga, Cuyo (Palawan), Zamboanga, Valencia City (Bukidnon), Barangay North Fairview (Quezon City), San Fernando (La Union), Alangalang (Leyte), Tagbilaran City (Bohol), Angeles City, Don Carlos (Bukidnon), and Dulag (Leyte).

Several impactful projects have been carried out by the Treñas administration, including the Iloilo City Nutrition Center, Iloilo City Action and Resilience (ICARE) centers, dialysis centers, the legislative building and other essential infrastructures, and the redevelopment of open spaces, public plazas and markets.

The city has also received multiple awards and recognitions under Treñas' leadership, with several outstanding offices earning various citations.

all throughout the region so this could navigate our patients from the lower levels of care like primary health centers, the level one hospitals, and level two hospitals towards WVMC as the end-referral hospital or the subspecialty hospital for the region," said Dr. Lemuel Umahag, Assistant Chief Medical Professional Staff for Specialty Centers.

Umahag noted that the channeling of the referrals must come from the primary care centers such as barangay and municipal health centers to the level 1 hospitals (district hospitals), Level 2 (provincial hospitals), and tertiary care hospitals.

Umahag emphasized that the referral system also comes with a screening on the patient's degree of medical condition in case there are primary cases and or priority cases that could be managed in the primary care centers before directing into other levels of hospitals.

He also stressed that there will be enhancement and

proper coordination of the referrals through the said system.

"As much as possible we have a guide where to refer to these patients because the essence of referrals is that there is proper coordination and patients are being channeled to the appropriate level of care facilities that they are supposed to be managed," said Umahag.


On the other hand, Dr. Joseph Dean Nicolo Medical Center Chief II, noted that they eye to decongest about 30 to 40 percent of their hospital beds in terms of primary and secondary cases and also plan to cater other tertiary cases.

Meanwhile, WVMC is one of the level 3 hospitals in Western Visayas with 425-bed capacity that provides medical services to different areas in the region.

The said level 3 hospital also aims to enhance healthcare accessibility, strengthening referral mechanisms, and ensuring seamless patient care across all levels of the healthcare system through the comprehensive referral system manual.

W. Visayas police told: Intensify anti-drug campaign

ILOILO CITY – Drug operatives in Western Visayas were drug syndicates and engagement with various stakeholders. ordered to sustain their aggressive campaign amid successful operations in the region last month.

Brig. Gen. Jack Wanky, the region's top cop, directed them to further intensify their intelligence gathering, operations against

Data released by the regional office showed that in February, the regionwide operations yielded around PHP40 million worth of shabu and marijuana, lower by PHP5 million when compared to their accomplishment in January.

Thursday said Wanky has a standing order for them to "intensify information gathering and continue the aggressive operations against those engaging in illegal drug activity across the

The 254 regional operations in February yielded more than Police Regional Office 6 spokesperson Lt. Col. Arnel Solis on 5.8 kg. of shabu with an estimated value of PHP39.67 million

> and over 2.5 kg. of marijuana worth PHP302,000 and arrested 334 suspects.

The biggest haul came from the Bacolod City Police Office with PHP11.1 million worth of drugs, followed by the Iloilo Police Provincial Office with PHP10.8 million and the Iloilo City Police Office with PHP9.4 million.

Wanky said these accomplishments reflect the collective efforts of the police, community, local government units, and other law enforcement agencies.

The suspects are now facing charges for violation of Republic Act 9165, the Comprehensive Dangerous Drugs Act of 2002. (PNA)

The analogy said it all

Last Sunday, I invited a very successful, rich but embattled older man to attend church and reconnect with his "Christian" roots. I was very honored that he agreed to attend and even came with his wife.

In order to meet up with them, I had to drive three hours from Lobo, Batangas and be at Victory Christian Fellowship-Estancia just a little before the 4 p.m. service. As usual, "the enemy" threw a monkey wrench into my plans. We received a call that my sister, who was visiting from New Zealand, had to be taken to the emergency room.

It was unfortunate and inconvenient but came as no surprise. Lesson 1: When any of us attempt to minister to others, especially those seeking the Lord or trying to reconnect with church, the devil will surely complicate matters and obstruct your plans. The choice was going to my sister or go to church?

God makes a way and, in this case, my wife Karen became designated caregiver while I rolled out the welcome mat for my friend and his wife. The second constant I have observed among people who "visit or return to church" is that the preaching is almost always on point or a bullseye.

In the case of my "rich but not so young" friend, the preaching for the service was the story of "The Rich Young Ruler" who was deeply religious and wanted to know what else he needed to do to inherit eternal life. Half of me shook my head in disbelief, the other half silently chuckled.

Most of us, if not all of us, have heard the story of the Rich Young Ruler in the Bible and like the subject, we go away finding it difficult to even think of selling all or give away everything to the poor, much less going into ministry. The rest of us don't see ourselves as rich or in the ruling class. Either way, "It ain't easy."

The "youngish pastor" Dennis Sy, who used to live the "Tsinoy Rich Life," started out by sharing that in Jewish culture then, being rich was associated with being blessed by God and therefore aligned with God's will.

The challenge for many people, or what creates confusion, is their unfamiliarity with how Jesus/ God talks and operates. Beginning with Abraham down to the Rich Young Ruler, God challenges us in order to see how we react, and to know where our heart is.

The Rich Young Ruler operated from religiosity and not familiarity. Jesus was addressing the young guy directly and "rulers" or bosses just like him who have put in so much to acquiring wealth they have become "slaves" to wealth or "captives" of the lifestyle. The lesson is not generic or applies to all.

While he acknowledged Jesus Christ as "teacher," it is safe to say that he had no personal or working relationship with Jesus. He did not ask Jesus to elaborate, he did not ask "Teacher, why and how?" – he simply walked away grieving, thinking of all is possessions.

To drive the point home, Pastor Dennis used a standard size carry on suitcase with wheels like many of us use. From there, he recreated a familiar scene at many local airports and budget airline check-in counters.

As he "enters," St. Peter stops him and says, sorry your baggage is oversized and won't fit the metal cage that measures correct size and weight. He insists that it's not heavy, it has all his valuable possessions and he needs to bring it through.

I really thought Pastor Dennis was going to do what many Filipinos do: spread everything on the floor, choose between light and heavy, bulky vs squishy and repack using an eco-bag.

But when he opened up the carry-on suitcase,

he took out an even smaller carry-on suitcase and once again insisted on bringing his choice possessions in a smaller bag. The thing is, we all willingly give up what's not important or does not affect us.

I loved the analogy because every Filipino can relate to it. We bring all the weighty or heavy stuff as hand carry. In spite of being told about restrictions, weight limits and enough time to prepare and follow, we stubbornly assume we can haggle or insist.

But the reality is most of the time, we pay a very stiff price for excess weight in our baggage, our bodies and our life. While many people envy the rich and famous, we are ignorant of their high cost for maintenance of homes, businesses, lifestyle, etc. Some are living with a zoo full of white elephants.

One important thing to consider in today's topic is that the story of the Rich Young Ruler was about Jesus calling on the young man to seek eternal life and not just the material life. Jesus actually invited him to be part of his team. Jesus stayed, the young man walked away.

It was a timely "check-up" similar to annual physicals. The young man thought he was on the right direction: "been there, done that" but discovered he had the wrong conclusion, much like someone climbing 20 stories to discover he climbed the wrong building.

For many of us, it is not even the great possessions nor is it about the money that God wants to deal with. It is about our will versus letting God's will be done. The one who has the most toys does not have the most fun, he has the bigger mess.

Still a dirty money haven

Now that the Philippines, after missing its deadline, finally managed to get out of the gray list of countries under tighter monitoring by the Financial Action Task Force or FATF, the global dirty money watchdog may want to take a look at one of the biggest financial laundromats in this country: campaign finance.

Pressure from the Paris-based anti-money laundering FATF compelled the government, among other things, to tighten supervision of casino junkets and strengthen its framework for combating terrorism financing. The complete ban on Philippine offshore gaming operations and the local POGO copycat IGL or internet gaming licensee also helped.

While Philippine officials are patting themselves on the back, several nongovernment organizations are lamenting that the exit from the gray list was achieved partly at their expense, with their assets frozen and restrictions imposed for being classified as supporters of terrorist groups.

Several of these NGOs have been linked by government security officials to the Communist Party of the Philippines and New People's Army. The CPP and NPA are designated as terrorist organizations not only in the Philippines but also in the United States and the European Union.

The exit from the FATF gray list means the country is seen to have made significant progress in strengthening measures against money laundering and financing of terrorism.

Officials have stressed that exiting the list does not mean money laundering has been eliminated. Which is just as well, since Filipinos will laugh if told that the exit means the country is no longer a money laundering haven.

Some quarters are even hoping that the FATF will also exert pressure on the government for the passage of legislation for genuine campaign finance reforms and easing of bank secrecy laws.

Members of all Congresses since the restoration of democracy in 1986, with their powerful self-preservation instincts, have tossed out all proposals for regulating election campaign finance and lifting of the world's toughest bank secrecy laws.

Defanged by lawmakers and the judiciary, all that the Commission on Elections (Comelec) has managed to impose is a requirement for all candidates, win or lose, to file statements of contributions and expenditures or SOCE within 30 days after election day.

While verification of the accuracy of the financial declarations can be challenging for the understaffed Comelec, Chairman George Garcia has announced plans to upload the SOCE for public access, in hopes that interested parties particularly the candidates will be checking each other for possible lying in the statements. The Comelec can then act on complaints.

The Comelec also oversees compliance with spending limits set under the Omnibus Election Code – currently at P10 per voter for the races for president and vice president, P3 for other positions and P5 per voter for political parties.

Comelec officials have said the spending limits set under the Code passed in 1991 have become unrealistic and must be increased. This will be welcomed by moneyed candidates, who can then openly spend more for their campaigns without worrying about breaking the rules and facing sanctions. But raising the spending limit may be frowned upon by those with limited resources.

For candidates who are flush with cash from illegal activities, the sky's the limit in campaign spending.

Alice Guo is under investigation on charges of faking her Philippine citizenship to run for mayor of Bamban, Tarlac. POGOs are believed to have bankrolled her campaign for election.

Offshore gaming and the crimes linked to POGOs, such as cyberscams, kidnapping for ransom and human trafficking, aren't the only illegal activities that have financed election campaigns in this country.

Other forms of illegal gambling such as jueteng have been laundered for successful career shifts to politics. If the jueteng lords don't seek public office themselves, they bankroll the campaigns of candidates and even contribute heavily to the war chests of presidential bets.

Anti-crime watchdogs had previously noted

that moneyraising criminal activities such as kidnapping for ransom and daring robberies of

banks and armored vehicles tended to spike during election season.

Apart from gambling barons, among the biggest donors to election campaigns are smugglers and drug traffickers.

When the candidate backed by such lowlifes wins, the campaign donors become untouchable, intensifying their criminal activities with impunity.

Some of the offenses are international criminal activities that transcend borders, so the FATF should be interested in the opportunities for money laundering related to such crimes.

Even groups designated as foreign terrorist organizations – the targets of the FATF focus on combating terrorism financing – engage in criminal activities to raise funds. The Abu Sayyaf, one of such organizations, has a long track record of lucrative fund-raising through ransom kidnapping and extortion. Security officials say the New People's Army is among the biggest maintainers of marijuana farms around the country.

There's a legally binding United Nations Convention Against Corruption, adopted by the UN General Assembly in October 2003 and which entered into force on Dec. 14, 2005. Corruption has been one of the biggest hindrances to the elimination of poverty and the achievement of UN development goals.

The global campaign against money laundering is a critical component of any battle against corruption. The FATF should be interested, for example, in the laundering of slush funds and kickbacks by politicians and other government officials worldwide.

It can set up a black or gray list of countries and territories that are money laundering havens for crooks in government and their cohorts in the private sector.

Exiting the FATF gray list is a step forward. With pressure from the FATF, perhaps Philippine lawmakers will finally be compelled to legislate campaign finance reforms and relax bank secrecy laws.

82 elderly Ilonggos receive cash gift under expanded centenarians law

ILOILO CITY (PIA) — Eighty-two elderly beneficiaries from the first district of Iloilo, including one centenarian from Igbaras town, receive their cash gift under the Expanded Centenarians Act of 2024 during the inaugural distribution done simultaneously in different areas of the country on February 26, 2025.

During a program in Miag-ao town, National Commission of Senior Citizens (NCSC)-6 Project Development Officer IV Gretchen Anne T. Orbista said that there are a total of 421 beneficiaries in the city and province of Iloilo qualified for the program, noting that succeeding payouts will also be held in every district.

She added that these senior citizens ages 80, 85, 90, and 95 will receive P10,000, while centenarians maintain their P100,000 benefit.

In an interview, Rosinica Sarjena, 80, thanked the government, noting that she will use the money to buy her maintenance medicines.

"Pasalamat gid ako kay nakabaton ako diyes mil (P10,000). Daad palawigon pa ako para makabaton naman ti sien (P100,000)," Sarjena added.

(I am really thankful for the P10,000. Hopefully, I will have a long life so that I can receive the P100,000)

ILOILO CITY (PIA) — Member agencies of the Regional Council Against Child Labor (RCACL) in Western Visayas and other partners have pledged support for efforts to eradicate child labor in the country.

Stakeholders affirmed the vow during the Information and Service Caravan on Child Labor Prevention and Elimination Program and ILO Convention 190 or Violence and Harassment Convention 2019 Signing of Commitment in Iloilo City.

Western Visayas stakeholders solidified their pledge of support against child labor, backing the DOLE's efforts in upholding the rights and welfare of children, giving them countless opportunities to thrive, and consequently usher them towards economic freedom.

In her keynote message on behalf of DOLE Secretary Bienvenido E. Laguesma, Bureau of Workers with Special Concerns OIC-Director Leilani Reynoso imparted the importance of the activity.

"Ang Philippine Program Against Child Labor ay ibinalangkas alinsunod sa Philippine Development Plan at Labor Employment Plan 2023-2028 na magpatupad ang pamahalaan ng isang holistic approach at siguraduhin na may sapat na programa at polisiya upang maprotektahan at masuportahan ang mga sektor na may higit na pangangailangan kabilang ang child laborers at kanilang pamilya," Reynoso explained.

Meanwhile, Department of Labor and Employment (DOLE) 6 Assistant Regional Director Melisa S. Navarra expressed gratitude to all the DOLE's partners, citing

Additionally, some participants were given access to various entrepreneurship programs through the release of livelihood checks to the parents of child laborers from Brgy. Sapal, San Lorenzo, Guimaras.

Simultaneous services were also offered for free including medical and dental services, processing of clearances and IDs, pampering services like haircut, massage, and nail care, exhibit and distribution of information materials, and other interactive activities or games for children.

Under the "Project Angel Tree," a ceremonial distribution of school supplies, particularly bags containing various school items for child laborers from the various districts of Iloilo City was also conducted.

These activities aim to signify the labor department and partner agencies' commitment to the welfare of the children and the eradication of child labor in the country. (AAL/AGP/PIA 6)

Among the agencies joining the event were the Philippine Statistics Authority (PSA), Government Service Insurance System (GSIS), Social Security System (SSS), Public Attorney's Office (PAO), Department of Information and Communications Technology (DICT), PHILHEALTH, Department of Health (DOH), and the Iloilo Provincial Government Environment and Natural Resources Offices (IPGENRO).

Meanwhile, the Armed Forces of the Philippines also extended security assistance for the event and offered free haircut and medical assistance to the elderly; while staff from the Iloilo Science and Technology University (ISAT-U) Miag-ao campus offered nail care services to the beneficiaries. A newly opened bridge costing P1.2 billion in Isabela province collapsed Thursday night, leaving six – including a child — injured. Part of the bridge collapsed when a dump truck carrying boulders passed over it. The truck was estimated to be weighing 102 tons and was on its way from neighboring Kalinga to the northern part of the province.

The 990-meter Cabagan-Sta. Maria Bridge was only opened to vehicles last month, even as construction began more than 10 years earlier, authorities say.

Heads will roll, the Palace vowed. As they should. Bridges are supposed to connect one area to another to facilitate the movement of goods and people. People take passing bridges for granted – it is never assumed that one might collapse under the weight of any one vehicle using it.

The assumption is that bridges work, because they cost a lot of money, because professionals are supposed to have planned them, because the bidding process for them was transparent and above board, and their construction followed the

specifications to the letter.

People crossing a bridge do so thinking about what they are going to do once they reach their destination on the other side. They hardly fret about whether the bridge is strong enough for the load, whether the right materials were used for its construction or whether irregularities attended any point of the process.

It is a given, not only that heads must roll, but that a full investigation be conducted on the reason for the collapse. It is not enough that someone be pointed to as the culprit behind the incident. More importantly, we have to make sure that no similar event happens in the future.

How many bridges are there in the Philippines, how many sets of plans, bidding documents, and bidders were included in each one? How may government offices, local government units, bids and awards committee members, and other officials are involved in such high-stakes

decisions?

At the same time we wonder: How many other projects were riddled with the same flaws as the ones that determined the unfortunate collapse, and when will they show signs of these imperfections?

Every government project carries with it a presumption of regularity, which makes people confident about using the facility instead of questioning it.

The Isabela mishap was not an accident. It is the inescapable result of corruption, negligence, ineptitude, or a deadly combination of these. Let the consequent probe unearth the reasons, and may these findings be made public so they could serve as a guide on how ordinary taxpayers should demand accountability from their leaders. Bridges are supposed to connect people and facilitate trade and movement, not endanger citizens' lives. (manilastandard.net)

Accelerating mass transit projects

Newly installed Transportation Secretary Vince Dizon, in a recent press briefing, said he aims to accelerate big-ticket transport projects, particularly high mass transit ones as he voiced the need to push forward with more public-private partnerships (PPPs).

His remarks are indeed a welcome development for motorists and commuters alike and serve as an affirmation of the significant contribution of the private sector in realizing large scale projects for public benefit—in this case, with the goal of picking up the pace to complete mass transit projects within a faster timeline.

While there is progress over the years, the pace of developing our mass transit systems remains slow and sluggish compared to our neighboring countries. Delays due to right of way issues, red tape, and financial constraints have significantly slowed progress.

For decades, the Philippine rail system which used to be working back in the day (I remember riding the Philippine National Railways from Paco Station to Bulan, Sorsogon) has been left behind in the region as countries like Indonesia, Thailand, and even Vietnam make huge strides to modernize their mass transit networks.

The launch of the Jakarta Mass Rapid Transit in 2019 for example should serve as a wake-up call for the Philippines—which has long struggled with chronic delays—to accelerate its railway projects and improve the service of existing ones.

I have been to Tokyo, New York, Singapore, London, South Korea, Paris, Hong Kong, and other progressive cities with dependable and efficient rail networks that have

become the default choice for transportation of the people, and I have clearly seen the difference reliable transportation spells for the economy. An efficient transportation network is an economic growth enabler—bridging the gap between rural and urban areas, spurring job creation, facilitating faster trade, and promoting convenience for the riding public.

Sadly, the case is highly different here in Metro Manila where the vast majority is heavily reliant on road transport. The problem with such a situation is road transport is highly prone to congestion and delays. Top of mind of course is EDSA. We've seen the impact on our economy—with billions in losses daily due to traffic gridlocks. All sorts of solutions have been attempted but the problem simply is congestion. No amount of bus lanes and any other solutions

By now, we should have all realized that infrastructure delays bear significant social and economic costs.

It's time to move full speed to finally bring to life these long-awaited mass transit projects, and (hopefully) finally unburden the suffering of millions of Filipinos of daily traffic woes that have long plagued our country.

High mass transit projects are the key to the success of the government's traffic reform program for three primary reasons: to improve connectivity between rural and urban areas, decongest Metro Manila traffic, and ease public transportation woes experienced by millions of daily commuters.

We have seen in the past how collaboration between the public and private sectors have enabled national

progress and with the growing economic demands of our country, the need to accelerate the completion of transport projects—particularly rail systems—have never become more urgent and necessary.

Private sector participation can and should play a key role in the development of these public transport systems. Beyond the financial investment, the private sector can introduce innovation through technology transfer. On the part of the public sector, the government bears the responsibility to cultivate and maintain a regulatory environment that encourages private investment. PPPs after all thrive in an environment of mutual confidence—with both sides working together to deliver projects effectively and efficiently for national progress.

In improving our transportation infrastructure, particularly our rail systems, we must keep in mind that this is a shared responsibility—which if addressed properly—will also result in shared benefits.

While I understand that we are still far from having a public transportation system similar to the likes of Japan and Singapore, I am hopeful that development of key transport projects—particularly rail systems--can be significantly accelerated during the term of President Ferdinand R. Marcos Jr.

Filipino commuters deserve nothing less. We need to act now.

 - 4.1. That the loan agreement shall be for a period of **two (2) years**, commencing from the date of their signing;
 - 4.2. The loan shall earn a compounded interest of 4.9%, every after forty (40) days based on the unpaid amount, including its accrued penalty at two percent (2%) per annum, which is also compounded with the unpaid amount and its interest;
 - 4.3. Payments made by the Defendant/Debtor shall be applied first to the accrued penalties (if any), next, on its accrued interest, and finally applied to the principal amount of the loan; notwithstanding taxes and fees, which shall also be borne by the debtor;
 - 4.4. That in case of default, the Plaintiff/Creditor holds the right to demand, either by notice or writing, immediate payment of the loan and its accrued interest and penalty, from the debtor;
 - 4.5. That No. 7 of the terms and conditions of the said loan agreement enumerates the conditions wherein the Debtor may be considered in default; i.e.:
 - A. "Failure to comply with the covenants or obligations expressed or implied in" the Loan Agreement." (Emphasis added);
 - B. "Failure of Debtor to pay any principal amount or interest for the accumulated period of sixty (60) days from the signing of the Agreement or the last date of payment." (Emphasis added);
 - C. "Insolvency or inability of debtor to pay";
 - D. "An attachment or levy upon, all or substantial part of the Debtor's properties which would materially impair the Debtor's ability to meet his obligation under the agreement.";
 - E. "Violation of any law, regulation, judgment or administrative decision of decree, including non- payment of taxes, in such circumstances where the Creditor reasonably believes that said violation will have an adverse effect on the Debtor's ability to meet his obligations XXXXXXXXX";

- 5. That for reference purposes, the total amount of penalty including the principal, under the said loan agreement is, computed at P13,097,838.01, a copy of the loan computation, based on the conditions of the loan agreement, certified by a Certified Public Accountant, and is mark attached herein as **EXHIBIT** "C" and is made an integral part of this complaint;
- 6. That after the agreed period of **two (2) years** the defendant is expected to have make full payment of the loan amount, including all its interest/s and penalties;
- That the defendant did not pay the amount he borrowed from the plaintiff, including its agreed interest and penalty even after demand has been made;
- 8. That the demand has been made orally through conversation and electronic messages. The proof of demand is corroborated by a certain ISABELLA VERONICA M. DAZON, a copy of her Judicial Affidavit is hereunto mark and attached as **EXHIBIT "D"**, a written demand has been also been sent to the residence of the defendant, A copy of the Demand Letter is attached and sub-mark herein as **EXHIBIT "D-1"** and the LBC receipt is sub-mark as **EXHIBIT "D-2"** and made an integral part of the complaint;
- That on account of the terms and conditions of the Loan Agreement between the Plaintiff and Defendant, the latter is considered in **DEFAULT**, primarily due to his failure to comply with the covenant or obligations, either expressed or implied in the said Loan Agreement;
- 10. That the foregoing circumstances constitute a breach of obligation on the part of the Defendant, and a sufficient cause of action for the plaintiff to file an action for collection of sum of money;
- 11. Therefore, defendant's obligation to pay the Plaintiff the amount of FIVE MILLION ONE HUNDRED THOUSAND (5,100,000.00) Philippine Currency, and all its interest and penalties, is now **DUE AND DEMANDABLE**;

II. SECOND CAUSE OF ACTION

- 12. Defendant's failure to perform his obligation has caused mental anguish on the part of the plaintiff, with the thought of the defendant's absconding from his obligation, prompting them to seek legal assistance for the collection of the borrowed sum of money by the defendant. Plaintiffs incurred additional damages by way of legal fees. A copy of the contract of legal services is herein mark and attach as EXHIBIT "E" and is made an integral part of this complaint;
- 13. Furthermore, under the law, once the debtor incurs a default, the creditor has the right to enforce payment of the credit through legal action. In the same manner, debtor is considered in default upon demand of creditor, and therefore, is obliged to

make payment to the creditor. Default instigates the moment the creditor demands the performance of the obligation. Without the Debtor incurring default, the Creditor sustains no right to enforce payment through the filing of a legal action, the pertinent provision of Art. 1169 of the Civil Code of the Philippines, States That, to wit:

"Those obliged to deliver or to do something incur in delay from the time the obligee judicially or extrajudicially demands from them the fulfillment of their obligation."

In view of the foregoing, plaintiff now seeks, from the defendant, to make full payment of the loan together with all the stipulated interest and penalties that have accrued over the years.

PRAYER

WHEREFORE, premises considered, it is most respectfully prayed of this Honorable Court to render a decision, after due notice and hearing, that judgement be rendered in favor of the plaintiff against the defendant and ordering the latter as follows:

- 1. To perform their obligation as stipulated in the above-mentioned contract and pay the plaintiffs the principal amount of P5,100,000.00, including the interest, penalty and surcharges as provided for in the loan computation;
- 2. To pay plaintiff moral and exemplary damages after just determination by the Honorable Court; and
- 3. To pay plaintiff the amount of 100,000.00 as attorney's fees as well as the cost of suit, including, but not limited to, appearance fee and filing fee.

BIR to taxpayers: Comply with tax obligations

ILOILO CITY (PIA) — The Bureau of Internal Revenue (BIR) kick-starts its regional tax campaign on Feb. 21, reminding the taxpayers to comply with their tax obligations.

Hosted by the BIR Revenue Region No. 11-Iloilo City at the Iloilo Convention Center, the event with the theme "Buwis na Tapat, Tagumpay Nating Lahat," aims to emphasize the shared responsibility of the taxpayers through diligent tax payments, hardwork, and willingness to contribute to national progress and the BIR's dedication to honest and courteous service to every Filipino.

BIR Commissioner Romeo D. Lumagui Jr., who graced the kick-off activity, recognized the significant milestones of the institution, highlighting the result of its service improvements where it has collected more than P2.85 trillion revenue, higher than its tax collection in 2023.

Lumagui said this is not only the highest revenue collection recorded in the Bureau's history but the first time it has ever reached the target set by the Development Budget Coordination Committee (DBCC).

"This is only the result of the tireless efforts of the BIR employees, their commitment, dedication, and countless hours spent serving the public and most importantly, the growing partnership with our institution and the taxpayers. With all these achievements, we would like to congratulate our nation builders – all of us, for our contribution to our

PBBM: Solutions to Kanlaon unrest must be guided by science

BACOLOD CITY (PIA) President Ferdinand Marcos Jr. urged officials of local government units and national government agencies to let science guide their planning for Kanlaon eruption response and redevelopment.

In his visit to La Carlota City in Negros Occidental recently, Marcos, in a briefing with local officials, underscored the significance of scientific data in their planning of both short and long-term solutions for the Kanlaon crisis.

The President said all volcanic hazards and risks issued by the Philippine Institute of Volcanology and Seismology (Phivolcs) must be taken into consideration to ensure the safety of the affected population.

"We have to be the ones to make the plan. But again, it will be guided by science."

According to the President, the locations of the proposed permanent evacuation centers and possible redevelopment areas must be safe from all hazard types, and have critical facilities and infrastructure such as water supply, electricity, roads, and sewage systems among others.

The livelihood and employment of the displaced population must also be given importance, the President pointed out to the mayors of towns and cities around Kanlaon Volcano.

"Hindi lang basta-basta kung saan ilalagay [ang permanent evacuation

centers at redevelopment areas]... Marami ang kailangan na consideration na dapat kasama sa planning," he noted.

(Permanent evacuation centers and redevelopment areas must not be placed anywhere. Plenty of considerations must be included in the planning.)

Meanwhile, local chief executives from the hardhit town and cities of La

Castellana, La Carlota, and Canlaon raised concerns over the rapid depletion of their respective Quick Response Funds (QRF) being used for the food of internally displaced persons (IDPs) and maintenance of of the government in evacuation centers.

As funding concerns grow over the needs of IDPs who remain in evacuation centers amid the active threat of Kanlaon Volcano, the Office of Civil Defense (OCD) recently allocated over P100 million worth of assistance to the affected LGUs in Negros Island.

President Marcos also reiterated the commitment supporting the needs of the Negrense IDPs until this calamity is over and they can finally return to their normal lives. (AGP/BPS/ PIA Negros Occidental)

DSWD Western Visayas starts 'i-Registro ang F1KD sa 4Ps' program



ILOILO CITY (PIA) — The Department of Social Welfare and Development (DSWD) in Western Visayas has commenced the enrollment process for pregnant and lactating mothers (PLMs) among the beneficiaries of the Pantawid Pamilyang Pilipino Program (4Ps).

This initiative is under the "i-Registro ang F1KD sa 4Ps," a digital and self-service platform that simplified the process of enrolling pregnant and lactating 4Ps beneficiaries to the Pantawid Pamilya Information System (PPIS) needed for the implementation and provision of the First 1,000 Days (F1KD) conditional cash grants.

The F1KD program provides monthly health grants worth P350 to female 4Ps beneficiaries who are pregnant and households that have children from 0 to 2 years old.

This additional financial assistance aims to cover essential health and nutrition expenses during this critical period of a child's life and support the prevention of malnutrition and child stunting.

To strengthen the rollout of the registration, the DSWD's National Household Targeting Section (NHTS), led by Regional Field Coordinator Mark Louis M. Babiarte, has conducted a series of orientations and live demonstrations among 4Ps staff in the provinces of the region.

During the special 4Ps meeting in Roxas City, DSWD 6 4Ps Division chief Belen P. Gebusion emphasized that this "digital tool simplifies the process of updating beneficiary information

Heat vegetable oil in a skillet over medium heat; cook and stir onion and garlic until onion is tender, about 5 minutes. Add zucchini, yellow squash, bell peppers, and mushrooms; continue cooking and stirring until vegetables are tender, about 5 minutes more. Pour tomatoes into skillet and season with oregano, basil, red pepper flakes, salt, and black pepper; bring to a simmer. Cook shrimp in vegetables sauce until they are bright pink on the outside and the meat is no longer transparent in the center, about 5 minutes. Serve shrimp and sauce over rigatoni.

BFAR-6 undertakes gender-responsive training for employees
