petitioners' motion for reconsideration.

Earlier, the Sangguniang Panlalawigan passed Resolution 2025-062 authorizing Gov. Defensor to represent the Province of Iloilo before the SC relative to the petitions versus the controversial ruling.

Provincial Administrator Raul Banias noted that the ruling is "a clear Social Injustice for the Artisanal Fishermen and to the autonomy of the local government units (LGUs) that squarely run against the principles of Social Justice that guides us in the province in the formulation of policies and programs."

Banias, a former mayor of the coastal municipality of Concepcion, stressed that the ruling threatens the livelihoods of small scale fisherfolk, destroys marine biodiversity, and undermines the efforts of the LGUs in sustainable fisheries management.

Atty. Anfred Panes was elected Secretary with 635 votes against Atty. Kchyrziahshayne Dinopol who obtained only 122 votes.

Atty. Esther Lee-Trimañez who was unopposed to the position of Treasurer was elected with 709 votes.

In the Auditor position, Atty. Jordana Mari Jaco won against Atty. Peter John Pacheco with 567 votes against the latter's 166.

Atty. Ma. Theresa Malones-Sanchez was elected Public Relations Officer with 564 votes defeating her opponent retired Prosecutor Jeremy Bionat who got only 191 votes.

Meanwhile, all the elected Board of Directors also came from the Team Abanse, namely: Atty. Christian Arfel Cuadras who got 632 votes, Atty. Ian Thomas Besana – 628 votes, Atty. Doni June Almio – 580 votes, Atty. Doriedel Lozañes – 551 votes, and Atty. Alfred Clement Palmares – 522 votes.

The IBP-Iloilo Chapter election this year was marred by controversy after Atty. Ronnie Delicana, who ran for Director under Atty. Reyes's slate, filed an election protest against Penetrante citing that she allegedly is a government employee working as a professor at West Visayas State University (WVSU).

The Election Committee of IBP-Iloilo Chapter, however, dismissed the protest as Penetrante was not a regular employee of WVSU and has not renewed her contract with the state university.

DICT launches eGovPH and kicks off eLGU IN Iloilo

The Department of Information and Communications Technology (DICT) launched its eGovPH mobile application and kicked off eLGU at Iloilo Convention Center in Mandurriao District on Tuesday, February 25.

The event was graced by DICT 6 Regional Director Ralph Joseph Moncatar, Government Digital Transformation Bureau (GDTB) Director June Vincent Manuel Gaudan, among others

Local leaders from municipalities in Iloilo Province along with other stakeholders have also joined forces to support eGovPH and eLGU, promoting innovation and convenience through this initiative.

Iloilo Governor Arthur Defensor Jr. and Iloilo City Mayor Jerry Treñas through their representatives, also showed their support to DICT's approach for a seamless transaction which will also boost the city and province of

eGovPH is a one-stop-shop platform composed of different government services including PhilHealth, Social Security System (SSS), PAG-IBIG, Government Service Insurance System (GSIS), Bureau of Internal Revenue (BIR), among others. This app aims to ease the transaction of citizens through mobile digitalization.

In his message RD Moncatar acknowledged the significant people behind the eGovPH team for making the app possible through technological advancement.

"This is a significant step towards transforming the way we serve our communities and citizens through modern technology," Moncatar said.

Moncatar emphasized that eGovPH and eLGU aim to modernize and simplify local government services, making them more accessible, efficient, and transparent.

On the other hand, Gaudan stressed the significance of digitalization in Iloilo for faster economic growth and to provide better services, with the help of local officials, stakeholders, and the community.

"Although rooted in culture, we need to move forward with technology... The core of DICT solutions are simplification, integration, security, automation and sustainability," said Gaudan.

The said initiative aims to provide 66.5 million liters per day (66.5 MLD) of potable or drinkable water through the use of advanced reverse osmosis technology that will benefit over 400,000 residents or around 50,000 households in Iloilo City.

Significant figures have joined the groundbreaking ceremony including Metro Pacific Investments Corporation Chairman, President and Chief Executive Officer Mr. Manny Pangilinan, Department of the Interior and Local Government (DILG) Secretary Juanito Victor "Jonvic" Remulla, Iloilo City Mayor Jerry Treñas, Iloilo Governor Arthur Defensor Jr., LWUA Administrator Mr. Jose Moises Salonga, and LWUA Chairman Mr. Ronnie Ong, among others

During his speech, Treñas expressed his excitement for witnessing the groundbreaking ceremony of the said project, highlighting its significance towards Iloilo City's economic growth in terms of having a reliable and sustainable water supply to the community.

Gov. Defensor also expressed his gratitude for the said project, calling it a "game changer". He also acknowledged Metro Pacific's efforts for the previous project partnerships and hopes for a more collaboration along with other stakeholders to the further development of the city and province of Iloilo.

In an interview, Mr. Angelo David Berba, chief operating

officer (COO) of Metro Pacific Iloilo Water (MPIW) stated that the energization of the desalination plant will be in the first quarter of 2027 as local and national permits along with tariff increase will be processed and secured first to have the desalination plant granted.

The prices or tariff for water distribution will depend on LWUA-approved tariff rates whether it's commercial or domestic. Commercial rate ranges from Php40 to Php50 per cubic meter while Domestic costs Php25 per cubic meter.

In terms of waste to energy technology, Berba noted that they will be getting about three to four megawatts of power source from the Integrated Solid Waste Management Facility (ISWMF) which is also located in the said barangay.

They will also be getting power from power providers including MORE Power, Meralco Thermal (previously Global Business Power Corp.), and other major power distributors in case ISWMF will not be ready yet.

Berba said that the desalination plant in Ingore will be the biggest bulk water supplier once it will be energized in 2027, which will be bigger than the other bulk water suppliers such as Flo Water that distributes 30 MLD of water, and Metro Iloilo Bulk Water Supply Corporation that provides 50 MLD.

Meanwhile, SUEZ will be handling the design and operation of the desalination plant through the use of membrane technology before handling it to the local communities while JEMCO will be in charge of its construction.

Cash benefits under Expanded Centenarian Act starts implementation

Meanwhile, for 2025, more than Php2.9 billion will be distributed to over 275,000 senior citizens nationwide through the efforts of the National Commission of Senior Citizens (NCSC) and other partner government agencies.

Iloilo town committed to preserve indigenous cultural heritage

ILOILO CITY (PIA) — The local government unit (LGU) of Tubungan town remains steadfast in its commitment to preserving the cultural heritage of its Indigenous Peoples (IP) and advancing educational development.

In collaboration with the Department of Education, the LGU has expanded its Schools of Living Tradition (SLT) with the inauguration of three additional schools in the town.

Municipal IP Focal Person and Public Employment Service Office (PESO) Head Emelyn Tano said the inauguration of the SLTs at Victoria Integrated School (VIS) and Bato Elementary School (BES), and Igdampog Elementary School (IES) located in their respective villages, marked the fourth of five planned SLTs in the municipality.

Retirement haven or hell?

As one of the many Filipinos married to a foreigner, I am particularly sensitive to matters that affect foreigners in the Philippines, particularly their safety and security. As a Christian, I take to heart the repeated reminders of God in the Bible:

Exodus 22:21 – "Do not mistreat an alien or oppress him, for you were aliens in Egypt."

Leviticus 19: 33 – "Do not mistreat foreigners who are living in your land. Treat them as you would a fellow Israelite and love them as you love yourselves. Remember that you were once foreigners in the land of Egypt. I am the Lord your God."

I can quote many other verses all the way to the gospel of Jesus Christ, but I might already be preaching to the choir, as they say. Another reason I'm sensitive to the plight of foreigners in the Philippines is because we are the most present "foreign population" globally.

From OFWs, immigrants, TNTs now living in fear of the Trump forces to nurses in the UK, Japan, etc., there are millions upon millions of Filipinos living as aliens abroad. I was once one of them and I benefitted from the kindness as well as experienced the discrimination and exploitation.

Today, let me share the sentiments and pain experienced by one of many Koreans who was evicted from Camp John Hay by the BCDA.

"Ten years ago there were more Koreans living in Baguio. Now there are less because of bad coverage in media about Koreans being targeted by some Filipinos. This will only add more to the bad horror stories that Koreans have been having in the Philippines.

"So why can't we just turn around and make this a good story where Korean rights were protected, and we can go around and tell other people to come to the Philippines. My wife is Filipina so of course I want the Philippines to be better and richer. My daughter is half Filipina, of course I want the Philippines to be a better country.

"So why can't we make this into a good example where if a Korean person asked me and say I want to invest in the Philippines, I want to retire there, should I go? What can I tell them? Of course I'll tell them No! Even though I married a Filipina, and my child is Filipina.

"The government will steal your money, and they will not respect your rights. The sheriffs, even though they are supposed to come after 30 days, they will not respect it. They will turn off water and electricity every single day.

"Why should I lie to my own countrymen? I will talk to them honestly. So, I hope this can become a good example, whenever there is bad news in Korea about the Philippines, I can tell then 'no, that's not what happened" if they followed the due legal process.

"'The Philippine government will listen to you. They are fair.' That is what I want to say to my daughter and my wife and to other Korean people. But from what I saw now, I cannot say that.

"Everyone does not want to be evicted from their home. No country can stand safe if all the citizens are afraid that the police may show up just like what happened to us. Our child was locked in the room, and they sealed the room and I'm not able to enter my own house where my child is.

"Who wants to live in a country like that? Who wants to live in a country where 20 policemen can one day show up and evict you? No society can be healthy that way. So I believe the more people find this out, and if the President (PBBM) and the Mayor (Benjie Magalong) and the reporters help us, we have a good chance.

"No one wants to live in a country where they can be evicted with their child in 24 hours. No one wants to live in that country.'

When asked by media what the Philippine

Retirement Agency was doing, Eric Pati, who heads PRA-DOT CAR-Northern Luzon, stated:

'The prime mandate of the PRA is to entice foreigners, foreign retirees and Filipino retirees to come to the Philippines and make the Philippines as their second home.

"Part of our prime mandate is to protect and assist our retiree members.

"Our target is to make the Philippines the first-place retirement haven in Southeast Asia and hopefully these kind of issues will be resolved and to get rid of the negative impact – multiplier effect when they go home and then they will tell of the horrible experiences they had. "If these affected foreign retirees will go home, they would tell stories, there's no permanency there and everything, it would defeat our purpose of promoting the retirement industry of the Philippines. That's why all of us in the PRA are worried about the situation.

"It will reverse or overturn the efforts to entice. That's why management is now on top of the situation, reading posts on Facebook and why we will be meeting all our retirees (under PRA) who are affected."

What if K-pop and Korean telenovela stars start commenting on this miscarriage of justice in the Philippines? That would hit us 100 times harder!

Job applicants

Snubbing public debates worked for the UniTeam for president and vice president. in 2022. On the other hand, attending debates worked for Rodrigo Duterte in 2016.

And getting to know applicants for elective office always works for voters, especially in this age of disinformation and the decline in the quality of Philippine education.

Debates can help level the playing field, allowing candidates who are qualified but relatively unknown and with modest war chests to shine against wealthy but unworthy rivals whose main qualification is their

A nationally televised debate can give voters an idea of the capabilities and personalities, for example, of those who are seeking Senate seats, currently dominated by a largely disappointing

So it's good to know that the Commission on Elections is considering making attendance of candidates in debates mandatory.

Obviously, this cannot be done for all elective positions, and the requirement cannot be applied to all debates staged by every Juan and Juana.

The Comelec will have to clearly define the debate parameters, and limit the attendance requirement to races with only a handful of candidates, such as in the contests for president and vice president.

A debate among the organizations vying for party-list seats can be unwieldy. As for the more than 60 Senate aspirants, perhaps they can be made to draw lots for division into groups whose members can then face off in a Comelec-approved debate.

Mandatory attendance can be limited to only one debate for the position at stake. The debate must be registered and coordinated with the Comelec.

For local posts, debates can be organized for the positions of congressman, governor, vice governor, mayor and vice mayor.

If mandatory attendance at debates cannot be implemented in time for the elections this May, the Comelec can prepare for such a requirement for the general elections in 2028, at least for the races

No talk, no mistake was among the strategies that contributed to the stunning victory of Ferdinand Marcos Jr. and his running mate Sara Duterte in

The pair snubbed all debates and gave interviews only to friendly folks and organizations.

On the other hand, in 2016, candidate Rodrigo Duterte saw his ratings rise steadily after he attended the presidential debate organized by TV 5 in Cebu.

The start of the debate was marred by inordinate delay – to borrow the current go-to excuse for the mass dismissal of the Marcoses' ill-gotten wealth cases - after then vice president Jejomar Binay questioned the debate rules.

During the long wait, Binay's rival Mar Roxas was in a snit and snapping at everyone backstage. Duterte, who had initially sent word that he would not attend the debate, left his rivals and walked onto the stage with a bemused look on his face. He saw me fanning myself at the interviewers' table at the end of the nearly empty hall, waved and began cracking jokes – all while the live broadcast of the show continued.

It was vintage Duterte, putting his formidable natural folksy charm on full display to the nation. When the debate finally got underway, after a delay of over an hour during which tempers became frayed, his rivals pounced on Duterte for his human rights record.

Unfazed, an unapologetic Duterte poked fun at his rivals, bragged about his human rights record and even promised to kill, kill, kill, and to jet-ski to Panatag (Scarborough) Shoal.

We all know what happened: voters watched Duterte, who had entered the presidential race at the last minute, and liked what they saw.

After the debate, he was the only candidate who was mobbed by supporters outside the venue. In the next days, his rivals saw his ratings surge past the erstwhile frontrunner, Grace Poe.

The rivals

scrambled to



catch up, belatedly putting peace and order high on their campaign agenda. But it was too late; Duterte had become unstoppable.

Candidate BBM was dogged during his presidential campaign by what he described as the sins of his "ancestors." Did Imeldific complain about being described as ancient? BBM also skirted his tax evasion case involving his clan's extensive real estate holdings, of which he was the administrator.

The Marcos camp then decided to control the campaign narrative, through the skillful use of social media - a tack that his opponents only belatedly caught on to and tried to use.

Complementing this approach was BBM's steadfast avoidance of presidential debates. Inday Sara followed the UniTeam leader. As we have seen in her public appearances, she lacks the natural charisma of her father.

Today, however, with artificial intelligence facilitating the spread of fake news and malicious content online, people are increasingly learning to take with a grain of salt information obtained from social media – much of which is unfiltered, anonymous and therefore lacking accountability.

Even pop-up ads online promoting candidates can have the opposite effect, which is to annoy and turn off the recipients. Such materials are intrusive and irritating, like those campaign posters that assault us from electric poles, trees, utility wires and walls of government buildings.

Debates offer a credible platform for voters to get to know candidates. Job applicants must pass interviews before being hired. Why should applicants for government jobs that seriously affect our lives be spared from public grilling?

4 Antique towns institutionalize 'Kadiwa' for farmers, **MSMEs**

SAN JOSE DE BUENAVISTA, Antique - Four local government units (LGUs) are working on ordinances to institutionalize the Katuwang sa Diwa at Gawa para sa Masaganang Ani at Mataas na Kita or Kadiwa ng Pangulo.

The initiative being pushed by the towns of San Remigio, Tobias Fornier, Anini-y, and Bugasong aims to give farmers, fisherfolk, and micro, small, and medium enterprises (MSMEs) direct market

Betty Baldevia, Agri-Business and Marketing Coordinator of the Office of the Provincial Agriculturist (OPA), said Wednesday that Kadiwa eliminates middlemen, allowing sellers to earn more by offering products at farmgate prices.

"The LGUs found the Kadiwa effective in helping their farmers, fisher folks and MSMEs be able to sell their produce without going through the middlemen, anymore," she

She added that farmers, fisherfolks and MSMEs can earn more by selling their produce at farmgate prices during the Kadiwa or trade fair.

With the provincial board approving a provincial ordinance for Kadiwa on Feb. 17, OPA plans to coordinate with LGUs to hold monthly trade fairs across municipalities to boost local product sales.

"We plan to hold the monthly Kadiwa in the various municipalities to help promote and sell the products of the farmers, fisher folks and MSMEs," she said.

A meeting with the Department of Labor and Employment (DOLE) and other agencies on March 4 will determine the venues for this year's Kadiwa events.

Participants may also qualify for DOLE's Tulong Panghanapbuhay sa Ating Disadvantaged Workers (TUPAD) program, receiving a PHP480 daily wage during the trade fair.

In 2024, eight Kadiwa trade fairs generated PHP1.4 million in sales, benefiting farmers, fisherfolk, and MSMEs.


Earlier this month, the Department of Health blasted the siren on the rising number of dengue cases in the country, particularly those in Metro Manila, Calabarzon and Central

On Feb. 17, the DOH said there were eight other local government units that have logged "a concerning rise" in the number of patients with dengue, with Quezon City announcing a dengue outbreak after 10 died from the viral infection in recent weeks.

Dengue is a viral infection spread by mosquitoes that causes fever, muscle and joint pain, and rash. It can range from mild to severe, and sometimes fatal.

The first reported dengue outbreak in the Philippines was in 1906, and the first epidemic of severe dengue was in 1953. Authorities now say dengue has become endemic in the Philippines and is a major public health problem.

In the Philippines, children and adolescents are at the highest risk of dengue infection. In the study of 2,103 hospitalized pediatric cases of suspected dengue, 86.1 percent were

were considered severe dengue.

It appears the government's 4S campaign - "Search and Destroy" mosquito breeding places, "Secure Self Protection" from mosquito bite, "Seek Early Consultation" when signs and symptoms of dengue occur, and "Say Yes to Fogging" as a last resort when there is an impending outbreak – is on the success roll..

From Jan. 5 to 18, the DOH said it recorded 15,904 new cases, which dropped to 15,134 from Jan. 19 to Feb. 15.

The DOH attributed this improvement to heightened public awareness, intensified cleanup efforts, and strengthened vector control measures.

While there is this short-term decline, the overall dengue burden remains significantly higher than last year.

From Jan. 1 to Feb. 15, 2025, the country

laboratory confirmed, and over 80 percent recorded 43,732 cases, a stark increase from **27,995** in the same period in **2024**.

> The highest number of cases have been reported in CALABARZON (9,113), the National Capital Region (7,551), and Central Luzon (7,362), with 17 local government units identified as dengue hotspots, the health department stated.

> However, the agency stated that the case fatality ratio decreased to 0.38 percent from 0.42 percent last year, indicating improved case management.

> LGUs have themselves launched intensive vector control measures and clean-up drives to eliminate mosquito breeding sites," it added.

> The slight downturn has been attributed to heightened public awareness resulting from intensified information campaign by the government against the deadly mosquito-borne **disease.** (manilastandard.net)

Ensuring water access

With the various technological advancements in today's society, it may come as a surprise to many that access to basic needs remains a critical issue, especially in rural and remote areas.

Around 40 million Filipinos as of 2024 still lack access to formal water resources and are instead dependent on rainwater, rivers, or creeks for their daily needs, according to the Department of Environment and Natural Resources (DENR) underscoring the greater urgency of addressing the problem of water access in the country.

While water costs are relatively lower compared to other basic needs, such as food, shelter, clothing, many areas in the Philippines still lack the necessary infrastructure to provide potable water to underserved communities due to the high amount of investment needed. DENR estimates show that around PHP250 billion in investments is needed for basic water access in the country.

Government cannot do this alone, which is why the private sector must step up to bridge the gap. Beyond the financial investment, private enterprises are in the best position to introduce technological advancements and innovative solutions to accelerate the provision of potable water to underserved communities.

Just recently, business leader and philanthropist

Manuel V. Pangilinan, more commonly known as MVP, led the recent groundbreaking of the largest desalination plant in Metro Iloilo which, once completed, can turn saltwater into potable water.

The PHP5 billion facility – a project spearheaded by Metro Pacific Water together with French water solutions provider Suez - is expected to produce more than 66 million liters of water daily. This is equivalent to providing potable water access to around 400,000 households, making it a prime example of the power of private sector investment.

Another example is the Water Access Electrification Program of Meralco's social development arm One Meralco Foundation. The foundation just recently energized the water system of Barangay Guinsangan in South Cotabato, which has limited access to reliable water supply.

These projects are concrete demonstrations of how private sector investment can introduce long-term innovative solutions to address the country's water challenges, which will not only benefit public health but also contribute to economic development.

The urgency and importance of providing water access to underserved communities cannot be overemphasized given that this is the most basic human requirement for health and well-being.

Water is simply a necessity. Without potable water, it is impossible to ensure a community's survival and health, both of which are necessary in the growth of a nation. Lack of water access can trap communities in poverty, limiting access to hygiene and sanitation, exposing children and the elderly to greater risk of illnesses, endangering food security, and even stunting economic productivity as people are forced to spend hours to find potable water sources or collect and store water.

In short, water access can spell the difference between life and death.

It is in this light that the private sector can play a critical role in providing water access for underserved communities here in the country.

Providing and ensuring water access for all is a win-win situation that not only nurtures and protects life, but also ensures continuous economic productivity for collective progress. By investing in new technologies, introducing innovative designs, and partnering with the government, private entities can help pave the way not only for water access but water security for future generations to come.

Asteroid probabilities and anxiety

over the world were mesmerized by the news that an asteroid named 2024 YR4 had a slight probability of hitting the Earth in 2032. Initially, scientists from the National Aeronautics and Space Administration's (NASA) Center for Near Earth Object Studies calculated that the 300 ft. wide asteroid had a 2.3 percent chance of hitting the Earth in December of 2032. In a few days, the estimated chance of impact became 3.1 percent. The Internet then exploded with hundreds of doomsayers predicting a great calamity. Today, the probability of impact has gone down to .001 percent or near zero.

The recent interest surrounding the asteroid 2024 has highlighted the need for people to understand numbers, facts, and sciences more. During the weeks where the probability of impact was going up, thousands of posts and videos about the asteroid were beginning to cause some anxiety to many people. Apparently, people focused on the phrase "probability of impact" without understanding the science. Then people

During the last few weeks, people all became focused on the Torino Scale, which is a zero to ten index measure of the danger of an asteroid impact. Asteroid 2024 YR4 rated a three in the said Torino scale and the anxiety level for some became even higher. Some people seem to revel in wallowing in what some call apocalyptic anxiety. Some people on the other hand seem to enjoy causing such anxiety by harping on the alleged dangers.

> A deeper understanding of probabilities would have put things in better perspective. First, even the initial probability of a hit was quite small. A probability expert explained to me that with those odds, the probability of dying from an asteroid is lower than being killed by a crab.

> Second, with the earth mostly covered by water, the chances of hitting land were also quite small. Third, even if it hit land, the probability was high that it would hit an unpopulated area. Lastly, just looking at the size of the asteroid would have shown that it is at worst a city killer and not an extinctionlevel event asteroid strike.

OBLIQUE OBSERVATIONS

The fact is that the anxiety one feels because of the fear of an asteroid hit has a higher chance of doing damage than the aforesaid asteroid itself. Anxiety in itself can lead to more serious illnesses that can do more harm.

There are many things happening around us that can cause anxiety. We can lessen our anxiety just by looking at the science and math. We can further lessen it by just being prepared. The so-called big earthquake for Metro Manila is a sure bet. We just don't know when it will hit. If you truly want to be anxious. You can be anxious about that or you can prepare for these things. Of course, if you want to still be anxious about the asteroid, you can hold on to the fact that the chances of asteroid 2024 YR4 hitting our moon are still within the realm of possibilities.

This is my oblique observation.

Of ghost students and stolen education

Now, this is truly disturbing. On top of the alarming findings of EDCOM II on the failures of the Philippine educational system, we now face the issue of "ghost students" in private schools. The Department of Education (DepEd) has flagged 12 private schools for listing nonexistent students as beneficiaries of the government's Senior High School Voucher Program (SHSVP). The scale of this deception is significant, with the fraudulent vouchers amounting to PHP52.5 million for School Year 2023-2024 alone.

Pulling off such a scheme requires collusion within the ecosystem of the voucher program, raising serious concerns about oversight and accountability.

What makes this even more disheartening is that millions of students struggle to enroll in senior high school. A Senate hearing in 2023 revealed that out of six million Filipinos aged 16 to 18 years old, only 68 percent or about four million – were enrolled. Many factors contribute to this crisis, with economic hardships topping the list. Poverty, the high cost of education, the need to work and support their families, and the lack of access to schools in remote areas all prevent students from continuing their education.

senior high school students were enrolled in private schools during School Year 2023-2024, the same period when "ghost students" were flagged in 12 private schools. In contrast, 1,081 private senior high schools, accounting for 98.89 percent of the total, remained unaffected by the issue during the same school year. Talk about a bad apple spoiling the bunch.

The government introduced the voucher system to subsidize deserving Grade 11 and Grade 12 students in participating private schools. It intends to support the education of deserving but impoverished students, providing subsidies ranging from PHP14,000 to PHP22,500, contingent on their location. in monitoring and accountability within the To ensure the efficient use of these funds, DepEd directly distributes the vouchers to

the beneficiaries' chosen schools.

If we take the average subsidy per student at PHP18,250, the PHP52.5 million worth of fraudulent vouchers means that 2,877 poor students were denied access to education. Private schools already benefit financially by enrolling students through the voucher program, yet some have resorted to unethical practices to exploit the system.

In my previous columns, I have always emphasized the value of education and the lengths to which families go to send their children to school. I know many families who disliked the K-12 system, as it added two more years before their children could finish high school. Yet despite these concerns, Filipino families adapted to the new system, fully aware that their sacrifices would ultimately benefit their children's future.

I now fear that the discovery of "ghost students" will have consequences for legitimate beneficiaries. The DepEd's SHSVP raises serious concerns about the integrity of the voucher system and the effectiveness of subsidies in education. Fraud on this scale undermines the very purpose of the program, which is to provide financial support to underprivileged but deserving students. Data from DepEd shows that 1,474,702 When funds meant for real students are siphoned off through fraudulent means, thousands of eligible learners are deprived of access to education, further widening the already significant gap in senior high school enrollment.

> The credibility of the voucher system itself is also at risk. If such schemes go unchecked, public trust in the program could erode, potentially leading to stricter regulations or even reductions in funding. This could hurt legitimate students and private schools that genuinely rely on government support to continue providing quality education. Additionally, the involvement of multiple parties in the fraud suggests weaknesses system, exposing vulnerabilities that could be exploited further if left unresolved.

FRESH VIEWPOINTS: **A NEW PERSPECTIVE**

Beyond financial losses, the misuse of education subsidies contributes to systemic inefficiencies and deepens existing inequalities in access to quality education. Instead of addressing the barriers that prevent students from enrolling in senior high school – such as poverty, high tuition costs, and lack of nearby schools - the fraudulent use of public funds diverts attention and resources away from necessary reforms. If this issue is not effectively addressed, it could discourage policymakers from expanding or improving similar subsidy programs in the future, ultimately affecting the long-term prospects of education accessibility in the country.

Now, I hear that Education Secretary Sonny Angara is leaving no stone unturned in exposing the fraud in the voucher system. He has vowed to prosecute those involved, which comes as a relief to us, citizens. After all, President Ferdinand R. Marcos Jr. has pledged to fight corruption in his administration.

Last week, I came across a news report about a school principal who was sentenced to 11 years in prison for "pocketing" PHP5,000 a measly sum compared to the PHP52.5 million voucher fraud. This stark contrast highlights the urgent need for a concerted effort from the government to ensure that those who conspired to defraud the system are brought to justice. It is not enough to simply uncover the fraud; authorities must relentlessly pursue and hold accountable those who stole funds meant for poor and deserving students. Only through decisive action can the integrity of the voucher system be restored and public trust upheld.

free from violence and oppression," said Kezzie Lyn B. Hilado, coordinator of Ugsad Regional Gender Resource Network in her opening message.

She further underscored that this event is more than just a campaign as it is a movement, a revolution, and a promise to create a world where women, girls, and gender-expansive people live free from violence and fear.

"As we rise today, we honor the voices of survivors, reaffirm our unwavering commitment to gender justice. and our solidarity to all those who continue to rise against oppression. Our voice, our actions, and our collective strength is a people matter. So let us rise, resist, and unite for a future where freedom and equality are not privileges, but fundamental rights for all," Hilado added.

Some of the key partners expressed their support in the biggest mass action to end violence against women and girls.

In a solidarity message, the chief of the Promotion and Education Division of the Commission on Human Rights Region 6 Christopher Montaño believes that for us to truly rise together, the community needs to cooperate, stand for the values of dignity, respect, inclusion, human rights' care and above all, love.

"On behalf of our office, we will continue and we commit in solidarity with each one of you that together we will fight to ensure that the rights of our women and girls will always be upheld," stated Montaño.

The annual activity aims to show the local communities and the world what one billion looks like and shed light on the rampant impunity and injustice survivors often face.

Tano emphasized that this initiative is crucial in safeguarding traditional knowledge, including music, dance, arts, crafts, and indigenous livelihoods.

The IP Schools of Living Tradition provide a venue for integrating these cultural practices into the educational framework, ensuring that younger generations inherit and sustain these essential traditions which not only promotes cultural preservation but also equips the IP community with valuable skills for the future.

"The crucial role and support of the LGU are instrumental in ensuring that traditional knowledge is passed down to younger generations, fostering a sense of identity and pride among the IP community," said Tano.

She added that by preserving cultural heritage and empowering Indigenous communities, the SLT program also contributes to peace-building efforts and the holistic peace and development of the community, aligning with the Philippine government's "Whole-of-Nation" approach.

COMPLAINT

COMES NOW, the plaintiffs, through the undersigned counsel, and unto this Honorable Court, most respectfully avers, that;

- 1. The parties may be served with summons and other processes of this Honorable Court thru the undersigned counsel at his office address at FMB Bldg., 7th St. Lawaan Village, Balantang, Jaro, Iloilo City;
- 2. For this complaint, the heirs of **JAN PAUL MARK BOSQUE** is represented by FEMY C. BOSQUE who is of legal age, married, Filipino and a resident of Brgy., Devera, Sara, Iloilo. A copy of the Special Power of Attorney of the heirs, is hereto attached and marked as EXHIBIT "A" and made an integral part of this complaint;
- 3. On the other hand, defendant JEVRON PAROHINOG, of legal age, single, Filipino and is residing in Sitio Calumpang, Brgy. Poblacion, Zone 2, Estancia, Ioilo; where he may be served with summons and court processes by this Honorable Court;

I. FIRST CAUSE OF ACTION

- 4. That on February 8, 2021, defendant requested for a loan from the late JAN PAUL MARK BOSQUE in the amount of FIVE MILLION ONE HUNDRED THOUSAND PESOS (P 5,100,000.00) to which he was granted by the deceased. With this, the parties entered a Loan Agreement signifying the following conditions:
 - 4.1. That the loan agreement shall be for a period of **two (2) years**, commencing from the date of their signing;
 - 4.2. The loan shall earn a compounded interest of 4.9%, every after forty (40) days based on the unpaid amount, including its accrued penalty at two percent (2%) per annum, which is also compounded with the unpaid amount and its interest;
 - 4.3. Payments made by the Defendant/Debtor shall be applied first to the accrued penalties (if any), next, on its accrued interest, and finally applied to the principal amount of the loan; notwithstanding taxes and fees, which shall also be borne by the debtor;
 - 4.4. That in case of default, the Plaintiff/Creditor holds the right to demand, either by notice or writing, immediate payment of the loan and its accrued interest and penalty, from the debtor;
 - 4.5. That No. 7 of the terms and conditions of the said loan agreement enumerates the conditions wherein the Debtor may be considered in default; i.e.:
 - A. "Failure to comply with the covenants or obligations expressed or implied in" the Loan Agreement." (Emphasis added);
 - B. "Failure of Debtor to pay any principal amount or interest for the accumulated period of sixty (60) days from the signing of the Agreement or the last date of payment." (Emphasis added);
 - C. "Insolvency or inability of debtor to pay";
 - D. "An attachment or levy upon, all or substantial part of the Debtor's properties which would materially impair the Debtor's ability to meet his obligation under the agreement.";
 - E. "Violation of any law, regulation, judgment or administrative decision of decree, including non- payment of taxes, in such circumstances where the Creditor reasonably believes that said violation will have an adverse effect on the Debtor's ability to meet his obligations XXXXXXXXX";

A copy of the Loan Agreement is attached herein as **EXHIBIT** "**B**" and is made an integral part of this complaint;

- 5. That for reference purposes, the total amount of penalty including the principal, under the said loan agreement is, computed at P13,097,838.01, a copy of the loan computation, based on the conditions of the loan agreement, certified by a Certified Public Accountant, and is mark attached herein as **EXHIBIT "C"** and is made an integral part of this complaint;
- That after the agreed period of two (2) years the defendant is expected to have make full payment of the loan amount, including all its interest/s and penalties;
- That the defendant did not pay the amount he borrowed from the plaintiff, including its agreed interest and penalty even after demand has been made;
- 8. That the demand has been made orally through conversation and electronic messages. The proof of demand is corroborated by a certain ISABELLA VERONICA M. DAZON, a copy of her Judicial Affidavit is hereunto mark and attached as **EXHIBIT "D"**, a written demand has been also been sent to the residence of the defendant, A copy of the Demand Letter is attached and sub-mark herein as **EXHIBIT "D-1"** and the LBC receipt is sub-mark as **EXHIBIT "D-2"** and made an integral part of the complaint;
- That on account of the terms and conditions of the Loan Agreement between the Plaintiff and Defendant, the latter is considered in **DEFAULT**, primarily due to his failure to comply with the covenant or obligations, either expressed or implied in the said Loan Agreement;
- That the foregoing circumstances constitute a breach of obligation on the part of the Defendant, and a sufficient cause of action for the plaintiff to file an action for collection of sum of money;
- 11. Therefore, defendant's obligation to pay the Plaintiff the amount of FIVE MILLION ONE HUNDRED THOUSAND (5,100,000.00) Philippine Currency, and all its interest and penalties, is now **DUE AND DEMANDABLE**;

II. SECOND CAUSE OF ACTION

- 12. Defendant's failure to perform his obligation has caused mental anguish on the part of the plaintiff, with the thought of the defendant's absconding from his obligation, prompting them to seek legal assistance for the collection of the borrowed sum of money by the defendant. Plaintiffs incurred additional damages by way of legal fees. A copy of the contract of legal services is herein mark and attach as EXHIBIT "E" and is made an integral part of this complaint;
- 13. Furthermore, under the law, once the debtor incurs a default, the creditor has the right to enforce payment of the credit through legal action. In the same manner, debtor is considered in default upon demand of creditor, and therefore, is obliged to

make payment to the creditor. Default instigates the moment the creditor demands the performance of the obligation. Without the Debtor incurring default, the Creditor sustains no right to enforce payment through the filing of a legal action, the pertinent provision of Art. 1169 of the Civil Code of the Philippines, States That, to wit:

"Those obliged to deliver or to do something incur in delay from the time the obligee judicially or extrajudicially demands from them the fulfillment of their obligation."

In view of the foregoing, plaintiff now seeks, from the defendant, to make full payment of the loan together with all the stipulated interest and penalties that have accrued over the years.

PRAYER

WHEREFORE, premises considered, it is most respectfully prayed of this Honorable Court to render a decision, after due notice and hearing, that judgement be rendered in favor of the plaintiff against the defendant and ordering the latter as follows:

- 1. To perform their obligation as stipulated in the above-mentioned contract and pay the plaintiffs the principal amount of P5,100,000.00, including the interest, penalty and surcharges as provided for in the loan computation;
- 2. To pay plaintiff moral and exemplary damages after just determination by the Honorable Court; and
- 3. To pay plaintiff the amount of 100,000.00 as attorney's fees as well as the cost of suit, including, but not limited to, appearance fee and filing fee.
