# **Iloilo International Airport** to undergo major upgrades

TWO key projects of the Department of Transportation (DOTr) and the Civil Aviation Authority of the Philippines (CAAP) under the Iloilo International Airport Development Program are currently in the mobilization phase, with a combined allocation

of over PHP 190 million from the DOTr General Appropriations Act (GAA) 2024, downloaded to CAAP.

These infrastructure upgrades follow the directive of President Ferdinand R. Marcos Jr.

Dizon to modernize the country's transport hubs under the Build Better More program.

The first project, with a total cost of PHP 132.90 million, focuses on the rehabilitation and improvement of and DOTr Secretary Vince the Passenger Terminal

**Redevelopment of Iloilo City's 5 markets** near completion

THE simultaneous construction and redevelopment of five public markets in Iloilo City are in full swing and they may open within the year.

This was disclosed by Iloilo Mayor Jerry Treñas as he provided updates on the ongoing projects during a press conference last June 3, 2025.

The redevelopment of two market malls-Iloilo Central Market and Iloilo Terminal Market-are funded through the public-private partnership (PPP) between the city government and SM Prime Holdings, Inc. (SMPHI).

"SM has informed me that their construction will be completed by September and October 2025. By September, our vendors can start moving in, and operate together with the opening of the mall-Iloilo Central Market-in October. I don't want our vendors to start operating before the mall is finished, because that would defeat the purpose of ensuring good business for them," Treñas explained. Treñas added that the Arevalo Market is expected to be completed first among the public markets under redevelopment and may open as early as October this year. The La Paz Market follows closely, as it is already fully funded and complete with the necessary facilities. "The last to be finished will be the Jaro Market, since it is the biggest in the city. But it will also be the most improved, with a designated parking area and a police station to be constructed at the back to help monitor illegal activities, especially drug-related concerns," he said. The city mayor emphasized the importance of aligning vendor operations with mall developments for better business performance.

hopefully will happen soon," Treñas said.

The city mayor further emphasized his administration's commitment to sustainable development, promoting a circular economy focused on waste energy reduction and aligning with sustainable development goals (SDG) of United Nations (UN).

"We're making sure that we have redundancy in water by starting our negotiations in Aboitiz eventually, hopefully that will push through together with the desalination project of the Metro Pacific Iloilo Water (MPIW). Like power, water is very important. It's one of the considered sustainable development goals under the UN," he added.

He also noted the construction of school buildings, helping informal sectors in terms of infrastracture project, and vendors livelihood trainings and programs during his tenure.

Treñas reflected on the city's transformation since he first took office in 2001, recalling the challenges Iloilo City faced at the time such as it was once considered the dirtiest city in the country as garbage was everywhere, and waste collection was a major issue, and the streets used to be dark that safety was a also a concern for anyone heading home.

ILOILO City Health Office (CHO) reported a total of six monkeypox (Mpox) cases wherein four were confirmed while two were suspected as of June 2, 2025.

The patients have separate cases in which one has domestic travel history. They are currently undergoing isolation, medical treatment, and are reported to be in stable condition.

CHO Head Dr. Mary Ann Diaz said they are currently working to clearly define what constitutes community transmission, in response to questions on whether the city has identified any confirmed cases or outbreaks.

According to the protocols of the Department of Health (DOH), close contacts of these six cases are not required to isolate unless they are

Meanwhile, Treñas reiterates his intention to continue helping, but clarifies he will not accept any formal position in City Hall. "I will continue to help out. As I have said, I will not accept any position here in City Hall. At the very least, I think I'll accept the designation— not appointment— as political advisor for Raisa.

The difference between an appointment and a designation is that in designation, you are not appointed and you won't have a salary so for me, it's okay to be designated as a political advisor and I will help out politically. But you know, Raisa has been a very independent person ever since," said Treñas, expressing confidence in his successor's readiness to lead, citing her management education and commitment.

conditioning units, fire alarm system, ducting, lighting fixtures, chilled water piping), plumbing Improvements and installation of new furniture and special equipment, including escalators and elevators, and repair of the passenger boarding bridge and departure conveyor.

On the other hand, the second project, worth PHP 37.55 million, involves the supply, installation, and commissioning of three (3) new 600 KW chillers to ensure reliable temperature control in the terminal. This includes mechanical and electrical works, civil/structural works.

Currently, the PTB can accommodate 367 domestic and 360 international passengers. After the completion of ongoing and planned works, these capacities are expected to rise to 675 domestic and 407 international passengers, boosting service potential at Iloilo airport. In addition to ongoing works, CAAP and DOTr have lined up several major infrastructure projects for implementation in 2025 which include the PTB rehabilitation worth PHP 141.11 million, asphalt overlay of the existing runway amounting to PHP 550 million, and procurement of runway asphalt overlay works amounting to PHP 49.98 million. "These improvements at Iloilo International Airport are part of DOTr and CAAP's commitment to give a better travel experience for passengers-by ensuring that airports across the country are safe, efficient, and passengerfriendly," said CAAP Director General Lt. Gen. Raul L. Del Rosario AFP (Ret).

He cited the strong partnership between the local government and the private sector for the city's development.

Treñas emphasized that more than physical developments—the most valuable legacy of his administration is the restored sense of pride among Ilonggos.

"It's not the infrastructure, it's not the plaza, it's not

Treñas also emphasized the city's progress but noted that there is still much work to be done, especially in terms of addressing children's nutrition and education efforts through establishment of public libraries equipped with books and free Wi-Fi.

He also stressed the need for sufficient water and power supply, as coal-fired power plants are no longer an option.

"We must continue working to ensure Ilonggos are prepared in times of need," he added.

# DepEd Iloilo eyes temporary learning spaces in fire-hit school

ILOILO CITY – The Department of Education (DepEd) Schools Division of Iloilo is considering establishing 10 temporary learning spaces to ensure learning continuity after a fire destroyed several classrooms of the Alimodian National Comprehensive High School in Alimodian town on Monday.

"The temporary classrooms will serve as our stopgap solution while we prepare long-term reconstruction plans," Schools Division Superintendent Dr. Ernesto Servillon Jr. said in a statement on Wednesday.

A comprehensive rehabilitation plan was crafted after Servillon led the inspection of the damaged areas on Tuesday.

# **IP youth leader to represent PH** in Taiwan leadership program

ILOILO CITY – A youth leader from the indigenous peoples (IP) community in Lambunao, Iloilo will represent the Philippines in the 2025 Asian Girls in Action Project power camp in Taiwan on July 20 to 27.

Sharielle Angelie Lemonar, 15, an incoming Grade 10 student of the Caninguan National High School in Barangay Caninguan, passed the stringent screening and got the slot through her project "Kubong Kultura" (cottage of culture), aimed at preserving and celebrating the rich indigenous traditions of the Panay Bukidnon tribe.

"She is one of only 10 young female leaders from across Asia to participate in the youth leadership

program. The camp brings together outstanding girls from diverse cultural backgrounds to collaborate on projects that empower women and promote cultural heritage," the Baryo Balangaw Creative Initiatives said in a statement on Wednesday.

Baryo Balangaw Creative Initiatives, a local nongovernment organization committed to bridging communal art experiences and sustainability, mentored Lemonar and helped shape her cultural and communitybased advocacy.

Lemonar's project offers hands-on workshops in traditional crafts such as weaving and tubok (natural dyeing) while providing training in digital

marketing.

By equipping local women with both ancestral and modern skills, the project helps them grow sustainable livelihoods and strengthen their cultural identity.

"Kubo ng Kultura is a space that aims to empower women and rural communities by promoting and preserving the rich culture and traditions of the Panay Bukidnon people through our traditional handcrafts such as basketweaving and embroidery or 'panubok'," Lemonar said during her presentation before officials of the municipal government of Lambunao on Monday.

# Research center cultures 600K 'sugpo' larvae in Iloilo City

ILOILO CITY - Around 600,000 larvae of tiger shrimps (Penaeus monodon), locally known as "sugpo," are currently stocked in two earthen ponds at the Dumangas Brackishwater Station of the Southeast Asian Fisheries and Development Center Aquaculture Department (SEAFDEC/ AQD) here.

The larvae were harvested from the biosecure hatchery at SEAFDEC/AQD's main station in Tigbauan, Iloilo on May 20.

"These larvae, produced using wild spawners from Carles, Iloilo, were used to seed another grow-out run under SEAFDEC/AQD's 'Oplan Balik Sugpo' program," the research center said in a statement on Wednesday.

Grow-out culture involves raising the tiger shrimp from juvenile to harvest size in ponds or cages.

The larvae are expected to be harvested after 120 days of culture.

The "Oplan Balik Sugpo" program, initiated by SEAFDEC/AQD chief Dan Baliao, seeks to revive the once-thriving black tiger shrimp sector in the country. The program focuses on improving local broodstock, strengthening biosecurity practices, and promoting sustainable farming approaches.

That is where the fault lies: the government collects and collects but barely gives out directly to Filipinos, except 4Ps and ayuda as a legal form of vote buying. PBBM gets no PR benefit because congressmen take all the credit, get the votes and entrench themselves in power.

So, what is the plan? To show Filipinos "natauhan siya" or acknowledge the voters' rebuke? Let me point out that the voters' rebuke is just a small segment of the angry, dissatisfied population. The fact that Filipinos are cutting costs, spending less and living lives on "second

> Denzel Washington reminds us that "dreams without goals are just dreams, and ultimately they fuel disappointment," and in the play Jesus Christ Superstar, Judas goes: "Every time I look at you, I don't understand why you let the things you did get so out of hand? You would have managed better if you had a plan."

# It's about accountability

The provisions on impeachment in the Constitution are not in Article VI on the legislative branch, but under a separate Article XI, on the "accountability of public officers." This should indicate the importance attached to accountability by the framers of the Charter.

Section 3(4) of Article XI states: "In case the verified complaint or resolution of impeachment is filed by at least one-third of all the Members of the House, the same shall constitute the Articles of mandate? Impeachment, and trial by the Senate shall forthwith proceed."

It's a reflection of our level of literacy that we have redefined "forthwith." Maybe the framers of the Constitution should have included a definition of terms in Article XI.

After seeing Senate President Francis Escudero redefine the meaning of "forthwith," we're now faced with the prospect of senators voting not to proceed with trying an impeachment complaint forwarded by the House of Representatives.

Can senators turn their back on a constitutional

The excuse is that senators are of two minds on whether or not an impeachment trial that opened in the current 19th Congress can be carried over to the incoming 20th.

Shouldn't they just go ahead and begin the trial (even if no longer forthwith from the filing of the House justice committee. As for the impeachment trial in the Senate, the proceedings

officially started upon receipt by the chamber of the Articles of Impeachment from the House - which was way back in February.

Maybe Chiz Escudero is simply interpreting this sui generis case based on his appreciation of the Constitution and the Senate's own rules. But he is being perceived to be stalling and trying to stop the trial and consequently prevent the VP's ouster.

Ironically, Lipa, Batangas has become the next destination and development site for real estate developers building exclusive commercial-residential communities, while people in the outskirts of Lipa don't have running water.

Senator Bong Go did not win as number one just because of his allegiance to FPRRD. He won because he consistently focused and supported public health. His Malasakit Centers and support for hospitals are well known and hugely admired by the poor, doctors and even hospital administrators and the middle class.

Filipinos can afford and have to buy rice, so the

Section 1 of Article XI states: "Public office is a public trust. Public officers and employees must at all times be accountable to the people, serve them with utmost responsibility, integrity, loyalty, and efficiency, act with patriotism and justice, and lead modest lives."

The last part alone, on "modest lives," if applied, could decimate the entire national leadership. One look at the parking areas of the Senate and the House of Representatives would easily prove this. And we're not yet even looking at the lawmakers' pricey clothing, designer bags and shoes.

Accountability should be foremost in our minds as we watch the senators sparring over the impeachment of Vice President Sara Duterte.

We've impeached a president, a chief justice and an ombudsman, although only the chief justice was convicted and ousted in a trial. Joseph Estrada was ousted as president by people power, became mayor of Manila and nearly won a second term as president. Merceditas Gutierrez guit as ombudsman and kept her fat pension, and was even appointed by President Marcos to the board of trustees of the Government Service Insurance System.

Now here we are, still groping in the dark on the way forward in the first-ever impeachment trial of the Vice President of the republic.

Articles of Impeachment), let the 20th Congress continue the proceedings, and keep going unless stopped by the Supreme Court? The SC, whose members may be removed through an impeachment trial, may even decide to keep its hands off the Senate impeachment process.

This case being the first-ever impeachment involving the second highest official of the land, the issue is expected to end up in the SC anyway, with VP Sara's lawyers bringing it to the High Court. Senators, despite their political alliances, are supposed to sit as impartial judges in an impeachment trial.

At the rate certain senators are shooting their mouths off about what they think of the impeachment, they should have the delicadeza to inhibit themselves in case the trial pushes through, for having already prejudged the case even before the presentation of the charges and evidence.

Inhibition in this case, however, is not a rule but a personal decision, so we're not expecting it from anyone. And we might yet see the Senate plenary voting not to proceed with the trial.

This means the charges against the VP will have to be refiled in the 20th Congress, after the one-year period from the filing of the current complaints lapses. That period, according to the House secretary general, started upon the receipt of the complaints by the If the perceptions are valid, the question is why.

Escudero has become the subject of (mostly ugly) speculations, with nothing to do about public accountability. One is that he is courting the support of the pro-Duterte senators to keep his post as Senate chief in the 20th Congress. Or is he acting on behalf of President Marcos? This presumes that BBM truly finds no reason to get rid of the VP through impeachment, which in turn implies that BBM has no control over his favorite cousin the Speaker.

Another speculation is that Escudero is courting the support of the Dutertes (and the Mindanao / Visayas vote) for a possible run for the presidency in 2028.

Impeachment is a political process. But it's also about accountability. Shouldn't this be the primordial consideration of every member of the Senate? The higher the position, the higher the bar should be set for public accountability.

We already know the issues raised in the Articles of Impeachment filed against the Vice President. Doesn't the nation deserve to know the truth and see justice rendered? Doesn't VP Sara herself want a definitive ruling on her professed innocence?

It's a one-of-a-kind event. This sui generis episode in our national life should be memorable for being good for the health of our society.

Abeto Street, Mirasol, Mandurriao, Iloilo City, and Lerma M. Mercurio-Armendez residing at Q. Abeto Street, Mirasol, Mandurriao, Iloilo City. According to the petitioners, the Spouses Leopoldo P. Mercurio and Maria Maido-Mercurio at the time of their respective deaths left real and personal properties with an estimated value of Four Million One Hundred Fifty Two Thousand Four Hundred Sixty Seven and 98/100 Pesos (Php4,152,467.98), to wit:

# Antique health office urges outdoor spraying during 'Brigada Eskwela'

SAN JOSE DE BUENAVISTA, Antique – The Antique Integrated Provincial Health Office (IPHO) is proposing to the Department of Education (DepEd) Schools Division of Antique to include outdoor insecticide spraying as part of the "Brigada Eskwela."

IPHO Information Officer Irene Duldoco said in an interview Wednesday that outdoor spraying is proposed after the cleanup activity, particularly in areas with clustering of dengue cases.

"There are already five deaths due to dengue; the latest is a four-year-old child. That is why we really have to make sure that the schools are safe," she said.

Duldoco said IPHO has dengue-treated screens they could provide to schools upon request to make sure that the classrooms are free from mosquitoes.

They also have insecticides for spraying if schools cannot request them from their rural health units.

"There are 1,740 dengue cases in the province from Jan. 1 to May 31," Duldoco said.

The 1,740 dengue cases in the province already include the five deaths in the towns of Culasi, Sebaste, Anini-y, Valderrama and Tobias Fornier.

Office (ICPO), Bureau of Quarantine, Civil Aviation Authority of the Philippines (CAAP), Philippine Ports Authority (PPA), Bureau of Fire Protection (BFP), and Philippine Coast Guard (PCG)

Meanwhile, a patient approaching the end of 21day isolation period may possibly extend or prolonged if symptoms appear or continue beyond the initial timeframe.

The public is also urged to remain vigilant, seek early medical attention, report symptoms honestly, practice frequent handwashing, wear face masks and long sleeves, avoid crowds when possible, and travel safely.

standby response funds would be utilized to implement the rehabilitation plan, according to the Schools Division of Iloilo.



Based on initial investigation, 14 rooms, including a canteen and a clinic, were razed by the fire, while the school's gymnasium was partially damaged. (PNA)





The new chief of the Philippine National Police, Gen. Nicolas Torre III, wants to hit the ground running as he buckles down to work.


First off, he vowed to make appointments in the institution during his term to be "based solely on merit," and "only the most competent will be entrusted with the right positions in the right places...Deliver excellence in your police work... and you will be recognized and rewarded, "Torre said.

His plans for the PNP include four key thrusts. One, implement a three-minute emergency response. Two, reinforce unity and morale among its ranks. Three, further modernize its technology. And four, hold erring officers accountable.

Torre enjoined the 230,000-strong institution to ensure "swift response to the public, unite and uplift the morale of your fellow public servants, and hold yourself and others within the ranks accountable. Just real talk. No need for endorsements under my leadership."

"Of course, I have to reiterate that all of these actions must be done within the ambit of the law, evidence-based, and rights-respecting. I challenge each and every member of the PNP to be louder

than me, not only in words but also in action," he explained.

Before becoming the 31st PNP chief, Torre was the director of the Davao Regional Police Office and later headed the Criminal Investigation and Detection Group.

In both positions he chalked up two outstanding accomplishments.

In Sept. 2024, he led the enforcement of the arrest warrant for preacher Apollo Quiboloy, who faces allegations of child abuse, sexual abuse, and qualified trafficking.

In March this year, Torre was the ground commander of the police team that arrested former President Rodrigo Duterte and handed him over to the International Criminal Court in The Hague, Netherlands, to face allegations of crimes against humanity during his administration's drug war.

On the PNP's continuing drive against illegal drugs, Torre said police operatives would intensify kegal arrests of suspected traffickers.

in question. The problem is communication. This episode on the EDSA rehabilitation highlighted an often overlooked yet essential aspect of governance and The new top cop pledged to work harder to keep the country safe, respect Filipinos' rights, and gain the people's trust.

"To the Filipino people, the very reason for our existence, we, the Philippine National Police, shall work harder to earn and ensure that our communities are safe, your rights are respected, and your trust is earned," Torre said. "I believe that we are ready to deliver on your expectations as we have done in the past," Torre added.

So what will happen if police commanders fail to meet the three-minute emergency response time?

They may be removed to improve performance: "'If you can't do the mission, well, someone else will take your place and try to (accomplish) the mission."

A promising start to his new post, if his words are any indication, that should be matched by sustained and concrete action in the coming months. (manilastandard.net)

**ESPRESSO MORNINGS** 

President Ferdinand R. Marcos Jr. over the weekend ordered the suspension of the rehabilitation of the Epifanio de los Santos Avenue (EDSA)—a welcome and necessary intervention in light of the potentially chaotic rollout of the project.

According to the President, the postponement paves the way for government agencies to find a better way to implement the long overdue rehabilitation of Metro Manila's main thoroughfare as commuters and motorists were left with more questions than answers after the Metropolitan Manila Development Authority (MMDA) initially announced the new "odd-even" traffic scheme that was supposed to be enforced alongside the repairs.

The supposed two-year project was put on pause following complaints and questions from the general public over the massive disruption resulting from the roadworks, which was coupled with confusing pronouncements from the government.

Large infrastructure projects are disruptive by nature, but the lack of clear communication about the details of the EDSA rehabilitation, particularly on mobility and traffic, only heightened public anxiety since initial announcements made by government officials lacked fundamental details, leaving motorists guessing for answers.

There is no doubt that EDSA needs rehabilitation. The intention and necessity of the project are not public service: public information.

This serves as a wake-up call for the MMDA and other government agencies that large-scale projects require a robust public information strategy—clarity over chaos.

We're not just talking about an infrastructure project here that would require minor adjustments on the part of commuters and motorists. We're talking about a major public undertaking that requires the cooperation of the people to succeed in a timely basis.

With millions of vehicles and commuters traversing EDSA on a daily basis, a potential disruption of this magnitude should be accompanied by correct, clear, timely, and accessible information. We cannot allow major decisions surrounding a project this big to be executed in a vacuum.

Public information cannot be an afterthought in situations such as this given that EDSA is a lifeline not only for the economy but in the daily lives of millions of people.

Effective public information campaigns are borne out of comprehensive planning, and consultations with technical experts, businesses, motorists, and the riding public. To say that a public information campaign is truly effective, it should address the basic concerns of the public well in advance of the implementation of the infrastructure project, and should inform the public of the essentials: what, when, where, why, and how they

#### will be affected.

Government communicators must go beyond media interviews, press releases, and piecemeal and vague advisories. Effective public communication in this regard should involve clear timelines, rerouting and traffic schemes, on-the-ground information drives, easyto-memorize reminders, and visual and multilingual guides—all of which are accessible to the public in various channels.

The most important aspect and challenge here is how to explain all in a way that the general public—from the office executive to the street vendor—can understand and plan around. Anything less than this is disrespectful to the daily lives of Filipinos.

The suspension of the EDSA rehabilitation is an opportunity for the government to go back to the drawing board, not only to improve the technical details of the project but to overhaul its public information campaign.

As a resident of Metro Manila and a concerned citizen, I share the President's call on government agencies involved in this project to find a better way to implement the rehabilitation of EDSA—one that works with and for the people, not around them.

# Discipline, technology, social engineering via NCAP

There is a recent call by a motorcycle rights group to hold a so-called "Unity Ride for Equality and the Preservation of Life." Despite its title, the event is clearly a protest ride against the implementation of the No Contact Apprehension Policy (NCAP). Last Monday, transport groups also staged a protest caravan against the aforesaid NCAP implementation. Apparently, motorcycle groups and transport groups are clearly organizing to protest this new iteration of NCAP enforcement.

One of the main complaints of the motorcycle groups is that the NCAP policy allegedly prevents them from utilizing "underutilized" open lanes. Specifically, these groups are citing the bicycle lanes, the PUV lanes and the lanes for four-wheel vehicles, which at times are allegedly not as congested as the motorcycle lane. In addition, this is the same complaint that motorists even those of the four-wheel variety use when they do illegal counterflow in small streets. The other lane is underutilized so they must be allowed to do illegal counterflows.

The other related complaint is that fixing them in a single lane prevents them from weaving in and out of other lanes, which is more convenient for them. This particular logic is ridiculous and self-centered. Weaving in and out of traffic is dangerous and increases the possibilities of collision and even road rage as evidenced by recent incidents of road rage have shown. This kind of thinking is the same twisted logic that people use when they illegally use lines for senior citizens or PWDs or when they park on spaces reserved for senior citizens or PWDs. Despite the clear rules against illegal use of these lanes or spaces, many feel entitles to use the same since it is not used all the time.

It must again be reiterated that the rules for these lanes have long been in place. The NCAP only makes enforcement more efficient. Essentially, the argument can be simplified as motorcycles and PUVs in the past could occasionally get away with violating the rules and NCAP makes it impossible to violate the rules. As such, NCAP must be scrapped to allow them to violate the rules because these rules inconvenience them. Stripped down, their arguments can be exposed as a clear attempt to force a return to the chaotic situation where their shortcut mentality can thrive.

Unfortunately, we cannot allow this culture of rule bending to continue forever. The NCAP issue deals with a larger issue of our ability to do an incremental system of social engineering. If we allow a situational application of rules and a system where the ability to evade enforcement is rewarded to continue then we will perpetuate this culture of chaos to remain indefinitely. Poverty and inconvenience are not get out of jail a free card. Highways are shared spaces which require sacrifice. Admittedly, some will need to sacrifice more but as long as the rules are evenly and universally applied then it is not discriminatory. NCAP is not antipoor because it essentially allows PUV's more use as long as their drivers follow the rules.

Filipinos have shown that when they are in an environment where rules are enforced strictly, they can adhere to the same. In Taiwan, there are violations of rules, such as driving under the influence of alcohol, which will automatically cause deportation for the overseas worker no exceptions. This rule is known by all OFWs and in general violations are rare. Why can't we impose that in our own country. If technology and lack of human intervention except in review is what it takes, then let us support the use of technology to instill discipline. Let us put more cameras and not less to monitor all sorts of violations which could include littering and even jaywalking. Let us increase the fines not lessen it.

Instead of retreating, we as a nation must push forward with more draconian measures to finally instill discipline and an internalized compulsion to follow the rules and avoid shortcuts no matter the consequence. If we have to drag recalcitrant rule-breaking members of our society kicking and screaming towards a more disciplined and orderly system, we must do so for all our sake. If we push onward with more measures maybe we can finally have order in our society.

NCAP must be retained. Let government tweak and adjust it but it must be retained.

# Advancing equity through open gov't partnership (1st of 2 parts)

Amid the euphoria of victory and the despair of defeat in the midterm elections lies a crucial yet often overlooked democratic exercise—one frequently buried in mainstream print and social media: the active participation of citizens in shaping national and local budgets. Known as Open Government Partnership (OGP) Week, the event held from May 19 to 23 in the Philippines brings together government institutions, civil society organizations (CSOs), private sector partners, and the youth to champion the core values of transparency, accountability, citizen participation, and innovation in governance.

The OGP is a global initiative, and the Philippines is proud to be one of its eight founding members since its launch in 2011. The OGP aims to promote transparent, accountable, and inclusive governance. It brings together reform-minded governments and CSOs to co-create and implement concrete commitments that advance open governance. Through collaboration, the OGP fosters citizen participation, combats corruption, improves public services, and strengthens trust between governments and the people they serve. Today, the partnership includes 77 countries and 150 local governments-representing over two billion people-working alongside thousands of CSOs to drive meaningful democratic reforms. The Philippines holds a distinctive position on the global stage, having once been hailed as the 'NGO/ CSO Capital of the World' due to the remarkable number and vibrancy of its civil society organizations. Over the years, the active engagement of nongovernment organizations (NGOs) in governance has evolved into a formidable political force. Their collective voice and mobilization capacity have not only influenced public policy but, at critical moments in the nation's history, have helped shape political outcomesdemonstrating the power of organized citizen action to make or unmake governments. On Feb. 6, 2025, President Ferdinand R. Marcos Jr. stressed the need for transparency in governance as he officially opened the 2025 OGP Asia and the Pacific Regional Meeting (APRM), which brought together 800 participants from 40 countries, including government officials, civil society leaders, and policy experts. He stated, 'Our people can only truly participate in governance if they have access to information. This access is made possible by government transparency, digitalization, and the institutionalization of the Freedom of Information

(FOI) through legislation, which is a constitutionally recognized principle.'

# FRESH VIEWPOINTS: A NEW PERSPECTIVE

E-Net's advocacy for marginalized, excluded, and vulnerable (MEV) groups is deeply grounded in the lived realities and challenges these communities face on the ground. As of September 2023, the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) had the highest number of out-of-school children, primarily due to the high cost of education. The dropout rate among indigenous children was three times the national average, while a staggering 60 percent of children with disabilities were not enrolled in any formal educational institution or learning facility. These figures indicate a pressing need for inclusive and equitable education policies.

The Philippine education system faces complex, multifaceted challenges. Addressing the specific needs of vulnerable sectors requires the collective effort of civil society organizations, communities, parents, and government stakeholders. Many of these issues have been highlighted in reports by the Second Congressional Commission on Education (EDCOM), which I have discussed in previous columns.

in participatory governance, and CSO-government collaboration in the justice sector, among others.

One session that stood out to me was the education budgeting advocacy led by the Civil Society Network for Education Reforms (E-Net Philippines), Inc. E-Net is a coalition of over a hundred civil society organizations and education advocates dedicated to promoting the right to education for all—particularly the marginalized, excluded, and vulnerable sectors, or MEVs. As the civil society representative to the OGP Steering Committee on Education in the Philippines, E-Net plays a vital role in bridging grassroots experiences with policy-level dialogue, contributing meaningfully to participatory governance in the education sector.

E-Net emphasizes that public budgets should reflect public priorities—but too often, they overlook the voices and needs of the most marginalized. It asserts that budgeting must be a tool for inclusion and equity, not exclusion and privilege. E-Net advocates for the right to education of MEVs that include indigenous peoples, learners with disabilities, outof-school youth and adults, children in conflict with the law or in detention, those in disaster-prone or conflict-affected areas, urban poor and street children, LGBTQIA+ youth, migrant children, children of OFWs, and those living in extreme poverty. We are fortunate to see a strong and active civil society community in the education sector. Their efforts to bring the plight of marginalized, excluded, and vulnerable (MEV) groups to the attention of the government—and to advocate for increased education funding in response to these needs—are both timely and essential.

OGP is more than just a venue for policy dialogue—it is a powerful reminder of the essential role that citizens and civil society organizations play in building a more inclusive and accountable government. With education at the forefront, the OGP underscored the urgency of sustained collaboration, evidence-based advocacy, and meaningful public participation to address the needs of the marginalized, excluded, and vulnerable sectors.

More importantly, the value of education is undeniable, as captured in John Dewey's powerful reminder: 'Education is not preparation for life; education is life itself.' Ensuring that education remains accessible and equitable is not merely a policy objective—it is a fundamental step toward building a just and empowered society.



The petitioner met respondent sometime last 2012 when he was studying in Cebu City and was currently enrolled at that time. That petitioner started to show to respondent that he was interested with her and courted her and after a few weeks she accepted him and they become lovers. That during the relationship they had problems as respondent continued to have communications with her male friends, but she would not allow him to read her text messages with them, which caused their constant fighting and bickering. Their sexual relationship later resulted to the pregnancy of the respondent. Respondent then asked petitioner to marry her, and he reluctantly agreed even though he was not yet ready for a family life as he was still studying and very young at that time and could not support a family and agreed only for the sake of their unborn child. That they decided to get married on January 14, 2013, in the Hall of Justice in Iloilo City, before Honorable Judge Maniba, and just a week later, after they got married, respondents gave birth to their son last January 22, 2013, at Western Visavas Medical

#### respondent and he was so embarrassed about it.

Months have passed and petitioner decided to forgive her for the sake of their child, and they transferred apartment and moved to Delgado Street, Iloilo City to start anew as petitioner thought everything would be alright, but he was wrong, and she was again involved with another man. There were instances during the weekend that respondent said she will have a team building but she was lying as she was meeting a guy in Mandurriao Plaza and someone told the respondent that they saw his wife riding with him on his motorcycle. The petitioner confronted the guy and his wife but they both denied it and told him that he was just accompanied by his wife to go home which he did not believe at all knowing what his wife is capable of doing.

Months passed by and one day petitioner checked her cellphone, and he discovered some deleted messages with another guy he did not know, they argued for days that resulted to their separation as they decided to leave the apartment and move back to their respective houses. Petitioner came back to the house of his aunt while the respondent was living with her family and their son, and every weekend petitioner went to her house to visit his son. After several weeks petitioner keep thinking about his family as he did not want his child to have a broken family and he tried to talk to respondent, and she promised him that she will change for the better. The petitioner tried to forget about what she had done, and they started to be doing again and later, respondent asked him to rent an apartment in Bolilao, and they then lived together again.

Then one day, petitioner saw messages on her phone and he got devastated upon reading all their exchange messages that she was inviting the guy into their room during the night on weekends while he was working and he also saw a message that she is entering other guys as chatmates and planning on meeting up and was using another messenger app to log in order for her not to get caught. The petitioner confronted her, and she again denied and told him that it was just her best friend. That petitioner decided to pack up and went home thinking that it is too much to handle and he left the apartment and went home feeling depressed and pathetic and he did not know what to do and what to feel or what her reason why she did these things to him.

The petitioner could no longer afford to stay in such toxic relationship that he decided to separate from her as he could no longer swallow what she has done to him. The petitioner sucked the life out of him, and he was very devastated by what she was doing to their family, but he tried to move on with his life for the sake of his son. That herein parties have one child but have not acquired any property during their union. The abovementioned circumstances and or actuations of respondent clearly demonstrate her insensibility or inability to show her love and respect to petitioner and to comply with her basic marital obligations towards her husband which are indeed apparent manifestations of psychological incapacity to comply with her essential obligation of marriage as provided for in the Family Code which provides inter alia that the husband and wife are obliged to live together, observe mutual respect, fidelity, and render mutual help and support. SAN JOSE DE BUENAVISTA, Antique – The Antique Integrated Provincial Health Office (IPHO) reminded the public to observe precautionary measures, including handwashing, as protection against the monkeypox (mpox) viral disease.

> IPHO information officer Irene Duldoco said in an interview Wednesday that Antique has no mpox case. However, it would be better for Antiqueños to take precautionary measures due to the province's proximity to Iloilo.

Iloilo province has one confirmed mpox case, while Iloilo City has four laboratoryconfirmed and two suspect

#### cases.


"Antiqueños travel to Iloilo City or province back and forth for their transactions. It is really better that they do frequent handwashing and other precautionary measures," she said.

Duldoco advised home isolation if they suspect having signs and symptoms of mpox such as fever, painful rash, muscle ache, back pain, and low energy.

The rural health unit or health worker should be informed immediately for appropriate medical intervention.

"Keep yourselves well-informed about mpox by listening to the programs of the DOH or IPHO through the media so you would know what to do to prevent yourselves," Duldoco said. (PNA)


