

'NO GHOST FLOOD CONTROL PROJECTS

DPWH says flood control projects





Bo. Obrero Punong Barangay James Conlu confirmed the existence of three flood control projects in his barangay and expressed gratitude for these dreamcome-true infrastructure which he dreamed of since he was a kagawad. He underscored that the positive impacts are being felt by his community.

CONTRARY to false claims, all flood control projects funded by the national government and awarded through competitive bidding to two (2) of the country's top 15 construction firms in terms of flood control projects are existing and currently under construction, according to records from the DPWH Iloilo City District **Engineering Office** (ICDEO).

Records from the ICDEO show that St. Timothy

President Ferdinand Marcos Jr. led the inauguration of the upgraded Iloilo Fish Port Complex (IFPC) at the New Market Hall in Brgy. Tanza Baybay, Iloilo City on August 13,

fishery business in Region 6, catering a wide range of fisheries industry operations, including fish brokerage, cold storage, seafood and poultry dressing plants, fishing vessel operations, fuel supply, and warehousing.

As of March 2025, IFPC's rehabilitation was 100% complete, expanding its capacity to cater to more clients and stakeholders in Western Visavas.

The upgraded fishing port operates a 390-kilowatt peak solar photovoltaic system, powered by 1,152 solar panel modules which are installed across its key structures, including the new market hall, refrigeration and cold storage buildings, commercial and administration buildings,

IFPC also currently supports over 1,400 fisheries industry players, composed of 21 licensed fish brokers with 369 helpers, 503 fish traders (viajeros) along with 344 aides, 66 overland suppliers, seven vessel operators, and 37 retailers along with 74 staff.

The inaugural ceremony was also marked as PDFA's milestone in their 49th founding anniversary. Throughout the rehabilitation, the said agency ensured uninterrupted services for all clients and stakeholders, as daily fish landing, trading, and the popular "Paluto" within the fishing port complex continues to operate.

Coinciding with the event, the Department of Agriculture- Regional Field Office 6 (DA-RFO 6) also reaffirmed its commitment by providing over Php 37 million worth of interventions to rice and corn farmers in Western Visayas. These include four-wheel tractors, corn mills, corn shellers, hammer mills, rice combine harvesters, village type rice mills, forage choppers, and fiberglass boats with engines.

The Philippine Crop Insurance Corporation (PCIC) also turned over checks to rice and corn farmers who were severely affected by flooding from monsoon rains, intensified by Typhoons Crising, Dante, and Emong in the said region.

Meanwhile, fisherfolk associations also received 20-footer fiberglass boats with 13HP engines to boost their fishing capacity.

The said event was attended by government presonnel including DA Secretary Francisco Tiu Laurel Jr., DA Undersecretary for Fisheries Drusila Esther Bayate, DA Region 6 Executive Director Dennis Arpia, Bureau of Fisheries and Aquatic Resources (BFAR) Region 6 Director Remia Aparri, PFDA Acting General Manager Atty. Glen Pangapalan, and PFDA-IFPC Port Manager Jovy Garrido.

This milestone was also joined by local government officials in the city and province of Iloilo including Governor Arthur Defensor Jr., Mayor Raisa Treñas, Congresswoman Julienne Baronda, USWAG Partylist Representative Cong. James Jojo Ang Jr., Brgy. Tanza Baybay Captain Wilbur Orada, and Brgy. North Baluarte Alan Aurelio.

DA deploys animal sentinels to 9 Iloilo towns

ILOILO CITY - The Department of Agriculture (DA) 6 (Western Visayas) has expanded its swine sentineling protocol in Iloilo to cover nine additional municipalities after the successful entation in the town of Oton

Iloilo Provincial Veterinarian, Dr. Darel Tabuada, said that almost all of the sentinel animals dispersed in Oton, the pilot site in Iloilo, survived.

The department distributed 72 sentinel piglets to sele

farmers in Oton last year.
"It means that in their environment, there are no longer traces of the African swine fever (ASF) virus," he said in an interview

The expansion will cover 181 farmers from Zarraga, New Lucena, Mina, Janiuay, Dingle, Banate, Barotac Viejo, and Batad based on the letter from the department's livestock program sent to Tabuada on Aug. 7.

The sentinel animal for the municipality of Lambunao is s for delivery to 13 farmers on Aug.19.

Each farmer will receive one piglet, along with one bag of starter and one bag of grower feed, multivitamins and antibiotics. as part of the pack

Tabuada said they are trying to put Oton on the yellow (surveillance) zone, but due to some lacking documents, they intend to wait for the result of the latest sentineling in nine towns that will last for 45 days.

Meanwhile, he said the provincial government also has its own sentineling or financial assistance for the ASF recovery program in 14 municipalities.

The provincial government has already downloaded PHP10.03 million to the local governments to purchase 1,672 piglets for distribution to 836 farmers.

BARANGAY CONFIRMATION

Bo. Obrero, Lapuz Punong Barangay James Conlu confirmed in an interview with DYSI Super Radyo Iloilo that these projects exist, describing them as the realization of long-held dreams of residents.

"Yes, that is correct. These are existing projects. We have three sections of flood control projects. I am wondering why these have become ghost projects because they are there on site. They were stopped because of permit issues but they have resumed. We are thankful because these are almost finished and we have felt the impacts," Conlu

He further recalled: "I was still a barangay kagawad when we dreamed of having this. We are thankful for this project. DPWH has been inspecting the projects at least once every month. We have felt the impact already.'

Meanwhile, Alpha & Omega General Contractor & Development Corporation, ranked second among the top 15. was awarded one project:

President Bongbong Marcos Jr. personally inspected flood mitigation projects in Barangay San Isidro, Jaro, awarded to F. Gurrea Construction, Inc., an Iloilo-based

MAYOR'S STATEMENT

Iloilo City Mayor Raisa Treñas in an interview with GMA News said that nearly P4 billion worth of flood control projects in the city were either poorly constructed, unfinished, or missing: "Yung iba hindi namin makita kasi sometimes sa projects naka-specify lang, naka-general lang, slope protection for Iloilo, walang specific address. Kaya hindi din kami makabigay ng specific kung ano ba, details kung ano na, kumusta na yung project. Kaya ghost talaga kasi hinahanap natin. Hindi natin mahanap, nagtatago, or maybe, with the help of DPWH, they can locate these and they can explain to us kung saan ba at makita na natin yung ghost. Baka buhay pala," Treñas said.

DPWH RESPONSE

In a press statement dated August 12, 2025, Engr. Roy Pacanan, OIC District Engineer of ICDEO, rebuked Mayor Treñas: "All of the foregoing projects were procured through open and competitive bidding, with the project allocations (programmed amounts) in accordance with the 2024 and 2025 General Appropriations Act. The quantities for each project were determined based on the values reflected in the Construction Materials Price Database. ensuring accurate cost estimate."

He also criticized the Iloilo City Government for several local projects that remain unfinished despite substantial funding. "Least we forget of the following projects of the Iloilo City Government which remained unaccomplished despite billions of public funds sourced from loans," Pacanan said, enumerating the following:

* Construction of Class "AA" Iloilo City Slaughterhouse, Brgy. Tacas, Jaro Design and Build Scheme for the Construction of Iloilo City Hospital, including site development at Brgy. San Pedro, Molo

* Rehabilitation of Public Markets, including Jaro Big Market at Brgy. Desamparados, Jaro

Records show that the city government secured P180 million in bank loans for the slaughterhouse project, and P2 billion in loans for the three public markets, the Iloilo City Hospital, and a parking building - all of which remain unfinished.

"Finally, as government officials, we have a duty to be vigilant with the information we share. We must ensure that every statement is accurate, truthful, and responsible - because in our positions, even a single piece of misinformation can mislead the public and erode trust," Pacanan stressed.

Licensing Division (BPLD), the number of permits issued annually in the said years are the following:

- * 2021 16,180
- * 2022 17,379 (+7.4%)
- * 2023 18,927 (+8.9%)
- * 2024 19,599 (+3.6%)

As of July 2025, the city has already reached 17,857 business permits, and it is expected to surpass the 2024 record by the end of the year.

"If these inputs of the Department of Agriculture will become successful, especially its INSPIRE program, and our commercial farms will become fully operationalize, hopefully, we can see that our swine inventory in the province will stabilize," he said.

In addition, she also cited the official records from BPLD, indicating that most reasons for the closure of 961 businesses in 2024 were beyond the city's control. Primary reasons are the following:

- * 128 low sales, low income
- * 8 high rental
- * 288 bankruptcy, losses
- * 40 end of contract
- * 118 closure of business, no one to manage
- * 145 change of business name or ownership
- * 35 pandemic
- * 72 health issues, old age, death of owner, personal reasons
 - * 6 merger
 - * 21 owner moved abroad
 - * 11 sold property
 - * 6 fire incident
 - * 5 unserviceable units
 - * 11 no clients, no boarders
 - * 4 renovation * 2 - dealership
 - * 61 other personal reasons

Moreover, Mayor Treñas expressed her dismay to some people who are spreading false information or study that negatively portrays Iloilo City.

She also stated that the city's business tax collection has

also been increasing each year:

- * ₱638.7 million 2022
- * ₱754.5 million 2023 (+18.1%)
- * ₱875.1 million 2024 (+16.0%)

"These figures clearly demonstrate that business in Iloilo City continues to thrive and progress." She stressed. "The data does not indicate that the real property tax increase is a direct reason for business closures.

City gov't upgrades waste diversion monitoring in brgys

More than he bargained for?

After stirring the kaldero of corruption in his fourth State of the Nation Address, it may be that President Bongbong Marcos got more than he bargained for.

Aside from being applauded by some of the suspects, PBBM ended up getting an unexpected response of support from the public as well as a mountain of expectations for the President to expose and arrest the people involved.

Hence all the questions from the media on who and when? As in who are the immediate suspects and when will the President have them arrested and detained? Unfortunately, the President answered the question with another question.

"Don't we have any more investigative journalists in the Philippines? That's your job, look it up."

We could read the President's challenge in two ways. Either PBBM stirred the kaldero too early and has been found lacking or unprepared. Instead of tinimbang ka ngunit kulang, tinanong siya, hindi naman niya masagot (he was asked but he had no answer).

This reminded me of a lesson from Jesus Christ in the book of Luke chapter 14, verses 28 to 32:

"Suppose one of you wants to build a tower. Will he not first sit down and estimate the cost to see if he has enough money to complete it? For if he lays the foundations and is not able to finish it, everyone who sees it will ridicule him, saying 'this fellow began to build and was not able to.' Or suppose a king is about to go to war against another king. Will he not first sit down and consider whether he is able with ten thousand men to oppose the one who is coming against him with twenty thousand? If he is not able, he will send a delegation while the other is still a long way off and will ask for terms of peace."

Did the President get more than he bargained for?

Perhaps that is why he challenged the members of media to be "investigative journalists" and find the suspects. Was he indirectly telling the media he needs bullets, reasons or justification to go after the people

he believes are involved?

The fact that the corrupt contractors are in bed with corrupt politicians makes the matter politically complicated for PBBM. He is not the type to rock the boat except when someone like Rodrigo Duterte insults him to his face by calling him names or if certain individuals show no fear and no respect for him or his office.

If PBBM were to go after the corrupt contractors and politicians, they could turn on him politically or personally. PBBM already has enough enemies, so much so that he does not need to add his current "allies" to his list of haters.

So, the next best thing is to call in "Replacement Assassins." For the record I am stating that term is a figure of speech. A "Replacement Assassin" is someone who exposes an enemy or wrongdoer without connecting the action to the source.

I actually teach this in my media training seminars, especially to people who experience or encounter injustice, corruption or abuse of power in different levels of government and society but can't risk being identified or fired.

The "Replacement Assassins" are members of media, clergy, NGOs or independent minded politicians like Mayors Belmonte, Magalong, etc., people committed to good government, justice and equality.

As far as members of the media are concerned, PBBM needs to be sure that when things begin to stink, that he has people he can trust and who have integrity and courage to investigate and charge the suspects without fear or favor.

Don't waste the time and risk the lives of media without the necessary structure to go after the corrupt.

Even without asking, we now hear or read the inputs of Senator Ping Lacson, Mayor Benjie Magalong, Mayor Vico Sotto as well as members of media giving PBBM tips, signposts and primers on the corruption

involving flood control projects.

Last week, the chairman and president of San Miguel Corporation generously and confidently announced their willingness to step up to the challenge and expense of fixing the flooding problems in Metro Manila. etc.

Many expressed surprise with RSA's bold statement without realizing or perhaps forgetting that San Miguel Corporation has been dredging many rivers, canals, etc. and has made "Clean Rivers" their corporate commitment.

Ramon Ang is not the type to shoot his mouth off without a plan. I would wager that if PBBM gave RSA and San Miguel a green light, they would easily and immediately be on site. That is the nature and character of Ramon Ang.

While people talk about the kaldero of corruption, RSA with his background on engineering, competency in technology and infrastructure development has probably done the due diligence, put together the operations manual.

His recent bold statement was just his usual way of getting reaction and feedback to a plan already on the table. He has nothing to lose if people or government say no or suspiciously "look a gift horse in the mouth." RSA can simply step aside with no loss of face. But those who block the offer must have a good reason, as well as be able to do what SMC can do.

Allowing San Miguel Corporation to take the lead in addressing the flooding problem will set the standard on the right way and the right solution, based on years of experience and proven positive results.

In the meantime, PBBM can put together his "A Team" and adapt the show's catchphrase: "I love it when a plan comes together."

Stages of corruption

Hearing public officials detailing how corruption happens in flood control and other infrastructure projects, you wonder why the problem has persisted for so long.

The problem has long been identified, with its vile consequences known. The MO, with the numerous permutations, are also known.

So why have the perpetrators not been identified and prosecuted? The only plausible reason is because they are VIP crooks – rendered untouchable either by the right connections, or because of their perceived clout in elections.

Even if they are behind roads that melt in the rain, bridges that collapse and ghost or guni-guni flood control projects, they can do no wrong. They can get away with anything, including murder.

An example is the Ampatuan clan, whose notoriety for violence, murder and corruption was ignored by several administrations. Why? Because the clan could deliver any number of votes needed by whoever was in power.

Even the notoriety for brutality of Andal Ampatuan Jr. was seen as an asset, to rein in violent troublemakers at the time led by the Moro Islamic Liberation Front. So what if he reportedly had a penchant for decapitating enemies?

Gloria Macapagal Arroyo held back for a few days in condemning the Ampatuans following the Maguindanao massacre in 2009, until searchers started pulling out the victims' bodies one by one, like a danse macabre scene, with many squished together inside vehicles crushed by a backhoe belonging to the provincial government.

The Ampatuans left behind several mansions amid the abject poverty in their province, fleets of luxury bulletproof vehicles, and arsenals packed with highpowered guns sourced (according to their packing crates) from the Department of National Defense itself.

Maguindanao under the Ampatuans was just among the worst examples of the state of the rest of the Philippines. And the sorry state remains to this day.

For private contractors, these are the six stages of corruption, according to Pasig Mayor Vico Sotto:

Collusion or anomalies in procurement and bidding. Cutting costs to implement substandard projects, or the more brazen version: collecting payment for ghost projects.

Payment of kickbacks or commissions to political patrons.

Tax evasion.

Evasion of proper business taxes and fees to local governments.

And his kicker – once the first five stages have been mastered, the sixth stage comes in: contractors use one percent of the proceeds from their crooked deals to "help" the needy in their communities and buy votes for their entry into politics.

Sotto is referring to two of the companies included in the list of 15 contractors released by President Marcos last Monday, in a rare press conference that even included a PowerPoint presentation about questionable flood control projects nationwide.

It was the President's follow-through on his "mahiya naman kayo" shame campaign that he launched during his fourth State of the Nation Address last month.

The list, drawn up by the Department of Public Works and Highways, is just the initial salvo, Communications Undersecretary Claire Castro told "Storycon" on One News yesterday.

It includes Sunwest, a company owned by the family of Ako Bicol party-list Rep. Elizaldy Co, who chaired the powerful appropriations committee in the previous 19th Congress, and his brother who previously held the same House seat, Christopher Co.

Earlier this year I told Sen. Imee Marcos of reports that Zaldy Co belongs to a family that has long been enormously wealthy. Her comment: "Yeah, right!"

Zaldy Co has said he divested his shares in Sunwest when he was elected to Congress. As of yesterday, there was no comment from him or his brother.

Those who reacted were senators. Iloilo City villages gear up to become ARTA-compliant

ILOILO CITY - Iloilo City barangays are gearing up for the implementation of the Ease of Doing Business and Efficient Government Service Delivery Act

Iloilo City Local Economic Development and Investment Promotion (LEDIP) Office head Velma Jane Lao said the that the Ease of Doing Business should be implemented not only by the city government but also at the barangay

"This time, it is expanded in barangay LGUs (local government units). The purpose of this is to promote transparency and accountability in barangays," Lao said in an interview on Tuesday.

A three-day training for the city's 180 barangays kicked off on Monday with personnel from ARTA.

They were guided in developing their Citizen's Charter, which outlines the services available in the barangay, including the 3-7-20 processing day rule: three days for simple, seven days for complex and 20 days for technical transactions, calculated as calendar days and fees.

They were also guided on zero-backlog reporting, indicating that they have no pending tasks, and the Client

NGCP's Transmission Rates up due to New MAR and Under-Recovery

The Energy Regulatory Commission's (ERC) approval of NGCP's Maximum Allowable Revenue (MAR) and Under-Recoveries (UR) from 2016 to 2022, along with the decrease on the energy consumption from June to July 2025 Billing Period, resulted in an increase in NGCP's Transmission Rates in the July 2025 Billing Period which will be translated by the Distribution Utilities in the electric bills of their end consumers effective August

From PhP0.4611/kWh in June 2025 Billing Period, Transmission Rates rose to PhP0.5923/kWh or an increase of PhP0.1312/kWh.

Ancillary Services Rates, on the other hand, went down from PhP0.6182/kWh in June to PhP0.5872/kWh in July, a decrease of PhP0.0310/kWh.

Overall average Transmission Rates for the July 2025 Billing Period have increased to PhP1.3233/kWh, up by 9.25% from June's PhP1.2113/kWh.

The ERC earlier approved a UR fixed rate of PhP0.0384/kWh to be implemented for 84 months, or until the UR amount of PhP28 Billion is fully collected.

In addition, the ERC allowed NGCP to recover the MAR increase of PhP6.62 Billion, raising the previously approved MAR from PhP 51.47 Billion to PhP 58.10 Billion, translating to an anticipated increase of PhP0.0629/kWh.

The ERC approval forms part of NGCP's Fourth Regulatory Period Reset, covering years 2016-2022. The third reset, covering 2010-2015, took place more than a decade ago

The approved increase will help finance NGCP's efforts to further strengthen the power grid.

"These are the reports being complied by the city government every year. We have to abide by that because that is our service standard or commitment to the public availing of our services," Lao said.

She said that while there is no deadline, they hoped to see the 180 barangays already starting with their Citizen's

They also hoped that all barangays could come up with the standard number of days and time for the processing of desired services.

Lao said the compliance of barangays with the Ease of Doing Business will further improve the level of compliance of the Iloilo City government. (PNA)

During his press conference on Monday, President Ferdinand Marcos said that just 15 contractors out of 2,409 accredited bodies cornered P100 billion, or 18 percent, of the P545 billion allotted to flood control projects during the first three years of his administration.

Among the 15 contractors, five had projects in almost the entire country.

There was also a mismatch between the most floodprone areas in the country and those with the highest number of flood-control projects.

Sixty-four percent of all projects under the present administration also lacked clear descriptions. Many suspiciously carried the same price tags even though they were in different locations.

In the President's words, the initial findings he received after his call for accountability in flood-control projects, which he made during his State of the Nation Address just two weeks ago, were disturbing. This was the same speech during which he famously uttered: "Mahiyanaman kayo (have some shame)!"

In Monday's press conference, Mr. Marcos said they were not accusing anyone of anything - yet. He was cautious about naming names and making unsubstantiated allegations. Nonetheless, the frequency

with which the companies' names appeared in the initial summary stood out. Certainly, the list will give way to investigations and, hopefully, in the not-so-distant future, indictments and convictions where they are due.

These revelations sting because flooding has become a gut problem for many Filipinos, given the frequency and intensity of the weather disturbances here and the uneven capacity of local governments and communities to deal with disasters.

Lest we become carried away by what the findings point to, it is always good practice to ground ourselves on what we have and what we don't. Indeed, this is only the tip of the iceberg. The irregularities being talked about only relate to projects in flood mitigation. There are numerous other infrastructure projects in the country. Flood control projects simply came to the surface because of the severe flooding incidents that occurred just days before the President delivered his SONA.

Second, these only represent projects beginning July 2022, when the Marcos administration took office. There are far too many tainted deals from years and administrations before. The connivance between contractors and government officials has been going on for generations.

We wonder: who among those who stood, clapped for, and cheered the President during the SONA were in fact there in the gallery without shame?

Mr. Marcos challenged investigative journalists to do their jobs in exposing these malevolent alliances, some sort of twisted "public-private partnership." We do as much, but has it not always been the job of those in government to perform their duties with honesty and integrity, and to prevent the likelihood of corruption among their ranks, and to keep probing no matter who is involved and no matter how much it would hurt, politically?

It's not a figure of speech: corruption kills. We look forward to the subsequent probes and hope that this will yield real consequences for the guilty on the one hand, and for those whose lives and livelihoods are at stake, on the other,

Integrity in the healthcare system

Universal healthcare in the Philippines has always been a noble aspiration, a dream where every Filipino, regardless of income or social standing, can access quality medical care without the fear of bankruptcy.

Recently, huge strides have been made in pursuit of this aspiration. In his fourth State of the Nation Address (SONA), President Ferdinand R. Marcos Jr. touted the zero-balance billing policy for patients admitted in a public hospital - a landmark step in making healthcare truly accessible.

According to the Philippine Health Insurance Corporation (PhilHealth), the zero-balance billing policy applies to all Filipinos, not just the indigent, who are admitted to a basic or ward accommodation in a Department of Health (DOH)listed hospital. While these are promising developments in our healthcare system, deep-seated issues persist that threaten to derail the very promise of free and universal healthcare for all.

Last month, former lawmaker and longtime advocate of universal healthcare, lawyer Erin Tañada, sought the suspension or revocation of the medical licenses of two doctors who were allegedly involved in a multi-level marketing (MLM) scheme.

Previous Senate hearings have revealed that these doctors were prescribing medicines produced by a specific pharmaceutical company in exchange for financial incentives and material rewards. The more they prescribed, the more points they earned, which could be converted into luxury cars, foreign trips, and other incentives. Sadly, these hearings seem to have faded from public memory, so a

resolution was never brought to light.

While MLM schemes are not prohibited by the law, such practice is widely viewed as unethical, especially in the medical field where decisions should be based on science and the best interest of the patient. The practice of MLM schemes in the healthcare sector compromises the expertise and integrity of the medical profession since commercial interests are involved. Worse, such practices threaten the very integrity of the medical practice and the healthcare system, eroding the trust of patients.

One can clearly see the tug-of-war between efforts to provide better healthcare access to the poor and the actions of those who exploit the system.

I have deep respect and admiration for doctors and professionals in the healthcare industry, especially those who continue to serve the Filipino people despite the many challenges of our system. It saddens me to know that the reputation of this highly respectable field is tainted by a few

This situation should serve as a wake-up call for the government, especially the DOH, the Professional Regulation Commission and the Board of Medicine, to strengthen their oversight mechanism and establish clear regulations that prohibit profit-oriented prescriptions by physicians. I call on our legislators to explore the possibility of enacting a law that prohibits such unethical schemes.

To truly cultivate the country's healthcare system, we must not only regulate unethical practices, we must also address the root causes that make these a tempting option

This poses the question: What kind of healthcare system and culture are we cultivating? If left unaddressed, we risk corrupting future medical professionals and damaging our public health system to the point that it could be irreversible, and universal healthcare remains an aspiration.

Many doctors, especially those in public hospitals, face long hours, strenuous shifts, and are forced to make do with inadequate facilities and compensation. While they are expected to uphold the highest standards of ethics and professionalism, the sad reality is that many of them are working in a broken system that undervalues their expertise and service.

If we want to prevent corruption in the medical field, we must ensure that our doctors are properly compensated, adequately supported, and given opportunities for growth that do not come at the expense of their integrity.

Al as proactive tool for youth mental health

Aug. 12 is International Youth Day. It is an awareness day designated by the United Nations (UN) to draw attention to the prevailing issues surrounding youth and to celebrate the potential of our youth as "partners in today's global society." By virtue of a UN resolution, the world body recognized the urgent need to engage the youth and the various local governments in collaborative efforts in forming fruitful partnerships in nation building.

According to several relevant studies, youths all over the world in general have certain common issues. These are limited access to opportunities for education, healthcare and decent work alongside the presence of stumbling blocks to political participation and representation. More importantly, the most pressing issue for youths everywhere is the prevalence of mental health conditions.

To lessen harmful acts done by youths all over the world caused by mental health conditions, some countries are resorting to increased surveillance and early intervention. Schools in the United States are using artificial intelligence (AI) software like Gaggle and Lightspeed Alert to track the online activities of youths looking for signs they might hurt themselves or others. Due to suicide and criminal actions caused allegedly by mental health conditions, AI surveillance systems are being used by the US schools to dip into online conversations and notify both school authorities and law enforcement. With these surveillance systems, students have been called to office, arrested and interrogated for online remarks that could lead to harm. The developers of the applications insist that the main purpose of the system is preventive not punitive If the online comments indicate a desire to harm, then the school authorities should do early intervention.

Admittedly, the prospect of online surveillance might seem radical. There are some however who see the positive potential of such surveillance being used in the Philippines for purposes of early intervention. There have been some recent cases of minors harming themselves due to bullying. There are even cases of minors harming others through physical or

online bullying. The recent viral video of some minors beating up a fellow student with apparent glee should sound an alarm to school authorities on the possible connection of mental health conditions on both the victims and the bullies themselves.

In observance of International Youth Day, perhaps it is time to reflect again on the prevalence of mental health conditions among our youth. Maybe it is time to be more proactive and maybe it is time we also use available technology to help authorities to be more proactive.

A significant step backward for children's rights

While the rest of the country reeled from the devastation brought by recent storms and the southwest monsoon (habagat)—causing widespread flooding, landslides, and displacement—a senator chose this moment to file a bill that would inflict further harm on countless Filipino children by lowering the minimum age of criminal responsibility to just 10 years old.

It is strikingly ironic that Senator Robin Padilla, who knows firsthand the harsh realities of incarceration from his years in prison for illegal possession of multiple firearms, would now push to impose criminal liability on children as young as 10 years old who commit "heinous crimes." Heinous crimes include murder, infanticide, kidnapping and serious illegal detention resulting in death or rape, robbery with homicide or rape, destructive arson, rape, and carnapping where the driver or passenger is killed or raped. It is difficult to imagine a 10-year-old child committing such horrific acts independently. And if they do, it is almost certainly under the influence, coercion, or instruction of an adult.

Anyone who has spent time with a 10-year-old knows that children at this age are still making sense of their surroundings, gradually learning right from wrong, and heavily dependent on the guidance of adults in their families and communities. It is therefore absurd to treat children in conflict with the law (CICL) the same way as adult criminals who deliberately prey on unsuspecting victims.

Child rights advocates have repeatedly emphasized that the Juvenile Justice and Welfare Act already holds CICL accountable. The Child Rights Network (CRN), a civil society organization that has consistently championed children's rights, underscored the real issue—not the age of criminal responsibility, but the poor implementation of Republic Act 9344, or the Juvenile Justice and Welfare Act (JJWA) of 2006.

To begin with, the JJWA provides a comprehensive framework for addressing the needs of children at risk and those in conflict with the law. It emphasizes prevention, diversion, rehabilitation, and reintegration—prioritizing the protection of children's rights and their overall well-being. This law reflects the Philippines' commitment as a signatory to the United Nations Convention on the Rights of the Child (UNCRC). Nineteen years after the enactment of the JJWA, child rights advocates continue to lament implementation gaps and inadequate resources that hinder the effective rehabilitation and reintegration of CICL in society.

Since the enactment of the JJWA, numerous documents, studies, protocols, guidelines, circulars, and memorandums—including its Implementing Rules and Regulations—have been issued to support its effective implementation. Despite this, only a limited number of national and local government officials and staff have fully understood the law and are actively working to uphold and protect children's rights. In fact, there is a barangay-level protocol for handling cases involving CICL and children at risk (CAR), recognizing that barangays serve as the first responders in addressing these issues.

Countless trainings and seminars have also been conducted for police officers, LGU personnel, NGO workers, and community members—those directly involved in the frontlines of JJWA implementation. Yet, significant gaps in implementation remain. The handling of CICL and CAR continues to fall short, despite the existence of detailed procedures meant to guide their treatment from start to finish.

The Juvenile Justice and Welfare Act (JJWA) created the Juvenile Justice and Welfare Council (JJWC), composed of key government agencies-including the Department of Justice, Department of Social Welfare and Development. Department of Education, Department of the Interior and Local Government, Commission on Human Rights and the National Youth Commission-and two representatives from non-government organizations. Notably, none of these agencies have recommended lowering the minimum age of criminal responsibility. On the contrary, they strongly opposed previous attempts to reduce it to 12 years old, standing firm in their commitment to protect the rights and welfare of children. We can be certain that the JJWC, together with child rights advocates, will once again stand firmly against this harmful and regressive attempt to lower the minimum age of criminal responsibility to 10.

A quick visit to the JJWC website reveals the real situation of CICL and CAR and makes it clear why lowering the minimum age of criminal responsibility from 15 is both unnecessary and unjust. The JJWC highlights that these children are often victims of circumstances beyond their control—such as abuse, neglect, dysfunctional families, and indifferent communities. Rather than punishment, what they need is compassion, support, and access to appropriate services that uphold their rights to survival, development, and meaningful participation.

(PAP), on the other hand, has consistently emphasized, based on extensive scientific research, that children and adolescents are fundamentally different from adults—particularly in areas such as decision-making, impulse control, risk-taking behavior, identity formation, and overall psychological maturity.

Responding effectively to the needs of CICL and CAR requires more than the standard whole-of-government approach. It demands the active cooperation of communities, civil society organizations, concerned individuals, and international partners. Laws, ordinances, and official policies alone cannot dismantle the deep-seated bias that views children as criminals rather than as victims of systemic failures. What is urgently needed is sustained advocacy that promotes children's rights and fosters a deeper understanding of their circumstances.

It is therefore imperative for government officials, law enforcers, local leaders, and community members to fully understand the JJWA, its implementing rules and regulations, and the various guidelines that govern the proper handling of CICL and CAR cases. The current push to lower the minimum age of criminal responsibility will not be the last. Unless we fully embrace and implement the core intent of the law—to protect, rehabilitate, and reintegrate children—such proposals will continue to surface.

Blaming the minimum age of criminal responsibility for the rise in criminality has become a tired and recurring excuse. At one point, there was even a proposal to jail the parents of juvenile offenders. Worse, there was a vicious attempt—echoed even by the country's highest official—to blame the principal author of the JJWA, rather than address the root causes of youth offending.

It is far easier to label children as criminals, delinquents, or social problems than to confront the deeper issues. Few are willing to hold society accountable for creating the conditions that breed challenges—poverty, homelessness, and communities that fail to nurture, protect, and support their children.

119 Antique farmers, fisherfolk to get insurance claims

SAN JOSE DE BUENAVISTA, Antique - The Philippine Crop Insurance Corporation (PCIC) in Antique will release the insurance claims of 119 farmers and fisherfolk in the next few days.

PCIC Antique head Clogene Galuego said in an interview on Wednesday that 119 farmers were affected by the southwest monsoon, enhanced by tropical cyclones Crising, Dante and Emong last month. They reported damage to crops and fishing boats.

"We had received a total amount of PHP640,108 from our PCIC regional office only yesterday, that is why we will be releasing it already in the next few days," Galuego said.

Each farmer will receive about PHP20,000 per hectare of their damaged crops, Galuego added.

However, it may still vary depending on the age, erop and area that were insured with the PCIC.

Aside from the farmers, there will also be fisherfolk who could receive their claims.

"There were 11 fishing boats that were also reported damaged," Galuego said.

The insurance claim will be PHP40,000 per unit if their fishing boat is motorized and PHP10,000 if nonmotorized.

Galuego also reminded farmers and fisherfolk to visit their Municipal Agriculture Offices (MAOs) to file their Notice of Loss since filing of claims for tropical cyclone Emong, the most recent weather disturbance to affect Antique, will be until Aug. 14. (PNA)

Meanwhile, Joel Sabio of Sta. Clara Farmers Association in Oton received a rice combine harvester designed to modernize the process of harvesting, threshing, cleaning, and bagging in one operation, hence, reducing post-harvest losses.

Sabio noted that this post-harvest equipment is a helping hand to the association that has over 90



School-based immunization targets over 80K learners in Iloilo

ILOILO CITY - The Hoilo Provincial Health Office (IPHO) is urging parents' support for the school-based immunization targeting 80,623 learners in public schools in the province.

Bakuna Eskwela will start this month until September, with 27,231 Grade 1 and 36,278 Grade 7 eligible learners for measles, rubella, tetanus, and diphtheria, and 17,114 Grade 4 female learners for human papillomavirus (HPV).

"The Bakuna Eskwela program of the Department of Health and the Department of Education aims to protect learners from vaccine-preventable diseases," IPHO head of health service delivery division Dr. Rodney Labis said in a media interview on Wednesday.

"It is an opportunity for health workers to extend protection to children who have not received any vaccines since they were small."

Labis encouraged parents to attend their schools' Parent-Teacher Association meetings to learn more about the immunization program.

He said it is also important for the target children to understand the benefits of the vaccine.

ICPO is country's best city police office

ILOILO CITY – The Iloilo City Police Office (ICPO) was recognized as the country's Best City Police Office, while the city government received a special award for its support to the Philippine National Police during the 124th Police Service Anniversary at Camp Crame in Quezon City on Tuesday.

ICPO Director Col. Kim Legada and former Iloilo City mayor Jerry Treñas received the award from President Ferdinand R. Marcos Jr. in a ceremony at the PNP national headquarters.

The police office bested two other finalists -- the Davao City Police Office and the Butuan City Police Office -- while the city government won over the city governments of Zamboanga and Pasig for the highly urbanized/independent city category as top performing city for investment in resources, infrastructure, and other strategic peace and order initiatives boosting the local police force.

"This award is a testament to the hard work, professionalism, and commitment of every member of ICPO, as well as the strong partnership we share with our local government and stakeholders. We will continue to serve with honor and dedication to ensure the safety and security of our beloved Iloilo City," Legada said in a statement.

Data showed that from April 2024 to March 31 this year, ICPO logged a 96.43 crime clearance efficiency and 92.73 percent solution efficiency, surpassing national targets.
