

lloilo emerges as national leader in community-driven development

THE province Iloilo is cementing its place on the map of good governance for being the first province to institutionalize community-led initiatives and people empowerment.

The Community-Driven Development (CDD) Day was launched in Iloilo on September 17, 2025 under the presence of Department of Social Welfare and Development (DSWD) Secretary Rex Gatchalian.

The event was rooted in Provincial Ordinance No. 2025-336 authored by then board member and now Bingawan Mayor Matt Palabrica which designates the third Wednesday of September every year as CDD Day in the province of Iloilo.

Iloilo's CDD roots run deeper. Back in 2012, the Sangguniang Panlalawigan passed Resolution No. 2012-377 declaring Iloilo as a Predominantly Community-Driven Development Province.

Gov. Arthur Defensor Jr. reaffirmed the provincial government's commitment to the programs and projects of the DSWD under his development mantra "MoRProGRes Iloilo" which is a whole-of-province approach to achieving a robust, progressive, globally-competitive, and resilient Iloilo.

MoRProGRes Iloilo is also a convergence initiative with the different national government agencies which pushes for community-driven programs and grassroots development.

"We are doing things here in convergence. We have a whole-of-province approach but we are also communitydriven. We are ready to partner with all your programs and projects as we have been doing before. We are ready to counterpart in a more practical term – in your KALAHI program, 4Ps, and SLP as well as other programs that we

can converge here in the province of Iloilo," Defensor said

"We look forward to promoting and pursuing this fundamental approach in doing things together with MoRProGRes Iloilo," the governor added.

Secretary Gatchalian lauded Defensor for "embracing development in the point of view of the marginalized and the vulnerable."

"When I found that Iloilo has a provincial resolution or ordinance enshrining community-driven development, I can tell you that you are the first LGU to have that. We have been pushing that in Congress but hindi natatapos. May you be the shining beacon and example of a local government unit or provincial government that leads the way in CDD," Gatchalian said.

The DSWD Secretary further lauded the provincial government for creating the Iloilo Provincial Convergence Committee led by the Provincial Social Welfare and Development Office which oversees and ensures the successful implementation of CDD programs.

Gatchalian said Iloilo may be the first, if not the only LGU, to have a convergence committee that makes sure that government services are delivered in the most efficient way.

The CDD Day launching was also graced by Vice Governor Lee Ann Debuque, Provincial Administrator Raul Banias, municipal mayors, DSWD officials and employees, PSWDO employees led by acting head Rani Melvi Cuarte, Capitol department heads, IPCC members, and other program partners and stakeholders.

tourism and the economy. She also emphasized the significance of open spaces in developing the potentials of young talents.

Additionally, the said project is part of the city's vision to turn La Paz Plaza into a multi-purpose sports hub. The location currently features a rehabilitated tennis court, a butterfly garden, and a koi pond, with a district library slated for future development.

Representatives from the GBP, including Antonio Cabalhug Jr., FVP for Panay Site of Meralco PowerGen (MGen) and Community Relations Officer Michael Guanco, highlighted their supprt to the community's growth and improvement.

They also shared updates on the lighting system wherein test and commission are planned to be conducted on September 26, 2025.

The La Paz Plaza football lighting project in Iloilo City also marks the first time a local government unit (LGU) has illuminated a plaza football field to meet international football standards.

Meanwhile, the scheduled date of the turnover ceremony also coincides with the mayor's 100th day in office, celebrating community, sports, and urban innovation. (via Iloilo City Government)

Provincial gov't rolls out PalengQR-Ph plus, fostering digitalization in local business and transport sectors

To foster the wider digitalization in the province, the Iloilo Provincial Government adopted the "PalengQR-Ph — a joint initiative by the Bangko Sentral ng Pilipinas (BSP) and Department of the Interior and Local Government (DILG) — on September 22, 2025.

The event, held at Iloilo Provincial Capitol, was graced by Vice Governor Nathalie Ann Debuque representing Governor Arthur Defensor Jr., BSP Monetary Board Member Benjamin Diokno, BSP Deputy Governor Bernadette Romulo-Puyat, DILG Iloilo Provincial Director Carmelo Orbista, Provincial Legal Officer Atty. Dennis Ventilacion, Local Economic Development and Investment Promotions (LEDIP) Center Chief Aulynn Yue Sin, among others.

Launched in 2022, the "PalengQR-Ph Plus" Program aims to promote digitalization across the country through implementing cashless payments in public markets, community stores, local transportation, and other business establishments.

In her speech, BSP Deputy Governor Romulo-Puyat emphasized the significance of using PalengQR-Ph Plus, which will bring convenience when going to public markets and terminals by applying cashless payments with the very exact amount.

Aside from digital payments, the said initiative — benefiting not only consumers but also market vendors, tricycle drivers, and Micro, Small, and Medium Enterprises (MSMEs) — provides access to other financial services, including savings, loans, and insurance.

The 42 municipalities and one component city across the province also committed in adopting the use of QR Ph through Governor Defensor's Executive Order No. 83, Series of 2025.

Currently, the said program is already adopted by around 270 local government units (LGUs) across the country.

to the said position, in concurrent capacity and in addition to his present duties," Secretary Lopez's order reads.

Conlu thanked Secretary Lopez and his LTO Region 6 colleagues for their support, while LTO-6 Regional Director Atty. Gaudioso P. Geduspan II welcomed the move as a win for stronger regional cooperation.

"Region 6 and the newly created LTO NIR would share the same goal and programs: enhanced enforcement of transport laws and road safety initiatives between two neighboring Visayan regions," Director Geduspan said, stressing that Conlu's new role is on top of his current post.

The appointment is more than a promotion on paper—it's the next chapter in a career built on hands-on transport reform. As former head of Iloilo City's Public Safety and Transportation Management Office (PSTMO), Conlu led bold changes that reshaped how people move around the city.

Under his watch, Iloilo became the first city in the Philippines to implement a localized Public Transport Route Plan — a milestone that modernized routes and set a benchmark for other urban centers.

Conlu's rise is rooted in community service. He began his public life as a Barangay Kagawad (2010–2015), then chaired the Iloilo City Urban Poor Affairs Office (2015–2017), where he pushed housing and welfare programs for the city's most vulnerable.

In 2017 he moved to the PSTMO, and during the COVID-19 pandemic he served as Iloilo City's COVID-19 Chief Implementor — balancing public health priorities with the urgent need to keep people and goods moving.

"It is both a privilege and an honor to serve the people of Western Visayas in this new role," Conlu said, echoing the humility and results-driven leadership that defined his tenure to date.

As Conlu takes on the LTO-NIR portfolio alongside his LTO-6 responsibilities as assistant regional director, Director Geduspan voiced confidence that his track record of pragmatic reforms and frontline crisis management will accelerate enforcement and road-safety programs across the neighboring Visayan regions. City Council wants lifetime ID for persons with permanent disability

ILOILO CITY - The Sangguniang Panlungsod (City Council) of Iloilo on Wednesday passed a resolution calling for the issuance of lifetime identification cards for persons with permanent disabilities.

During their regular session, Councilor Lyndon Acap authored a resolution urging the Persons with Disability Affairs Office (PDAO) to provide a lifetime ID after the sector expressed concerns regarding the requirements for renewing their Persons with Disability (PWD) IDs despite the permanent nature of their physical conditions.

"The renewal process has caused a hardship and stress to PWDs because it requires them to undergo medical examinations and secure medical certification and personally process their applications from the Persons with Disability Affairs Office," he said in his resolution.

Acap said the lifetime membership identification cards would address the concern, ease the burden of persons with permanent disabilities, and guarantee their continuous access to privileges.

Councilor Alan Zaldivar said the lifetime membership identification card is indeed beneficial for the sector.

"In fact, our office received a lot of inquiries," he said.

Zaldivar said renewing their card is "very uncomfortable" for members with permanent disability since they have to personally appear before the PDAO.

"With this, probably we can say that it is one way of giving them the incentives and the privilege, addressing the concerns of our persons with permanent disability," he added. (PNA)



Pirates and 'black shirts'

With thousands upon thousands protesting in Luneta and EDSA, who would have imagined that a small group of approximately 500 "boys" and men would end up grabbing everybody's attention, including local and international media.

They were noticed for two things in particular – their violence and their symbolic outfits. Small in numbers, their choice of black shirts, black balaclavas (ski masks) and their black Jolly Roger pirate flags mixed with reckless courage and anger, certainly forced us to watch!

How do you ignore such outfits that bring up images of Hamas and ISIS fighters and, for the Boomer Filipinos, the "Black Shirts" of the early 1970s, a Muslim defense group that waged a bloody and bitter war against Ilagas.

But more importantly, that flag, the toothy pirate flag that was prominent in the Indonesian protest marches, carried by many in the Nepalese uprising, is now seen in protest marches in the Philippines and France.

You can't be blamed if you were thinking of the Pirates of the Caribbean or the Houthi rebels in the Straits of Hormuz. But why did that pirate's flag seem comical, grinning more than menacing?

With a few Google clicks and AI assist, we are introduced to the world of "Gen Z Warriors." The pirate flag referred to in all the conflicts has an unlikely origin. It begins in the Manga world created in Japan.

It is part of an anime or Japanese animation series entitled "One Piece" that came out in 1999 and has set or broken records in publishing, even garnering a broadcast slot on Netflix with millions of devoted followers, most of whom are Gen Z.

Written and illustrated by Eiichiro Oda, "One Piece" follows the adventures of Monkey D. Luffy and his crew the Straw Hat Pirates in search of the mythical treasure known as the "One Piece" to become the next king of the pirates.

Through its run, the series established the Straw Hat Pirates as vehemently opposed to corruption, injustice and strongly anti-authority, waging their fight against a corrupt "World Government."

Many of today's Gen Z grew up reading and watching "One Piece" and following the Straw Hat Pirates. While the adult world branded many of them as entitled, soft or unmotivated, long running series such as "One Piece" served as imaginary model for aspiration.

The Jolly Rogers Flag of the Straw Hat Pirates may smile and grin but be forewarned – it has also become the flag that symbolizes defiance and freedom for many Gen Zs around the world.

In terms of optics, whoever came up with the idea of black masks, black shirts and the pirate flag clearly understood the art of media engagement, either a political strategist or PR expert.

By tapping into a global body of people who relate to the Straw Hat Pirates, ISIS and Hamas, complete with "I support Palestine" placards, they certainly got everybody's attention, especially the international media.

But now they also have so many critics and enemies. For starters, the violence they unleashed on the police was not aligned with the peaceful protests and seen as an attempt to hijack the legitimate protest.

The police exhibited maximum tolerance not only as ordered but possibly as their tacit recognition of people's grievances. Because of that, the black shirts fearlessly subjected the police to activist brutality.

We always call upon the police and the military to support the people, but we do nothing or say nothing to condemn the violent troublemakers masquerading as activists.

Last Monday, Sept. 22, 2025, a message on Facebook popped up on some chat groups claiming:

"Police brutalities are starting, always stay safe. It has become prevalent in the following areas: Recto, P. Noval, University Tower, basically any areas near UST.

"Additionally, police are permitted to shoot civilians

up until midnight. Most police are also in disguise, as to trick or to fool people."

The above message is a clear example of destabilization, agitation, if not sedition.

As a result of last Sunday's violence, many sectors including the media have called on DOJ Secretary Boying Remulla to apply the full force of the law, especially the NBI, to identify who the pirates are that attempted to hijack the peaceful protest of Sept. 21, 2025.

Any group that publicly, frontally and fearlessly attack members of the uniformed services must be arrested and charged. To the credit of Manila Mayor Isko Moreno and the DOJ, at least 100 adults are now facing criminal charges.

Were the pirates just a "fraternity of hooligans" or were they "hoodlums for hire" paid to agitate the police into attacking the protesters with a plan of creating negative content and videos for online propaganda?

Apparently so, after some of the people arrested confessed that they were paid P3,000 to create chaos in the streets and attempt to siege Malacañang.

Lest we forget or you just didn't know, Malacañang was attacked before Martial Law was declared. My father Louie Beltran and his best friend Jimmy Barbers recounted how they were caught between the mob and the gates and escaped a close call!

That attack on the Palace gates is why Mendiola bridge was shut down and has been a no man's zone ever since. Regardless of political color or affiliation, our country should have no room for anarchists or acts of violence.

Art used to imitate life, now we see life imitating art. The big difference is in art nobody gets hurt, nobody gets killed. In life people die! Let us speak out against violence as we speak out against corruption.

The original sinners

Who has the original sin in the flood control mess?

Seeing the players in this scandal pointing fingers at each other, it's complicated to identify the original sinner.

Sen. Panfilo Lacson says his fellow lawmakers are the original sinners, with their budget insertions providing the opportunities for infrastructure projects that are difficult to keep track of, and facilitating the payment of kickbacks.

Lacson is suggesting that the Senate and the House of Representatives agree to end budget insertions. Good luck on that.

Say goodbye to insertions, to the pork barrel, to those epal moments distributing tax-funded ayuda? Really, what are they smoking in the Blue Ribbon

Just watching congressmen realigning the P255.5 billion budget for flood control that was cut from the proposed 2026 budget of the Department of Public Works and Highways is not inspiring confidence that they are ready to say goodbye to all that.

Of the P255.5 billion that DPWH chief Vince Dizon slashed from his own department, the House budget amendment and revision sub-committee realigned P32 billion to the "KBL" (kasal, binyag, libing) aid program – the Aid for Individuals in Crisis Situations. AICS is the state-funded dole-out program used by politicians for self-promotion. The Department of Health got P29.2 billion from the realigned DPWH budget while the Department of Education got P26.5 billion.

It's fine to provide all forms of assistance to the needy, especially since there are still too many Filipinos genuinely falling under the extremely poor income category.

What is detestable is seeing politicians taking personal credit for aid bankrolled by taxpayers, such as AICS. Even ayuda recipients contribute to state coffers, through value-added and excise taxes automatically slapped on basic commodities and services as well as "sin" products such as cigarettes and kwatro kantos.

The Malasakit health centers, over which Rodrigo Duterte's anak-anakan Sen. Bong Go has effectively staked personal ownership, is part of AICS. This is why nobody believes the Department of Social Welfare and Development when it insists that politicians have no say in the distribution of AICS and other ayuda supervised by the DSWD.

Why does the budget slashed by the executive from the DPWH have to be realigned by lawmakers? It's still a proposed spending program; just cancel the amount from the outlay.

Budget insertions and pork barrels, however, are habit-forming. Lawmakers must be suffering these days from acute withdrawal symptoms.

Even getting them to return to the pre-Duterte practice of releasing their statements of assets, liabilities and net worth (SALN) is like forcing them to undergo a root canal without anesthesia.

All we've heard so far, even from new Speaker Bojie Dy (and for that matter, President Marcos), is openness to the release of SALNs. No one has followed the example of four congressmen, three of them belonging to the Akbayan party-list and the fourth a former representative of the same group, who released their SALNs three weeks ago.

With all suspicious eyes on Congress, there are lawmakers who must be hoping that the party poopers will eventually get tired and need rest. While everyone is sleeping, the crooks can then return to business as usual. Or else produce a 20,000-page budget report using fine print, and see who would have the patience to go through that! Bore the people to death, or at least to distraction, so the looting can be done while nobody is looking.

Yesterday's hearing of the Senate Blue Ribbon committee was particularly nauseating, as sacked DPWH district engineer Henry Alcantara provided more details about the systematic plunder of public coffers. The stolen amounts mentioned were mind-boggling. Probers should find out how the thieves accumulated such mountains of cash.

even if gradually, from the banking system? Or did the cash come mostly from casinos?

Alcantara could not offer first-hand information or material evidence directly linking Senators Jinggoy Estrada and Joel Villanueva and former senator Bong Revilla to kickbacks from their massive budget insertions.

But it was interesting that Alcantara claimed the funds were for the election campaigns of Revilla and Villanueva. As for around P1 billion in cash allegedly delivered to Ako Bicol party-list Rep. Elizaldy Co, it wasn't for his campaign. Maybe it was just plain greed.

You can see why lawmakers have consistently and strenuously resisted every effort to implement campaign finance reforms. Election campaigns are among the biggest and most efficient laundromats for dirty money in our plundered country. The Financial Action Task Force should look into this and review its lifting of the Philippines from its gray list.

Thanks to dynastic politics – with clans occupying nearly all available elective seats in their turfs – the system of checks and balances in government has become as ineffective as flood control projects.

We are the original sinners – for voting thieves and incompetent morons into office. They are in government not to give justice to their classification as public servants, but for power and its perks, for the billions in public funds for them to claim as their own and give away.

Can lawmakers really say goodbye to the pork barrel, the huge election campaign donations and massive kickbacks from their earmarked projects, the dynastic succession, the phalanx of state-funded bodyguards?

We would be so lucky.

Sparks from a Screen

There are memories that cling to you, not because they were grand or spectacular, but because they quietly shaped the person you were destined to become. For me, it was the year 2005. I was a child then, small enough to still be told what to do, yet old enough to crave the feeling of being trusted. My uncle, a teacher himself, often asked me to help him encode his students' grades. It was such a simple task, really—numbers, names, and endless rows in a spreadsheet. Yet, to me, it felt like holding the key to a secret world. Each click, each keystroke, made me feel powerful, as though I was no longer a child but a teacher in training. And there was something intoxicating about it—the thought that I could, in some way, shape the lives of students through those numbers. Looking back, I realize it was never just about typing grades. It was my first taste of responsibility, my first brush with the influence and dignity that came with teaching. My uncle's house was also one of the few homes in our community with internet access. To step inside it was to step into the future. I would spend hours marveling at this glowing portal, fascinated by its promise. At that time, the internet was slow, clunky even, but to me, it was a wonder. Those afternoons were filled not only with numbers and grades but also with dreams—dreams of what technology might become, and of what I might one day do with it. Years passed, and the dream that began in that room blossomed into reality. Today, I am an ICT teacher at San Enrique National Comprehensive High School. The young girl who once typed numbers in wide-eyed wonder is now guiding students through the vastness of the digital world.

It is a responsibility that feels heavier than I imagined, yet deeply fulfilling. I know now what my uncle knew then: that education is not just about knowledge—it is about shaping futures. Motherhood has only deepened this calling. My one-year-old child was born into a digital age so different from the one I knew. While I once marveled at the rare privilege of internet access, he will grow up in a world where information is limitless, where voices can cross oceans instantly, and where social

media has the power to make or break entire movements. But herein lies the double-edged sword. The same platforms that connect families and fuel creativity are also tools for politicians during campaigns. We have witnessed how social media can sway public opinion, how it can amplify both truth and lies, and how it can become the battlefield where the fate of a nation is contested. As much as it empowers, it can also manipulate. This is why I see my role as an ICT teacher not merely as teaching students how to use technological tools, but how to understand them. I want my students to see beyond the surface of apps and platforms, to question, to discern, and to recognize that every click has consequences. Technology is not neutral; it is shaped by those who wield it. And if I can open even a few young minds to this truth, then I know I am doing my part. For me, teaching ICT is not only about coding, presentations, or spreadsheets-it is about nurturing critical thinkers who will one day quard our democracy, demand accountability, and use their voices to uplift rather than divide. It is about preparing them for a world where power is no longer measured by muscle or money, but by the reach of one's ideas and the courage to use them well. As I watch my child grow, I hold on to this hope fiercely. I hope for a future where he can live in a country no longer trapped in the quagmire of old problems, but rising into something better. I hope for Filipinos who are not merely consumers of technology, but creators of change through it. And I hope that in some small way, through my teaching, I can plant the seeds of this brighter future. When I think of where it all began—one uncle, one computer, one child entrusted with grades—I am reminded of how influence works. It does not always shout; sometimes, it whispers. Sometimes, it is hidden in the simplest tasks, only to bloom years later into a vocation, a mission, and a legacy. And so, I continue—teaching, guiding, mothering—with the belief that the sparks I light today will carry forward into the lives of others, shaping not only their futures, but perhaps the future of our nation itself.



Last Sunday, the streets of Manila erupted with a familiar but urgent call to send to jail all those involved in massive corruption in the country. But the peaceful protest against anomalous, substandard and even non-existent flood control projects, while overshadowed by the violence that took place later that day, sent a clear and loud message: the looting of the national treasury must stop, and stop now.

The tens of thousands of Filipinos who gathered at Rizal Park and the People Power Monument in Manila and in other cities throughout the archipelago were there to underscore the fact that corruption persists on an even larger scale now than ever before.

The occasion marked the anniversary of martial law declared by then President Ferdinand Marcos Sr., yet the rallying cry was not about the past, it was about the present: a corruption scandal so brazen it threatens to overshadow even the infamous Priority **Development Assistance Fund or pork barrel scam** of 2013.

At the heart of the outrage are billions of pesos allocated for flood control projects, many of which turned out to be ghost contracts or dangerously substandard.



Gov't must heed clamor for change

The Discaya couple, who own a total of nine handles crises such as this. construction firms that bagged multi-billionpeso flood control projects, have become symbols of a system that rewards greed and punishes accountability.

But this time, the people are pushing back.

The twin "Baha sa Luneta" and "Trillion Peso March" protests were not just expressions of anger; they were declarations of civic ownership.

Among those who took part in the protest action were Church officials.

An outspoken bishop quoted Psalms: "Because the poor are plundered, because the needy groan, I will now arise."

A prominent cardinal called for repentance and restitution. Their presence, alongside activists, artists, and opposition lawmakers, signaled a rare convergence of moral, political, and cultural

Big protest actions against corruption indicate massive disenchantment with how government

Will institutions respond with integrity, or retreat into partisan paralysis?

We recall that earlier, President Marcos Jr. even welcomed the protests and claimed to support public outrage.

But if the administration is serious about reform, it must pursue the prosecution of those who benefited from the scam, recover stolen assets, and overhaul the procurement systems that enable such abuse.

The protests also remind us that real change does not begin in the halls of Congress or the Palace: it begins in the streets, in the voices of ordinary citizens who refuse to be silent.

The tens of thousands of Filipinos, from battlehardened activists to religious leaders and celebrities, who converged to demand accountability for what may be the largest corruption scandal in contemporary Philippine history, have already spoken, and government is left with no choice but to listen to them. Gangs, camps, and order

Recently, news and social media feeds were filled with youthful offenders destroying public property and engaging police officers in violent fights in the Mendiola area. The said images are now overshadowing the massive and effective peaceful rallies at both Luneta and EDSA.

The gatherings at both EDSA and Luneta where thousands of people showed collective outrage against corruption, are crucial and historic events. There is a feeling that now is the time to push for reforms in how government spends people's money. People from all walks of life gathered at the two sides and brandished placards and shouted chants and curses at those they perceived to be behind all these shenanigans. For these mass actions to produce concrete results, the pressure must be constant and eventually translated to the ballot box.

Unfortunately, the scenes of protesters destroying traffic lights, throwing bricks at police personnel, and even entering a private property to destroy and deface run the risk of bringing more harm than good to the struggle against corruption. I have had friends who try to defend these actions by stating that many of these people are angry and fed up and are justified in venting their anger. With apologies to

some of my friends, I can never abide with any form of anarchy or wanton undirected violence. These forms of violence are actually counterproductive. The stoplights, the private properties concerned and even the hapless police have nothing to do with the issues at hand. Passion is a valid driving force in any movement but undirected negative emotions manifested in useless violent acts do nothing but damage the things that matter.

What is more unsettling is that most of the violent acts are being done by young kids or those who have just reached adulthood. Whether these violent actions were a result of outside agitation or a result of true anger at their plight, these actions cannot be allowed to run unchecked. First of all, incidents like these can damage the very movement now mushrooming against corruption. Second, uncontrolled youths that are allowed to run wild without consequence or intervention will eventually erode peace and order in any local government.

I used to work for a local government for nine years. One of our main problems when we started our first term was the large number of youthful offenders in our city jail. In personal interviews with many of them, we all saw the anger, feeling of hopelessness, and despair in those young kids. It

was for this reason that my mayor started a highoctane program in educating these kids and giving them "re-education" programs. I saw the slow but steady improvement in their disposition. There were, however, truly disturbed and violent kids that needed to be separated from the community. I remembered these kids when I saw the aforesaid clips of the so-called "geng geng". In my experience, many of them can still be saved given enough intervention.

My pet project then which I hoped government could implement is a special camp for certain youthful offenders which would be manned by trained reeducators. There is a similar camp in China that could serve as a model where wayward youths are given tough love but non-violent re-education sessions to make them productive members of society again. It would be a combination boot camp and healing institute. Funding and personnel? Perhaps, the wayward funds could be diverted to this project and some legislators could be made to volunteer as a way of atonement. Just a thought.

When the people say 'Enough!'

The Filipino public is growing increasingly outraged as more reports surface of ghost projects and incomplete, substandard flood control initiatives across the country. Citizens from various sectors have expressed alarm over the depth and persistence of corruption. The Department of Public Works and Highways (DPWH) has emerged as a symbol of this problem, with some employees reportedly feeling ashamed to wear their uniforms amid mounting public anger.

The recent State of the Nation Address (SONA) by President Ferdinand R. Marcos Jr. sparked a stir in a nation long numbed by corruption. His sharp words – "Mahiya naman kayo (Shame on you)" – have stirred Filipinos to take action, reporting ghost projects, incomplete works, and substandard flood control structures through the "Sumbong sa Pangulo" website. In just days, the list of complaints has grown, forming a map of alleged irregularities that netizens now pore over with vigilance.

All sectors are now raising their voices against corruption, particularly the scale of anomalies linked to the DPWH. This broad outrage is a positive sign, as civil society organizations, the Church, youth, business, academe, and concerned citizens are uniting to protest. Many have even remarked that past scandals, including the Napoles plunder case, pale in comparison to the magnitude of corruption now being uncovered.

A broad coalition of civil society organizations is voicing its anger and disgust, preparing for a massive rally at EDSA and Luneta on Sept. 21. Similar protest actions are also taking shape in major cities and provinces across the country. Widespread corruption, long tolerated by a weary public, has now become the force uniting the nation in collective outrage.

Concerned citizens are even finding creative ways to show their disgust over corruption. In Quezon City, senior citizens turned their weekend Zumba routine into a protest dance. In Marikina, more than 500 runners joined the "Takbo Laban sa

Korapsyon," while over 150 cycling groups staged the #KontrakTOUR Bike Protest from Quezon City Hall to Luneta Park. The most dramatic, however, was the walkout of thousands of University of the Philippines students, which spread widely across social media. Similar protests have also erupted in universities and major cities, especially across the National Capital Region.

Thirty business groups have condemned what they describe as the "shameful, unabated, continuing, and excessive acts" of corruption. Their demand goes beyond simply curbing greed within the DPWH – they are calling for an end to these practices and jail time for those involved. Even the Philippine Chamber of Commerce and Industry (PCCI), the country's largest business association, has urged the government to act swiftly, warning that corruption in flood control projects could erode investor confidence and alarm neighboring countries. The business sector stressed its concern, noting that it is among the country's biggest sources of tax revenues.

The President is just as outraged at the scale of corruption in the DPWH. He even said that if he were not President, he might be out there marching on Sept. 21. In his words, "We should all be frustrated. You can demonstrate, but keep it peaceful." With that, he gave voice to the very sentiments now rumbling across the nation.

What struck me most was the way he drove the point home: "To show that you are enraged. Demonstrating your anger is crucial. Demonstrate your disappointment. Demonstrating your desire for justice is crucial. It is important to demonstrate your desire for justice and fairness. What's wrong with that?" Indeed, what is wrong with anger when faced with corruption this brazen and this deep? Who in their right mind would not be furious? And day after day, as more ghost projects and substandard works are exposed, the reasons for outrage only multiply.

Currently, Bulacan holds the dubious distinction of having the most corrupt flood

control project in the country. Fittingly, it was the first case filed by the new DPWH secretary – a sweeping charge against 20 personnel from the Bulacan 1st District Engineering Office and four private contractors accused of massive corruption. The public has made it clear that the guilty should face jail time. The outrage is palpable. The people are angry. And yes, even the President is outraged.

Some fear that this outrage could spiral into chaos, like what happened in Nepal and Indonesia where frustrated mobs turned violent. The police are already on red alert as preparations intensify for the Sept. 21 rally. There are even whispers that this could become another EDSA III. But I disagree. The two EDSAs toppled presidents. What we are witnessing now is different – a national outrage sparked not against the sitting leader, but by him. This time, it is the president himself exposing corruption and taking it head-on.

As the President put it, "I want to show that there is justice. I want to show that there is fairness. I want to hold these people accountable." Those are not just words; they are a challenge – to the corrupt, to the complicit, and to the complacent.

In the end, this is no longer just about ghost projects or flood control scams – it is about a nation finally refusing to be ghosted by corruption itself. The anger is real, the outrage is raw, and the momentum is building. Sept. 21 will not be remembered as a day of chaos but as a day when Filipinos stood up to say: enough. With Marcos keeping his word and the people sustaining their fury, the event could mark the beginning of a reckoning – not only for the DPWH, but for every public official who still believes corruption is business as usual.

ORDINANCE INSTITUTIONALIZING THE PHILIPPINE APPROACH TO SUSTAINABLE SANITATION (PhATSS) FOR GRADE 2 (G2) – BASIC SANITATION OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

Introduced by: SB Member Nemesio A. Cachite

Section I. TITLE. This Ordinance shall be known as "PHILIPPINE APPROACH TO SUSTAINABLE SANITATION (PhATSS) FOR GRADE 2 (G2) – BASIC SANITATION OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

Section II. DECLARATION OF POLICY. Through the implementation of the Philippine Approach to Sustainable Sanitation (PhATSS), the LGUs shall able to convert the Philippine Sanitation goals into doable steps and also and also allows them to determine the best combination of programmatic approaches, technologies and services needed in their locality; PhATSS implementation shall be guided by the principles of equality, participation, responsiveness, accountability, and transparency. Implementation shall be anchored on a community – based participatory process that leads to positive behavioural change among households and communities and that encourages progressively increasing demand for sustainable sanitation.

Section III. DEFINITION OF TERMS. For the purposes of this Ordinance, the following terms shall mean:

- a) Zero Open Defecation this means to when no feces are openly visible or exposed to the environment. Achieving ZOD might involve the use of any form of toilets.
- b) Verification of the ZOD status of the barangay entails on the spot check in selected households and in the community to assess whether or not they have achieved ZOD.
- c) Certification is the official confirmation and recognition of Zero Open Defecation status.
- d) Sanitation refers to the hygienic and proper management, collection, disposal of human excreta (feces and urine) and domestic wastewater to safeguard the health of individuals and communities. This is usually concerned with preventing diseases by hindering pathogens or diseasecausing organisms found in excreta and wastewater from entering the environment and coming into contact with people and communities.
- e) Sustainable Sanitation is the process of empowering families and communities to partner with local governments and other stakeholders to address sanitation issues and problems using affordable, appropriate and dynamic sanitation technologies and supported by enabling legal/ regulatory framework, management systems, technical assistance from various sources and access to financing mechanisms with a system of rewards and incentives for the protection of the environment and people's health.
- f) Grade 2 (G2) or Basic Sanitation Status is the status of the community wherein households, schools, child development centers and public institutional facilities have their own sanitary toilets that are functional and communities properly manage animal excreta and properly dispose their solid waste, in addition to maintaining the norm that open defecation is unacceptable.

Section IV. OBJECTIVES. It is the objective of this Ordinance to promote sustainable sanitation thru PhATSS G2 level for all residents of the Municipality of Bingawan.

- a) All barangays having their own barangay sustainable sanitation plans and budgets in place in line with the Municipal-wide Investment Plan for Health (MIPH);
- b) All barangays declared PhATSS G2 Level Compliant;
- c) All river systems designated as Water Quality Management Areas;
- d) Achieving 100% of the household in the municipality with sanitary toilets;
- e) Universal access to safe and adequate sanitary facilities have been achieved;
- f) Proper hygiene practices are accepted norms within families and communities;
 and
- g) Sustainable sanitation is institutionalized.

Section V. PHATSS G2 LEVEL SANITATION PROGRAM. All of the following criteria shall be complied to determine the G2 Sanitation Level:

- a) Open Defecation is not practiced and all households are properly disposing sanitary napkins and diapers;
- b) 100% of households have their own sanitary toilet with soap and water, and have available water and soap at/or near their toilets with septic tank and no sharing of toilet;
- c) All schools have safe, functional and gender-segregated toilets with soap and water, with overall pupil to toilet ratio not exceeding 100:1;
- d) All Child Development Centers (CDCs) have at least one age-appropriate sanitary toilet with soap and water that is safe and functional;
- e) All other public institutional facilities have at least one (1) functional sanitary toilet soap and water;
- f) All households and public institutional facilities are practicing segregation and/or composting of solid waste at source;
- g) Presence of functional materials recovery in the barangay;
- h) Availability of mechanism to sustain the local ordinance on ZOD, in addition to creating a local ordinance on having toilets in all households, CDCs and other public institutions;
- i) Animal excreta management, solid waste management and a monitoring mechanism to sustain G2 status; and
- Sanitation financing to reach G3 status allocated through localized sectoral master plans and local development plans.

Section VI. ORGANIZING THE G2 VERIFICATION AND CERTIFICATION

TEAM. The agencies and members of the Verification and Certification Team shall be established at the municipal level through an executive order or council resolution. The composition of the team shall include but not limited to:

- 1) Municipal Health Officer as Core Leader
- 2) Rural Sanitation Inspector
- 3) SB Member, Chair, Committee on Health
- Representative from the Municipal Health Board
- 5) Representative from the Provincial Health Office
- 6) Representative from the Provincial DOH Office
- 7) Representative from the DepED District Office
- 8) Representative from the Municipal Social Welfare and Development Office

- 9) Representative from the Municipal Environment and Natural Resources Office
- 10) Federation President, Barangay Health Workers
- 11) Representative from the Civil Society Organization
- 12) President, Liga ng mga Barangay

Section VII. VERIFICATION AND CERTIFICATION OF BARANGAYS FOR G2

- 1. Documentation Requirements. Prior to requesting for verification, the Barangay LGU prepares the following necessary documentation required for PhATSS Services Level G2:
 - Copy of G1 Certificate
 - Community map
 - Copy of Barangay Action Plan to reach G3
 - Copy of Annual Investment Program (from either the barangay or municipal that reflects budget allocations for sanitation to G3
 - Local Ordinance on management of animal excreta and solid waste
 - · Equipment list used for solid waste collection
 - Schedule of collection of garbage
 - List of designated EcoAides
 - · List of household head names of all residents of the barangay
 - List of all public institutional facilities located in the barangay
- 2. Requests. The barangay LGU submits the following requirements to Municipal PhATSS Verification and Certification Team:
 - Request Letter for G2 Certification
 - Monitoring report form (FHSIS) 100% access of household to sanitary toilets
 - Copy of G1 Certificate
- 3. Verification. At least 50% plus one of the Verification and Certification Team members should be present during the verification and certification activity in the requesting barangay. There should be at least one (1) representative either from the Provincial DOH Office or Provincial Health Office in all verification and certification activities in the barangay. The team randomly selects at least 10% of the households and visit these households on the spot for interview and assessment. For public institutional facilities, the team randomly sample 50% of each type of public institutional facilities.
- 4. Certification.
 - a. For Barangays: The Municipal PhATSS Verification and Certification Team awards the G2 Certification.
 - b. The Municipal Health Office shall submit to the Sangguniang Bayan Member, Chairperson Committee on Health, a Certification Report that contains the following:
 - Provincial Health Office or the presence of a representative from the Provincial Health Office or the Provincial DOH Office in all barangay verification and certification activities;
 - ii. Compilation of PhATSS G2 Certificates of all barangays;
 - iii. Latest quarterly FHSIS Report reflecting 100% access to sanitary toilet of all households in the municipality;
 - iv. Upon verification of the validity of the documents, the Sangguniang Bayan Member, Chairperson – Committee on Health shall file a resolution endorsing the certification of their municipality having complied with all criteria for G2;
 - A copy of the approved resolution shall be forwarded to PHO;
 - vi. Upon satisfactory review of the reports, the Provincial Health Office and the Provincial DOH Office shall jointly confer and award a municipal wide G2 certification; and
 - vii. Confirmation of the presence of a representative from the Provincial Health Office.

Section VIII. SUSTAINABILITY. For the program to be sustainable, the following shall be observed:

- a) G2 non compliant barangays shall include the purchase of toilet bowls and other materials in their Annual Operation Health Plan and Annual investment Program.
- b) Barangays who are not 100% G2 compliant and required to allocate budget necessary for the G2.
- A regular advocacy thru information and education campaign shall be done within the barangay level by the Verification and Certification Team or barangay officials;
- d) Encouragement of the construction of sanitary toilet during the Pre-Marriage Counselling.
- e) There should be a Barangay Task Force created that will monitor households that have no sanitary toilets.

Section IX. BUDGET. The Municipal Government of Bingawan shall allocate funds for the purchase of toilet bowls and other materials, incentives and PhATSS G2 Level program under the Municipal Health Office allocation.

Section X. MONITORING AND VALIDITY.

- a) There shall be a Barangay Task Force created that will monitor G2 Sanitation Level of the Barangay.
- b) Barangay officials thru the Barangay Health Board will submit report to the Municipal Health Board as to them accomplishment of G2.
- c) The municipal G2 verification and certification team shall monitor and evaluate every quarter the accomplishment of each barangay on PhATSS Service Level G2.
- d) PhATSS Service Level G2 shall be monitored every quarter and consolidated by the Rural Sanitation Inspector. The Municipal Health Officer shall present the consolidated report to the Local Health Board and shall submit the same to the Provincial Sanitation Coordinator.
- e) The Provincial Health Office shall conduct spot checks of the certified G2 barangays annually. During which, the G2 certification status of the barangay may be revoked, if the barangay does not maintain the criteria required in the PhATSS Services Level G2, and only after two (2) failed spot checks.

Section XI. DISTRIBUTION SCHEME

- a) Target Beneficiaries:
 - 1. 1st Priority Indigent Households without toilets
 - 2. 2nd Priority Indigent Households with unsanitary toilets
 - 3. 3rd Priority Indigent Households sharing toilets
- b) Identification of Recipients/Beneficiaries:
 - The Barangays, through their respective Punong Barangays shall submit Barangay Council resolutions with target beneficiaries to the Municipal Sanitary Inspector.
 - Beneficiaries identified by the Punong Barangays shall be validated by the Municipal Sanitation Inspector. Once qualified, it shall be endorsed to the Project Management Committee.
 - 3. The Project Management Committee, upon receipt of the resolution, shall validate if the list of beneficiaries have met the criteria. The committee shall make a recommendation to the mayor for approval.
 - 4. An orientation on PhATSS G2 Level Management shall be conducted by the Municipal Health Office together with the Project Management Committee, Municipal Officials, Municipal Health Office personnel, BHWs and Punong Barangays prior to actual implementation.

Section XII. INCENTIVES. The Barangay's 100% PhATSS status shall be included as one of the criteria in the selection of Top Performing Barangay and Seal of Good Local Governance in the barangay (SGLGB).

Section XIII. PENALTY CLAUSE. Penalties for households that have no sanitary toilets are hereby imposed as follows:

- a) First Offense Admonition;
- b) Second Offense Counselling; and
- c) Third Offense Fine of P2,500.00

Section XIV. SEPARABILITY CLAUSE. If any portion or provision of this Ordinance is declared void or unconstitutional, the remaining portion thereof shall not be affected thereby and shall remain in full force and effect.

Section XV. REPEALING CLAUSE. All ordinance, resolutions and regulations or parts thereof which are inconsistent with this Ordinance are hereby repealed and modified.

Section XVI. EFFECTIVITY CLAUSE. This Ordinance shall take effect after compliance to the posting and publication requirements.
