## lloilo City to review flood mitigation projects

MAYOR Raisa Treñas led the ocular inspection of Phase 1 of the flood mitigation structure at Brgy. Mohon, Arevalo in Iloilo City on September 2, 2025.

The inspection of the structure was also joined by representatives from the City Engineer's Office (CEO), Office of the Building Official (OBO), City Environment and Natural Resources Office (CENRO), Department of the Environment and Natural Resources (DENR), and Mayor Sofronio Fusin Jr. from the municipality of Oton.

The said structure with its Phase 1 amounting

TO celebrate the accessible health services in the City of Love, the Iloilo City Government distributed about 272 mobility aid devices during the anniversary of the first ever USWAG Physical Rehabilitation Center located at Brgy. Taal, Molo on September 2, 2025.

The said distribution was led by Mayor Raisa Treñas, through the support of the Department of Health (DOH) wherein mobility aids that were given included 110 wheelchairs, 123 quadcanes, 14 walkers, and 25 crutches.

The rehabilitation center - launched in August 28, 2024 during the administration of former Mayor Jerry Treñas —is the first-ever free facility in

over Php90 million and with a span of 300 meters — was handled by the contractor, St. Gerrard Construction General Contractor and Development Corporation which is reportedly owned by the controversial Discaya family.

This was also implemented through the Iloilo City District Engineering Office (ICDEO) which included an esplanade and a bike lane.

In an interview, Chairman, Kap. Rico Francis Acap said they did not expect such project will exist in Brgy. Mohon, which also covered other nearby areas. He added that the said project was also not coordinated with their barangay.

"It was during the project's construction that Typhoons Crising and Dante first entered and caused flooding in our barangay," Acap said.

During the inspection, the project's signboard did not indicate a starting date, target completion date, and some key details, raising concerns about unclear information and possible lack of transparency.

Under the Circular No. 2013-004 of the Commission on Audit (COA), signboards of government projects should include essential details such as project name, implementing unit, description, funding, cost, and duration.

Acap cited that the "almost completion" of the project was about three months ago, stating that it began around January 2025.

He also conveyed the residents' fears and concern, noting they were assured with positive benefits that the project will bring them, but the reality in their barangay shows otherwise.

He also added that they did not expect that the embankment of the structure would reach five meters, contrary to the three meters that was indicated during the visit and orientation of the ICDEO during their visit to the said barangay. OBO also confirmed that the supposed embankment of the project was only three meters.

"Based on their presentation (ICDEO), the project was highlighted for its positive benefits, particularly flood mitigation, which was supposed to help address flooding in our area. However, after what happened, our residents are now fearful that whenever typhoons come, flooding might keep happening again," Acap said.

Also, Oton MDRRMO Head Malvin Nad said that they will be reviewing and further study the flood mitigation structure located in the said area to check if it is directly attributed to the flooding in Oton.

He stated that when the southwest monsoon occurred which lasted four days, flood affected Oton, a municipality just beside Arevalo district. It was also discovered that the flood water which is supposed to go directly to Iloilo River, went back to the said town before going to Batiano River.

Nad cited the barangays in Oton affected by the previous flooding which include San Nicolas, San Antonio, Poblacion North, Alegre, Buray, Tagbac Sur, Lambuyao, Cagbang, Tuburan, Mambog, Cabolo-an Sur, and Cabolo-an Norte.

He also stressed that flooding in their town is common but not as longer compared to the recent flooding due to southeast monsoon.

#### Iloilo City to purchase 1.5K bags for P20/kg. rice program

ILOILO CITY – The city government here will purchase 1,500 bags of low-cost rice, each weighing 50 kg., in line with the implementation of the "Benteng Bigas Meron (BBM) Na!" Rice Program.

Mayor Raisa Treñas, in an interview on Tuesday, said the city government has allocated PHP500,000 for the program.

Iloilo City that provides accessible rehabilitation services for Ilonggos seeking to recover body functions affected by medical conditions or injuries.

This facility also offers initial patient evaluations, and comprehensive therapy services for stroke, neurologic disorders, orthopedic and congenital conditions, osteoarthritis, and other pain syndromes affecting the patients's mobility and their everyday lives.

During its first year of operation, the rehab center has catered 36 patients, with eight successfully discharged, and also conducted about 684 therapy sessions.

Mayor Raisa Treñas expressed gratitude to DOH's support through donating mobility aids for indigent Ilonggos. In her present leadership, she reaffirmed her commitment of prioritizing free and quality health services.

The city mayor also revealed plans of opening more rehabilitation centers in other districts of Iloilo City to reach and cater everyone. Treñas said the program has specific beneficiaries, among them members of the Pantawid Pamilyang Pilipino Program, solo parents, senior citizens, indigents, and persons with disabilities.

"We planned to sell in our Merkado Lokal and Uswag Rolling Stores," she said.

She said the 1,500 bags will be sold gradually until December, aiming to probably release about 200 bags during the Merkado Lokal every Thursday and Friday of the third week of the month.

A beneficiary can purchase up to 10 kg. of rice per month.

Last week, the Sangguniang Panlungsod (city council) passed a resolution authorizing Treñas to sign an agreement with the Food Terminal, Inc. (FTI) to procure rice from the National Food Authority.

The city government will set the date for the program launch once the FTI, based in Manila, has signed the agreement.

The program is already being implemented in the province of Guimaras, while the Department of Labor and Employment rolled out the program to minimum wage earners in the region on June 13, for the benefit of 4,500 workers.

Under the program, the local government and the Department of Agriculture will have a counterpart subsidy share to reduce the cost of rice to PHP20 per kg. (PNA)

Defensor emphasized the province's bold vision to make Iloilo a Forest Province, noting that stronger forests mean stronger and safer communities.

"We want to dedicate the whole month of September in preparation so that our work towards our vision will gain traction," he said. "The forest is the best flood control project."

The governor explained that Iloilo's forest development strategy, anchored on Executive Order 195 or Tanom Iloilo for More Progress, goes beyond ceremonial planting. It focuses on tree growing and forest development interventions in three key areas including recovering primary forests in the mountains, maximizing Integrated Social Forestry Areas for livelihood and sustainability, and mobilizing public and private lands for tree-growing initiatives.

For Defensor, protecting forests is not just about conservation but also about flood prevention, water security, and livelihood

opportunities for Ilonggos. By engaging local governments, communities, schools, businesses, and civic groups, the program aims to turn Piyesta sa Kakahuyan into a convergence movement for environmental resilience.

DENR's Red Raul Lorilla called the celebration "a symbol of a community united in the crucial mission of rehabilitating our forests and preserving our natural heritage for future generations."

Buyco meanwhile underscored the broader impact of the initiative.

"This is a memorable step forward for a cleaner and healthier community, a greener and healthier province, a greener and healthier forest province. Please continue to support our climate-resilient forest province."

Now on its 25th year under Provincial Ordinance No. 2000-040, Piyesta sa Kakahuyan continues to evolve into more than a celebration of trees. (Capitol News)

### Iloilo City to provide early intervention for kids with autism

ILOILO CITY – The local government here is gearing up to pilot another program that will cater to children on the spectrum, or those with autism spectrum disorder (ASD), this month.

The "RISEable" program will provide early intervention to children on the spectrum, Mayor Raisa Treñas said in a media interview on Monday.

"We will help with their early intervention. We will be having a school for them," she said, noting that most parents suffering from mental health issues, like depression, have children with ASD.

She noted that early them to be "highly functional" when they grow older.

The City Social Office (CSWDO) will pilot the program and will soon open it in other districts of the city.

She said they have already tapped early education teachers, but they have yet to review the specifics of its implementation.

"We will be getting help from the occupational therapists, and then we are looking at how we can link with the developmental pediatrician to review the development of the children," the city mayor

On the other hand, the its launch on Aug. 18. city government will also launch the "Tindahan Livelihood Carts (TLC) ni Inday" program, a livelihood project for solo parents, out-ofschool youths, and young mothers on Sept. 4.

## Protecting our northern plank

**Editorial** 

With the Philippine Navy's brand-new forward operating base on strategic Batanes island near Taiwan, we are now in a better position to defend our northern flank.

The facility in Mahatao town will host Navy and Marine units under the Northern Luzon Naval Command tasked with securing the Luzon Strait.

This should provide a commanding lookout tower for the Philippines on our northern shores, particularly with the reported appearances in August of armed Chinese vessels in the Bashi Channel, a waterway that separates Taiwan and the Philippines, between Y'Ami Island of the Philippines and Orchid island or Lanyu of Taiwan.

Given the erratic situation between China and Taiwan, where there are more than 160,000 Overseas Filipino Workers, the operating base in Batanes should provide a breathing space for our officials who may have to launch quickly a shielded exodus for our countrymen working in Taiwan.

Beyond doubt, the northern base will be a tactical fortress for our country's security.

President Marcos Jr. recently pointed out that the country would be inevitably drawn into an allout war between global superpowers

Beijing and Washington over Taiwan. China considers Taiwan as a renegade province and has not ruled out using force to bring the territory under its control.

Not unexpectedly, Beijing has slammed President Marcos' statement as a gross violation of the 'One-China' policy that the two governments agreed upon when they established official diplomatic relations way back in 1975.

But the Philippine Navy's decision to establish a forward operating base in Batanes is timely and appropriate as reports indicate that three China

Coast Guard ships had been seen patrolling the eastern and western sides of the island-province last month.

That the CCG vessels were monitored passing through the Bashi Channel has been described as a "very unusual" track.

The three ships are large and armed, possibly indicating a hidden agenda by Beijing to mobilize other naval and coast guard assets in the area as part of preparations to seize Taiwan by force in the future.

We need to defend national sovereignty and territorial integrity with all our available resources.

And our Navy deserves credit for doing everything possible to achieve that objective even with limited resources at this point. (manilastandard.net)

### Accountability in flood control projects

Last week, President Ferdinand R. Marcos Jr. Construction & Supplies Corp., Wawao Builders, revealed that since 2022, only 15 contractors were MG Samidan Construction, L.R. Tiqui Builders, awarded some 20 percent of the total PHP545 Inc., and Road Edge Trading & Development billion flood control budget nationwide, equivalent to a staggering PHP100 billion in contracts.

Of the 15 contractors, five firms reportedly received flood control contracts in nearly every region of the country – a fact that the President flagged as "disturbing" as he highlighted the mismatch in the location of most of these flood control projects in contrast with the most floodprone areas in the country.

While the President's revelation is only the tip of the iceberg, it already paints a picture as to why year after year, Filipinos continue to wade through floodwaters that ruin homes, disrupt economic activity, and even claim lives. Now we know why: it's because a select group of contractors has been living off the people's money and the results are as murky as the waters they were supposed to control.

The 15 contractors named by the President who cornered nearly a quarter of the country's flood control projects are Legacy Construction Corp., Alpha & Omega General Contractor & Development Corp., St. Timothy Construction Corp., QM Builders, EGB Construction Corp., Topnotch Catalyst Builders, Inc., Centerways Construction and Development, Sunwest, Inc., Hi-Tone Construction & Development Corp., Triple 8 Construction & Supply, Inc., Royal Crown Monarch

Services.

It is highly unacceptable and downright immoral that a handful of companies are raking in billions while thousands, if not millions, of ordinary hardworking, tax-paying Filipinos wade through floodwaters and are left to drown in incompetence and corruption.

What's worse is that it seems that official records have also been tainted with corruption. Case in point is President Marcos Jr.'s recent inspection of a river protection structure in Calumpit, Bulacan, which has been tagged as "completed" in 2023 based on official records but, in reality, remains unfinished. President Marcos criticized the project as substandard and demanded an explanation from the contractor - St. Timothy Construction Corp., which is also part of the top 15 contractors awarded with flood-control projects.

The recent revelation of the President demands not just a thorough and transparent accounting on the budget for flood control but is a clear call on the Department of Public Works and Highways (DPWH) to bare the truth about these projects publicize the contracts, the locations, the timelines, the actual budgets, and the true status of these projects.

The people deserve to know whether these projects have been completed or have even

started, have met the necessary engineering standards, and are actually value for money.

If these contractors failed to deliver their promised projects or have lapses, it is simply not enough to shame them. They should be fined, blacklisted, stripped of future contracts, and be made to face the full extent of the law.

Given the "disturbing" revelation over these flood control projects, it is a must to have an independent audit of both completed and ongoing projects to check compliance with engineering standards, timelines, environmental safeguards, and budget.

I also call on the government, especially the DPWH, to provide the people with open-access status reports on all these flood control projects - an accessible website or online platform that details timelines, budgets, and status reports on the performance of each contractor. These status reports should be verified with site visits and quality inspections.

Flood control is not just a matter of technical expertise, it is a matter of governance, transparency, and public safety. People's lives, property, and livelihoods are at stake here.

As no less than the President said: "Mahiya naman kayo."

The call is clear: Accountability. Now.

### Personal anti-corruption crusade guide

These days, social media is abuzz about the topic of corruption. You can't open your various social media accounts without seeing someone a) rant against corruption in general; b) post stories or memes about alleged corrupt officials and contractors; or c) discuss the topic of the socalled nepo babies. The collective rage and vitriol against alleged corrupt officials and contractors are so palpable these days.

Despite all the anger, many are asking what can actually be done about corruption. Some people have resorted to naming specific individuals of performing corrupt practices. Unfortunately, pointing fingers at specific individuals without proof can lead to possible legal consequences. Some people are looking at the events in Indonesia and are wondering if rioting and targeted destruction can be an option. Again, inciting violence and actually doing violence may lead to extreme legal liabilities, especially when violence ends up physically harming someone.

There are actually more concrete and legal steps available to ordinary citizens if one truly wishes to join the fight against corruption.

First of all, one needs evidence. With today's technology, this is actually now easier. Officials or their kin, nowadays, actually flaunt lavish lifestyle that cannot be possibly supported by their declared income. You can actually report your corrupt official neighbor or acquaintance for unexplained wealth to the Office of the Ombudsman, either through an actual complaint or a simple letter. If you feel that a government project is so shoddy or not worth the money spent on the same, you can send a complaint to the 8888 Citizens' Complaint Center via SMS or message their website. You can also send an email or complaint to the Department of the Interior and Local Government (DILG) if the official involved is a local government official. If you do wish to follow through on these actions, one will have to invest time and effort. Unfortunately, many cases against officials end up dismissed because complainants lose interest or lose steam.

It is recommended that one read up on the Anti-Graft and Corrupt Practices Act or Republic Act 3019. It is not a difficult read, and even non-lawyers can quickly learn how officials can be charged under this act. Actually, other than corrupt acts, public officials can be charged for negligence, abuse of authority, and many other related actions. People should realize that public

officials are actually vulnerable to cases. This is why I always marvel at how some officials can foolishly believe that they can get away with acting arrogant. Officials are actually one letter or phone call away from being removed, losing their benefits, or ending up in jail so long as the requisites are present.

Of course, people often cite lack of time or fear for their safety as their main concerns. As such, joining anti-corruption groups or movements can be a better option for crusading individuals. Other than safety in numbers, resource pooling is easier in a group. For cases against local officials or congressman, one can always go to their possible political opponents, who will be more than motivated to carry the cudgels for one's crusade. There are also crusading media personalities who can assist any group in these endeavors.

In the end, if you truly believe in fighting corruption, then get off your chair and go out and do something about it.

## Negros Power to invest P192-M to acquire mobile substation

BACOLOD CITY - particular permanent The Negros Electric and Power Corp. is investing PHP192 million for the procurement of a 37.5 megavolt amperes (MVA) mobile substation as part of the first three years of the five-year development plan in its franchise area in central Negros.

Negros Power president and chief executive officer Roel Castro said in a press briefing on Wednesday, marking their first year of operation, that they are targeting to acquire the mobile substation by May next year.

"The new mobile substation will support growth in the area," he

This September, Negros Power eyes the completion of the Mountain View Substation upgrade with a budget of PHP25 million, and by November, targets to transfer the Mountain View 12MVA to the Murcia Substation with a budget of PHP10 million.

"The first three years are really more of rehabilitation and catching up. The next two years are really catching up, and hopefully in the third year, we will already be where we should be," Castro

"But we will not stop there because we still have two years to bring our system forward to make sure that our system, in the fifth year, is already ahead of the curve," Castro said.

Part of the modernization and expansion phase is putting in place the supervisory control and data acquisition system for real-time monitoring, control, and data acquisition, establishment of three more substations, expansion of lines and increased capacity, and continuous improvement of system reliability and capacity.

Castro said that, including the Sitio Electricification Program, Negros Power has already spent more than PHP1.2 billion out of its PHP2.1 billion investment to implement a five-year

IN THEIR ANNUAL BUDGETS

#### **EXPLANATORY NOTE**

In any government corporation, the greatest asset is their personnel. When they perform well, the institutions benefit and if they don't the whole government suffers or will be at the losing end.

Local Government Units as employers are obliged to take care of their workforce by giving them the proper benefits as mandated by the government.

As stated in Congress Joint Resolution No. 4 series of 2009 (Item 1), among the governing principles of the Compensation and Position Classification System (CPCS) is the establishment of performance-based incentive scheme which integrates personnel and organizational performance that shall reward exemplary civil servants and well-performing institutions.

In concurrence, Republic Act No. 10149 also known as the "GOCC Governance Act of 2011" states in its declaration of policy that reasonable, justifiable and appropriate remuneration schemes are adopted for the employees of GOCCs and their subsidiaries to prevent or deter the granting of unconscionable and excessive remuneration packages.

Executive Order No. 201 s. of 2016 under the order of by then President Benigno S. Aquino III, authorized the grant of additional benefits for both civilian and military and uniformed personnel.

By instituting the policy among LGUs to ensure that all applicable laws granting benefits, emoluments and incentives to government workers are included in their annual budgets; they will in turn, strive to improve their work performance and will bring positive impact to local governance.

**WHEREFORE**, on motion made by SP Member Santillan, and duly seconded en masse, be it

**RESOLVED**, as it is hereby **RESOLVED**, in a Regular Session duly assembled by the Sangguniang Panlalawigan of the Province of Antique to approve:

#### **PROVINCIAL ORDINANCE NO. 2022-315**

AN ORDINANCE INSTITUTING THE POLICY FOR LOCAL GOVERNMENT UNITS
TO ENSURE THAT ALL APPLICABLE LAWS GRANTING ADDITIONAL BENEFITS,
EMOLUMENTS AND INCENTIVES TO GOVERNMENT WORKERS ARE INCLUDED
IN THEIR ANNUAL BUDGETS

**SECTION 1. SHORT TITLE** – This ordinance shall be known as "An Ordinance Instituting the Policy Among Local Government Units to Ensure that All Applicable Laws Granting Additional Benefits, Emoluments And Incentives to Government Workers are Included in their Annual Budgets".

**SECTION 2. DECLARATION OF POLICY** – The provincial government of Antique hereby declares as its policy to institute the policy among local government units to ensure that all applicable laws granting additional benefits, emoluments and incentives

to government workers are included in their annual budgets.

**SECTION 3. OBJECTIVE** – This ordinance aims to grant benefits, emoluments and incentives to government workers in all Local Government Units of Antique based on prescribed guidelines, criteria and conditions set forth by applicable laws, decrees, orders and memorandum circulars issued and enacted by duly recognized government authorities.

**SECTION 4.DEFINITION OF TERMS** – For the purpose of this Ordinance, the following terms shall be construed or referred to as:

- a) Annual Budget/Executive Budget refers to a financial plan embodying the estimates of income and expenditures for one (1) fiscal year in conformity to Section 6 of this ordinance "Form and Content of Local Government Budget".
- b) Appropriation refers to an authorization made by ordinance, directing the payment of goods and services from local government funds under specified conditions or for specific purposes.
- c) Attendance Bonus a payment made to employees by their employer as part of their wage to reward satisfactory attendance at work.
- d) Collective Negotiation Agreement (CNA) is a contract negotiated between an accredited employees' organization as the negotiating unit and the employer/management on the terms and conditions of employment and its improvements that are not fixed by law.
- e) Department of Budget and Management is an executive body under the Office of the President of the Philippines and is responsible for the sound and efficient use of government resources for national development and also as an instrument for the meeting of national socio-economic and political development goals.
- f) Fund refers to a sum of money, or other assets convertible to cash, set aside for the purpose of carrying out specific activities or attaining certain objectives in accordance with special regulations, restrictions, or limitations, and constitutes an independent fiscal and accounting entity.
- g) Government-Owned or Controlled Corporation (GOCC) refers to any agency organized as a stock or nonstock corporation, vested with functions relating to public needs whether governmental or proprietary in nature, and owned by the Government of the Republic of the Philippines directly or through its instrumentalities.
- h) Gratuity Pay an incentive given voluntarily or beyond obligation usually for some services.
- Local Chief Executive (LCE) are the elected officers of the local government units (LGUs), they are as follows: Barangay Captain (Punong Barangay), Municipal Mayor, and the Provincial Governor.
- j) Local Finance Committee (LFC) the body composed of the Local Planning and Development Coordinator, Local Budget Officer, and the Local Treasurer.
- k) Mid-year Bonus is a boost in employees' salary equivalent to their full month's salary usually given not earlier than May 15.
- Performance Based Bonus (PBB) an incentive granted to the agency and individuals in government offices who reached its target criteria and conditions. The goal of the PBB is to strengthen the effectiveness of the incentives system to help agencies achieve the mission-critical objectives and expected outcomes of the government.
- m) Policy a course or principle adopted or proposed by a government, party, business or individual.
- n) Productivity Enhancement Incentive (PEI) is a variable payment, made as an incentive to increase productivity or reward employees for their contributions.
- o) Service Recognition Incentive (SRI) an incentive granted to the government personnel in recognition of their hardwork, commitment and dedication to public service.
- p) Year-End Bonus is a boost in employees' salary equivalent to their full month's salary usually given at the close of the year.

**SECTION 5. SCOPE OF COVERAGE** – This ordinance shall cover all the Local Government Units in the province of Antique.

**SECTION 6. BENEFITS, EMOLUMENTS AND INCENTIVES GUIDELINES AND APPLICABILITY** – All Local Government Units of the Province of Antique are enjoined to ensure that their Annual Budgets shall contain and include the computed benefits, intended for their local officials, as well as their regular and contractual employees. Subject to existing laws, orders, decrees and statutory guidelines, the grants shall include but not limited to the following:

**6.1 Year-End Bonus** - Pursuant to CPCS Implementing Circular No. 2016-01 (3<sup>rd</sup> Issue), Year-End Bonus which is equivalent to one (1) month basic pay as of October 31 shall be given to the qualified employee not earlier than November 15 of the current year.

It shall be granted to each employee who has rendered at least a total or an aggregate of four (4) months of service, whether continuous or intermittent, including leaves of absence with pay, from January 01 to October 31 of the current year.

Those employees who have rendered at least a total or an aggregate of four (4) months of service from January 01 of the current year but who have retired or separated from government service before October 31 of the same year shall be granted within the month of retirement or separation, a pro-rated share of the Year-End Bonus based on the monthly basic pay immediately preceding the date of retirement or separation, as follows:



Length of Service	Percentage of the Year-End Bonus
4 months but less than 5 months	50%
5 months but less than 6 months	60%
6 months but less than 7 months	70%
7 months but less than 8 months	80%
8 months but less than 9 months	90%
9 months but less than 10 months	95%

6.2 Mid-year Bonus - also known as 14th month pay is equivalent to one (1) month basic pay as of May 15 shall be given to entitled personnel not earlier than May 15 of the current year. This incentive was among the additional grants authorized through the Executive Order No. 201 s. of 2016 (Section 4) and to the Standard Allowances and Benefits under the Total Compensation Framework embodied in the Congress Joint Resolution No. 4 (s. 2009).

Pursuant to DBM Budget Circular No. 2017-2 dated May 8, 2017, the grant of the Mid-Year Bonus to personnel of provinces, municipalities and barangays shall be charged against their respective local budget as determined by their respective Sanggunian, subject to the following conditions:

- Personnel has rendered at least a total or an aggregate of four (4) months of service from July of the immediately preceding year to May 15 of the current year;
- Personnel remains to be in the government service as of May 15 of the current year;
- Personnel has obtained at least a satisfactory performance rating in c) the immediately preceding rating period, or the applicable performance appraisal period.
- Those who have rendered a total or an aggregate of less than four (4) months of service from July 1 of the preceding year to May 15 of the current year, and those who are no longer in the service as of the latter date, shall not be entitled to the Mid-Year Bonus.
- The Mid Year Bonus of personnel hired on part-time service in one or more agencies shall be in direct proportion to the number of hours/days of parttime services rendered.
- The Mid Year Bonus of those on detail to another government agency shall be paid by the parent agency, while those on secondment shall be paid by the recipient agency.
- The Mid Year Bonus of personnel who transferred from one agency to another shall be paid by the new agency.
- A compulsory retiree, whose services have been extended, may be granted Mid-Year Bonus, subject to the pertinent provisions of the current circular.
- Those who are formally charged administrative and/or criminal cases which are still pending for resolution, shall be entitled to Mid-Year Bonus until found guilty by final and executory judgment. Provided, that:
  - 1. Those found guilty shall not be entitled to Mid-Year Bonus in the year of finality of the decision. The personnel shall refund the Mid-Year Bonus received for that year.
  - If the penalty imposed is only a reprimand, the personnel concerned shall be entitled to the Mid-Year Bonus.
- If funds are insufficient, the Mid-Year Bonus may be granted at lower rates but at a uniform percentage of the monthly basic pay as of May 15 of the current year.
- 6.3 Productivity Enhancement Incentive (PEI) This incentive was also among the additional grants authorized through the Executive Order No. 201 s. of 2016 (Section 4) and to the Standard Allowances and Benefits under the Total Compensation Framework embodied in the Congress Joint Resolution No. 4 (s. 2009).

Stipulated in the Budget Circular No. 2017-4 dated December 4, 2017, the following guidelines are enumerated herein:

- The Productivity Enhancement Incentive of Php 5,000 shall be 6.3.1 given to personnel not earlier than December 15 of the current year, subject to the following conditions:
  - The employees are still in the service as of November 30 of the current year; and
  - The employees have rendered at least a total or an aggregate of four (4) months at least satisfactory service as of November 30 of the current year, including leaves of absence with pay.
- 6.3.2 Those who have rendered less than the total aggregate of four (4) months of service but still in the service as of November 30 of the current year shall be entitled to pro-rated PEI, as follows:

Length of Service	Percentage of the PEI
3 months to less than 4 months	50%
2 months to less than 3 months	40%

6.3.3 The granting of PEI at rates not exceeding Php 5,000 as determined by the Sanggunian shall be subject to the following considerations:

- The conditions under 6.3.1 hereof of the entitlement of personnel to the PEI shall be strictly observed.
- The Personnel Services (PS) limitation in LGU budgets under Sections 325 and 331 of R.A. No. 7160 shall be complied with.
- If funds are sufficient, the PEI may be granted at lower but uniform rate for all employees of an LGU.
- **6.4 Service Recognition Incentive (SRI)** a one-time grant to acknowledge all public servants for their collective and unceasing participation in and invaluable contribution to the establishment of streamlined government processes and responsive delivery of services to the public thru the Administrative Order No. 45 dated December 24, 2021.
- 6.4.1 In accordance to DBM Budget Circular No. 2021-4 dated December 28, 2021, the distribution shall be in adherence to the following conditions and guidelines on the Grant of SRI:
  - a) The civilian personnel are occupying regular, contractual or casual positions.
  - The personnel are still in the service as of November 30 of the current year.
  - The personnel have rendered at least a total or an aggregate of four (4) months of satisfactory service as of November 30 of the current year, inclusive of services rendered under any of the alternative work arrangements prescribed by the Civil Service Commission.
  - Those who have rendered less than a total or an aggregate of four (4) months of service as of November 30, shall be entitled to a pro-rated share of the SRI, as follows:

Length of Service	Percentage of the PEI
3 months to less than 4 months	50%
2 months to less than 3 months	40%
1 month to less than 2 months	30%
Less than 1 month	20%

- **6.4.2** The grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunian depending on the LGU's financial capability, at a uniform rate not exceeding Ten Thousand Pesos (PhP10,000) each, subject to the following conditions:
  - The SRI shall be charged against their respective local government funds, subject to the PS limitation in LGU budgets pursuant to Section 325 (a) and 331 (b) of R.A. No. 7160.
  - In determining the amount of the SRI, the sanggunian shall exercise prudence and judicious use of government funds, ensuring that the expenditure is reasonable and will not, in any way, adversely affect the delivery of services to the public.

The payment of the SRI to all qualified government employees shall not be earlier than December 21 of the current year.

6.5 Collective Negotiation Incentive (CNA) - The grant of CNA incentive to employees in government agencies was authorized thru the Administrative Order No. 135 dated December 27, 2005. This may be granted to both management and rank-and-file employees of agencies with approved and successfully implemented CNAs in recognition of their efforts in accomplishing performance targets at least cost in containing more efficient and viable operations through cost-cutting measures and systems improvement.

Every Local Government Units shall accomplish, as of September 30 of the current year, at least an average of 70% of all the targets under their programs/activities/ projects approved in the LGU budget for its respective fiscal year. The CNA Incentive for the year shall be a one-time benefit to be granted not earlier than December 15.

Pursuant to Section 73 of the General Provisions of the General Appropriations Act of FY 2021 and the DBM Budget Circular No. 2021-3 dated November 17, 2021 provided the guidelines on the grant of CNA incentives, to wit:

#### 6.5.1 Rules on the Grant of CNA Incentives

- There is a valid CNA executed between the agency and the recognized employee organization which includes a provision on cost-cutting measures to be undertaken collectively by the agency and its personnel;
- The one-time annual payment of CNA Incentive shall be made through a written resolution signed by agency representatives from both labor and management, and approved by the agency
- The CNA Incentive that may be granted shall be limited to the amount determined by the DBM; and
- The use of MOOE for the payment of CNA Incentive shall be subject to approval by the agency head and made only during the validity of appropriations. Any excess amounts therefrom after payment of the CNA Incentive shall revert to the General Fund.

#### Allowable Source of Funds for CNA Incentives

The CNA incentives are sourced solely from the following MOOE items after considering the fiscal year operating requirements:

- a) Communication Expenses;
- b) Repairs and Maintenance;
- c) Supplies and Materials Expenses;
- d) Transportation and Delivery Expenses;
- e) Traveling Expenses; and
- f) Utility Expenses.

The above sources of CNA incentives should have become available as a result of cost-cutting and systems improvement measures undertaken collectively by the agency and its personnel, as identified in their respective CNA and supplements thereof.

**6.6 Performance Based Bonus (PBB)** - Executive Order No. 80 dated July 20, 2012 adopts the Performance-Based Incentive System for government personnel to recognize and reward the exemplary performance of employees in public sector.

To be eligible for the grant of the Performance Based Bonus (PBB), each agency must satisfy the criteria and conditions under the four dimensions of accountability: Performance Results, Process Results, Financial Results, and Citizen/Client Satisfaction Results and attain a total score of at least 70 points pursuant to Memorandum Circular NO. 2021-1 dated June 3, 2021.

#### 6.6.1 PBB Targets, Assessment, And Scoring System

The agency accomplishments for each of the criteria shall be rated using a scale of 1 to 5 (where 5 is the highest).

#### 6.6.2 Eligibility of Delivery Units and Individuals

- a) The delivery units (DUs) of eligible agencies shall no longer be ranked. However, the unit/s most responsible for deficiencies shall be isolated. Eligible DUs shall be granted of PBB at uniform rates across the agency, including its officials and employees.
- b) The corresponding rates of the PBB shall be based on the agency's achieved total score.
- c) An official or employee who has rendered a minimum of nine (9) months of service during the fiscal year and with at least a Very Satisfactory rating may be eligible for the full grant of the PBB.
- d) An official or employee who rendered less than nine (9) months but a minimum of three (3) months of service and with at least a Very Satisfactory rating shall be eligible for the grant of the PBB on a pro-rata basis corresponding to the actual length of service rendered, as follows:

- e) Officials and employees who failed to submit the previous year SALN as prescribed in the rules provided under CSC Memorandum Circular No. 3 s. 2015; or those who are responsible for the non-compliance with the establishment and conduct of the review and compliance procedure of SALN, shall not be entitled to the PBB.
- f) Officials and employees who failed to liquidate all cash advances received in the current fiscal year within the reglementary period, as prescribed in COA Circular 97-002 dated February 10, 1997, and reiterated in COA Circular 2009-002 dated May 18, 2009, shall not be entitled of the PBB.

#### 6.6.3 Rates of the PBB

The total score as stated shall be the basis in determining the amount of the PBB an agency is eligible for. The maximum rate of the PBB for agencies that will achieve 100 points shall be 100% of the 65% monthly basic salary (MBS) of an individual as of December 31 of the current year.

**6.7 Gratuity Pay** - Section 1 of the Administrative Order No. 46 dated December 29, 2021, all workers whose services are engaged through Job Orders and Contract of Service employees who have rendered a total or an aggregate of at least four (4) months of satisfactory performance of services as stipulated in their respective contracts as of 15 December, and whose contracts are still effective of the same date, may be granted a one-time Gratuity Pay not exceeding Five Thousand Pesos (P5,000) each.

Local government units (LGUs) engage workers through COS and JO, utilizing appropriate and available funding sources from their respective local government funds in conformity to the Department of Budget and Management (DBM) issued supplemental guidelines for its effective implementation.

#### SECTION 7. ROLE OF THE SANGGUNIANS AND LOCAL FINANCE COMMITTEE

Within one hundred twenty (120) days of every fiscal year, all local Sanggunians shall deliberate and tackle the intent of this ordinance with their Local Finance Committee to ensure that the granting of benefits, emoluments and incentives intended for their local officials, as well as their regular and contractual employees are computed and included in their Annual Budgets.

**SECTION 8. BUDGETARY COMPONENTS** – All local government units through their Local Chief Executives, Sanggunians, Local Finance Committee and all offices and departments concerned shall ensure that all necessary benefits, incentives and emoluments contained in this ordinance with budgetary allocations shall be complied with. A substantial amount shall be incorporated in their budgets to effectively implement the mandate of this ordinance.

**SECTION 9. SUPPLEMENTARY CLAUSE** –The grant of incentives, emoluments and benefits for all concerned as stated herein, in the incoming years shall conform with the latest national laws, Presidential Executive Orders, Memorandum Circulars, Decrees and other statutes that may take effect after the passage of this ordinance.

**SECTION 10. PENALTY CLAUSE** – Criminal and administrative charges and penalties may be charged to the violators as provided under the Local Government Code and other applicable laws.

**SECTION 11. SEPARABILITY CLAUSE** – If any section or provision of this Ordinance shall be declared unconstitutional or invalid, the other remaining provisions shall not be affected thereby and shall remain in full force and effect.

**SECTION 12. REPEALING CLAUSE** – Allordinances, rules and regulations, or parts thereof, that are in conflict with or inconsistent to the provisions of this Ordinance, are hereby repealed or amended accordingly.

**SECTION 13. EFFECTIVITY** – This Ordinance shall take effect after the approval of the Governor. Copies of this ordinance shall be posted for a minimum period of three (3) consecutive weeks in conspicuous places owned by the Province, municipalities and barangays. The ordinance shall also be published in a newspaper of general circulation within the Province of Antique upon approval.

AN ORDINANCE CREATING ANTIQUE SPORTS COMMISSION AND REVISING FOR THIS PURPOSE RESOLUTION NO. 407-2002, OTHERWISE KNOWN AS "RESOLUTION ADOPTING AN ORDINANCE ESTABLISHING THE ANTIQUE SPORTS COUNCIL" AND PROVIDING FUNDS THEREOF

#### **EXPLANATORY NOTE**

**WHEREAS**, Article XIV, Section 19 (1) of the 1987 Constitution provides that "The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international development of a healthy and alert citizenry";

**WHEREAS**, Republic Act 7160 otherwise known as the Local Government Code of 1991 requires provincial level to conduct PalarongPanlalawigan which shall cater traditional sports and disciplines included in the Regional, National and International games in coordination with the Department of Education;

WHEREAS, Section 7 (m) of R.A. No. 6847 provides that the PSC shall encourage, promote, and sustain the creation and establishment of regional, provincial, municipal, and barangay or school district sports promotion and development councils composed of officials from the Department of Education, local government officials and representatives of the private sector that shall initiate, conduct and coordinate sports activities in their respective jurisdictions in order to ensure the implementation of the National Policy and Program of "SPORTS FOR ALL";

**WHEREAS**, EO No. – 64, series of 1993 centers on the national policy of "Sports for All" which shall make accessible to all Filipinos regardless of age, gender, talent, and capabilities a program of physical fitness and sports, and promote the desirable traditional and universal values in physical fitness and sports;

**WHEREAS**, EO No.44, signed by President Joseph Estrada in December 2, 1988, otherwise known as the Philippine Youth Games – BatangPinoy, serves as the National Sports competition program for children, and is envisioned to address the need for grassroots sports program centered on values formation inherent in the practice of sports and play;

**WHEREAS**, the role of professional coaches, trainers, and referees is indispensable to produce quality athletes who will bring pride and honor to the Province of Antique;

WHEREAS, in consideration of foregoing premises, we need to amend the Resolution No. 407-2002, "Resolution Adopting an Ordinance establishing the Antique Sports Council" thereby creating "Antique Sports Commission Ordinance" to revitalize the sports programs, projects, activities in Antique through grassroots approach with active support from the Local Government Unit, Philippine Sports Commission (PSC), Department of Education (DepEd) other non-government entities and individuals to produce world class athletes.

**WHEREFORE,** on motion made by SP Member PioJessielito C. SumandeSr, and duly seconded en masse, be it

**RESOLVED, as it is hereby RESOLVED**, in a Regular Session duly assembled by the SangguniangPanlalawigan of the Province of Antique, to approve:

#### **PROVINCIAL ORDINANCE NO. 2022-332**

AN ORDINANCE CREATING ANTIQUE SPORTS COMMISSION AND REVISING FOR THIS PURPOSE RESOLUTION NO. 407-2002, OTHERWISE KNOWN AS "RESOLUTION ADOPTING AN ORDINANCE ESTABLISHING THE ANTIQUE SPORTS COUNCIL" AND PROVIDING FUNDS THEREOF

SECTION 1. TITLE - This ordinance shall be known as the "ANTIQUE SPORTSCOMMISSION".

**SECTION 2. DECLARATION OF POLICY** - The Province of Antique declares as a policy that the sports shall community-based Sports program aims to bring the Culture of sports excellence for Poverty Reduction at the grassroots barangay level to promote self-discipline, physical fitness, healthy lifestyles and alert citizenry. The Province of Antique shall advocate sports as a venue of various sports events such as local, national and international to promote tourism industry. It is also the policy of Antique to implement the Long Term Athlete Development (LTAD) framework to observe the scientific-based approach to develop and provide a clear pathway based on sound principles of human growth and development.

#### **SECTION 3. DEFINITION OF TERMS**

- 1. ASC Antique Sports Commission
- 2. CSO Civil Society Organization
- 3. PSC Philippine Sports Commission
- 4. NSA National Sports Association
- 5. POC Philippine Olympic Committee
- 6. SEF Special Education Fund
- 7. LSA Local Sports Association
- 3. LTAD Long Team Athlete Development
- 9. ASDP Antique Sports Development Program
- 10. Athletes A person who is proficient in sports and other forms of physical activities
- 11. Trainees A person undergoing training for a particular job or profession
- 12. Coaches one who instructs players on the fundamentals of sports and directs team strategy.
- 13. Team event means an event in the games in which a team composing of five or more players competes in a game, race, heat or event can only win one medal.
- 14. Individual event means an event in the games in which an athlete competes either alone or in which up to a maximum of 4 athletes compete together in a game, race, heat or event (for example as a pair, doubles, or relay team).
- 15. Special Sports Category are non-Olympic sports but are recognized by the International Olympic Committee (IOC).
- 16. Regular Member means a member of the Commission that shall carry out the official functions and responsibilities of Commission and who is also a Voting Member.

**SECTION 4. THE ANTIQUE SPORTS DEVELOPMENT PROGRAM** – the Antique Sports Development Program is hereby established to carry out the declared policy and boost the potentials of Antique as producer of outstanding athletes in various fields of sports. The Antique Sports Development Program shall have the following components, to wit:

A. Long Term Athlete Development (LTAD) Framework

#### Introduction

Scientific research has shown that it takes at least 10 years, and approximately ten thousand (10,000) hours of training for talented athletes to achieve sporting excellence. There is no shortcut.

Athlete improve their performance as a result of two separate and distinct parameters, constantly interplaying over time. These factors are:

- 1. Training
- 2. Growth and development

Framework of Antique Sports Commissions is about achieving optimal training, competition and recovery throughout an athlete's career, particularly in relation to the important growth and development years of young people. If a long term approach to training is not adopted there is likely to be a plateau in performance, when growth and development slows significantly, which for some athletes may result in their performances getting worse. At this point the short term training approach cannot be reversed. This often leads to drop out before an athlete has achieved close to their potential.

#### Our Mission

To create the ideal environment for athlete training, competition structuring and coach education, and as such determines strategic directions for "Go Sports Antique" Program.

The Antique Sports Commission also sets up a system of accountability to ensure the sport is delivered with integrity by clarifying roles and areas of responsibility. The LTAD serves as Antique Sports Commission main tool for elite athlete talent development, as well as for athlete retention. One of the core aims of the framework is to ensure that the desire and talent of each and every athlete, at whatever level, is matched by the appropriate training and competition environment.

#### **Antique Sports Commission – Vision**

As an Antique Sports Commission in coordination with the LGU's and the Department of Education and Office of the Lone District of Antique, mandated by the Province of Antique to spearhead expansion of Sports and Education Development Program to:

- 1. Everybody has the opportunity to learn sports properly
- 2. Everyone that wants to, is ensured of a chance to achieve their own potential
- 3. Everyone has the opportunity to enjoy sports as part of a healthy lifestyle
- 4. We achieve Gold Medal Success in International Sports Competition

#### Rationale

There are five clear reasons for Antique Sports Commission Long Term Athletes Development (LTAD) framework:

- 1. To establish a clear athlete development pathway
- 2. To identify gaps in the current athlete development pathway
- 3. To realign and integrate the programs for developing athletes and sports in the
- 4. To provide a planning tool, based on scientific research, for coaches and administrators
- 5. To guide planning for optimal performance

It is anticipated that the principles of LTAD will also be used by Antique Sports Commission development partners like the Philippine Olympic Committee (POC), the Philippine Sports Commission (PSC), National Sport Associations (NSAs), Local Sports Associations (LSAs) and Funders to review sports initiatives led by Antique Sports Commission, and to inform any future initiatives. Under Antique Sports Commission intervention for Coaching and Talent Development, it is hoped that all sports providers nationwide will be trained to use LTAD in a similar way. This will enable the sports community to pull in one direction towards achieving Antique Sports Commission goals and targets. What must be kept in mind is that Antique Sports Commission LTAD Framework is a flexible process ad not a products in itself. It should be used as a planning and evaluation tool to enable authorities at every level to audit existing programs and activities based on:

- 1. ATHLETE DEVELOPMENT
- 2. INSTRUCTOR/COACH DEVELOPMENT
- 3. ANTIQUE SPORTS COMMISSION MANAGEMENT AND ADMINISTRATION

Together with the launch of specific National Sports Association (NSA) Ranking System using their International Point System (IPS), the LTAD Framework will help identify our programs strength and weaknesses to guide us in preparing specific action to build on strengths and address weaknesses. Most importantly, however it will give Antique Sports Commission the means to achieve and implement a high level of accreditation standards for clubs, coaches and athletes in particular. Accreditation is the public recognition by Antique Sports Commission that a Local Sports Association, club or team has a program that is effective and athlete-centered.

- 1. The "critical period" of accelerated adaptation are not fully taken advantage of
- 2. Poor training between 6-16 years of age cannot be fully corrected (athletes will never reach genetic potential)
- 3. The best coaches are encouraged to work at elite level
- 4. Coach education tends to skim the growth, development and maturation of young people
- 5. Coaches, Athletes and Parents lack education in LTAD principles and its framework
- $\hbox{6. Administrators and officials need to be educated in LTAD principles}\\$

Basically, we have too many sports clubs in the Philippines offering too little training time and in most instances, too much competition. This leaves many athletes in a "twilight zone" of training less than 14 hours a week, hoping for success in international competition, and expecting overseas tours and training for their national level success.

For an athlete training 8 hours a week, the benefits are social, fun participation, team building and for health benefits. For those athletes wishing for an international career and who are serious about optimum performance at the national level then training in a program with high performance objectives, 18-25 hours of training is approximately what is will take to achieve their goals.

However, in most countries and in most clubs locally, the vast majority of athletes train between 8 and 14 hours per week. This is the "twilight zone" – too much volume to be fun and achieve the social and happy benefits of the participation level (8 hours and under), and not enough to achieve the competitive results for optimum performance that an athlete expects. In other words, it is too much training for participation in the sport, and too little to be considered really serious in terms of the competitive nature of our sport.

Removing this "twilight zone" should be the major focus of every sport club in the Philippines, and of course, will be the requirement for the national sport training program.

The Long Term Athletes Development (LTAD) framework is a sport development protocol that is based on human growth and development. In short, it is about adopting an athlete-centered approach to elite athlete development.

- 1. Sport Fundamentals-basic movement literacy
- 2. Sports Skills- building technique
- 3. Training to Train- building the sport engine
- 4. Training to Compete optimizing the sport engine
- Training to Win- maximizing the sports engine.

Stage 1: Sport Fundamentals

Female: 5 to 8 years of age Male: 6 to 9 years of age

The Sport Fundamentals stage should be structured and fun for children with, major emphasis is on developing basic movement literacy and movement skills.

The skills to be developed are:

- 1. The ABC'S Agility, Balance, Coordination, and Speed
- $2. \quad \mathsf{RJT}-\mathsf{Running}, \, \mathsf{Jumping}, \, \mathsf{Throwing}$
- 3. KGB'S Kinesthetic, Gliding, Buoyancy, Striking with the body (Water Evolution)
- 4. CK'S Catching, Kicking, Striking with an implement

In order to develop basic movement literacy successfully participation in as many sports as possible should be encouraged. Speed, power and endurance should be developed using fun and games. In addition, children should be introduced to the simple rules and ethics of sports. No periodization of training should take place at this age, instead there should be well-structured teaching programs with proper progressions that are monitored regularly.

Stage 2: Sports Skills - building technique

Female: 8 to 11 years of age Male: 9 to 12 years of age

During this stage young athlete should learn how to train and develop the skills gained as their main sport. There may be participation in complementary sports (i.e. those sports, which use similar energy systems and movement patterns). Athletes should also be taught the basic technical / tactical skills, and ancillary capacities, including:

- 1. Warm up and cool down
- 2. Stretching
- 3. Hydration and nutrition
- 4. Recovery
- 5. Relaxation and focusing.

This stage coincide with peak motor coordination development; therefore there should be an emphasis on skill development training. Workout sessions should also include the use of "own body weight" exercise like using medicine balls and Swiss ball exercises, while developing flexibility and suppleness.

Stage 3: Training to Train building the sports engine

Female: 11 to 14 years of age Male: 12 to 15 years of age

During the Training to Train stage, there should be emphasis on aerobic conditioning. This is the stage where there is greater individualization of fitness and technical training. The focus should still be on training rather than competition and the training should be predominantly of high volume, low intensity workloads. It is important to emphasize that high volume, low intensity training cannot be achieved in a limited time period, and therefore the athletes' time commitment to train should increase significantly.

Stage 4: Training to Compete - Optimizing the sport engine

Female: 14 to 16 years of age Male: 15 to 18 years of age

During the Training to Compete stage, there should be a continued emphasis on physical conditioning to focus on maintaining high volume workloads but with increasing intensity. The number of competitions should be similar to the end of the previous stage but the emphasis should be developing individual strengths and weaknesses through modeling and nurturing technical and tactical skills based around specific strokes or distances, but not both.

As a result, there should be either double or triple periodization of the training year. In addition, the ancillary capacities should be refined so they are more specific to the individual's needs. During this stage, training should also focus on developing maximum strength gain through the use of sport specific resistance training. This should be coupled with continued work on core body strength and maintaining suppleness.

Stage 5: Training to Win – Maximizing the sport engine

Female: 16 and above years of age Male: 18 and above years of age

This is the final stage of athletic preparation. The emphasis should be on specialization and performance enhancement. All of the athletes' physical, technical, tactical, mental and ancillary capacities should now be fully established with the focus shifting to the optimization of performance. Athletes should be trained to peak for specific competitions and major events. Therefore, all aspects of training should be individualized for specific events. There should be either double, triple or multiple periodization of training, depending on the competitions and events being trained for. During this stage, training should continue to develop sport specific strength, develop core body strength and maintain flexibility and suppleness.

**SECTION 5. CREATION OF THE PROVINCE OF ANTIQUE SPORTSCOMMISSION –** There is hereby created the Province of Antique Sports Commission under the Office of the Governor.

**SECTION 6. COMPOSITION OF THE ANTIQUE SPORTS COMMISSION** – The Antique Sports Commission shall be composed of the following members with three (3) representatives from Civil Society Organizations accredited by the SangguniangPanlalawigan of the Province of Antique and one (1) local sports association/organization in the private sector that have advocacy on sports development.

- 1. Office of the Governor/Duly Authorized Representative
- 2. Congressman, Province of Antique/Duly Authorized District Staff
- 3. SP Chairperson, Committee on Youth and Sports Commission
- . SP Chairperson, Committee on Education
- 5. SP Chairperson, Committee on Good Government
- 6. SP Chairperson, Committee on Oversight
- 7. President, Liga ng mga Barangay
- 8. President, League of Municipalities in the Philippines-Antique Chapter
- 9. Authorized Representative from Department of Education, Antique Division
- 10. Head of Antique Sports Office
- 11. President, Antique Chambers of Commerce
  - B. Honorary Members there shall be honorary members with advocacies on sports programs, with speaking rights but shall not have voting rights.

SECTION 7. TERM OF OFFICE – Each member shall hold a fixed term of three (3) years.

**SECTION 8. MEETINGS** – The Commission shall meet at least once a month or as often as the Chairperson desires to convene the same, serving notice to its members at least one (1) day before the scheduled meeting.

#### SECTION 9. POWERS, FUNCTIONS, DUTIES AND RESPONSIBILITIES OF THE COMISSION –

The Antique Sports Commission shall primarily be responsible for the formulation and development of sports programs and other related activities of the province. For the attainment of said purpose the Commission shall be in charge of the following functions and powers:

- 1. Subject to the approval of the SangguniangPanlalawigan, formulate and adopt the Comprehensive Sports Development Program of the Province of Antique starting from the grassroots level to develop potential athletes for national and international competitions.
- 2. Assist in sports festivals, league competitions, DepEd sports activities, BatangPinoy and other sports activities and coordinates with the Department of Education and the Colleges of the Province to integrate their entire sports program and directed to achieve the vision of developing career and national athletes.
- 3. Maintain, administer and supervise the management of existing sports facilities of the Provincial Government located at Binirayan Sports Complex.
- 4. Provide incentives to athletes, coaches, trainers, consultants, referees, and other persons or entities involve in supporting the sports development program.
- 5. Regulate all sports tournament conducted within Antique not sponsored by the Municipality, DepEd or the Philippine Sports Commission.
- 6. Formulate rules and regulations regarding the accreditations of sports associations.
- 7. To address one of the most pressing problems of depression due to pandemic restrictions that usually result to suicides as World Health Organization (WHO) admits killing about 800,000 annually.

**SECTION 10. SCHOOL SPORTS POGRAM** – The Antique Schools Division Office, in consultation and cooperation with Antique Sports Commission, shall formulate a yearly sports program for all public and private schools in the primary and secondary levels for the following purposes;

- a. Instill sports awareness among the learners and students.
- b. Foster the value of self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry.
- c. Ensure a ready supply of competitive athletes that will represent the province during provincial, regional, and national competitions.
- d. Enhance sports facilities and equipment of the schools.

The Antique Sports Commission shall partner with the Department of Education, Schools Division of Antique (DepEd) Special Program for Sports (SPS) in supporting its sports programs and activities and facilitate the establishment of SPS in other schools all throughout the Province by providing financial assistance, sports equipment, and free use of the sports facilities.

The free use of sports facilities shall include delegates representing the province of Antique in national and international competition.

**SECTION 11. INCENTIVES FOR COACHES, TRAINERS, AND REFEREES –** The Commission shall provide incentives to local coaches, trainers, and referees from the Antique.

**SECTION 12. BENEFITS AND INCENTIVES FOR ATHLETES –** There shall be allowance for athletes that will participate in sports activities depending on the level of competition. For school based competition, the incentives and benefits to be given shall be subject for the approval of the school board. As for other school activities, there shall be a recommendation from the Commission for the approval of the Local Chief Executive.

Sponsorship and/or donations from outside sources shall be deposited on a trust fund specifically for the purpose of funding the implementation of the sports program and/or upon the request of the donor/sponsor.

**SECTION 14. HALL OF FAME FOR ANTIQUE SPORTS –** The Provincial Government shall establish a Hall of Fame for Antique Sports to give prestige for athletes and/or coaches, both in the past and in the generations to come and bring glory to the Province of Antique in regional, national, and international competitions.

**SECTION 15. REPEALING CLAUSE –** All Ordinances, Executive Orders, and all other local rules and regulations inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

**SECTION 16. SEPARABILITY CLAUSE –** Should any part or provision of this Ordinance be declared invalid or unconstitutional, any part or provision not affected thereby shall continue to be in full force and effect.

**SECTION 17. EFFECTIVITY –** This Ordinance shall take effect immediately following compliance with the publication requirements under the Local Government Code of 1991.

## ORDINANCE CREATING THE PROVINCIAL HOUSING AFFAIRS AND RESETTLEMENT OFFICE (PHARO) REPLACING THE PROVINCIAL HOUSING UNIT (PHU) UNDER THE OFFICE OF THE GOVERNOR

#### **EXPLANATORY NOTE**

WHEREAS, shelter provision is one of the major functions of the Government. The 1987 Philippine Constitution under Social Justice and Human Right Provision, states that the Government shall make available at affordable cost, decent housing, and basic services to underprivileged and homeless in urban center and resettlement areas.

**WHEREAS**, likewise, Section 17 of Republic Act 7160 otherwise known as, the Local Government Code of 1991, mandates the cities and provinces to implement programs and projects for low-cost housing and mass dwelling for its people. These expressed responsibilities have been further enhanced under R.A. 7279 or the Urban and Housing Development Act of 1992, (UDHA) which devolved to LGUs, the task of implementing socialized housing programs and handling humane eviction policies.

WHEREAS, in light of these guiding laws and policies, the Province of Antique was among of the few Provinces which heeded these directives on local housing initiatives. The Province has vast mountainous terrains, long coastal waters, and significant numbers of river systems but its diverse landscape cannot evade the onslaught of floods, landslides, and other natural calamities because the geographic location of the Province is within the typhoon path or corridors of the country. Furthermore, based on the 2008 study by the Mines and Geosciences Bureau (MGB), the Province of Antique is prone to flooding or flash floods which provides an indicative estimate that 17% of the population and 19.86% or 19, 842 hectares are affected to flood hazards. The disaster that occurred in the province affected 26,199 families or 115,413 persons of which 41 people died, 33 were injured and 60 were missing was caused by a tropical typhoon Frank last June 21, 2008, caused massive flooding.

WHEREAS, this made the provincial leaders mindful of the devastations brought by typhoons which left many people homeless and affected. In response, some measures have been adopted to cushion its impact not only by strengthening disaster preparedness but also how to deal with the long-term approach to other relevant issues like inadequacy of decent housing units, the proliferation of informal settlers, lack of relocation sites, environmental pollution caused by squatting colonies and in extreme cases, involuntary eviction when government projects need clearing work to pave way for another project/s.

**WHEREAS**, to specifically address the above concerns, the Provincial Housing Board (PHB) was created through an Ordinance which is a policy-making body geared to cater to programs related to housing. Likewise, Provincial Ordinance No. 2021- 250, which amended the older version, has further strengthened and expanded its powers and among them is to

recommend the creation of a housing office that will serve as the implementing arm of the PHB. While there is an existing Provincial Housing Unit (PHU) that implements various programs pursuant to E.O. No.123, Series of 2017, such however is not enough because the current setup is just a small unit, has an inadequate workforce with no regular personnel, has limited facilities and no separate budget which hinders to effectively manage its priorities and chart its direction.

WHEREAS, finally, under Executive Order No. 138 Series of 2021 issued by the National Government in compliance with the "Mandanas Ruling" which compels LGUs nationwide to fully implement the devolved functions, mass dwelling, and low-cost housing are among those included. In adherence thereof and to prepare for the enormous tasks ahead as mandated/incorporated on transition plans, there is a pressing need or urgency that a regular Housing Office attached to the Office of the Governor shall be created.

WHEREFORE, on motion made by SP Member Egidio P. Elio, and duly seconded by SP Members Molina, Alamis, Azucena, Canjaand Niquia, be it

#### **PROVINCIAL ORDINANCE NO. 2022-329**

## ORDINANCE CREATING THE PROVINCIAL HOUSING AFFAIRS AND RESETTLEMENT OFFICE (PHARO) REPLACING THE PROVINCIAL HOUSING UNIT (PHU) UNDER THE OFFICE OF THE GOVERNOR

**Section 1. Title of the Ordinance**. The Ordinance shall be known and cited as "Provincial Housing Affairs and Resettlement Office (PHARO) of the Province of Antique."

**Section 2. Declaration of Policy.** It is hereby the policy of the Province to uplift the conditions of the underprivileged and homeless Antiqueños and in resettlement areas by ensuring their access to an adequate, safe, secure, habitable, sustainable, resilient, and affordable home. For this purpose, the following goals shall be observed:

- To promote and help improve the quality of life of the underprivileged, the homeless, the displaced, and the low-income families by promoting home ownership through affordable, decent, and long-term housing programs;
- To take charge of the implementation of the province-initiated housing projects in coordination with appropriate agencies, funding institutions, and concerned Local Government Units;
- To facilitate the rational use and development of the rural and urban lands for housing development;
- 4. To encourage more effective people's participation in urban and countryside development; and;
- 5. To implement measures that will ensure compliance with pertinent laws, national policies, local ordinances, and order/s concerning resettlement and local housing programs in the Province.

**Section 3. Operating Principles.** The formulation and implementation of policies, rules, regulations, and directives of the Provincial Housing Affairs and Resettlement Office (PHARO) shall be guided by, and circumscribed by the Vision and Mission of the Province of Antique, which read:

VISION: "ANTIQUE Province, star of Western Visayas: Home of Globally - competitive healthy Antiqueños living in well balanced environment with a vibrant, sustainable, and inclusive economy, proud of their culture and heritage and guided by transformational and God-centered governance.

MISSION: To enable the Antiqueños to become healthy and competent in sustainably improving their lives in ecologically balanced, economically balanced, and sustainably peaceful communities.

**Section 4. Office Mandate.** To serve as the implementing arm of the Province in the promotion, advocacy, and production of decent shelter and the resettlement of the province's informal shelters, particularly the underprivileged, homeless, displaced, and landless families, as well as those in the formal sector, in the spirit of social justice, upliftment of human dignity. And environmental protection in pursuit of national development.

**Section 5. Objectives.** The Provincial Housing Affairs and Resettlement Office (PHARO) shall have the following objectives:

It should measures to enable Local Government Units (LGUs) to guide and implement its specific mandates based on UDHA and to facilitate linkage with the Comprehensive Land Use Plan;

**PHB** – refers to the Provincial Housing Board created through Provincial Ordinance No. 2021 – 250 which is tasked to formulate the housing policy, act as the Recommendatory and Advisory Body on all housing programs in the harmony of various development plans and programs;

**Socialized Housing** - refers to housing programs and projects covering house and lots and house lots only undertaken by national and local government or the private sector for the underprivileged and the homeless citizens which shall include sites and service development, long term financing, liberalized terms on interest payments and such other benefits in accordance with UDHA;

ILOILO CITY – The Sangguniang Panlungsod (City Council) is working on an ordinance for the mandatory coordination by national government agencies, offices, and government corporations with the Iloilo City government for the planning and implementation of projects.

During the council's regular session on Wednesday, Councilor Rex Marcus Sarabia expressed hope that the ordinance, once passed, would reduce "ghost projects."

"This is intended to also curb corruption and properly implement projects in Iloilo City," he said.

Sarabia said he knew the ordinance was going to be controversial and expected it to be challenged before the courts because there are adverse parties that might be affected.

"I recognized the bold stance of this legislative measure. But in view of the developing circumstances of our city and discoveries of our quadcom hearings, we are compelled to make a decisive step to secure our local economy, and secure the interest of the Ilonggos,' he said.

In the same session, Sarabia also authored a proposed ordinance enabling the summary demolition of structures considered as public nuisance that unlawfully obstruct the flow of water along rivers, creeks, and waterways.

He said their quadcom hearing showed several illegal structures, mostly private, impeding the flow of water.

"The national law, including the Civil Code and the Water Code, recognizes that summary demolitions are allowed in view of public nuisance, and also that the flow of water and the drainage of the same are imbued with public interests. So, I believe we have the proper national law that provides our legal basis for this particular ordinance," Sarabia said.

The proposed ordinance on mandatory coordination was referred to the Committee on Rules, and the other one to the quad committee for their appropriate action.

The city council last month formed a quad committee composed of the Committees on Public Services, Environmental Protection and Ecology, Engineering and Public Works, Disaster Relief, and Public Safety to investigate, in aid of legislation, public and private infrastructure projects that may cause flooding in the city.

During the series of hearings, the Iloilo City District Engineering Office (ICDEO) of the Department of Public Works and Highways failed to attend as it awaits advice from its central office.

The ICDEO officer in charge, engineer Roy Pacanan, submitted his courtesy resignation on Sept. 1 in response to the directive of newly appointed Public Works Secretary Vince Dizon. (PNA)
