

Iloilo Mayor Raisa Treñas unveils 42 bold initiatives in her first 100 Days

ILOILO CITY'S first elected lady mayor delivers inspiring State of the City Address highlighting compassion, integrity, and inclusive progress

"Malayo pa, pero malayo na."

With these words, Mayor Raisa S. Treñas captured the spirit of her first 100 days as Iloilo City's first elected woman mayor, a time marked by concrete achievements, compassionate leadership, and a renewed sense of unity among Ilonggos.

Delivering her State of the City Address (SOCA) before the Sangguniang Panlungsod, barangay officials, private sector partners, and community leaders, Mayor Treñas reflected on her administration's journey to "Rise to Action", a people-centered governance framework that puts every Ilonggo family at the heart of public service.

"Public service is both a privilege and a responsibility. It is a great honor to be with you on this journey," she said.

Mayor Treñas vowed to sustain and expand the legacy of past leaders who helped shape Iloilo's progress, including former Mayor Jerry Treñas and former Senator Franklin Drilon and to continue what she called the "next chapter of the Iloilo Miracle."

Within her first 100 days, the Treñas administration launched 42 programs and initiatives under the Rise-to-

Provincial gov't pushes forest province lloilo through stakeholders summit

In line with the 25th anniversary of Piyesta sa Kakahuyan, the Iloilo Provincial Government conducted a Stakeholders Summit Towards a **Forest Province at Grand Xing Imperial Hotel** on October 6, 2025.

The event—with the goal of making Iloilo province a "Forest Province" by 2044—was joined by environmental advocates, local chief executives, civic organizations, and private sectors.

This summit also consisted of exchange of ideas and forged partnerships to strengthen tree-growing activity and forest development initiatives in the province under the Tanum Iloilo for MoRProGRes that was mandated by Governor Arthur Defensor Jr. through the Executive Order No. 195 Series of 2024.

In his speech, Governor Defensor highlighted the "Forest Province" vision, a long-term goal to make Iloilo's ecosystem climate-resilient and ensure sustainable food production. The provincial government also plans to boost tree-planting efforts with fruit-bearing trees and valuable crops to achieve this vision.

Based on the data of the Department of Environment and Natural Resources (DENR) Region VI, Iloilo province has a total of 471,940 hectares of forest cover, which includes 357,857 hectares designated as forestland and an additional 114,083 hectares classified as alienable and disposable (A&D) land.

The provincial government will also utilize a MoRProGRes Forest Map in the inventory of forestland and watershed areas that need reforestation.

Meanwhile, the stakeholders also showed their support towards Tanum Iloilo for MoRProGRes and their contribution to a sustainable ecosystem.

Action Framework, built upon three pillars:

- * RisingHealthandSocialServices
- * RisingEconomy
- * RisingLivability

Each pillar embodies the administration's A.C.T.I.O.N. priorities which are Access to education and social services, Comprehensive health and wellness, Trabaho at negosyo, Immersive tourism and culture, Orderly and safe communities, and Nature-based sustainability.

RISING HEALTH AND SOCIAL SERVICES

Under Rising Health and Social Services, the City strengthened its commitment to health, welfare, and inclusive education:

- * E-Health Tawag and RISEMed make medical consultations and free medicines accessible in communities.
- * Uswag Nutrition Center launched the RAIS-Sustansya foodmix, targeting malnourished children, producing 1,282 sachets daily.
- * La Paz Maternity Clinic was upgraded into a Primary Health Care Center, offering not only holistic maternal and women's health services but also services for everyone.
- * RISEable, Iloilo City's first SPED and Early Intervention Center, now provides free therapy and educational support for children with special needs.
- * Over 3,000 Ilonggos have benefited from the Uswag Atipan Center, a one-stop social assistance hub at City

"From womb to tomb, we provide services that make every Ilonggo family stronger and more productive," Mayor Treñas declared.

RISING ECONOMY

The Mayor highlighted the city's 7.1% economic growth in 2024, making it the fastest-growing economy in Western Visayas, based on the latest data from PSA Iloilo. The city's Gross Domestic Product (GDP) also rose from P160 billion in 2023 to P171 billion in 2024, making Iloilo City the second-largest contributor to the regional economy.

- * The city achieved a 96% employment rate, lowering unemployment to 4.1%.
 - * The Public Employment Service Office (PESO)

facilitated over 128,000 job solicitations, with a 92.6% placement rate.

- * The TLC (Tindahan Livelihood Carts ni Inday) and SIGE Asenso Program supported small entrepreneurs and market vendors.
- * RISE MERKADO modernized public markets and promoted clean, efficient trading spaces.
- "We understand how opportunity can change lives. Every job we create, every livelihood we support, builds a stronger, more empowered community," she said.

RISING LIVABILITY

Mayor Treñas also emphasized her administration's focus on livability, housing, and sustainability:

- * Through PASIlong: Pabahay sa Pamilyang Ilonggo, over 2,000 housing units are in the pipeline, with an additional 30,000 sqm of land acquired for future projects.
- * Environmental programs like EcoCycle, RISEtoGreens, and SunRISE strengthen climate resilience and
- * The City continues to maintain low crime rates, with over 287 drug personalities arrested and P56.5 million worth of shabu seized from July to October 2025.

"To improve our transport system and resolve the traffic problem, we already have the Metro Iloilo Integrated Public Transport System Study funded by the Swedish Government. Our goal is to move people, not just vehicles," Mayor Treñas said.

In behalf of Ilonggos, she also expressed gratitude to the Swedish Government for the partnership not only in advancing the public transport system in Iloilo City, but also in pursuing other shared priorities for the city's economic development, including tourism promotion and citizen engagement.

She also acknowledged the increasing challenges brought by climate change and flooding.

We truly feel the impact of climate change and the hardships brought about by flooding. That is why we warmly welcome the directive of President Bongbong Marcos that there should be coordination with local government units to ensure that projects are effective," she emphasized.

Mayor Treñas assured the public that, "The Iloilo City Government assures all residents that we will focus on all flood control projects and related concerns. We will continue to work with the national government and agencies to protect our city and the lives of Ilonggos against the effects of flooding."

A CITY OF AWARDS AND RECOGNITIONS

In her first 100 days, Treñas highlighted Iloilo City's continued success as a multi-awarded city in governance, innovation, health, culture, and sustainability.

The city was named Best LGU by the PSA Iloilo, while the City Health Office earned recognition under the Harmonized Health Excellence Awards. Iloilo was also among the Top 5 Most Business-Friendly LGUs (PCCI) and StartUp Champion for Western Visayas (DOST VI).

The Iloilo Dinagyang Festival 2024 won Best Cultural Festival at the 2025 Pearl ATOP Awards, and the city gained international recognition as a Most Promising City for Public Transport and Bicycle-Friendly City at the Southeast Asia Mobility Awards.

It also ranked number 1 among Highly Urbanized Cities the 124th Police Service Anniversary, was named Hall of Famer and 2024 Regional Grand Winner for Best PESO by DOLE, and received the PRIME HRM Bronze Award from the CSC Region VI.

Despite challenges brought by four typhoons and flooding, the Mayor reaffirmed her stand for transparency, accountability, and good governance.

"Just like our fight against floods and storms, we must fight poverty and corruption together. If there are failed and delayed projects, someone must be held accountable. We should not be negligent; this is not the Ilonggo way," she stressed.

As part of the Mayors for Good Governance (M4GG) Observer Status, Mayor Treñas pledged to uphold transparency and open-door governance.

Closing her address, Mayor Treñas recalled her father's final message before stepping down as mayor:

"Before my father stepped down as mayor, he said: 'I leave behind a city ready for greater dreams and achievements.' Now, let us fulfill this together."

She reaffirmed her commitment to the city's long-term vision of a Creative, Smart, and Sustainable Iloilo, promoting partnerships with the academe and private sector, and pursuing innovation through initiatives like the Bamboo Industry Roadmap, which aims to make Iloilo the Bamboo Powerhouse of Southeast Asia by 2030.

Guimaras' economy grows by 3.9 percent in 2024

The economy of Guimaras recorded a 3.9 percent growth in 2024, slower than the 8.2 percent growth posted in the previous year. The Gross Domestic Product (GDP) of Guimaras was estimated at Php 18.15 billion in 2024.

In terms of the contribution to the 3.9 percent GDP growth of the province by major industries, Services contributed 3.4 percentage points. Industry followed with 0.5 percentage point contribution. Meanwhile, Agriculture, forestry, and fishing pulled down the growth by 0.02 percentage point.

Among the industries, the fastest growth was observed in Human health and social work activities with 14.9 percent. This was followed followed by Professional and business services and Financial and insurance activities with 13.5 percent growth and 11.4 percent growth, respectively. On the other hand, Agriculture, forestry, and fishing posted a decline of 0.1 percent. (PSA Guimaras)

SEAFDEC shortens milkfish farming period to 85 days

THE Southeast Asian Fisheries Development Center Aquaculture Department (SEAFDEC/AQD) has successfully harvested two tons of market-sized milkfish (bangus) in just 85 days—nearly halving the traditional culture period.

The breakthrough took place at SEAFDEC/AQD's DumangasBrackishwater Station (DBS) in Iloilo, where researchers used a combination of probiotics and high-protein feeds during the first 30 days of culture to accelerate growth and improve overall fish health.

"The average initial weight of fingerlings was 37 grams, and they grew to 350–400 grams in just 85 days," said DBS Station Head Edgar Somblingo.

The trial involved stocking fingerlings from SEAFDEC/AQD's Tigbauan Main Station into one of the ponds at a density of one fish per square meter.

The use of probiotics helped maintain optimal pond water quality by breaking down organic matter, creating a less stressful environment that promoted better growth, improved feed efficiency, and reduced feed conversion ratios.

"Shortening the grow-out period could mean lower

production costs for fish farmers. This method can make milkfish culture more profitable," Somblingo added

He also noted that the trial achieved not only faster growth but also better survival rates and higher average body weights compared to traditional methods.

SEAFDEC/AQD Chief Dan Baliao emphasized that the agency is continuing trials to ensure consistent results before promoting the protocols to wider industry stakeholders.

"This is part of SEAFDEC/AQD's ongoing efforts to refine milkfish farming through practical and cost-saving techniques, but we want to be sure our methods are consistent before we share them with the industry," Baliao said.

The success at DBS marks a promising development for the aquaculture industry, especially amid rising production costs and growing demand for sustainable, efficient farming techniques.

The department, according to Baliao, will share the farming protocols with fish farmers once further trials confirm the results. (PIA)

'Built to break'

Today's column title can apply to the crumbling leadership and integrity of the Senate, it could apply to the many commercial buildings in Bogo, Cebu that crumbled or crashed during the recent earthquake or the Piggatan bridge in the town of Alcala, Cagayan.

Built to break could be "by design," poor choices or simply by mismanagement. Sadly, it is Filipinos who suffer the consequences – directly or indirectly – with lives, lost wealth or progress.

The Senate has gone through three Senate presidents – Zubiri, Escudero and now Sotto. The new Senate Blue Ribbon committee is now destined to have a rotation from Marcoleta to Lacson to I don't know who. In contrast their multi-billion building remains unfinished.

What nobody is talking about is where did the disruption in the Senate begin. Or who is the "Disruptor?" Listening to the "elected" and "appointed," it is apparent that President Bongbong Marcos greatly influenced the changes, based on what Sen. Sotto said regarding a conversation with PBBM.

While Malacañang will disavow this to hell, "the testimony of many" (senators) tells us otherwise. In truth, there is no real separation of powers in the Philippines. It is all about the political majority and who is president.

As far as the ruling party or PBBM is concerned, there are only two major political concerns: the impeachment of Sara Duterte and protecting President Marcos Jr. from the stain of theft and shame now spreading like a virus over government.

Those agendas, however, have become so intertwined that the overhaul of the Senate leadership has turned into a political minefield. You can't touch one raw nerve without triggering the other. Any wrong move or negative perception by the public can become a political career ender.

And so, we are where we are, you have a thinly split Senate where political colors and alliances are blurred and even questionable, where the once congenial body

For sure, there are people who agree with Sen. Alan Peter Cayetano that the nation, with its seriously damaged institutions, needs a reset for a clean slate.

A snap election, however, is not the answer. Not only because there's no law for this, and we're no longer under a dictatorship, which allowed Ferdinand Marcos to pit himself against Corazon Aguino in the 1986 snap election.

The more fundamental reason is that our electoral system itself is a major part of the corruption sinkhole into which our nation has fallen.

It starts with the fielding of candidates. Cayetano proposes the resignation of President Marcos, Vice President Sara Duterte and all members of the Senate and the House of Representatives.

In the unlikely event that they all do so – presumably with Cayetano and his sister Pia themselves leading the move, as suggested by their naughty brother – there must be a stringent requirement that no one related to the resigned officials, up to the fourth degree of blood or marriage ties, can run for the vacated positions.

Otherwise we will simply have the same dog with a different collar, a cosmetic change, with the same surnames and the same MOs for robbing the nation blind.

A snap election will merely provide yet another opportunity for opaque fundraising, with billions again funneled into one of the biggest and most efficient laundromats for dirty money in our looted country: campaign finance.

It will provide yet another opportunity for venal politicians to use taxpayers' money for buying votes, for claiming credit for state-funded doleouts or ayuda used for personal promotion.

Looting politicians thrive on voters who are perpetually dependent on political patrons for cash handouts, endorsements for medical care, jobs with hardly any qualifications required, and help during emergencies or special occasions such as weddings, baptisms and funerals – kasal, binyag, libing.

Thanks to the flood control scandal, there is heightened public awareness that the ayuda and patronage doled out by the thieves are bankrolled by every taxpayer.

has turned into a daily dog fight with utter loss of respect and honor.

Meanwhile, here are two important lessons for PBBM and the senators: "He who troubles his own house will inherit the wind, and the fool will be servant to the wise." (Proverbs 11:29)

In the context of "casting out undesirables:" "Now. when the pharisees heard it, they said, 'this fellow does not cast out demons except by Beelzebub, the ruler of demons."

But Jesus knew their thoughts, and said to them: "Every Kingdom divided against itself is brought to desolation, and every city or house divided against itself will not stand."

There was a time when a hollow block was proudly "Jackbilt," meaning the company placed its reputation behind hollow blocks that surpassed industry standards for strength and load bearing walls.

But nowadays, any enterprising fellow can put up a backyard hollow block making plant with no permit, no safety standards, not even government rules on the sand-to-concrete ratio or how many days to sun dry homemade hollow blocks.

Having "built" two resorts and two homes, I myself have had issues with adulterated imported cement, hollow blocks that crack and crumble because of low cement content with brown sand or muddy river sand.

Now we have steel bars that may or may not pass Bureau of Standards tests, and we can add to that substandard steel bars made from induction furnaces banned but imported from China.

After the destructive earthquake that hit Bogo, Cebu, I got to watch videos of government buildings, commercial establishments, as well as many homes that crumbled during the magnitude 6.9 earthquake.

While a magnitude 6.9 earthquake is highly destructive, I could not ignore the fact that many of the structures I

saw were "all flesh and no bones" – or showed inadequate steel reinforcement.

The front columns of a government office revealed that the palitada or plaster was two times thicker that the concrete post it was covering, obviously to make the column "big."

I thought that the more modern and commercial establishments would be better off but were not. I assume that builders cut corners in terms of amount of steel bars used or the quality of those round bars.

Earthquakes are one thing, but quality and safety standards are within human control. When the local construction and cement industry complained about adulterated imported cement, it took government a while before clamping down.

The same problem happened to backyard-made hollow blocks and an effort was made among local governments to clamp down on these. Unfortunately, it was ningas cogon or a short-lived blaze that died.

Last year and this year, the media called out the problems regarding imported steel bars and conduction furnaces that do not eliminate impurities, resulting in low-grade round bars that easily snap or break where the impurities are.

The DTI tries to do its best but being undermanned and underfunded, they are barely able to scratch the surface or cover all the regions in the Philippines. Congress needs to enact stricter laws regarding imported steel and totally ban the use and importation of induction furnaces.

Lastly, we also need to be stricter on the management side so that major bridges don't crumble one after another like the Cabangan bridge in Isabela and the Piggatan bridge in Alcala, Cagayan province. Is it poor construction or poor management against overloading?

No quick fix

The snap election proposal, with its call for mass resignations, was dead in the water. Malacañang summed up a common reaction: "wishful thinking." Even Cayetano's allies in the DDS dismissed it as an "impossible dream."

Maybe Cayetano was inspired by leadership changes in other countries now being similarly rocked by anti-corruption protests.

A common feature of these protests is that they are mostly leaderless, with Gen Zs playing a prominent role. And why not, since they are the ones inheriting the rotten systems developed by their elders.

Another feature is the exposure of the lifestyles of officials who are living beyond their means. This openness, transparency and swiftness in the exchange of information, which digital technology has made possible, is a trend that the Independent Commission for Infrastructure is bucking impressively.

There are speculations that the ICI may finally relent in conducting open hearings, but only after resigned speaker Martin Romualdez and all the senators implicated in the flood control mess (plus Zaldy Co, in case he comes out of hiding and decides to return home) have faced the commission. And after the nerve that Benjie Magalong struck, plus the home that he stumbled into in his short-lived stint as investigator, have been decisively eliminated from ICI scrutiny.

Before all this, opening the ICI hearings to the public will be nothing but wishful thinking, like the mass resignation prior to snap elections.

Our system does not allow those swift political changes arising from the anti-corruption protests now spreading across the planet. We can't even get rid pronto of lawmakers who have been implicated in the latest corruption scandal.

Even if they are indicted for plunder and held without bail, they can continue serving as lawmakers until they are convicted with finality – which could **Sketches**Ana Marie

be after 20 years. Years before a final ruling, they can plead cognitive decline and exemption from prosecution. Or they can move for dismissal of the case due to "inordinate delay" in the legal process.

Because of the state of our legal system, people often think the best they can get in terms of swift justice is watching public hearings on high crimes and seeing the big fish wriggling in the net. Being leviathans, no net can hold them too long, and they will likely wriggle free eventually. They can swim their way back to elective office, possibly to a post higher than the one they occupied when they were indicted.

People who had expected the ICI to pick up where the congressional probes left off have shifted their expectations for open proceedings to the new ombudsman, Jesus Crispin Remulla.

Since the retirement of Samuel Martires as ombudsman, Remulla had been bruited about as the strongest contender for the post. While Remulla will certainly coordinate with the ICI, the Constitution mandates the Office of the Ombudsman to conduct probes on its own in cases involving public accountability and betrayal of public trust.

These are what people dismayed over largescale corruption want: an open and efficient probe, indictments, prosecution, conviction and punishment of crooks, in a process that complies with the constitutional mandate for speedy trial. Structural reforms to excise the rot and prevent its return. And a citizenry enlightened and enraged enough by the scandal to pick a better set of officials in the 2028 elections.

There is no quick fix to our nation's problems. Without institutional reforms and an informed electorate, a snap election will just be a band-aid solution, which will open opportunities for more corruption.

NCIP underscores support for indigenous communities

SAN JOSE, Antique (PIA) — The National **Commission on Indigenous** Peoples (NCIP) shared its successes in addressing the needs of Indigenous Peoples (IPs) in the province.

Charlen E. Panaguiton, NCIP head for Aklan/ Antique, during the "Pagpaathag" program of the Philippine Information Agency (PIA) Antique, reported on their intervention to the cultural communities located in the different towns in Antique.

She noted that NCIP requested tilapia fingerlings from the Office of the Provincial Agriculturist (OPA) through the office of SP Gaseva Recopuerto. These were subsequently provided to the Ati community in Badjang, San

Additionally, NCIP distributed vegetable seedlings to the Ati community in Brgy. Igcococ, Sibalom, and native piglets to the Ati community in Brgy. Masanag, Hamtic,

beyond food security and livelihood programs, NCIP's primary focus includes the recognition and delineation of ancestral domain titles.

She reported the completion of the survey conducted for the ancestral domain of the Iraynun Valderrama, Antique.

Furthermore, the claim on the ancestral domain in Busog, Valderrama, Antique, is currently undergoing the Commission's deliberation.

To address the IPs' needs more effectively, NCIP intends to review the ancestral domains sustainable development plans in the municipalities of Valderrama and Laua-

This aims to identify appropriate solutions for their development needs.

NCIP also stresses the importance of establishing organized and accredited indigenous peoples? organizations to foster empowered and united IP communities.

Antique LGUs, other gov't agencies preparing for exit of 4Ps members

SAN JOSE DE BUENAVISTA, Antique - The Department of Social Welfare and Development (DSWD) asked local government units and other concerned government agencies in Antique to prepare for the massive graduation of household beneficiaries enrolled with the Pantawid Pamilyang Pilipino Program (4Ps).

Antique Pantawid Provincial Link Jeffrey Gabucay said in an interview on Tuesday that they will conduct a Local Chief Executive (LCE) forum on Oct. 14 and 15 as part of the preparation for the exit of household beneficiaries.

The beneficiaries will exit from the program after availing of the maximum of seven years under the 4Ps law Republic Act 11310.

We have to prepare for the massive graduation of the household beneficiaries by next year to ensure that they can still receive continued support to overcome poverty," Gabucay said.

Antique has 23,470 household beneficiaries, including the 5,394 households that graduated from the program last

The 4Ps was implemented in Antique in 2009.

"During the forum, we will be discussing with the LCEs and other government agencies on how they could further help the beneficiaries by providing them with livelihood or skills training," Gabucay said.

Graduating 4Ps will be turned over to local government units where they are residents to receive continuing assistance since they will no longer be receiving cash grants after their graduation.

A 4Ps household beneficiary receives around PHP4,500 per month under the program for the health and educational needs of the children, and rice subsidy. (PNA)

Agriculture – the two houses of Congress where devious insertions were made by wily hands covered by barong Tagalog or chic coats, with their hitherto undetected private sector accomplices wearing safety-focused work wear.

If the arrival of the hallows symbolized a pleasant afterlife for many – the 117 million population from Tawi Tawi to Batanes– it might have raised a pleasant feeling for those who feel they have lost their future.

We heard President Ferdinand Marcos Jr. underline the need to establish solid cases against those involved in aberrant flood control projects, stressing that pursuing weak charges could backfire and undermine government efforts for accountability.

"We know many of these people are not innocent, but if you're going to bring them to court, you must have a very strong case," he said.

He warned rushing cases with incomplete or weak evidence could result in dismissals that would embolden violators and damage the credibility of the government's anti-corruption drive, reiterating all government actions must remain within the bounds

of the law.

"We have to follow the law. Otherwise, whatever we do is not legitimate. And we have to be very, very clear that we go after the guilty ones."

On Sept. 11, President Marcos created the Independent Commission for Infrastructure which is currently investigating suspected anomalous DPWH projects in different parts of the country.

This came 45 days after President Marcos called out those behind irregularities in flood control projects with his new classic in Filipino: "Mahiya naman kayo sa inyong kapwa Pilipino."

Unknown then by a trusting public was some of those who gave the President a standing ovation would be accused later during the public hearings of making budget insertions in bold billions of pesos.

The people's anger cannot be muffled for much longer.

They want those accountable punished by law, while having their eyes focused on the destruction of political dynasties and the mistitled party-list political parties. (manilastandard.net)

Rebuilding trust with transparency

As Filipinos continue to grapple with the magnitude of corruption hounding the country's infrastructure projects, especially flood control, the government is turning to blockchain technology to ensure transparency in public spending—a step towards restoring public trust.

The Department of Public Works and Highways (DPWH) recently partnered with the Blockchain Council of the Philippines (BCP) to launch Integrity Chain, which is described as "a blockchain-powered platform designed to embed transparency, accountability, and public trust into national infrastructure projects."

The Integrity Chain, according to the DPWH, aims to "transform infrastructure governance by offering a real-time public dashboard that tracks project spending and progress, enabling citizen feedback and anomaly reporting, and providing tamper-proof records to deter corruption."

At its core, blockchain is a tamper-proof digital ledger. The IBM defines blockchain as "an immutable or unchangeable and tamper-proof digital ledger or record of all transactions within a network."

For the government, this is not just about using new technology; it's about ensuring that infrastructure spending can be publicly audited.

As DPWH Secretary Vince Dizon said: "From the budget process to the procurement process, to the award of the contract, to the implementation of the project, to the monitoring of the project, to the payments

As Filipinos continue to grapple with the magnitude of rruption hounding the country's infrastructure projects, Everyone should be watching now, everyone."

The move is a welcome response to public outrage and the call for accountability over the widespread corruption that has hounded the country's infrastructure spending. After all, the flood control scandal did not just waste public funds—it claimed lives, slowed down economic progress and eroded public trust.

Blockchain offers a way to slowly rebuild that trust not through empty promises but through accountability—ensuring that public spending is traceable and auditable, and that project progress is verifiable.

But while blockchain is a strong deterrent against corruption, it is not a cure-all for the ills plaguing our society. It can make corruption harder, but not necessarily impossible. It can expose anomalies but not motives. This is why, with all the revelations regarding widespread corruption, we Filipinos have all the more reasons to be vigilant on how public funds are used.

As the DPWH said, Integrity Chain enables citizen feedback and anomaly reporting, but it is up to us to use it. The technology is simply a tool—it is still up to us to call out discrepancies, demand explanations from officials, and ensure that data recorded is true and correct.

Transparency is only meaningful when people are empowered to act on what they see.

The launch of Integrity Chain is a step in the right

direction, but its utilization must not be limited to the DPWH alone. Its utilization should be expanded to other agencies such as the Bureau of Customs and Bureau of Immigration, among others. In fact, the whole of government should adopt technologies that promote transparency and accountability.

And while technology is a huge help in ensuring that public funds are properly used, it is not enough to fix the country's broken system. It must be supported with public vigilance, political will, and a commitment to justice.

In line with this, we should not allow the recent exposures of corruption in flood control projects to fade into obscurity. Everyone who benefited from and enabled the suffering of the Filipino people—from lawmakers to government officials and private contractors—should be made to face the full extent of the law.

It is our responsibility to continuously demand transparency and accountability from our government and public officials. We owe it to the victims of flooding whose suffering is continuously worsened by greed. We owe it to taxpayers who fund public projects. And we owe it to future generations who deserve a better country than we have today.

Are we ready for the Big One?

Recently, a magnitude 6.9 earthquake hit the province of Cebu. Other than toppling buildings and killing some civilians, the said tremor has triggered new interest or concern on the topic of "The Big One." The so-called "Big One" is the projected and overdue magnitude 7.2 or stronger earthquake expected to hit Metro Manila in the near future.

The "Big One" is expected to have its center along the West Valley Fault, which historically has its major movements occurring every 400 to 600 years. Since its last activity happened around 1658 then scientists are saying that the probability of experiencing a major jolt along the said line is increasing every year. Are we ready for the big

There was a 2004 study conducted by the Japan International Cooperation Agency (JICA), the Philippine Institute of Volcanology and Seismology (Phivolcs), and the Metropolitan Manila Development Authority (MMDA), which came up the likely scenarios of the said magnitude earthquake striking the National Capital Region.

The Philippine and Japanese governments are set to revisit the said study to adjust the same to reflect the increased population and number of buildings. The previous study predicted casualties in the thousands along with buildings toppling during the quake.

With the current controversies surrounding flood control projects, some are raising questions about the stability of our bridges, roads and buildings and their ability to withstand the effects of earthquakes. Last April, building experts in the country expressed their concerns about the readiness of buildings and structures in case a major quake hits the metro. Some have called for an extensive architectural and structural audit.

Unfortunately, some critics have pointed out possible character flaws that Filipinos have that may spell trouble for us all. First, we have a collective amnesia and lack of obsessive continuous momentum in any effort we do. After some noise about disaster preparedness, "ningas kugon" stepped in and we lost steam. We really

need to learn to apply ourselves to tasks with a maniacal non-stop fervor. Second, we need to demand excellence both from ourselves and everyone in society. The concept of "pwede na yan" must be stamped out from every child in our school system. The concept of no kid left behind needs to be reevaluated and a shift to a more draconian system needs to be implemented. As long as we allow mediocrity to continue, then we will have problems with our disaster preparedness. A strict enforcement of our building and all laws for that matter must be implemented. These two main flaws will always prevent any meaningful disaster preparedness program in our country.

We already have a collective anger over corruption. Hopefully, we can have a collective passion applied to disaster preparedness. Otherwise, we are doomed.

A significant step backward for children's rights

While the rest of the country reeled from in society. the devastation brought by recent storms and the southwest monsoon (habagat) causing widespread flooding, landslides, and displacement—a senator chose this moment to file a bill that would inflict further harm on countless Filipino children by lowering the minimum age of criminal responsibility to just 10 years old.

It is strikingly ironic that Senator Robin Padilla, who knows firsthand the harsh realities of incarceration from his years in prison for illegal possession of multiple firearms, would now push to impose criminal liability on children as young as 10 years old who commit "heinous crimes." Heinous crimes include murder, infanticide, kidnapping and serious illegal detention resulting in death or rape, robbery with homicide or rape, destructive arson, rape, and carnapping where the driver or passenger is killed or raped. It is difficult to imagine a 10-year-old child committing such horrific acts independently. And if they do, it is almost certainly under the influence, coercion, or instruction of an

Anyone who has spent time with a 10-year-old knows that children at this age are still making sense of their surroundings, gradually learning right from wrong, and heavily dependent on the guidance of adults in their families and communities. It is therefore absurd to treat children in conflict with the law (CICL) the same way as adult criminals who deliberately prey on unsuspecting victims.

Child rights advocates have repeatedly emphasized that the Juvenile Justice and Welfare Act already holds CICL accountable. The Child Rights Network (CRN), a civil society organization that has consistently championed children's rights, underscored the real issue—not the age of criminal responsibility, but the poor implementation of Republic Act 9344, or the Juvenile Justice and Welfare Act (JJWA) of 2006.

To begin with, the JJWA provides a comprehensive framework for addressing the needs of children at risk and those in conflict with the law. It emphasizes prevention, diversion, rehabilitation, and reintegration—prioritizing the protection of children's rights and their overall well-being. This law reflects the Philippines' commitment as a signatory to the United Nations Convention on the Rights of the Child (UNCRC). Nineteen years after the enactment of the JJWA, child rights advocates continue to lament implementation gaps and inadequate resources that hinder the effective rehabilitation and reintegration of CICL

Since the enactment of the JJWA, numerous documents, studies, protocols, guidelines, circulars, and memorandums—including its Implementing Rules and Regulations—have been issued to support its effective implementation. Despite this, only a limited number of national and local government officials and staff have fully understood the law and are actively working to uphold and protect children's rights. In fact, there is a barangay-level protocol for handling cases involving CICL and children at risk (CAR), recognizing that barangays serve as the first responders in addressing these issues.

Countless trainings and seminars have also been conducted for police officers, LGU personnel, NGO workers, and community members—those directly involved in the front-lines of JJWA implementation. Yet, significant gaps in implementation remain. The handling of CICL and CAR continues to fall short, despite the existence of detailed procedures meant to guide their treatment from start to finish.

The Juvenile Justice and Welfare Act (JJWA) created the Juvenile Justice and Welfare Council (JJWC), composed of key government agencies including the Department of Justice, Department of Social Welfare and Development, Department of Education, Department of the Interior and Local Government, Commission on Human Rights and the National Youth Commissionand two representatives from non-government organizations. Notably, none of these agencies have recommended lowering the minimum age of criminal responsibility. On the contrary, they strongly opposed previous attempts to reduce it to 12 years old, standing firm in their commitment to protect the rights and welfare of children. We can be certain that the JJWC, together with child rights advocates, will once again stand firmly against this harmful and regressive attempt to lower the minimum age of criminal responsibility to 10.

A quick visit to the JJWC website reveals the real situation of CICL and CAR and makes it clear why lowering the minimum age of criminal responsibility from 15 is both unnecessary and unjust. The JJWC highlights that these children are often victims of circumstances beyond their control-such as abuse, neglect, dysfunctional families, and indifferent communities. Rather than punishment, what they need is compassion, support, and access to appropriate services that uphold their rights to survival, development, and meaningful participation.

FRESH VIEWPOINTS: A NEW PERSPECTIVE

The Psychological Association of the Philippines (PAP), on the other hand, has consistently emphasized, based on extensive scientific research, that children and adolescents are fundamentally different from adults—particularly in areas such as decision-making, impulse control, risk-taking behavior, identity formation, and overall psychological maturity.

Responding effectively to the needs of CICL and CAR requires more than the standard whole-of-government approach. It demands the active cooperation of communities, civil society organizations, concerned individuals, and international partners. Laws, ordinances, and official policies alone cannot dismantle the deep-seated bias that views children as criminals rather than as victims of systemic failures. What is urgently needed is sustained advocacy that promotes children's rights and fosters a deeper understanding of their circumstances.

It is therefore imperative for government officials, law enforcers, local leaders, and community members to fully understand the JJWA, its implementing rules and regulations, and the various guidelines that govern the proper handling of CICL and CAR cases. The current push to lower the minimum age of criminal responsibility will not be the last. Unless we fully embrace and implement the core intent of the law—to protect, rehabilitate, and reintegrate children—such proposals will continue to surface.

Blaming the minimum age of criminal responsibility for the rise in criminality has become a tired and recurring excuse. At one point, there was even a proposal to jail the parents of juvenile offenders. Worse, there was a vicious attempt echoed even by the country's highest official—to blame the principal author of the JJWA, rather than address the root causes of youth offending.

It is far easier to label children as criminals, delinquents, or social problems than to confront the deeper issues. Few are willing to hold society accountable for creating the conditions that breed these challenges—poverty, homelessness, and communities that fail to nurture, protect, and support their children.

COMPLAINT

Plaintiff, National Grid Corporation of the Philippines (NGCP), by counsel, respectfully states:

- 1. NGCP is a private corporation created and existing under Philippine laws, with principal office address at NGCP Building, Quezon Avenue corner BIR Road, Diliman, Quezon City. It may be served with notices and other court processes through its Right-of-Way Department Visayas Division, Banilad Power Complex, Nasipit, Talamban, Cebu City, and copy furnished the afore-mentioned principal office.
- 2. Pursuant to Republic Act (R.A.) No. 9511, NGCP was granted a franchise to operate, manage and maintain, and in connection therewith, to engage in the business of conveying or transmitting electricity through a high-voltage back-bone system of interconnected transmission lines, substations and related facilities, systems operations, and other activities that are necessary to support the safe and reliable operation of a transmission system and to construct, install, finance, manage, improve, expand, operate, maintain, rehabilitate, repair and refurbish the present nationwide transmission system of the Republic of the Philippines.
- 3. Under Section 4 of the same law, NGCP was granted the power of eminent domain, subject to the requirements of the Constitution and existing laws, *viz*:
 - "SEC. 4. Right of Eminent Domain. Subject to the limitations and procedures prescribed by law, the Grantee is authorized to exercise the right of eminent domain insofar as it may be reasonably necessary for the construction, expansion, and efficient maintenance and operation of the transmission system and grid and the efficient operation and maintenance of the subtransmission systems which have not yet been disposed by TRANSCO. The Grantee may acquire such private property as is actually necessary for the realization of the purposes for which this franchise is granted: Provided, That the applicable law on eminent domain shall be observed, particularly, the prerequisites of taking of possession and the determination and payment of just compensation."
- 4. NGCP's basic critical mandate is to transmit high voltage electricity generated by the generating plants of power producers to the various distribution companies and electric cooperatives across the country. This crucial mandate plays a vital role in ensuring the steady and reliable delivery of electricity to the public. Given the indispensable nature of its operations, NGCP's mandate is imbued with public interest.
- 5. AlegriaLlego, who reportedly died without issue, reportedly left eleven (11) known siblings, namely: GualbertoLlego, married to Lydia Gualberto (both reportedly deceased), NidaLlego-Jamandre, married to Alfredo Jamandre (both reportedly deceased), Merlin Llego, married to Emma Llego (both reportedly deceased), Lorna Llego-Boongaling, married to Albino Boongaling, RolanhilLlego, married to LeteciaLlego, Norma Llego (reportedly deceased), Jessie Llego, married to NildaLlego, Eden Llego-Gelangco, married to Perfecto Gelangco (both reportedly deceased), RoselLlego, married to NorfelyLlego, Victory Llego, married to Elsa Llego (both reportedly deceased), and EsmaelLlego (reportedly deceased).
 - 5.1. Defendants SpousesLorna Llego-Boongaling and Albino Boongaling, SpousesRolanhilLlego and LeteciaLlego, Spouses Jessie Llego and NildaLlego and Spouses RoselLlego and NorfelyLlego, known surviving siblings of AlegriaLlego, are all of legal age, Filipinos and residents of Brgy. Ingore, Lapaz, Iloilo City, where they can be served with summons, notices and other court processes.
 - 5.2. Defendants RoelLlego, RitchelleHortillosa, RutchelHortillosa, Rowena Valenzuela, RaylinLlego, RomelLlego, and RonaidaLlego, known surviving children of Spouses GualbertoLlego and Lydia Gualberto, are all of legal age, Filipinos and residents of Brgy. Ingore, Lapaz, Iloilo City, where they can be served with summons, notices and other court processes.
 - 5.3. Defendants JonalynHermano, Analie Gabion, Aaron Jamandre, Bethel Zaldivar, ErlindaJacosalem, ErlenBraca, and Daisy Belandres, known surviving children of Spouses NidaLlego-Jamandre and Alfredo Jamandre, are all of legal age, Filipinos and residents of Brgy. Ingore, Lapaz, Iloilo City, where they can be served with summons, notices and other court processes.
 - 5.4. Defendants **Jemima Depigran**, **Helen Tolin**, **ArmeLlego**, **ArnelLlego**, **MetchelLlego**, **Rey Llego**, **and Mary Joy Llego**, known surviving children of Spouses Merlin Llego and Emma Llego, are all of legal age, Filipinos and residents of Brgy. Ingore, Lapaz, Iloilo City, where they can be served with summons, notices and other court processes.
 - 5.5. Defendant Christine Gelangco, known surviving child of Spouses Eden Llego-Gelangco and Perfecto Gelangco, is of legal age, Filipino and a residentof Brgy. Ingore, Lapaz, Iloilo City, where she can be served with summons, notices and other court processes.
 5.6. Defendants JanuarLlego, Ismael Llego, Janet Bedaño, Eugene Llego, Gideon Llego, Jay-R Llego, and Mark Anthony Llego, known surviving children of Spouses Victory Llego and Elsa Llego, are all of legal age, Filipinos and residents of Brgy. Ingore, Lapaz, Iloilo City, where they can be served with summons, notices and other court processes.

- 5.7. NGCP cannot ascertain the existence, identities, and whereabouts of the complete heirs of EsmaelLlego, Norma Llego, as well as the existence, identities, and whereabouts of the other heirs of AlegriaLlego, despite diligent and exhaustive efforts.
- 5.8. The heirs of AlegriaLlegoare impleaded herein because AlegriaLlego appears to be the registered owner of Lot No. 3799-C-1-C as reflected in Transfer Certificate Title No. T-134187, *infra*.
- 6. Defendant **Anthony Uygongco** is of legal age, Filipino and with an office address at La Filipina UyGongco Corporation, PH2C+HWF, Quarantine Road, Brgy. Progreso, La Paz, IloiloCity, where he can be served with summons, notices and other court processes. He is impleaded herein because he is the declared owner of Lot No. 3799-C-1 as reflected in Tax Declaration No. 15-04-011-00150, *infra*.
- 7. Defendant **City Government of Iloilo** is a local government unit duly organized and existing under the laws of the Republic of the Philippines, with office address at De la Rama Street, Plaza Libertad, Iloilo City Proper, Iloilo City, where it can be served with summons, notices and court processes. It impleaded herein because a warrant of levy is annotated on Tax Declaration No. 15-04-011-00150, *infra*.
- 8. NGCP cannot ascertain the existence, identities and whereabouts of all other persons who may have any claim or interest over the property subject of this Complaint, despite diligent and exhaustive efforts.
- 9. The above-mentioned unknown claimants and interest-holders are impleaded herein pursuant to Section 1,¹ Rule 67 of the Rules of Court and Section 14, Rule 3 of the Revised Rules of Civil Procedure, because NGCP cannot determine with certainty the identities of all persons who have the exclusive ownership of the property herein sought to be expropriated, despite diligent and exhaustive efforts. NGCP undertakes to cause, by way of motion for leave of court, the service of summons to them, by publication pursuant to Section 16, Rule 14 of the Revised Rules of Civil Procedure.
- 10. In order to meet the increasing demand for electricity in the cities, municipalities and provinces in the Islands of Panay and Guimaras and to support the continuing growth and development in the area, there is a need for NGCP to construct a new transmission system that will suit the present and future power requirements therein. Without this new transmission system, the power requirements in the aforementioned region will not be supplied, leading to power outages.
- 11. Owing to this necessity, NGCP must immediately construct the transmission line, substations and other facilities that will transmit uninterrupted power to the distributors of electricity in the aforesaid area. This undertaking is for the use and benefit of the public and is known as the **Panay-Guimaras 138kV Interconnection Project** (the Project).
- 12. The Energy Regulatory Commission (ERC) approved the Application filed by NGCP for the approval of the Panay-Guimaras 138kV Interconnection Project, docketed as ERC Case No. 2017-110RC in a Notice of Resolution,² promulgated on 17 April 2024, a pertinent portion of which provides:
 - "Notice is hereby given that the Commission, after due deliberation and evaluation, in a Regular Commission Meeting held on 17 April 2024, **RESOLVED** the following matters:
 - ¹Section 1. The complaint. The right of eminent domain shall be exercised by the filing of a verified complaint which shall state with certainty the right and purpose of expropriation, describe the real or personal property sought to be expropriated, and join as defendants all persons owning or claiming to own, or occupying, any part thereof or interest therein, showing, so far as practicable, the separate interest of each defendant. If the title to any property sought to be expropriated appears to be in the Republic of the Philippines, although occupied by private individuals, or if the title is otherwise obscure or doubtful so that the plaintiff cannot with accuracy or certainty specify who are the real owners, averment to that effect shall be made in the complaint.

 - "1. NGCP's proposed Panay-Guimaras 138kV Interconnection Project in the instant *Application* amounting to Two Billion Three Hundred Twenty Million Six Hundred Forty-Five Thousand Seven Hundred Twenty-Five Pesos and Seventy-Six Centavos (Php2,320,645,725.76) is hereby APPROVED, subject to optimization based on its actual use and verified expenses incurred during the reset process for the subsequent regulatory period, following the procedures stated in the Rules in Setting the Transmission Wheeling Rates (RTWR), as amended, and other relevant issuances of the Commission. The project cost indicated herein is solely for the purpose of determining the permit fee;
 - "x xx"
- 13. Given the foregoing, there is genuine necessity and urgency to immediately construct and implement the Project which is intended to accommodate the entry of the 40 MW Sibunag Wind Power Plant which will result in increased power supply and transmission towards Panay and reliability and flexibility of the grid in the area. Hence, the immediate completion and energization of the said project are critically important.
- 14. The Project's route commences at NGCP's existing Iloilo Substation in Brgy. Ingore, La Paz, Iloilo City, and stretches via overhead transmission line towards the Ingore Cable Terminal Station in the same barangay. It then proceeds via submarine cables towards the Sawang Cable Terminal Station in Brgy. Sawang, Buenavista, Guimaras, and continues via overhead transmission line towards the projected Zaldivar Substation in Brgy. Zaldivar, Buenavista, Guimaras, where it terminates.
- 15. The determination of the areas to be affected by the construction of the Project, which includes the property subject of this Complaint, was the result of an in-depth study by the engineering group of the NGCP. It included the survey and re-survey of the areas to be affected and spot mapping thereof to determine the terrain, suitability of the soil, tower deflections, and other technical and social factors. The choice of the areas to be affected as well as of the path of the transmission lines is neither arbitrary nor whimsical. Varying factors are always considered, such as, but not limited to the integrity of the line and the grid, the cost, and the ease of maintenance of the transmission lines.
- 16. The route of the Project was established by NGCP in good faith, taking into account all the mentioned paramount technical considerations, to cause the least possible damage to the affected localities, avoiding as far as practicable urbanized, commercial and public areas, thereby making it the least burdensome to the general public and all the landowners in the area, taken as a whole. The selection of the route and the taking of the properties affected by it, including the property subject of this Complaint, are in accordance with the ruling of the Supreme Court in the case of **Sumulong vs. Guerrero**, **G.R. No. 48685**, **September 30**, **1987**, wherein it was held:
 - "xxx Absent a clear showing of fraud, bad faith, or gross abuse of discretion, which petitioners herein failed to demonstrate, the Court will give due weight to and leave undisturbed the [expropriator]'s choice and the size of the site for the project. The property owner may not interpose objections merely because in their judgment some other property would have been more suitable, or just as suitable, for the purpose. The right to the use, enjoyment and disposal of private property is tempered by and has to yield to the demands of the common good. x xx." (Bracketing and replacement supplied.)
- 17. To fully implement and complete the project, NGCP needs to immediately take, by voluntary acquisition or expropriation, properties, or portions thereof, that are affected or traversed by the Project. It is genuinely necessary to take the properties traversed by the transmission line project because the transmission line would physically occupy the affected properties, through its construction and through its operation and maintenance after it is energized. The high voltage of electricity that would be transmistion line requires that its transmission/power line corridor be cleared of occupants and of both natural and man-made obstacles for its proper operation and maintenance, and for the safety of people, properties and the transmission line itself. This public use of the affected properties necessitates their taking.
- 18. The genuine necessity and public use for which the taking of properties for the transmission line project of NGCP are in accordance with the rulings of the Supreme Court, particularly in the cases of **The Manila Railroad Company vs. Mitchell, G.R. No. 19280, March 16, 1923 (En Banc)**, and **MORE Electric and Power Corporation vs. Panay Electric Company, Inc., G.R. No. 248061, September 15, 2020 (En Banc)**, and **National Power Corporation vs. Benjamin Ong Co, G.R. No. 166973, February 10, 2009**.
 - ³ "When the law says that private property may be taken for public use only when it is necessary for such use, it means a reasonable, not an absolute necessity x xx"
 - ⁴ "x xxWithout a doubt, the provision of uninterrupted supply of electricity is a public purpose which is distinct from the general purpose of electricity distribution. Such distinct purpose is both public and genuine."
 - ⁵"x xxthere is no doubt that the installation of transmission lines is important to the continued growth of the country. Electricity moves our economy; it is a national concern."
- 19. In the exercise of its right of eminent domain, NGCP intends to expropriate portionofaparcel of land denominated as**Lot No. 3799-C-1-C**, situated in Brgy. Ingore, La Paz, Iloilo City. As indicated in the pertinent portion of the Index Map,⁶ the said portion of Lot No. 3799-C-1-C is within the route and site of the project.
- 20. Lot No. 3799-C-1-C is registered under Transfer Certificate of Title (TCT) No. T-134187⁷in the name of AlegriaLlego. It is still declared underTax Declaration (TD) No. 15-04-011-00150, covering Lot No. 3799-C-1, in the name of Anthony Uygongco. The affected area sought to be expropriated consists of 372 square meters, more or less, as shown in the Sketch Plan⁹ and Narrative Technical Description, and is more particularly described below, to wit:

21. To enable NGCP to construct and maintain the **Panay-Guimaras 138kV Interconnection Project**, it is both genuinely necessary and urgent to acquire, upon payment of just compensation, the above-described affected portion of Lot No. 3799-C-1-C, upon payment of just compensation, to ensure stability and reliability of power supply in the cities, municipalities and provinces in the Islands of Panay and Guimaras, as well as other parts of the country.

- 22. NGCP's personnel conducted negotiations with the defendants for the acquisition of the above-described affected portion of Lot No. 3799-C-1-C. They made initial negotiations with defendant Rowena Llego Valenzuela on December 3, 2023, in Brgy. Ingore, Lapaz, Iloilo City. Defendant Rowena Llego Valenzuela explained that the land belonged to her late aunt, AlegriaLlego, and had been verbally divided among Alegria's siblings. On December 4, 2023, they conducted negotiations withdefendant Aaron Jamandre, a nephew of AlegriaLlego who resides on the subject property. He confirmed the verbal division of the land and expressed willingness to cooperate, provided the compensation was appropriate. A follow-up negotiation on January 15, 2024, revealed details about AlegriaLlego's siblings, most of whom are deceased. Defendant Aaron Jamandrealso confirmed that the property remained under AlegriaLlego's name as the mother lot, with no formal subdivision. However, no settlement could be reached between the parties due to the unresolved issues on ownership, lot subdivisionand documentation. Considering the urgency involved in the construction of the project, NGCP has no other recourse but to file the instant case.
- 23. Expropriation aims to condemn a property to public domain to the exclusion of all persons, who all lose their respective interests over the same and, therefore, who must share in the payment of just compensation in accordance with their respective interests. The Supreme Court in the case of **Republic vs. Court of Appeals**, **G.R. No. 146587**, **July 2**, **2002**, held:
 - "x xxAnin rem proceeding, condemnation acts upon the property. After condemnation, the paramount title is in the public under a new and independent title; thus, by giving notice to all claimants to a disputed title, condemnation proceedings provide a judicial process for securing better title against all the world than may be obtained by voluntary conveyance." (Citing Cadorettevs. US CCA (Mass) 988 F2d 215; emphasis supplied.)
- 24. NGCP is willing and able to pay the just compensation for the above-described portion of Lot No. 3799-C-1-C to the defendants who may be determined by this Honorable Court as rightful recipients thereof pursuant to **Section 9**, **Rule 67 of the Rules of Court**, as may be necessary, subject to deductions for capital gains and documentary stamp taxes for the transfer of the property in the name of NGCP, which NGCP shall directly pay to the Government, and subject to the settlement by defendants of all applicable estate taxes and all outstanding taxes pertaining to prior transfers of the subject property, if any, and all other outstanding taxes under the National Internal Revenue Code (NIRC), and other outstanding realty taxes and dues under the
- 25. Considering that the registration of the transfer in fee simple of the above-described portion of Lot No. 3799-C-1-C in the name of NGCP by virtue of this expropriation proceeding may require the settlement of the estate involving the property, if applicable, the payment of the applicable estate taxes, the settlement of all outstanding realty taxes and dues under the Local Government Code, if any, and the settlement of all outstanding taxes pertaining to prior transfers of the subject property, if applicable, defendants must be required to submit the necessary documents and proof of the settlement of the estate and payment of the said taxes and dues before just compensation is paid to them.
- 26. Recognizing further the urgency of the resolution of expropriation cases involving transmission lines, in OCA Circular No. 127-2021 dated 13 October 2021, the Chief Justice of the Supreme Court enjoined judges to give primacy to cases that involve, among others, government expropriation, and infrastructure projects (including energy transmission projects),commercial and economic-impact cases.
- 27. Moreover, an expropriation proceeding being an action *quasi in rem*, ¹² jurisdiction over the defendants is not required. It is only required that there is jurisdiction over the *res*. Concomitantly, prior service of summons upon the defendants is not required for the issuance of the Writ of Possession.
- 28. In *NM Rothschild & Sons (Australia) Ltd. vs. Lepanto Consolidated Mining Company,* ¹³the Supreme Court held that:
 - "[W]hen the case instituted is an action *in rem* or *quasi in rem*, Philippine courts already have jurisdiction to hear and decide the case because, in actions *in rem* and *quasi in rem*, **jurisdiction over the person of the defendant is not a prerequisite to confer jurisdiction on the court**, provided that the court acquires jurisdiction over the *res*."
 - 29. Again, in *Macasaet vs. Co, Jr.*, ¹⁴the Supreme Court held:
 - "Jurisdiction over the person, or jurisdiction *in personam*—the power of the court to render a personal judgment or to subject the parties in a particular action to the judgment and other rulings rendered in the action—is an element of due process that is essential in all actions, civil as well as criminal, except in actions *in rem* or *quasi in rem*. Jurisdiction over the defendant in an action *in rem* or *quasi in rem* is not required, and the court acquires jurisdiction over an action as long as it acquires jurisdiction over the *res* that is the subject matter of the action. The purpose of summons in such action is not the acquisition of jurisdiction over the defendant but mainly to satisfy the constitutional requirement of due process." [Emphasis supplied]

ALLEGATIONS IN SUPPORT OF THE ISSUANCE OF A WRIT OF POSSESSION

- 30. Section 13 of R.A. 11361¹⁵ provides that Rule 67 of the Rules of Court governs plaintiff's expropriation cases. Under Section 2 of the said rule, NGCP may already enter and possess the subject property during the pendency of the expropriation case, ¹⁶ thus:
 - "SEC. 2. Entry of plaintiff upon depositing value with authorized government depositary. Upon the filing of the complaint or at any time thereafter and after due notice to the defendant, the plaintiff shall have the right to take or enter upon the possession of the real property involved if he deposits with the authorized government depositary an amount equivalent to the assessed value of the property for purposes of taxation to be held by such bank subject to the orders of the court. Such deposit shall be in money, unless in lieu thereof the court authorizes the deposit of a certificate of deposit of a government bank of the Republic of the Philippines payable on demand to the authorized government depositary." [Emphasis supplied].
- 31. Pursuant to the above Rule, NGCP shall cause to be served, among other means, together with the summons and the instant Complaint, a Notice to Take Possession¹⁷ upon the defendants.
- 32. In the interest of immediate project implementation within established timelines, NGCP shall deposit with the Clerk of Court of this Honorable Court, in favor of the defendants, 100% of the BIR zonal value of the portion of the subject property sought to be expropriated, in the total amount of One Million Eight Hundred Sixty Thousand Pesos (Php1,860,000,00), thereby placing it in *custodialegis*, pursuant to OCA Circular No. 113-2019

- 33. Upon deposit of the provisional amount, which is higher than the assessed value of the affected portion of the subject property, NGCP would have fully complied with the requirements for the issuance of a writ of possession as mandated by law.
- 34. In a long line of cases¹8and in accordance with OCA Circular No. 113-2019, once the above requirements are complied with, it becomes the ministerial duty of the trial court to issue the writ of possession in favor of the NGCP, without need of any further hearing. Therefore, this Honorable Court can already immediately issue to NGCP an order to take possession of the subject properties and start the implementation of the Project.
- 35. In the case of *Municipality of Cordova v. Pathfinder Development Corporation*, ¹⁹ the Supreme Court emphasizes the mandatory issuance of the writ of possession upon the receipt of the required deposit. "*No hearing is actually required for the issuance of a writ of possession, which demands only two (2) requirements:* (a) the sufficiency in form and substance of the complaint; and, (b) the required provisional deposit x xxx. Upon compliance with these requirements, the petitioner in an expropriation case is entitled to a writ of possession as a matter of right and the issuance of the writ becomes ministerial."

36. Corollary to the successful and complete implementation of the Writ of Possession, and for the orderly and peaceful entry of the NGCP into the subject property for project implementation, the assistance of the Philippine National Police (PNP) and temporary access through the subject property to the area being expropriated are necessary. In view of the requirement under Section 28.2, Rule 28²⁰ of the Revised Philippine National Police Operational Procedures, the Order for issuance of a writ of possession needs to specifically direct the PNP to render assistance in order for the PNP to have basis to act. As such, NGCP prays that this Honorable Court also direct the PNP Officers to resist in the implementation of the Writ of Possession that will be inside. also direct the PNP Officers to assist in the implementation of the Writ of Possession that will be issued.

Filed before this Court is an Amended Petition filed by Gina Clemente Delos Santos, represented by her attorney-in-fact, Alex Clemente Delos Santos, seeking to correct certain entries in the Certificate of Live Birth of her daughter, Erin Sofiya Delos Santos Molina (Registry No. 2014-122), issued by the Municipal Civil Registry of San Jose, Antique. The petition names the Municipal Civil Registrar of San Jose, Antique; the Civil Registrar General; Eric Gomez Molina, and Gian Izak Delos Santos and Gian Saneca Delos Santos as respondents.

The petitioner, the biological mother of Erin Sofiya, states that her daughter was born on December 28, 2013, in San Jose, Antique. The child's birth was registered on January 15, 2014, with the Certificate of Live Birth indicating that the parents, Gina C. Delos Santos and Eric G. Molina, were married on June 15, 2013, in San Jose, Antique. This entry led to Erin Sofiya being considered a "legitimate"

child. However, it was later discovered that the petitioner's marriage to Eric Gomez Molina was not registered with the Philippine Statistics Authority (PSA). The petitioner was still legally married to Adil Amin El Gamal, whom she married in a civil rite on June 10, 1994, in San Jose, Antique. The marriage to Adil El Gamal was confirmed by a certification from the Office of the Civil Registrar General. Because the petitioner had a subsisting marriage to Adil El Gamal, she had a legal impediment to marry Eric Molina. Therefore, there was no valid marriage between the petitioner and Eric Molina at the time of their daughter's birth, which makes Erin Sofiya an "illegitimate" child conceived and born out of wedlock.

The petitioner seeks to rectify the erroneous entries on the birth certificate of Erin Sofiya Delos Santos Molina to reflect her true status. The following corrections are prayed for:

- 1. The last name in Item No. 1, currently "Molina," should be changed to "Delos Santos";
- 2. The entries for the Date and Place of Marriage of Parents in Items No. 20a and 20b, currently "June 15, 2013 in in San Jose, Antique," should be deleted and replaced with "Not Applicable"; and
- 3. That Erin Sofiya be allowed to continue using the surname "Molina" because her biological father, Eric Gomez Molina acknowledges her as his daughter.

The amended petition, being sufficient in form and substance, is hereby set for hearing on December 4, 2025, at 8:30 in the morning at the session hall of this Court, Justice Calixto Zaldivar Hall of Justice, Brgy. 5, Binirayan Hills, San Jose, Antique, at which time and place any interested party may appear and show cause why the petition should not be granted.

Iloilo to donate P5M for Cebu quake victims

ILOILO CITY - The provincial government here is sending PHP5 million as financial aid to quake-hit Cebu.

Earlier, the governor said they intend to send the assistance through the provincial government within the week.

On the other hand, the city government is also eyeing to send assistance, although it has yet to disclose the amount.

The quake on Sept. 30 was felt at Intensity 4 in the province.

It left some cracks at the provincial capitol building, but it was later declared as structurally sound by the Provincial Engineer's Office and the Provincial Disaster Risk Reduction and Management Office. (PNA)





Set aside. Prepare the vegetables by steaming the eggplant and string beans for 10 minutes. Steam the bok choy for 5 minutes.





Swedish envoy explores possible collaboration with Iloilo

ILOILO CITY - Swedish Ambassador to the Philippines Anna Ferry on Wednesday led the Team Sweden delegation to strengthen bilateral cooperation with Iloilo City on economic development, including public transport, and explore more areas of cooperation.

Ferry said that they would like to better understand the priorities of Mayor Raisa Treñas and Iloilo City, learn areas for development or already ongoing programs, and look at how they can provide support to achieve the goals.

"Sweden is strong in various sectors. We have technology and knowledge. And we are happy to share that knowledge in areas like those mentioned, transportation, rail, upgrade of airports, but also in areas like renewable energy, energy efficiency, water management, and water treatment. So, there are a few areas that we are looking into how we can expand our cooperation," she said in a statement.

Just recently, Sweden, through Swedfund, its development finance institution, has inked a deal to provide up to 6 million Swedish Krona (roughly PHP30 million) through grants for feasibility studies of the integrated public transport system project in Metro Iloilo.

"The purpose of this partnership is to provide a study, exploratory, on how the city, the surrounding LGUs (local government units) can have an integrated bus transit system. So, it will be better for all the citizens of Metro Iloilo City to commute, and it will also contribute to the goal of the city and province to have a livable city," Ferry said in a media interview.

The support also aimed to showcase how data-driven and efficient public transport solutions can reduce greenhouse gas emissions, mitigate congestion, and improve accessibility in Iloilo City.

Sweco (a Swedish engineering consultancy) and Metro Iloilo-Guimaras Economic Development Council signed the contract in August this year for Sweco to undertake a feasibility study for this project.

The study will propose the phased implementation of an integrated public transport network plan.

Stepping for the first time in Iloilo City, she said she was happy to see and experience the city, which is "really a livable city."

"I see that you can walk and bike, you have open spaces, parks and of course I tasted the fantastic food," she said.

The Swedish envoy, who also attended the first State of the City Address of Mayor Treñas, was joined by Swedfund project manager Louise Bernander. (PNA)
