Rep. Garin files bill expanding **MORE** Power to Iloilo's 1st District

ILOILO First District Representative Janette Garin has submitted House Bill No. 6292 to expand the franchise of MORE Electric and Power Corporation (MORE Power) to seven municipalities in the 1st District of Iloilo — Igbaras, Tubungan, Oton, Tigbauan, Guimbal, Miag-ao, and San Joaquin.

The bill was submitted on Monday, November 24, 2025, to the Bills and Index Service Office of the House of Representatives.

In her explanatory note, Garin stated that she is seeking an amendment to certain provisions in Republic Act No. 11212, which was also amended by RA No. 11918. This currently authorizes MORE Power to operate as a distribution utility in Iloilo City and several municipalities in the 2nd and 4th districts of the province, including Passi City.

Garin further expressed that the proposed expansion will provide MORE Power the opportunity "to establish, operate, and REP. GARIN / page 2

THE Iloilo Provincial Government has formally entered into a landmark publicprivate partnership with AC Health and Healthway Medical Network to establish and operate dialysis centers across Iloilo's district and provincial hospitals.

This initiative seeks to significantly expand access to life-saving hemodialysis services by equipping all 12 district hospitals and the provincial hospital with modern, DOH-compliant dialysis centers.

Each center will initially operate 8 dialysis stations, helping address the urgent gap in dialysis services across the province.

maintain, for commercial purposes and in the public interest, a distribution system for the conveyance of electric power to end users in the 1st District."

The congresswoman based her reasoning on the performance of MORE Power since it took over the Iloilo City distribution system five and a half years ago.

"In that short period, MORE Power has reduced electric rates in Iloilo City from among the highest in the country to among the lowest," according to Garin.

Its customer base also significantly increased—from 63,000 customers it reached 101,000—along with the continuous improvement of facilities described by Garin as "aging and decrepit," which were inherited from the previous distribution utility.

"We believe that such service, marked by high standards and proven to be fast, reliable, responsive, modern, and forward-looking, should also be made available to Ilonggos living outside Iloilo City," she added.

Garin also mentioned that the Energy Regulatory Commission (ERC) has already granted a Certificate of Public Convenience and Necessity (CPCN) to MORE Power for its expanded franchise areas in Passi City and the municipalities of Alimodian, Leganes, Leon, New Lucena, Pavia, San Miguel, Santa Barbara, Zarraga, Anilao, Banate, Barotac Nuevo, Dingle, Dueñas, Dumangas, and San Enrique.

Police to launch bomb threat awareness drive in city schools

ILOILO CITY (PIA)

— The Iloilo City Police
Office (ICPO) is set to
conduct a series of forums
in schools across the city
to strengthen coordinated
responses to bomb threats
and prevent unnecessary
class disruptions, ICPO
director Col. Kim Legada
has announced.

Legada said that the forums will focus on standard protocols, coordination procedures, and proper response measures, ensuring that schools and authorities can act quickly and efficiently in response to threats. He said that having clear guidelines will not only protect

students but also help minimize panic and operational delays.

At a press briefing on Nov. 19, the police chief urged the public to remain patient as investigations into the recent threats continue. He disclosed that no suspects have been confirmed yet, and that releasing premature details could compromise the ongoing probe.

To further enhance safety, Legada said police visibility in schools has been increased, and coordination with school officials is ongoing. The ICPO is also working closely with other government agencies to comprehensively address the issue and accelerate efforts to identify those responsible.

Highlighting the importance of preparedness, the police chief emphasized that strong security protocols in educational institutions are crucial in maintaining safety and preventing disruptions.

Over the past three days, ICPO has reported multiple bomb threats targeting schools across the city. While no explosive devices have been found, the repeated incidents have disrupted classes and caused fear among students, teachers, and parents.

From Nov. 12 to Nov. 19, the ICPO logged 26 bomb threats involving 15 schools and one commercial establishment.

To address the situation, coordination meetings

are currently serviced by the Iloilo Electric Cooperative I (ILECO I), but she emphasized that the constitution itself permits and encourages competition.

"The Constitution is clear: no franchise for a public utility shall be exclusive in character," according to Garin, citing Section 11, Article XII of the 1987 Constitution.

"Public interest will be better served if we allow competition that gives Ilonggos in the 1st District a choice — to access modern, dependable, affordable, and efficient electric distribution services already being enjoyed by Iloilo City residents. It is the right time to do this, and to continue the progress of Iloilo City and to jump-start the progress in the nearby parts of Iloilo Province."

Congresswoman Garin also affirmed the Supreme Court ruling that validated the validity of RA 11212 and RA 11918, recognizing that the expansion of MORE Power's franchise is anchored on promoting the common good

She further added that the municipalities in the 1st District have passed resolutions urging her to pursue legislation to include them in the MORE Power franchise area

According to the congresswoman, this call represents the desire of local leaders and residents to benefit from the "fast, reliable, responsive, modern, and forwardlooking services" that MORE Power is known for providing.

Authorities reminded the public that issuing bomb threats, whether real or hoax, is a serious criminal offense, punishable by up to five years in prison, a fine of up to P40,000, or both. City Mayor Raisa Treñas-Chu and Iloilo Governor Arthur Defensor Jr. also each offered a P100,000 reward for any useful information that could lead to the identification of those responsible for the series of bomb threats in schools across the city and province of Iloilo. travel in Southeast Asia.

This event also highlighted the oath-taking of the Iloilo City Health and Wellness Tourism Council and its Technical Working Group.

In her message, Dr. Tupas emphasized the significance of inner well-being and having a sense of feeling great.

"It is the best caption in white work: if you rise up, or if you wake up, you have to feel great. If you feel great, you'll also look great inside and out," Tupas said.

Tupas added that medical tourism is not a new concept for Iloilo City, as it has already catered to patients from Panay Island and balikbayans, citing they return because of the excellent service provided by Ilonggo doctors and medical staff.

She also outlined that Iloilo City is the first local government unit across the country to market medical tourism

Prior to the end of her term as councilor at the Sangguniang Panlungsod, Tupas proposed the first medical tourism ordinance—a policy designed to institutionalize the initiative—in January 2025.

Furthermore, the city has a goal to attract 30% of tourists by 2030, to avail of the city's medical and wellness tourism packages.

On the other hand, Mayor Raisa Treñas emphasizes Iloilo City's readiness to adapting medical tourism, highlighting the crucial link between quality healthcare and tourism growth.

"Tourism grows faster when a city offers quality health services. Today, people choose to travel to places where they feel comfortable and well taken care of. They don't just look at the destination, they also look at the services and the care provided to them," she said.

She added that the city will also level up its district health facilities into primary health centers. The city's initiative will also include expanding USWAG Physical Rehab Center and USWAG Pharmacy that provides free maintenance medications. (via Iloilo City Government) DECEMBER 1 - 7, 2025

Provincial gov't recognizes efforts of nutrition workers in 3rd BNS Convention

TO recognize the efforts and contribution of nutrition workers in the community, the Provincial Government of Iloilo in collaboration with the Federation of Provincial Nutrition Volunteers of Iloilo, Inc., and the Provincial Nutrition Committee, conducted the third Barangay Nutrition Scholars (BNS) Convention at Grand Xing Imperial Hotel on November 24, 2025.

With the theme, "BNS: Kaagapay sa Pagkakaisa, Katuwang para sa Nutrisyong Sapat at Seguridad sa Pagkain tungo sa MoRProGRes Iloilo", the event was joined by over 1,300 BNS across the province. The event was also spearheaded by Provincial Health Officer II Dr. Maria Socorro Quiñon, along with Vice Governor Nathalie Anne Debuque, Department of the Interior and Local Government (DILG) Iloilo Provincial Director Engr. Festival organizer to implement changes in Dinagyang 2026

ILOILO CITY (PIA) — The Iloilo Festivals Foundation, Inc. (IFFI) is set to implement major adjustments for the 2026 edition of the world-renowned Dinagyang Festival.

In a press briefing on November 18, IFFI unveiled a new parade route for both the Kasadyahan sa Kabanwahanan and the Dinagyang Tribes Competition. Performances will now start at the Freedom Grandstand and end at the Iloilo Sports Complex, which will serve as the only two judging areas for the said competitions.

I doubt if a trip to the US, once the top favorite travel destination of many Pinoys, would have elicited the same excited reaction. More likely, I would've been warned to steer clear of US Immigration and Customs Enforcement agents.

Some older ladies, meanwhile, upon learning of my upcoming visit to Korea, said, "ooh, oppa!" Literally, an older brother, but Pinoy fans of K-drama associate the word with the handsome male stars of Hallyu, the Korean Wave.

Korean culture has not only conquered the world and Filipino hearts, it has also altered concepts of physical beauty. These days there is emphasis on East Asian features so slim, clean-cut and delicate both men and women look like aliens from a planet in the future where wrinkles and eyebags have been permanently eradicated.

You can see this concept of beauty, no longer Caucasian-centric, from the way our younger generations are styling themselves, and from the models used in local advertising. Many of the youths are channeling the superstars of K-pop: BTS, Blackpink, and now animated stars HUNTR/X and the Saja Boys of "KPop Demon Hunters" fame.

This year, "Golden," from the monster hit animation movie, has been nominated for Grammy Song of the Year. If the song wins, it will top the Grammy nomination bagged for the first time by a Korean pop group, BTS, for Best Pop Duo/Group for "Dynamite" in 2021 (followed by "Butter" in 2022).

"KPop Demon Hunters" the movie, meanwhile, has been nominated at the upcoming Oscars for best animation film.

Hallyu has been a boon to Korean tourism, just like "The Lord of the Rings" trilogy, "The Hobbit" and the world of J.R.R. Tolkien made New Zealand, where the movies were produced, a popular travel

destination.

Pinoys have become familiar with Korea's Joseon dynasty, setting for many Hallyu period dramas, and its main palace located in Seoul, Gyeongbokgung.

The last time I toured Gyeongbokgung Palace, pre-pandemic, I was still using a Canon IXUS digital

Last Monday when I visited Gyeongbokgung – Korean for "shining happiness" or "great blessing" – the palace was packed with tourists, many of them foreigners, all using either smartphones to take photos or else large professional cameras. It was a good day for photos, with exquisite fall colors and the Bugaksan Mountain in the background making the scenery even more picturesque.

Adding to the colorful scenery was a sight that was rare during my pre-pandemic visit: most of the tourists – foreigners and locals, men and women alike – were wearing traditional Korean garb or hanbok as they explored the palace.

Even this fascination with Korean traditional dress has become a revenue earner for the country. Hanbok rental stores have mushroomed, allowing tourists to don the costumes for prices ranging from the equivalent of P400 to P2,000.

Thanks to K-drama, the world has become familiar with the hanbok as well as Gyeongbokgung, built in 1395. The palace is the setting for many period K-dramas, and its traditional kitchen is featured in this year's Netflix hit "Bon Appetit, Your Majesty."

K-pop fans also know Gyeongbokgung as the setting for BTS' live performances of "Idol" and "Mikrokosmos."

Again thanks in large part to Hallyu, Korean cuisine has gone global, along with other products such as cosmetics and clothing.

The Korean Wave, which has earned billions of dollars for South Korea, has raised global awareness even of the conflict on the Korean peninsula, due to movies and TV series such as the monster hit "Crash Landing on You."

I've visited Korea's Demilitarized Zone a few times so it was fascinating to watch "CLOY." Yesterday

l visited another

sector of the DMZ, called Pamintuan

the peace trail, here in Gimpo City.

A force for peace is how South Korea is presenting its robust (and still growing) defense industry – as a deterrent to armed conflict and therefore a contributor to peace. But more on this in my next article.

Being a cultural powerhouse has paid off for the South. Last year, the country was tagged by the UK's The Telegraph as the fastest growing travel destination, as international arrivals

In actual numbers, South Korea had 16.37 million international tourists last year, although this was just around 94 percent of the arrivals in 2019. The revenues were also lower compared to pre-pandemic, at \$16.45 billion – earnings that our tourism sector can only dream of.

jumped 48.4 percent from 2023 levels.

Many of those arrivals include young Filipino K-pop fans, who go to Korea just to watch their favorite bands perform live. Filipinos are not alone; youths from other parts of Asia do the same.

South Korea is a model for what a strong national brand can do. Even with periodic political upheavals, and being technically at war with its belligerent northern neighbor, South Korea is seen by much of the world as innovative, safe, fun and a generally benign player on the global stage.

Just 72 years since it signed an armistice with the North, South Korea has become the 13th largest economy.

Last Saturday, the Group of 20 major economies picked South Korea as host of the G20 summit in 2028, coinciding with the 20th anniversary of the launch of the grouping.

The Koreans can rightfully sing, like the animation girl band Huntr/x: "We're going up, up, up, it's our moment, you know together we're glowin', gonna be gonna be golden."



The AI boom hits a crossroads in 2026

Editorial

After three years of breakneck growth and soaring valuations, the AI industry enters 2026 with some of the euphoria giving way to tough questions.

Here is a look at what is at stake:

Money is pouring into artificial intelligence, with spending expected to reach more than \$2 trillion worldwide in 2026, according to the consulting firm Gartner.

But concern is growing. Stock markets are closely monitoring tech giants Apple, Microsoft, Google, Amazon and Nvidia, and startups like OpenAI, amid fears of a speculative bubble.

Several major investors — including Japan's SoftBank and Peter Thiel -divested Nvidia shares in mid-November.

"No company is going to be immune, including us," Google CEO Sundar Pichai warned.

Yet Nvidia reported "off the charts" demand for its chips, indicating the fever continues.

Jobs under threat?

The debate over whether AI will destroy jobs continues, with answers still elusive.

"The AI phenomenon is here and influencing how firms think about the labor force," US Fed Vice Chair Philip Jefferson said.

True AI believers think employment will be

so transformed that a universal income will be needed.

Most forecasts see gradual change. McKinsey projects 30 percent of US jobs could be automated by 2030, with 60 percent significantly altered.

Gartner analysts suggest AI will create more jobs than it eliminates by 2027.

Super-intelligence now?

AI innovation raises the specter of super-intelligent machines like those in science fiction.

Anthropic founder Dario Amodei contends the next level of AI could debut in 2026 and become smarter than Nobel Prize winners.

This artificial general intelligence (AGI) will work at a higher standard than any person, he said.

OpenAI chief Sam Altman said by early 2028 that his ChatGPT-maker could create a "legitimate AI researcher" capable of discoveries.

Meta CEO Mark Zuckerberg spent hundreds of millions of dollars in 2025 hiring researchers to achieve AGI.

But Meta's departing Chief AI Scientist Yann LeCun calls talk of manufacturing AI "geniuses" in a data center "complete BS."

Media facing tidal wave

transformation in the information ecosystem since the printing press," consultant David Caswell told AFP.

Traditional media face threats from chatbots and Google's AI overviews, which regurgitate content without users visiting original sites, eroding traffic and revenue.

Survival options include becoming high-value products like The Economist; implementing blocking techniques; or winning compensation through lawsuits or partnerships, as the New York Times, Associated Press and AFP have done.

Clean up the slop

Despite promises of cancer cures and climate solutions, many see "AI slop — low-grade AIgenerated content — as the technology's most visible impact for now.

Creating slop requires little effort but generates clicks and revenue by gaming platform algorithms.

These creations, often presented as real, saturate social feeds with content ranging from fake Spotify bands to TikTok videos claiming to show explosions on the frontlines in Ukraine.

The platforms have responded with labeling, moderation, and anti-spam measures, though no Generative AI represents "the largest silver bullet has emerged to stop the tide. AFP

Silence the 'Wang-Wang'

A recent video making the rounds on social media captures a black van-escorted by two motorcycles with blinkersaggressively weaving through traffic with sirens, or "wangwang", blaring. No license plate is in sight, but the vehicle bears the logo of the Department of Transportation (DOTr).

The footage, posted just as the holiday carmageddon begins, has reignited public outrage over this glaring display of entitlement. Acting Transportation Secretary Giovanni Lopez called the incident a clear abuse of traffic rules.

"Yung mga ganitong arogante at mayabang na drayber, siguradong mahuhuli namin kayo. At kailanman, hindi na kayo papayagan pang makapagmaneho ng sasakyan. Wala kayong puwang sa kalsada (We will surely catch these arrogant and boastful drivers. We will not allow you to drive ever again. You have no place on the roads)," he said in a statement.

The incident occurred despite the DOTr's issuance of a memorandum last month revoking the authority of its officials to use protocol license plates and banning the use of sirens and blinkers. The memorandum aligns with Administrative Order No. 18 and the Land Transportation Office's (LTO) Administrative Order No. 2024-001, which prohibit the use of devices that produce "exceptionally loud or startling sound" by government officials.

In a country where traffic congestion is a daily ordeal, the continued misuse of "wang-wang" by supposed "VIPs" is a blaring reminder of the abuse of power, entitlement, and normalization of privilege—while millions endure daily hardship: hours stuck in traffic jams and long queues for public transport just to get to work, school, or home.

This is not the first time that the misuse of sirens and blinkers has gone viral on social media or made headlines. We've seen how public officials bypass traffic jams with "wang-wang" and escorts, sidelining other vehicles. I personally see this on our roads.

At a time when public trust and confidence in the government are at a low ebb, the use of "wang-wang" is not merely a symbol of entitlement—it's an insult to the Filipino people. It represents a mindset that public office is a license to bypass the rules that bind the nation. That public officials—who are supposed to serve the people and enforce the law—are somehow above it. It perpetuates the perception that there are two sets of rules: one for the powerful, and another for the ordinary citizen.

And it is infuriating to see that some officials continue to flout the rules-emboldened by a system that rewards the corrupt and punishes ordinary citizens, as we've seen in the flood control scandal.

The use of sirens should be strictly limited to emergency responders—ambulances, fire trucks, and police vehicles responding to actual emergencies—not "VIP convoys' sidelining the very motorists they are supposed to serve.

It's time to silence the "wang-wang" again.

The late former President Benigno "Noynoy" Aquino III famously banned the use of sirens during his term, making it a hallmark of his "daang matuwid" governance. The prohibition was a powerful statement to the Filipino people. It told the nation that public officials would endure the same traffic and get stuck on the same roads as everyone else.

With widespread corruption scandals hounding the government, there is all the more reason for our public officials to display humility and show that they are not above the law, but bound by it. They should return to the very essence of public office: public service.

Silencing the "wang-wang" is a simple but powerful step toward restoring dignity to public office. When officials follow the rules they implement for everyone else, it shows respect for the very people they serve. It shows that they don't just walk—but drive—the talk.

As the saying goes, public office is a public trust. And at a time when that trust is severely broken, rebuilding it requires more than just statements. It requires visible and tangible action.

Up to when will the government turn a blind eye and tolerate this? And when will the people's patience snap, so that they will decide to take stronger actions against those who abuse

The road is all ours and not for a few in government. They should be public servants, not abusers on the road.

Sulong Lokal: Building a nation that chooses its own

Sulong Lokal is a growing movement that wants Filipinos to choose and support more locally made products. It believes that when we buy what Filipino workers, farmers, and small businesses create, we help build a stronger and more self-reliant country. This effort is led by Negosyo Advocates, a network of entrepreneurs, local producers, cooperatives, academics, and supporters who want to improve local production and make it easier for Filipino businesses to grow. Their first national conference showed how serious this goal is and how many people are ready to take part in the change.

Many speakers in the conference shared the same message: Filipino talent is strong, but the system does not support Filipino producers enough. Local businesses face many problems. Markets are filled with cheap imported goods that often push out local products. Farmers struggle when foreign goods enter the market at low prices.

Manufacturers deal with high electricity costs, corruption, and slow and complicated processes in government agencies. Innovators and scientists talked about how even simple materials for tools and equipment cannot be mass-produced in the Philippines. These challenges stop small and medium businesses from growing and also hold back the country as a whole.

The Sulong Lokal campaign hopes to change these issues by encouraging Filipinos to buy local products and by pushing for long-term policies that help producers. During the conference, Negosyo Advocates president Joy Cerrafon explained that Sulong Lokal has two main goals. First, it wants to promote local goods so more Filipinos choose them every day. Second, it wants to push the government to support farmers, artisans, manufacturers, and small businesses through fair policies and better systems. The campaign includes a seal for Filipino-made products, a digital marketplace, community events, and efforts to teach people why buying local matters. It recognizes that choosing local goods helps families, communities, and the economy, but it also understands that this choice must be supported by beneficial policies.

Negosyo Advocates plays a key role because it brings together people from very different backgrounds. Farmers sit beside scientists, transport manufacturers speak with renewable energy groups, and cooperatives work with business owners and students. Even though their fields are different, their challenges are very similar. The shipbuilding sector shared that the Philippines is the fourth largest shipbuilder in the world but still depends heavily on imported materials and faces corruption. Jeepney body builders explained that they design vehicles suited for difficult mountain roads but often deal with unclear rules and expensive parts. Renewable energy workers said solar power is becoming more common, but most large solar projects are controlled by foreign companies.

Scientists discussed good inventions that cannot be produced in large numbers because the country lacks factories. These stories demonstrate that different industries face similar pressures: local producers work diligently, but the system often makes their work more challenging rather than easier.

Many speakers gave simple but powerful explanations. They said that buying local is not only an emotional choice. This choice is also practical and economic. When a Filipino buys a product made in the Philippines, the money stays in the community. Purchasing locally pays a farmer, supports a small store, keeps a factory open, and helps a transport worker. Small and medium enterprises make up 99.6 percent of all businesses in the country. They employ millions of people. But in many government discussions, they have no formal voice. This imbalance leads to policies that favor big companies or importers instead of local businesses that give jobs to ordinary Filipinos. Several participants said that the balance needs to change because a strong country must be able to produce many of the things it needs.

The conference also showed that unity is the best strategy. Many people agreed that no single business can resolve these problems alone, but

many businesses working together can influence real change. The presence of groups like the National Economic Protectionist Association, the Mama Sita Foundation, the United Broiler Raisers Association, and local banks showed that many want to help build this movement. People talked about forming stronger groups, improving industry clusters, and working together on policy changes. They asserted the need to tackle issues such as corruption, unfair competition, smuggling, and inadequate support for local industries. These problems harm everyone, not just entrepreneurs. They limit jobs, weaken communities, and prevent longterm economic growth.

The last part of the conference focused on solutions. Participants said that Filipino producers are ready to grow if the system becomes fairer. They asked for better infrastructure, more affordable electricity, simpler government processes, and trade rules that do not harm local businesses. They also asked for public education so more people understand the importance of choosing Filipino products. They want young people to support local industries and feel proud of buying what their own country produces. There was also a call to support national industrialization so the country can do more than just assemble or import products. Many speakers said the Philippines must learn to produce its own raw materials, machines, tools, and technologies. This is the only way to create more jobs and stronger communities.

Through all these discussions, one message became clear. Sulong Lokal is not just about buying local. It is about changing the way Filipinos think about their economy. It asks people to believe that Filipino workers can produce quality products. It asks the government to create policies that help local industries. FRESH VIEWPOINTS / page 11

Corruption Philippines: The clear and present danger for the nation

Elizaldy Salcedo "Zaldy" Co is a Filipino of his own volition, or businessman and politician who previously served as representative for Ako Bicol Partylist in the House of Representatives. In a televised video presentation beamed from overseas, Zaldy Co admitted to having facilitated large scale budget insertions and implicated high-ranking government officials.

Are the unsworn video revelations made by Zaidy from a foreign country after his resignation and after his departure acceptable before the courts of law or in the investigations in the Philippines? Will his revelations prove the culpability and accountability of top government officials and private contractors implicated in the corruption of flood control measures and other infrastructure projects?

Will Zaldy Co's confessions be a powerful catalyst for accountability? Can it dismantle the escutcheon of corrupt power structure and put closure on the ongoing investigations and put an end on corruption in the Philippines? Will Zaldy Co's confession serve as the catharsis and yield redemption of the nation from regression? Or, will his confessions trigger further investigations, sow more confusion or discombobulation and evolve into public agitation, disillusionment undermining public trust, and institutional erosion?

Curiously, are Zaldy Co's revelations premeditated or calculated to cast aspersions, sow dissension, instigate public agitation, and destabilize government? Are his disclosures

were they orchestrated by a powerful person with a Machiavellian and Rasputin-like mind, if not by a dominant faction wanting to seize power? These questions trigger a litany of questions and more questions begging for answers.

Whether Zaldy Co's allegations can ultimately be substantiated or not, the public impact and political fallout of his statements can no longer be undone. Suffice it to say that his revelations reaffirm the widespread perception that corruption is systemic and deeply entrenched in the nation. It also reconfirms that corruption has inflicted severe damages across economic, social, and economic governance sectors, including the loss of billions in government funds, hindering economic development, and causing a decline in the quality of public services.

While the exact total amount of all-time corruption is impossible to quantify, the estimated annual losses to corruption in the Philippines range from P700 billion to P1.4 trillion. Based on a 2024 population estimate of around 119 million Filipino citizens, this equates to roughly P5,882. to P11,765 per Filipino citizen per year lost of public funds.

These figures represent a significant portion of the national budget - approximately 20% of the annual government appropriations that are siphoned off. The experts highlights this profound opportunity costs of corruption stating that these funds could have been

Moreover, this funds could have been used for construction farm to market roads and bridges to facilitate delivery of government services, and open new business and trade in the remote rural communities,

Accordingly, the total estimated losses from corruption over the past decade from 2016-2025, amounted to as high as P8.8 trillion an amount that exceeds the entire proposed 2026 national budget. Moreover, corruption have also damage the Philippines' international relations by eroding trust, reducing diplomatic influence and international cooperation, as corrupt government are seen as unreliable partners, hindering foreign aid, discouraging foreign investors, fueling conflict, and destabilizing the economy, and weakening its standing in the community of nations.

Metaphorically, like a metastasizing cancer, corruption has permeated all the organs of government and is draining the nation of its own blood. Undoubtedly, corruption severely undermines the development and wellbeing of Filipinos and has metamorphosed into The Clear and Present Danger to the Philippines.

ILOILO CITY (PIA) — Various national government agencies (NGAs) and non-government organizations partnered to enhance the delivery of services to former rebels (FRs) and their families, consequently strengthening peacebuilding and reintegration efforts in Western Visayas through an event dubbed "Handog Serbisyo, Hakbang Tungo sa Kapayapaan: Enhanced Comprehensive Local Integration Program and Firearm Remuneration Program Strengthening" held on November 20, 2025, at Sam's 21 Hotel, Mandurriao, Iloilo City.

Early identification, intervention program for kids with autism eyed

ILOILO CITY - The Sangguniang Panlungsod (city council) here is eyeing an ordinance requiring the establishment of an early identification and intervention program for children with autism spectrum disorder (ASD) and other neurodevelopmental disorders.

Under the proposed ordinance, the program will have developmental screening services, referral pathways, and intervention services as components, targeting children below 18 years old who are residents of the city.

It shall be implemented through barangay health centers, public daycare centers and public schools in coordination with private stakeholders, hospitals and educational institutions.

During the floor deliberation on Wednesday, Councilor Mandrei Malabor said the program will focus on initial screening or assessment and the interventions or referral will come later.

"This will allow indigent parents in the city to have their children assessed. The most is they will have the knowledge on how to manage their children. We have gone around the city and there are a lot of parents, especially in informal areas, who are not aware of the conditions of their children,' he said.

Dr. Celina Gellada, one of the two developmental pediatricians in Western Visayas, said the initiative "is long overdue for children with developmental disorders.

"As you all know, early childhood is the most critical period to identify children with developmental and behavioral disorders. The earlier that we identify them and we can start them on intervention, then they will have better outcomes, they can perform better in schools, they will have maybe opportunity to hold a job later on and all these things," Gellada told the council.

"When we say early intervention, we hope that we see, we identify these children as young as three and up to five years old."

The Philippine Society for Developmental and Behavioral Pediatrics has no exact data, but the 2023 data from the Center for Disease Control showed that the prevalence of autism is one for every 31 children below eight years old. (PNA)

vice mayor and PHP92,000 for councilors per month. Any excess is a discretion of the one preparing the budget, which is the mayor," Sarabia said.

During their committee hearing, they found the program to be "under budget" so it was returned to the local finance committee for correction and to reflect the minimum appropriations.

Under the proposed budget, 43.84 percent will be for general public services intended for planning, financial, administrative, legal and legislative services; while 27.09 percent will be for social services, to include the delivery of education, health and protection of the marginalized sector services.

Meanwhile, 17.66 percent of the budget is allotted for economic services to fund initiatives to promote economic growth and increase productivity in agriculture and other industries; while 11.41 percent will be for other services that are not included in the three mentioned sectors.

The local government is targeting to source 55.13 percent of the allocation from local sources and 44.87 percent from external sources, including the National Tax Allotment Share. (PNA)


