City gov't opens redeveloped Jaro big market

THE Iloilo City Government opened the redeveloped Jaro Big Market on December 10, 2025.

It was led by Mayor Raisa Treñas, in the presence of Vice Mayor Lady Julie Grace Baronda, councilors of Sangguniang Panlungsod, Local Economic Enterprise Office (LEEO) Head Maricel Mabaquiao, Jaro Public Market Vendors Association President Gregorio Sambolan, among others.

The new Jaro Big Market is described as a modern facility that retains the appearance and spirit of Jaro, the Mestizo District of Iloilo. Its architectural

Philippines' Primelectric Explores South In a significant move to bolster infrastructure development and secure

kilo rice rollout By Mary Joy Cavañas TO enhance food security across the Iloilo province, Governor Arthur Defensor Jr. said that the Provincial Government eyes to continue the rollout of P20 pesos per kilo of rice, as part of its mandate under the "Sipag at Tiyaga for MoRProGRes" Program, linking agriculture with food, health, and nutrition security interventions. According to Defensor, the subsidized rice will be limited to targeted beneficiaries of the program across the province, including 9,000 families detected with malnutrition. He also noted that through the national government's support this initiative will expand, as it is included in the 2026 budget. Iloilo City approves P4.5-B budget for 2026

ILOILO CITY – The Sangguniang Panlungsod (city council) passed the more than PHP4.5 billion 2026 general budget and PHP86.96 million budget for the local economic enterprises of Iloilo City during its regular session on Wednesday.

In his committee report, Appropriations Committee chairperson Rex Marcus Sarabia said next year's

design was also inspired by the traditional and old houses in the district.

Located at the ground floor are the wet section and transport access, while dry goods, services, and elevated parking. The redeveloped market also has high ceilings and wide walkways providing comfortable movement for vendors and shoppers. It also has a pitch-roof design that gives an airy, heritage-inspired look.

The market capacity consists of existing vendors, including 122 stallholders and 171 transient vendors. There are also 547 new kiosks wherein 330 are located at the ground floor and 217 are at the second floor.

Jaro Big Market also has facilities, including:

- * Parking area 68 cars, 62 motorcycles, 10 transport slots
 - * Access stairs
- * Ramp (from the sidewalk to the ground floor, there are ramps on both sides of the building)
- * Elevator
- * PUJ loading and unloading bay (El 98 Street)
- * Delivery bays and service road
- * Sprinkler system
- * Generator set
- * PA system
- * Rainwater harvesting
- * Septic vault, cistern tanks, individual grease traps for wet sections, provision for STP
 - * Security features: CCTVs

Rental rates in the market range from P790 to P1,021 per month, depending on the stall type and category.

In her message, Mayor Raisa Treñas conveyed her thanks and appreciation to the vendors and community members. She also emphasized how beautiful and well-arranged the new market is.

"You will now notice how lovely our market is — spotless, neat, more spacious, all authorized vendors are welcome back, and we can host more legitimate vendors. There is a dedicated parking space and quality amenities to enhance the service and working environment for both vendors and customers here," Treñas said.

Treñas also expressed gratitude to everyone's support, including Jaro's residents, vendors, market committee, and LEEO, in making the market's redevelopment possible.

She added that the market is not just a project of the city, but a part of the lives of the vendors and their families.

"Today, we come together to celebrate the opening of the new and more improved Jaro Big Market. Let us continue to take care of it. This is not just the legacy of my father's administration (former Mayor Jerry Treñas) — but also your legacy for your families. This is where your livelihoods come from, and where you send your children to school," said Treñas.

(DA), also prioritizes clustered irrigated farms across the province wherein they receive inputs, such as fertilizer and farm tools.

Through this, farmer beneficiaries repay the inputs with palay, which will be processed at the rice processing center in Pototan, funded by the Korea International Cooperation Agency (KOICA).

Defensor also noted that the rice from this program will also be sold for P20 to the beneficiaries, and the rest at a market price to others, in which the revenues will be used to sustain the subsidized component.

Moreover, Defensor noted that the Provincial Government has long provided seeds and fertilizers to farmer beneficiaries, which is linked into the "Sipag at Tiyaga for MoRProGRes" Program.

This initiative will also tap the support of National Food Authority (NFA), whereas the provincial agriculture targets to produce six tons per hectare, and other food security efforts under the said program.

budget is 8.62 percent higher than this year's budget.

Of the total estimated income, 55.13 percent is expected to be generated from local sources, while 44.87 percent is projected to come from external sources.

In a media interview, Sarabia said among the significant items in the budget are the PHP30 million allocation for the assistance to individuals in crisis situation, which increased from this year's PHP12 million; medical assistance, which is a new item in the budget with PHP20 million; funeral aid, PHP8 million; and employment assistance, PHP30 million.

"I am impressed with the 2026 budget because the people can really feel the support of the city government. Almost PHP100 million was appropriated for services and assistance," he said.

Also included in the budget is the salary increase

and health insurance coverage for job orders.

Sarabia said they also secured around PHP40 million to PHP70 million for socialized housing.

He said there is a need to secure relocation sites for those affected by flood control projects.

"This is a serious step of the city government to complete flood control projects, whether being implemented by the Iloilo City government or the national government," he said.

Antique LGU to sustain 'Aruga' project

SAN JOSE DE BUENAVISTA, Antique - The local government unit (LGU) of San Jose de Buenavista has committed to sustaining the "Aruga" (care) project of the Department of Social Welfare and Development (DSWD), which looks into the welfare of children with disabilities.



The initiative was piloted in Antique's capital town, following the signing of a memorandum of agreement (MOA) between the LGU and the department in June of this year, which is valid for one year.

San Jose de Buenavista Persons with Disability Affairs Office (PDAO) head Amie Dava said in an

> interview on Tuesday that the local government has decided to sustain the initiative, following its significant impact on the holistic development of child beneficiaries.

"A funding of PHP600,000 had already been included in the 2026 Annual Investment Program (AIP) of San Jose de Buenavista for the continuity of the project," she said.

The fund will be used as financial assistance for the 100 kid beneficiaries who will receive PHP2,000 per month, to be released twice within a school year for their educational, medical and other needs.

"They are also able to undergo skills training,

large-scale projects, having built its reputation as a critical contractor for South Korea's power plants, semiconductor fabs, and major infrastructure.

"For utilities facing growing demand and challenging environments, this partnership is a direct investment in grid resilience."

The timing of the visit is pivotal. In response to the forecasted bulk of supplies required by Primelectric's ongoing and future expansion projects, Taeyoung Electric has undertaken a major capital investment: a new manufacturing plant in Ansan, South Korea.

Scheduled for inauguration in April 2026, the facility represents a direct capacity boost to meet the escalating needs of partners like Primelectric. It stands as a tangible commitment to the long-term alliance, ensuring a stable and scaled supply chain for the next phase of the Philippine utility's growth.

While Taeyoung is categorized as a strong tier-2 specialist in the competitive Korean market, its credentials are premier. The company is renowned for its deep-seated relationships with Korean industrial giants like KEPCO, POSCO, and Samsung C&T—a testament to the quality and reliability it brings to monumental projects.

IP families affected by dam project receive P7-M in livelihood grant

ILOILO CITY -**Indigenous Peoples (IP)** families affected by the implementation of the Jalaur River Multi-Purpose Project Stage II (JRMP II) in the **Municipality of Calinog** in Iloilo received an additional PHP7 million for their livelihood projects from the Department of **Labor and Employment** (DOLE).

Steve Cordero, Watershed Management Section Chief of the Institutional Management Division of the National Irrigation Administration (NIA), said DOLE is part of the interconvergence mechanism under JRMP II.

"As of this time, we are now on our fourth tranche of livelihood program from DOLE with a total amount of almost PHP19 million. We continuously avail of the program of DOLE because of our good performance during their monitoring," he said in a phone interview on Wednesday.

The check was released by DOLE, led by Regional

'If'

Just to put things in their proper place, the column title "IF" is not about the popular song of Bread but rather the poem written by the English poet Rudyard Kipling sometime in 1895.

The poem speaks of real life challenges, human nature, character, trials and tribulations. It serves as a reminder to be grounded, to be bold, dealing with failure as much as with success. It also shows that critics and envy abound, even several centuries ago.

Every now and then, I read the poem to remind me that all of the above comes with life and are consequences of dealing with people and to serve as a personal compass.

While reading the poem early this week, I was reminded of a friend who is a visionary, a patriot and someone so bold and is in the habit of defying the odds. But in the process, he is constantly disparaged, doubted, even maligned by lesser individuals and envious groups.

He has been called nothing more than a mechanic, a China man, unqualified, inexperienced in the world of real business, dreaming, boastful, even crazy.

But in spite of all these, he maintains his composure and diplomacy. He has come to accept that crab mentality, small-time thinking is and will be part of the business landscape. "The criticism," he says, "only stops when the critic dies."

Rather than get petty and vindictive, his form of revenge is "radical success" and profit. Instead of wasting energy and resources, he chooses to put them into thinking big and doing more.

I refer to none other than Ramon S. Ang a.k.a RSA, chairman and president of San Miguel Corporation.

While talking to one of his officers in B-Meg, we recalled how we reacted in disbelief that SMC would break the mold and invest in "mega" poultry farms and modern feed mills.

Today, those mega farms and mills are no longer sufficient to meet the public demand for chicken as well as feeds for poultry, hogs, dogs, goats, etc. We believed in market history, RSA followed data and believed in market capacity.

When RSA went into infrastructure and started bidding three times higher than the competition, people said he was over investing and would go broke, especially with NAIAX, on April 15, 2013. Today, the NAIAX is already beyond capacity.

When RSA decided to embark on building the SMC-Bulacan Airport, he was blocked, opposed by government officials back then. "Only in the Philippines will you find such a massive, game changing project built on private land" and "private sector funded."

But instead of "hurrahs" and "let's go," politicians found ways and means to "skin the cat," line their pockets or steal business ideas. Others said the project would never get off the ground, while fake NGOs falsely accused RSA and the project of destroying the environment.

Even a bill that would allow an export processing zone in the proposed airport was vetoed. That bill would have maximized economic benefits and job generation for the province of Bulacan.

Today, people are pinning the donkey's tail on NNIC and the NAIA. People who could not accept defeat at the bidding as well as the changes in tenancy now agitate in their interest rather than cooperate with the majority of satisfied locators at NAIA.

In spite of such pests, RSA and SMC remain focused on what is essential. SMC continues to be very profitable from "a little of everything." All the expansion programs, the diversification into infrastructure, power, petroleum plus the traditional businesses have come together in spite of head winds and disrespect.

If, in your own little way, you have been subjected to the same behavior or insults, read the words and

Corruption in our plundered country, according to President Marcos, is a cancer that must be

One thing about certain cancer treatments: they can kill the cancer cells – along with the host.

In the excision, can Doctor Bongbong Marcos wield the scalpel or obliterate the carcinogens with chemo or radiation with surgical precision, so that the patient not only survives, but also thrives post-op?

Cancer treatment has improved exponentially in my lifetime. I know many cancer survivors, including several who were diagnosed to be in advanced stages, who regained their health, who had children and are still active a decade or two after their initial diagnosis. Cancer is no longer a surefire death sentence.

Still, despite advances in medicine, cancer remains a major killer, with certain types more aggressive than others. And sometimes, the treatment can hasten the patient's demise.

Doc BBM correctly diagnosed the disease. Now can he prescribe the proper treatment?

After that impressive launch of his anti-corruption crackdown, through his memorable "mahiya naman kayo" State of the Nation Address followed by the identification of the biggest public works contractors and the opening of the sumbongsapangulo reporting site, BBM now seems to be groping blindly for his next moves.

The economy and other sectors are feeling the uncertainty. Business confidence is down; consumption is dampened; investors are on waitand-see

Opportunists are stirring unrest in the military and police, compelling BBM to buy their loyalty with a salary (and consequently, retirees' pension) hike, leaving the next administration to deal with "fiscal collapse." Is this cure worse than the disease?

Maybe the perpetually overworked and underpaid public school teachers and health workers should take up arms and spread rumors that they are planning to stage a coup.

Certain groups are exploring ways to exploit the public outrage, to seize power through extraconstitutional means so they can become the new ruling class of thieves.

Presumably, there is increased public awareness that corruption takes away hefty sums from state coffers than can otherwise be used to improve government services.

For example, those billions in kickbacks pocketed by the looters in Congress could have built all the new roads in Mega Manila, to be used for free by taxpayers. Instead the government has to get the private sector to build the roads needed to ease traffic.

Since profit drives private enterprise, of course tolls are collected on these roads: P35 minimum to use just about a kilometer of the NAIA expressway from Macapagal Boulevard to the NAIA Terminal 1. For the four-kilometer Muntinlupa-Cavite Expressway, the toll is P23 for cars, P47 for buses and light trucks and P70 for heavy trucks.

With its billions in funding, how can the Department of Public Works and Highways be unable to build and maintain bypass roads of just one or four kilometers, which are badly needed to decongest Metro Manila traffic? Where do our road user's taxes go? (OK, now we know – to overpriced traffic barriers, cat's eyes and other kickback-enabling procurements.)

All these road tolls are tacked on to logistics costs, which contribute to inflation in food and all other commodities that require road transportation. And the steep tolls discourage their regular use, even among middle-class motorists, defeating the purpose of decongesting ground-level traffic.

Our government services are so pathetically inefficient NAIA operations had to be privatized, which resulted in higher fees for everything at the airport.

Now Lufthansa Technik Philippines, aircraft maintenance provider for international carriers, with 3,200 highly skilled employees, could pack up from the NAIA following an over-tenfold jump in its monthly lease rate, after its 25-year lease expired last August.

The Germans see a Fraport 2.0 shaping up – something that is reportedly spooking investors from the world's third largest economy (and Europe's largest)

Unless a compromise is struck soon, Lufthansa will

reportedly pack up and relocate to more investment-friendly and predictable countries.

The private sector addresses the weaknesses in governance, providing services that the state cannot deliver properly. But surely it's not impossible to mobilize taxes to provide the infrastructure that we need, to spare the public from stiff road tolls and other fees.

Those trillions of pesos in public works funds pocketed by thieves could have built all the bypass roads, skyways and bridges that the government had to toss to the private sector. The trillions could have built science-based flood control projects that adhered to contract specs and actually worked.

DA W. Visayas to pilot mobile soils lab in Iloilo's 1st district

In a deployment activity and technical advisory for farmers on Monday, Integrated Laboratories Division officer-incharge Chief, Dr. Lerisa Balopeños said the activity hosted by the municipality of Guimbal on Dec. 9 to 12 is their first deployment

Balopeños said the deployment will be a crucial one and will involve all their soil scientists, with a target release of results in three days.

The activity aims to provide site-specific fertilizer recommendations based on soil analysis, capacitate farmers and agricultural extension workers on soil and nutrient management, update soil health and soil fertility map data, and monitor soil chemical, physical, and biological parameters.

Adaptive balance fertilization strategy (ABFS), crop protection, and weather/adaptation and mitigation initiatives in agriculture will also be provided.

For now, Balopeños said the MSL is equipped to test soil parameters for nitrogen, phosphorus, and potassium, and acidity or alkalinity.

"We will try to offer more soil parameters next year," she

She added they target to deploy the MSL in other provinces

of Western Visayas after they have completed Iloilo.

She said the tests have to coincide with the planting season

She said the tests have to coincide with the planting season to determine the fertilizers needed for their type of soil.

Meanwhile, James Earl Ogatis, chief of the agri-fishery information section, said that starting next year, their agricultural information caravan will now become an agricultural services caravan.

Instead of technical persons, he will bring the MSL, an agricultural information provider, mobile disinfection vehicle, and the regional crop protection vehicle (mobile pest and disease laboratory) to the local government units. (*PNA*)



Addressing ceaseless corruption

President Ferdinand Marcos Jr. has heard the interminable criticism from all corners against political dynasties, perceived as enabling widespread corruption and nepotism.

This week, the 68-year-old President pushed for the swift passage of key reforms, including the antipolitical dynasty measure, independent people's commission bill, amendments to the party-list system and a bill strengthening accountability on public finance.

The President, during a meeting with the Legislative-Executive Development Advisory Council, grasped the nettle and, without hesitation, urged Congress which will adjourn before the Christmas holidays, to prioritize the four bills, according to Palace Press Officer Claire Castro.

The President's moves signifies taking a decisive, bold action to solve a problem or seize an opportunity rather than avoiding it.

These proposals cover the Anti-Political Dynasty bill; Independent People's Commission Act; Party-list System Reform Act; and Citizens Access and Disclosure of Expenditures for National Accountability or CADENA Act to

institutionalize transparency and accountability on public finance.

The President instructed the Senate and the House of Representatives to "take a closer look" at the four priority measures and ensure their passage "as soon as possible."

First off, the anti-dynasty bill prohibits individuals from running for or holding public office if they have a relative up to the fourth degree of consanguinity or affinity who is an incumbent official at the national or local level.

These dynasties have been severely criticized because they are widely perceived to weaken democratic institutions, enable widespread corruption and nepotism, limit equal opportunity for public service, and are strongly linked to higher poverty rates and underdevelopment in areas they control.

We will see how Congress will address the Presidential order on taking a bold, decisive action to finally pass the long-pending Anti-Political Dynasty bill into law..

While there is no single, fixed number for Philippine political dynasties, we know they are

extremely prevalent, with estimates showing over 70 percent of provinces and a vast majority of Congress dominated by political families.

Ballpark figures suggest there are over 170 dominant dynasties existing as of a 2010 analysis, demonstrating a systemic control of power despite the Constitution's anti-political dynasty provision.

In the provinces, 73 out of 80, or 94 percent, have at least two dominant political families.

In the House of Representatives, 74 percent, or 170 representatives belong to political families while 80 percent, or 18 of 23 senators, are from political families in the Senate.

Given the current punching scenes on corruption and the obvious lack of transparency and accountability at present, the people will be closely watching how Congress will tackle the priority bills.

Their actions will not be ignored by a watching public, aching for transparency, accountability, and empowerment against corruption across government sectors including the infrastructure zone. (manilastandard.net)

Violence and authority

The recent brutal killing of a dog allegedly by a local official in Sadanga, Mountain Province, is the latest incident of animal cruelty this year – sparking public outrage, and rightfully so.

According to news reports, the dog, an American Pitbull named Axle, was repeatedly hit with a piece of wood by a man reported to be a municipal official during a community gathering. CCTV footage of the incident, which has made the rounds on social media, showed the dog attempting to flee but continuing to be hit by the man. The dog later died from the injuries sustained, according to the report.

While some would dismiss animal cruelty as a lesser issue compared to the human-centered ills plaguing our society, the tragic death of Axle at the hands of someone in authority is not simply about the loss of one animal's life – it is a betrayal of public trust.

It is frustrating and disappointing that a person – who supposedly implements the law – is allegedly the one breaking it as well. Animal cruelty is not a trivial matter; it reflects a deeper disregard for life and compassion. Allowing such behavior to go unchecked normalizes violence and erodes the values of empathy and responsibility that should prevail, especially among public officials, whose very essence of duty is

to serve.

After all, how can we trust those in power to uphold the law if they are the ones perpetuating violence against the most vulnerable and voiceless members of our society? When leaders commit cruelty, consequences must be harsher, not lighter.

As a society, we must recognize that our treatment of animals mirrors our soul as a nation. I have repeatedly said that a society that is cruel to animals is a broken society bereft of decency and good moral order.

This incident underscores the urgent need for accountability and consistent enforcement of the Animal Welfare Act. Laws are only as effective as the people entrusted to uphold them, and when those in positions of authority are implicated in such acts, it sends a chilling message that cruelty can be tolerated.

Public outrage over the death of Axle is not enough. It should be channeled into tangible action that would lead to reform and ensure accountability. What is needed is a holistic approach that addresses policy gaps, education, governance, and community participation when it comes to pushing for animal welfare.

Once again, I call on our lawmakers to pass the amendments to the Animal Welfare Act with increased

penalties for cruelty, especially for public officials. Second, the stricter implementation of the Animal Welfare Act is a must to promote accountability and deter others from abusing animals.

Third, education must play a bigger role in advocating for animal welfare. This includes integrating responsible pet ownership in basic education curricula, information campaigns at the barangay level, and training for public officials, particularly those in enforcement roles.

At its core, this issue is about morality. Killing a defenseless animal is not just a crime – it is a moral failure. When leaders engage in such acts, they send a message that cruelty is acceptable, that power excuses violence. This cannot stand.

Axle's death should not just be part of the news cycle. It should serve as a wake-up call for stronger animal welfare policies in the country.

Justice for Axle must be pursued to reaffirm that cruelty has no place in our society, especially when instigated by a public official. Accountability must be swift to send a clear signal that violence in any shape or form has no place in our country.

Corruption Philippines: Breakthrough or breakout?

What is corruption, and why should we Filipinos be dignity, hope and future bothered about it?

The United Nations Convention Against Corruption (UNCAC), a treaty which the Philippines ratified and is obligated to adhere to its provisions, views corruptions as a serious crime and a scourge that must be prevented with collective bold action.

Corruption, as defined by the World Bank, is the abuse of public office

for private gain. It encompasses a wide range of behavior, from bribery to extortion, embezzlement or theft of public funds, and the use of public power for private benefit. Corruption include nepotism, fraudulent practices such as misleading actions or omissions to gain advantage or avoid an obligation, as well as collusive practices agreements between parties for improper purpose or personal benefit.

In the Philippines, corruption is defined by Republic Act No. 3019 (Anti-Graft and Corrupt Practices Act) as the abuse of public office for private gain. Specific corrupt practices include causing injury to any party, giving unwarranted benefits, or acting with manifest partiality, evident in bad faith, or gross inexcusable negligence. Other forms, such as bribery, embezzlement, and awarding contracts to unqualified individuals, are also illegal under the act.

According to reports, the Philippines loses around P700 billion pesos

every year to corruption - money lost that should have funded essential public services. Every peso stolen from public funds is a peso denied to the sick, the hungry, and the struggling Filipino.

Every amount stolen is not just money lost - but it is life taken away from someone who needed it most. More the money stolen from government funds could have funded the expansion of eater, light and power and telecommunication services. Furthermore, corruption damages the country's economic prospects, undermines the rule of law and public safety, eroding public confidence in governance, and demising international respectability of the country.

Overall, corruption leads to financial losses, poor quality services, social instability, and diminished quality of life for the people. Ultimately, every peso stolen from the government represents a missed opportunity for a better life for Filipinos. Corruption robs us of our safety,

better future prosperity. It is a critical issue that demands our collective concern and action.

President Bong-Bong Marcos first exposed the alleged corruption involving "ghosts" anti-flood measures and "phantom" infrastructure projects

during his fourth State of the Nation Address (SONA) on July 26, 2025. He subsequently revealed initial audit findings and details on August 11, 2025.

As of November 30, 2025, 130 days have past since the SONA last July 26, 2025, and 111 days have elapsed since August 11, 2025 - the day the President made the revelation. The Senate Blue Ribbon Committee began its investigation on August 19, 2025 or 101 days to date; while the Independent Commission for Investigation (ICI) f started its investigation on September 16, 2025, or 73 days to date. Since then, it is not yet publicly known how many cases have been filed by the DOJ for prosecution. Available information do not provide a clue regarding the total number of cases filed specifically as a result of the investigation by the Senate Blue Ribbon Committee.

According to reports, the fact-finding body have so far recommended at least two (2) batches of cases to the Ombudsman for prosecution of nine (9) individuals involved in the "flood control scam" and other anomalous and substandard infrastructure projects. Accordingly, the first batch of cases were filed in mid-November by the Ombudsman with the Sandiganbayan. Ironically, there was no mention about the names of those to be prosecuted.

As reported by the media, it was PBBM himself who initiated the ongoing investigations, and he acknowledges the peoples frustration over the slows pace but emphasizes that building an "air-tight" cases based on solid evidence and due process is crucial for the successful prosecutions that withstand legal challenges.

Expediting investigations and prosecutions of graft and corruption cases is imperative to mitigate severe and further damage to the economy, regain the public trust and improve citizens well-being. It is crucial to

combat widespread impunity and ensure accountability for misuse of public funds for personal gain.

Delays in the administration of justice can render eventual judgement meaningless and unfair due to severe economic, social, and political damage. The legal maxim "justice delayed is justice denied" holds true because excessive delays in the legal system undermines its purpose as prompt and timely resolution is essential for justice to be meaningful.

Prolonged delays can erode evidence, degrade witness memories, and impose hardships on all the parties involved, and ultimately nullifying the benefits of a just outcome, causing prolonged hardships for all parties, and diminishing faith in the legal system's ability to be fair and effective.

Moreover, it causes real harm to Filipinos and diminish international respectability for the Philippines.

In the light of all the foregoing, and with all due respect to all our duly constituted authorities and legal luminaries, sans malice and without being

presumptuous, if it has not been done yet, to expedite investigations and prosecutions of corruption cases within the bounds of due process,

the President may issue Executive Order/s to strengthen existing anti-corruption bodies, streamlining and mandating full cooperation and coordination between all executive agencies, key anti-corruption bodies such as the Ombudsman, the DOJ, the Commission on Audit (COA) and the ICI for inter-agency cooperation to prevent jurisdictional overlaps and ensure evidence is shared efficiently. Moreover, the President may issue an official directive to bolster witness protection program encourage more insiders to come forward, ensuring their safety and providing them with strong support thereby securing vital testimony and documentary evidence.

Corollary to all of the foregoing, the investigation bodies can expedite

Following the findings of the Education Commission II, the Department of Education (DepEd) and the Department of Budget and Management (DBM) have signed a joint circular to establish more child development centers (CDC) in the country's underserved areas. There are 3,800 barangays in the country that have no CDCs, as reported by the Early Childhood Care and Development (ECCD) Council.

The signing of the joint circular is also in line with the directive of PBBM to ensure quality education for Filipino children.

Establishing child development centers in underserved areas is crucial in ensuring that all children, regardless of their socio-economic background, have access to quality early childhood education. These centers provide a safe and nurturing environment where young children can develop foundational skills in language, cognition, social interaction, and emotional regulation. Research has proven that early education significantly influences a child's lifelong learning trajectory, academic success, and overall well-being. These centers, situated in underserved communities with limited resources and learning opportunities, significantly contribute to breaking the cycle of poverty by providing children with a robust start and leveling the playing field. Investing in early childhood development is not only a matter of equity but also a powerful strategy for building a more inclusive and prosperous society.

I think the establishment of CDCs should prioritize geographically isolated and disadvantaged areas (GIDAs). These are communities that face major challenges in accessing basic services due to their remote location and socio-economic conditions. Often situated in mountainous regions, islands, or conflictaffected zones, GIDAs suffer from poor infrastructure, including limited roads, inadequate healthcare, and a lack of schools. Transportation and communication are difficult, and children in these areas often have to walk for hours, cross rivers, and navigate rough terrain just to attend school.

High poverty rates, limited access to education, and poor health outcomes distinguish GIDAs beyond

geographic barriers. These compounded disadvantages make them priority areas for government and development efforts to ensure that no community is left behind in the push for inclusive growth and social equity.

As of 2022, the Department of Health (DOH) identified 3,427 GIDA barangays across the country, with Mindanao accounting for 1,878 of them - more than half of the total. The recently signed joint circular between the Department of Education (DepEd) and the Department of Budget and Management (DBM) underscores the need to address this gap. The circular specifically prioritizes low-income local government units (LGUs) and provides clear guidelines on how they can access funding from the Local Government Support Fund (LGSF). This funding can be used for the construction, rehabilitation, or upgrading of multipurpose buildings (MPBs) that will serve as CDCs, helping bring early childhood education closer to the country's most underserved children.

In this context, the role of local government unit (LGU) officials is crucial in transforming national policies into meaningful, on-the-ground results. The President has clearly expressed his commitment to expanding access to early education, and it is essential that LGU officials respond with urgency, initiative, and accountability. To fully realize the directive to establish CDCs in GIDA areas, they must actively and purposefully engage. Furthermore, they must strategically use the LGSF funding, prioritize the construction and enhancement of CDCs over less critical projects. By aligning local actions with national priorities, LGUs can play a pivotal role in breaking the cycle of inequality and giving every Filipino child, regardless of location, a strong and fair start in life.

The establishment of CDCs should also embrace a holistic approach that integrates both education and nutrition. Children in GIDA areas are among the most vulnerable, often facing severe poverty and food insecurity that compromise their health and learning

A well-nourished child is far more likely to succeed in school and in life, making nutrition an indispensable pillar of any robust early learning initiative.

We should be deeply concerned about the extent of stunting in the Philippines. The United Nations Children's Fund (UNICEF) reports that one in three children in the country suffer from stunting. The Philippines ranks fifth in the East Asia and Pacific region for the highest stunting prevalence and is also among the top 10 countries worldwide with the highest number of stunted children.

It is therefore essential that CDCs extend their role beyond the traditional scope of early education by addressing the needs of children even before they enter the classroom. This involves actively engaging families and communities to promote prenatal care, proper nutrition, responsive parenting, and early stimulation at home. By laying a strong foundation during the critical first 1,000 days of a child's life, CDCs can help ensure that children arrive healthy, developmentally ready, and prepared to learn. This holistic and forward-looking approach recognizes that early childhood development begins well before formal instruction and requires the collective involvement of families, caregivers, and the wider community.

REGULATION ORDINANCE NO. 2025-336

AN ORDINANCE ESTABLISHING AN EARLY IDENTIFICATION AND INTERVENTION PROGRAM FOR CHILDREN WITH AUTISM SPECTRUM DISORDER (ASD) AND OTHER NEURODEVELOPMENTAL DISORDERS IN ILOILO CITY, PROVIDING FUNDS THEREFOR, **AND FOR OTHER PURPOSES**

WHEREAS, section 15, Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among

WHEREAS, RA 7277 (Magna Carta for Disabled Persons) as amended by RA 9442, states that Disabled persons are part of Philippine society, thus the State shall give full support to the improvement of the total well-being of disabled persons and their integration into the mainstream of society. Toward this end, the State shall adopt policies ensuring the rehabilitation, self-development and self-reliance of disabled persons. It shall develop their skills and potentials to enable them to compete favorably for available opportunities.

WHEREAS, UNICEF focuses on ensuring the rights and well-being of children with autism, advocating for their inclusion in society and access to necessary support services.

NOW, THEREFORE, be it ordained, as it is hereby ordained by the Sangguniang Panlungsod of Iloilo City, in session duly assembled, that:

SECTION 1. TITLE

This Ordinance shall be known as the "Iloilo City Early Identification and Intervention Program for Children with Autism Spectrum Disorder and other Neurodevelopmental Disorders Ordinance

SECTION 2. DECLARATION OF POLICIES - The Iloilo City Government hereby declares the following policies:

- a. The City Government recognizes and promote the rights and welfare of children with developmental conditions, particularly those with Autism Spectrum Disorder (ASD).
- b. It affirms the State's commitment to uphold the rights of children to proper health care and development, and in accordance with Republic Act No. 7277 (Magna Carta for Disabled Persons), Republic Act No. 9442 (Amending RA 7277), and Republic Act No. 11148 (Kalusugan at Nutrisyon ng Mag-Nanay Act).

SECTION 3. OBJECTIVES

This Ordinance aims to:

- a. Establish a city-wide program for the identification of Autism Spectrum Disorder and other neurodevelopmental disorders among children;
- b. Ensure timely referral and access to intervention services for children at risk or diagnosed with autism and other neurodevelopmental disorders;
- Promote awareness, capacity-building, and training for allied health professionals, child development workers, and teachers on ASD;
- orders identification into existing different ntegrate autism and other neurodevelopmental public health programs;
- e. Create an efficient data collection, case management and monitoring system for children screened and diagnosed with autism and other neurodevelopmental disorders.
- **f**. To establish linkages and collaboration with relevant agencies.

SECTION 4. DEFINITION OF TERMS

For purposes of this Ordinance, the following terms shall mean:

- a. At Risk Children who exhibit early signs or manifestation of neurodevelopmental disorder.
- b. Autism Spectrum Disorder (ASD) is a neurodevelopmental condition characterized by difficulties in social communication, social interaction and presence of restricted repetitive patterns of behaviors, interests or activities. (DSM-5-TR)
- c. Developmental Screening The use of standardized tools to assess if a child is at risk for developmental delays, including autism.
- d. Identification The process of identifying neurodevelopmental disorders (NDDs) through clinical assessments, genetic testing and advanced imaging
- e. Intervention Referral, therapies and support services provided to address
- f. developmental needs of children with neurodevelopmental disorders such as but not limited to physical speech therapy, occupational therapy, and educational behavioral interventions.
- g. Neurodevelopmental Disorders are a group of conditions that affect the brain's development and function, leading to difficulties in areas like language, social interaction, learning, and motor skills.

SECTION 5. SCOPE AND COVERAGE

This Ordinance shall cover all children below 18 years of age whose parents or guardians are residents of Iloilo City. It shall primarily be implemented through barangay health centers, public daycare centers, and public schools, in coordination with private stakeholders, hospitals, and educational institutions.

SECTION 6. PROGRAM COMPONENTS

The Iloilo City Early Identification and Intervention for Autism and other Neurodevelopmental Disorders Program shall consist of the following components:

a. Developmental Surveillance Services

Barangay health centers and child development centers shall offer initial surveillance screening using the parents concern or observation about their children.

Screening at the Health Centers will be conducted by a licensed medical or allied health professionals trained to administer a standardized screening tool.

b. Referral Pathways

Children identified as at risk shall be referred to specialized professionals and institutions for further assessment and management.

c. Intervention Services

The City Health Office (CHO) shall coordinate with the City Social Welfare and Development Office (CSWDO), Government hospitals, therapy centers and schools for educational placement and developmental support.

d. Awareness Campaigns A city-wide information drive or dissemination shall be conducted annually to educate

e. Training and Capacity-Building Training programs shall be provided for health workers, child development

the public on the importance of early identification and intervention for neurodevelopmental

workers, teachers, and barangay officials to recognize early signs of autism and other neurodevelopmental disorders and refer children for screening.

f. Parental Support and Counseling

Parents of children with suspected or diagnosed ASD and other neurodevelopmental disorders shall be provided counseling services, support groups, and orientations on how to manage the condition of the child.

g. Data Management and Monitoring

The Iloilo City Government shall establish a database system to track screening results, intervention, and outcomes. All data shall be handled in compliance with the Data Privacy Act of 2012.

h. Public awareness campaign

Raise understanding and acceptance through education, media outreach and community activities.

i. Linkages, networking and collaboration with relevant agencies

Enhance autism support by establishing strong linkages, proactive networking, and sustained collaboration with government agencies, NGOs, schools, and health partners to expand services and community awareness.

SECTION 7. HIRING OF MEDICAL PERSONNEL

The City Government shall allocate funds to engage the services of a licensed Developmental Pediatrician, Psychologists, Psychometrician, Occupational Therapist, Speech Pathologist and other allied health professionals.

SECTION 8. IMPLEMENTING MECHANISM

a. Lead Implementing Office

The City Health Office (CHO) shall serve as the lead agency in the implementation of this program, in close coordination with the City Social Welfare and Development Office (CSWDO) and the City Department of Education Schools Division of Iloilo (DepEd-Iloilo City).

b. City Inter-Agency Committee on Autism and other Neurodevelopmental Disorders and Support

A City Inter-Agency Committee on Autism and other Neurodevelopmental Disorders Support (CIACANDS) is hereby created to oversee the implementation, composed of: City Mayor - Chairperson

City Health Officer – Vice Chairperson

CSWD Officer - Member

City Schools Division Superintendent - member

Chairperson SP Committee on Health - member

Chairperson SP Committee on Social Services - member Chairperson SP Committee on Education - member

Representative from Persons with Disabilities Affairs Office (PDAO) - member

Representative from Autism Society of the Philippines Iloilo - member

Representative from SPED - ISEC Iloilo City - member

Representative from RISEABLE Early Intervention Center - member

The Committee (CIACANDS) shall meet at least once a year and be responsible for policy development, inter-agency coordination, resource mobilization, monitoring and evaluation of the program.

The City Inter-Agency Committee mentioned in Par (b) above shall formulate and issue the Implementing Rules and Regulations (IRR) within sixty days (60) from the effectivity of this ordinance.

SECTION 9. PARTNER PROVIDERS

The City Government may enter into Memorandum of Agreement (MOA) with hospitals, therapy centers, and non-government organizations who has the medical and technological capacity to provide free or subsidized screening and intervention services for children referred through the program.

SECTION 10. FUNDING

The amount necessary to implement this Ordinance shall be charged to the Annual Budget of the City Government, through the City Health Office under a dedicated program for Autism Early Identification and Intervention Support Services.

Additional funding may be sourced from:

National government grants

Special Education Fund

Private donations, corporate social responsibility (CSR) initiatives, and NGOs

Partnerships with international aid organizations

SECTION 11 MONITORING AND EVALUATION

A biennial review of the ordinance's effectiveness shall be conducted by the CIACANDS, with findings and recommendations presented to the Sangguniang Panlungsod for policy enhancement. Metrics shall include early diagnosis rates, access to intervention, and long-term outcomes for

SECTION 12. SEPARABILITY CLAUSE

If any provision of this Ordinance is declared unconstitutional or invalid, the other provisions not affected shall remain in full force and effect.

SECTION 13. REPEALING CLAUSE

All ordinances, executive orders, rules and regulations, or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 14. EFFECTIVITY

This Ordinance shall take effect fifteen (15) days after publication in a local newspaper of general circulation and submission to the Office of the President for approval, pursuant to the Local Government Code.



Iloilo City Government partners with St. Robert's International College to promote education to persons deprived of liberty.

The USWAG Scholarship Program of the Iloilo City Government now supports over 2,500 scholars, providing educational assistance that eases financial burdens and helps young Ilonggos pursue their dreams.

Beyond financial aid, the RAISKOLAR Program strengthens the scholar community through mentorship and fellowship. Alumni are gathered into a network that guides new scholars, shares opportunities, and empowers them to give back. Initiatives like RISE TO LEARN monthly sessions, RAISKOLAR CAMP leadership training, and weekly ISTORYA ISKOLAR features that learning, inspiration, ensure empowerment continue inside and outside the classroom.

USWAG Scholarship also extends its reach through partnerships, such as with St. Robert's International College (SRIC) for their Green Volunteers initiative, and the distribution of learning modules to Persons Deprived of Liberty at the Iloilo City Male Dormitory-BJMP. These collaborations reflect the program's commitment not only to scholars but to the wider community.

Since 2010, the scholarship program aided more than 30,000 students in their education. From classrooms to communities, USWAG is more than a scholarship — it is a movement of hope, service, and leadership that prepares scholars to rise, lead, and inspire.

DENR 6 exec highlights role of mangroves in community protection

ILOILO CITY – The Department of Environment and Natural Resources in Western Visayas (DENR 6) on Wednesday emphasized the role of mangroves in protecting communities and preserving marine habitats.

DENR 6 Regional Executive Director Raul Lorilla, in a forum on Wednesday, said a coastal community in Capiz that survived Super Typhoon Yolanda in 2013 planted mangroves, which lessened the impact of succeeding typhoons.

"That is how nature-based solutions are being pursued by the DENR in relation to various strategies that are being espoused by the government. We still maintain that the nature-based solution is worth being implemented, considering its long-lasting impact on the community," he said.

DENR data showed that around 9,727 hectares of coastal areas in the region were planted with

These include the Bakhawan Eco-Park in Kalibo and the Katunggan It Ibajay Mangrove Ecopark in Aklan; the Madulano Mangrove Rehabilitation Project in Capiz; and established areas within

> the Taklong and Tandog Group of Islands Natural Park.

In Iloilo, there is the Leganes Integrated Katunggan Ecopark in Leganes town, and mangrove plantations in Iloilo City.

"Nature-based solution is a system wherein we adopt the course of nature," he added.

Other benefits of mangroves include mitigating the impact of climate change, providing a breeding ground for marine life, fuel wood, medicines, and carbon sequestration.

why we emphasized that planting of mangroves and other tree species is crucial in terms of the global challenges that we are facing on climate change," he added.

Other than mangrove planting, the DENR aims to increase the forest cover in the region, currently at 12 percent.

He said they are partnering with local government units and encouraged private and survey claimants, and lot owners to plant trees in their vacant spaces.

"We are more particular on forest cover that is implemented in forest land because that is its ecological component and requirement to address the vulnerability of the environment," he said. (PNA)

making the Congress adjust its legislative calendars by setting aside non-urgent legislative measures and focus on urgent matters such as the corruption investigations and prosecutions of corruption cases.

The Senate Blue Ribbon Committee can also fasttract its investigations by setting time limits on debates, creating specific sub-committee/s and focusing on the inquiry on a narrow scope to expedite hearings and reportings and move the investigations forward quickly than the traditional process.

Likewise, independent bodies like the Ombudsman and the Sandiganbayan can "motu proprio " expedite prosecution of corruption cases by setting aside ongoing backlogs, upgrading its procedures, improve technology, and conduct marathon hearings of cases. Likewise, it can hire additional justices to increase its capacity for streamlining case filings and trials. It can deputize "resident ombudsman" to assist in conducting fact-finding inquiries and investigatory activities.

The Supreme Court can also help expedite the investigations and prosecutions of cases through administrative reforms, designation of the Regional Trial Courts (RTCs) to function as special anti-corruption courts specifically for cases involving corruption in government infrastructure projects, and other courts dedicated to handling these specific types of cases. Since R.A. 10660 have expanded the jurisdiction and functions of the Regional Trial Courts, it can help expedite proceedings by offloading cases from the Sandiganbayan. This streamlines the process by ensuring these cases are automatically assigned to judges who exclusively focus on them, thereby preventing them from being lost in general case backlogs.

According to media reports, while the "ghost projects scandals" highlight significant fraud, they are not the only corruption case, but it is widespread across the Philippine public services, from the national agencies like the DPWH down to the barangays.

Failure to stop corruption now in the Philippines now leads to severe and devastating economic instability, reduce investors confidence, worsens poverty and fosters inequality, compromises public services, weakens the rule of law, erode public trust, and creates a vicious cycle that destabilizes the nation.

Ultimately, failure to counter and stop corruption now create fertile ground for extremist groups or subversives to exploit public discontent, recruit members, and undermine the government thereby leading to instability and fragmentation of the Filipino nation. Moreover, according to governance experts and international bodies like the United Nations and World Bank, failure to stop widespread corruption compromises national security of the country and renders the citizens more vulnerable.
